## Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

## Overview of Bill

The object of this Bill is to make further provision regarding administrative expenditure payable from the Administration Fund.

## Outline of provisions

**Clause 1** sets out the name, also called the short title, of the proposed Act.

**Clause 2** provides that the proposed Act will be taken to have commenced on 1 April 2023.

**Schedule 1** amends the *Electoral Funding Act 2018* for the purpose set out in the overview above.
