# Better Regulation Legislation Amendment (Miscellaneous) Bill 2024

Act No , 2024

An Act to amend various Acts and regulations administered by the Minister for Customer Service and Digital Government, the Minister for Better Regulation and Fair Trading and the Minister for Building.

### The Legislature of New South Wales enacts—

### 1 Name of Act

This Act is the Better Regulation Legislation Amendment (Miscellaneous) Act 2024.

### 2 Commencement

This Act commences as follows—

- (a) for Schedule 1.14[2]—on a day or days to be appointed by proclamation,
- (b) otherwise—on the date of assent to this Act.

### Schedule 1 Minor amendments

### 1.1 Associations Incorporation Act 2009 No 7

### Section 77 Distribution of assets

Omit section 77(4). Insert instead—

- (4) A person aggrieved by the operation of this section in relation to an association's property may apply to the Supreme Court for an order about the disposal of the property.
- (5) The Supreme Court may deal with an application by making the orders the Court thinks fit in relation to the disposal of the association's property.

### 1.2 Building and Construction Industry Security of Payment Act 1999 No 46

### Section 8 Right to progress payments

Insert at the end of the section—

- (2) A person is not entitled to a progress payment under subsection (1) if the construction contract—
  - (a) does not comply with the *Home Building Act 1989*, section 4, or
  - (b) involves construction work that is residential building work done in contravention of the *Home Building Act 1989*, section 92.

### Section 13A Application to authorities of Licensing and Registration (Uniform Procedures) Act 2002

Omit section 13A(3)(c).

Omit "common property" wherever occurring. Insert instead "association property".

### Section 11 Application to licences of Licensing and Registration (Uniform Procedures) Act 2002

Omit section 11(3)(h).

### 1.6 Fair Trading Act 1987 No 68

### [1] Section 58 Scheme for publication of service station fuel prices

Insert ", whether or not the building or place is staffed" after "there" in section 58(6), definition of *service station*.

#### [2] Section 58(6), definition of "service station"

Insert at the end of the definition—

**Example—** a public electric vehicle charging station that is not staffed

### [3] Section 58(6), definition of "standard retail price"

Omit the definition. Insert instead—

**standard retail price**, in relation to a prescribed fuel supplied by retail at a service station, means the following—

- (a) for hydrogen—the price per kilogram at which the fuel is available to retail customers, without discounts or special offers,
- (b) for electricity—the price calculated in accordance with arrangements approved by the Secretary by order published on the NSW legislation website,
- (c) otherwise—the price per litre at which the fuel is available to retail customers, without discounts or special offers.

### [4] Section 60D Fit and proper person

Omit "suspension" from section 60D(3)(b)(ii). Insert instead "cancellation".

### **Section 13 Membership of Advisory Board**

Omit "personally or in the ordinary course of post" from section 13(4)(e).

### 1.8 Home Building Act 1989 No 147

### [1] Sections 33E(1)(b)(i) and (1A)(b)(i), 33F(1)(b)(i) and (1A)(b)(i) and 33G(1)(b)(i) and (1A)(b)(i)

Insert "and test" after "Install" wherever occurring.

### [2] Section 33F Additional requirements for obtaining endorsed contractor licenses and supervisor and tradesperson certificates relating to medical gasfitting work

Omit section 33F(1A)(a). Insert instead—

- (a) has successfully completed the VET qualification Certificate IV in Plumbing, and
- [3] Section 33G Additional requirements for obtaining endorsed contractor licenses and supervisor and tradesperson certificates relating to medical gas technician work

Omit section 33G(1A)(a)(ii).

### 1.9 Motor Dealers and Repairers Act 2013 No 107

#### [1] Section 5 Motor dealers

Omit "second-hand" from section 5(5).

### [2] Section 150 Purposes for which powers of authorised officer may be exercised

Omit "Part 4.5 of the Road Transport Act 2013" from section 150(b).

Insert instead "the Road Transport Act 2013, Part 4.5 or 4.5A".

### 1.10 Pawnbrokers and Second-hand Dealers Act 1996 No 13

#### [1] Section 28 Pawnbroker's record of pledges

Omit section 28(3). Insert instead—

(3) A pledge is not validly made unless—

- (a) the person pawning the goods signs the record, including by, if the record is kept in electronic form, signing a hard copy or attaching an electronic signature, and
- (b) at the time of signing, the record contained all the particulars required by or under this Act to be included in the record.

### [2] Section 28(4)

Omit "original record, or hard copy,". Insert instead "record".

### [3] Section 29A Agreement to extend redemption period

Omit "original record" from section 29A(5)(a). Insert instead "record".

### [4] Section 29A(6)(a) and (b)

Omit the paragraphs. Insert instead—

- (a) the person entering the extending agreement with the pawnbroker signs the record, including by, if the record is kept in electronic form, signing a hard copy or attaching an electronic signature, and
- (b) at the time of signing, the document contained all the particulars required by or under this Act to be included in the document.

### [5] Section 29A(7)

Omit "original of any such".

### 1.11 Residential Tenancies Act 2010 No 42

#### [1] Section 178 Members of Rental Bond Board

Omit "of the Department of Customer Service" from section 178(1)(a).

Insert instead ", who is the Chairperson of the Board".

### [2] Section 178(1)(a), note

Insert at the end of section 178(1)(a)—

**Note—** Secretary is defined in section 3(1) to mean the Commissioner for Fair Trading or, if there is no person employed as Commissioner for Fair Trading, the Secretary of the Department of Customer Service.

### [3] Section 178(2)

Omit the subsection.

### [4] Schedule 1 Membership and procedure of Rental Bond Board

Omit clause 4(5). Insert instead—

(5) To avoid doubt, the deputy of a member who is the Chairperson has the member's functions as Chairperson and is taken to be Chairperson.

### [1] Section 197 Application of Act to electronic form plans and other documents

Omit ", other than an office copy of a court order," from section 197(1)(b).

### [2] Section 197(3) and (3A)

Omit section 197(3). Insert instead—

- (3) If a plan is lodged electronically, any other document that is required to be lodged with the plan must also be lodged electronically in an electronic form approved by the Registrar-General.
- (3A) Subsection (3) does not apply to a document excepted from that subsection by the regulations or another Act or by the Registrar-General.

### [1] Section 186 Strata scheme information to be given to lessee

Insert at the end of section 186(3)—

Maximum penalty—5 penalty units.

### [2] Section 191 Building work to which Part applies

Omit section 191(1). Insert instead—

- (1) This part applies to the following building work—
  - (a) residential building work carried out on a building or part of a building that is part of the parcel of a strata scheme,
  - (b) building work carried out on a building or part of a building that is—
    - (i) part of the parcel of a strata scheme, and
    - (ii) used or proposed to be used for mixed use purposes that include residential purposes,
  - (c) building work that—
    - (i) is carried out on a building or part of a building that is not part of the parcel of a strata scheme, and
    - the owners corporation is liable to pay for under a strata management statement or a building management statement registered under the *Conveyancing Act 1919*, Part 23, Division 3B.
- (1A) Building work specified in subsection (1)(c) is taken to be carried out on a building in a part of the parcel of a strata scheme for the purposes of this part.

### Dissolution of Building Insurers' Guarantee Corporation and closure of Building Insurers' Guarantee Fund

- (a) the Building Insurers' Guarantee Corporation is dissolved, and
- (b) the Building Insurers' Guarantee Fund is closed, and
- (c) the balance of the Building Insurers' Guarantee Fund is transferred to the Self Insurance Corporation, and
- (d) the assets, rights and liabilities of the Building Insurers' Guarantee Corporation are transferred to the Self Insurance Corporation.
