Road Transport Legislation Amendment (Speed Camera Detection) Bill 2024

Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

Overview of Bill

The object of this Bill is to amend the *Road Transport Act 2013* to permit evidence of the average speed of a light vehicle between detection points to be used as evidence of the actual speed of the vehicle for the purposes of speeding offences.

Outline of provisions

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act.
