No. 1 **Commencement—consequential amendment**

Page 2, clause 2, line 6. Omit all words on the line. Insert instead—

This Act commences as follows—

- (a) Schedule 1[3A] and [4A]—on the day that is 12 months after the date of assent to this Act,
- (b) otherwise—on the date of assent to this Act.

No. 2 **Expiry of offence of displaying Nazi symbols on or near synagogue, Jewish school or Sydney Jewish Museum—consequential amendment**

Page 3, Schedule 1. Insert after line 17—

**[3A] Section 93ZA(1)**

Omit “other than on or near a synagogue, a Jewish school or the Sydney Jewish Museum”.

No. 3 **Expiry of offence of displaying Nazi symbols on or near synagogue, Jewish school or Sydney Jewish Museum—consequential amendment**

Page 3, Schedule 1. Insert after line 19—

**[4A] Section 93ZA(2) and (3)**

Omit “(1AA) or” wherever occurring.

No. 4 **Expiry of offence of displaying Nazi symbols on or near synagogue, Jewish school or Sydney Jewish Museum**

Page 3, Schedule 1. Insert after line 23—

**[5A] Section 93ZA(5)**

Insert after section 93ZA(4)—

- (5) Subsection (1AA) and the definition of *Jewish school* expire on the day that is 12 months after the date of assent to the *Crimes Legislation Amendment (Racial and Religious Hatred) Act 2025*.

- No. 10     **Amendment of Graffiti Control Act 2008**  
Page 6, Schedule 3, lines 1–29. Omit all words on the lines.
