#### (Paper No. 66)

\*3089 CO-LOCATION OF CHILD PATIENTS IN ADULT WARDS AT HUNTER HOSPITALS—Mr Craig Baumann asked the Minister for Health—

- (1) Is the Minister aware that due to a lack of beds at the John Hunter Hospital and other Hunter health care facilities, child patients are being co-located in the adult hospital wards and vice versa?
- (2) What initiatives has the Department of Health put in place to prevent this from happening?
- (3) How many additional children's hospital beds will be required in the Hunter Valley to prevent the practice of child patient co-location from occurring?

Answer—

I am advised by the Hunter New England Area Health Service:

- (1) The practice of admitting child patients into an adult ward within any Hunter New England Area Health facility is extremely unlikely and almost non-existent. The admission of adults into adolescent wards, whilst also unlikely, has, on some rare occasions, occurred with sound practices in place to ensure the safety of children.
- (2) The Hunter New England Area Health Service has developed the Security of Children Admitted to Hunter New England Facilities (2008) policy to provide clear advice to clinicians and managers regarding the security and appropriate bed management of infants, children and adolescents in Hunter New England Health facilities.
- (3) There is not a routine overflow of paediatric and adolescent patients requiring admission and creating a significant demand for additional paediatric/adolescent beds.
- \*3090 FUNDING FOR MOTOR-NEURONE DISEASE RESEARCH—Mr Craig Baumann asked the Minister for Health—
  - (1) Has the Department of Health engaged in funding any motor-neurone disease research in the last budget period?
  - (2) What ongoing programs has the Department of Health implemented to specifically support people living with motor-neurone disease in New South Wales?

Answer-

I am advised:

(1) and (2) NSW Health provides generalist neurological services to meet the needs of all people with progressive, neurological disorders, rather than services focused on specific diagnostic groups.

NSW Health has four multidisciplinary motor neurone-disease clinics situated at Calvary, St Josephs, Royal North Shore and Prince of Wales Hospitals. The clinics provide as a minimum, medical, nursing and allied health services with some clinics providing additional services, such as palliative care and sleep studies.

In addition the NSW Department of Health currently funds the Motor Neurone Disease Association NSW under the Non-Government Organisation Grant Program. Further information relating to the mission and activities of the Motor Neurone Disease Association can be found on the Association's web site at: www.mndnsw.asn.au

I am further advised that this question should also be referred to my colleague the Hon. Verity Firth MP, Minister for Science and Medical Research as this matter also comes within her area of responsibility.

- \*3091 FUNDING FOR MOTOR-NEURONE DISEASE SUPPORT—Mr Craig Baumann asked the Minister for Ageing, Minister for Disability Services—
  - (1) How much funding has the Department of Ageing Disability and Home Care (DADHC) provided to motor-neurone disease support groups in the last budget period?
  - (2) What ongoing programs are in place to support people living with motor-neurone disease in New South Wales?

Answer-

(1) DADHC has been working with the Motor Neurone Disease Association (MNDA) of NSW to trial initiatives aimed at assisting with the care needs of people with Motor Neurone Disease (MND).

I am advised that these initiatives included:

- the allocation of \$500,000 in April 2006 and \$450,000 in March 2008, to enhance the MNDA of NSW equipment pool;
- \$2 million to NSW Community Options (COPS) from the Home and Community Care Program in 2005. This includes \$200,000 to pilot a case management model for people who require support for a limited time targeting people with MND. This pilot is still in operation;
- \$1 million in June 2007 to a consortium consisting of Multiple Sclerosis Limited, the Muscular Dystrophy Association and the Motor Neurone Disease Association for flexible respite over a period of four years; and
- \$600,000 in May 2007 to the Motor Neurone Disease Association of NSW to improve information and referral services and to provide rapid response short term flexible support services.

DADHC is also working closely with MNDA to identify ways to ensure current funded services are able to respond quickly to the needs of this client group. A quick response protocol has been developed for dealing with applications for high level in-home personal care services through the Attendant Care Program and the High Needs Pool.

(2) Services which people with Motor Neurone Disease are able to access include the Attendant Care Program and a full range of services funded through the Home and Community Care Program.

I am advised that NSW Health also provides recurrent funding to MNDA to provide comprehensive information, support and advocacy for people living with the disease, their families and carers across NSW. This is administered by the Sydney South West Area Health Service. There are also four MND Clinics located at Calvary, St Josephs, Royal North Shore and Prince of Wales Hospitals. These clinics are funded jointly by the MNDA of NSW and the individual Departments of Neurology and Allied Health of the relevant hospitals. In addition to the specialist services, people with Motor Neurone Disease are eligible to access generalist neurological services, community nursing, allied health, centre-based day care services, palliative care and rehabilitation services.

I am further advised that MNDA also received one-off local carer grant funding through the NSW Carers Program in 2007, to conduct education workshops and establish support groups in three different Area Health Services over three years. This project is administered by the Greater Southern Area Health Service.

\*3092 POLICE RADIO—Mr Craig Baumann asked the Minister for Police, Minister for the Illawarra—

Acknowledging that criminal and antisocial elements within the community can currently listen in on police radio networks:

- (1) Are plans in place to encrypt the police radio network in regional areas?
- (2) If so, what is the timing on the implementation of this encryption?
- (3) In the meantime are police officers issued with mobile phones to ensure secure communication when required?

Answer-

The NSW Police Force has advised me:

(1) and (2) The digitisation and encryption of all operational radio channels within the regional locations of Newcastle, the Central Coast and Wollongong have already been completed. Progress is proceeding in accordance with the NSW Government Radio/Wireless Strategy 2003-2018.

(3) Any operational requirements for secure digital communications in regional areas can currently be facilitated through established special operations channels. Police also have a secure and auditable method of interrogating police operational databases for confidential information through the use of Mobile Data Terminals.

## \*3093 PAEDIATRIC REGISTRARS IN THE HUNTER REGION—Mr Craig Baumann asked the Minister for Health—

Regarding the paediatric registrars in the Hunter region:

- (1) Is the Minister aware of a shortage of paediatric registrars in Hunter region hospitals?
- (2) Has the Department of Health engaged in any programs to ensure the number of paediatric registrars increases?
- (3) What is the Government doing to attract more senior clinicians to Hunter hospitals?

Answer—

I am advised by the Chief Executive of the Hunter New England Area Health Service:

(1) and (2) John Hunter Children's Hospital is the lead hospital in the Northern Paediatric Training Network, one of 3 Networks in NSW established to support paediatric specialist training. Geographically this Network supports Paediatric Registrars based in Hospitals from Gosford up to the NSW northern border.

Trainees rotate within these networks to obtain broad experience across a number of sites. This will result in Paediatric Training being a more popular career choice for medical officers when considering their specialist career options and ensures that the service requirements of the various hospitals are met.

There are currently 20 registrars working in the Northern Network and approximately half of these are employed in the 2 accredited Paediatric Training Hospitals in the Hunter region, John Hunter Children's Hospital and Maitland Rural Referral Hospital.

Currently there is one Paediatric Registrar vacancy in the Northern Network, which is actively being recruited to. Coverage from alternate workforce has been arranged pending this recruitment to ensure adequate staffing levels are maintained. Recruitment for the 2009 intake of registrars will take place in August/September of this year.

(3) NSW Health has invested extensively in medical recruitment at both a State and Area Health Service level. This includes both national and international recruitment campaigns. Current medical vacancy levels in the Hunter are lower than they have been in the last five years.

The introduction of the Joint Medical Program between the University of Newcastle, University of New England and the Hunter New England Area Health Service significantly increases the number of medical students in the region. As many students are from local families, it is anticipated that many of these doctors will remain in the region after they graduate.

## \*3094 TWO PERSON CREWS FOR HUNTER AMBULANCES—Mr Craig Baumann asked the Minister for Health—

Regarding two person crews for Hunter ambulances:

- (1) Has the Government engaged the NSW Ambulance Service and the Health Services Union in discussions concerning the lack of two person crews for ambulances in the Hunter region?
- (2) Is additional funding required to furnish Hunter region ambulances with two person crews?
- (3) When will this funding be made available?
- (4) Will additional ambulance officers be required to ensure two person crews on Hunter roads?
- (5) What has the Government done to recruit more ambulance officers in New South Wales?
- Answer—

I am advised by the Chief Executive, Ambulance Service of NSW:

(1) The issue of single officer responses is an ongoing industrial issue between the Ambulance Service and the Health Services Union and has been the subject of extensive discussion at the state, divisional and local levels. The Ambulance Service and the Health Services Union are currently seeking the assistance of the Industrial Relations Commission to resolve this matter.

(2) to (4) In 2003/2004 the NSW Government committed \$41 million to provide an additional 230 ambulance officers over four years for rural and regional areas.

Since 2004, 27 additional officers have been placed in the Hunter area in consultation with the Health Services Union as part of this rural enhancement program. This included an agreement to place six additional paramedics at Ambulance stations in the Outer Hunter area.

(5) In addition to the rural enhancement program, in May 2005, the NSW Government announced an additional 250 ambulance positions for the Sydney metropolitan area to be recruited by 2008/09. As a result of this enhancement, 142 new staff were recruited by the end of 2006/07.

The Ambulance Service of NSW undertakes local and overseas initiatives to recruit operational staff.

- \*3095 STUDENT ENROLMENT AND TRUANCY LEVELS—Mr Chris Hartcher asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—
  - (1) How many students are enrolled at:
    - (a) Terrigal High;
    - (b) Kincumber High;

(c) Erina High?

(2) What is the rate of truancy in each school in:

(a) 2006;

(b) 2007?

Answer-

- (1) There are 1,289 students enrolled at Terrigal High School, 1,016 at Kincumber High School and 1,003 at Erina High School.
- (2) The Department of Education and Training does not collect truancy rate data on a locality basis.

Student attendance data is collected from all public schools and each school makes this information publicly available through annual school reports.

\*3096 SHARED ACCOMMODATION IN PUBLIC HOSPITALS—Mr Chris Hartcher asked the Minister for Health—

- (1) What is the policy in public hospitals in relation to men and women being accommodated in the same ward?
- (2) Which hospitals have a policy of accommodating men and women in the same ward?
- (3) Why do men and women share the same ward at Gosford Hospital?

Answer-

- (1) to (3) I refer the Member to my response to Question No. 0905 in the Legislative Assembly. A similar policy is in place at Gosford Hospital.
- \*3097 EARLY INTERVENTION CASEWORKERS—Ms Katrina Hodgkinson asked the Minister for Community Services—
  - (1) As of 13 May 2008 how many caseworker positions exist within DoCS, which have been 'quarantined' to provide case management for families involved in the Brighter Futures program?
  - (2) As of 13 May 2008, how many of these caseworker positions were actually filled?
  - (3) As of 13 May 2008 how many families in NSW are receiving assistance through the Brighter Futures Program?
  - (4) As of 13 May 2008 how many families have been approved for eligibility in the Brighter Futures program by a Community Services Centre or have been referred from a community agency or individual or Aboriginal Maternal Infant Health Service but have not yet received this support?
  - (5) Will the Minister provide me with a copy of the interim report of the evaluation of the Brighter Futures program by the Social Policy Research Centre at the University of NSW?

\*3098 SCHOOL CROSSINGS—Ms Katrina Hodgkinson asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

With the installation of the flashing lights and electronic alert system at the Campbell Street School Crossing in Young, will the RTA withdraw funding for the Traffic Guard (Lollipop Lady) at this location?

Answer—

I am advised:

No. The installation of a school zone alert system (flashing lights) at this zone does not supplant the role of a School Crossing Supervisor.

#### Answer-

Maintenance in schools across the State is an ongoing activity, constantly delivered throughout the year through a comprehensive suite of initiatives designed to best meet a range of circumstances:

- Preventative Maintenance is regular work performed by a contractor to keep specific building elements and equipment in good repair.
- Programmed Maintenance is work based on items that are picked up in the bi-annual condition assessments of each school. Annual maintenance plans are developed by schools in conjunction with their local Asset Management Unit.
- Essential Urgent Repairs are maintenance works undertaken immediately by the contractor if required by the school, with the school contributing up to its specific contribution limit.
- The Extra Maintenance Program is a four year state-wide program aimed at injecting additional funding into priority areas.

The Department of Education and Training continues to work with school Principals and school communities to identify priority projects to deliver safe, well-maintained learning environments for the students of NSW.

\*3101 DISABILITY HOMES IN HORNSBY—Mrs Judy Hopwood asked the Minister for Ageing, Minister for Disability Services—

In relation to disability homes in the Hornsby electorate:

- (1) What is the number of disability homes that are currently owned or leased by the Department of Ageing, Disability and Home Care in the Hornsby electorate?
- (2) What is the maximum number of disabled persons that could be accommodated in the homes listed in response to (1)?
- (3) What is the actual number of disabled persons currently being accommodated in the homes listed in response to (1)?
- (4) (a) Are there any future plans to lease, purchase or build additional disability homes in Hornsby?

(b) If so, what are they?

Answer-

- (1) I am advised that the Department of Ageing, Disability and Home Care (DADHC) owns 11 and leases two properties in the Hornsby Electorate. They are used as group homes to provide long term supported accommodation to people with a disability.
- (2) I am advised that the maximum number of people with a disability that can be accommodated in the group homes is 54.
- (3) I am further advised that as at 13 June 2008, the actual number of people with a disability currently accommodated in the group homes is 49. The Metro North Region is actively working to fill vacancies
- (4) (a) I am advised that under Stronger Together, planning is underway to allocate an additional 650 supported accommodation places across the state over the next three years. It is anticipated that at least 100 of these places will be allocated to the Met North region. All allocations are made on the basis of equitable population distribution and identified need.

(b) Not applicable.

\*3103 FOSTER CARERS-Ms Sonia Hornery asked the Minister for Community Services-

- (1) How many foster carers are there in the electorate of Wallsend?
- (2) How many children do they care for?

Answer—

(1) and (2) The electorate of Wallsend falls across the catchments of Edgeworth and Charlestown Community Services Centres.

As at 31 March 2008 394 carers were being paid across both Community Services Centres, catchments. They cared for a total of 644 children and young people.

\*3104 MOREE ABORIGINAL LANDS COUNCIL—Mr Kevin Humphries asked the Minister for Local Government, Minister for Aboriginal Affairs, Minister Assisting the Minister for Health (Mental Health)

What is the current status of the Moree Aboriginal Lands Council with particular reference to:

- (a) the outcome of the role of Lawler and Associates who acted in an Administrative capacity for 3 years;
- (b) the costs of an appointed administrator;
- (c) the most recently audited set of financial statements;
- (d) the legal status of the current committee and their ability to prioritise tenants, set and collect rents and also evict tenants;
- (e) the future of the Moree LALC?

Answer-

(a) to (e) Lawler Partners' role in the administration of Moree Local Aboriginal Land Council ceased in June 2006 when the administrator, Mr Paul Gidley, joined the firm of Ferrier Hodgson Newcastle. In the period following the conclusion of the administrator's term (May 2007) the Moree Local Aboriginal Land Council again substantially breached the Aboriginal Land Rights Act (ALRA). As at 3 June 2008 the Moree Aboriginal Land Council had failed to hold an AGM and elect a Board as required by the ALRA.

Upon a request from the NSW Aboriginal Land Council, I appointed an administrator, Mr Andrew Hoholt, to the Moree Local Aboriginal Land Council for a term of six months effective from 3 June 2008. The costs of an appointed administrator vary depending on the characteristics of the land council and the complexity of the administration. The costs of the administrator for the six month appointment to the Moree Aboriginal Land Council were agreed with the NSW Aboriginal Land Council prior to the appointment and will be sixty thousand dollars excluding GST (subject to the provisions of the ALRA which allow a process for variation to those costs in certain circumstances with the prior agreement of the NSW Aboriginal Land Council).

Under the ALRA, Local Aboriginal Land Councils are not required to provide me with a copy of their audited financial statements. Those statements are provided to the NSW Aboriginal Land Council. Following the appointment of the administrator on 3 June 2008 the former office holders were removed from office and therefore have no legal status. The future operational functions of the Moree Local Aboriginal Land Council will be managed by the administrator in conjunction with the members of the Moree Aboriginal Land Council.

\*3105 TRUANCY TRENDS—Mr Kevin Humphries asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—

With respect to truancy trends across the Barwon electorate:

- (1) What are the primary and secondary truancy trends in each DET regional area?
- (2) What are the results of the Walgett trial for non-compulsory attending students?
- (3) What has been the result of announcements made by the Premier that the Government would hold parents accountable and if necessary gaol parents if their children did not attend school?

- (1) The Department of Education and Training does not collect truancy rate data on a locality basis. Student attendance data is collected from all public schools and each school makes this information publicly available through annual school reports.
- (2) The trial is in its early stages but Walgett Community College reports a decrease in the number of

unexplained student absences.

- (3) The legislation referred to is currently being drafted and is expected to be introduced later in 2008.
- \*3106 STUDENT DEBT—Mr Kevin Humphries asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—

Are students who receive student allowances via Centrelink but are not meeting the regular attendance criteria leaving the education system with a Commonwealth Centrelink debt?

Answer—

This question is best directed to Centrelink.

- \*3107 SUTHERLAND HOSPITAL BUDGET FOR NEW EQUIPMENT—Mr Malcolm Kerr asked the Minister for Health—
  - (1) Is Sutherland Hospital provided with funds in its budget to pay for new equipment?

(2) How many pieces of new equipment has it paid for from its budget each year for the past five years? Answer—

I am advised by the Chief Executive of the South Eastern Sydney and Illawarra Area Health Service:

(1) and (2) New equipment is purchased from the Hospital's Equipment budget on a needs basis.

Between 2003/04 and 2007/08 (to date) 787 items of equipment were purchased by Sutherland Hospital.

\*3108 NANOPARTICLES IN NSW FOOD—Ms Clover Moore asked the Minister for Emergency Services, and Minister for Water representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—

Given growing concern about the increased use of nanoparticles in agricultural chemicals, food and food additives, food packaging and food contact materials:

- (1) What safety testing is required before food produced using agricultural chemicals that contain nanoparticles is sold in NSW?
- (2) What safety testing is required before food, including processed food and food additives, that contain nanoparticles is sold in NSW?
- (3) What safety testing is required before food packaging and food contact materials that contain nanoparticles is sold in NSW?
- (4) What is the NSW Government's response to the call of Friends of the Earth Australia that all particles smaller than 300 nanometres should require health and environment assessment prior to use in food and food associated products?
- (5) What consideration has the NSW Government given to implementing a limit on the size of particles used in food and food related products sold in NSW?
- (6) What consideration has the NSW Government given to introducing requirements to label food and food associated products sold in NSW that were produced using nanoparticles?

Answer-

(1) to (6) With respect to food regulation in Australia, government and industry have a joint responsibility to ensure that food safety risks are understood and managed. Under the auspices of the Council of Australian Governments a nationally coordinated framework to food regulation was adopted in November 2000. In terms of standards setting, Food Standards Australia New Zealand is the statutory authority responsible for developing all domestic food standards based on scientific/technical criteria.

One of the primary outputs of the framework is the Australia New Zealand Food Standards Code (Food Standards Code) which in New South Wales is implemented via the Food Act 2003. The Food Standards Code and the Food Act 2003 provide safeguards to ensure that food, however produced, must be safe and suitable as determined by robust safety assessments of food products under Australian and New Zealand conditions. It is an established process, proven to be a solid system that helps keep our foods safe. The use of nanotechnology for chemical applications in the agricultural sector is in its infancy. It is anticipated that a robust food safety assessment would be undertaken within established frameworks before food produced using agricultural chemicals that contain nanoparticles would be allowed to be sold.

The Food Authority advises that it is not aware of any application lodged with Food Standards Australia New Zealand for approval of the addition of manufactured nanoparticles in food. An application would include a rigorous safety assessment in accordance with the Food Standards Code assessment procedures and that assessment would be made available for public and stakeholder input. Food Standards Australia and New Zealand advice is that they are not aware of any food sold in Australia that contains any new type of manufactured nanoparticles. The current scientific evidence of nanotechnology application is that the likelihood of nanoparticles being released from packaging material is low because applications in this area are being directed at fixing or embedding nanoparticles into packaging. Food Standards Australia and New Zealand are continuing to monitor research developments related to nanotechnology and food safety occurring around the world on ongoing basis.

Additionally, recognising the emergence of nanotechnologies and that nanotechnology can lead to novel properties of products raising health, environmental, social and ethical issues, the Australian Office of Nanotechnology has developed the National Nanotechnology Strategy. It aims to establish the environment that allows Australia to capture benefits of nanotechnology while addressing the issues impacting on successful and responsible development of nanotechnology. It complements other Australian Government initiatives and existing research, innovation and industry policies that promote the development of enabling technologies and facilitate greater coordination of policies affecting nanotechnology.

The National Nanotechnology Strategy includes specific initiatives to:

- address the health safety and environmental impacts of nanotechnology on regulations and standards;
- undertake a public awareness and engagement program to provide balanced advice on nanotechnology;
- establish a nanoparticle metrology capability at the National Measurement Institute; and
- facilitate a whole of government approach to nanotechnology through establishing the Australian Office of Nanotechnology.

The National Nanotechnology Strategy recognises the importance of the need for regulatory frameworks to keep pace with improved knowledge on the impact of nanotechnology. A key component of the strategy is to undertake analysis of the impact of nanotechnology on regulatory frameworks, including the nationally coordinated approach to food regulation. These frameworks are being reviewed to ensure regulatory systems address the health, workplace and environmental implications of nanotechnology.

\*3109 PLASTIC BAG WASTE—Ms Clover Moore asked the Minister for Climate Change and the Environment, Minister for Women, Minister for Science and Medical Research, and Minister Assisting the Minister for Health (Cancer)—

Given that the Environment Protection and Heritage Council did not resolve to take mandatory action to phase out plastic bags:

- (1) (a) Does the NSW Government remain committed to phasing out plastic bags by January 2009?(b) If not, why not?
- (2) What date does the NSW Government plan to phase out plastic bags by?
- (3) Given that previous voluntary measures have not worked, what measures are being considered by the NSW Government to:
  - (a) Significantly reduce plastic bag use;
  - (b) Phase out plastic bags altogether?
- (4) Why has the NSW Government refused to commit to banning plastic bags without other States when South Australia has committed to banning plastic bags?

Answer-

(1) (a) and (b) The NSW Government remains committed to a nationally consistent plan to phase out plastic bags.

(2) Timing of a phase out will be dependent on Environment Protection and Heritage Council (EPHC) discussion of the outcomes from the additional work that Council has requested on plastic bags.

- (3) (a) and (b) Measures being considered by the NSW Government and the EPHC include:
  - working with the major supermarkets on further voluntary actions;
  - developing a national plan of action on litter reduction;
  - investigating alternatives including biodegradable bags; and
  - assessing a Victorian trial that tests a retailer charge on plastic bags with funding to go towards environmental outcomes.

Information on all of these strategies will be presented at the next EPHC meeting in November 2008. NSW will consider this additional information prior to determining the best course of action to reduce bag use.

(4) All governments, including NSW, recognise that there is strong community support for taking action on lightweight plastic bags. Single-use bags waste resources and create litter which can harm marine and other mammals, as well as causing visual pollution. Many members of the community are already taking action by using reusable bags.

Given the further work commissioned by the Environment Protection and Heritage Council and the Victorian retailer trial, unilateral action by NSW is not appropriate at this time.

\*3110 LARGE ERECTING SHOP ROLLING STOCK—Ms Clover Moore asked the Deputy Premier, Minister for Transport, Minister for Finance—

With regard to the progressive removal of rolling stock from the Large Erecting Shop in Eveleigh, which is the longest continuous operating railway workshop in Australia:

- (1) Given that the roof of the State Heritage listed AAH19 carriage was damaged by exposure to the elements the last time it was removed from the Large Erecting Shop in Eveleigh and the NSW Transport Museum is short of undercover space, how will the NSW Government ensure that the AAH19 carriage is not damaged by exposure to the elements at the NSW Rail Transport Museum?
- (2) Is the NSW Government aware of the Friends of Eveleigh advice that covering timber carriages with canvas can cause major damage to paintworks?
- (3) What is the NSW Government's response to the widespread community view that the Large Erecting Shop is the most suitable place to store and protect rail heritage?
- (4) Does the NSW Government have ownership records prior to 2006 of heritage rolling stock currently stored at the Large Erecting Shop?
- (5) What is the NSW Government's response to concerns that it plans to relocate all rolling stock currently located at the Large Erecting Shop?

Answer-

I am advised:

(1) to (5) An asset management plan for the AAH 19 carriage (also known as the "Commissioner's Car") is in place to ensure that this important asset will be there for future generations to enjoy. The Commissioner's Car is currently being stored under cover and cared for by the NSW Rail Transport Museum at Thirlmere.

The Government's Sustainable Rail Heritage Asset Management Strategy aims to ensure that the State's rail heritage is preserved for the public of NSW. A key element of the strategy is the recognition and enhancement of the role played by existing volunteer run rail heritage preservation groups in regional NSW.

The Office of Rail Heritage is focused on appropriately allocating core rail heritage assets to, and supporting the conservation activities of these volunteer rail heritage custodians.

Where core Government owned heritage rolling stock cannot be placed with an existing custodian, the Office of Rail Heritage will place the item in a secure, RailCorp storage location.

The current tenants of the Large Erecting Shop, the Company 3801 Ltd and the Powerhouse Museum are aware of the proposed vesting to the Redfern Waterloo Authority, with the Powerhouse Museum indicating it is actively considering alternative storage locations for its rolling stock.

The Company 3801 Ltd has made representations to the Redfern Waterloo Authority to stay in the Large Erecting Shop site.

\*3111 NATURAL DISASTERS—Ms Clover Moore asked the Minister for Emergency Services, and Minister for Water—

Following publication of "Taking a punch: Building a more resilient Australia" by David Templeman and Anthony Bergin for the Australian Strategic Policy Institute, which identifies that most Australians are unlikely to find themselves victims of a terrorist attack but many will face the risks posed by a natural hazard, agricultural or health crisis or a significant failure in critical infrastructure such as power or water:

- (1) Is the NSW Government aware of the analysis and conclusions in this paper?
- (2) What actions has the Government taken to ensure that NSW is adequately prepared for a large mass causality situation such as a natural disaster?

- (3) What has the Government done to ensure that NSW is able to withstand a disaster and return to its pre-disaster state quickly?
- (4) What has the Government done to test NSW capacity to respond to large-scale emergencies?
- (5) What initiatives has the Government taken to ensure the community, emergency volunteers, businesses and others are prepared for large scale natural disasters?
- Answer-

(1) Yes.

- (2) This question should be addressed to the Minister for Health.
- (3) NSW has comprehensive, well-developed and rehearsed emergency management arrangements encompassing disaster prevention, preparation, response and recovery. The State Disaster Plan and other sub-plans can be viewed on www.emergency.nsw.gov.au Community resilience has been increased through a range of education programs and projects undertaken under the joint Commonwealth-State-local Natural Disaster Mitigation Program.
- (4) NSW emergency plans are tested and rehearsed to ensure all response agencies are familiar with their roles and responsibilities in an emergency. The emergency management system also is regularly tested during major emergencies such as floods, storms and bushfires.
- (5) A range of initiatives ensures volunteers, businesses and the community are as prepared as possible for emergencies. These include training programs for emergency services personnel; the SES On-line Business FloodSafe Toolkit; SydneyAlert; detailed information on personal and business disaster preparation and response on the emergencyNSW website; and community education programs such as FireWise and community FloodSafe guides.
- \*3114 COST ASSESSMENT DEPARTMENT—NSW SUPREME COURT—Mr Jonathan O'Dea asked the Minister for Police, Minister for the Illawarra representing the Attorney General, and Minister for Justice—

What were the costs incurred in maintaining and running the Cost Assessment Department of the NSW Supreme Court for each of the years between 1994 to 2007?

Will the Minister implement a review of the Department of Housing's standard written communications to ensure that they are not perceived as being overbearing or ambiguous and to avoid causing unwarranted distress to recipients?

Answer—

Communications are written in a client-friendly, plain English style whenever changes to Housing NSW policy and procedures are made, or when a client complains about inappropriately worded correspondence received from Housing NSW.

\*3117 SUPPORT FOR DISABLED STUDENTS—Mr Greg Piper asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—

Is it standard policy for permanently disabled TAFE students to be advised of note-taking support on a weekly basis, rather than under a permanent arrangement for the duration of the course?

Answer—

Support may be on a weekly or ongoing basis. TAFE NSW teachers aim to ensure that the needs of the students are met and the most effective use is made of the available resources.

\*3118 TAFE CLASSES—Mr Greg Piper asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—

Does a teacher always supervise TAFE classes participating in simulated work practice and is additional support for disabled students always provided as required by legislation?

Answer—

All TAFE NSW classes participating in simulated situations are supervised by a teacher.

TAFE NSW takes all practical steps to provide reasonable adjustments in meeting its obligations under the Disability Discrimination Act (1992) and the Disability Standards for Education (2005).

Support options are negotiated on an individual basis and may change throughout the duration of the course. TAFE NSW teachers aim to ensure that the needs of the students are met and the most effective use is made of the available resources.

\*3119 PUBLIC DENTAL SERVICES IN THE TWEED-Mr Geoff Provest asked the Minister for Health-

Given that of the three dentist positions at the Tweed Hospital, one dentist has resigned, another has taken long-term leave, and the third position has never been filled, leaving the Tweed Hospital with no full time dentists currently available:

- (1) Why was the third dentistry position at the Tweed Hospital never filled?
- (2) When is it anticipated that the two vacant dentistry positions at the Tweed Hospital will be filled?
- (3) Given that the fill-in dentist only visits the Tweed Hospital one day a week, why have more replacement dentists not been recruited to meet the enormous demand for dental services in the Tweed?

Answer-

I am advised by the Chief Executive of the North Coast Area Health Service:

- (1) to (3) A Dental Officer was appointed to the third position in early 2008. This Dental Officer has subsequently resigned and his position has been replaced by a locum Dental Officer. The Tweed Hospital is currently recruiting to the vacant position held, in the interim, by the locum Dental Officer. Interest has been displayed from local Dentists and it is likely this position will be filled in the near future.
- \*3120 HOUSING AVAILABILITY IN THE TWEED—Mr Geoff Provest asked the Minister for Housing, Minister for Tourism—
  - (1) Is the Minister aware that as many as 30 homeless people are living in Kingscliff beach sand dunes as a result of the lack of available housing in the Tweed?
  - (2) Will the Minister ensure that these homeless people are urgently found emergency accommodation?
  - (3) How many Tweed residents are currently on public housing waiting lists, and what is the present waiting time for public housing?
  - (4) Are there any NSW Government plans to address the shortage of housing in the Tweed?

(a) If yes, what are they?

(b) If no, how does the Minister intend to meet the growing demand for housing in the Tweed?

- (1) Housing NSW is not aware of this. If this is the case please direct them to the nearest Housing NSW office for assistance.
- (2) Housing NSW can offer a range of services to assist homeless people with finding accommodation. These include Temporary Accommodation, wait-turn and priority housing, Rentstart (Bond Assistance) and assistance to locate rental accommodation in the private sector. The NSW Department of Community Services also provides accommodation to homeless people through its Supported Accommodation Assistance Program.
- (3) The number of people on the housing register varies and changes constantly. The Tweed area is a high demand area and waiting times vary depending upon the specific housing requirements of individual applicants.

- (4) Yes.
  - (a) Housing NSW has a long term asset plan designed to increase the supply of public housing and is targeting the type of accommodation most in need. This plan will see a net increase of 350 public housing properties over the next ten (10) years in the Tweed through redevelopment and acquisitions. Housing NSW is also seeking to supplement its housing stock through its Headlease program to assist in meeting the demand for affordable housing in this area.

Through the Council Of Australian Governments, the Federal Government and the NSW Government are working to establish the National Rental Affordability Scheme which will stimulate the supply of rental housing in NSW by encouraging institutional investment in new affordable rental housing.

The NSW Government is also committed to increasing the supply of affordable housing across NSW through the not-for-profit community housing sector. Under the \$49.8 million Affordable Housing Innovations Fund, the NSW Government will assist community housing providers to develop or purchase housing using a combination of debt and equity.

The Iemma Government has invested over \$20.4 million in the Tweed area since 2004.

- \*3121 CATTLE TICK FEVER—Mr Geoff Provest asked the Minister for Emergency Services, and Minister for Water representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—

- (2) As the NSW DPI does not hold quantities of the Imizol vaccination due to its short shelf life, will the Minister consider an offer made from the Blissett family to re-establish a cattle dip facility on their land for use by surrounding properties, as means of preventing cattle tick outbreaks?

\*3122 HEALTH CARE COMPLAINTS COMMISSION—Mrs Jillian Skinner asked the Minister for Health—

- (12) What protocols exist within the HCCC for the socialising (professional or otherwise) of complaints and resolution officers, with the NSW medical profession and its associated professional bodies?

- (3) What do people from the Forster-Tuncurry area do if they need public dental treatment?

(3) and (4) The public oral health service at Forster-Tuncurry operates under the Priority Oral Health Program. The focus of the Priority Oral Health Program is to ensure that those in the greatest need of oral health treatment are prioritised for treatment.

Eligible patients requiring dental services may contact the Hunter New England Area Health Service oral health call centre on 1300 720 023 to be triaged. Dependent on their triage category, the patient may:

- be issued a voucher and referred to a private practitioner participating in the Oral Health Fee for Service Scheme for follow up treatment with the public oral health service; or
- be placed on a priority waiting list.

The Foster Dental Clinic will continue to operate in accordance with the Priority Oral Health Program.

\*3125 CLOSURE OF WISEMANS FERRY ROAD—Mr Ray Williams asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

Given a truck loaded with "hotmix" overturned on Wisemans Ferry Road at Cattai near Riverside Oaks on Wednesday afternoon 7 May at approximately 2 pm dropping 'hotmix' onto the road reserve but that the road was not blocked and the truck was removed by a tilt tray at 4 pm that same afternoon:

Why did the RTA works officer close the road until 8 pm that night forcing local residents to either wait four hours in a traffic jam or travel an additional 50 km on other roads to bypass the road closure, when the road could have remained open and the "hotmix" removed from the side of the road the next morning after peak traffic movement?

Answer-

I am advised:

There was spilt material on the road surface which made it inappropriate for road safety reasons to open the road to traffic until such time as this material was removed.

The RTA, local police and the "hotmix" contractor controlled traffic and removed the spilt "hotmix" as quickly and safely as possible. This was completed at 7 pm when the road was reopened.

- In addition the implementation of a monitoring process was agreed to, including improved communication and feedback between Emergency Department management and the Mental Health Service regarding mental health bed capacity.
- The Area Health Service's Mental Health Service has an Area wide bed management system in place, which enables the networked management of all mental health beds.
- The South Eastern Sydney Illawarra Area Health Service will be adding another 40 non-acute mental health beds within the area over the next twelve months. These units will ease the overall bed demand across the Area Health Service.

  - (1) For all the state-owned generators, when were the most recent coal contract negotiations held?

  - (1) Has the Minister received any valuation advice for both the generator and retail businesses over the past three years?

(2) Will he release a copy of this valuation advice?

Answer—

The Government's energy reform project is being led by the Treasurer.

- \*3134 RENEWABLE ENERGY TARGETS—Mr Mike Baird asked the Minister for Emergency Services, and Minister for Water representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—
  - (1) What steps has the Government taken to reach its renewable energy targets in 2008?
  - (2) What potential projects (both feasible and actual) are in line to help the Government achieve its renewable energy target by 2020?
  - (3) What costs are forecast for the Government to achieve its renewable energy target by 2020?
  - (4) What costs are forecast if the renewable energy target is not achieved by 2020?

Answer-

It is not the Government's role to speculate on what projects the private sector may or may not bring forward to meet its 2020 renewable energy target and the NSW Government has not set a renewable energy target for 2008.

The NSW renewable energy target will be subsumed into the Commonwealth Government's commitment to a 20 per cent renewable target - the 20 per cent Mandatory Renewable Energy Target (MRET). The MRET's design is yet to be finalised and therefore the costs cannot be forecast at this time.

- \*3135 ENERGY CONSUMPTION—Mr Mike Baird asked the Minister for Emergency Services, and Minister for Water representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—
  - (1) How much energy does the average household in NSW currently consume?
  - (2) What was the average consumption figure in each of the past five years?
  - (3) What is the average energy consumption for households in the Manly electorate?

Answer—

(1) and (2) This information is available in various publications released by organisations such as the Australian Bureau of Agriculture and Resource Economics, Energy Supply Association of Australia and the Australian Bureau of Statistics.

(3) The Department of Water and Energy is not aware of energy consumption information that would allow analysis at an electorate level.

- \*3136 GREENPOWER SCHEME—Mr Mike Baird asked the Minister for Emergency Services, and Minister for Water representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—
  - (1) How many and what percentage of customers in the State subscribe to the GreenPower scheme?
  - (2) How many and what percentage of customers in the Manly electorate subscribe to the GreenPower scheme?

- (1) I am advised that at 31 March 2008, 201,365 households and 12,637 commercial customers in NSW are now subscribing to GreenPower.
- (2) The Department of Water and Energy, as the national Program Manager of the GreenPower scheme, does not collect information that would allow analysis at an electorate level. However, I am advised that the Department provided funding to Manly Council in 2007 to assist with a community education program on GreenPower.
- \*3137 IMPACT OF GREENPOWER SCHEME—Mr Mike Baird asked the Minister for Emergency Services, and Minister for Water representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—
  - (1) What impact has the GreenPower scheme had in reducing consumption of fossil fuels since it was introduced in NSW?
  - (2) What impact has the GreenPower scheme had in reducing greenhouse gas emissions since it was introduced in NSW?
  - (3) What impact has the GreenPower scheme had in boosting the renewable energy industry since it was introduced in NSW?

(1) to (3) I am advised that the GreenPower scheme has reduced fossil fuel consumption in Australia by over five million megawatt hours and in NSW by over two million megawatt hours since it commenced in NSW in 1997.

This equates to around five million tonnes of greenhouse gas abatement, two million tonnes of which can be attributed to NSW homes and businesses.

The Government does not track the actual value of GreenPower participant's contracts or the value of every Renewable Energy Certificate surrendered under the GreenPower program, but I am advised that for 2007 alone the number is estimated to be in the vicinity of \$45 million nationally.

- \*3138 CLEAN ENERGY ROUNDTABLE—Mr Mike Baird asked the Minister for Emergency Services, and Minister for Water representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—
  - (1) How many times has the Government's Clean Energy Roundtable met since it was formed?
  - (2) When was the most recent meeting?

(3) What recommendations has the Roundtable made and which of these have the Government adopted? Answer—

The committee has met once, on the 29 May 2007. There were no formal recommendations of the meeting.
