- *0423 CONVEYANCE OF INMATES—Mr Richard Amery asked the Attorney General, and Minister for Justice—
 - (1) Are inmates brought from prisons to appear at the Mount Druitt Court House to answer charges?
 - (2) Which authority is responsible for conveying these inmates to and from the court?
 - (3) (a) Is the Government proposing any changes to the arrangement for transporting inmates to and from the Mount Druitt Court House?
 - (b) If so, what are these changes?

Answer-

I am advised:

- (1) Yes.
- (2) Corrective Services NSW transports inmates between correctional centres and the court. Defendants who are arrested and refused bail by police (known as Bail Act Form 7's) during court sitting hours are transported to court by NSW Police.
- (3) No.
- *0425 PRINCE OF WALES HOSPITAL EMERGENCY DEPARTMENT STAFF—Mr Michael Daley asked the Minister for Health, and Minister for Medical Research—

With regard to the \$5 million enhancement for three emergency specialists and two emergency registrars at the Prince of Wales Hospital Emergency Department:

- (1) Have these positions been advertised?
- (2) When will these extra ED emergency staff commence work?

Answer-

I am advised:

- (1) and (2) The details in respect to this policy will be announced after the budget process is completed in September 2011.
- *0426 COMMUNITY-BASED ADDICTION PROGRAMS—Mr Robert Furolo asked the Minister for Health, and Minister for Medical Research—

With regard to the \$10 million enhancement for keeping drug and alcohol dependent people out of hospital and the Minister's proposal to create up to eighty extra residential beds in community-based addiction programs:

- (1) What programs have been funded by 31 July 2011 and In which locations?
- (2) How has the efficacy of these programs been measured?
- (3) How many of these beds have been opened and In which locations?

Answer-

(1) to (3) The Government is currently undertaking a review of health priorities.

The specific timing and scope of the new drug and alcohol treatment projects will be announced after the budget process is completed in September 2011.

*0427 BUS SERVICE 235—Ms Sonia Hornery asked the Minister for Transport—

Will the government extend the 235 bus service from Maryland to Minmi and If so, when?

Answer-

I am advised:

- (1) and (2) There are currently no plans to extend route 235 from Maryland to Minmi.
- *0428 FIXED SPEED CAMERA—NEWCASTLE ROAD, JESMOND—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) In the wake of the Government turning off around one-quarter of the state's fixed speed cameras, what measures is the Minister taking to deter drivers from speeding along Newcastle Road, Jesmond which had a fixed speed camera operating at the approach to one of the busiest intersections in Newcastle, on the crest of a hill?

- (2) Have accidents and injuries fallen by 26 per cent and fatalities by two-thirds in the three years following the installation of fixed speed cameras?
- (3) Have accidents and injuries decreased since the installation of the Newcastle Road fixed speed camera?

Answer-

I am advised:

- (1) Following the recent audit of speed cameras a number of cameras have been turned off because they were not delivering the expected road safety benefit. This decision does not condone speeding at these locations and the Roads and Traffic Authority (RTA) will review locations to develop a program of alternative road safety treatment works.
- (2) An overall analysis of crashes at all fixed speed camera locations comparing three years preinstallation compared to three years post-installation found that overall crashes and injuries were reduced by 26 per cent and fatalities reduced by 67 per cent. However, the results differed for some individual locations.
- (3) Crashes and injuries increased at the Newcastle Road, Lambton fixed speed camera in the three years following installation in June 2000. Prior to the camera being installed there were 35 crashes resulting in 10 injuries over three years and after the camera was installed this increased to 49 crashes resulting in 46 people being injured over three years. This is why the camera is being decommissioned and other alternative road safety works considered.
- *0429 HOMELESSNESS IN THE HUNTER REGION—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—
 - (1) How many people are currently recorded as homeless in the Hunter region?
 - (2) What steps is the Government taking to find accommodation for homeless persons in the Hunter?
 - (3) What steps is the Government taking to prevent homelessness?

Answer—

- (1) In the 2006 Census there were 1981 people recorded as homeless in the Hunter Region.
- (2) Homeless people are able to access a range of services to assist in finding accommodation through Housing NSW, the Community Housing Sector and Specialist Homelessness Services.
- (3) The Hunter Regional Homelessness Action Plan is available on the Housing NSW website. The Plan provides details of homelessness initiatives in the area.
- *0430 ADDITIONAL FUNDING TO COMMUNITY SERVICES—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—
 - (1) In view of statistics revealed this week that NSW Community Services received almost 80 child abuse reports a day from the Hunter Central Coast region during the last financial year, making it the worst region in the state, is the Government planning to provide additional funding to Community Services in the Hunter?
 - (2) What steps is the Government taking to provide more support for families in the Hunter?

Answer-

- (1) and (2) The Department of Family and Community Services funds a wide range of programs for families in the Hunter Central Coast including:
 - Two new Family Preservation and Restoration Pilot projects to provide an intensive intervention designed to reduce the likelihood of children entering OOHC and provide intervention tailored to minimise significant statutory child protection involvement and promote early restoration, where possible.
 - Two new Aboriginal Intensive Family Based Services projects to provide an intensive family based intervention to Aboriginal families with children who are at risk of entering Out of Home Care (OOHC).
 - Two new Whole of Family Teams to provide multidisciplinary and multi-agency intervention to families with complex child protection concerns.
 - Over \$33 million was allocated to more than 100 other programs in the region.
- *0431 CABRAMATTA COMMUTER CAR PARK—Mr Nick Lalich asked the Minister for Transport—
 - (1) Was the commuter car park situated at Cabramatta announced by the former State Government?
 - (2) Can the Minister advise when this project will commence?

Answer-

I am advised:

- (1) The previous government issued a media statement on 21 February 2010 promising the Cabramatta car park would be under construction by March 2010. Construction on the car park had not been initiated as at 26 March 2011.
 - It is of concern to the Government that there have been reports such as in the Sydney Morning Herald on February 12, 2011, which include claims nearby car parks operated by Fairfield City Council and in close proximity to Cabramatta railway station are currently underutilised.
- (2) The Commuter Car Park and Interchange Program is currently being reviewed to address the needs of local communities to ensure appropriate prioritisation of work and to establish the program of work and associate funding. This includes an assessment of the proposed Cabramatta commuter car park.

The NSW Government is committed to improving the experience of customers using the public transport system and making it easier for commuters to access public transport. This includes an assessment of the Cabramatta commuter car park.

*0432 CANLEY VALE COMMUTER CAR PARK—Mr Nick Lalich asked the Minister for Transport—

- (1) Was the commuter car park at Canley vale announced by the former State Government?
- (2) Can the Minister advise when this project will commence?

Answer—

- (1) I refer the Member for Cabramatta to his comments as reported in the Fairfield Advance on 2 March 2011.
- (2) The Commuter Car Park and Interchange Program is currently being reviewed to address the needs of local communities to ensure appropriate prioritisation of work and to establish the program of work and associated funding. This includes an assessment of the proposed Canley Vale commuter car park.

The NSW Government is committed to improving the experience of customers using the public transport system and making it easier for commuters to access public transport.

*0433 FAIRFIELD INTERCHANGE—Mr Nick Lalich asked the Minister for Transport—

What is the latest information on the progress of the Fairfield Interchange?

Answer-

I am advised:

The Fairfield Transport Interchange is being reviewed as part of the Commuter Car Park and Interchange Program to ensure appropriate prioritisation of work and to establish the program of work and associated funding.

The NSW Government is committed to improving the experience of customers using the public transport system and making it easier for commuters to access public transport.

The Government has committed to establishing a \$40 million Park and Travel Safety Fund to make trains, stations and car parks safer, including:

- More CCTV cameras on platforms and in stations, trains and car parks;
- Improved lighting at stations and transport access areas and;
- More reliable help points in stations and car parks.

*0434 CLOSE THE GAP STRATEGY—Mr Paul Lynch asked the Minister for Citizenship and Communities, and Minister for Aboriginal Affairs—

- (1) Has the Minister sought budget enhancements to implement the Government's component of the Close the Gap strategy?
- (2) If so, for how much?
- (3) If not, why not?

Answer-

- (1) The Overarching Bilateral Implementation Plan (OBIP) to Close the Gap in Aboriginal Disadvantage is an agreement between NSW and the Australian Governments that consolidates commitments to close the gap in Aboriginal disadvantage made under the National Indigenous Reform Agreement (NIRA). Funding arrangements under the OBIP are regular reviewed and agreed between parties.
- (2) Not applicable.

(3) See above.

Additionally, the Government is considering the NSW Auditor General's report into Two Ways Together, the previous Government's ten year policy on Aboriginal affairs, which highlighted that the policy did "not deliver the improvement in overall outcomes for Aboriginal people that was intended".

In its initial response to the Auditor General's report, the Government has committed to working with Aboriginal communities to develop a new approach to Aboriginal affairs. It has formed a Ministerial Taskforce on Aboriginal Affairs with key Aboriginal leaders to develop that approach, including policy, program and funding priorities.

- *0435 REPRESENTATIONS CONCERNING PLUMBING ISSUES—Mr Paul Lynch asked the Minister for Family and Community Services, and Minister for Women—
 - (1) Has the Minister received representations from Mohamed Ahmad dated 25 May 2011, as the owner of premises in Ashcroft, concerning plumbing issues caused by contractors retained by Housing NSW?
 - (2) If so, what is the Minister's response?

Answer-

- (1) and (2) I have responded to Mr Ahmad on this matter.
- *0436 CORRESPONDENCE WITH CHIEF JUSTICE BATHURST—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) What was the date on which your letter concerning alleged further complaints against Magistrate Malonev was sent to Chief Justice Bathurst?
 - (2) What was the date on which you received the letter, dated 17 June 2011, from E J Schmitt purporting to be a response to the letter referred to in (1) above?
 - (3) Why did you not provide copies of both letters to all members of the Legislative Assembly:
 - (a) as soon as possible;
 - (b) before Magistrate Maloney addressed the Council;
 - (c) before the substantive motion concerning the magistrate was moved?

Answer-

I am advised:

- (1) 14 June 2011.
- (2) 17 June 2011.
- (3) I believed that Magistrate Maloney would give details of the response in his address to the Legislative Council. This belief was based on advice from the Judicial Commission that a copy of the letter referred to in question two was also provided to Magistrate Maloney and his legal representatives.
- *0437 EMPLOYEES ON "UNATTACHED LIST"—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) How many employees of the Department of Attorney General and Justice are currently on the "unattached list"?
 - (2) For what periods of time have they been on that list?
 - (3) What were the substantive positions of those employees before they became "unattached"?

Answer-

I am advised:

SES officers who are no longer appointed to a position are usually referred to as 'unattached officers'. Currently there are no unattached SES officers.

Excess employees are managed in accordance with the Premier's Memorandum No. 2011-11 Changes to the Management of Excess Employees and the Managing Excess Employees Policy.

*0438 COMMUNITY CORRECTIONS ORDERS AND PERIODIC DETENTION—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

In light of your media release of 6 January 2008, what legislative initiatives do you propose in relation to:

- (a) community corrections orders;
- (b) periodic detention?

Answer-

Guardian

I refer the Member to my speech, on behalf of the (then) Opposition, in the "Agreement in Principle" Debate in respect of the Crimes (Sentencing Legislation) Amendment (Intensive Correction Orders) Bill 2010, on 22 June 2010.

I made a considered speech and expressed the (then) Opposition's views on the Bill. I took into consideration the views expressed to me by a number of learned persons and bodies, including the differences between the originally proposed "community corrections order" and the ultimate "intensive correction order".

I refer the Member, in particular, to the final paragraph of my speech, in which I stated "...on balance the Opposition will not oppose the bill but will instead carefully monitor the success of intensive correction orders as a valid sentencing option."

*0439 NSW CRIME COMMISSION—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

In light of your media release of 4 June 2008, when do you propose to alter oversight arrangements over the NSW Crime Commission?

Answer—

I am advised:

On 11 August 2011, my colleague, the Minister for Police and Emergency Services, announced that the Government will establish a special commission of inquiry into certain aspects of the NSW Crime Commission, including oversight arrangements.

*0440 ADDITIONAL FUNDING FOR JUVENILE JUSTICE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

In light of your media release of 29 July 2007, how much additional funding have you secured for Juvenile Justice since 26 March 2011?

Answer-

The NSW Budget provides funding to reduce the state's juvenile remand population, with more than \$11 million over four years for programs to speed up bail applications for young people and to help them meet their bail conditions.

The government will invest a further \$7 million over four years to manage young offenders in Broken Hill.

Almost \$10 million over four years of additional maintenance funding has been allocated to ensure the continuation of the quality of Juvenile Justice's asset base.

*0441 ADDITIONAL FUNDING FOR CORRECTIONAL CENTRES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

In light of your media releases of 4 August 2007 and 18 December 2009, how much additional funding have you secured for NSW correctional centres since 26 March 2011?

Answer-

All funding details for NSW correctional centres will be included in the State Budget, to be announced by the Treasurer.

*0442 ADDITIONAL FUNDING FOR NSW ANALYTICAL LABORATORIES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

In light of your media releases of 21 July 2007 and 7 October 2001, how much additional funding have you secured for NSW Analytical Laboratories since 23 March 2011?

Answer-

I am advised:

As the Division of Analytical Laboratories falls within the portfolio responsibilities of the Minister for Health, the question should be directed to the Minister for Health.

*0443 COST CUTTING MEASURES WITHIN TAFE—Mr Paul Lynch asked the Minister for Education—

Will the Minister's cost cutting measures within TAFE take into account TAFE's role in:

- (a) the need for skilled tradespeople in NSW;
- (b) English language classes;
- (c) retraining of retrenched workers;
- (d) supporting adults seeking to improve their employment prospects?

Answer_

(1) to (4) We don't speculate on any measures in relation to the NSW budget which will be handed down by the Treasurer on 6 September 2011.

The NSW Government is committed to a strong TAFE NSW.

TAFE NSW plays a central role in addressing the challenges the NSW economy faces in increasing workforce participation and improving business productivity.

*0444 APPLICATIONS TO THE SUPREME COURT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

In the period 28 March 2011 to 26 July 2011, how many applications to the Supreme Court have you authorised to detain sexual offenders after the expiry of the period of imprisonment to which they were sentenced?

Answer—

I am advised:

This question relates to applications made under the Crimes (Serious Sex Offenders) Act 2006 for continuing detention orders. For the period in question, no such applications have been made or approved.

For the period, 28 March 2011 to 26 July 2011, applications have been made to the Supreme Court of NSW for an Extended Supervision Order in relation to three offenders.

*0445 CHARGE BARGAINING—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Do you propose to alter or review the guidelines for the Office of the Director of Public Prosecutions in relation to charge bargaining?

- *0446 WORK PERFORMED BY HUGO HALLIDAY—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) What work has been done by Hugo Halliday for your departments since 26 March 2011?
 - (2) What work has been done by Hugo Halliday for you since 26 March 2011?
 - (3) In relation to questions (1) and (2):
 - (a) What was the precise nature of the work?
 - (b) What was the precise value of the work?
 - (c) Is the work ongoing?

Answer—

I am advised:

(1) and (2) Nil.

(3) Not applicable.

- *0447 COTTAGE FAMILY CARE CENTRE—Dr Andrew McDonald asked the Minister for Family and Community Services, and Minister for Women—
 - (1) What is the annual NSW Government contribution to the Cottage Family Care Centre, Campbelltown?
 - (2) From what other sources is budget for this centre derived?
 - (3) How many staff are employed by this centre?
 - (4) What services are provided by this centre?
 - (5) What referral criteria are there?
 - (6) How many children (in total, and numbers per day) are currently cared for by the Cottage centre?
 - (7) Are changes to their funding expected in the September 2011 budget?

Answer—

- (1) The Department of Family and Community Services, Community Services division will provide the Cottage Family Care Centre, Campbelltown with funding through the Early Intervention and Placement Prevention Program (EIPP):
- (2) This is a question for the Cottage Family Care Centre.
- (3) This is a question for the Cottage Family Care Centre.
- (4) Under the EIPP, the Cottage Family Care Centre delivers Intensive Family Support Services including information and advice, family focussed casework involving assessment and case planning, home visiting involving practical support and supportive counselling and skills training, counselling, skills focussed groups, and parent support groups.
- (5) The Cottage Family Care Centre receives referrals from the local Community Service Centres regarding families with children aged 0-5 years who are assessed as meeting the risk of significant harm threshold.
- (6) The number of children receiving support services varies according to a number of factors.
- (7) Details of the Budget will be released on 6 September 2011.
- *0448 WILLIAM CAREY CHRISTIAN SCHOOL—DEDICATED BUS—Dr Andrew McDonald asked the Minister for Transport—
 - (1) Are there any plans for a dedicated bus to the William Carey Christian School from the Chipping Norton/Moorebank area?
 - (2) Has the option for a shared bus with other schools (such as All Saints Senior College) been examined?
 - (3) What financial options are available for assistance to schools such as William Carey Christian School to finance their own buses?

Answer-

I am advised:

(1) to (3) Students residing in Chipping Norton/Moorebank are able to catch a Veolia Transport regular passenger bus service to Liverpool Station where they are able to access bus services direct to the school.

The option of a shared bus with other schools has been investigated, however differences in school start and finish times and the potential to inconvenience students already travelling on other school bus services makes diversion of these services unviable.

The Department of Transport does not provide funding for schools to own or operate buses.

- *0449 BRIDGE OVER CAMBRIDGE AVENUE CAUSEWAY—Dr Andrew McDonald asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) (a) Has any recent design or costing work been done on a new bridge over the Cambridge Avenue causeway, Glenfield?
 - (b) If so, what is the current expected cost?
 - (2) As the road is designated as a regional road, entering into Commonwealth land, what responsibility do the three levels of government individually have for meeting this cost?
 - (3) Does the Government have any plans to construct a high-level bride at the causeway site?

Answer-

I am advised:

- (1) (a) The most recent investigations were completed in 2008. The consultants estimated the strategic cost of their two recommended four lane high level bridge options at \$29.04 million and \$36.8 million (2008 dollars). I am advised that neither estimate is endorsed by the RTA, and both would likely be subject to change following environmental studies and geotechnical assessment.
 - (b) See reply to (1) (a). The strategic cost estimate prepared by consultants in 2008 has not been reviewed or revised.
- (2) Cambridge Avenue west of the Georges River is designated a Regional Road, which means that the funding of any upgrade is the primary responsibility of Campbelltown City Council.
 - East of the Georges River, all lands are owned by the Department of Defence.
- (3) The Government has no current plans to construct a high level bridge to replace the causeway. However, pending completion of feasibility and scoping studies for the proposed intermodal terminals at Moorebank, it is not possible to make any definitive statement on the future role and standard of Cambridge Avenue.
- *0450 READING RECOVERY PROGRAM—Mr Ryan Park asked the Minister for Education—

What criteria is used by the department to determine the schools that require funding to implement the Reading Recovery program?

Answer-

Schools are allocated teaching positions to implement Reading Recovery on the basis of need. This includes the socio-economic disadvantage of the community, the numbers of non-English speaking and Aboriginal students enrolled in the school, as well as the school's Year 3 NAPLAN results.

*0452 REDUCTION OF RED TAPE—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

What specific strategies does the Minister have to reduce red tape for police officers in the Wollongong Local Area Command?

Answer—

I have set up a high level working group to investigate red tape reduction measures to ease the administrative burden on officers and return police to the front line. These measures will benefit police across the State, including those in the Wollongong Local Area Command.

*0453 CYCLEWAY NETWORK—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

What is the Government's plan to increase the cycleway network in the Wollongong Local Government Area?

Answer-

I am advised:

The Roads and Traffic Authority (RTA) will continue to provide funding to local councils under the cycleways program to improve the cycleway network in the Southern Region, including Wollongong.

Currently, the RTA is working with Wollongong Council to develop and construct a safe cycling facility along the Princes Highway from Dapto to Kembla Grange. This is a staged project, with stage one due to start by October 2011.

The RTA contributed funding in 2010-11 for the design of this project and is contributing \$250,000 for construction of stage one in 2011-12.

Additionally, the RTA is working with local bicycle user groups, Bicycle NSW, local councils, Wollongong University and interested cycling enthusiasts through the Illawarra Regional Cycling Consultative Forum to continue improving cycling facilities in Wollongong.

*0454 REVIEW OF SPEED LIMITS—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

What roads in the Wollongong Local Government Area will be part of the review of speed limits across the State?

Answer-

I am advised:

The roads to be reviewed will be identified through feedback received from the Safer Roads NSW website.

The roads nominated will then be prioritised to identify the top 100 roads (or sections of roads) and will be reviewed by the end of March 2012.

- *0455 REDUCTION OF PRISON POPULATION—Mr Ryan Park asked the Attorney General, and Minister for Justice—
 - (1) What is the Government's plan to reduce the prison population by one-fifth, given your commitment to this target in 2010?
 - (2) What is the time limit for achieving this target?

Answer-

In regard to (1) and (2) the Government is committed to reducing the prison population by way of appropriate strategies.

*0456 REMOVAL OF GRAFFITI FROM PUBLIC HOUSING—Mr Ryan Park asked the Minister for Family and Community Services, and Minister for Women—

What time limits does Housing NSW have for removing graffiti from public housing properties?

Answer-

Once a report of graffiti is received, it is inspected and a works order is raised. Graffiti that is obscene, personal or racial in nature removed within 48 hours. All other graffiti is removed within 20 working days.

*0457 JOBS CREATION—Mr Ryan Park asked the Treasurer—

What specific targets has the Government set for the creation of new jobs in the Wollongong Local Government Area?

Answer-

The Government's Jobs Action Plan targets the creation of 100,000 new jobs through the provision of a payroll tax rebate of \$4,000 per full time employee.

Out of the 100,000 new jobs, 40 per cent are reserved for regional NSW and 60 per cent for metropolitan NSW.

- *0458 REGIONAL RELOCATION INITIATIVE—Mr Ryan Park asked the Treasurer—

Answer—

(1) and (2) The Regional Relocation Grant is part of our Regional Kick Start package, delivering on our election commitment to boost regional NSW and assist in relieving congestion in our larger cities.

To be eligible for the \$7,000 Regional Relocation Grant, applicants must meet several criteria which includes the purchase of a home within a regional area on or after 1 July 2011 and on or before 30 June 2015 by those moving from the metropolitan area to the regional area.

It is important that the setting of the metropolitan boundary is done on a consistent basis. The definition of metropolitan area comprises the local government areas in the Sydney Statistical Division for Australian Bureau of Statistics purposes, including the Newcastle and Wollongong local government areas. This definition is regularly used to classify the different areas of the State and was used by previous NSW Labor Governments.

The NSW Government is monitoring the take-up of this initiative through the Office of State Revenue.

*0459 MEMORIAL DRIVE (NORTHERN DISTRIBUTOR)—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

Are there any plans for the next stage of Memorial Drive (Northern Distributor) in the Keira electorate? Answer—

I am advised:

There are no short or medium term plans to extend Memorial Drive. There is no funding or forward road development programming for such an extension.

The NSW Government inherited a \$5.2 billion budget blackhole from the former State Labor Government, which means delivering any projects outside the current capital program and our election commitments is extremely difficult.

*0460 CRIMINAL INFRINGEMENT NOTICES—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

How many criminal infringement notices have been issued by police in the Wollongong Local Government Area command since 2008?

Answer—

The NSW Police Force has advised me that both Wollongong and Lake Illawarra Local Area Commands cover the Wollongong Local Government Area. 1742 Criminal Infringement Notices have been issued by police from both Commands in the period 2008 - 2011 to date.

I regret any inconvenience caused to passengers as a result of cancelled services.

I am advised:

- (1) Over the two months of June to July 2011, 9 trips or 0.12 percent of trips out of a total of 7,223 trips were cancelled on Route 433. No trips were cancelled on Routes L37 and L39.
- (2) Any cancellation of services operated from the Leichhardt Depot is primarily due to late running caused by traffic conditions existing at the time, including wet weather, collisions and general traffic congestion. These are factors over which State Transit has no control.
- (3) and (4) On-time running data for Sydney Buses services is collected on a network wide basis only and is published on a Sydney Buses network basis in State Transit's Annual Reports and on the State Transit website.

- (2) The total gross expenditure on all matters relating to metro including North West Metro, CBD Metro and West Metro is \$438 million.

*0464 COMPENSATION CLAIMS—Mr Jamie Parker asked the Minister for Transport—

- (3) One claim was received in late July and is currently being assessed.

*0465 CARBON TAX—Mr Chris Patterson asked the Treasurer—

What is the likely impact of the Carbon Tax on the cost of living?

Answer-

The main impact on the cost of living from the Commonwealth's proposed carbon price will be higher retail electricity prices.

Wholesale electricity prices will rise by an annual average of 38% more than would have been the case without a carbon price between 2013 and 2017.

This could translate into a 15% rise in retail electricity prices for NSW households over the same period.

Higher wholesale electricity costs also increase operating costs for businesses and the Government.

The Hunter, the Illawarra and the Central West regions will be hardest hit among NSW regions in terms of employment growth. Low employment growth will exacerbate cost of living pressures in these regions.

Commonwealth modelling suggests there will be a one-off addition to the Consumer Price Index (CPI) of 0.7% after the carbon price is introduced.

The Commonwealth expects a further 0.2% to be added to the CPI after a transition to a global "cap and trade" scheme. This figure is supported by the assumption of a global market for carbon permits being in operation by 2015-16

The impact of a "cap and trade" scheme could be greater than 0.2% if no genuinely global market for carbon permits emerges.

The Ministerial Advisory Group is co-chaired by Andrew McCallum, CEO of the Association of Children's Welfare Agencies and Jim Moore, Acting Director-General of the Department of Family and Community Services.

(3) to (5) The Government and the non-government sector share a common commitment to doing better for children in out-of-home-care. All parties acknowledge this transfer must occur in a way which is beneficial for children and young people.

Together with the non-government sector, the Government is working to:

- reduce the number of children and young people entering and staying in out-of-home-care in NSW
- increase the number of children and young people restored to their families as quickly as possible, where it is safe to do so
- increase the stability of placements.

In the interests of protecting children, families and carers, the Department of Family and Community Services, will retain service capacity as a provider of last resort to ensure that the needs of children who are in care are met.

All organisations providing out-of-home care must be accredited by the NSW Children's Guardian and comply with the NSW Standards for Statutory Out-of-Home Care.

At the same time, great care will be taken to ensure high quality, continuous service provision throughout the state, especially in rural and remote locations such as the Northern Tablelands.
