*9406 HUNTINGTON'S DISEASE RURAL SOCIAL WORKER—Mr Philip Donato asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

Will support be given to the 600 plus families known to be suffering from Huntington's Disease (HD) throughout New South Wales by funding HD-specific Rural Social Workers to provide support throughout regional New South Wales after funding was cut in April 2018?

Answer—

*9407 POLICE-TO-POPULATION RATIO FOR ORANGE—Mr Philip Donato asked the Minister for Police, and Minister for Emergency Services—

Considering that New South Wales has almost the lowest police-to-population ratio of all states in Australia, and Orange reportedly has the lowest police-to-population ratio in New South Wales, will you commit to boosting the number of police officers attached to the Orange Police Station by 14 to raise Orange's police-to-population ratio level with the New South Wales state average?

Answer-

I am advised:

Police positions are attached to Police Area Commands or Police Districts. All police resources are flexible resources available to respond to incidents across the district. Local resources are supplemented by specialist police who are managed centrally but can be deployed across boundaries to meet the changing community needs, changing crime patterns and emerging issues.

 - (1) Is the M5 Cashback affordable?

The appointment committee recommended candidates that it considered suitable.

I recommended the appointment of the current State Coroner after reviewing the selection committee's recommendations.

- *9416 STAFF AT WESTMEAD HOSPITAL—Ms Julia Finn asked the Minister for Health, and Minister for Medical Research—
 - (1) How many vacant positions of employment were at Westmead Hospital in April 2011?
 - (2) How many vacant positions of employment are at Westmead Hospital as at 1 September 2018?
 - (3) What is the composition of employment at Westmead Hospital?
 - (a) What proportion of these employees are employed on a:
 - (i) Full-time basis;
 - (ii) Part-time basis;
 - (iii) Casual basis?
 - (4) What proportion of total employees working at Westmead Hospital are employed by the NSW Public Service?
 - (5) How many employees at Westmead Hospital are contractors, sub-contractors or employed by an agency?
 - (a) What is the annual trend in these figures in each year from 2011 to 2018?

Answer-

Recruitment processes at Westmead Hospital are conducted in accordance with NSW Ministry of Health recruitment guidelines.

The majority of the workforce at Westmead Hospital are employed by the NSW Health Service. In addition, agency contractors and contingent workers are used by Westmead Hospital to cover unplanned leave and vacancies. Visiting Medical Officers are engaged under contract

arrangements as provided for under the Health Services Act 1997.

- *9417 LIBRARY FUNDING IN NEW SOUTH WALES—Ms Jo Haylen asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
 - (1) Which local government area in New South Wales was in receipt of the highest amount of funding per capita for libraries in each year from 2010-11 to 2017-18?

I am advised:

All councils receive \$1.85 per head in accordance with the Library Regulation, and a subsidy adjustment, which boosts the total payment. All figures are published in the Library Council of NSW Annual Reports.

 - (2) What is the total funding allocated to the program between 2011 to 2018 (as at 25 September 2018)?
 - (3) Will the program be expanded in response to the recommendations of the Parliamentary Inquiry into the provision of drug rehabilitation services in regional, rural and remote New South Wales?

Questions regarding MERIT program participation and funding along with questions regarding the Government response to the Parliamentary Inquiry Report entitled Provision of drug rehabilitation services in regional, rural and remote New South Wales should be directed to the Minister for Health.

Questions regarding reoffending by MERIT participants should be directed to the Minister for Corrections.

- *9419 VISUAL AND HEARING IMPAIRMENT IN INDIGENOUS CHILDREN—Ms Jo Haylen asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—
 - (1) What are the current rates of visual impairment in indigenous children aged:
 - (a) 0 to 6 years;
 - (b) 7 to 12 years;
 - (c) 13 to 18 years?
 - (2) What are the current rates of visual impairment in non-indigenous children aged:
 - (a) 0 to 6 years;
 - (b) 7 to 12 years;
 - (c) 13 to 18 years?
 - (3) What are the current rates of hearing impairment in indigenous children aged:
 - (a) 0 to 6 years;
 - (b) 7 to 12 years;
 - (c) 13 to 18 years?

*9420 SUPPORTING LIVE MUSIC IN NEW SOUTH WALES—Ms Jo Haylen asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

- (1) With the net closure of over 176 venues since the introduction of the lockout laws, many of which provided live music, what is the Government doing to support live music in New South Wales?
- (2) What is the Minister's response to criticism that the Government had completed just five of 25 recommendations from its night time economy taskforce?
- (3) Why are the Government's contemporary music plan and the night time economy master plans overdue?

Answer-

I am advised:

The Government supports the music sector through direct financial investment to build audiences and engagement with music.

In 2017-18, the Government invested almost \$23 million in funding to support individual artists, projects and organisations that actively contribute to Sydney and New South Wales' contemporary music landscape.

In addition, the Government invested \$525,000 over the past two years to support the Live and Local program in Western Sydney and regional New South Wales.

The Government also supports cultural organisations, such as the Sydney Opera House, Carriageworks and the Museum of Contemporary Art host live musical performances and major events.

The Government is also developing a NSW Contemporary Music Strategies with specifically guided actions to promote live music and address regulatory barriers the industry faces. Development of this Strategy is on track and Create NSW aims to provide it to Government for consideration by the end of October 2018.

As at October 2018, the Government's Night Time Economy Taskforce has implemented four of the 25 actions of Night Time Economy Roundtable Action Plan. The other 11 actions are being progressed.

Development of the masterplan is in progress, aiming to maximise opportunities and benefits for the night time economy, and is expected to be completed by the end of 2018.

- *9422 NSW POLICE OFFICERS ON LEAVE FROM WOLLONGONG LOCAL AREA COMMAND—Mr Ryan Park asked the Minister for Police, and Minister for Emergency Services—
 - (1) How many NSW Police Officers are on leave from Wollongong Local Area Command due to stress related illnesses (as at 25 September 2018)?
 - (2) What was the number of NSW Police Officers on leave from Wollongong Local Area Command on leave due to stress related illnesses at the same time in each year from 2015 to 2017?
 - (3) How many NSW Police Officers are on leave from Wollongong Local Area command due to injuries obtained while completing their duties (as at 25 September 2018)?
 - (4) What was the number of NSW Police Officers on leave from Wollongong Local Area Command due to injuries obtained while completing their duties at the same time in each year from 2015 to 2017?

Answer-

I am advised:

At various times a number of police officers in any Police District or Police Area Command will be on long term sick leave, light duties, the return to work program, or seconded away from their substantive position.

- *9423 WESTMEAD HOSPITAL NURSES—Ms Julia Finn asked the Minister for Health, and Minister for Medical Research—
 - (1) What percentage of nurses at the Westmead Hospital are employed on contracts as opposed to permanent employment?
 - (2) Is the navigation role in the emergency department permanently funded and staffed?
 - (3) Is the neonatal retrieval service fully funded at Westmead Hospital?
 - (4) When staff are required for the neonatal retrieval service, are replacements provided in the ward to ensure nurse to patient ratios are maintained?

Answer-

Nursing staff on temporary contracts are primarily made up of transition to practice registered nurses, registered midwives and enrolled nurses.

The Emergency Department Navigator role is a permanently funded role.

The neonatal retrieval service is provided by Newborn Emergency Transport Service (NETS), part of the Sydney Children's Hospitals Network.

NETS does not impact on local staff.

- *9424 DRUG TREATMENT AND REHABILITATION—Mr Philip Donato asked the Minister for Health, and Minister for Medical Research—
 - (1) What is the average waiting time for patients seeking treatment at drug treatment and rehabilitation centres in Orange, as I am advised Lyndon House presently has a six to eight week wait?
 - (2) What mobile services exist for drug treatment and rehabilitation of those persons affected who reside in the rural townships and villages in the Orange electorate?
 - (3) What drug treatment and rehabilitation services are currently available in the townships of Forbes and Parkes?

Answer—

Lives Lived Well, formerly The Lyndon Community, provides residential withdrawal and rehabilitation services in Orange. Clients are assessed and access is prioritised according to clinical need.

Health services are not provided on the basis of electorate.

The local health district provides comprehensive assessment and treatment services, opioid treatment and the Magistrates Early Referral into Treatment (MERIT) program in Forbes and Parkes.

*9425 ILLAWARRA ESCARPMENT—Mr Ryan Park asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—

How much funding has been allocated to walking tracks located between Stanwell Park and Mount Keira in each financial year 2011-12 to 2017-18?

Answer-

I am advised:

\$40,000 in 2012-13 and \$315,426 in 2016-17.

- *9426 MID COAST COUNCIL—Mr Ryan Park asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Was the newly formed Mid Coast Council given a commitment of \$30 million by the Government as part of the amalgamation process?
 - (2) How much has currently been given to this Council as at 20 September 2018?
 - (3) When will the remainder be allocated?

Answer-

I am advised:

Mid-Coast Council was provided with \$20 million on 14 June 2016 under the New Council Implementation Fund and the Stronger Communities Fund.

- *9427 DECLARATIONS SOUGHT OR MADE UNDER THE RESTRICTED PREMISES ACT—Mr Paul Lynch asked the Minister for Police, and Minister for Emergency Services—
 - (1) Have any declarations been sought or made under the Restricted Premises Act since 1 November 2015 (to 25 September 2018)?
 - (a) If so, in relation to which premises?

Answer—

I am advised:

Between 1 November 2015 and 25 September 2018 above there were seven restricted premises declarations made. Currently two applications are pending a Supreme Court decision. It is not appropriate to provide information about any premises, as it may compromise police operations.

- *9429 RESPONSE TO RECOMMENDATION OF OMBUDSMAN REPORT—Mr Paul Lynch asked the Attorney General—

What action, if any, was taken in response to recommendation 6 of the report by the Ombudsman on the Restricted Premises Act in review of Police use of firearms, search powers and new offence provisions dated October 2016?

Answer-

I am advised:

Recommendation 6 of the Ombudsman's report entitled Restricted Premises Act: Review of police use of firearms search powers and new offence provisions was implemented by the Justice Portfolio Legislation (Miscellaneous Amendments) Act 2016, which commenced on 25 October 2016.

- *9430 OVERCROWDED FOUR CARRIAGE SERVICE ON THE T5 CUMBERLAND LINE—Mr Paul Lynch asked the Minister for Transport and Infrastructure—
 - (1) What is your response to the concerns of Lisa Palaszewski in relation to the overcrowded four carriage service on the T5 Cumberland Line and how this impacts the safety of passengers?
 - (2) Why did Sydney Trains refuse to adequately respond to Ms Palaszewski's concerns?

Answer—

I am advised:

- (1) Sydney is expanding and the Government is working hard to deliver an integrated transport system that meets the needs of customers now and in the future. Introduced on 26 November 2017, the new timetable is a step towards modernising the network in line with other major cities around the world. The new timetable is an important part of Stage 1 of the Government's \$1.5 billion More Trains, More Services program. The program boosts network capability, provides better infrastructure and represents the single largest increase in capacity on the network. The new timetable has been developed using a combination of Opal card data and customer feedback, ensuring that services reflect demand across the broader network. Since the introduction of the new timetable, there has been a 6 per cent decrease in overcrowding across the network notwithstanding there being an increase in patronage. It is disappointing that NSW Labor has committed to cancelling a significant number of train services across the rail network if it is elected in March 2019.
- (2) In the last five years customer satisfaction across the public transport network has increased by 10 per cent to 89 per cent. Sydney Trains responded to Ms Palaszewski's feedback within five working days of receipt. In an email sent to Ms Palaszewski on 20 September 2018 she was invited to call the customer relations team at Sydney Trains to discuss her concerns. To date Ms Palaszewski has not responded to this invitation.
- *9431 POST MORTEM REPORT—Mr Paul Lynch asked the Attorney General—
 - (1) When will a post mortem report relating to the death of Paul Francis Hatcher on 27 October 2017 at Campbelltown be made available to the family?
 - (2) Why has the post mortem report not previously been released?

Answer—

I am advised:

I wish to extend my sympathy to the Hatcher fam ily for the loss of Mr Paul Francis Hatcher.

Post mortem reports are prepared by the Department of Forensic Medicine and are provided to the Coroner upon completion.

Once received, the Coroner's Court has confirmed they will provide the post mortem report for Mr Hatcher to family members who have requested a copy.

Questions relating to the preparation of post mortem reports should be directed to the Minister for Health and Medical Research.

*9432 ASSISTANCE AVAILABLE TO JURORS—Mr Paul Lynch asked the Attorney General—

- (1) What facilities are available to assist jurors in New South Wales in coping with exposure to violence and confronting evidence in trials?
- (2) How many jurors availed themselves of such facilities or assistance in the period 1 July 2017 to 30 June 2018?

Answer-

I am advised:

Through the Juror Support Program, the Office of the Sheriff provides access to free therapeutic counselling services to jurors in New South Wales who have completed their jury service. Jurors can access up to three confidential face-to-face or telephone counselling sessions at no cost, with further sessions granted on request. Information about the Juror Support Program is provided to each Juror after the completion of jury service, which can be accessed at www.juror.nsw.gov.au/brochure/discharged.

If requested by the Court, the Office of the Sheriff can arrange for counsellors to support jurors on-site at the immediate conclusion of a court trial when the nature, content or course of that trial is particularly distressing.

Specific data for the time period 1 July 2017 to 30 June 2018 is not available

- *9433 REVIEW OF THE RESTRICTED PREMISES ACT—Mr Paul Lynch asked the Minister for Police, and Minister for Emergency Services—
 - (1) Why did the Police refuse to provide to the Ombudsman information that the Ombudsman thought was relevant to the review of the Restricted Premises Act concerning Police use of the firearms search powers and new offences provisions?
 - (2) Has this attitude been adopted by the Police in relation to any other reviews or reports by the Ombudsman?

The NSW Police Force provided the Ombudsman with all of the information required to be provided under the Restricted Premises Act.

The PricewaterhouseCoopers evaluation report was used by NSW Trustee and Guardian to refine their new service delivery arrangements, before implementation and transition to the new service delivery model was completed in April 2017.

- *9435 HEAVY VEHICLE INSPECTIONS—Ms Sonia Hornery asked the Minister for Roads, Maritime and Freight—
 - (1) How many authorised heavy vehicle inspectors are employed at the Roads and Maritime Services

Carrington Depot as at 24 September 2018?

(2) How many heavy vehicle owners were unable to arrange an inspection prior to their vehicle's registration expiring and were forced to provide a Heavy Vehicle Authorised Inspection Station (HVAIS) inspection report instead during 1 July 2017 and 30 June 2018?

- (1) As at 24 September 2018 there were twelve authorized heavy vehicle inspectors employed at Carrington Depot.
- (2) Heavy Vehicle Authorised Inspection Station (HVAIS) inspection reports are issued for a range of reasons, not necessarily associated with owners being unable to arrange an inspection prior to the vehicle's registration expiring, as such this information is not available from Roads and Maritime Services' systems.

Answer—

New South Wales mental health services receive referrals from a wide range of sources. These include individuals and families referring themselves, referrals from other health professionals such as general practitioners, and referrals from hospital emergency departments or inpatient units. All referrals are triaged by the mental health service and assessment arranged within the most clinically appropriate time.

The Hunter New England Health (HNEH) Centre for Psychotherapy is one of a number of publicly funded services that supports patients who are diagnosed with Borderline Personality Disorder, other support is provided directly by General Practioners and the local community mental health teams. Treatment for Borderline Personality Disorder is a focus of the Government's mental health reform. Since 2010 the NSW Ministry of Health has funded development of the Project Air Strategy for Personality Disorders (Project Air). Project Air is implementing more effective and comprehensive approaches to personality disorder treatment across early identification, engagement and treatment options. This funding is supporting a staged program rollout across New South Wales. Consultation on the rollout of Project Air to Hunter New England Local Health District (HNE LHD) is due to begin in April 2019.

The HNE LHD is implementing an Eating Disorders Service Plan 2016-21. The plan includes new eating disorder programs in inpatient and community-based settings across the district. HNE LHD provides a range of acute hospital and community-based services to assist people with eating disorders. This includes access to emergency services, mental health professionals, dietetic support and more specialised services based on each person's needs. The model of care is focused on keeping people well enough to stay out of hospital through prevention, promotion, early intervention and support services. With the implementation of the HNE LHD Eating Disorders Service Plan, clinicians in community mental health teams now provide treatment to people with eating disorders who would have previously required referral to HNEH Centre for Psychotherapy. The local Plan is part of the statewide improvement in eating disorders. As part of the statewide program a day patient treatment centre is located in Newcastle and receives referrals from across New South Wales.

- (1) There is no waitlist for the Nexus Unit. Admission of a young person is based on their mental health clinical presentation, as well as the available community based options that could provide care and treatment in a less restrictive way.
- (2) and (3) The Government is investing a record \$2.1 billion in recurrent and capital funding for mental health in the 2018-19 budget. This is an increase of \$104 million from the previous year. This includes \$100 million annually to strengthen community mental health supports under the Government's 10-year reform of mental health services. The reform includes increased collaboration between services and improved continuity of care for people in contact with the mental health system.

These programs have statewide coverage and include the Hunter New England Local Health District.

The Government recently announced an investment of nearly \$90 million over three years to support the implementation of the Strategic Framework for Suicide Prevention in New South Wales. The Framework sets out priorities for further coordinating, integrating and investing in suicide prevention activities, while building on what is already in place.

Eight new or expanded initiatives will begin to be rolled out in the 2019-20 financial year with full implementation by 2020-21. These initiatives have statewide coverage and will include the Hunter New England Local Health District.

The Government has allocated \$1.1 million annually over five years from 2017-22 for the statewide rollout of Project Air across New South Wales. Project Air aims to implement more effective and comprehensive approaches to the management of personality disorder. Project Air will be rolled out in Hunter New England Local Health District by 2020.

NSW Health and Education have also jointly commissioned 'Project Air for Schools' to assist school staff to effectively identify, respond, support and refer students with severe and complex mental health issues, including self-harm, suicide, trauma and emerging personality disorder.

Four direct routes have been implemented from the suburbs to the city centre, running every 15 minutes between 7:00 am and 7:00 pm; and bus connections have been improved to key locations such as John Hunter Hospital, the University of Newcastle, major shopping centres and Newcastle's beaches. Customers in Dudley. Mount Hutton and Warners Bay also have improved choice, convenience and accessibility thanks to the new On Demand bus service.

In the first three months of the new network, Newcastle Transport analysed over 90,000 trips and considered feedback provided by customers using the network. Refinements to the network based on community feedback and network performance were implemented on 29 July. The refinements address the bulk of community concerns regarding the network and deliver service improvements. Customer complaints regarding the changes to the Newcastle bus network fell by 77 per cent from January to September 2018.

Keolis Downer Hunter is committed to delivering the best possible service for customers, and all feedback that has been received will be taken on board. Keolis Downer Hunter will continue to monitor the network and make improvements where necessary over the duration of its contract.

Local Health Districts and Specialist Health Networks' Mental Health Services maintain close working relationships with Primary Health Networks and GPs within their catchment. This facilitates linkages and coordinated care for patients exiting inpatient mental health services and those transitioning from active community case management to GP care.

In 2017, New South Wales endorsed the Commonwealth Bilateral Agreement on Care Coordination supporting the implementation of coordinated care reforms that improve patient health outcomes. This agreement brings together Primary Health Networks and New South Wales-based Local Health Districts and Specialty Health Networks to act as a coordinated system.

- *9514 JUNK FOOD ADVERTISING—Mr Alex Greenwich asked the Minister for Health, and Minister for Medical Research—
 - (1) Is it true that 20 per cent of children and young people in New South Wales are overweight or obese?
 - (2) What does the Government consider to be the definition of junk food?
 - (3) What assessment has been made of the outcomes of the NSW Healthy Eating and Active Living Strategy 2013-2018, including the key objectives:
 - (a) Reducing intake of energy-dense nutrient-poor food and drinks;
 - (b) Increasing community awareness of healthy eating as a protective factor against chronic disease;
 - (c) Increasing intake of water in preference to sugar-sweetened drinks?
 - (4) What action has the Government taken to address the advertising of junk food?
 - (5) How has the Government supported national regulations on food marketing to children?
 - (a) What advice and recommendations has the Government contributed to this process?
 - (6) What is the Government's policy about the sale of junk food on NSW Health facilities and campuses?
 - (a) How does this policy support healthier eating?
 - (7) What further action will the Government take to reduce exposure to junk food and its advertising? Answer—

In 2017, the NSW Population Health Survey showed that around 1 in 5 children in New South Wales were overweight or obese.

NSW Health food and drink definitions are based on the 2013 Australian Dietary Guidelines which define healthy and unhealthy foods and a healthy diet. Discretionary foods are those which are not necessary for a healthy diet and are high in saturated fat, sugars and/or salt.

NSW Health routinely monitors the health related targets and objectives of the Healthy Eating and Active Living Strategy. This information is published on the HealthStats NSW website at: www.healthstats.nsw.gov.au/IndicatorGroup/ChildObesityTopic

Action to address unhealthy food and drink advertising is a matter for the Australian Government, as regulation of print and broadcast media is primarily their responsibility.

The Healthy Food and Drink in NSW Health Facilities for Staff and Visitors Framework aims to increase the availability and promotion of healthy choices for staff and visitors of our health facilities.

- *9515 BIKE SUPERHIGHWAYS—Mr Alex Greenwich asked the Minister for Transport and Infrastructure—
 - (1) What assessment has the Government made of the outcomes of the Bike Superhighways being implemented in London that have resulted in massive increases in bicycle use in congested inner city areas?

- (2) What assessment has the Government made of similar schemes in Denmark, The Netherlands, California, Germany, India and now planned for Melbourne?
- (3) Has the Government considered similar Bike Superhighways for Sydney?
- (4) Has the Government considered integrating Bike Superhighways into all major transport projects? (a) If not, why not?
- (5) What plans does the Government have to include Bike Superhighways in Sydney's transport planning?

Answer-

I am advised:

Over the last five years the Government has committed over \$250 million to delivering walking and cycling infrastructure projects across New South Wales.

Transport for NSW considered the cycling superhighways in London, as well as those in the Netherlands, Denmark, Germany and other countries when developing the Government's 40 year long term integrated transport vision for New South Wales. The Future Transport 2056 strategy is publicly available.

*9516 TRAFFIC SIGNALS—Mr Alex Greenwich asked the Minister for Roads, Maritime and Freight—

- (1) Considering that pedestrians in inner city areas spend about 20 per cent of their time waiting at traffic signals, what assessment has the Government made of measures to increase pedestrian crossing time at traffic signals in high pedestrian zones?
- (2) How does the Government balance pedestrian and vehicle priority at traffic signals in the CBD and Inner City?
- (3) Does 'adaptive signal control' allow vehicles to be detected on approach to traffic signals, giving longer phases for a green light for vehicles?
 - (a) Are these signals used in Sydney?
 - (b) Does this technology result in shorter times for pedestrians to cross?
- (4) Do pedestrian actuation buttons for traffic signals not register how many pedestrians are waiting?
 - (a) If so, what measures does the government use to ensure priority for pedestrians where there are large numbers of people crossing at traffic lights?
- (5) What is the rationale for locating pedestrian actuation buttons at traffic signals?
 - (a) Why are these not placed on all signal posts?
 - (b) What criteria are used to determine when only one button will be provided on one signal post at crossings?
- (6) Does the Sydney Coordinated Adaptive Traffic System take pedestrian traffic into account:
 - (a) If so, how?
- (7) What plans does the Government have in high pedestrian zones to:
 - (a) Count pedestrians at high pedestrian zone crossings and remove priority to vehicles;
 - (b) Provide for automatic pedestrian walk phases;
 - (c) Allow 'leading interval' on 'walk' signals so pedestrians can start walking before cars move, increasing their visibility to drivers;
 - (d) Provide the maximum feasible green pedestrian time;
 - (e) Expand the number of 'Barnes Dance' intersections where pedestrians cross at all directions instead of having to wait?
- (8) What action will the Government take to improve pedestrian access at traffic signals in the CBD and Inner City?

Answer-

I am advised:

Roads and Maritime Services recently reduced the cycle time of traffic signals in the Sydney CBD, which means that the pedestrian phase is activated more frequently and in turn reduces waiting times.

Roads and Maritime uses adaptive signal control, as part of the Sydney Coordinated Adaptive Traffic System (SCATS), to continually vary the length of green time given to vehicles and pedestrians based on traffic conditions. SCATS is installed at traffic signals in New South Wales. Information about traffic signals, including design, is available on the Roads and Maritime's website.

The Government's Road Safety Plan 2021, released in February, identifies liveable and safe urban communities as a priority area and outlines the Government's plans for high pedestrian zones, including partnering with local government to expand 40 kliometres per hour zones and expanding the pedestrian

protection program. As announced in the 2018/19 Budget, the Government is investing \$180 million over five years for infrastructure safety upgrades for pedestrians, cyclists and other road users.

*9517 380 BUS SERVICES—Mr Alex Greenwich asked the Minister for Transport and Infrastructure—

- (1) Has the Government removed the Central Business District to Bondi Junction section of the 380 bus route?
 - (a) If so, what is the rationale for cutting these services?
- (2) Do the replacement 333 bus services stop at fewer bus stops and will this reduce accessibility for passengers?
- (3) Is there no longer a 333 bus stop between Lang Road/Queen Street and the Waverley Bus Depot, resulting in a distance of more than one kilometre between stops?
- (4) What assessment has the Government made of impacts of these changes on access for people with limited mobility?
- (5) What assessment has the Government made of providing mass transit between the Central Business District and beachside suburbs to carry the large number of people who travel between these destinations instead of relying on buses?
- (6) What plans does the Government have to increase bus services along Oxford Street to service local residents and businesses?
- (7) What further action will the Government take to improve public transport and reduce traffic congestion along Oxford Street?

Answer-

I am advised:

- (1) The upgraded route 333 now provides a higher frequency, high capacity, 'turn up and go' service between Bondi Beach, Bondi Junction and Circular Quay.
- (2) Additional stopping locations have been provided on route 333.
- (3) Under the old timetable, route 333 did not stop between Waverley Bus Depot and Lang Road Queen Street. That has not changed.
- (4) Customers with limited mobility continue to have access to alternative, allstops bus routes.
- (5) Transport for NSW is working with land use agencies from the State and local governments to collaboratively design a multimodal strategy for South East Sydney that will consider the needs of people moving to, from and within this subregion. This strategy will investigate the initiatives of Future Transport 2056, including new metro connections and light rail extensions.
- (6) Route 333 has been upgraded to operate along Oxford Street seven days a week, with services at least every six minutes during the day and every 10 minutes at night. Additional stops have been provided along Oxford Street.
- (7) Roads and Maritime Services is developing a plan for Oxford Street that will consider opportunities for improving travel times, reliability, safety and facilities for all road users, including those using public transport.
- *9518 PRISON LITERACY—Mr Alex Greenwich asked the Minister for Counter Terrorism, Minister for Corrections, and Minister for Veterans Affairs—
 - (1) What proportion of prisoners in New South Wales are considered to be illiterate or innumerate?
 - (2) What programs does the Government provide in prison to address limited literacy and numeracy?
 - (3) What data does the Government have on the success of these programs?
 - (4) Does the Government expect that all prisoners are either:
 - (a) Functionally literate and numerate on release; or
 - (b) Have been linked with programs post-release that address literacy and/or numeracy?
 - (5) What further steps will the Government take to ensure prisoners are literate and numerate on or soon after release?

Answer-

I am advised:

- (1) In 2017-18, of the 11,130 inmates who completed a core skills assessment, approximately 6 per cent were considered illiterate or innumerate.
- (2)Corrective Services NSW (CSNSW) delivers qualifications from the Foundation Skills and Information and Communication Technology training packages that aim to develop foundation language, literacy, numeracy, digital skills and vocational studies. CSNSW also provides Intensive Learning

Centres at Lithgow, Mid North Coast, South Coast and Wellington Correctional Centres where qualified CSNSW teachers deliver this service.

- (3) Following the Government's education reforms 98% of inmates with a sentence of more than six months have completed a core skills assessment. The number of inmates completing literacy and numeracy programs has increased by 53 per cent compared to 2015-16.
- (4) (a) The Government recognises that not all inmates who are illiterate and/or innumerate have a sentence length that provides enough time to undertake the volume of learning they require to develop functional literacy and numeracy.

Inmates have complex needs and may have other needs that are a priority over participation in education programs.

- (4) (b) CSNSW Education Service Co-ordinators and external education providers contracted by CSNSW co-ordinate and develop post-release strategies that promote and improve transition programs for inmates identified as needing to, or planning to, continue studies post release.
- (5) In 2017, CSNSW transitioned to a new and revised education and training model. As a result of this new model we have more than doubled the number of inmates completing literacy and numeracy programs. Under the new model teaching hours have significantly increased.

CSNSW is continuing to work toward improving the literacy and numeracy skills of inmates.

- *9519 LYMPHOEDEMA SERVICES IN NEW SOUTH WALES—Mr Alex Greenwich asked the Minister for Health, and Minister for Medical Research—
 - (1) Is it true that lymphoedema impacts around 22,000 people in New South Wales?
 - (2) What evidence does the Government have about the health and financial benefits of early intervention to prevent progress to advanced stages of lymphoedema?
 - (3) What progress has the Government made in developing a state wide lymphoedema policy and plan with integrated evidence-based services?
 - (4) What evaluation has the Government carried out into the effectiveness of its:
 - (a) Online training for generalist health staff;
 - (b) Specialist training for allied health staff?
 - (5) How does the Government assess the need for lymphoedema services and how well this need is met, including at the local service level?
 - (6) What data does the Government have about waiting times for access to lymphoedema treatment?
 - (a) What is the average wait in:
 - (i) New South Wales;
 - (ii) The inner city health districts?
 - (b) What impact do these waits have on treatment outcomes?
 - (7) What plans does the Government have to expand services for people living with lymphoedema?

Answer-

Evidence shows that early identification and treatment of lymphoedema are key factors in preventing its progression and minimising the risk of cellulitis.

Evaluation of the Health Education and Training Institute online training modules for health professionals concluded that the training program increased the skills, knowledge and confidence of staff through the therapist's perceived capabilities in applied lymphoedema practice.

Specialist training evaluation is ongoing with regular surveying of students to determine their use of accredited skills, challenges and ongoing capability and training.

Decisions about the configuration of services for people with lymphoedema, and the nature of the support provided, are made by local health districts and specialist health networks.

I am advised that waiting lists strictly for lymphoedema patients alone are not available.

- *9520 ROAD UPGRADES—Mr Clayton Barr asked the Minister for Roads, Maritime and Freight—
 - (1) How many vehicles travel per day on:
 - (a) Putty Road;
 - (b) Main Road, Heddon Greta;
 - (c) Lake Road, Elrington;
 - (d) Leggetts Drive, Richmond Vale;
 - (e) Main Road, Edgeworth?

- (2) Since 2010, how many reported vehicle/motorcycle crashes have occurred along these roads (to 27 September 2018)?
- (3) Since 2010, what safety upgrades have been undertaken by Roads and Maritime Services (to 27 September 2018)?
- (4) What future safety upgrades has Roads and Maritime Services identified as needing completion on these roads?

Answer-

I am advised:

(1) (a) Putty Road: 703 (2018)

(b) Main Road, Heddon Greta: 15,531 (2014)

(c) Lake Road, Elrington: 8,403 (2012)

(d) Leggetts Drive, Richmond Vale: 2,905 (2014)

- (e) Traffic data is not available for this locality.
- (2) Interactive crash statistics with reports on road user deaths and injuries, locations and crash types for the five years up to and including 2017 are available on the Centre for Road Safety's website.
- (3) and (4) The Government established the Safer Roads program in 2014-15 to fund targeted safety infrastructure projects aimed at reducing the occurrence and severity of crashes in New South Wales. More than \$260 million has been invested, delivering 627 projects across the State (at end of June 2018).

In the 2018-19 Budget, the Government announced a record \$1.9 billion in dedicated road safety initiatives over five years. This included \$640 million to save lives on country roads through infrastructure safety upgrades and \$180 million to increase liveability and safety in urban communities through infrastructure safety upgrades for pedestrians, cyclists and other road users. Round one of the Saving Lives on Country Roads program was announced in September 2018, with \$50 million being invested in the delivery of 97 road safety projects. A second round of infrastructure upgrades will take place next financial year.

- *9521 WILD DOGS IN THE LOWER HUNTER—Mr Clayton Barr asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) What is the estimated wild dog population in the Lower Hunter as at 27 September 2018?
 - (2) Since 2010, what control programs are currently, or have been, in place to target wild dog populations across the Cessnock electorate (to 27 September 2018)?
 - (3) Has Local Land Services been informed of domestic animals being accidently baited in the Cessnock electorate during baiting programs?
 - (a) What processes are in place if this occurs?

Answer—

- (1) Wild dogs can have a home range from 400 to 100,000 hectares, averaging about 4,000 hectares in eastern New South Wales, which makes it difficult to accurately estimate wild dog populations in any given area. Population sizes are more generally gauged by absence/presence modelling. Local Land Services records sightings and predation incidents as reported. The Hunter Regional Strategic Pest Animal Plan (2018) reported wild dogs being considered endemic throughout the Hunter Local Land Services region, with the Cessnock electorate having a medium level presence.
- (2) Wild dog control programs are generally undertaken in autumn to coincide with the wild dog breeding season. The following Cessnock electorate regions were subject to wild dog control programs since 2010: Congewai, Cedar Creek, Millfield, Quorrobolong, Pokolbin, Keinbah and Corrabare State Forest.
- (3) I am advised Local Land Service (LLS) has not been notified of accidental baiting in the Cessnock electorate.
- (a) Although very rare, accidental poisoning of domestic dogs has occurred (this has not been reported to Hunter Local Land Services as happening in the Cessnock electorate). In this instance the issuing Authorised Control Officer ([ACO] Hunter LLS biosecurity officer who has undergone specific training to handle and distribute 1080 baits and products) undertakes an investigation to ascertain the circumstances leading to the accidental poisoning. Actions investigated include:
- Baits were laid in accordance with all sections of the 1080 Pesticide Control Order by the end user including appropriate notification, signage and distance restrictions;

- Risk assessment that accompanied the approved bait included any risk mitigating measures that were included by the ACO;
- Only lands approved by the ACO were baited.

Environmental Protection Authority (EPA) is notified of the investigation and the outcomes. Any findings/outcomes from this investigation are used to further refine the risk assessment for future baiting programs to strengthen safety. Post point of sale (bait issuance) the Environmental Protection Authority (EPA) is the body charged with investigating and prosecuting any persons wilfully misusing 1080.

- *9522 GREYHOUND RACING NSW LEGAL STAFF AND CONSULTANTS—Mr Clayton Barr asked the Minister for Lands and Forestry, and Minister for Racing—
 - (1) How much money has Greyhound Racing NSW (GRNSW) spent on external legal advice, legal activity and legal consultants in each financial year from 2011-12 to 2018-19 (as at 27 September 2018)?
 - (2) How many individuals have been investigated, for the purpose of possible legal action by GRNSW, in each financial year from 2011-12 to 2018-19 (as at 27 September 2018)?
 - (3) How many Full-time equivalent employees within GRNSW were considered to be employed for the purposes of their legal expertise in each financial year from 2011-12 to 2018-19 (as at 27 September 2018)?
 - (a) What was the total cost of these employees in each financial year from 2011-12 to 2018-19 (as at 27 September 2018)?
 - (4) Have there been any special or specific investigations ordered by GRNSW that have had a final legal bill in excess of \$50,000?
 - (a) If so, what was the final cost of each of these special investigations?
 - (5) Is GRNSW required by law to go through a tender process for the outsourcing of any legal work?
 - (a) If so, what is the threshold amount above which a tender process is required?
 - (6) With which external legal advisory or consultant businesses have GRNSW engaged, where the quantum of the fee is in excess of the tender threshold amount?
 - (a) What was the total amount spent with each of these external entities in each financial year from 2011-12 to 2018-19 (as at 27 September 2018)?
 - (7) Do any of the legal professional employees of GRNSW meet with Members of Parliament?
 - (a) If so:
 - (i) Who have they met with?
 - (ii) How often did the meetings occur?
 - (iii) Is any such employee required to register with GRNSW any such meeting?

Answer-

Advice was sought from Greyhound Racing NSW (GRNSW), which has provided the following responses:

- (1) Expenditure figures for external legal advice, legal activity and legal consultants for the financial years in question, noting that these expenses include the cost of engaging stewards, some of whom are legally qualified:
- 2011-12 \$81,434
- 2012-13 \$493,218
- 2013-14 \$615,538
- 2014-15 \$711,809
- 2015-16 \$938,688
- 2016-17 \$1,370,396
- 2017-18 \$1,267,876
- 2018-19 \$310,966 (to 30 September, 2018).

GRNSW stated that the expenses related to major matters such as:

- · Special Commission of Inquiry into Greyhound Racing in New South Wales
- Inquiry into the Unauthorised Export of Greyhounds\
- Response to Legislative Council resolution pursuant to Standing Order 52 (request for documents)
- Defence of Victorian County Court proceedings (Marshall & Anor v McGuiness & Ors)
- Defence of NSW Supreme Court proceedings (Absalom v GRNSW & Anor).

GRNSW stated that it has understood the term "legal action" to mean administrative inquiries that GRNSW, as regulator, undertook against industry participants for breaches of the Greyhound Racing Rules.

GRNSW stated that due to the limitation of its data maintained, it is only able to provide figures for investigations and/or inquiries commenced by its Regulatory and Investigations Units from 2014-15 onwards:

- 2014-15 111 investigations commenced
- 2015-16 187 investigations commenced
- 2016-17 156 investigations commenced, 160 inquiries determined
- 2017-18 150 investigations commenced, 135 inquiries determined
- 2018-19 10 inquiries determined

GRNSW noted that its inquiry into the unauthorised export of greyhounds (2015-16 – ongoing, and 308 individuals) are not included in figures above.

GRNSW stated that if its assumption is incorrect, and the term legal action is intended only to capture possible litigation commenced by GRNSW against participants, the figure is zero. It noted that it has been named as a defendant in Supreme Court matters instigated by participants, but not prosecuted a civil or criminal action against a participant or greyhound racing club.

- (3) GRNSW advised that the number of full-time equivalent employees considered to be employed for the purposes of their legal expertise are:
- 2011-12 to 2014-15, 0
- 2015-16, 1
- 2016-17, 1
- 2017-18, 2
- 2018-19, 2.

Costs are:

- 2011-12 to 2014-15, n/a
- 2015-16, \$178,654
- 2016-17, \$243,231
- 2017-18, \$323,127
- 2018-19, \$110,466 (as at 30 September 2018).
- (4) Yes GRNSW has commissioned one investigation that has a final legal bill in excess of \$50,000 (inquiry into the unauthorised export of greyhounds, 9 December 2015 to present, \$527,126.94).

In responding to this question, GRNSW noted:

- as there is no time period specified, its response is limited to the period 1 July 2017 to date
- as the question refers to "special or specific investigations ordered by GRNSW," it has confined its answer to inquiries and/or investigations commenced or commissioned by it and, for example, has not included any appeals (or other proceedings in which GRNSW is not the moving party) arising from inquiries and/or investigations
- it understands the reference to "final cost' in question 4(a) to be a request for a total of its external costs associated with each investigation, given the reference "final legal bill" in question (4)
- it has included the costs of engaging external legal consultants to act as Stewards.
- (5) GRNSW stated that neither the Greyhound Racing Act 2017, nor any other applicable statute or regulations, require it to go through a tender process for the outsourcing of any legal work.
- (a) Not applicable
- (6) As per its response to Question (5), GRNSW stated that a tender threshold does not apply.
- (a) Not applicable
- (7) GRNSW advised that its Legal Professional Employees (LPEs) meet with Member of Parliament as part of their duties to engage with relevant stakeholders (including lawmakers) to further the interests of GRNSW and the greyhound racing industry in NSW. LPEs generally attend such meetings with GRNSW Board Members and/or its Chief Executive Officer.
- (a) (i) to (ii) Noting that no specific dates were requested, GRNSW stated that it limited its response to meetings that have taken place since 1 July 2017 and advised of the following meetings:

*9523 SOCIAL HOUSING IN TWEED—Ms Tania Mihailuk asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

Considering a Tweed-Shire Council-commissioned report found that the number of social houses available in the region is nearly half of the New South Wales average, how will the Government ensure that adequate social housing is provided in Tweed?

Answer-

I am advised that information on the NSW Government's investment in social and affordable housing is available at https://www.socialhousing.nsw.gov.au.

*9524 ADDITIONAL NURSING STAFF FOR BANKSTOWN-LIDCOMBE HOSPITAL—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—

Following the appointment of its first Prostate Cancer specialist nurse, what other additional nursing staff have been proposed in what specialties for Bankstown-Lidcombe Hospital in the next 12 months?

Answer—

Since 2011, the Government has increased the nursing and midwifery and other allied staff by more than 16,000 full-time equivalent (FTE). From June 2013 to June 2018 Bankstown-Lidcombe Hospital has also increased its nursing workforce by 90 FTE.

The South Western Sydney Local Health District regularly reviews staffing levels against demand for services at its facilities.

- *9525 DOONSIDE RAILWAY STATION—Mr Stephen Bali asked the Minister for Transport and Infrastructure—
 - (1) What was the annual commuter usage of Doonside Railway Station in 2016 and 2017?
 - (2) What is the anticipated cost of installing the Transport Access Program at Doonside Railway Station?
 - (3) Considering that Doonside Railway Station has been design ready for the Transport Access Program since 2011, does the design need to be updated for any safety or changes regulation?
 - (4) When will the Government commit to building the accessible station program, including lifts, at Doonside Railway Station?

Answer-

- (1) Aggregated Opal data is publicly available on the Transport for NSW Open Data Hub.
- (2) This information is commercially sensitive.
- (3) Any previous design would be reviewed and revised in accordance with current legislative requirements.
- (4) Stations across the network are assessed to see which ones are delivered under this program. This assessment process uses evidence-based criteria, including current and future patronage. It takes into account the needs and demographics of customers who use the station. It also considers the location of important services, such as hospitals or schools and the accessibility of other transport interchanges. Doonside Station will continue to be considered as part of this process.
- *9526 SOCIAL HOUSING CHARLESTOWN—Ms Jodie Harrison asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) Considering the 11,480 increase in social housing homes across New South Wales announced in August 2018 since 2011-12 (to 20 September 2018), how many of these are located in the Charlestown electorate?
 - (a) How many are 1 bedroom?
 - (b) How many are 2 bedroom?
 - (c) How many are 3 bedroom?

- (d) How many are 4 or more bedrooms?
- (e) How many are newly constructed?
- (f) How many are established properties?

*9527 AFFORDABLE HOUSING CHARLESTOWN—Ms Jodie Harrison asked the Minister for Planning, Minister for Housing, and Special Minister for State—

How many government affordable housing properties are there in the Charlestown electorate?

Answer-

I am advised:

Department of Planning does not collect electorate based data for affordable housing.
