#### 8 MARCH 2018

- \*7677 IMPROVING AIR QUALITY—Mr Alex Greenwich asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) What is the progress of Clean Air for NSW following consultation in 2016 and the summit in 2017?
  - (2) When will a Clean Air for NSW strategy be finalised?
  - (3) What is the progress of the review that commenced in 2016 of the load-based licensing (LBL) scheme?
  - (4) When will a new LBL scheme be finalised?
  - (5) To what extent will a new LBL scheme encourage the adoption of new pollution control technologies?
  - (6) What consideration will you give to reviewing and updating Environmental Protection Licences for the state's five coal-fired power stations to ensure emission reduction controls that are common in the United States of America, Europe and Japan such as Selective Catalytic Reduction and Flue Gas Desulfurisation are put in place?
  - (7) How does the Government encourage generators to undertake best practice remediation of ash dams once coal fired power stations retire?
  - (8) What commitment will the Government give to mandating best practice principles for the remediation of ash dams once coal fired power stations retire?
  - (9) Will the Government introduce bonds to ensure best practice remediation of ash dams once coal fired power stations retire?
  - (10) What assessment has been made of the Dust Stop Pollution Reduction Program and other controls of air pollution from mines given 80 air pollution alerts were issued in the Hunter Valley in October 2017 for exceedances of the national standard for coarse particle pollution?

#### Answer-

## I am advised:

- (1) and (2) The Environment Protection Authority (EPA) and Office of Environment and Heritage are considering stakeholder feedback from the Clean Air for NSW Consultation Paper and the Clean Air Summit, and liaising with other government agencies to finalise Clean Air for NSW.
- (3) to (5) Following public consultation on an issues paper in late 2016, the issues raised in submissions are being considered.
- (6) New South Wales has a strong and comprehensive regulatory framework for controlling air pollution. Regulatory requirements for air pollution from power stations are set out in outcome based environment protection licences that are regularly reviewed . Regulatory requirements, including emission limits and monitoring requirements for air emissions, are tailored to take into account the likely impacts of any emissions and any relevant site specific circumstances, such as the available technology and the practicality of installing that technology at a site.

The EPA's review of air emissions from the state's five coal fired power stations has been finalised and is available here http://www.epa.nsw.gov.au/your-environment/air/industrial-emissions

- (7) Environment protection licences and other regulatory notices can require specific closure and remediation actions, and remain in force after power stations close. This ensures that all environmental issues are addressed and that remediation and rehabilitation is completed to a standard suitable for the future intended land use.
- (8) and (9) The Government expects that generators will remediate and rehabilitate ash dams after their closure to achieve the relevant environmental objectives for the intended future land use. Specific licence or notice conditions achieve these expectations.
- (10) Under the Dust Stop Program, coal mines have implemented management practices and controls that are estimated to have reduced particle emissions by 22,000 tonnes per year of 19 per cent. The EPA is continuing to work to further reduce particle emissions from mines, particularly during adverse weather. The EPA issues alerts on a cautionary basis, particularly in the face of adverse weather events.
- \*7679 PHARMACY DEPARTMENT AT GOSFORD HOSPITAL—Ms Liesl Tesch asked the Minister for Health, and Minister for Medical Research—
  - (1) How many staff were employed in the Pharmacy Department at Gosford Hospital in each financial year from 2013-14 to 2016-17?

- (2) How many staff resigned from the Pharmacy Department at Gosford Hospital in each financial year from 2013-14 to 2016-17?
- (3) What was the rate of staff turnover at Gosford Hospital in each financial year from 2013-14 to 2016-17?

#### Answer-

Staffing levels within Gosford Hospital Pharmacy Department have increased over the past four years and the number of permanent staff resignations within the Pharmacy Department has reduced over the past four years.

The Central Coast Local Health District's staff turnover is below the state average of natural staffing attrition for all local districts.

### \*7681 ETHICS CLASSES—Mr Alex Greenwich asked the Minister for Education—

- (1) What action has the Government taken to prevent New South Wales high school students being prevented from attending ethics classes?
- (2) At which high schools, if any, has this occurred?
  - (a) Are any of these schools in the Sydney electorate?
- (3) How does the Government ensure parents understand ethics classes options and can elect this option if they wish?
- (4) What assessment has the Government made about improving the process for parents and guardians who elect ethics classes for their children including:
  - (a) Making it easier for parents to elect ethics classes;
  - (b) Making it easier for students to enrol in ethics classes:
  - (c) Ensuring schools do not interfere in parents' choice of ethics classes?
- (5) What further action will the Government take to ensure easy access to ethics classes in all high schools?

#### Answer-

I'm advised there are currently no Special Education in Ethics (SEE) classes operating in New South Wales high schools.

Primary Ethics has been approved to provide SEE classes in New South Wales government schools and deliver a curriculum for Kindergarten to Year 6 students. There are currently no plans from Primary Ethics or applications from other providers to deliver SEE in New South Wales high schools.

I'm advised Section 33A of the Education Act 1990 allows Special Education in Ethics SEE as an option for children whose parents have withdrawn them from Special Religious Education (SRE). Section 33A states that a government school cannot be directed (by the Minister or otherwise) not to make SEE available at the school.

Principals must allow time for SRE/SEE where authorised representatives of approved providers are available. Where a parent/caregiver requests SEE, and it is not currently available in the school, the school will provide the parent/caregiver with the name and contact details of Primary Ethics.

\*7683 SHUTTLE BUS SERVICES BETWEEN EASY ACCESS STATIONS—Ms Tania Mihailuk asked the Minister for Transport and Infrastructure—

Why has consideration not been given to providing a shuttle bus between Bankstown and Sefton Railway Stations while lift access is unavailable at Bankstown to accommodate less mobile passengers who are reliant on disabled parking within the Bankstown CBD?

#### Answer-

## I am advised:

Support for customers during the lift replacement period at Bankstown Station is provided by two additional station team members. Customers may be offered a taxi to travel to the nearest accessible station.

- \*7684 CARDIO-THORACIC SURGEON AT WOLLONGONG PUBLIC HOSPITAL—Mr Paul Scully asked the Minister for Health, and Minister for Medical Research—
  - (1) Is the Minister aware that his predecessor pledged to appoint a cardio-thoracic surgeon to Wollongong Public Hospital during the 2015 election?
  - (2) Why has the Government not implemented this pledge?
  - (3) Is the Government abandoning the election pledge made by the Minister's predecessor?

(a) If not, by what date will the pledge be implemented?

#### Answer-

- (1) to (3) The development of thoracic services remains a part of the surgical planning for the Illawarra Shoalhaven Local Health District.
- \*7689 HERITAGE ITEMS AND ARTEFACTS AT HURLSTONE AGRICULTURAL HIGH SCHOOL—Mr Anoulack Chanthivong asked the Minister for Education—
  - (1) What heritage items and artefacts are currently housed at Hurlstone Agricultural High School, Glenfield?
  - (2) How many heritage items or artefacts have been removed from the school in 2017?
    - (a) Where were these artefacts or heritage items relocated?

## Answer-

- (1) I'm advised as at 13 March 2018, 293 heritage items and artefacts have been identified that are currently housed at Hurlstone Agricultural High School, Glenfield. The local Member is invited to view the school's register of these items at the school.
- (2) I'm advised that no heritage items or artefacts were moved from the school in 2017.
- \*7691 ENFORCEMENT OF SECTION 39 OF THE WORKERS COMPENSATION ACT 1987—Mr Clayton Barr asked the Minister for Finance, Services and Property—
  - (1) Since the enforcement of Section 39 of the Workers Compensation Act 1987, how many injured workers have contacted the State Insurance Regulatory Authority (SIRA) or Workers Compensation Independent Review Office (WIRO) to disclose their suicidal thoughts or discuss mental health illnesses that have initiated, or been aggravated, as a result of the decision to end their weekly entitlements (to 8 March 2018)?
  - (2) How many injured workers have had their weekly entitlements cut, as per Section 39 of the Workers Compensation Act 1987 (to 8 March 2018)?
  - (3) Has the Government received any briefings from the Commonwealth Government on how many injured workers who were affected by Section 39, have:
    - (a) Been successful in their application for a disability support pension?
    - (b) Been unsuccessful in their application for a disability support pension, and have been successful for a Newstart Allowance?
    - (c) Been unsuccessful in their application for a disability support pension, and have been unsuccessful for a Newstart Allowance?
  - (4) If an injured worker has had their weekly payments cut, is ineligible for Centrelink support, and is unable to return to work, what options are available to them to earn an income?

#### Answer—

(1) Since the introduction of State Insurance Regulatory Authority's (SIRA) Support and Information Service in June 2017 up to 6 March 2018, nine workers who have contacted SIRA have expressed thoughts of self-harm or discussed mental health illnesses as a result of weekly payments ceasing. All nine have been offered community based mental health services to support them. SIRA has undertaken a follow-up calls with these workers.

SIRA has put in place an after-hours answering service on the SIRA 13 10 50 customer service line as well as access to an independent 24-hour counselling service for workers experiencing acute psychological or financial / social distress. While these services have been used by other workers compensation claimants, to date no worker affected by section 39 has accessed these services.

Between 1 September 2017 to 8 March 2018, the Workers Compensation Independent Review Office (WIRO) Solutions Service received calls from seven people who made reference to suicide and 15 referring to depression as a result of the impact of section 39.

- (2) 3,315 affected workers have ceased weekly payments between 1 October 2017 and 8 March 2018.
- (3) No. SIRA is working with Centrelink on data linkages to inform collection of this information.
- (4) The New South Wales workers compensation scheme is broadly in line with other Australian jurisdictions, where there are limits on entitlements to weekly benefits:
- In Victoria, there is a capacity test at 130 weeks and benefits cease if there is any capacity
- In South Australia, entitlement is up to two years, unless permanent impairment is greater than 30 per cent

- In Queensland, the entitlement is up to five years total for weekly and medical, or by reaching a financial cap prior to this point
- In Western Australia, there is no duration cap, however, there is a cap of \$190,700 in total benefits
- In Tasmania, entitlement is up to nine years where permanent impairment is less than 15 per cent, and to retirement age if greater than 30 per cent.

Across the New South Wales workers compensation system, at 26 weeks, 89.3 per cent of workers have returned to work (RTW). Over the last five years the RTW rates have continued to improve and as a national benchmark, New South Wales has the highest rate of workers returning to work (90 per cent) when compared to other jurisdictions.

Of the 3,842 workers affected by section 39 of the Act, 541 (14 per cent) are currently working and a further 950 (25 per cent) have a current work capacity, but are not working.

All workers affected by section 39 may access SIRA's vocational programs which are designed to assist workers to return to work. These workers can access the programs prior to ceasing weekly payments and can continue until program completion.

All workers who have ceased weekly payments due to section 39 will continue to be entitled to reasonably necessary medical and related treatment for a further two or five years, depending upon the level of permanent impairment. This includes assistance from workplace rehabilitation providers, who assist workers and employers to identify appropriate supports for a worker to re-enter the workforce, either with the existing employer or with a new employer.

Workers who have already ceased weekly payments can access Community Connect payments (up to \$1,000) to assist them to adjust to their changed circumstances.

SIRA's Support and Information Service can also assist all workers affected by section 39 to connect with community based services, for example Ability Links.

Eligibility for Centrelink benefits is based on each applicant's individual financial circumstances, this accounts for any income and assets held by the individual and their partner. Therefore, SIRA cannot provide commentary on an individual's eligibility for Centrelink benefits.

- \*7692 SECTION 39 OF THE WORKERS COMPENSATION ACT—Mr Clayton Barr asked the Minister for Finance, Services and Property—
  - (1) How many injured workers will have their weekly entitlements cut as a result of Section 39 of the Workers Compensation Act 1987 in each month from February 2018 until June 2019?
  - (2) How many injured workers, impacted by Section 39, have been approved for the continuation of the payment of medical accounts where approval was sought after the cessation of their weekly entitlements?
  - (3) How many injured workers have successfully appealed their whole person impairment assessment since July 2017, which has allowed them to continue to receive weekly entitlements through the workers compensation scheme?

#### Answer-

(1) A total of 2,288 workers are projected to cease weekly payments from February 2018 to June 2019.

- (2) Of the 2,843 claims that have ceased weekly payments between September 2017 and January 2018, 2,166 claimants have received medical, hospital or other allied health services after the cessation of weekly payments.
- (3) As at 12 March 2018, 408 workers affected by section 39 have lodged an application with the Workers Compensation Commission. Of the 408 applications:
- 190 workers are disputing their assessed level of whole person impairment, of which:
  - 67 have been assessed above 20% and will continue to receive weekly payments
  - 9 have been assessed as not yet reaching maximum medical improvement (not MMI) and will continue to receive weekly payments
  - 27 cases are still to be assessed
- 218 workers are seeking certification that they cannot be assessed due to their not MMI status, of which:
  - 142 have been assessed as not MMI and will continue to receive weekly payments
  - 14 are still to be assessed.

Therefore, of the 408 workers who made application to the Workers Compensation Commission, 218 will continue to receive weekly payments.

In addition, as at 16 March 2018, insurers have reported to SIRA that 256 workers have been deemed by their insurer as being above 20 per cent permanent impairment and will continue to receive weekly payments.

\*7693 FUNDING FOR A PALLIATIVE CARE AND HOSPICE FACILITY FOR ORANGE—Mr Philip Donato asked the Minister for Health, and Minister for Medical Research—

Will the Government consider funding the construction and operation of a dedicated eight plus bed palliative care and hospice facility for Orange from the funds generated from the sale of the Snowy Hydro scheme?

Answer-

The allocation of funding generated from the sale of Snowy Hydro is a matter for the Premier.

- \*7694 POLICE TRANSPORT COMMAND—Mr Clayton Barr asked the Minister for Police, and Minister for Emergency Services—
  - (1) Where is the Police Transport Command (PTC) located?
  - (2) Are there officers from the PTC stationed in the Hunter?
    - (a) Do these officers regularly patrol train services on the Hunter line and the Newcastle/Central Coast line?
    - (b) Are these patrols daily?
    - (c) Are these patrols extended to bus services in the Cessnock and Lake Macquarie areas?
  - (3) Do officers from the PTC need to obtain permission from private owner/operators before they can board a bus to undertake patrols?
  - (4) Are PTC officers provided adequate personal protective equipment to assist them in undertaking their roles?
  - (5) What are the main offences targeted by PTC officers in the Hunter region?

Answer-

I am advised:

- (1) The Police Transport and Public Safety Command (PTPSC) has locations in a number of areas throughout the network.
- (2) (a) Yes.
- (b) The Command provides a dedicated, proactive and targeted police presence undertaking intelligence-based patrols.
- (c) Yes.
- (3) No
- (4) As with all sworn NSW Police Force officers, PTPSC officers are provided with appropriate arms and appointments to undertake their duties.
- (5) The PTPSC focuses on reducing alcohol related crime, anti-social behaviour, stealing, assaults and

sexual offences.

- \*7695 INJURED WORKERS IN NEW SOUTH WALES—Mr Clayton Barr asked the Treasurer, and Minister for Industrial Relations—
  - (1) Since 1 January 2018, how many new workers compensation claims have been made in New South Wales (to 8 March 2018)?
    - (a) How many of these have had successful return to work outcomes within two weeks of their claim being submitted?
    - (b) How many of these are ongoing claims?
  - (2) Upon the initial notification of their claim, were each of these injured workers provided details on Section 39 of the Workers Compensation Act 1987 and how this may possibly affect their claim in the future?
  - (3) Have each of these injured workers who have submitted new claims been advised of the step-by-step process they will need to undertake as part of their workers compensation claim?

#### Answer-

- (1) The total number of claims will be published in the Annual Report.
- (2) This is not communicated upon initial notification as section 39 is not applicable to the majority of injured workers, given that the majority of injured workers recover from their injuries and return to work in less than five years.
- (3) Yes.
- \*7696 NEW TIMETABLE COST—Ms Julia Finn asked the Minister for Transport and Infrastructure—
  - (1) Is the following information contained in the 2016-17 Transport for NSW Annual Report:

    - (c) Cost of the "We're moving forward" advertising campaign;
    - (d) Cost of providing new maps at each railway station?
  - (2) If so, which pages is the information contained on?
  - (3) Will the Minister make publicly available the estimation done by Transport for NSW which indicates "there will be no impact on local businesses as a result"?

- \*7698 REVERSE VENDING MACHINE IN GRANVILLE—Ms Julia Finn asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) How many containers have been processed by the reverse vending machine in Granville since the commencement of the scheme (as at 8 March 2018)?
  - (2) What is the total amount which has been paid out by the reverse vending machine in Granville since the commencement of the scheme (to 8 March 2018) as:
    - (a) A voucher to be redeemed at a participating retailer;
    - (b) An e-payment into a PayPal account via the myTomra App;
    - (c) A donation to one of the charities shown on the machine's screen?

- \*7699 POINT TO POINT TRANSPORT—Ms Julia Finn asked the Attorney General—

Does the Government require ridesharing services to comply with the Disability Discrimination Act 1992 or New South Wales anti-discrimination law?

Answer—

I am advised:

Anyone who experiences discrimination through the use of ridesharing services can either make a complaint to the Anti-Discrimination Board of NSW or the Australian Human Rights Commission under the Anti-Discrimination Act 1977 (New South Wales) or the Disability Discrimination Act 1992 (Commonwealth) respectively.

- \*7705 DREDGING THE ENTRANCE CHANNEL—Mr David Mehan asked the Minister for Lands and Forestry, and Minister for Racing—
  - (1) When will dredging of sand from The Entrance channel occur?
  - (2) Will this be deposited onto the Entrance beach to complete the groyne project?

Answer—

- (1) The dredging is expected to commence in late April 2018.

  - (2) How many of these classrooms currently have air conditioning?
  - (3) Which of these classrooms meet criteria for air conditioning as per the Government's Air Cooling Policy?
  - (4) Under the Government's Air Cooling Policy, at what average temperature does it become recommended for a classroom to have air conditioning?
  - (5) When is the last time the Air Cooling Policy was reviewed?

#### Answer—

I'm advised public schools that are eligible for air cooling under the Department of Education's Air Cooling Policy are identified by the department and prioritised in a program of necessary works.

The department cools all habitable spaces in New South Wales public schools located in areas that have a mean maximum January temperature of 33 degrees Celsius or higher. In addition to this, air cooling is provided in schools with students that have special needs, in all demountable teaching spaces, and in those areas where temperature combined with humidity is likely to cause heat stress.

I'm advised the schools listed have a mean maximum January temperature of between 26 and 26.5 degrees Celsius.

Any public school below the policy threshold may make a local decision to install air-conditioning at their cost.

The department has a set of design standards that recommend sustainable and cost-effective approaches to improve thermal comfort in schools via passive measures such as insulation, sunscreens, improved ventilation and appropriately designed landscaping.

- \*7707 WARRAWONG SERVICE CENTRE—Ms Anna Watson asked the Minister for Finance, Services and Property—
  - (1) How many full-time equivalent staff are currently employed at the Warrawong Service Centre as at 8 March 2018?
  - (2) How many full-time equivalent staff were employed at the Warrawong Service Centre as at 8 March 2017?
  - (3) How many full-time equivalent staff were employed at the Warrawong Service Centre as at 3 June 2016?

#### Answer-

On 28 February 2018 there were 21.22 full-time equivalent positions at the Warrawong Service Centre. On 28 February 2017, there were 19.66 and on 31 May 2016, there were 20.26.

### Answer—

Looking only at bed numbers is an outdated approach, and does not reflect the volume and quality of health services delivered to patients in our hospitals or in the community.

In 2012, activity based funding was introduced in New South Wales. Funding to local health districts and speciality health networks is now based on activity, or the number and mix of patients treated, rather than the number of beds.

\*7715 SERVICE NSW PRIVACY POLICY—Ms Jenny Aitchison asked the Minister for Finance, Services and Property—

- (1) What policy is in place for handling serious privacy breaches of information handled by Service NSW?
- (2) Have any serious privacy breaches occurred since 1 January 2015 (to 8 March 2018)?
  - (a) If so, what breaches have occurred and when?
  - (b) If so, how were they handled?

#### Answer-

Service NSW's Privacy Management Plan sets out how individuals can make a privacy complaint and request an internal review under the Privacy and Personal Information Protection Act 1998. I am advised from 1 January 2015 to 8 March 2018, Service NSW served over 27.8 million customers and over the same period, 9 privacy complaints were identified as serious privacy breaches. Each complaint related to the way Service NSW has handled personal information. A serious privacy breach has been defined by Service NSW as where an internal review was conducted, the breach was substantiated and the NSW Privacy Commissioner was notified of the complaint.

The 9 complaints have been formally investigated by Service NSW's Privacy Officer. The NSW Privacy Commissioner was also notified and actions were taken by Service NSW to remediate and respond to each complaint.

A third party was engaged to undertake an independent review of a photo card processing error that occurred in April 2017. In response, Service NSW implemented remediation actions and improvements to internal controls to prevent further breaches occurring.

The overall impact of these platforms is being considered as part of the reform of the residential tenancy laws.

Sydney is a victim of its own success. In 2015-16 Sydney Harbour hosted 311 cruise ship visits making it the most visited cruise ship port in Australia.

The CIRG has now provided advice and recommendations to Government, which are currently being considered as the Government finalises the Cruise Development Plan. This Plan will set out a long-term strategy to develop the cruise industry in New South Wales, and will be released throughout the course of 2018.

The CIRG considered a number of locations, however, no decision has been made regarding a site for a proposed new cruise ship facility. Full public consultation, including consultation with local communities, will occur during the development assessment process for any new site.

  - (1) Is the Minister aware of reports of 40 minute wait times to access the Hunter New England Mental Health Line?
  - (2) Are these wait times considered suitable?
  - (3) What actions, if any, will be taken to reduce wait times?

Answer-

(1) to (3)

The Mental Health Access Line is a single point, statewide service that is accessed by consumers and health professionals. There are varying degrees of urgency with requests and the team uses the NSW Health Crisis Triage Rating Scale to assign a level of urgency of the need for care. Callers in a life-threatening situation requiring immediate assistance from emergency services are advised to call Triple Zero (000).

The most recent Hunter New England Mental Health Access Line performance data indicates that in December 2017 20 per cent of calls had a wait time of over two minutes.

The Government is investigating a number of strategies to improve wait times for the Mental Health Line. These include an on-hold message for health professionals that referrals can also be sent via email

or fax to the Mental Health Line 24 hours per day, seven days per week, and a call-back option for callers while still retaining their place in the queue. These will further improve the service provided by the Hunter New England Mental Health Line and direct people to the services most appropriate to their needs.
