What support has the NSW Government provided to the GWS Giants AFL team in order for them to partake in their inaugural AFL season next year?

Answer—

The NSW Government has provided indirect assistance to the GWS Giants team with support to upgrade the Sydney Showgrounds, which will provide fans with a modern 25,000 seat stadium to showcase home games from season 2012.

The Sydney Showground re-development is being funded by the State Government, the Australian Football League and the Royal Agricultural Society of NSW (RAS). The NSW Government is contributing \$45 million to the re-development and \$8.5 million to Blacktown International Sports Park (BISP), an elite sports facility that will be a training and development resource for the community.

The stadium enhancement will greatly benefit the community, with an additional \$500 million of economic and social value for NSW and an estimated 4,000 jobs for Western Sydney.
