With regard to clause 11 of the Residential Tenancies Regulation 2010, which prescribes the water efficiency measures that residential premises are required to have before a tenant can be charged for water use:

- (1) Why are water efficiency measures required for taps in kitchen sinks and bathroom hand basins but not for toilets, when domestic water consumption for toilet flushing is significantly higher than water consumption from kitchen sinks and bathroom hand basins?
- (2) Will the Government amend the regulation to also require water efficiency measures for toilets before a tenant can be required to pay water usage charges?

Answer—

NSW Fair Trading advises me that:

- (1) Landlords can meet the water efficiency measures prescribed in the Residential Tenancies Regulation 2010 with only a small once-off installation cost, which would cost less than \$200 for most homes. However, the cost to install a dual flush toilet is significantly higher and could place an onerous financial burden on landlords, which would no doubt be passed on to tenants through higher rent charges.
- (2) There is no current proposal to amend the Regulation. The new measures have not been in place long enough to enable a proper review of their impact to be carried out. When the Regulation is next reviewed, the water efficiency measures will be examined to assess whether they are meeting the policy objectives.

Answer-

I am advised that:

(1) and (2) From 30 June 2010 to date, based on an assessment by postcode, NSW Fair Trading has received 30 home building enquiries from within the Baulkham Hills electorate, involving 30 different traders. However, not all of the traders were based in the Baulkham Hills electorate.

Fair Trading has a number of enforcement options available to encourage and enforce compliance with legislation. For minor breaches, a formal warning may be sufficient. In relation to more serious matters, penalty infringement notices (monetary penalties), licence cancellations or suspensions, public warnings and rectification orders can be issued. In a case where a trader has a record of repeated breaches, legal proceedings against the trader may be commenced.

Of the home building matters that occurred in Baulkham Hills from 30 June 2010 to date, one resulted in three penalty notices being issued to a trader to the total value of \$2,650. Another matter, in relation to a different trader, is still under investigation and four matters are subject to mediation. The remaining matters have been resolved by way of telephone and on-site mediation.

The Baulkham Hills electorate has been included in the Sydney Metropolitan Compliance campaign to ensure ongoing compliance with the legislation.

The June 2011 audit of solar panel installations will also focus on the Baulkham Hills electorate. Solar arrays will be assessed to ensure that installers have complied with the Electrical (Consumer Safety) Act 2004 and the Home Building Act 1989.

(3) From 30 June 2010 to date, Fair Trading has received 110 enquiries relating to building tradespeople in the post codes of the electorates surrounding Baulkham Hills (Castle Hill, Hawkesbury, Parramatta, Toongabbie and Riverstone).

Fair Trading also conducted two compliance campaigns in the electorates surrounding Baulkham Hills during May 2010 and April 2011. A total of 24 Penalty Notices to the value of \$19,370 were issued during these campaigns.
