*4846 UTILITIES BILLS—Ms Sonia Hornery asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What steps is the Minister taking to ensure that the 2261 billing errors with gas, water and electricity companies that occurred in 2016 do not occur in 2017?

Answer—

Both the independent Australian Energy Regulator and the Energy and water Ombudsman NSW monitor the retailer compliance with the national billing requirements in New South Wales.

The Australian Energy Regulator wrote to retailers at the start of this year and named billing compliance, including estimated readings, as one of their top priorities for 2017.

My Department works closely with the Australian Energy Regulator and the Energy and Water Ombudsman NSW to ensure accuracy in the billing mechanisms and respond to issues when they arise.

- *4847 NEW SYDNEY WATER CUSTOMER CENTRIC STRUCTURE—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
 - (1) Were there any costs associated with Sydney Water moving to a new "customer centric structure" in the last financial year (2015-16)?
 - (a) If so, what were those costs?

Answer-

No. The new structure reduced Sydney Water's divisions from eight to six, thereby creating savings for customers.

*4848 CLARIFICATION OF ANNUAL REPORT TERM—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What is meant by the term " help us achieve our vision of being the life stream of Sydney " (reference page 23 of the Sydney Water Annual Report 2015-16)?

Answer—

The 'Lifestream' concept is the vision of Sydney Water's Corporate Strategy. It recognises Sydney Water's past and refers to its future role in sservicing the growth of Sydney as well as the organisation's efforts on providing value to customers.

- *4849 WESTERN SYDNEY ARTS GRANTS—Ms Julia Finn asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
 - (1) What grants have been made in each financial year from 2011-12 to 2016-17 (to 21 February 2017) to:
 - (a) Artists based in the Cumberland Local Government Area?
 - (b) Art organisations based in the Cumberland Local Government Area?

*4850 WESTERN SYDNEY DIABETES PREVENTION AND MANAGEMENT INITIATIVE-Ms Julia Finn asked the Minister for Health, and Minister for Medical Research-

What annual funding has been made available to Western Sydney Local Health District to implement the Western Sydney Diabetes Prevention and Management Initiative in each year it has been operational?

Answer-

The impact diabetes has on our health system is significant- it is estimated that treating diabetes costs the Western Sydney Local Health District in excess of \$126 million and in 2016-17, the budget allocated for additional initiatives is \$1,373,706.

- *4851 ILLAWARRA CAPITAL INVESTMENTS-Mr Paul Scully asked the Treasurer, and Minister for Industrial Relations-
 - (1) Are the Government's budget cost overruns on Sydney infrastructure projects impacting on the rollout of capital investments in infrastructure in the Illawarra region?
 - (a) If so, what is the Government's strategy to address the cost overruns to ensure that capital investments in Illawarra infrastructure are not delayed from commencement?

Answer-

Approved and budgeted Illawarra projects will proceed based on their own individual funding arrangements.

- *4852 CRUISE DEVELOPMENT PLAN—Mr Paul Scully asked the Minister for Tourism and Major Events, and Assistant Minister for Skills—
 - (1) Did the Government announce the development of a 10 year Cruise Development Plan in June 2014?(a) If so, what factors are delaying the release of the 10 year Cruise Development Plan?
 - (2) What stakeholders have been consulted in the development of the Cruise Development Plan?
 - (3) What issues have been raised for inclusion in the Plan?
 - (4) Will the Cruise Development Plan include Port Kembla?(a) If not, why not?
 - (5) When will the final 10 year Cruise Development Plan be released?

Answer-

The Government recognises the importance of the cruise sector to the New South Wales economy, and is committed to preparing a long-term cruise strategy, as foreshadowed in the Visitor Economy Industry Action Plan.

The long-term cruise strategy will investigate how we can best accommodate future demand, develop emerging cruise destinations throughout the state and make sure that the regulatory environment balances the needs of industry and community. Extensive consultation with all relevant Government and industry stakeholders is a critical part of the plan development.

The plan will cover the full range of issues that affect the cruise industry, including existing and new infrastructure, destination management and regulation that may impact on the success of the cruise industry for both Sydney and the regions. The plan will include actions that can help us grow the sector in New South Wales, including emerging regional ports like Eden, Newcastle and Port Kembla, to ensure we share more of the economic benefits from the continuing growth of the cruise market. The Government will continue to liaise with key stakeholders as we bring the plan to completion.

*4853 RELEASE OF ELDERLY PATIENTS FROM HOSPITAL—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

Considering a constituent has reported concerns that her elderly mother was released from a Hunter New England Hospital early because of bed block, what is the Minister doing to ensure that elderly patients are not released before they have recovered?

Answer—

All patients are discharged when they are medically stable and no longer need to have their care provided in a hospital setting.

If an elderly patient is not able to manage in the community, they may be discharged to an aged care facility or be considered for transfer to a step down sub-acute facility area, such as the Short Term Resident Accommodation Service.

*4854 SYDNEY WATER, WATER BAR—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What was the total cost of the Sydney Water, Water Bar at the Easter Show and Sydney Festival, including staff time?

Answer—

Total cost of the Water Bar at the Easter Show sand Sydney Festival in 2016 was \$68,000. 114 Sydney Water staff volunteered their time to run the water bar. This prevented about 33,900 single serve plastic bottles being purchased, saving customers over \$100,000 over the two events.

*4855 EQUAL FUNDING FOR NEW SOUTH WALES PUBLIC SCHOOLS—Ms Sonia Hornery asked the Minister for Education—

How is the Minister ensuring that all New South Wales public schools will receive their fair share of funding in 2017?

Answer-

The Government's 2016-17 Budget delivers record funding of \$12 billion for NSW public schools. A further \$554 million has been allocated in 2016-17 to support the delivery of capital works projects in New South Wales public schools.

Schools are already benefiting from the \$219 million additional funding provided in 2017 to schools through the Department of Education's needs-based Resource Allocation Model.

Funding has also been allocated to key reforms such as improving teacher quality.

New South Wales will continue to advocate for the full Gonski funding.

*4856 T-CORP BORROWING FACILITY—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

(1) How much of an increase did NSW Treasury demand from Sydney Water in order for the corporation to use the T-Corp borrowing facility as referenced on page 30 of the Annual Report?

(2) How much did Sydney Water pay NSW Treasury in order to use the T-Corp facility in 2015-16? Answer—

The Government Guarantee Fee Policy is a component of the Government's Commercial Policy Framework which was introduced over 20 years ago. The fee is paid by government businesses to NSW Treasury for the guarantee that the Government provides in relation to the Corporation's borrowings.

Sydney Water's government guarantee fee expense in 2015-16 was \$117.1 million. This was \$19.3 million higher than 2014-15, although the credit rating of Sydney Water remained unchanged.

The increase in the fee in 2015-16 was mostly due to higher average debt totals in 2015-46 and the impact of higher fee rates in 2015-16 on refinanced debt. these higher fee rates are based n independent market based credit spreads prevailing in 2015-16.

- *4857 GREENHOUSE GAS EMISSIONS—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
 - (1) Is the Minister concerned that Sydney Water net greenhouse gas emissions increased by 74 per cent in 2015-16?
 - (2) What steps will the Minister take to reduce these net emissions?

Answer—

(1) and (2) in 2015-16, Sydney Water reduced its total greenhouse gas emission by 7.2 per cent compared to 2014-15. Net emissions increased in 2015-16 as Sydney Water exhausted its supply of carbon credits (NSW Greenhouse Abatement Certificated, of NGACs) that it had been using to offset some of its emissions. The NGACs were created from customer water and energy efficiency projects up to 2012, such as water efficient showerheads and washing machines.

However, Sydney Water's grid electricity consumption in 2015-16 was 331GWh, which is 9 per cent below the 1998 baseline of 365GWh, and Sydney Water generated a record 56GWh of electricity from its own renewable sources (biogas, hydro and solar). This is equivalent to 21 per cent of Sydney Water's electricity demand, which reduces demand for fossil fuel based grid power and the impact of electricity costs on customer water bills.

- *4858 ILLAWARRA-SHOALHAVEN REGIONAL PLAN—Mr Paul Scully asked the Minister for Planning, Minister for Housing, and Special Minister for State—
 - (1) When will the Annual Monitoring Report mentioned on page 14 of the Illawarra-Shoalhaven Regional Plan be released?
 - (2) What are the factors delaying the release of the 2016 Annual Monitoring report?

Answer-

- (1) The Annual Monitoring Report is currently being finalised and will be released in the coming months.
- (2) As Regional Plans continue to be rolled out across NSW, the approach for monitoring and reporting will be aligned across all the Regional Plans. The recent release of new draft Regional Plans has set the framework for the finalisation of an Implementation Plan and Annual Monitoring Report for the Illawarra-Shoalhaven.

*4859 COUNTERING VIOLENT EXTREMISM TRAINING PROGRAM—Mr Paul Lynch asked the Attorney General—

- (1) Has the Department of Justice developed and implemented the Countering Violent Extremism Training Program (as referred to at page 18 of the Department of Justice Annual Report 2015-2016)?(a) If not, why not?
 - (b) If so, when?

Answer—

The Member should direct his question to my colleague, the Minister for Counter Terrorism.

- *4860 STAFF AT WARATAH POLICE STATION—Ms Sonia Hornery asked the Minister for Police, and Minister for Emergency Services—
 - (1) How many allocated staff at Waratah Police Station are available to attend to incoming calls to the station?
 - (2) On how many occasions in 2016 were ample staff not available to answer calls to Waratah Police Station phones?
 - (a) Was this due to a shortage of staff?
 - (i) If so, when will more staff be allocated to Waratah Police Station?
 - (ii) If not, what is the government doing to ensure calls to Waratah Police Station don't go unanswered?

Answer-

Operating hours of police stations and staffing arrangements within a Local Area Command (LAC) vary according to operational requirements. Waratah Police station is open 24 hours a day.

LACs provide a 24 hour mobile policing response to all areas within the boundary of each Command. Local Area Commanders routinely explore options to maximise police coverage across LACs.

- *4861 OVER 55'S HOUSING PROPERTIES IN THE WALLSEND ELECTORATE—Ms Sonia Hornery asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) How many public housing properties in the Wallsend electorate are designated for Over 55's?
 - (2) How many tenants in the properties designated for Over 55's are under the age of 55?
 - (3) Are existing tenants consulted or advised if the 'Designated for Over 55's' criteria is amended to allow younger tenants to reside in these properties?

Answer-

Properties that are subject to the State Environmental Planning Policy (Housing for seniors or people living with a disability) 2004 are for:

- Clients over 55 years of age;
- Clients who receive a disability support pension (regardless of age);
- · Aboriginal and Torres Strait Islander clients who are 45 years of age or over;
- A client whose partner (married or de facto) is aged over 55 years or receives a disability support pension.

FACS builds and refurbishes homes so tenants with a disability or older people are able to live safely and comfortably. Social housing applicants are matched to accommodation suitable to their needs.

*4862 CHANGES TO THE PENSION—Ms Sonia Hornery asked the Minister for Finance, Services and Property—

- (1) Should flagged changes to pensions by the Commonwealth Government go ahead, will individuals no longer eligible for the pension lose access to discounts on New South Wales Government services such as car registration, local government rates etc?
 - (a) If so, how many pensioners would be impacted by the changes?

Answer-

On the 1 January 2017, the Commonwealth Government introduced changes to pension concessions. The Government relies on the Commonwealth Government to provide information on who is eligible to receive pension concessions.

Enquires about the eligibility requirements for pension concessions should be directed to the

Commonwealth Government.

*4863 DESIGNATED REDUCED ACTIVITY PERIODS AT JOHN HUNTER HOSPITAL—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

Which 2017 calendar dates at the John Hunter Hospital are designated as 'reduced activity periods'? Answer—

All HNE LHD hospitals, including John Hunter Hospital, comply with mandatory NSW Health Policy PD2012_038 Surgical Activity During Christmas/New Year Policy, in conjunction with Information Bulletin 182016_050 Christmas closedown Periods for 2016-2018.

1 -6 January 2017 and 25-31 December 2017 are designated reduced activity periods at John Hunter Hospital.

The activity reduction does not affect patient access to emergency care and treatment

*4864 HUNTER REGION FIRE SERVICES—Ms Sonia Hornery asked the Minister for Police, and Minister for Emergency Services—

(1) Will the funding of fire services in the Hunter be maintained in real terms?(a) If not, by what amount will the budget be decreased or increased?

Answer-

Fire & Rescue NSW (FRNSW):

The Hunter region has benefited from the overall increase of over \$13 million in the FRNSW 2016-17 budget. The Government has delivered new FRNSW stations at Salamander Bay and Rutherford, with major renovations completed at Tea Gardens, Merriwa and Cardiff. New stations have also been funded for Maryland and Murrurundi and Abermain.

In May 2016, construction was completed at Lambton on the new Metropolitan North emergency services hub. The complex now includes Area and Zone offices, trucks and crews from three existing fire stations, and a major incident control centre for bush fires, storms and other major incidents.

Work on Wingham Fire Station is complete and the Newcastle Communications Centre has received major renovations worth almost \$3.5 million. New firefighting trucks have also gone to Salamander Bay, Minmi, Morisset, Cessnock, Scone, Muswellbrook and Lambton, with a CAFS pumper at Cardiff.

NSW Rural Fire Service (NSW RFS):

The NSW RFS budget has also increased by almost \$11 million in 2016-17.

Recent NSW RFS investment in the Hunter Region has included, the provision of new Fire Control Centres, Brigade Station improvements, and provision of new fire appliances and support vehicles. NSW RFS Districts comprising the greater Hunter Region have seen investment of over \$2.5 million in Brigade Stations and Fire Control Centres, and over \$3 million for Brigade Tankers and Appliances in 2016-17.

*4865 SAINT JOHN'S COLLEGE ACT-Mr Paul Lynch asked the Minister for Education-

- (1) Have you received a request to amend the Saint John's College Act?
 - (a) If so, what does the amendment seek to do?
 - (b) If so, what is your response to the request?

Answer-

(1) Yes.

- (a) I'm advised the request seeks various changes to the Act, particularly to the composition and selection process for members of the College Council.
- (b) Since St John's College is a private institution, it is important there be broad agreement in the College community about any amendments to the St John's College Act 1857.

*4866 RESOURCES FOR THE NSW PRIVACY COMMISSIONER—Mr Paul Lynch asked the Attorney General—

What steps will you take to remedy the resource constraints on the role of the NSW Privacy Commissioner, especially as identified in her most recent Annual Report?

Answer—

The Government will continue to provide the Information and Privacy Commission with the support it

needs to deliver high levels of service to the community. *4867 NSW JUSTICES ASSOCIATION-Mr Paul Lynch asked the Attorney General-What is your response to the request by the NSW Justices Association to be provided with assistance in the provision of an office and training accommodation? Answer-There are four Justice of the Peace membership associations in New South Wales each of which operate independently of government. Justices of the Peace in New South Wales are not required to join an association. *4868 WOLLONGONG HARBOUR MASTER PLAN-Mr Paul Scully asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry-(1) Has the Government agreed to commence the process of a master plan for the Wollongong Harbour? (a) If so, what is the intention of the master plan process for Wollongong Harbour? (2) Have consultations in developing the master plan started? (3) What individuals and organisations have been consulted so far in the development of the master plan? (4) What is the scheduled timeframe for consultations to be completed for the master plan? (5) When will departmental officials brief me on the master plan process as I requested in a letter to the Minister's predecessor on 13 December 2016 and to the new Minister on 30 January 2017? Answer-This is a matter for the Minister for Lands. *4869 MEETINGS OF THE CABINET IN WOLLONGONG—Mr Paul Scully asked the Premier— (1) How many times has the New South Wales Cabinet met within the Wollongong Local Government Area since March 2011 (to 21 February 2017)? (2) What were the dates and venue of these New South Wales Cabinet meetings? (3) Does the Premier intend for the New South Wales Cabinet to meet in the Wollongong Local Government Area before March 2019? (a) If not, why not? (4) Where does the Premier purchase her coffee when in Wollongong? Answer-(1) to (3) The Government has held offsite Cabinet meeting across a variety of locations throughout the State. Future locations will be decided in due course. (4) I recently enjoyed a skim mocha from Bull and Bear on Victoria Street. I hope you support this wonderful local business. *4870 M1 MOTORWAY IMPROVEMENTS BETWEEN FIGTREE AND DAPTO—Mr Paul Scully asked the Minister for Roads, Maritime and Freight-(1) What is the status of the Roads and Maritime Services (RMS) project for future improvements to the M1 Motorway between Figtree and Dapto? (2) What is the outcome of the preliminary survey work and preliminary environmental investigation mentioned on the RMS website? (3) What preliminary design work and traffic modelling is currently being planned by the RMS? (4) Which parts of the M1 Motorway road network have been subject to preliminary works for this RMS project? Answer-This information is available on the Roads and Maritime Services website. *4871 SYDNEY WATER BUSINESS EFFICIENCY COSTS—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council-What are the details of the \$69 million in Business Efficiency costs (referred to on page 28 of the Sydney Water Annual Report 2015-16)? AnswerSydney Water invested \$69 million in business efficiency projects in 2015-16, most of which are information technology programs, which build business capability and efficiencies. Projects largely offer a positive return on investment through delivering operating efficiencies and enhanced business processes.

*4872 ISSUES RELATING TO PRIVACY BREACHES IN SYDNEY WATER ANNUAL REPORT—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What were the circumstances surrounding the four complaints or issues relating to privacy breaches mentioned on page 65 of the Sydney Water Annual Report 2015-16?

Answer—

The four complaints were regarding the alleged breached to personal information and were handled in a manner consistent with New South Wales privacy laws. There was no evidence to suggest Sydney Water breached privacy legislation in any of the cases. Each case was resolved satisfactorily and an recommendations resulting from the outcomes have been put in place.

- *4873 ANNUAL REPORT STATEMENT—Mr Chris Minns asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
 - (1) Does the Minister agree with Sydney Water's statement on page 29 of the Annual Report 2015-16 that "Gearing (debt divided by debt plus equity) remained relatively flat " considering it increased in 2015-16 by \$620 million?
 - (a) If the Minister agrees with Sydney Water that a \$620 million increase in debt is "relatively flat", what number would the Minister nominate as 'above trend' in terms of debt gearing?

Answer-

Gearing, measured as debt divided by debt plus equity, increased from 48.8 per cent in 2014-15 to 49.2 per cent in 2015-16. The 0.4 per cent increase in gearing is considered to be 'relatively flat'. The increase in debt in 2015-16 was accompanied by a similar increase in equity, mostly due to higher system asset values.

*4874 PROTECTION FOR TEACHERS AGAINST VIOLENT STUDENTS—Ms Sonia Hornery asked the Minister for Education—

Considering that in the first half of 2016, there were 264 incidents in Hunter schools (across the region's 10 Principals Networks) related to violence, drug use, weapons, welfare and use of technology, what measures are being implemented to protect teachers and students from violence?

Answer—

Our schools are among the safest places in the community, however, from time to time, incidents do affect schools just as they do affect the community and society as a whole.

The Department of Education has taken action to increase school awareness of the need to report all incidents so that appropriate support and advice is provided to staff and students.

- *4875 MERRYLANDS COMMUNITY HEALTH CENTRE—Ms Julia Finn asked the Minister for Health, and Minister for Medical Research—
 - (1) For each of the past four financial years (to 21 February 2017) how many patients were assisted by Merrylands Community Health Centre in the following fields:
 - (a) Child and Family Health Nursing including home visiting for all new parents;
 - (b) Early Childhood Health clinics, support with infant feeding and parenting, developmental screening, parenting groups;
 - (c) Counselling services for children, families and adults;

The Merrylands Community Health Centre provides a range of services in the Holroyd and Parramatta areas to children, young people and their families.

Services offered range from health promotion, prevention and early detection to assessment and treatment.

Integrated and Community Health staff work in partnership with General Practitioners, hospitals, nongovernment agencies and other organisations to provide care at the Community Health Centre, in people's homes or in other venues, such as Early Childhood (Baby Health) Centres and schools.

Integrated and Community Health is unable to extract the number of individual patients at early childhood clinics. The number of patients attending Early Childhood Clinics was not available.

Answer—

The Government's commitment to develop, implement and evaluate policy with our First peoples is well documented in OCHRE, the Government's plan for Aboriginal affairs.

As the strongest policy commitment to date to principles of self-determination for Aboriginal communities in NSW, OCHRE is fundamentally changing the way the Government does business with Aboriginal communities.

Numerous reports criticise previous governments for the lack of discipline and patience needed to rigorously evaluate programs in the Indigenous policy area, the Productivity Commission's 2016 Overcoming Indigenous Disadvantage report is just one example.

Whilst OCHRE was published in April 2013, the commitment to localised community-specific approaches meant taking time for genuine co-design and implementation planning in partnership with Aboriginal communities. There would have been no value or purpose served in commencing the evaluation of OCHRE until the initiatives were matured enough to be evaluated.

The evaluation of OCHRE needs to be both independent and ethical and for the first time, the evaluation of a Government Aboriginal affairs plan has received ethics approval from the Aboriginal Health and Medical Research Council.

The Government has developed a new model for conducting research and evaluation with Aboriginal communities in New South Wales. Never before have the measures of success, what data is to be collected and how it is to be analysed, been determined by Aboriginal communities.

The Government is listening to its Aboriginal community partners and will continue to take the time necessary to ensure our approach to the evaluation of OCHRE remains respectful and ethical.
