Under the Decade of Decentralisation policy, there is a long-term target to relocate 1,500 targeted to regional New South Wales by 2021.

I am advised that Government agencies are progressing this election commitment and that over half the 1,500 target positions have already been relocated or identified for relocation. This includes:

- relocating 300 positions to Gosford from the Department of Finance, Services and Innovation over the next four years;
- relocating up to 50 positions to Queanbeyan from the Department of Finance, Services and Innovation over the next three years;
- investigating locating the maintenance facilities of a new XPT rail fleet outside of Sydney; and
- creating 50 jobs in Queanbeyan to establish a Rural Education Hub.

The Government is committed to encouraging job growth in our regions and making it easier to private industry to invest in and grow our regional economies.
