#### **11 SEPTEMBER 2013**

(Paper No. 176)

- \*4508 UNIVERSITY INTERNS IN THE HUNTER REGION—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—
  - (1) How many university interns did the Department of Family and Community Services recruit for unpaid placements in the Hunter Region in 2012-13?
  - (2) How long were the unpaid placements?
  - (3) Did these interns do the work of caseworkers, including removing children from unsuitable homes?

#### Answer-

A number of student placements were undertaken in the Hunter Region in 2012-13 by Newcastle University students, as they have been in previous years. Placements and timeframes are coordinated with the university. Students work within an agreed learning contract under the supervision of both Community Services and the university.

\*4509 PUBLIC HOUSING MAINTENANCE WAITING TIME IN WALLSEND ELECTORATE—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—

What is the average waiting time for the resolution of maintenance issues in public housing properties in the Wallsend electorate?

Answer-

Time frames for responsive repairs vary depending on the urgency of the matter.

Approximately 90 per cent of works orders issued are completed within agreed time frames, with the balance being resolved shortly after. Delays may be a result of property access issues and unforeseen site conditions.

- \*4510 HUNTER TRANSPORT PLAN—Ms Sonia Hornery asked the Minister for Transport—
  - (1) When will the Hunter Transport Plan be released?
  - (2) Will the new timetable include an express train service between Newcastle and Sydney?

Answer—

I am advised:

- (1) The Hunter Regional Transport Plan will be released before the end of the year.
- (2) The new timetable will be implemented on 20 October 2013 and provide an additional 70 express services between Newcastle and Sydney.
- \*4512 WORKCOVER INDEPENDENT REVIEW OFFICE BUDGET—Ms Sonia Hornery asked the Minister for Finance and Services—
  - (1) What was the 2012-13 budget provided to the WorkCover Independent Review Office to review compensation cases?
  - (2) How much of this budget was spent on the review of compensation cases?

Answer—

- (1) The WorkCover Independent Review Office was not part of the 2012-13 Treasury budget papers, as it was not enacted until after the budget cycle had been completed.
- (2) \$1.4 million was spent in 2012-13 by the WorkCover Independent Review Office in reviewing work capacity decisions and providing access to free independent legal advice to injured workers.
- \*4513 BALMAIN HOSPITAL HOMEOPATHY CLINIC COST—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

In the 2012-13 financial year;

- (1) How many full time equivalent staff were employed by the homeopathy clinic at Balmain Hospital?
- (2) How many patients were seen at the clinic?
- (3) What was the total cost of the clinic?
- (4) What was the total cost of the clinic to NSW Health?

Answer—

I am advised:

The Homeopathy Clinic was established in August 1990 following the closure in 1989 of the Sydney Homeopathy Hospital in Glebe. The Homeopathy Clinic was, and continues to be, funded through the William Moore Estate special purpose and trust fund established to solely fund Homeopathy Services. There are no costs to NSW Health.

In the 2012-13 financial year, the homeopathy clinic at Balmain Hospital employed the equivalent of 0.51 FTE per week. This consisted of 0.26 FTE of Administration staff and 0.25 GP VMOs. In the 2012-13 financial year, 340 clients were seen at this clinic.

- \*4514 BALMAIN HOSPITAL HOMEOPATHY CLINIC—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
  - (1) What conditions are treated by the homeopathy clinic at Balmain Hospital?
  - (2) How are patients referred to the homeopathy clinic?
  - (3) What oversight of clinical care at the homeopathy clinic is performed by the Central Sydney Local Health District?
  - (4) Does this clinic support NSW Health policies regarding:
    - (a) Fluoridation of the water supply?
    - (b) Immunisation?

#### Answer-

I am advised:

- (1) and (2) Patients are self-referred to the homeopathy clinic at Balmain Hospital. Conditions treated at the clinic include:
  - · Hayfever
  - · Irritable bowel
  - · Allergies
  - · Perimenopausal and postmenopausal symptoms
  - · Chronic back pain,
  - · Headaches,
  - · Post viral fatigue,
  - · Chronic fatigue syndrome,
  - · Chronic otitis media
- (3) Balmain Hospital, as a part of Sydney Local Health District, provides oversight of clinical care by conducting the following:
  - · Annual performance appraisals
  - · Credentialing and reappointment by the Medical and Dental Appointments Advisory Committee
  - · All incidents and complaints are documented and investigated by Balmain Hospital management and reported to the Sydney Local Health Executive if required
  - · As a part conditions of employment, all VMO General Practitioners must comply with all NSW Health policies and Australian Health Practitioner Regulation Agency registration.
- (4) Yes.
- \*4515 SYDNEY SOUTH WEST AREA HEALTH SERVICE COMMUNITY PAEDIATRICS STAFFING—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

How many full time equivalent employees are currently employed in the combined area department of Community Paediatrics are;

- (a) Staff specialists?
- (b) Career medical officers?
- (c) Registrars?

#### Answer-

I refer the Member to the answer to LA Question 4516.

\*4516 CENTRAL SYDNEY AND SOUTH WESTERN SYDNEY COMMUNITY PAEDIATRICS STAFFING—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the division of Sydney South West Area Health Service into separate districts:

(1) How many full time equivalent staff will be employed in Community Paediatrics in the Central Sydney Local Health District as:

- (a) Staff specialists;
- (b) Career medical officers;
- (c) Registrars?
- (2) How many full time equivalent staff will be employed in Community Paediatrics in the South Western Sydney Local Health District as:
  - (a) Staff specialists;
  - (b) Career medical officers;
  - (c) Registrars?

#### Answer-

Since 2011, there has been an Inter-District Agreement (IDA) regarding Community Paediatrics across the two Local Health Districts. A review has been conducted to determine the most appropriate structure, noting population estimates.

Given the complexities associated with clinical and corporate governance and future service developments, services will be split into two teams, effective later this year.

- \*4517 SYDNEY SOUTH WEST AREA HEALTH SERVICE COMMUNITY PAEDIATRICS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
  - (1) When is the Sydney South West Area Health Service Department of Community Paediatrics being divided between two separate local health districts?
  - (2) Has the Minister considered keeping the Department of Community Paediatrics combined across the two local health districts and managing it as a single department?

## Answer-

I refer the Member to the answer to LA Question 4516.

- \*4518 OUT OF HOME CARE PROVIDERS REPORTING—Dr Andrew McDonald asked the Minister for Family and Community Services, and Minister for Women—
  - (1) What is the average ratio of caseworker to clients at Out of Home Care (OOHC) providers?
  - (2) What data are OOHC providers required to report to Family and Community Services?
  - (3) Are OOHC providers required to report on:
    - (a) Stability of placements;
    - (b) Time spent with clients;
    - (c) Number of case workers per client?
  - (4) What feedback has the Government received from out of home care providers regarding the OOHC transition?
  - (5) Has the Government received any correspondence from OOHC providers regarding the inadequacy of the unit cost process for out of home care?

#### Answer—

- 1. The Auditor General reported the Community Services caseworker to child ratio as 1:25 in 2011-12.
- 2 3. OOHC providers are required to provide specific data about the children in their care for the OOHC Minimum Data Set (MDS) via an online portal available on the Community Services website.
- 4 5. Community Services recently held a series of Service Sector Development Forums across New South Wales where leaders from the OOHC NGO sector actively participated and explored the next steps in developing and building a responsive, sustainable and vibrant sector. The feedback received from these Forums has informed and contributed to recent strategic planning for the next phase of OOHC transition.
- \*4519 OUT OF HOME CARE PROVIDERS ACCOUNTABILITY—Dr Andrew McDonald asked the Minister for Family and Community Services, and Minister for Women—
  - (1) What oversight and accountability mechanisms are in place for Out of Home Care (OOHC) providers?
  - (2) How does the Department ensure the quality of OOHC provision?
    - (a) How is the quality of carer provision measured?
  - (3) Is there an independent group within Family and Community Services (FACS) responsible for OOHC oversight and accountability?
    - (a) If yes, how many full time equivalent employees are in this group?
    - (b) Does this group or any other group undertake unannounced visits to foster care providers as an oversight mechanism?

- (4) What investigations did FACS undertake following the drowning of a toddler in a pool at his foster home as reported in the Sydney Morning Herald on 13 June 2013?
  - (a) Is the carer who was responsible for this child still a foster carer?
  - (b) If so, how many children are in their care?
  - (c) Have there been any sanctions placed on the OOHC provider who placed or supervised the placement of this child?
- (5) How many New South Wales OOHC providers are not accredited?

#### Answer-

- (1) OOHC providers must comply with a number of legislative, statutory and service specifications. These mechanisms are monitored by a number of independent Government agencies, including the Office of the Children's Guardian and the NSW Ombudsman.
- (2) All OOHC providers must be accredited with the Office of the Children's Guardian and must demonstrate capabilities against the NSW Standards for Statutory OOHC. Details are available on the Guardian's website, http://www.kidsguardian.nsw.gov.au/
- (3) The Department of Family and Community Services manage Performance Monitoring Frameworks through contracts. This includes an annual formal performance review. The NSW Ombudsman independently reviews service delivery and allegations of a child protection nature. It also coordinates the Official Community Visitors scheme which visits OOHC providers. The Office of the Children's Guardian also visits OOHC providers.
- (4) A number of safety and wellbeing assessments have been undertaken, including an internal Community Services' review. The death was also the subject of a Coronial Inquest.
- (5) See answer 2, above.
- \*4520 LIQUOR LICENCING IN CHIPPENDALE—Mr Alex Greenwich asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the Arts—
  - (1) How many liquor licences have been issued to premises in Chippendale?
    - (a) How many of these premises are considered high impact?
    - (b) How many of these premises are late trading?
  - (2) How many liquor licence applications are currently pending for premises in Chippendale?
    - (a) How many of these premises are considered high impact?
    - (b) How many of these premises are late trading?
  - (3) How many complaints against liquor outlets in Chippendale have been made over the past 12 months?
    - (a) What is the trend in these complaints?
  - (4) What liaison has the Office of Liquor, Gaming and Racing had with Redfern Police and City Central Police about licensing complaints in Chippendale?
  - (5) What assessment has the Government made of the cumulative impacts of these licenced premises in Chippendale?
  - (6) What conditions have been imposed on Chippendale licenced premises in response to community impacts?
  - (7) What further action will the Government take to ensure protection of residential amenity and safety?

#### Answer—

(1) For the purpose of this response, the suburbs of Darlington and Chippendale have been combined as both have a postcode of 2008.

As at 23 September 2013 there are a total of 41 licensed premises in the 2008 postcode, comprising:

- 5 full hotels
- 3 general bars
- 26 on-premises licences
- · 5 packaged liquor licences, and
- 2 producer/wholesaler licences.
- (a) A premises may be considered "high impact" if it has the potential for a high risk of alcohol related crime. That being the case, the five (5) hotel licences may fall into that category.
- (b) Of the five (5) full hotel licences, two (2) have extended trading authorisations.
- (2) As at 24 September 2013, there are four (4) applications pending for the 2008 postcode three (3) on-premises licences and one (1) producer/wholesaler.
  - (a) Nil
  - (b) Nil

- (3) The Office of Liquor, Gaming and Racing (OLGR) has received one (1) complaint since 1 September 2012. The complaint alleged noise from a hotel was disturbing the quiet and good order of the neighbourhood. In response to the concerns, the hotel implemented noise amelioration measures which resolved the matter.
  - (a) A trend cannot be identified as only one complaint has been received.
- (4) The OLGR regularly engages and interacts with local police, local councils and other external stakeholders to monitor compliance levels and achieve resolution of complaints and noise disturbance issues.
- (5) In 2012, the OLGR in conjunction with Independent Liquor and Gaming Authority ILGA, commissioned research into the cumulative impact of licensed premises within New South Wales. Arising from that research the Environment and Venue Assessment Tool (EVAT) was developed to assist with the determination of new liquor licence applications. This tool is currently being trialled in the Sydney (including Chippendale) and Newcastle Local Government Areas.
- (6) The Independent Liquor and Gaming Authority (Authority) considers each application on its own merit as matters raised as issues of concern as part of the CIS (Community Impact Statement) consultation can vary considerably.

The Authority often imposes a "low impact" condition on approvals that did lodge either a Category A or Category B CIS as the condition states

"... The business authorised by this licence must not operate with a greater overall level of social impact on the well being of the local and broader community than what could be reasonably expected from the information contained in the Community Impact Statement, application and other information submitted in the process of obtaining this licence/authorisation."

Other conditions that may be imposed could include, but not be limited to:

- the standard noise condition
- CCTV
- · joining the local liquor accord
- keeping an Incident Register.
- (7) The Liquor Act currently provides a number of mechanisms to facilitate community consultation and avenues for residents to make a complaint should the quiet and good order of the neighbourhood of licensed premises be unduly disturbed.
- \*4521 FREE RANGE EGG LABELLING AUDITS—Mr Alex Greenwich asked the Minister for Primary Industries, and Minister for Small Business—
  - (1) How many egg producers in New South Wales were audited in the 2012-13 financial year?
  - (2) Does the NSW Food Authority inform egg producers of audits in advance or are they unannounced?
  - (3) How many egg producers were found to have incorrectly labelled their eggs as free range?
  - (4) What action has been taken against egg producers found to have incorrectly labelled eggs?
  - (5) What standard does the NSW Food Authority use to determine whether eggs are produced in free range conditions?

## Answer-

- (1) The NSW Food Authority (the Authority) conducted audits and inspections on 100 egg producers in the 2012-13 financial year.
- (2) Audits and inspections conducted on licensed egg producers are conducted on an unannounced basis except in cases where notification is required to ensure that officers can access facilities and comply with animal health and quarantine restrictions.
- (3) In 2012 one producer was found to have incorrectly labelled eggs as free range.
- (4) A penalty notice was issued to a producer in 2012 for incorrectly labelling eggs as free range. This licensed egg producer received further inspections to ensure all eggs were correctly labelled.
- (5) The Authority enforces Clause 2.1.2.3 of the "Model Code of Practice for the Welfare of Animals: Domestic Poultry, 4th Edition".
- \*4522 ANTI-DISCRIMINATION TAFE NSW REQUIREMENTS—Mr Alex Greenwich asked the Minister for Education—
  - (1) What legal requirements do TAFE NSW colleges have to prevent or address discrimination under the Anti-Discrimination Act?
  - (2) What legal requirements do private education providers have to prevent or address discrimination under the Anti-Discrimination Act?
  - (3) What resources does the Government provide to enable TAFE NSW to meet these responsibilities?

- (4) What assessment has been made of non-discriminatory access to adult and vocational education under reforms to TAFE NSW?
- (5) What further action will the Government take to ensure non-discriminatory access to adult and vocational education?

#### Answer-

- (1) Under the NSW Anti-Discrimination Act 1977, TAFE NSW is an educational authority. The Act makes it unlawful for the staff (and students over the age of 16) of an educational authority to engage in sexual harassment and for the authority to discriminate against students in education on the grounds of race, sex, transgender, marital or domestic status, disability, homosexuality or age.
- (2) Under the NSW Anti-Discrimination Act 1977, private educational authorities are exempt from some obligations, such as the provisions making sex discrimination in education unlawful. The only obligations under the Act that apply to private providers in their capacity as education providers relate to racial discrimination and sexual harassment.
  - The Commonwealth Disability Discrimination Act 1992 and Disability Standards for Education 2005 apply to private providers.
- (3) TAFE NSW does not receive separate funding for legislative responsibilities. The total funding received by TAFE NSW includes meeting these responsibilities.
- (4) People will be able to access training under Smart and Skilled, including through TAFE NSW, as long as they meet the eligibility criteria which are being aged 15 years or over, having left school, not having a Certificate IV or higher level qualification, and to be living or working in New South Wales
- (5) Approved providers under Smart and Skilled reforms will be required to:
  - comply with all relevant legislative and regulatory requirements
  - have established, documented and accessible consumer feedback and complaints handling policies and procedures
  - have an identified consumer protection officer
  - provide learners with details of an organisation's processes and pathways for resolving or escalating complaints.
- \*4523 PEDESTRIAN SAFETY IN OXFORD STREET PADDINGTON—Mr Alex Greenwich asked the Minister for Transport representing the Minister for Roads and Ports—
  - (1) What is the estimated number of pedestrians who use the signalised pedestrian crossing outside the Sydney electorate office in Oxford Street Paddington each day?
  - (2) What data does the Government have about accidents and pedestrian deaths or injuries at this crossing?
  - (3) What evidence does the Government have of motorists driving through red signals or performing illegal U-turns at this crossing?
  - (4) What assessment has the Government made of pedestrian safety at this crossing?
  - (5) What action has been taken in response to concerns for pedestrian safety at this crossing?
  - (6) What further action will the Government take to protect pedestrian safety at this crossing?

#### Answer—

#### I am advised:

- (1) Roads and Maritime Services records show, for the week ending 20 September 2013, the pedestrian crossing outside the Sydney electorate office in Oxford Street was activated an average 468 times per day. Roads and Maritime Services has no method of recording the number of pedestrians using the crossing.
- (2) During 2008 to 2012, there have been five reported crashes within 30 metres of the traffic lights on Oxford Street outside the Sydney electorate office. None of these reported crashes involved pedestrians. (Note: Roads and Maritime Services only report crashes where one or more people were killed or injured, or at least one vehicle was towed away.)
- (3) There has been one reported crash during 2008 to 2012 involving a vehicle making an illegal U-turn at the traffic lights on Oxford Street (crash location 85 metres west of Greens Road). Information on traffic infringements is held by the NSW Police Force.
- (4) (6) Roads and Maritime Services has inspected the site and found the line marking needs replacing, due to Ausgrid restoration works, and has arranged to have this rectified.
  - These traffic lights have five sets of displays on each approach and meet the necessary requirements.

- (1) Has the Minister had any requests to meet with the Public Service Association regarding concerns about public passenger services?
  - (a) If so, how many requests has the Minster received?
  - (b) If so, has the Minister met with the Public Service Association?
    - (i) If not, why not?
- (2) Will passenger safety be compromised by dividing public passenger services between three general managers within Roads and Maritime Services?
- (3) Are these new roles more generic in nature rather than being specific roles dealing with the Passenger Transport Act 1990 and Passenger Transport Regulation 2007?
- (4) Why were experts who act to protect and enhance passenger safety moved from Transport for NSW to Roads and Maritime Services?
- (5) Why have you retained the Wollongong and Newcastle offices within Transport for NSW, given that they carry out passenger safety functions?

Answer-

I am advised:

- (1) It is inappropriate for me to comment on meeting requests which I may or may not have received.
- (2) (5) This is a matter for the Minister for Roads and Ports.
