*4199 RECOMMENDATIONS OF A JOINT REGIONAL PLANNING PANEL—Mr Anoulack Chanthivong asked the Minister for Planning—

Does the Minister have the authority and power to reject a recommendation of a Joint Regional Planning Panel?

Answer-

The provisions relating to the responsibility of the Minister for Planning and the Joint Regional Planning Panel are set out in the Environmental Planning and Assessment Act 1979, Environmental Planning & Assessment Regulation 2000 and relevant EPIs and guidelines made under the legislation.

- *4215 MAITLAND POLICE STATION—Ms Jenny Aitchison asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—
 - (1) How many allocated staff at Maitland Police Station are available to attend to incoming calls to the station?
 - (2) How many times in 2016 has there not been ample staff to answer calls to Maitland Police Station phones?
 - (3) Is this due to shortage of staff?
 - (a) If so, when will more staff be allocated to Maitland Police Station?
 - (b) If not, what is the government doing to ensure calls to Maitland Police Station don't go unanswered?

Answer-

I am advised:

Operating hours of police stations and staffing arrangements within a Local Area Command (LAC) vary according to operational requirements. Maitland Police station is open 24 hours a day.

LACs provide a 24 hour mobile policing response to all areas within the boundary of each Command and aim to have an adequate number of police officers rostered on duty to match expected demand.

Since May 2011, 29 Probationary Constables have been allocated to the Central Hunter LAC, which polices the Maitland area. As at 31 August 2016, the Central Hunter LAC had an authorised strength of 157.

- *4216 WESTCONNEX CONSTRUCTION WORKERS PARKING—Ms Jo Haylen asked the Minister for Planning—
 - (1) What is the current state of the public transport plan for construction workers promised in the Westconnex M4 East Environmental Impact Statement?
 - (2) Can the Minister confirm whether construction vehicles have been parking in the parts of Reg Coady Reserve accessible to the public?
 - (3) How many complaints has the Government received regarding construction workers for the project parking in Haberfield and Ashfield?

Answer-

- (1) The EIS states that '[t]he construction workforce would be encouraged to utilise public transport'. The Proponent is required to implement the approved Construction Traffic and Access Management Plan that forms part of the Construction Environmental Management Plan, which includes measures to manage this issue.
- (2) The Department of Planning and Environment is not aware of, and has not received complaints about, construction vehicles parking in the parts of Reg Coady Reserve accessible to the public.
- (3) The Department of Planning and Environment has received 10 complaints about construction parking on the M4 East project in these areas.

*4217 HERITAGE ITEMS FROM HERITAGE HOMES ACQUIRED FOR WESTCONNEX—Ms Jo Haylen asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

Can the Minister confirm that all owners of heritage properties acquired for Westconnex were contacted about obtaining heritage items from their former homes before those items were made available to the public through the lottery system?

Answer-

I am advised:

Of the 23 properties identified by the heritage consultant as having salvageable items of heritage value, five former owners were unable to be contacted despite the best efforts of the project team. In instances where former owners had relocated and not provided forwarding contact details, the project team contacted their solicitors (where details were available) in an attempt to make contact with former owners but had no success in five cases.

In addition to the direct contact efforts, the project team conducted extensive consultation and promotion of the heritage salvage process throughout local newspapers, on the WestConnex website, at Inner West Council, during community forums and via letterbox drops and community updates to help ensure local residents were aware of the initiative.

Items labelled Supplementary in the catalogue were not identified as having heritage value but were salvaged as part of the process. These were also made available to the community.

- *4218 TREATMENT FOR A STROKE PATIENTS AT HOSPITALS—Ms Jenny Aitchison asked the Minister for Health—
 - (1) In the first few hours after a stroke, is early intervention treatment for a stroke patient available at all hospitals?
 - (a) If not, is this treatment available at Maitland hospital?

Answer-

I am advised:

NSW Health takes a multidisciplinary approach to the delivery of stroke services that includes NSW Ambulance, emergency departments, neurologists, neurosurgeons, radiologists and a range of other clinical specialties working together to get the best patient outcomes.

I refer you to The NSW Stroke Reperfusion Program: Early Access to Stroke Thrombolysis for further information.

- *4219 PROCEEDINGS AGAINST CURRENT OR FORMER CORRECTIONAL OFFICERS—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—
 - (1) Since 2011, on how many occasions has Corrective Services NSW pursued legal proceedings against current or former correctional officers as a result of their alleged misconduct or other offences?
 - (a) On how many occasions were the correctional officers found guilty?

Answer-

None. It is not the role of Corrective Services NSW (CSNSW) to pursue legal proceedings against any current or former correctional officer.

Claims of improper conduct by CSNSW staff are referred to its Professional Standards Committee for consideration and recommendation on appropriate action. This action can

include referring the matter to the NSW Police Force, if appropriate. If charges are laid, the police will undertake a criminal prosecution in the courts.

*4220 FIRE AND RESCUE CALL OUTS TO NEW SOUTH WALES CORRECTIONAL CENTRES—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

How many call outs have been made by Fire and Rescue New South Wales to assist with cell fires in NSW correctional centres in each year from 2011 to 2016 (as at 13 October 2016)?

Answer—

*4221 PROTECTIVE CLOTHING PROVIDED TO CORRECTIONAL OFFICERS—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

Other than smoke hoods, what other protective clothing is provided to correctional officers in the event they are required to combat a fire within a cell or other part of the correctional centre?

Answer—

No other protective clothing is provided to correctional centres, as they are expected only to extinguish fires where reasonably possible and where no danger exists to any person. Structural fire fighting is a matter for a professional fire fighting agency whose staff have the necessary equipment and apparel.

*4222 FIRE FIGHTING TRAINING PROFESSIONAL DEVELOPMENT—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

How often are correctional officers required to undertake professional development with regards to fire fighting training?

Answer-

Fire fighting training is a requirement of correctional officer primary training. Once assigned to a correctional centre, correctional officers receive regular on-site training to ensure they have the skills and knowledge to extinguish small fires in a safe manner.

- *4223 STATE EMERGENCY SERVICES UNITS IN NEW SOUTH WALES—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—
 - (1) In light of the forced council amalgamations, can you guarantee no State Emergency Services units throughout New South Wales will have their numbers reduced or be forcibly closed?
 - (a) If not, why not?

Answer-

NSW SES units are positioned to provide ongoing high quality emergency services to their communities. Amalgamations of councils have historically not seen a decline in the number of SES Units within individual Local Government Areas (LGAs). There have been long standing examples of multiple NSW SES Units in LGAs, particularly in regional NSW. For example, Tweed Shire has three Units and Richmond River Shire has four Units.

The NSW SES continues to work closely with councils through ongoing amalgamations to ensure standards of service delivery remain in place.

- *4225 PARKING SPACE LEVY—Mr Alex Greenwich asked the Minister for Transport and Infrastructure—
 - (1) What action has been taken on the review of the Parking Space Levy Act required as soon as possible 5 years after assent was given to the legislation?
 - (2) To what purposes have funds from this levy been allocated each year since 2009?
 - (3) What purposes or projects within the Category One area have received funds from the levy each year since 2009?
 - (4) What assessment has the Government made of how well the levy has achieved its aims?
 - (5) What consideration has the Government given to:
 - (a) The boundaries for application of the levy;
 - (b) Category 1 and Category 2 distinction;
 - (c) The districts to which each category applies;
 - (d) The rate at which the levy applies;
 - (e) Exemptions and concessions including for carshare spaces?

- (6) What plans does the Government have to consult about proposed changes?
- (7) When does the Government plan to inform the public about this review?

Answer-

Transport for NSW has commenced the statutory review of the Parking Space Levy Act 2009. A discussion paper has been released for public consultation. Interested stakeholders have been notified and provided with a copy. Information about the Parking Space Levy is available on the Transport for NSW website.

*4226 PARRAMATTA PARK TRUST—Ms Julia Finn asked the Minister for Trade, Tourism and Major Events, and Minister for Sport—

What discussions or meetings have been held between the Minister or the Minister's office with members or staff of the Parramatta Park Trust regarding the proposal for a new stadium which will encroach on Parramatta Park?

Answer—

Neither the Minister nor the Minister's Office has met with Members or staff of the Parramatta Park Trust

*4228 CYCLING TO WORK—Mr Alex Greenwich asked the Minister for Transport and Infrastructure—

With respect to the City of Sydney's Cycling in the City Course, escorted rides to work and recruitment of new bike riders in inner city precincts where buses are full:

- (1) What data does the Government have about the number of people who cycle to work in the inner city and whether it is increasing?
- (2) What assessment has the Government made on the number of inner city residing employees who cycle to and from work in the city centre?
- (3) What data does the Government have about the barriers to more people who reside in the inner city taking up riding to work?
- (4) What assessment has the Government made of programs to increase bike riding for commuters who reside in the inner city?
- (5) What assessment has the Government made of the City of Sydney program recruiting passengers on busy bus routes where buses are regularly full?
- (6) What assessment has the Government made of space that could be freed up on public transport if those able to ride bikes instead of using buses did so?
- (7) What support does the Government provide to CBD employers offering bicycles for short distance travel around the city?
- (8) What support does the Government give to CBD employers providing end of trip facilities?
- (9) What plans does the Government have to encourage more people to cycle to and from the city centre

and around the city where this is possible?

Answer-

Statistical information on cycling is available on the Bureau of Transport Statistics website and the Australian Bicycle Council's website.

Transport for NSW collects information from a number of sources to inform its planning strategies, including Sydney's Cycling Future and the Sydney City Centre Access Strategy. Walking and cycling infrastructure improvements are a key part of the NSW Long Term Transport Master Plan.

As part of the Future Transport Strategy, Transport for NSW will collaborate with councils and cycling advocacy groups. This work includes assisting the Greater Sydney Commission with walking and cycling modelling to inform the strategic direction for draft district plans.

The Government's 2016-17 Budget includes \$284 million over the next four years for walking and cycling. Transport for NSW will continue to work with councils to support targeted investment in walking and cycling projects that improve networks and promote walking and cycling as the best choice for short trips.

- *4230 389 BUS SERVICE RELIABILITY—Mr Alex Greenwich asked the Minister for Transport and Infrastructure—
 - (1) Considering the responses to LA Q2499 from February 2016 and LA Q3091 from May 2016 do not provide any data on service reliability or complaints, how does the Government make information about service reliability and complaints public?
 - (2) How many complaints have been made about cancelled or late running 389 bus services since 4 October 2015?
 - (3) What is the trend in complaints about cancelled or late running 389 bus services?
 - (4) What does Sydney Buses service data show about reliability of 389 bus services?
 - (5) What proportion of buses used on this route are accessible?
 - (6) What action has the Government taken to improve reliability of 389 bus services?
 - (7) Does the Government have any future plans to improve 389 bus service reliability?

Answer-

- (1) Real-time transport information, including service reliability, is available to customers through a number of apps. The Customer Satisfaction Index is available on the Transport for NSW website.

- *4231 WYONG HOSPITAL LANDHOLDING—Mr David Harris asked the Minister for Health—

What is the total landholding (in square metres) owned by the Government/NSW Health at the Wyong Hospital site?

Answer-

I am advised:

Health Infrastructure has advised that in March 2015 the Government announced \$200 million towards the redevelopment of Wyong Hospital.

This project will deliver upgraded facilities at the hospital to provide high quality health care for the communities in Wyong and surrounding areas in the Central Coast including additional acute patient beds, additional intensive care unit beds, upgraded emergency department, additional operating theatres, upgraded outpatient and ambulatory space and additional mental health beds.

I refer you to the Central Coast Local Health District's 2014-15 annual report.

*4232 EXPRESSIONS OF INTEREST FOR WYONG HOSPITAL—Mr David Harris asked the Minister for Health—

How many expressions of interest were received for the proposed Public/Private Partnership for Wyong Hospital?

Answer-

I am advised:

The expressions of interest process for Wyong Hospital closed at 5pm, on 14 October, 2016 and drew a strong response from non-government hospital operators to participate in the partnership program overall.

The process of evaluating the EOIs has now commenced and is expected to be completed in mid-2017.

*4233 AFFORDABLE HOUSING ADVOCACY—Mr Alex Greenwich asked the Treasurer, and Minister for Industrial Relations—

With respect to the Affordable Housing Working Group, which Treasury NSW is leading, as referred in LA Q3798:

- (1) What advocacy has the Government carried out with the Commonwealth Government to increase affordable housing?
- (2) What options is the Government supporting for national implementation and what is the timeline for action?
- (3) What further action is planned to increase affordable housing, particularly in established urban areas like the inner city?

Answer-

- (1) In October 2015, Treasurers at the Council on Federal Financial Relations requested that work be undertaken to identify solutions to improve the supply and provision of social housing. Following this an Affordable Housing Working Group was established, led by Commonwealth Treasury, to investigate innovative ways to improve the availability of affordable housing. NSW Treasury is a member of the working group, along with members from Victoria and Western Australia.
- (2) The report prepared by the Affordable Housing Working Group has not been provided for Government consideration at this stage.
- (3) The Government is committed to addressing housing affordability in New South Wales. Since coming to Government, we have achieved unprecedented levels of housing approvals in New South Wales. There have been over 70,000 residential building approvals in the last 12 months- more than double the annual average under the previous Labor government. In addition, over the last three years, the Government has provided over \$695 million in assistance to new homebuyers. We have also established the \$1.1 billion Social and Affordable Housing Fund- an innovative, ring-fenced source of funds which has been quarantined for social and affordable housing.
- *4234 COMMERCIAL POSTERS REGULATION—Mr Alex Greenwich asked the Attorney General—
 - (1) When will the required review of the Graffiti Control Act 2008 be finalised?
 - (2) What recommendations is the Government considering to address commercial bill posting?
 - (3) What evidence is available about measures that improve enforcement of illegal commercial poster provisions?
 - (4) Does the Government plan to make changes to the Act's commercial bill posting provisions?
 - (5) When does the Government plan to table the review report and its response to the review?

Answer—

I am advised the Department of Justice is working to finalise a review of the Graffiti Control Act ~2008. The Government will consider the recommendations made by the review, including in relation to the issue of commercial bill posting.

*4236 SECTION 31 OF THE IMPOUNDING ACT 1993—Ms Jodie Harrison asked the Minister for Local Government—

Will the Minister consider amending Section 31 of the Impounding Act 1993 to extend infringement notices to the owner of shopping trolleys, not only the individual who abandons the article?

Answer-

Councils have existing legislative options to deal with this issue. Under the Local Government Act 1993 and the Protection of the Environment Operations Act 1997, authorised officers can issue a fine to anyone abandoning a trolley or dumping one in a watercourse.

Under the Impounding Act 1993, councils can impound abandoned trolleys, and charge the relevant retailer a fee for their release.

- *4244 STRATEGIES FOR TREATING CORRECTIONS STAFF SUFFERING POST TRAUMATIC STRESS DISORDER—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

What strategies does Corrections NSW employ to assist staff suffering from Post-Traumatic Stress Disorder?

Answer-

Corrective Services NSW (CSNSW) has established a comprehensive Critical Incident Support Process. All staff involved in a workplace critical incident are informed of the

services available and are given time to attend counselling with a psychologist provided by its Employee Assistance Provider.

A psychologist can be requested to attend the workplace to meet with affected staff within 24 hours of an incident. The psychologist follows up with affected staff. Supervisors also follow up with staff members to monitor and offer support.

A peer support program is also available which can assist to direct staff to appropriate services in the community.

CSNSW promotes the Mental Health Line and Lifeline for staff in crisis as well as the Medicare scheme Better Access to Mental Health Care.

If the condition is covered by an accepted workers compensation claim all reasonable treatment recommended by the nominated treating doctor is covered under the claim.

*4245 STRATEGIES FOR TREATING CORRECTIONS STAFF SUFFERING DEPRESSION—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

What strategies does Corrections NSW utilise to assist staff suffering from depression?

Answer-

Corrective Services NSW (CSNSW) provides free confidential counselling services through its Employee Assistance Provider, and employs a Staff Alcohol, Tobacco and Other Drugs Counsellor who is available for assessments and advice.

A peer support program is also available which can assist to direct staff to appropriate services in the community.

CSNSW promotes the Mental Health Line and Lifeline for staff in crisis as well as the Medicare scheme Better Access to Mental Health Care.

If the condition is covered by an accepted workers compensation claim all reasonable treatment recommended by the nominated treating doctor is covered under the claim.

*4246 CELL FIRES IN NEW SOUTH WALES CORRECTIONAL CENTRES—Mr Guy Zangari asked the Minister for Corrections, Minister for Emergency Services, and Minister for Veterans Affairs—

- *4247 CONTENT OF THE BABY BLUE BOOK HEALTH RECORD—Ms Jo Haylen asked the Minister for Health—
 - (1) What consultations with external organisations does the Department engage in when devising content for the Baby Blue Book Health Record?
 - (2) What is the timeline for consultation for the next edition of the Baby Blue Book?
 - (3) How do organisations indicate their willingness to participate in these consultations?

Answer-

The Personal Health Record (PHR) or the Blue Book is subject to minor reviews each year. Each review has included external participants including clinicians, parents, carers and stakeholder groups.

In 2012, the online consultation attracted over 3000 parents, carers and clinicians providing input to the review. The Personal Health Record has, over time, changed to reflect consumer feedback.

The 2016 review, which is underway, will be complemented by targeted focus groups being held in a

range of locations across New South Wales, with a cross-section of demographic groups.

 - (2) Under what circumstances would councils not have the ability and authority to cancel infringement notices?
 - (3) What level of officer employed by a council has the authority to cancel an infringement notice after issuance?

Answer—

Any queries in relation to processes under the Fines Act 1996 should be referred to the Minister for Finance, Services and Property who is responsible for administering that Act.

- *4250 STAFF FROM LAND AND PROPERTY INFORMATION AND TITLE AND REGISTRY SERVICES—Mr Clayton Barr asked the Treasurer, and Minister for Industrial Relations—
 - (1) How many staff from Land and Property Information (LPI) Title and Registry Services (TRS) are expected to be transferred to the new operator?
 - (a) How many of these are full-time?
 - (b) How many of these are part-time?
 - (2) Will any of the current LPI or TRS full-time and/or part-time staff not be transferred?
 - (a) If so, will they be offered the opportunity for transfer within the public sector to other departments?
 - (3) Following the proposed transfer of LPI and TRS staff, what will be the FTE staffing numbers of LPI, still employed as Government sector public servant employees?

Answer_

- (1) and (2) The Land & Property Information transaction legislation includes a four year employment guarantee for award staff.
- (3) This question would be more appropriately directed to the Hon. Dominic Perrottet MP, Minister for Finance, Services and Property.
- *4251 OUTSIDE OF SCHOOL HOURS CARE CLASSIFICATION—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—

In answer to supplementary questions on notice to the 2016 Budget Estimates hearings the Minister advised that there were 643 Outside of School Hours Care providers in New South Wales, of which 346 were 'not for profit' providers and 208 'for profit' providers. How are the other 89 providers classified if they are neither 'for profit' nor 'not for profit'?

Answer-

The remaining services consist of Catholic, independent and State schools or are run by State, Territory or local Governments.

- *4252 SOCIO-ECONOMIC FUNDING—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—
 - (1) Under the Starting Strong funding model, can you confirm that a child in the most socioeconomically deprived areas in the state would attract \$1200 per year in funding if their parents could afford to send them to preschool for at least 15 hours a week?

- (2) Under the Starting Strong funding model, can you confirm that a child in the most socio-economically deprived areas in the state would receive up to \$2100 less funding than currently if their family can only afford to send them to preschool for less than 15 hours a week?
- (3) Under the Starting Strong funding model, can you confirm that a child in the most socio-economically advantaged areas of the state attending a preschool for at least 15 hours a week would receive an additional \$2400 per year?
- (4) Under the Starting Strong funding model, has funding increased more for the richest areas of the State?

Answer-

- (1) Under Start Strong, the maximum base rate per eligible child enrolled in 600 hours of preschool is \$6,600. This rate applies to all children from Aboriginal and/or low income families. Children in disadvantaged areas (SEIF A bands 1 to 8) will also attract the maximum base rate of \$6,600.
- (2), (3) and (4) Applicable rates are published on the Department of Education's website.
- *4253 PRESCHOOL ENROLMENTS—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—
 - (1) When do most New South Wales preschools undertake their enrolments for the coming year?
 - (2) Would most New South Wales preschools have completed their enrolments for 2017 before the Minister's Start Strong funding announcement was made?
 - (3) Where preschools have already completed their enrolment for 2017, does the Department expect those preschools to not meet the new funding model requirements until they enrol children for 2018?
 - (4) Is the Start Strong funding due to expire in July 2018?
 - (5) What arrangements have been made to give certainty to preschools for long term funding?

Answer—

- (1) and (2) Start Strong was announced during Term 3, 2016. Many services take enrolments during Term 4 for commencement in the following school year. Services can choose to take enrolments at any point during the year.
- (3) Start Strong replaces the Preschool Funding Model from 1 July 2017 with a transition period commencing from 1 January 2017. This transition period allows services additional opportunities to change their business model and enrolments before July 2017.
- (4) and (5) Start Strong relies on a combination of State and Commonwealth funding. New South Wales will continue to work with the Commonwealth to obtain funding certainty and to ensure that funding can be used to support current initiatives including Start Strong.
- *4254 MAMBO WETLAND—Ms Kate Washington asked the Minister for Finance, Services and Property—

Given that the Parliamentary Secretary for the Hunter has described the government's sale of environmentally sensitive land at Salamander Bay, which formed part of the Mambo Wetlands, a "mistake", what steps does the government intend to make to fix its mistake and restore the parcel of land to public ownership?

Answer—

The sale of the land at Salamander Bay is a decision for the Minister for Education.

- *4255 TARGET SAFETY IMPROVEMENTS ON HILLSBOROUGH ROAD, HILLSBOROUGH—Ms Jodie Harrison asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
 - (1) Considering the \$150,000 allocation to Roads and Maritime Services for target safety improvements on Hillsborough Road, Hillsborough, when will the bus stop be reallocated closer to the mid-block pedestrian signals?
 - (2) When will pedestrian fencing be installed along Hillsborough Road?
 - (3) When will additional traffic signals on Medcalf Street be installed?
 - (4) When will community consultation begin for the traffic study of state roads between Warners Bay and Charlestown?

Answer-

(1) The bus stop on Hillsborough Road will be relocated by the State Transit Authority.

- (2) The timeframe for installing pedestrian fencing is unknown at present as Roads and Maritime Services is assessing options for short-term safety improvements for pedestrians on Hillsborough Road east of the roundabout, including pedestrian fencing.
- (3) There are currently no plans to install traffic lights on Medcalf Street. The NSW Government provided \$150,000 for safety improvements involving the reconfiguration of the intersection of Medcalf Street and Ruswell Avenue at Warners Bay. As part of this project, Roads and Maritime installed an extra traffic signal mast arm on to the mid-block pedestrian lights in front of Biddabah Public School, to increase the visibility of lanterns for approaching motorists.
- (4) Roads and Maritime Services expect to release its draft corridor study in November 2016 for community consultation. When this is completed, Roads and Maritime will finalise the corridor strategy and undertake more detailed planning of short term priorities for consideration of future funding.
- *4256 COMMUNITY AND COURT LIAISON SERVICE—Ms Tania Mihailuk asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) How many NSW Local Courts are provided Statewide Community and Court Liaison Service, whether on a full-time or part-time basis as at 13 October 2016?
 - (2) Which local courts are provided that service on a full time basis?
 - (3) Which local courts are provided that service on a part-time basis?
 - (4) Which local court are provided that service via a video link?

What consultation has the Greyhounds Transition Taskforce undertaken with the Arena Sports Club in Yagoona regarding the future use of the Potts Park Greyhound track (as at 13 October 2016)?

Answer—

The operations of the Greyhound Transition Taskforce ceased following the Government's announcement that it would give the greyhound industry one more chance in NSW, subject to it agreeing to the strictest regulations to clamp down on animal cruelty.

The Greyhound Industry Reform Panel assisted by the industry controlling body Greyhound Racing NSW is best placed to consider and provide recommendations to Government in regard to the appropriate club footprint going forward, including the Arena Sports Club in Yagoona.

- *4258 OPERATIONAL SUPPORT PROGRAM—Ms Kate Washington asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—
 - (1) How many preschools were advised under the Department's operational support program last year to increase their fees to remain viable?
 - (a) Of these, how many are now being advised to decrease their fees to comply with the new Start Strong funding agreement?

Answer-

The Operational Support program supports community preschools to more closely align their businesses to the Preschool Funding Model to support sustainability over the longer term. It is delivered by peak non-government organisations and the NSW Small Biz Connect program.

Under Start Strong, community preschools are required to pass through at least 75% of the increased funding to families by lowering their daily fees with priority given to reducing fees for children from low income and/or Aboriginal families.

*4260 NEWCASTLE ATHLETICS FIELD UPGRADE—Mr Tim Crakanthorp asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

On 24 March 2016 you announced \$800,000 in funding to resurface the existing track at the Newcastle Athletics Field. Six months later this work has not started. When do you expect this work to begin and be completed?

Answer-

I am Advised:

Following funding announcements in March 2016, funding deeds were issued to all successful applicants.

The deed for the Newcastle Athletics Field upgrade was executed in July 2016. Newcastle City Council is responsible for project delivery.

- *4261 APPEALING PENALTY NOTICES—Mr Clayton Barr asked the Minister for Finance, Services and Property—
 - (1) Considering the response to LA Q3682 what department collects the data requested?
 - (2) What department can provide a response for the data requested?
 - (3) What data does the Office of State Revenue provide in relation to successfully appealed penalty notices?

Answer—

- (1) and (2) I am advised by the Office of State Revenue (OSR) that it collects data on successful appeals for all offences relating to unregistered driving. The data collected by OSR does not include matters that have been heard in Court and successfully appealed. Data concerning drivers who have successfully appealed their penalty notices but have been involved in accidents is not held centrally.
- (3) OSR provides information that summarises the reasons that penalty notices are cautioned or not actioned.
- *4262 ROADS AND MARITIME SERVICES E-TOLL ACCOUNTS—Mr Clayton Barr asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
 - (1) As at 1 September 2016 how many customers have direct debits from credit cards to top up their E-Toll accounts?
 - (2) Following the decision to recover merchant fees from 1 September 2016, what is the projected amount of funds to be recovered from 1 September 2016 to 30 June 2017?
 - (3) If this fee has previously been absorbed within the RMS E-Toll accounting, has the RMS E-Toll been a profitable area of RMS?
 - (4) If it has been profitable, why has the decision been made to no longer absorb this fee?

Answer-

I am advised:

- (1) 225,253.
- (2) Approximately \$2.4 million.
- (3) and (4) The NSW Government requires all agencies to recoup merchant fees (through surcharging) for payments accepted using debit or credit cards issued by card schemes such as Visa, MasterCard, American Express and Diners.

Surcharge rates are based on cost-recovery only, with NSW Treasury determining the surcharge rates for Visa and MasterCard, under the Government banking contract to be used across all agencies.

- *4263 ROUNDABOUT CONSTRUCTION—Mr Clayton Barr asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—
 - (1) With regard to funding allocations for the construction of a roundabout which costs less than \$3 million once approved by Roads and Maritime Services, what is the average time for construction from approval to completion?
 - (2) How many of these roundabouts have the funding allocated over three budget years?
 - (3) How many of these roundabouts had funding allocated in the 2015-16 Budget?
 - (4) How many of these roundabouts are expected not to be completed until 2017-18 Budget or beyond?

Answer-

(1) Under the State and Federal Blackspot programs, projects may be delivered over one to three years.

- (2) and (3) Three roundabout projects involve design and construction over three years, out of which, two had funding allocated in 2015-16.
- (4) Two roundabout projects are expected to be completed in the 2017-18 financial year, weather permitting.
- *4264 LOWER HUNTER HOSPITAL—Mr Clayton Barr asked the Minister for Health—
 - (1) Considering the replacement hospital for Maitland, what additional services will be offered that the existing Maitland Hospital does not?
 - (2) What services currently offered by John Hunter Hospital will not be offered?
 - (3) What percentage of the ownership is anticipated to remain as public ownership?

Answer-

I am advised:

The New Maitland Hospital will play an integral role in the Hunter New England Local Health District's well-established district-wide clinical networks and streams which bring together groups of health professionals from primary, secondary and tertiary care settings to improve clinical service delivery across the district.

Under the Health Partnerships model, the NSW Government retains ownership of the land on which a facility is constructed, and the buildings and equipment will return to Government ownership at the end of the negotiated and agreed contract with the non-government hospital operator.

- *4265 OUT OF ZONE SCHOOL ENROLMENT APPLICATIONS—Mr Clayton Barr asked the Minister for Education—
 - (1) How many out of zone school enrolment applications with siblings already attending the requested school in the Cessnock electorate were received for the 2016 school year?
 - (2) How many applications have been received for the 2017 school year?
 - (3) How many applications were approved for the 2016 school year?
 - (4) How many applications have been approved for the 2017 school year?

Answer—

(1) to (4) All schools are required to follow the department's enrolment policy. Where non local enrolment is possible and places exceed availability a panel is formed. Having a sibling does not and has not automatically guaranteed placement.

The vast majority of siblings out of zone who apply are accepted. 2017 enrolment plications are still being considered.

*4266 NEWCASTLE EAST END PROJECT—Mr Tim Crakanthorp asked the Minister for Planning—

How is the Government informing parties indicating interest in the purchase of the Newcastle East End project about the amended height limits for this site that are still awaiting legislative changes?

Answer—

UrbanGrowth NSW and The GPT Group have been clear in all public statements and in the EOI documentation (which includes the Expressions of Interest conditions, returnable schedules and the Information Memorandum), that the vendors will not support any increase in height to what was approved by the Joint Regional Planning Panel (JRPP).

One of the key sales terms in the EOI states that, "The Purchaser is restricted from increasing the height of the proposed buildings in accordance with the DA approved master plan".

The Contract for Sale also requires the purchaser to warrant that the purchaser:

- (1) has reviewed the development consent and the master plan, and are aware of the maximum building heights that apply to the property under the development consent and the master plan; and
- (2) will not lodge a Development Application for any building(s) on the property that would exceed the maximum building heights contained in the development consent and master plan.

Respondents will also be evaluated on their response to compliance with the height restrictions as set out in the DA approved master plan and their understanding of the Newcastle LEP and DCP and the Newcastle Urban Renewal Strategy and how the Respondent's vision complies with the objectives of these documents.

Newcastle City Council is the consent authority for future DAs, and the master plan approved by council allows for heights of up to RL40.

*4267 HAMILTON BUS DEPOT—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—

- (1) What is the estimated value of the Hamilton Bus Depot (89 Denison Street, Hamilton)?
- (2) Did the Minister or any other government department engage EJE Architecture, or any other firm, to investigate the future re-use of this site?

Answer_

- (1) In accordance with the Public Finance and Audit Act 1983, State Transit publishes a summary of the value of its land holdings at the end of each financial year. The summary includes bus depots and other land assets.
- (2) I refer you to my response to Budget Estimates supplementary question 128.

*4268 NEWCASTLE URBAN TRANSFORMATION AND TRANSPORT PROGRAM—Mr Tim Crakanthorp asked the Minister for Planning—

What was the cost of staff working on the Newcastle Urban Transformation and Transport Program in each financial year from 2014-15 to 2016-17 (as at 13 October 2016)?

Answer-

Novocastrians have been very clear they want locally based decisions about the Newcastle Urban Transformation and Transport Program (NUTTP).

Local employment has been prioritised within the NUTTP team, with local team members committed to Newcastle because they live in Newcastle and care about the city's future.

Overall, there are over fifty staff based in Newcastle working on the NUTTP.

*4269 FORMER WICKHAM SCHOOL OF ARTS—Mr Tim Crakanthorp asked the Minister for Planning—

- (1) Is the former Wickham School of Arts building listed on Hunter Development Corporation's Section 170 (NSW Heritage Act) Register?
- (2) What maintenance and security arrangements are in place for this building?
- (3) Does the Government have any plans for future adaptive reuse of this site?
- (4) Does the Government have any plans to demolish the building?

Answer-

- (1) Yes.
- (2) HDC engages the services of a site supervisor, landscaping contractors and security services to provide security and maintenance functions across the Honeysuckle urban renewal project area, including the site on which the former Wickham School of Arts building is located.
- (3) The building is contained within a larger site which is part of the Honeysuckle urban renewal project and as such it has been earmarked for future redevelopment. Adaptive re-use options for the building can be considered in detail as these future development proposals are considered.
- (4) There are no plans to demolish the building.
- *4270 POLES AND WIRES—Mr Tim Crakanthorp asked the Treasurer, and Minister for Industrial Relations—

Is the Government claiming exemption from the Commonwealth Competition and Consumer Act 2010 in respect of privatising the electricity poles and wires?

Answer-

The Government engaged early with the Australian Competition and Consumer Commission regarding the competition and regulatory framework. No exemption was claimed by the Government.

*4271 PORT OF NEWCASTLE—Mr Tim Crakanthorp asked the Treasurer, and Minister for Industrial Relations—

Did the Government claim exemption from the Trade Practices Act 1974 (as replaced on 1 January 2011 by the Competition and Consumer Act 2010) when Newcastle Port Corporation conducted a tender in 2010 for a multi-purpose terminal, including a container terminal with minimum capacity of 1 million twenty-foot container equivalent unit (TEU) per year, at the Port of Newcastle?

Answer-

I am advised that no exemption was claimed.

*4272 MANAGEMENT OF SOCIAL HOUSING—Ms Tania Mihailuk asked the Minister for Family and Community Services, and Minister for Social Housing—

- (1) Why is the Minister not transferring management of social housing to Community Housing Providers in the Newcastle and Lake Macquarie region?
- (2) What alternate plans does the Minister have for social housing properties in the Newcastle and Lake Macquarie regions?

Answer-

- (1) Properties in the Newcastle and Lake Macquarie regions were not included in the Management Transfer Program as redevelopment options are being considered in a number of local sites in order to increase and improve housing in these areas.
- (2) The Department of Family and Community Services (FACS) continually reviews the suitability of the properties it owns to ensure they meet the needs of the social housing system.  - (1) Will the Minister commit to reinstating funding to the Community Court Liaison Service Clinical Nurse Consultant at Bankstown Local Court to reinstate a full time service?
 - (a) If not, why not?
 - (2) Why did the Minister reduce the service from full-time Monday to Friday to one day a week?

Answer-

I am aware of the concerns regarding the service to Bankstown Local Court and I have raised those concerns with the Secretary of NSW Health.

I am advised that the Justice Health and Forensic Mental Health Network Statewide Community and Court Liaison Service nursing position at the Bankstown Local Court was established in 2015 as a multisite role that would also provide a custody l diversion service at the Silverwater Correctional Complex.

I am advised that the position commenced on a temporary basis with the provision of a five day service at the Bankstown Local Court while further planning was undertaken by the Network to determine service need at the Silverwater Complex.

I am advised that from 24 October 2016, the Justice Health and Forensic Mental Health Network has provided a 2-day per week court diversion service at Bankstown Local Court.

- *4275 824 SCHOOL BUS—Ms Jodie Harrison asked the Minister for Transport and Infrastructure—
 - (1) One of my Charlestown constituents is entitled to a Disabled Parking Permit for her son who is unable to walk more than 100 metres without pain or fatigue. However, the same child is expected to

walk approximately 1.2 kilometres on his journey to school as the 824 school bus, while servicing many students from Merewether High School, does not in fact stop at the school.

- (a) Can the Minister explain this discrepancy?
- (b) Will the Minister look into changing the current 824 bus route so it more adequately services all students Merewether High School, in particular those with a disability?

Answer-

Students with disability who are unable to travel to and from school under the Transport for NSW's School Student Transport Scheme may be eligible for transport assistance under the Department of Education Assisted School Travel Program. Information about this program is available on the Department of Education's website.

The Government is committed to providing school students with accessible public transport to and from school. Transport for NSW regularly monitors bus routes across the state and adjusts services when necessary.

- *4276 LAND AND HOUSING CORPORATION LAND AT FISHERMAN'S BAY—Ms Kate Washington asked the Minister for Family and Community Services, and Minister for Social Housing—
 - (1) Will the Government commit to not selling the Land and Housing Corporation owned land at Fisherman's Bay, land which was previously to be developed by UrbanGrowth?
 - (2) Will the community be given input into the current review of the future use of this land?
 - (3) Will the Government commit to incorporating this land into the Tomaree National Park?

Answer—

The Department of Family and Community Services continually reviews the suitability of the land and properties it owns to ensure they meet the needs of the social housing system.

 - (1) Based on the most recent preschool census, how many children were enrolled in New South Wales community based preschools for less than 15 hours per week (ie less than 600 hours per year)?

 - (4) How many preschools in New South Wales currently operate for 6 hours each day?

The NSW Government is firmly committed to closing the gap in health outcomes for Aboriginal people in NSW. This is reflected in the NSW Aboriginal Health Plan 2013- 023, developed in partnership with the Aboriginal Health and Medical Research Council of NSW.

In 2016-2017, the NSW Government has committed over \$23 million for programs in Aboriginal Community Controlled Health Services to address drug and alcohol misuse, chronic care, oral health, HIV, hepatitis B and C, sexually transmitted infections prevention, domestic and family violence, mental health, cardiovascular health and preventive health care. This includes an additional \$1.6 million allocated to 20 services from 2016-17, to align distribution of funding across the sector to address the Premier's Priorities and key health priorities for Aboriginal people in NSW.

As well as funding Aboriginal Community Controlled Health Services, NSW Health resources a range of targeted programs to contribute to closing the gap in health outcomes for Aboriginal people across NSW, with many provide services across the inner city area. These include

- Reducing risky alcohol and drug consumption among Aboriginal communities through the 'Stay Strong and Healthy It's Worth It' project, which raises awareness about the risks of alcohol consumption during pregnancy among Aboriginal women, their partners and family members:
- The Aboriginal Drug and Alcohol Workers Network, which supports Aboriginal drug and alcohol workers across local health districts, Aboriginal Community Controlled Health Services and Aboriginal Residential Rehabilitation and Healing Services to improve the delivery of drug and alcohol treatment to Aboriginal clients. A leadership group supports the Aboriginal Drug and Alcohol Network and contributes to drug and alcohol policy and service development at a statewide level;
- The NSW Aboriginal Mental Health Workforce Program, which comprises clinical leadership and trainee program in local health districts and the Justice Health and Forensic Mental Health Network, as well as mental health services in Aboriginal Community Controlled Health Services. Aboriginal mental health trainees undertake a three-year program comprising of an undergraduate degree, clinical placements and workplace training. The Clinical Leaders support trainees and their supervisors, consult on complex cases, contribute to service planning and promote culturally safe services that support effective engagement with Aboriginal people in mental health care.
- Reducing smoking in Aboriginal communities through programs such as Quit for New Life a smoking cessation support program for mothers of Aboriginal babies;
- Incorporating culturally relevant advertising content in partnership with National Indigenous Television, and dedicated community engagement elements in the Make Healthy Normal social marketing campaign to support Aboriginal communities. The Make Healthy Normal campaign aims to address increasing overweight and obesity in NSW, and is in line with the goals of the NSW Healthy Eating and Active Living Strategy 2013-2018;
- The Knockout Health Challenge, a community based healthy lifestyle and weight loss program for Aboriginal people;
- The Aboriginal Go4Fun program, a community based healthy lifestyle program for Aboriginal children aged seven to 13 years who are above a healthy weight, and their families. The culturally adapted program was piloted and evaluated with four Aboriginal communities from October 2015.

The Sydney Local Health District provides a wide range of Indigenous health programs, most in collaboration with Aboriginal agencies, to help close the gap among Aboriginal people in the inner city area. These include:

- The Sydney Metropolitan Local Aboriginal Health Partnership Agreement, a formalised alliance between the Aboriginal Medical Service (AMS) Redfern, the Sydney, Northern Sydney and South Eastern Sydney Local Health Districts, St Vincent's and Sydney Children's Hospital. The District also provides clinical services at AMS Redfern including podiatry, endocrinology, obstetrics, geriatric I aged care, paediatric, drug health, hepatitis.
- Yana Muru, the Local Health District's Sustained Health Home Visiting Program for families with Aboriginal babies (birth to two years) who require additional support.
- The Sydney Local Health District Healthy Homes and Neighbourhoods Integrated Care initiative provides care coordination for families with children (prenatally to 17 years) where the parents have a complex chronic condition or mental illness that is impacting on their ability to parent, and who are being seen by multiple agencies. Program staff are based on a social housing estate in Redfern and registered clients include Aboriginal families.
- A new Sydney Local Health District Sydney District Nursing Clinic was introduced at the Redfern Health Centre to complement in-home nursing services.
- Sydney Local Health District introduced 'Roaming Kitchen' in the Redfern! Waterloo area which provides education regarding healthy eating and food preparation to young Aboriginal people living locally.

• The Sydney Local Health District Youth Health Service (Youthblock) relocated to new premises in Abercrombie Street, Chippendale, providing easier access for local Aboriginal young people to multi-disciplinary clinical services.
