*2975 GLENDALE TRANSPORT INTERCHANGE—Ms Sonia Hornery asked the Minister for Transport—

Why was the Glendale Transport Interchange not featured in the NSW Transport Masterplan?

Answer-

I am advised:

One of the first major commitments of this Government was a contribution of \$15 million towards the construction of a road bridge and associated roads at Glendale.

The planned road bridge at Pennant Street and associated road upgrades are proposed to improve access to the surrounding growth areas for all modes of transport, including buses, taxis and private vehicles.

Our significant commitment to this project recognises the importance of Glendale and Cardiff as an emerging major regional centre in the Lower Hunter.

We will continue to work with Council to support the development and delivery of this project, and to honour our commitment of \$15 million to improve infrastructure in this emerging regional centre.

What strategies has the NSW Police Force put in place to prevent and deter violent crime in South-Western Sydney?

Answer-

This Government is ensuring the NSW Police Force has the right resources, in the right place and at the right time. On top of improving operational strength, we are maintaining dedicated resources that specifically target crime.

In Western and South Western Sydney there are Region Enforcement Squads, Metropolitan Robbery Units, Emergency Management Units, Region Strike Forces and Unsolved Homicide Teams in addition to resources at the Local Area Command level.

The Government is putting unprecedented resources into tackling gang crime and stopping drive-by shootings. The NSW Police Force is conducting a number of high visibility policing operations, including Operation Spartan and Strike Force Kinnarra to deal with gang crime and drive-by shootings in South West Sydney. Operation Spartan has made 556 arrests, laid 1046 charges and seized or located 50 firearms as at 6 November 2012. Police have also conducted 5727 person searches and 2172 vehicle searches as part of this Operation.

The Government has also given police enhanced powers and legislation to make it easier to put criminal gang members behind bars. This includes modernised consorting laws, the licensing of tattooists and parlour operators, and a new aggravated 'fire at dwelling' offence has been introduced.
