\*6419 MAGISTRATE ECKHOLD LOCAL COURT MATTERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Will recently proposed changes to the sittings at the Local Court at Dubbo mean that Magistrate Eckhold will hear fewer local court matters originating in Dubbo?

Answer-

The sitting days for all magistrates on the Dubbo Local Court circuit will be affected by the proposed changes.

\*6420 COURT ROOM VISITS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Since becoming Attorney General, how many and which magistrates have you observed in court rooms while the court was in session?

Answer—

In my role as Attorney General I have visited many courts across New South Wales.

- \*6421 STATE LIBRARY FUNDING CUTS—Mr Paul Lynch asked the Deputy Premier, Minister for Trade and Investment, Minister for Regional Infrastructure and Services, Minister for Tourism and Major Events, Minister for Hospitality, Gaming and Racing, and Minister for the Arts—
  - (1) What funding cuts have been imposed on the State Library?
  - (2) Why have research facilities at the State Library been reduced?

Answer—

- (1) All relevant information can be found in the State Library Annual Report which contains financial statements.
- (2) Research facilities have not been reduced at the State Library.
- \*6422 REPRESENTATIONS REGARDING MAGISTRATE ECKHOLD—Mr Paul Lynch asked the Deputy Premier, Minister for Trade and Investment, Minister for Regional Infrastructure and Services, Minister for Tourism and Major Events, Minister for Hospitality, Gaming and Racing, and Minister for the Arts—

Did you ask, request, suggest or in any way make representations to the Attorney General to remove or transfer Magistrate Eckhold from the Local Court at Dubbo?

Answer—

No. The Attorney General visited Dubbo at my request and met with a range of legal stakeholders and community groups.

- \*6423 NSW ELECTORAL COMMISSION—Mr Paul Lynch asked the Premier, Minister for Infrastructure, and Minister for Western Sydney—
  - (1) Is Simon Kwok employed by the NSW Electoral Commission?

- (a) If so, in what capacity?
- (b) If so, when did his employment commence?
- (c) If so, what are his qualifications for the position?

#### Answer\_

The NSW Electoral Commission has advised me of the following:

- (1) Yes.
  - (a) Mr Kwok is employed by the NSW Electoral Commission as Elections Manager.
  - (b) and (c) Mr Kwok has been employed as a permanent employee of the NSW Electoral Commission since 7 January 2013. He was recruited into his current role through a merit selection process.

## \*6424 PLUMBING COURSES AT MILLER TAFE—Mr Paul Lynch asked the Minister for Education—

What changes are proposed for plumbing courses at Miller TAFE for 2015?

Answer—

TAFE NSW - South Western Sydney Institute is changing the way that it delivers plumbing courses to ensure it continues to meet the needs of industry and employers in a financially sustainable way.

These changes will allow employers and apprentices a greater choice of course electives to make sure the skills being delivered best suit their needs. In some instances this may reduce the length of training, depending on the electives chosen.

\*6425 BUILDINGS THAT HOUSE BROTHELS—Mr Paul Lynch asked the Minister for Local Government—

Is it an appropriate use of Council resources to buy buildings that house brothels?

Answer—

Councils are the appropriate body to decide public resource allocation on behalf of the community. Councils are accountable to their electors.

- \*6426 2014 HUNTER REGIONAL TRANSPORT PLAN PROJECTS—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, Minister for the North Coast, and Vice-President of the Executive Council—
  - (1) What is the current status and cost of the Newcastle Local Government Area (LGA) project entitled "Safety works in King Street between Union Lane and Watt Street in Newcastle", listed under the Traffic Management and Road Safety Program in the 2014 Hunter Regional Transport Plan to commence in July 2013 with a cost of \$423,000?
  - (2) What is the current status and cost of the Maitland LGA project entitled "Upgrade the New England Highway between the hospital and railway station roundabouts in Maitland (Election Commitment)" listed under the Traffic Management and Road Safety Program in the 2014 Hunter Regional Transport Plan with a cost of \$41,710,000?
  - (3) What is the current status and cost of the Lake Macquarie LGA project entitled "Contribute to the Cardiff main street revitalisation project (election commitment)", listed under the Traffic Management and Road Safety Program in the 2014 Hunter Regional Transport Plan to commence in August 2013 with a cost of \$2,200,000?

## Answer-

I am advised:

- (1) This project is now complete. The final cost of the project was \$851,000, funded by the Commonwealth Government Black Spot Programme.
- (2) The Government committed \$45 million to this project through the Hunter Infrastructure and Investment Fund.
- Work at the hospital roundabout, including construction of slip lanes and installation of traffic lights, is complete.
- Minor works at the railway station roundabout are complete, and further enabling works are underway in advance of overpass works.
- A contract for construction of the overpass is expected to be awarded in December 2014, with construction expected to be complete in mid-2016.
- (3) The Government committed \$2.5 million to this project through the Hunter Infrastructure and Investment Fund.

- Lake Macquarie City Council spent \$300,000 on the project in 2012-13, and did design work at a cost
  of \$240,000 in 2013-14.
- Roads and Maritime Services allocated \$1,969 million to Council for construction in 2014-15.
- Council has advised Roads and Maritime Services that construction will begin before the end of 2014.
- \*6427 ADAMSTOWN RAILWAY LEVEL CROSSING—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—

Does the Government plan to remove the railway level crossing at Adamstown?

Answer-

I am advised:

- \*6428 TAXI TRANSPORT SUBSIDY SCHEME—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
  - (1) When was the maximum subsidy amount of \$30 per trip allowed under the Taxi Transport Subsidy Scheme last reviewed?
  - (2) When does the Government plan to conduct the next review of the maximum subsidy amount allowed under the Taxi Transport Subsidy Scheme?

Answer—

I am advised:

The Government has carried out a review of the subsidies and incentives that support Wheelchair Accessible Taxi services, including the affordability and availability of the Taxi Transport Subsidy Scheme.

A number of recommendations to improve the service for customers are now being considered.

- \*6429 P1 DRIVING TEST WAIT TIMES—Ms Sonia Hornery asked the Minister for Finance and Services—
  - (1) What is the average wait time to book a P1 driving test at Roads and Maritime Services centres in Newcastle, Charlestown and Wallsend?
  - (2) What action is the Government taking to reduce these wait times?

Answer-

The average wait time for driver testing for the Newcastle, Charlestown and Wallsend area is less than twelve days which is within the accepted standards.

Waiting times are closely monitored to allow for adjustments if required.

\*6430 FIRE AND RESCUE NSW FUNDING—Ms Sonia Hornery asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—

How much funding did the Government provide to Fire and Rescue NSW for each of the financial years from 2011-12 to 2014-15?

Answer-

- \*6431 GOING HOME STAYING HOME POLICY—Ms Sonia Hornery asked the Minister for Family and Community Services—
  - (1) Will the Minister reverse the cuts to funding under the Going Home Staying Home policy?
    - (a) If not, why not?

- \*6432 INTERNATIONAL CHILD CARE COLLEGE AT BROADMEADOW—Ms Sonia Hornery asked the Minister for Education—
  - (1) Why was the International Child Care College at Broadmeadow overlooked during the Smart and Skilled application process?
  - (2) How did the Smart and Skilled application process assess quality, as indicated in the National

Quality Framework assessment criteria, using only quantitative data?

(3) Why is there no provision for a review or appeal of decisions under the Smart and Skilled application process?

#### Answer—

- (1) International Child Care College at Broadmeadow was not overlooked in the Smart and Skilled application process. It was assessed under the same eligibility and assessment criteria applied to all applications.
- (2) Smart and Skilled contract applications assessment considered all information provided in the applications. This information was not quantitative data only.
- (3) The governance of the application process met high standards of rigour and probity. Robust governance arrangements were in place throughout the application process, including external probity advice. The process operated within the NSW Government Procurement Guidelines. The Department of Education and Communities offered organisations a review process if they felt they had been unfairly excluded or disadvantaged by the application process.
- \*6434 PEDIATRICS AND CHILD HEALTH RESEARCH—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

How much money did the Government allocate to pediatrics and child health research in the Hunter in each of the financial years from 2011-12 to 2014-15?

Answer-

I am advised:

The New South Wales State Government, through the NSW Medical Research Support Program, allocated over \$3.8 million in the 2011-12 financial year and over \$5.3 million in the 2012-13 financial year in funding to the Hunter Medical Research Institute.

\*6435 ROOTY HILL RAILWAY STATION PEDESTRIAN RAMPS—Mr Richard Amery asked the Minister for Transport, and Minister for the Hunter—

Does the gradient of the pedestrian ramps over the Rooty Hill Railway Station meet Australian Standard AS1428 for people with disabilities and people who use wheelchairs?

Answer—

I am advised:

In 2012, the Government announced the Transport Access Program which is delivering accessible, modern, secure and integrated transport infrastructure where it is needed most. This includes station upgrades, better interchanges and commuter car parks. This program includes more than \$770 million for improvements over four years.

Planning and design work is now underway to see which projects will come next. Access upgrades at Rooty Hill Station will be considered as part of this process.

The Transport Access Program is part of the Government's commitment to improve public transport services and provide a world class transport system people want to use.

- \*6436 GROUP HOMES—Mr Barry Collier asked the Minister for Family and Community Services representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—
  - (1) Does the Government have any plans to privatise and/or outsource the management of Group Homes?
    - (a) If so, when will the Minister begin the process of advertising the sale and/or outsourcing in (1)?

#### Answer—

The Government is committed to a disability service system that increases choice and control for people with disability. For this reason, in December 2012 the New South Wales Government became the first state to sign a historic agreement with the Commonwealth to implement the National Disability Insurance Scheme (NDIS).

These reforms mean the budget to support people with disability will increase from \$2.7 billion to a \$6.4 billion partnership between the New South Wales and Commonwealth Governments. Importantly, the NDIS will benefit around 140,000 people with disability in New South Wales alone.

The NDIS will provide all participants with an individual funding package, based on an assessment of

what is reasonable and necessary support to meet their needs, goals and aspirations. Each person with disability will have full choice and control over their funding and the supports they choose to access.

As New South Wales moves towards the full rollout of the NDIS, services provided by the government are being transitioned to the non-government sector.

- \*6437 DARLING HARBOUR LIVE DEVELOPMENT—Mr Alex Greenwich asked the Minister for Planning, and Minister for Women—
  - (1) Did the information provided to the community for the Darling Harbour Live development indicate a proposed "green wall" along Darling Drive facing Ultimo?
  - (2) Did photographs presented to the community display green walls as part of this development?
  - (3) Have residents repeatedly raised concerns about noise impacts and poor visual amenity during consultation on this project?
  - (4) What assessment was made of these concerns and the measures necessary to address them?
  - (5) What action has the Government taken to prevent noise impacts and poor visual amenity as raised by the community?
  - (6) What changes to the design for development along Darling Drive are intended?
  - (7) What further action will the Government take to prevent noise and visual amenity from large walls in the Darling Harbour Live development?

Answer-

I am advised:

The Department of Planning and Environment was not involved with the applicant's pre-application community consultation and the department is unaware of any proposed design changes.

- \*6438 AMBIENT AIR QUALITY REVIEW—Mr Alex Greenwich asked the Minister for the Environment, Minister for Heritage, Minister for the Central Coast, and Assistant Minister for Planning—
  - (1) What evidence does the Government have about the impact of air pollution on mortality and morbidity in New South Wales, and in urban areas in particular?
  - (2) What are the main contributors to urban air pollution?
  - (3) What strategies does the Government have in place to prevent death and harm from air pollution?
  - (4) What assessment has the Government made of the benefit of better air quality standards and their impact on human health?
  - (5) What contribution has the Government made, or intends to make, to the National Environmental Protection Measure for Ambient Air Quality review?
  - (6) Will the Government support tighter regulation of air quality and measures to reduce air pollution?
  - (7) What further action will the Government take to reduce air pollution?

Answer—

I am advised as follows:

- (1) Information is available in the "Summary for Policy Makers of the Health Risk Assessment on Air Pollution in Australia" which is available on the Commonwealth Department of Environment website.
- (2) This data is freely available online via the Air Emissions in My Community web tool at http://www.epa.nsw.gov.au/air/airemissionsinmycommunity.htm.
- (3) Through the Environment Protection Authority (EPA), the Government addresses emissions from industry, vehicles and commercial and domestic sources.

The EPA implements environmental regulatory requirements, licenses scheduled industry activities, conducts compliance and enforcement programs and implements non-statutory policies, programs and strategies to improve air quality and protect public health. These activities have been supported by a record budget allocation in 2014-15 to the EPA of \$141.6 million.

Control measures are targeted to areas where population health is most affected, and to the most polluting

activities in those areas.

Government initiatives to protect air quality are presented on the EPA website and include:

- Actions to reduce particle emissions as set out in Managing Particles and Improving Air Quality in NSW, and the Upper Hunter Air Particles Action Plan.
- Tightened regulation of industry licensed by the EPA, including through introduction of higher penalties and requirements to immediately report breaches of licence conditions and make monitoring results publicly available.
- The Dust Stop Program, under which pollution reduction programs have been placed on all open cut coal mines in NSW, requiring them to implement best practice measures to reduce dust emissions and monitor and report on the effectiveness of these actions.
- Regulatory inspections to monitor and enforce compliance with environment protection licence requirements, including unannounced aerial inspections of licensed coal mine operations and power stations in the Hunter Valley.
- The Wood Smoke Reduction Program which has provided councils in metropolitan and regional NSW with grants for community education, local enforcement and rebates to remove older wood heaters.
- Smoky vehicle enforcement by the EPA and Roads and Maritime Services, with increased penalties for smoky diesel trucks in the M5 tunnel.
- Regulation of low petrol volatility in summer and roll-out of vapour recovery at service stations in the Sydney Greater Metropolitan Region, to reduce emissions of ozone-forming pollutants.
- (4) The most recent estimates of the benefits associated with air quality standards and their impact on human health can be found in documents prepared for the review of national ambient air quality standards for particles.

These documents include: Exposure Assessment and Risk Characterisation to Inform Recommendations for Updating Ambient Air Quality Standards for Particles, Ozone, Nitrogen dioxide and Sulfur dioxide; Summary for Policy Makers of the Health Risk Assessment on Air Pollution in Australia and the Draft variation to the National Environment Protection (Ambient Air Quality) Measure Impact Statement. These documents can be found on the Commonwealth Department of Environment website.

- (5) The EPA has participated in the making and review of all air related National Environment Protection Measures. Since 2012, the EPA has led the review of the National Environment Protection Measure for Ambient Air Quality (AAQ NEPM) standards for particles. The EPA will continue to be involved in the next stage of the AAQ NEPM review, which will consider air quality standards for other pollutants.
- (6) The Government supports the improvement of air quality across NSW. Regulations and control measures are developed on relevant evidence including ambient air quality monitoring, the EPA air emissions inventory and particle characterisation studies to determine the measures that will deliver the greatest overall benefit for the community.

The EPA also develops legally enforceable pollution reduction programs (PRPs) with industry operators, which are included as conditions on their environment protection licences. All environment protections licences and PRPs are freely available online at ww.epa.nsw.gov.au/prpoeoapp/.

- (7) The Government has provided \$8 million over 4 years for a number of major studies and programs that will continue to improve understanding and management of air quality both for NSW overall and for targeted sectors and regions. In consultation with industry and the community, the EPA is currently developing a Diesel and Marine Emissions Management Strategy which aims to progressively control and reduce emissions from priority sectors.
- \*6439 ENTERTAINMENT QUARTER SALE—Mr Alex Greenwich asked the Minister for the Environment, Minister for Heritage, Minister for the Central Coast, and Assistant Minister for Planning—
  - (1) Was the lease for the Entertainment Quarter site at Moore Park, or part of the site, sold this year?
    - (a) If not, what negotiations are underway and what offers have been made for the sale of the lease?
    - (b) If so, who approved the sale given the initial lease requires the "landlord" to consent to any sublease of a significant part of the site?
    - (c) If so, what changes, if any, were made to the lease as a result of the sale?
  - (2) When was the concept of transferring the ownership of the lease first raised with the Government?
  - (3) What discussions have taken place with the current lessees about the future of the site?
  - (4) What information has the Government received about the lessees' intentions for the site?
  - (5) What assurances will the Government give to the community that any redevelopment of the site complies with the initial film related and ancillary activities purpose of the 1995 lease?
  - (6) What assurances will the Government give to the community that the land and the buildings on it

will be returned to the public as is required by the 1995 lease on its expiration?

#### Answer-

I am advised as follows:

- (1) No.
  - (a) The lease owner Colonial First State has entered into negotiations regarding the sale of the lease with an interested buyer.
  - (b) Not applicable.
  - (c) Not applicable.
- (2) Colonial First State advised the Centennial Park and Moore Park Trust in November 2013.
- (3) I am advised that Colonial First State has kept its tenants informed as to the ownership of the lease.
- (4) The lease is proposed to be transferred to a consortium on the same terms and conditions as the existing lease.
- (5) The Entertainment Quarter leaseholder must comply with all the terms of the lease and with State Environmental Planning Policy 47 which applies to the former Moore Park Showground site.
- (6) The Government will ensure that the terms of the Entertainment Quarter lease are complied with.
- \*6440 311 BUS SERVICE—Mr Alex Greenwich asked the Minister for Transport, and Minister for the Hunter—
  - (1) What are the monthly patronage numbers for the 311 bus service since the data reported in Q.3127 in October 2012?
  - (2) What patterns does State Transit report in patronage for the 311 bus service since March 2011?
  - (3) Has the trend for increased patronage on the 311 bus service continued since March 2011?
  - (4) What changes have been made in response to changing patronage levels on the 311 bus route?
  - (5) What assessment has the Government made of changes to the 311 bus route to improve access and service levels?
  - (6) What assessment has the Government made of returning the 311 bus to a 20 minute service?
  - (7) What plans does the Government have for improving the frequency, running times, and the general operation of the 311 bus service?

## Answer-

I am advised:

Route 311 patronage is reasonably constant on a monthly basis.

There are no reported instances of overloading on this service at any time of day.

Route 311 services are meeting the needs of customers.

Transport for NSW will continue to monitor this service to ensure it is meeting customer needs.

- \*6441 ROAD SAFETY FOR CYCLISTS IN OXFORD STREET—Mr Alex Greenwich asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, Minister for the North Coast, and Vice-President of the Executive Council—
  - (1) Will the Government provide a bike box on Oxford Street at the intersection with South Dowling Street to separate cyclists from traffic on the red signal and allow vehicles to turn left on the green arrow?
  - (2) Will the Government provide a bike box on Oxford Street at the intersection with Wentworth Avenue to separate cyclists from traffic on the red signal and allow vehicles to turn left on the green arrow?
  - (3) What plans does the Government have to improve road safety for cyclists in Oxford Street?
  - (4) What further action will the Government take to improve Oxford Street road safety?

## Answer-

I am advised:

- (1) and (2) Bicycle boxes must meet certain criteria, including minimum lengths on the approach to an intersection and the width of the lane. It must also consider the mix of traffic on the route. These locations do not meet the required criteria.
- (3) and (4) The Government aims, where possible, to separate cyclists from vehicles and pedestrians to increase road safety.

The City Centre Cycleway Network is being developed as part of the Sydney Centre Access Strategy and Sydney Cycling Future. The Government has identified and is committed to completing a separated cycleway between Bondi Junction and Sydney CBD. The Minister for Environment and Heritage and I

opened the first stage of the cycleway on 20 October 2014. Work with stakeholders continues to progress plans for further stages in the medium term.

Transport for NSW has also developed the Cycling Safety Action Plan 2014-16 with key stakeholders, including Bicycle NSW, Amy Gillett Foundation and NRMA Motoring and Services. A range of actions will be delivered over the next three years, including education and communications to riders and motorists, infrastructure improvements, and trials of innovative technologies.

Ongoing analysis of crashes along Oxford Street will continue to address issues identified for all road user groups.

- \*6442 MILLERS POINT HOUSING—Mr Alex Greenwich asked the Minister for Family and Community Services—
  - (1) Will the Government halt tenant relocations and property sales in the Millers Point, Dawes Point and The Rocks precinct until the development of the assets portfolio strategy recommended by the Inquiry into Social, Public and Affordable Housing?
  - (2) How will the Government ensure that sale decisions are consistent with strategic policy, make the best use of public assets and comply with obligations under the Housing Act 2001 to provide housing to those in need?
  - (3) How will the Government ensure all funds from the sale of these properties are used to buy or build additional social housing as referred to in recommendation two arising from the Inquiry?
  - (4) Will the Government retain community housing properties in this precinct as listed in recommendation 21 arising from the Inquiry?
  - (5) Will the Government transfer management of social housing properties in this precinct to community housing providers?
  - (6) Will the Government retain multi-unit dwellings, such as the Sirius building, for social housing as referred to in recommendation three arising from the Inquiry?
  - (7) Will the Government retain purpose-built social housing, such as the Cumberland and High Street properties, as referred to in recommendation 4 arising from the Inquiry?
  - (8) What other action will the Government take to implement the recommendations arising from the Inquiry into Social, Public and Affordable Housing report in Millers Point, Dawes Point and The Rocks?

Answer-

I refer the Honourable member to the answer for Question on Notice 6366.

- \*6443 CENTRAL TO EVELEIGH PLANNING PROJECT—Mr Alex Greenwich asked the Minister for Planning, and Minister for Women—

(1) to (9) Outside School Hours Care (OSHC) is a Commonwealth Government responsibility and the NSW Department of Education and Communities does not collect data on OSHC enrolments or usage.

The Department of Education and Communities' Community Use of School Facilities policy and procedures provide the policy framework for OSHC services in New South Wales public schools. Preference is given to children's services providers over other community users. To ensure consistency and fairness, the Department sets minimum fee structures for licences and leases. Asset Management Units assist principals in ensuring that the appropriate fee is charged. The approach to fee calculation is outlined in the community Use of School Facilities for Children's Services implementation procedures. The licence fee paid by the children's services operator is required to cover all of the school's costs associated with having the operator use school facilities for the purpose of providing the service.

Under Local Schools, Local Decisions and the Community Use of School Facilities policies, public school principals are encouraged to make school sites available for non-government OSHC services.

The Commonwealth Government subsidises fees for parents using OSHC services via the Child Care Benefit system. Funding for the establishment of OSHC services may also be available from the Commonwealth Government through its Community Support Programme.

The Government promotes good on-farm practices through field days, publications and technical advice provided through the Department of Primary Industries and Local Land Services.

AGL is required to undertake LDAR monitoring using agreed protocols and report to the EPA as part of the company's Annual Return process. The EPA has undertaken its own gas inspection program to provide independent assessment. All leaks detected under the program have been addressed by AGL.
- (b) The Protection of the Environment Operations Act 1997 requires parties holding an environment protection licence to make environmental monitoring data publicly available. AGL is required to make pollution monitoring data available to the public on its website.
- (2) (a) The Government formed a Coal Seam Gas Working Group comprising representatives from various government agencies, including the Office of Coal Seam Gas, the EPA, NSW Health and the Department of Planning and Environment. This group ensures all agencies are aware of issues relating to coal seam gas activities in New South Wales.

There are a number of scientific reports available that examine the medical impacts of methane on the human body. It is a scientific and medical area that is well understood within the health community and this is reinforced by NSW Health.

The EPA has commissioned the Commonwealth Scientific and Industrial Research Organisation to undertake research into fugitive methane emissions from a range of industry types in NSW, including the Coal Seam Gas industry, with respect to emission rates and monitoring. The results will provide a greater understanding of background and current methane emission levels.

(2) (b) and (c) Environment protection licence limits in relation to emissions are the responsibility of the EPA.

#### Answer-

A school consultative group was formed to consider how to best meet the educational needs of students at Wollombi Public School. Future options were discussed and the educational needs of students at the school were raised and considered. Consultation included individual meetings, Parents and Citizens Association meetings, community meetings, consideration of written submissions and an open response survey, in which there were 49 respondents. The Director, Public Schools NSW, consulted directly with every family at the school, all staff and the Local Member, regarding the school's future.

Educational data was considered by the consultative group. Information which has been used and is available to the public is accessible on the My School web site.

#### I am advised:

- (1) and (1a) In relation to requests for leave to be legally represented that have been formally recorded in the Tribunal's case management system between 1 January 2014 and 31 October 2014, I can advise the following:
  - NCAT received 2,683 Home Building applications. Of these applications, the Tribunal received 79 written requests for leave to be legally represented (2.94 percent), with 10 being refused (12.6 percent).
  - NCAT received 1,199 Strata and Community Schemes applications. Of these applications, the Tribunal received 3 written requests for leave to be legally represented (0.25 percent), with none being refused.
- (2) If a person is refused leave to be legally represented in NCAT proceedings, he or she may seek leave to appeal that decision. NCAT's internal appeal panel has not received any applications for leave to appeal in relation to legal representation in Home Building or Strata and Community Schemes matters. Nor has the Tribunal received any formal complaints.
- (3) As outlined in my response to question 2, NCAT has not received any applications for leave to appeal about a particular decision to grant or refuse a person permission to be legally represented. Nor has the Tribunal received any complaints.
- (4) The low application rate for leave to be represented in Home Building and Strata and Community matters, combined with the absence of any appeals or complaints about the Tribunal's decisions, indicate that the current provisions relating to legal representation are operating fairly.
- (5) The Government will continue to monitor the application of the guidelines to ensure that the current provisions relating to legal representation operate fairly.
- \*6521 SMALL BUSINESS SUPPORT—Mr Alex Greenwich asked the Minister for Small Business, and Minister for Regional Tourism—
  - (1) What avenues of support are available for small businesses under the Retail Leases Act 1994?
  - (2) What measures can be used to help businesses in high street shopping areas such as Oxford Street?
  - (3) How can the Government support pop-up shops, or other short term leases, that may help activate shopping streets and support startup businesses?
  - (4) Does the Government have plans to support small businesses by activating rarely used shopping streets?
  - (5) What further action will the Government take to support small businesses?

#### Answer—

(1) The Retail Leases Act (the Act) supports small businesses by providing a regulatory framework for their industry and by establishing a mediation process to assist in resolving disputes. It provides certainty on key issues which have important economic consequences for small businesses and seeks to create a level playing field between landlords and tenants. The Act is currently undergoing a periodic review to ensure it stays in touch with the needs of the market and to further increase transparency in the sector.

The Act's mediation regime provides a low cost, accessible and efficient service to help the parties to a lease to resolve their disputes. This service is provided by the Office of the Small Business Commissioner's (OSBC) Dispute Resolution Unit which also offers commercial, strategic and procedural advice and information to landlords and tenants about leasing issues. The OSBC has also produced the NSW Retail Tenants Guide and the Small Business Info Kit to provide practical advice about leasing and the provisions of the Act in everyday language. These resources have been translated into Arabic, Chinese (simplified), Korean and Vietnamese to help New South Wales retailers from diverse backgrounds.

- (2) Businesses in high street shopping areas are able to access support through the Government's Small Biz Connect program. The program provides highly subsidised face to face business advice supported by a retail health check developed in partnership with the Australian Retailers Association. The health check can assist small retailers to identify actions to improve their business.
  - The OSBC's Dispute Resolution Unit provides a low cost, accessible and efficient mediation service to help businesses resolve disputes, along with commercial, strategic and procedural advice. The OSBC can help with disputes or issues involving a small business and a landlord or tenant, other business. Council or Government.
- (3) Businesses wishing to start or create a pop-up shop can get support through the Government's Small Biz Connect program.
- (4) The Government through the OSBC is working closely with Councils and local business communities to identify opportunities to activate their small businesses. Where local champions have identified areas of opportunity the OSBC will partner to assist in facilitating knowledge and skills development enabling a group of small businesses to develop collective actions to reactivate their street.
- (5) The Government is working to ensure that small businesses have an environment conducive to doing business. The OSBC in partnership with the NSW Business Chamber has initiated the Small Business Friendly Councils Program, the first of its kind in Australia. 41 Councils, representing over 242,000 small businesses, have committed to participate in the Program. Councils in New South Wales have the opportunity to be formally recognised and demonstrate their commitment to their local small business community by committing to report on business improvement processes and ontime payment policies in their operational plans; establishing a business advisory board in conjunction with key stakeholders from the local business community; and implementing new initiatives such as streamlining procurement or establishing pre-lodgement Development Application meetings. The OSBC is also conducting a periodic review of the Retail Leases Act, with a view to introducing greater transparency to the retail leasing sector, which will benefit small businesses.

- A fee adjustment policy where recognition of prior learning and/or credit transfer has been granted.
- The requirement for a clear withdrawal with no penalty cut-off date (as determined by the Provider).
- The Provider must comply with one of the national Vocational education and training regulator standards for Registered training Organisations for the protection of student fees, such as being a member of an approved Tuition Assurance Scheme.
- \*6529 SMART AND SKILLED APPLICATION PROCESS—Mr Clayton Barr asked the Minister for Education—
  - (1) Why were some Registered Training Organisations (RTOs), who were unable to provide historical data as required in the Smart and Skilled application process, offered contracts ahead of other unsuccessful applicants who provided the required information?

(1) and (2) The High Needs Pool and Attendant Care Programs were aligned under a new policy, the Community Support Program (CSP), which has been implemented since 1 July 2014. All participants were advised in September 2013 of the changes. The CSP provides participants with greater flexibility, choice and control over their disability supports. Under the CSP, participants are allocated an approved individual budget rather than a prescribed number of hours and type of support.

For individuals transferring from Attendant Care Program and High Needs Pool, the individual budget is based on their current approved hours of support, inclusive of direct and indirect costs. Participants decide how they want to use their funds in an individual plan. There has been no reduction in Ageing, Disability and Home Care funding during this transition.

There are no plans to reduce or cancel Community Support Program funding packages on 31 December 2014.

\*6533 ROADSIDE ASSISTANCE—Ms Tania Mihailuk asked the Minister for Finance and Services representing the Minister for Fair Trading—

What safeguards will be put in place to ensure that motorists will be protected from unskilled roadside assistance operators, who will not be required to hold a relevant licence or tradesperson certificate upon commencement of the Motor Dealers and Repairers Regulation 2014?

The Australian Consumer Law requires companies providing roadside assistance services to guarantee that the work performed by their technicians is done with an acceptable level of skill and technical knowledge.

On how many occasions did NSW Fair Trading officers inspect motor vehicles for unsafe or poor quality repairs that were subject to an insurance claim in each of the years from 2011 to 2014?

#### Answer-

NSW Fair Trading's complaints database does not record whether motor vehicle repairs are subject to an insurance claim.

\*6535 PROSECUTIONS AGAINST PANELBEATING OPERATORS—Ms Tania Mihailuk asked the Minister for Finance and Services representing the Minister for Fair Trading—

How many prosecutions have been made by NSW Fair Trading against panelbeating operators in each of the years from 2011 to 2014?

# Answer—

NSW Fair Trading has prosecuted and issued penalty infringement notices for breaches under the former Motor Vehicle Repairs Act 1980, to the following number of panel beating operators, in each of the calendar years specified:

- 2011 nil prosecutions and 11 penalty infringement notices were issued against 9 operators.
- 2012 nil prosecutions and 30 penalty infringement notices against 21 operators.
- 2013 1 prosecution for 12 offences and 13 penalty infringement notices against 10 operators.

Police numbers are at record highs. As at December 2014 authorised strength was 16,485 and the Government's commitment is to boost the authorised strength of the NSW Police Force by 859 police officers, to reach 16,665 in August 2015. 679 of these additional positions have been brought online since December 2011.

The allocation of police resources is determined by the Commissioner. The most recent attestation was on 12 December 2014 and twelve recruits were allocated to the Bankstown Local Area Command.

- \*6541 MEASURES FOR INCREASING LIFE EXPECTANCY—Ms Tania Mihailuk asked the Minister for Natural Resources, Lands and Water, and Minister for Western NSW—
  - (1) What specific measures have been implemented in the last 12 months to promote healthier lifestyles and to increase the life expectancy rate in the following towns:
    - (a) Walgett;

- (b) Forbes; and
- (c) Bourke?

#### Answer-

See below list of programs and services that promote healthier lifestyles in the towns of Walgett, Forbes and Bourke.

- Munch and Move, a state-wide program which aims to promote and encourage healthy eating and physical activity habits and reduce small screen recreation (TV, DVDs, computers) among young children aged from birth to five years who attend early childhood education and care services. All centre-based child care services and preschools in Bourke, Forbes and Walgett participate in.
- Crunch&Sip program promotes and supports schools to implement a dedicated fruit, vegetable and water break during class time. 8 out of 9 schools in Bourke, Forbes and Walgett participate in this program.
- Active After Schools programs in Bourke, Walgett and Forbes provide active play and sporting
  opportunity to school aged children.
- Healthy Outback Kids Program in Bourke and Walgett primary schools established school kitchen gardens to be used in Science and Food Tech classes with the guidance from the Stephanie Alexandra Kitchen Gardens program and the Healthy Kids Association.
- The Western NSW Local Health District Health Promotion unit support physical activity leader training and support programs across the WNSW and free classes are held in Bourke, Walgett and Forbes with access open to community members over the age of 16yrs.
- NSW Health Challenge Walgett has participated in 2013 & 2014. Bourke participated in 2013.
- NSW Health Activity Challenge- Walgett Public School was in the pilot in 2013 and participated in 2014. This involved students being engaged in a virtual challenge around the world with distance covered tied to class daily pedometer readings.
- Healthy People and Places competitive grant process encourages local health facilities to work in partnership with local communities to design, implement and evaluate a HP project and Bourke was successful in 2014 to increase access to fruit and vegetables in Enngonia. Forbes was successful in 2013. Their project was in partnership within the local preschool on planting fruit trees.
- Marang Dhali Eating Well Project (MDEWP) is a food and cooking program for Aboriginal Communities. Aboriginal Health workers are trained to deliver this program locally and have run it in both Bourke and Forbes.
- Sales to Minors is a program aimed at reducing the access to cigarettes to minors. Compliance testing has been run in Forbes and Bourke in the last 12 months.
- Stepping On program is a prevention program for people identified as high risk of falling and sustaining injury. Local health staff are trained to run this program locally and is run in Bourke and Forbes. Walgett staff are trained and will commence classes in 2015.
- Health Promotion Capacity Building training aims to teach local health workers to undertake effective project planning, implementation and evaluation. Training has been undertaken at Bourke and is scheduled for Walgett in 2015.
- Housing for Health is a Public Health initiative to improve lifestyle and living conditions. Programs have been run at Bourke and Walgett in the last 12 months.
- Traditional Indigenous games are coordinated from Bourke providing access to traditional forms of sport. There is also a strong indigenous bowls competition between towns in the North West of NSW including Bourke and Walgett.

Service NSW gives priority consideration to directly affected staff from agencies such as Roads and Maritime Services (RMS) and Fair Trading. Since 2013, more than 75 per cent of those recruited to Service NSW are from the affected agencies.

The recruitment process was signed off by the Public Service Association in the Industrial Relations Commission.

Service NSW and partner agencies provide considerable support to assist staff who are applying for Service NSW positions.

Answer-

The Fairfield Motor Registry continues to deliver Roads and Maritime services.

Service NSW will continue to plan the network design to best meet customer needs and value for money.

- \*6551 TRAIN NOISE—Mr Alex Greenwich asked the Minister for Transport, and Minister for the Hunter—
  - (1) What are the trends in train and rail noise complaints in the inner city?
  - (2) How will the Government prevent noise from Eastern Suburbs Line trains impacting on adjacent Edgecliff and Woolloomooloo residents?
  - (3) How will the Government prevent train noise from impacting on residents adjacent to the City Circle railway lines at Circular Quay?
  - (4) How will the Government prevent noise from train horns impacting on residents adjacent to tunnels?
  - (5) What noise reduction programs are currently being trialled?
    - (a) What action is the Government taking to inform affected communities about these trials?
  - (6) What further action will the Government take to reduce rail noise impacts?

Answer-

I am advised:

All practical measures are taken to reduce noise from trains, the tracks and other structures across the rail network. This includes rail and train wheel profile grinding and the removal of track surface irregularities to reduce noise.

- \*6552 OXFORD STREET TRAFFIC—Mr Alex Greenwich asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, Minister for the North Coast, and Vice-President of the Executive Council—
  - (1) What assessment has the Government made of The Paddington Society and BIKEast March 2013 collaboration entitled "Oxford Street, Paddington: Proposal to Redesign a Thoroughfare Consistent with Paddington as a Village"?
  - (2) What action has been taken since community representatives presented this proposal to senior officers at Roads and Maritime Services?
  - (3) What determination has the Government made of the redeveloped Kensington High Street, London, where changes were designed to improve safety and access while maintaining traffic flow?
  - (4) What changes are being considered for Oxford Street traffic?
  - (5) What changes are planned to reduce speed limits and clearway hours following the successful reduction during afternoon peak hours?
  - (6) What changes are planned to improve pedestrian safety and access?
  - (7) What changes are planned to improve cycling safety and access?
  - (8) What changes are planned to improve bus travel times?
  - (9) What further action will the Government take to improve Oxford Street traffic conditions?

Answer-

I am advised:

The Paddington Society and BIKEast proposal to reduce Oxford Street to a single traffic lane with a wide central median and bus lane is not in line with current Government plans.

Oxford Street forms part of three strategic bus corridors, and traffic volumes along this route indicate at least two traffic lanes are required in peak periods.

When Roads and Maritime Services carries out an independent strategic review of the corridor in the 2015-16 financial year it will seek City of Sydney Council's input.

- \*6553 KINGS CROSS VENUES WITH A STRIKE—Mr Alex Greenwich asked the Deputy Premier, Minister for Trade and Investment, Minister for Regional Infrastructure and Services, Minister for Tourism and Major Events, Minister for Hospitality, Gaming and Racing, and Minister for the Arts—
  - (1) How many of the 19 licensed premises in the Kings Cross Precinct that have a strike against them under the Kings Cross Plan of Management:
    - (a) Have an on-premises licence that relates to a restaurant;

- (b) Close at or before midnight each day;
- (c) Are deemed high risk venues; and
- (d) Have been issued a strike for breaches of additional conditions for the Kings Cross Precinct that would not have been issued elsewhere in New South Wales?
- (2) Of the venues in Kings Cross that have an on-premises licence that relates to a restaurant and have a strike against them:
  - (a) How many received strikes for failing to provide alcohol sales data; and
  - (b) How many received strikes for other breaches, and what were these breaches?
- (3) What assessment has the Government made of the benefit of requiring the provision of alcohol sales data from restaurants that close at or before midnight?
- (4) What assessment has the Government made on the impost of providing alcohol sales data on restaurants that close at or before midnight?
- (5) Excluding the infringement charge for the strike, what costs will these restaurants incur if the strike given affects risk based licensing which commences next year, including additional fees for having a strike, capacity based fees and the Kings Cross Precinct loading?
- (6) For how many years will the strike issued to these restaurants result in increased fees under the risk based licensing scheme?
- (7) What information has the Government provided to restaurants with a strike about how it will affect risk based licensing costs so that these restaurants can make an informed decision on whether to challenge the strike in court?
- (8) What consideration will the Government give to removing the requirement on restaurants in the Kings Cross Precinct to provide alcohol sales data?

#### Answer-

- (1) As at 28 November 2014:
  - (a) 16, including four restaurants holding an on premises licence that also relate to catering, accommodation and a public entertainment venue.
  - (b) 11.
  - (c) 6.
  - (d) 18.
- (2) The Office of Liquor, Gaming and Racing publishes a Three Strike Register on its website, which is updated quarterly, containing information on Kings Cross venues with strikes recorded against them.
- (3) The Government introduced alcohol sales data reporting requirements from 1 January 2014 for licensed venues in Kings Cross to help inform the ongoing development of regulatory policy and enforcement strategy for that precinct. Insufficient time has passed to properly assess the utility of having a complete data set available from all licensed venues across all alcohol sales time periods in Kings Cross versus having a subset available which does not include data relating to restaurants.
- (4) The collection of alcohol sales data is ongoing. However, the Government has responded to concerns that some restaurants are experiencing difficulty in complying with hourly data recording requirements. The Government is amending the Liquor Regulation 2008 to limit hourly alcohol sales data recording in the Kings Cross precinct to high risk venues only, with all other premises in the precinct to be subject to a requirement to record daily alcohol sales.
- (5) Licensed premises will pay a base fee and a trading hours risk loading in 2015 under the risk based licence fee scheme. The compliance history risk loading, patron capacity risk loading and location risk loading commence in 2016.

The compliance history risk loading for a licensed venue will be:

- \$3,000, if one strike is in force;
- \$6,000 if two strikes are in force; and
- \$9,000 if three strikes are in force.

A patron capacity risk loading will be incurred if a venue has a compliance history risk loading. This loading will be as follows:

- \$1,000 for venues with a capacity of 60 patrons or less;
- \$3,000 for venues with a capacity of 61-120 patrons;
- \$5,000 for venues with a capacity of 121-300 patrons; and
- \$8,000 for venues with a capacity of 301 + patrons.

Licensed premises in a prescribed precinct, including Kings Cross, that are subject to compliance loading will also be subject to a \$2,000 location risk loading.

(6) A strike remains in force for three years. Venues that have incurred a strike since 15 March 2013 will

incur a compliance loading in 2016.

(7) The incurrence of a strike relies upon the commission of a prescribed offence. Licensees are entitled to argue their case before the courts where an offence is alleged to have been committed.

In September 2014, the Office of Liquor, Gaming and Racing wrote to all licensed premises in New South Wales to inform them of their licence fee estimate for 2015, and to provide them with information to assist with any decisions they need to make in relation to their licence and the risk based licence fee payable. The Office of Liquor, Gaming and Racing has also been liaising with Restaurant and Catering NSW and other peak bodies to provide their members with information about the scheme.

The Office of Liquor, Gaming and Racing has also published information about the risk based licence fee scheme on its website, and provides updates via its e-news service to industry stakeholders. Further written advice to industry will be provided in the first quarter of 2015.

- (8) Refer to answer to question (3).
- \*6554 METHAMPHETAMINE USE—Mr Alex Greenwich asked the Minister for Health, and Minister for Medical Research—
  - (1) What data does the Government have regarding the use of methamphetamine in the wider community and the trends in its use?
  - (2) What data does the Government have regarding the use of methamphetamine in the inner city?
  - (3) What inner city programs does the Government provide to:
    - (a) Address the prevention of methamphetamine use;
      - (b) Educate users about minimising harms; and
      - (c) To intervene or treat problematic use?
  - (4) What further action will the Government take to address increasing use of methamphetamine?

### Answer-

I am advised that:

- (1) and (2) The National Drugs Strategy Household Survey (NDSHS) 2013 report yields detailed information on alcohol, tobacco, and other drug use within Australia. The Alcohol and Other Drug Treatment Services (AODTS) in Australia 2012-13 report presents the latest annual snapshot of information about publicly funded alcohol and other drug treatment service agencies.
- (3) and (4) The Government continues to intervene and treat methamphetamine use through:
- 24 hour state-wide telephone services, including the Alcohol and Drug Information Service and the Drug and Alcohol Specialist Advisory Service.
- Local Health Districts provide inpatient and outpatient withdrawal management services and psychosocial intervention.
- The Stimulant Treatment Program is a specialised treatment option located at St Vincent's Hospital in Darlinghurst.
- Hospital Drug and Alcohol Consultation Liaison services are located in major hospitals across New South Wales.
- NSW Health provides treatment for people who have entered the criminal justice system.
- Non-government organisations deliver a large proportion of drug and alcohol treatment services in New South Wales through a series of grants managed both through the Ministry and by the Local Health Districts.
- The Government provides funding to support over 1000 treatment places in non-government service types.
- \*6555 DRAFT MASTER PLAN FOR THE ROYAL BOTANIC GARDENS, SYDNEY AND THE DOMAIN—Mr Alex Greenwich asked the Minister for the Environment, Minister for Heritage, Minister for the Central Coast, and Assistant Minister for Planning—
  - (1) How many submissions were made in response to the Draft Master Plan for the Royal Botanic Gardens, Sydney and the Domain exhibited in April?
    - (a) What concerns were raised in these submissions?
    - (b) What assessment has the Government carried out of this feedback?
  - (2) How will the Government ensure that plans maintain these unique environs without alienation and commercialisation?
  - (3) How will the Government ensure that plans maintain priority for botanic science purposes and passive recreation?

- (4) Will the Draft Master Plan:
  - (a) Retain all the site in public ownership;
  - (b) Ensure the current levels of green open space are retained;
  - (c) Increase the tree canopy and ensure that trees are not removed to provide views;
  - (d) Preclude hotels and other inconsistent development;

#### Answer—

I am advised as follows:

- (1) 113 submissions were received.
  - (a) The public feedback covered a broad range of issues including the impact of potential construction on the Gardens and surrounding sites, the need for greater public transport access and the number of events in Domain.
  - (b) The Trust is reviewing all submissions.
- (2) The Trust remains committed to its Vision, which includes "to protect and nourish a much-loved institution so that it can thrive and evolve, and continue to provide the people of Sydney and tourists from around the world with beautiful gardens and parks to enjoy for a further 200 years".
- (3) The Government continues to support botanic science purposes and passive recreation at the Royal Botanic Gardens through a recurrent budget allocation. In addition the Royal Botanic Gardens is bound by its Act to maintain priority for systematic botany and plant conservation.
- (4) (a) to (g) These issues will be addressed as part of the Conservation Management Plan and the final review of the public consultation and finalisation of the Master Plan process.
- (5) All priorities of the Draft Master Plan were opened for discussion as part of the public consultation process.
- (6) The Draft Master Plan and the outcomes of the community consultation are currently being considered.
- \*6556 VOLUNTEERS AT MOUNT DRUITT HOSPITAL—Mr Richard Amery asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
  - (1) What changes, if any, are being planned by the management of Mount Druitt Hospital that would affect the current role of volunteers raising funds for the hospital?
  - (2) Are there plans to stop volunteers from accessing the current kiosk and gift shop at the hospital?

Answer—

This question should be directed to the Minister for Health.

- \*6557 METHADONE CLINIC IN MOUNT DRUITT—Mr Richard Amery asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
  - (1) Were any complaints made to the local Police concerning the operations of the the former methadone clinic in Queen Street, St Marys?
    - (a) If so, what plans are in place to ensure that the operation of the new methadone clinic, near the entrance to Mount Druitt Hospital, is carried out with safety to neighbouring homes and passersby in mind?
    - (b) Did officials from Mount Druitt hospital hold discussions with Police concerning this matter?

#### Answer-

The NSW Police Force has advised me:

Mount Druitt Local Area Command has confirmed that local police did not receive any complaints about the former methadone clinic in St Marys.

Police are conducting regular patrols in the vicinity of the new clinic, in line with normal operational policing procedures, and are liaising with NSW Health and staff of the Mount Druitt/Blacktown Drug and Alcohol Service with regard to security at the clinic.

\*6558 CONSTRUCTION PROJECTS IN ROOTY HILL—Mr Richard Amery asked the Minister for Transport, and Minister for the Hunter—

- (1) Does the Government have information about the increased unit construction around Rooty Hill?
- (2) Does this information advise that there will be an increase in residents living in units near Rooty Hill Railway Station?

- (1) and (2) This is a matter for the Minister for Planning.
- (2) (a) and (b) The Government's Transport Access Program is delivering accessible, modern, secure and integrated transport infrastructure where it is needed most. This includes station upgrades, better interchanges and commuter car parks. This program includes more than \$770 million for improvements over four years.

More planning and design work will now occur to see which projects will come next. Rooty Hill Station will be considered as part of this process.

The Transport Access Program is part of the Government's commitment to improve public transport services and provide a world-class transport system people want to use.

- \*6559 AFFORDABLE HOUSING—Mr Robert Furolo asked the Minister for Family and Community Services—
  - (1) What is the status of the Affordable Housing Taskforce's report into affordable housing in New South Wales?
  - (2) What action has the Government taken in response to the Taskforce's Draft Report and any subsequent report(s)?
  - (3) What is the status of the State Environmental Planning Policy, affordable housing Choice that was identified in the Affordable Housing Taskforce's Draft Report?

#### Answer—

I am advised by the Department of Family and Community Services that this matter falls within the portfolio responsibilities of the Hon Pru Goward MP, Minister for Planning.

- \*6560 CHEMOTHERAPY SERVICES—Mr Jamie Parker asked the Minister for Health, and Minister for Medical Research—
  - (1) Which NSW Health chemotherapy services charge a chemotherapy co-payment for each original script, and what does this represent as a proportion of all chemotherapy services in New South Wales?
  - (2) How many different chemotherapy drugs are prescribed, on average, to a patient in their first cycle of chemotherapy?
  - (3) How many chemotherapy patients were charged a chemotherapy co-payment?
  - (4) What percentage of the total number of chemotherapy patients were charged a chemotherapy copayment?
  - (5) What percentage of the total number of chemotherapy patients were admitted as outpatients?
  - (6) What percentage of the total number of chemotherapy patients were admitted as "privately referred non-admitted" patients?
  - (7) Why did the Government refrain from signing the Federal Government's Public Hospital Pharmaceutical Reforms when they were introduced nationally?
  - (8) Why won't the Government sign onto the Federal Government's Public Hospital Pharmaceutical Reforms now?
  - (9) Why aren't chemotherapy patients admitted as inpatients in New South Wales?

### Answer-

### I am advised:

(1) to (9) Modern chemotherapy treatment practice does not usually require admission to a hospital. This approach is preferred by the majority of patients who would rather go home at the end of each treatment.

Most patients would be prescribed between one and three chemotherapy agents in their first course of chemotherapy. Data on patients who did, or did not pay a co-payment are not collected centrally.

The previous Government declined to sign up to the Commonwealth Government's pharmaceutical reforms.

- 24 hour trauma support and a peer support program managed by a psychologist.
- Beyond Blue mental health training.
- The NSW Police Force and the NSW Police Association jointly sponsored the recent [late October and early November 2014] speaking tour on "Emotional Survival for Law Enforcement" by Dr Gilmartin
- Statewide leadership training for supervisors on injury management, prevention and support.
- Regular programs such as RU OK Day and Mental Health Month.
- Monitoring traumatic incidents at Region, Local Area Command, rank and officer level.
- Implementation of recommendations from project evaluations, such as expanding Wellcheck.
- Mobile nursing services, physiotherapy services and follow up fitness programs.
- New deployment guidelines and psychological job analysis tools for injured officers.

We have also formed the Self-Harm Prevention Partnership, with members representing the NSW Police Force, the Police Association of NSW, the NSW Coroner, and Ministry for Police and Emergency Services.

The group is examining the causes of death, including suicide, of serving and former police officers. This work will help us get the fullest picture possible of the numbers affected, triggers for suicide and preventative strategies to be adopted.

#### Answer\_

I am advised by Endeavour Energy, as follows:

(1) Endeavour Energy does not record the number of unplanned interruptions based on State or federal electoral boundaries. However, it does collect this data by local government area (LGA). The Cabramatta electorate is largely encompassed within the Fairfield LGA.

There were a total of 167 unplanned interruptions between 1 January and 18 November 2014 in Fairfield LGA, resulting in an average interruption duration of 40 minutes without supply per customer. This compared favourably to the average interruption duration of 56 minutes across the whole Endeavour Energy network for the same period. This level of supply reliability in the Fairfield LGA is similar to that in Blacktown, Liverpool and Parramatta LGAs over this period.

The unplanned interruptions in the Fairfield LGA were caused by either: adverse weather conditions; interference with powerlines from trees, birds, animals and vehicles; switching errors; defective equipment; as well as a small number of unknown causes.

(2) To provide a safe, reliable and efficient electricity supply for customers, Endeavour Energy invested \$22.9 million to improve the overall condition of its network, cater for growth in electricity demand and replacement of ageing assets in the LGAs that comprise the Cabramatta electrorate.

This investment has included redevelopment of Canley Vale Zone Substation and the refurbishment of Cabramatta and Bonnyrigg Zone Substations, as well as augmentation of the transmission and distribution network supplying the Cabramatta electorate.

Cabramatta customers have also benefited from Endeavour Energy's ongoing maintenance programs that keep its network in good working order, such as routine line inspections, streetlight upkeep and other condition-based maintenance.

(3) The Government is responsible for setting reliability standards for the electricity distribution networks. This responsibility will not change as a consequence of the proposed partial lease of the network businesses.

The reliability standards applying to Endeavour Energy are set out as a condition of its licence, determined by the Minister for Resources and Energy. Endeavour Energy is required to publicly report on its performance against the standard in its Network Performance Report, which is available on Endeavour's website.

#### Answer-

(1) and (2) The Government is committed to a disability service system that increases choice and control for people with disability. For this reason, in December 2012 the NSW Government became the first state to sign a historic agreement with the Commonwealth to implement the National Disability Insurance Scheme (NDIS).

The NDIS will provide all participants with an individual funding package, based on an assessment of what is reasonable and necessary support to meet their needs, goals and aspirations. Each person with disability will have full choice and control over their funding and the supports they choose to access.

The NDIS will give individuals, with help from family members, flexibility to design a package of supports tailored to their specific needs, goals and preferences. Their Support Plan will ensure all their needs are met; that supports are delivered in the way that best suits them and their family; and they can change the plan or provider if they are not happy with the support provided or their needs or goals change.

The Government will work closely with people with disability, their families and carers, and the Commonwealth Government to ensure a smooth transition to the NDIS.

Firefighters and their trucks are mobile resources and on any given day, the greater Sydney area is protected by between 96 and 106 permanently staffed fire trucks. The Government has recently boosted the resources of Fire and Rescue NSW, with an additional five water tankers and extra 40 firefighters.

- (2) to (4) Roads and Maritime Services is currently preparing a route strategy along the course of Hillsborough Road and Medcalf Street between Newcastle Inner City Bypass and The Esplanade.

The strategy will identify issues along the route and provide options for improving both safety and traffic efficiency. Cost and feasibility of duplicating Hillsborough Road and upgrading the Chadwick Street intersection will also be assessed.

Any projects arising from the investigation will be considered for future funding.

- \*6596 HILLSBOROUGH ROAD AND CROCKETT STREET INTERSECTION—Ms Jodie Harrison asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, Minister for the North Coast, and Vice-President of the Executive Council—
  - (1) What data does Roads and Maritime Services possess on the frequency of motor vehicle accidents on Hillsborough Road between Warners Bay and Charlestown?
  - (2) How many of these accidents occurred at the intersection of Hillsborough Road and Crockett Street?
  - (3) What steps have Roads and Maritime Services taken to reduce motor vehicle accidents at this intersection?
  - (4) What funding has been allocated for upgrades to this intersection?

#### Answer-

### I am advised:

- (1) In the five year period to December 2013, there were 69 recorded crashes resulting in 35 persons injured on Hillsborough Road, east of King Street/Macquarie Road and west of Charlestown Road.
- (2) In the five year period to December 2013, there were 11 recorded crashes resulting in four persons injured at or within 10 metres of the intersection of Hillsborough Road and Crockett Street, Hillsborough.
- (3) to (5) Roads and Maritime Services is currently preparing a route strategy along the course of Hillsborough Road and Medcalf Street between Newcastle Inner City Bypass and The Esplanade.

The strategy will identify issues along the route and provide options for improving both safety and traffic efficiency. Cost and feasibility of duplicating Hillsborough Road and upgrading the Chadwick Street intersection will also be assessed.

Any projects arising from the investigation will be considered for future funding.

- \*6597 DUBBO BASE HOSPITAL—Ms Linda Burney asked the Minister for Health, and Minister for Medical Research—
  - (1) Will land be identified on the Dubbo Base Hospital site for the provision of child care?
  - (2) How much funding will be available to construct child care facilities on the Dubbo Base Hospital site?
  - (3) Will any site or facility on the Dubbo Base Hospital site be available to Playmates Child Care Centre?

### Answer-

### I am advised:

(1) to (3) An offer of assistance has been accepted by Playmates Cottage to obtain a list of appropriate Crown and Shire Council lands that may be considered for a new site.

The Government has allocated \$91.3 million towards Dubbo Hospital redevelopment stages one and two, with further funding of \$600,000 to plan stages three and four.

- \*6598 NSW LAND AND HOUSING CORPORATION PROPERTIES—Ms Linda Burney asked the Minister for Family and Community Services—
  - (1) How many of the properties owned by the NSW Land and Housing Corporation are currently being

leased for use by not-for-profit organisations to deliver social services?

- (2) Will all of these properties transfer to market based rent upon the expiration of the current lease?

  (a) If so, what are the estimated revenues for these rent increases?
- (3) Will Government funding to lease holding organisations be adjusted to compensate for the increase in rent?

### Answer-

I am advised by the Department of Family and Community Services that there are a number of properties owned by the NSW Land and Housing Corporation which are leased to not-for-profit organisations as community or neighbourhood leases. These leasing arrangements commenced up to two decades ago.

- \*6599 PESTICIDES TO CONTROL THE FRUIT FLY POPULATION—Mr Richard Amery asked the Minister for Primary Industries—
  - (1) When did the Australian Pesticides and Veterinary Medicines Authority determine that a product called Dimethoate, sold under the name of Rogor, was not to be used on edible crops such as citrus?
  - (2) Has the Department of Primary Industries received complaints from citrus growers objecting to the removal of this product because they considered it to be an effective weapon against fruit flies?
  - (3) Is there any evidence that the fruit fly population has increased since Rogor was removed as a product to control them?

#### Answer—

- (1) In October 2011, the Australian Pesticides and Veterinary Medicines Authority suspended the use of dimethoate on a number of food crops due to potential dietary risks. Dimethoate was nominated for review in January 1994.
- (2) Any complaints or submissions regarding the removal of dimethoate should be directed to the Australian Pesticides and Veterinary Medicines Authority because the federal government has governance of this matter.
- (3) There is no research or other scientific evidence to support the claim that fruit fly populations have increased in NSW due to the removal of dimethoate.
- \*6600 MICHELLE MCILQUHAM—Dr Andrew McDonald asked the Attorney General, and Minister for Justice—
  - (1) Is the Attorney General aware of the death of Michelle McIlquham in 2009 and the subsequent Coroner's investigation?
  - (2) Was the Coroner's report from 2012 removed from the Internet?
    - (a) If so, why?
    - (b) If so, will the Coroner's report be made publicly available and when will this occur?

#### Answer-

I am aware that Deputy State Coroner Dillon held an inquest into the very sad and sudden death of this young lady and my sincerest sympathies go out to Michelle's family. The loss of a daughter or son is a tragedy that no family should ever have to face.

The NSW State Coroner is committed to providing families and the community with easily accessible information regarding inquests. The NSW State Coroner website has recently undergone an upgrade of its search functions to include catchwords and phrases to enable the searching for a particular type of death to be more readily detectable. For the upgrade to be undertaken all findings, including Ms McIlquam's, were required to be temporarily taken off the website in order for them to be modified.

I am pleased to advise that as at 21 November 2014, the findings into the death of Michelle Mcllquam has again been posted to the NSW State Coroners website.

The Local Health District has an ongoing annual cost of \$20,000 per annum related to land owned by the District.

Care, maintenance and upkeep of the divested land is a matter for the operator.

(1) to (4) The Hunter Medicare Local is just one of a wide range of locally-based funded organisations that provide counselling services in locations across Newcastle and the Lower Hunter.

There were 36 staff members in January 2014 that were affected by the change. Consultation occurred with the Health Services Union who worked one-on-one with each staff member to identify suitable redeployment opportunities within the District.

Information on the establishment of Primary Health Networks that will continue to oversee the provision of primary healthcare services, including general counselling, is publically available.

#### I am advised:

(1) to (6) Sydney metropolitan and Hunter New England hospitals with capacity to perform surgery for patients with cerebral aneurysms are: John Hunter Hospital; Liverpool Hospital; Nepean Hospital; Prince of Wales Hospital; Royal North Shore Hospital; Royal Prince Alfred Hospital; St Vincent's Hospital; Westmead Hospital; Sydney Children's Hospital and The Children's Hospital at Westmead.

Ward and intensive care beds are not allocated or determined for specific surgeries, but allocated depending on clinical need.

The length of time a patient remains in intensive care or on a ward post-surgery is dependent on their clinical need.

- \*6604 CESSNOCK CORRECTIONAL CENTRE—Mr Clayton Barr asked the Attorney General, and Minister for Justice—
  - (1) Is Cessnock Correctional Centre now fully operational with all areas of the Centre opened and staffed?
    - (a) If so, how many inmates can the Centre incarcerate in the Minimum Security Section?
    - (b) If so, how many inmates can the Centre incarcerate in the Maximum Security Section?
    - (c) If so, how many full time equivalent (FTE) staff are employed at the Centre?

- \*6605 REMOVAL OF THE NEWCASTLE RAIL LINE AT WICKHAM—Mr Clayton Barr asked the Minister for Transport, and Minister for the Hunter—
  - (1) What will be the total cost to remove the Newcastle Rail Line at Wickham?
  - (2) Has any core sampling been done to measure and determine the level of asbestos contaminants in the soil under the existing rail line?
  - (3) Has any core sampling been done to measure and determine the level of any other contaminants in the soil under the existing rail line?
  - (4) Will the asbestos under the existing rail line be removed as a part of the proposed works?
  - (5) How much funding has been allocated to the removing or dealing with the asbestos along the rail corridor?

- (4) to (6) A contamination remediation strategy will be developed in accordance with the Environmental Planning and Assessment Act.

The cost of any remedial actions required will be determined once this strategy has been determined.

(7) Development of the first composite braking materials, which contained asbestos, began in NSW in about 1963.

The change over to non-asbestos composite braking materials on the suburban and freight fleets commenced in 1983 and was completed in 1984. The XPT fleet was changed over by mid-1988.

\*6606 AUSTRALIA-CHINA FREE TRADE AGREEMENT—Mr Clayton Barr asked the Deputy Premier, Minister for Trade and Investment, Minister for Regional Infrastructure and Services, Minister for Tourism and Major Events, Minister for Hospitality, Gaming and Racing, and Minister for the Arts—

What industries in New South Wales are expected to benefit from the Federal Government's free trade agreement between Australia and China?

#### Answer\_

The proposed China-Australia Free Trade Agreement (ChAFTA) provides for immediate improvement in access for New South Wales services, most manufacturing sectors and certain resources and agricultural sectors.

New South Wales agricultural industries that are expected to benefit from the reduction or removal of tariffs, typically over 4 to 9 year period, are sheep meat, wine, beef, horticultural and dairy industries.

New South Wales's resources sector is expected to benefit from the removal of tariffs on coal and other mineral commodities. These will be phased out over a period of up to 4 years.

Some of New South Wales's advanced manufacturing industry is expected to benefit from the removal of tariffs on entry into force or phased out over four years. Based on limited details released by the Federal Government, this includes pharmaceuticals, vitamins, health products, and certain medical devices and appliances.

New South Wales service providers are expected to benefit from improved market access, improved temporary work visa access and recognition of qualifications, particularly in education, but also financial and professional services.

\*6607 IMPACT OF FREE TRADE AGREEMENT ON PRIMARY INDUSTRIES—Mr Clayton Barr asked the Minister for Primary Industries—

What primary industries in New South Wales are expected to benefit from the Federal Government's free trade agreement between Australia and China?

#### Answer-

Department of Primary Industries is working to increase awareness of the potential benefits of the China Australia Free Trade Agreement (FTA) to farmers and primary industry associations and is exploring ways to make best use of all three FTA's announced this year to maximise benefits to New South Wales.

The China-Australia Free Trade Agreement (ChAFTA) is expected to give Australia a significant advantage over major competitors in the Chinese agriculture market the US, EU and Canada.

Examples of New South Wales primary industries that will potentially benefit from ChAFTA include:

- The beef industry, which set new export records to China in 2013.
- The sheepmeat industry, which will see tariffs reduced from 12-23 per cent to zero within eight years, and the removal of the 18 per cent tariff on frozen sheep meat within seven years.
- The dairy industry, which will benefit from the removal of the 15 per cent tariff on baby formula
  within four years and tariffs being reduced or removed from processed products such as ice cream,
  cheese, butter and yoghurt, as well as reductions on liquid milk and milk powders. All of these tariff
  reductions or removals achieved in under 11 years.
- The wool industry will benefit through a country specific quota of 30,000 tonnes of clean wool, in addition to the existing WTO quota and to the benefit of New South Wales wool producers, this quota allocation is growing at five per cent per year to 2024.
- The wine industry will benefit from the elimination of tariffs between 14-20 per cent within four years, making New South Wales's great wines competitive in the Chinese market.
- A range of horticulture industries benefit from the removal of tariffs, some as high as 30 per cent within four to eight years.
- Seafood tariffs will be reduced within four years and some of these, such as oysters, scallops and mussels, are as high as 14 per cent.
- The Grains industry will benefit with the removal of tariffs in this very competitive segment of the world market with measures within the FTA also covering cotton seeds, malt and gluten barley.
- The pork industry is a beneficiary through the elimination of tariffs as high as 20 per cent within the

next four years.

• The food manufacturing and processing sectors are also beneficiaries with tariffs on a large number of processed foods being removed over the next four to eight years. Again, some of these tariffs are as high as 30 per cent.

Beaumont Street and Lucky Charm newsagencies (both approximately 700m from Hamilton Station) and The Transit Store at Hamilton Station.

students. These policies are guided by relevant legislation including the NSW Children and Young Persons (Care and Protection) Act 1998 which aims to protect students from foreseeable risk of harm and provide guidance regarding what is reasonably practicable to ensure their safety.

The NSW Sexual Health in Schools project is a partnership between the NSW Department of Education and Communities and the NSW Ministry of Health. This professional learning explicitly addresses inclusive practices and strategies to support students from diverse backgrounds including students who are same sex attracted and/or gender questioning.

The school counsellor has an important role to play in supporting the student and their family. School counsellors also assist in organising appropriate referrals for students to relevant local services.

Schools work closely with the student and their parents or carers to ensure the needs of students are met in a timely and supportive way.

The Government is strongly committed to ensuring schools are safe, supportive and productive learning environments for all students. Schools play a very important role supporting, enhancing and building wellbeing.

I am advised:

Customer feedback is appreciated. We will continue to closely monitor South Line services.

Since the introduction of the October 2013, data shows that patronage is up and crowding is easing.

- \*6645 ROADS AND MARITIME SERVICES FIVE DOCK—Mr Guy Zangari asked the Minister for Finance and Services—
  - (1) When will Roads and Maritime Services cease operating out of its current premises in Five Dock?
  - (2) How many people are employed at Roads and Maritime Services Five Dock?

Answer-

- (1) The Five Dock Motor Registry continues to deliver Roads and Maritime services. Service NSW will continue to plan the network design to best meet customer needs and value for money.
- (2) Five Dock Motor Registry has 17 employees.
- \*6646 REPLACEMENT FIREFIGHTER DEPLOYMENT—Mr Barry Collier asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
  - (1) How many times were the following fire stations taken offline due to staff absences from 21 December 2013 to 21 November 2014:
    - (a) Miranda Fire Station:

- (b) Sutherland Fire Station; and
- (c) Menai Fire Station?
- (2) In each case, from which fire station(s) were firefighters deployed to replace firefighters from the station taken offline?

#### Answer-

Fire and Rescue NSW has advised me:

- (1) (a) 5 shifts out of 670 shifts.
  - (b) 13 shifts out of 670 shifts.
  - (c) 11 shifts out of 670 shifts.
- (2) Firefighters from Leichhardt, Mascot, The Rocks and Newtown fire stations were deployed to replace fire crews at Miranda fire station. Firefighters from Botany, Maroubra, The Rocks, Redfern, Concord, Glebe, Leichhardt and Mascot fire stations were deployed to replace fire crews at Sutherland fire station. Firefighters from City of Sydney, Redfern, Woollahra, Balmain, Ashfield, Mascot and Botany fire stations were deployed to replace fire crews at Menai fire station.

The Government has recently announced funding for Fire and Rescue NSW to recruit an additional 40 firefighters and to commission five state-of-the-art tankers. The new tankers provide additional capability on Total Fire Ban days, during bush fires and severe weather events. A new tanker was delivered to Miranda fire station on 24 November 2014 and will be staffed by additional firefighters. The additional firefighters will also be used to help ensure that full-time fire stations in Sydney are online and available to respond to fires and other emergencies.

- \*6647 MIRANDA FIRE STATION—Mr Barry Collier asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
  - (1) Given the recent large redevelopment of Westfield Miranda, is the Minister confident that Miranda Fire Station has sufficient specialised equipment to deal with a fire at such a large centre?
  - (2) When the Miranda Fire Station is taken offline, will the Minister take steps to ensure that replacement fire crews are trained in the use of such specialised equipment?

### Answer-

Fire and Rescue NSW has advised me:

- (1) Fire and Rescue NSW has specialised equipment to respond to fires or other emergencies at large structures such as the Westfield Miranda shopping centre.
- (2) Commissioner Mullins of Fire and Rescue NSW advises that firefighters who operate specialised equipment are suitably trained and certified. If firefighters from Miranda require specialised support, they request this by radio.
- \*6648 OYSTER BAY CONTAMINATION—Mr Barry Collier asked the Minister for the Environment, Minister for Heritage, Minister for the Central Coast, and Assistant Minister for Planning—
  - (1) What is the extent of the contamination of soil and groundwater, in terms of area, caused by the operation of the Shell Service Station in Carvers Road, Oyster Bay?
  - (2) Why has it taken four years for Shell to begin the clean-up of such contamination, which includes known carcinogens?
  - (3) What oversight has the Environment Protection Agency undertaken of the voluntary clean-up of the site and surrounding area by Shell?
  - (4) Will the Minister commission and make publicly available a full report of the contamination and clean-up by Shell?

### Answer-

I am advised as follows:

The contamination referred to is limited to the service station site and a number of adjacent properties. The affected properties have been purchased by Shell to facilitate remediation.

The remediation by Shell is regulated by the Environment Protection Authority (EPA) under the Contaminated Land Management Act 1997. The remediation is an iterative process, involving the purchase of the residential properties, tank replacement, delineation of contamination and remediation of the plume.

Reports in relation to the contamination and remediation are publically available from the EPA.

\*6649 RAIL TIMETABLE REVIEW—Mr Barry Collier asked the Minister for Transport, and Minister for the Hunter—

- (1) Will the Minister undertake a full review of the Sydney rail timetable before 28 March 2015?
  - (a) If so, will the Minister consider restoring all morning peak hour train services cut from Jannali and Como Station by the 20 October 2013 timetable?
  - (b) If so, will the Minister restore direct morning peak hour services from the Shire stopping at Kogarah Station between 7:30am and 9:50am?

#### Answer-

I am advised:

Load data and Transport for NSW's independent Customer Satisfaction Index shows that, since the introduction of the October 2013 timetable, there has been an increase in customer satisfaction, an increase in patronage and crowding is easing.

- \*6650 COAL SEAM GAS EXPLORATION—Mr Barry Collier asked the Minister for Natural Resources, Lands and Water, and Minister for Western NSW—
  - (1) Can the Minister assure the people of the Sutherland Shire that there will be no coal seam gas exploration or mining in the catchment area of the Woronora Dam?
  - (2) How many applications have been made and/or approved for coal seam gas exploration or mining in the Woronora catchment area?

#### Answer-

Questions relating to the approval process for coal seam gas exploration or mining should be directed to the Minister for Resources and Energy.

The Government is committed to protecting New South Wales water resources, and has established the most comprehensive regulatory regime for natural gas extraction in the Commonwealth in order to do so. The following measures have been taken to institute this regime:

- Introduced a new Water Monitoring Framework to map, monitor and protect groundwater resources across New South Wales. For the first time in Australia, computer modelling will be used, in conjunction with groundwater baseline data, to map and protect underground water resources in New South Wales.
- Introduced the Aquifer Interference Policy to protect our water supplies.
- Introduced the Strategic Land Use Policy to safeguard the environment and balance co-existence.
- Established the Office of Coal Seam Gas to properly regulate and oversight natural gas operations.
- Conducted an audit of all existing licences and applications to ensure companies are abiding by the conditions of their licences.
- Issued 'Show Cause' notices to companies that have failed to comply with those conditions, have failed to use the title area in good faith for the purpose in which it was granted, or for contravening the Act.
- Banned the use of BTEX chemicals in coal seam gas fracture stimulation fluids.
- Introduced 2 kilometers exclusion zones around residential areas.
- Introduced the Well Integrity Code of Practice to ensure world's best practice drilling techniques are used
- \*6651 REZONING OF UNIVERSITY ROAD, MIRANDA—Mr Barry Collier asked the Minister for Planning, and Minister for Women—
  - (1) Is the Minister aware of the proposal by Sutherland Shire Council to rezone University Road, Miranda, from 1 and 2 storey dwellings to 8 storey flats as part of its 2013 Local Environment Plan?
  - (2) Will the Minister consult the Miranda Public School community regarding the negative impacts that such a proposal will have on the special needs children of Miranda Public School, and their programs and therapy?
  - (3) Will the Minister seek a report on the impacts of the proposal as referred to in (2) and consider such a report with a view to retaining the present zoning of University Road, Miranda?

# Answer-

I am advised:

Council has passed a resolution to defer the site from the Draft Local Environment Plan.

- \*6652 ADAMSTOWN LEVEL RAIL CROSSING—Ms Jodie Harrison asked the Minister for Transport, and Minister for the Hunter—
  - (1) What efforts have been made to reduce waiting times at the Adamstown level rail crossing over the past 4 years?
  - (2) What is the current average wait time for traffic when a commuter train passes?
  - (3) What is the current average wait time for traffic when a freight train passes?
  - (4) What plans does the Government have to fix this congestion point?

Answer-

I am advised:

Closure times vary depending on train type and length, the direction of travel and train stopping patterns.

Roads and Maritime Services is undertaking an Inner Newcastle Traffic Study to investigate options to address congestion, which includes the Adamstown Railway Level Crossing and surrounding road network

The Government will continue to work with Council to deliver improvements to traffic congestion at this location.

- \*6653 MANUFACTURING JOBS—Ms Jodie Harrison asked the Minister for Transport, and Minister for the Hunter—
  - (1) Was the impact on local jobs considered when assessing tenders for Government contracts to build train, bus or ferry fleets?
  - (2) What predictions of job losses have been made by the Department?
  - (3) What support services will be provided to any manufacturing worker who loses their job due to tenders going interstate or offshore?

Answer-

I am advised:

Procurement is undertaken in line with NSW Government Procurement Guidelines.

Australian-based companies are given every opportunity to tender for NSW Government contracts through a fair and transparent process.

- \*6654 HEXHAM-FASSIFERN FREIGHT BYPASS—Ms Jodie Harrison asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, Minister for the North Coast, and Vice-President of the Executive Council—
  - (1) What effect has QR National's construction of the Hexham rail hub had on the future construction of a Hexham to Fassifern freight bypass?
    - (a) Who was consulted as part of this construction?
  - (2) What plans does the Government currently have to progress the construction of a Hexham-Fassifern freight bypass?

Answer—

I am advised:

A Lower Hunter Freight Corridor can complement investments by Aurizon and the Australian Rail Track Corporation at Hexham.

The major projects register on the Department of Planning and Environment website lists key stakeholders consulted regarding the approved Aurizon Train Support Facility at Hexham.

The 2014 State Infrastructure Strategy recommends the allocation of \$100 million toward corridor identification and preservation, which includes the Lower Hunter Freight Corridor. Consultation with the community, local councils and industry will be a key priority before a decision is made regarding a future corridor.

- \*6655 HUNTER SPORTS HIGH SCHOOL—Ms Jodie Harrison asked the Minister for Education—
  - (1) What was the original budget figure announced for the upgrading of Hunter Sports High School in June 2014?
  - (2) What is the current financial commitment from the Government to the upgrade?
  - (3) What planning has been undertaken and who is being consulted on the upgrade of Hunter Sports High School?

- (4) What parts of Hunter Sports High School will be upgraded?
- (5) When will construction commence?
- (6) When will construction of the upgrade be completed?

#### Answer—

(1) to (6) A project to upgrade the facilities at Hunter Sports High School was announced in the 2014-15 State Budget. The budget figure for the project has not been announced as the project has not gone to tender.

The masterplan for the school is currently being finalised as part of the first stage of the design process.

### \*6656 VIOLENCE IN SCHOOLS—Ms Jodie Harrison asked the Minister for Education—

- (1) How many incidents of violence and drug use was there in schools in the Charlestown electorate in each year from 2011 to 2014?

- (4) What arrangements are in place to ensure that students attending schools in the Charlestown electorate can attend appointments with a school counsellor in a confidential manner, without other students knowing about the appointment?
- (5) What support is available for teachers and support staff in schools in the Charlestown electorate to deal with incidents of violence, drug use and bullying?
- (6) Has the nature of the support available to teachers and support staff to deal with incidents of violence, drug use and bullying in schools in the Charlestown electorate changed over the last four years?

#### Answer—

- (1) Serious incident data collected by the Department is available on the Department website, broken down by region.
- (2) and (3) Annual allocations of school counsellor days are based on student enrolments, equity loadings, number of support classes and number of students on funding support.
- (4) Each school determines the most appropriate processes to assist students to attend appointments with the school counsellor in a confidential manner. This takes into account the school's context and physical layout, and student age.
- (5) and (6) The Department of Education and Communities' Safety and Security Directorate provides support to schools through a 24 hour a day, 7 days a week incident support hotline. Schools receive expert advice and support from seconded police officers and incident support officers to assist with the management of incidents. The Directorate also provides specialised incident management training to school staff to enable them to deal effectively with incidents that may occur.
- \*6657 FIRE STATION CLOSURES—Ms Jodie Harrison asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
  - (1) How many staff are currently employed in fire stations across the Charlestown electorate?
  - (2) On how many occasions have stations had to be temporarily closed due to lack of staff and/or funding in the past four years?
  - (3) Was the community notified when these fire stations were closed?
  - (4) What arrangements have been made to prevent such closures in the future?

#### Answer-

### Fire and Rescue NSW has advised me:

- (1) 81 staff, comprising Permanent and Retained (on-call) firefighters, are employed across the Charlestown electorate.
- (2) There are no occasions that a fire station has been temporarily closed in the Charlestown Electorate in the past four years due to lack of staff and/or funding.
  - Primary fire engines, staffed by permanent firefighters, are always online. However, secondary fire engines, staffed by retained firefighters, have been off line at Tingara Heights, Charlestown and Cardiff fire stations, for periods ranging from 30 minutes to 24 hours due to unavailability of retained firefighters. All fire engines are fully staffed on days of Total Fire Ban or severe weather events, even if this involves working of overtime.

- (3) No. Fire stations in the Charlestown electorate have not been closed.
- (4) Fire and Rescue NSW has not closed fire stations in the Charlestown electorate. Fire and Rescue NSW has strategies in place to maintain a full complement of firefighters.
- \*6658 ASSISTANCE FOR PEOPLE UNDER 65 WITH A DISABILITY—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
  - (1) Following the introduction of the National Disability Insurance Scheme (NDIS), what services will be available to people under 65 who are not classified as having a disability under the Act but who are unable to look after themselves after being discharged from hospital?
  - (2) What services will be available to provide assistance to these people with showering, house cleaning and transportation to and from appointments?

Answer-

I am advised:

NSW Health provides short term health services after a person is discharged from public hospital based on the person's clinical need, including Community Packages (ComPacks), community nursing and allied health services.

- \*6659 AMBULANCE STATION STAFFING SHORTAGES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
  - (1) Will the Government employ additional paramedics at Belmont, Cessnock, Nelson Bay and Birmingham Gardens Ambulance Stations to address the shortfall in staffing levels?
    - (a) If not, why not?

Answer-

I am advised:

There is no shortfall in staffing levels at these stations.

\*6660 SCIENTIFIC RESEARCH FUNDING—Ms Sonia Hornery asked the Deputy Premier, Minister for Trade and Investment, Minister for Regional Infrastructure and Services, Minister for Tourism and Major Events, Minister for Hospitality, Gaming and Racing, and Minister for the Arts—

What steps is the Deputy Premier taking to ensure that there is adequate funding for scientific research in New South Wales?

Answer-

In 2014-15 Budget, the Government committed \$14 million to support innovation and investment in the state's Research and development capacity under the Research Attraction and Acceleration Program, which is administered by the Office of Science and Research.

- \*6661 THE COMMONWEALTH SCIENTIFIC AND INDUSTRIAL RESEARCH ORGANISATION IN NEW SOUTH WALES—Ms Sonia Hornery asked the Deputy Premier, Minister for Trade and Investment, Minister for Regional Infrastructure and Services, Minister for Tourism and Major Events, Minister for Hospitality, Gaming and Racing, and Minister for the Arts—
  - (1) Can the Deputy Premier outline the Government's commitment to science research in New South Wales?

- (1) The Government has committed to and supported a number of programs to drive investment in Research and development and achieve those goals.

#### Answer-

The Inner City Schools Working Party will deliver its recommendations as part of the Inner Sydney Primary and Secondary School Asset Strategy.

### \*6663 REGIONAL CONSERVATORIUMS—Mr Ryan Park asked the Minister for Education—

- (1) What are the reasons for the delay in regional conservatoriums receiving funding that was due in early November 2014?
  - (a) Are directors being forced to go into overdraft to pay their staff as a result of this delay?
  - (b) Could this delay result in some conservatoriums potentially facing insolvency?
- (2) What action is the Minister taking to ensure funding is being expedited?
- (3) Can the minister provide assurances that processes will be in place to ensure that this situation will not occur again?

- \*6669 REVENUE FROM PRIVATELY OWNED RADARS—Mr Clayton Barr asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, Minister for the North Coast, and Vice-President of the Executive Council—
  - (1) Are privately owned radar operators permitted to set up on the side of a road without displaying the signage that is required by law?
    - (a) If so, why?
  - (2) How much revenue does the State collect from fines generated by privately owned radars?
  - (3) How much revenue does the operator make from each fine generated by a privately owned radar?

Answer-

I am advised:

- (1) Roads and Maritime Services requires independent contractors to display signage when conducting operations.
  - All mobile speed camera vehicles in New South Wales are clearly marked, with two warning signs around 250 metres and 50 metres before the vehicle and another up to 50 metres after the vehicle.
  - Procedures are in place to ensure that signage is placed in the most visible location, and regular audits are conducted.
  - Signage is part of our high visibility approach to speed camera enforcement and is advisory, and not required by law.
- (2) Fines from speed and red-light cameras are directed into the Community Road Safety Fund for road safety programs, including the new Safer Drivers Course for learner drivers and funding the roll-out of school zone flashing lights to all schools in the State, as well as initiatives such as enhanced high visibility police enforcement operations and engineering works.
  - Information on the number of penalty notices issued and their value is published on the Office of State Revenue website.
- (3) Private operators of mobile speed cameras are paid per enforcement hour and receive no payment or incentive for infringements issued.

\*6670 SHORT TERM LETTING AND OVERCROWDING IN APARTMENTS—Mr Alex Greenwich asked the Minister for Planning, and Minister for Women—

- (1) Which councils have met with the Government to discuss barriers to preventing short term letting and overcrowding in apartments?
- (2) What barriers have been identified by the Government that would prevent councils from accessing apartments in order to obtain sufficient evidence to prove the illegal use of an apartment through short term letting or overcrowding?
- (3) Will the Government give powers to local councils to access apartments where there is evidence of short term letting or overcrowding?
