*4150 EASY ACCESS AT ROOTY HILL RAILWAY STATION—Mr Richard Amery asked the Minister for Transport—

With regard to the funding in the budget for easy access to railway stations:

What is the timetable for the installation of easy access facilities for the Rooty Hill Railway Station?

Answer-

On 23 April 2012, the NSW Government announced a new Transport Access Program which will deliver accessible, modern, secure and integrated transport infrastructure where it is needed most. This includes station upgrades, better interchanges, ferry wharf upgrades and commuter car parks.

The Transport Access Program includes funding of more than \$770 million over four years, which will see improvements at more than 60 locations.

More planning and design work will now occur to see which projects will come next and Rooty Hill Station will be considered as a part of this process.

*4151 RUNNING OF 413 BUS SERVICE—Ms Linda Burney asked the Minister for Transport—

- (1) Is the Minister aware that the 413 bus service is still unreliable?
- (2) What is the Minister's proposal to alleviate this situation?
- (3) How often does the State Transit Authority monitor and review the bus services?

Answer-

I am advised:

A Service Review is planned for bus services from the Kingsgrove Depot, including the 413 service, next year. This will include a review of patronage demand that will establish whether any adjustment of service frequencies is required.

*4152 ADDITIONAL 413 BUS SERVICE—Ms Linda Burney asked the Minister for Transport—

Does the Government have any plans to add an additional 413 bus service to the existing morning route, to accommodate the increase in patronage?

Answer—

Please refer to the answer provided to LA Question 4151.

- *4153 CYCLISTS ROAD SAFETY—Ms Linda Burney asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) What are the current statistics for prosecution/enforcement for motorists who do not overtake safely, and do not leave enough space when overtaking a bicycle rider?
 - (2) How do current statistics compare with the previous year?
 - (3) Does NSW hold the worst Australian State statistics for cyclist fatalities and injuries?
 - (4) What is the Government proposing to combat these road offences to protect all road users?

Answer—

I am advised:

(1) and (2) This is a matter for the NSW Police.

(3) Australia wide cyclist injury statistics are not collected in a consistent format suitable for meaningful comparison between States.

(4) Transport for NSW is developing a new Cycling Safety Strategy and Action Plan for bicycle riders and investing in cycling infrastructure improvements across the NSW network.

Transport for NSW is also supporting the Amy Gillett Foundation to raise safety awareness among bicycle riders and other road users, starting with the "A Metre Matters" and "Stop on Red" campaigns.

*4154 PEDESTRIAN OVERHEAD BRIDGE - CANTERBURY—Ms Linda Burney asked the Minister for Transport representing the Minister for Roads and Ports—

How often does the Roads and Maritime Services review, clean and maintain the pedestrian overhead bridge at Canterbury Road and Church Street, Canterbury?

Answer—

I am advised:

Cleaning of the lifts and pedestrian bridge are scheduled weekly with maintenance carried out by Roads and Maritime Services when defects are identified or reported. Additionally, Roads and Maritime Services undertake a detailed structural inspection of the bridge once every two years.

- (1) Legal advice and minor assistance is not means tested.
- (2) Legal Aid NSW is unable to extract data to determine the exact number of grants approved for legal representation that fall within the special disadvantage policy.

*4156 INMATE POPULATION—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

- (1) As at 1 June 2013 what was the full-time inmate population of Corrective Services NSW facilities?
- (2) What was the daily average remand inmate population in Corrective Services NSW facilities during:
 - (a) 1 January 2011 to 30 June 2011;
 - (b) 1 July 2011 to 31 December 2011;
 - (c) 1 January 2012 to 30 June 2012;
 - (d) 1 July 2012 to 31 December 2012;
 - (e) 1 January 2013 to 31 May 2013?

Answer—

I am advised by Corrective Services NSW that:

- (1) As at 1 June 2013, the full-time inmate population was 10,042. This figure includes inmates on remand.
- (2) The daily average remand inmate population during:
 - (a) 1 January 2011 to 30 June 2011 was 2747;
 - (b) 1 July 2011 to 31 December 2011 was 2646;
 - (c) 1 January 2012 to 30 June 2012 was 2613;
 - (d) 1 July 2012 to 31 December 2012 was 2575;
 - (e) 1 January 2013 to 31 May 2013 was 2820.
- *4157 CRIMINAL MATTERS LEGAL ASSISTANCE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many people do you estimate will no longer receive legal assistance from the Legal Aid Commission in relation to criminal matters in the Local Court where a prison sentence is a possibility for the period 1 July 2013 to 30 June 2014?

The relevant policy change regarding legal aid in Local Court defended matters has not yet been

implemented.

In any event, grants of legal aid in relation to criminal matters in the Local Court where a prison sentence is a possibility are not expected to be affected during the specified period.

Under Section 42U(1) and (4) of the Aboriginal Land Rights Act 1983 community development levies collected by the Chief Commissioner of State Revenue are remitted to the NSW Aboriginal Land Council for payment into the NSW Aboriginal Land Council Community Fund. *4164 TEMPE HIGH SCHOOL CAPITAL WORKS—Mr Ron Hoenig asked the Minister for Education—

With regard to the Department of Education submission to the Total Asset Management (TAM) Plan to the NSW Treasury:

What major capital works projects that the Sydney Region Asset Reference Group considered were of higher priority in the region to the request of Tempe High School for a creative arts/performance space and new hall?

Answer-

The Department of Education and Communities submits a prioritised Total Asset Management (TAM) Plan to NSW Treasury each year, in response to emerging asset and facilities requirements in government schools throughout the state. To prepare the annual TAM Plan, each region prioritises major and minor capital works projects for their respective schools.

In 2013-2014 there were 13 nominated projects in the Sydney Region that were assessed by the Sydney Region Asset Reference Group as having a higher regional priority than the Tempe High School major capital works nomination.

*4165 EASTLAKES SHOPPING CENTRE—Mr Ron Hoenig asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—

With regard to the Eastlakes shopping centre development application:

- (1) What was the detail of discussions held between officers of the Department and the proponent?
- (2) What information was communicated by the Department to the proponent?
- (3) Did the Department indicate in any way to the proponent what should be contained in the application?
- (4) Has the Minister investigated the matters I have personally conveyed to him in relation to the handling of the application?

Answer-

- (1) These discussions were related to either the assessment process or the assessment of the merits of the proposal.
- (2) The Department communicated with the Proponent on a range of matters relating to either the assessment process or the assessment of the merits of the proposal.
- (3) The Department had no role in determining what should be contained in the application.
- (4) I am advised that all processes have been conducted in accordance with the policies of the Department.
- *4166 RENT ASSESSMENT INCLUDING CLEAN ENERGY SUPPLEMENT—Mr Clayton Barr asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—

By assessing the Clean Energy Supplement as a source of income and at an assessment rate of 25 per cent, what will be the fortnightly increase to Housing NSW's income from Social Housing Rent?

Answer—

NSW Land and Housing Corporation estimates that additional rent of 1.26 per cent per fortnight will be collected as a result of the increase in assessable income. Funds from rental income are used to support maintenance and other operational costs.

- *4167 JOINT REGIONAL PLANNING PANEL—Ms Sonia Hornery asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—
 - (1) On what dates will the Joint Regional Planning (JRP) Panel sit to determine the proposal for a \$1.1 million expansion of Soldiers Point Marina?

(2) Who is on the JRP Panel?

- (1) Port Stephens Council has advised that it is still addressing assessment matters associated with the proposal. A likely date for a public determination meeting is the 26 September 2013.
- (2) For this Development Application, the Hunter and Central Coast Joint Regional Planning Panel will be:

 - Ms Kara Krason;

*4168 MINING ROYALTY REVENUE—Ms Sonia Hornery asked the Deputy Premier, Minister for Trade and Investment, and Minister for Regional Infrastructure and Services—

Under the Resources for Regions programs:

What steps has the Government taken to ensure that the Hunter Region communities affected by mining get an adequate and fair share of mining royalty revenue?

Answer—

- *4169 JOHN HUNTER HOSPITAL EMERGENCY DEPARTMENT—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) What is the Government doing to improve waiting times at John Hunter Hospital Emergency Department?
 - (2) Why does John Hunter Hospital Emergency Department have fewer staff than some Sydney Hospital Emergency Departments, which treat fewer people?
 - (3) What percentage of patients presenting to John Hunter Hospital Emergency Department in the past 12 months are not being treated within the Federal Government's four hour benchmark?

Answer-

I am advised:

(1) to (3) The John Hunter Hospital Emergency Department is appropriately and fully staffed, noting that staffing is dependent on demographics, number of patients and the services the Hospital provides. The Emergency Department's patients are triaged before registering with clerical staff. The 'fast track area' where minor injuries are treated is being reviewed and an Early Treatment Zone is being developed where suitable patients can be treated in the waiting room.

John Hunter Hospital has also enrolled in the "Whole of Hospital" program being introduced across the whole State. The program is aimed at improving access to care, but particularly focused on achieving improved patient flow.

*4170 MINMI PUBLIC TRANSPORT IMPROVEMENTS—Ms Sonia Hornery asked the Minister for Transport—

Given that the size and scope of the proposed development at Minmi is for an additional 3000 dwellings, how and when will the existing bus and train service be augmented to serve the increased population?

Answer—

I am advised:

New or additional services for Minmi will be considered as part of Transport for NSW's yearly Growth Buses program.

- *4171 WHITEBRIDGE LAND SELL OFF—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) What steps is the Government taking to ensure that Whitebridge residents are fully included in the decision making process regarding the sale of the Roads and Maritime Services (RMS) owned land in Whitebridge?
 - (2) (a) Does the Government recognize the importance of the land's biodiversity and its proximity to the renowned Fernleigh track?

(b) If so, why is the Government considering the sale of the land?

Answer-

I am advised:

NSW Government policy requires disposal of surplus property following the completion of appropriate pre-disposal activities. Roads and Maritime Services staff have met with local residents earlier in 2013,

and will meet with owners adjoining its land holding in Lonus Avenue, Whitebridge to communicate the disposal process.

The environmental value of the land and the adjacent conservation area is protected through appropriate zoning, with approximately 85 per cent of the Roads and Maritime Services land holding in Lonus Avenue, Whitebridge zoned Environmental Protection 7(2) Conservation (secondary).

*4172 SYDNEY PORTS CORPORATION—Mr Jamie Parker asked the Minister for Transport representing the Minister for Roads and Ports—

- (1) Which commercial wharves in Sydney, not used for Cruise Passenger Terminals, will remain in public ownership following the lease of Port Botany?
- (2) Have there been any discussions or plans for Sydney Ports to intensify port uses and freight movements at White Bay and Glebe Island?
- (3) Has there been consideration of the concerns of Leichhardt Council and the community regarding the traffic congestion that will result if all port traffic for White Bay and Glebe Island is not contained within a separate port road? If so;
 - (a) What impact?
 - (b) What steps have been taken to address these concerns?
- (4) Will all traffic for White Bay and Glebe Island be contained within a separate port road?
 - (a) If not, what portion of traffic relating to White Bay and Glebe Island will use the local council road network?
- (5) What are the reasons for not containing all port traffic for White Bay and Glebe Island on a separate port road?
- (6) What research and analysis is being undertaken of the costs and transport benefits of retaining versus removing Glebe Island Bridge?
- (7) What is the community consultation plan relating to the decision to retain or remove Glebe Island Bridge?
- (8) What consideration has been given to reinstating the Glebe Island Bridge as a pedestrian way, cycleway and potentially for Light Rail?
- (9) What is the current position of Roads and Maritime services on whether to retain or remove the Glebe Island Bridge?
- (10) What is the foreseen percentage of the Bays Precinct to be allocated for community use for open space and recreational purposes?
- (11) Will the Minister commit to undertaking a comprehensive analysis of the economic, recreational, cultural and social benefits of establishing sporting fields at White Bay and in the Rozelle Railway Marshalling Yards?

Answer-

I am advised:

(1) All of the wharves at Glebe Island and White Bay except White Bay Wharf 4 and White Bay Wharf 5.

(2) Refer to Volume 1 of the Bays Precinct Taskforce Report (August 2012).

(3) A dedicated port road has been constructed from the intersection of The Crescent and James Craig Road specifically for passenger access to the White Bay Cruise Terminal on ship days. This road removes passenger terminal traffic from local roads.

Sydney Ports undertook extensive consultation with Leichhardt Council and the local community as part of the development of the White Bay Cruise Terminal.

(4) and (5) A sub-committee of the Bays Precinct Implementation Committee is investigating the feasibility of a separate port road to Glebe Island and White Bay.

(6) to (8) Transport for NSW is overseeing an independent cost benefit analysis of the options for retaining or removing the Glebe Island Bridge. Consultation with key stakeholder groups, including local councils, is being undertaken as part of this process.

(9) Roads and Maritime Services will implement any future Government decision on retention or removal of the Glebe Island Bridge.

(10) A key priority is to investigate more open space and recreational opportunities at the head of Rozelle Bay. Opportunities will be assessed on a site-by-site basis.

(11) The Government has announced five priority tasks it will focus on in response to the recommendation of the Bays Precinct Taskforce. Other issues identified by the Taskforce will be examined in the coming months.

- *4173 SYDNEY PORTS CORPORATION INCOME—Mr Jamie Parker asked the Treasurer, and Minister for Industrial Relations—
 - (1) What portion of the income of Sydney Ports Corporation is;
 - (a) Currently generated by Port Botany?
 - (b) Expected to be generated by Port Botany following the lease of Port Botany to the NSW Ports Consortium?
 - (2) What was the income of Sydney Ports Corporation for the;
 - (a) 2011-2012 financial year?
 - (b) 2010-2011 financial year?
 - (3) What is the projected income of Sydney Ports Corporation for the 2012-2013 financial year?
 - (4) What impact will the lease of Port Botany to the NSW Ports Consortium have on the income of Sydney Ports Corporation for the 2013-2014 financial year?
 - (5) Is the annual income of Sydney Ports Corporation expected to decrease following the lease of Port Botany to the NSW Ports Consortium?
 - (6) Has any work been done to calculate how Sydney Ports Corporation will make up for the income shortfall as a result of the leasing of Port Botany?

Answer—

(1) to (3) Financial information on the Sydney Ports Corporation is available in its annual reports.

(4) and (5) On 31 May 2013 the Government announced the long term lease of Port Botany and Port Kembla to the NSW Ports Consortium for \$5.07 billion. The lease payment of \$5.07 billion incorporates discounted future cash flows attributable to Port Botany over the term of the lease.

The transaction delivered net proceeds of \$4.3 billion to be invested in the NSW Government's infrastructure fund, Restart NSW. The NSW Ports Consortium is comprised mainly of Australian superannuation funds and other highly experienced asset owners who will ensure the ongoing operational integrity of Port Botany.

As a consequence of the receipt of the upfront lease payment for Port Botany, the income of this asset will go to the lessee.

(6) Sydney Ports Corporation continues as a stand-alone entity and will generate revenue in accordance with its operations.

Answer-

I am advised:

(1) and (2) Fees from car parking help support the provision of improved car-parking services for both staff and the public. They ensure that valuable resources are not diverted from clinical services to pay for car parking.

Local Health Districts are responsible for determining car parking fees at existing hospital car parks, except those which are the subject of long-term commercial contracts.

- *4175 NEWCASTLE CALVARY MATER HOSPITAL—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - How many general medicine staff specialists were based at Newcastle's Calvary Mater Hospital in:
 (a) 2007;
 - (b) 2012?
 - (2) What were outpatient numbers at the hospital in:
 - (a) 2007;
 - (b) 2012?
 - (3) How many people used specialist gastroenterology services at the hospital in:
 - (a) 2007;
 - (b) 2012?

Answer—

I am advised:

- (1) to (3) Staffing levels are a matter for Local Health Districts and will, like the number of individual treatments provided, vary over time according to patient need.
- *4176 NATIONAL PALLIATIVE CARE STRATEGY—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Will palliative care services or jobs be reduced after 30 June 2013, when New South Wales becomes responsible for ongoing funding of palliative services initiated under the National Palliative Care Strategy (2010)?
 - (2) Will the Government recommit to the National Palliative Care Strategy?

Answer-

I am advised:

The National Palliative Care Strategy guides palliative care policy development and service delivery across Australia but does not fund palliative care services.

The National Palliative Care Strategy is ongoing and New South Wales continues to commit to the Strategy's important goals related to awareness and understanding, appropriateness and effectiveness, leadership and governance, and capacity and capability.

The 2013-2014 State Budget includes the Government contribution of \$100 million in growth funds to make up for the failure of the Commonwealth Government to continue with essential National Partnership funding for palliative care and rehabilitation services.

*4177 OPHTHALMOLOGISTS SERVICES IN THE HUNTER—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

The Minister states "People who need non-urgent care can continue to see ophthalmologists in their private rooms or offices as Medicare patients" (LA Question 3318).

What ophthalmologists in the Hunter Region can people see as Medicare patients?

Answer—

I am advised:

Any patient can seek an appointment with an ophthalmologist in their private rooms under Medicare. Those specialists may choose to charge a gap fee above the Medicare scheduled fee; this is at their discretion. Appointments with GPs, other local specialists, optometrists and referrals to the state ophthalmic facility are other options.

- *4178 VICTIMS OF SEXUAL ABUSE LIAISON STAFF NEWCASTLE CITY LOCAL AREA COMMAND—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Does the Newcastle City Local Area Command have any staff dedicated to liaising with members of the public who have been the victim of sexual abuse?
 - (2) If so, how many staff members carry out this role?
 - (3) How long have they been doing so?

Answer—

The NSW Police Force has advised me that Detectives attached to the Newcastle City Local Area Command (LAC) provide victim care and liaison when sexual abuse complaints are received, and throughout subsequent investigations.

Sexual assault investigations routinely include referral to support services including Hunter New England Local Health District and where relevant, other local services such as sexual assault counsellors.

Additionally, the Child Abuse Squad attached to the State Crime Command has an office in Newcastle staffed with officers who provide assistance to victims of sexual and other abuse aged 16 and under.

*4179 OPERATION APOLLO—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

What crimes have individuals arrested under Operation Apollo been charged with?

Answer-

The NSW Police Force has advised me that as at 27 June 2013, a total of 566 charges have been laid under Operation Apollo. Specific charges include Acts Intended to Cause Injury; Dangerous or Negligent Acts Endangering Persons; Deception and Related Offences; Illicit Drug Offences; Public Order Offences; Theft and Related Offences; Property Damage and Environmental Pollution; Weapons and Explosives Offences; Offences against Justice Procedures, Government Security and Government Operations; and Road Traffic and Motor Vehicle Regulatory Offences.

*4180 EXPRESS RAIL SERVICES FROM THE HUNTER-Ms Sonia Hornery asked the Minister for Transport-

In preparing for the new CityRail timetable, has there been an investigation into 'express' services between the Hunter and the Sydney terminal?

- (a) If so, what were the results of this investigation?
- (b) If not, why not?

Answer-

I am advised:

The NSW Government is introducing a new rail timetable and has always said it will deliver more services. Once it is finalised we will be able to advise customers of the changes.

Customers will benefit from extra express services across the network as well as changes to stopping patterns that will reduce crowding on many services and provide consistent service times.

*4181 CLOSURE OF NEWCASTLE RAIL LINE-Ms Sonia Hornery asked the Minister for Transport-

*4183 PUBLIC TRANSPORT INFORMATION AND PRIORITY SYSTEM—Mr Robert Furolo asked the Minister for Transport—

In regard to the Public Transport Information and Priority System (PTIPS):

- (1) Is data collected through PTIPS used to obtain on-time running information and monitor the on-time running and reliability performance of specific bus routes?
 - (a) If so, is on-time running information on specific bus routes publicly available?(i) Where is that information published?
 - (b) If not, are there any plans to use the PTIPS data to collect information on the on-time running of individual bus routes?

Answer-

I am advised:

Data collected through the Public Transport Information and Priority System is used as a management tool by Transport for NSW and bus operators to monitor and improve on-time running performance.

It also provides real time information for Sydney Buses services available through smart phone applications TripView, TripGo and Arrivo Sydney, which are available to customers as a new initiative of this Government.

On-time running and reliability performance data is reported on the Transport for NSW website on a regular basis.

*4184 BENCHMARKING OF TRANSPORT AND BUS SERVICES—Mr Robert Furolo asked the Minister for Transport—

With regard to the job description for the position of the Deputy Director General, Transport Services, outlined in the Transport for NSW Annual Report 2011-2012:

- (1) Has the benchmarking of transport services been completed?
 - (a) If not, when will the benchmarking be completed?
 - (b) If so, do they include benchmarking of on-time-running and reliability of bus services?
- (2) Has benchmarking of on-time-running and reliability of bus services been done?

The Government is working hard to ensure customers have access to the best real time transport information.

Information is also available by phone at 131 500 Transport Info, through the 131500.com.au website, the next bus SMS service and Twitter alerts.

*4185 FREIGHT RAIL OPERATIONS ENVIRONMENT PROTECTION LICENCES—Mr Robert Furolo asked the Minister for the Environment, and Minister for Heritage—

In regard to freight rail operations on the Metropolitan Freight Network:

- (1) What operators have been issued with environmental protection licences for freight rail operations on the Metropolitan Freight Network?
- (2) What are the conditions in the licence in relation to noise abatement?
- (3) What enforcement and monitoring is undertaken to ensure licence conditions are complied with?

Answer-

I am advised as follows:

(1) Under the Protection of the Environment Operations Act 1997 rail freight operators are not required to hold environment protection licences. Licences are instead issued to rail track owners.

The Australian Rail Track Corporation and Sydney Trains are the two rail track owners that have been issued with environment protection licences for freight rail operations on the Metropolitan Rail Network.

(2) The licences specify noise limits for new or substantially modified locomotives introduced to the rail network.

(3) Compliance with licence conditions is enforced by the NSW Environment Protection Authority (EPA). Noise monitoring is undertaken for each class of locomotive prior to approval being granted to operate on the metropolitan rail network. If a locomotive does not meet the noise limits in the licence it is not approved for use on the network.

Licence holders are also required to undertake Pollution Reduction Programs to target priority noise issues such as wheel squeal, train horns and locomotive engine noise.

Full details of noise limits, approved locomotives and pollution reduction programs are available for public viewing on the EPA public register.

*4186 HURSTVILLE LOCAL ENVIRONMENT PLAN—Mr Robert Furolo asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—

In regard to the 2012 Hurstville Local Environment Plan (LEP):

- (1) What zoning was recommended by Hurstville City Council for the area of Peakhurst bounded by Jacques Avenue, Forest Road, Pearce Avenue, Trafalgar Street and Lawrence Street?
- (2) What was the process by which the Department of Planning and Infrastructure determined the zoning for this area should be R3?

- (1) R2 Low Density Residential.
- (2) This site was exhibited in the draft LEP as R3 Medium Density Residential. Following exhibition, Council resolved to change this zoning back to R2. The Department reintroduced the R3 medium density zoning into the final LEP to provide opportunities for greater housing diversity in areas outside the Hurstville City Centre.
- (3) The Department's decision to adopt a zoning of R3 was based on strategic planning principles such as allowing medium density housing on sites with good access to public transport and existing services.

This was supported by Council's own studies which identified this area as being suitable for increased residential densities.

- (4) There are no appeal rights once land has been rezoned under a Local Environmental Plan.
- (5) The draft Metropolitan Strategy for Sydney highlights the urgent need to provide housing and jobs close to transport and services. This Government is committed to delivering more housing and jobs and will continue to work with Councils as part of this process.
- *4187 FUNDING FOR ROAD PAVEMENT AND UPGRADES—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

Routine maintenance, including delimitation and pothole repairs, is carried out across the network on all Roads and Maritime Services' maintained roads including Old Canterbury Road.

Additional funds will enable NSW to deepen and accelerate already announced reforms, including Great Teaching, Inspired Learning.

The Illawarra Shoalhaven LHD released its Health Care Services Plan 2012-2022 - Working Together Building Healthy Futures - in October 2012. The Plan states that Bulli Hospital will become a Centre of Excellence for Aged Care over the next ten years.

Since October 2012, work has been ongoing through the development of detailed Clinical Service Plans, to determine the service delivery models that will be delivered from the Bulli Hospital site in order for it to become a Centre of Excellence for Aged Care services for the Illawarra Shoalhaven, and the Local Health District will work to implement these as resources allow.

The Local Health District is currently finalising its Asset Strategic Plan which will identify and prioritise the work that is required to be undertaken at the Bulli Hospital site in order to ensure the physical infrastructure is fit for purpose.

*4200 CYCLIST FATALITIES AND INJURIES—Mr Jamie Parker asked the Minister for Transport representing the Minister for Roads and Ports—

Answer—

I am advised:

- (1) Pedal cycle fatality data for 2012 and 2013 (1 January to 23 June inclusive only) are preliminary as at 24 June 2013 and are subject to change. Pedal cycle injury data for 2012 are preliminary and subject to change. Pedal cycle injury data for 2013 are incomplete at this time and have not been supplied.
 - (a) There were 16 pedal cycle fatal crashes, resulting in 16 pedal cycle fatalities from 1 January 2012 to 23 June 2013. Of the 16 pedal cycle fatalities;
 - four were on roads sign posted 50km per hour;
 - four were on roads sign posted 60km per hour;
 - one was on a road sign posted 70km per hour;
 - four were on roads sign posted 80km per hour;
 - one was on a road sign posted 90km per hour;

- one was on a road sign posted 100km per hour; and
- one was on a road sign posted 110km per hour.
- (b) Of the 16 pedal cycle fatal crashes, there were 13 crashes (with 13 pedal cycle fatalities) which involved a driver or rider of a motor vehicle. These 13 crashes involved 12 cars/car derivative drivers and three light truck drivers. Note that there may be more than one motor vehicle controller involved for a pedal cycle crash.
- (c) The following data detail three variables which cover controller error, controller alcohol and controller distraction. Note that these variables are not mutually exclusive and should not be added together.

Controller error covers items such as where the controller decamped, manipulates controls, avoids vehicles/objects/animals, drives in wrong lane, disobey traffic control, brakes hard, loses control and does not observe pedestrians.

Controller alcohol provides information on whether the alcohol test taken resulted in a blood alcohol concentration level above or below 0.05.

Controller distraction covers items such as illness (sudden & chronic), fatigue, hand held mobile phones and distractions inside and outside the vehicle. It should be noted that it is understood that mobile phone usage as a distraction factor is understated in the crash reporting by the Police.

Of the 16 pedal cycle rider fatalities:

- one had loss of control recorded for controller error;
- two had a blood alcohol concentration (gram per 100mL) of 0.05 or more;
- three had a distraction factor recorded (one was sudden illness, one was distraction outside the vehicle, one was other unspecified distraction).
- (d) (i) Of the 15 motor vehicle controllers involved in a pedal cycle fatality crash, there were none with controller error recorded.

(ii) Of the 15 motor vehicle controllers involved in a pedal cycle fatality crash, there were none with an illegal blood alcohol concentration.

(iii) Of the 15 motor vehicle controllers involved in a pedal cycle fatality crash, there were none with mobile phone recorded as a controller distraction.

- (e) This is a matter for the Minister for Police and Emergency Services.
- (f) This is a matter for the Minister for Police and Emergency Services.
- (2) In 2012 there were 1,009 injury crashes involving a pedal cycle, which resulted in 1,057 injuries and of these 1,028 were injured pedal cyclists.
 - (a) Of the 1,028 pedal cycle injuries:
 - one was on a road sign posted 20km per hour;
 - nine were on roads sign posted 30km per hour;
 - 20 were on roads sign posted 40km per hour;
 - 603 were on roads sign posted 50km per hour;
 - 281 were on roads sign posted 60km per hour;
 - 51 were on roads sign posted 70km per hour;
 - 33 were on roads sign posted 80km per hour;
 - two were on roads sign posted 90km per hour;
 - 16 were on roads sign posted 100km per hour;
 - six were on roads sign posted 110km per hour; and
 - six on roads with unknown sign posted speeds.
 - (b) Of the 1,009 crashes involving a pedal cycle injury, 842 crashes involved a motor vehicle controller (resulting in 854 pedal cycle injuries). There were a total of 852 motor vehicle controllers involved in these crashes, of which 659 were car/car derivative drivers, 81 were light truck drivers, 13 were heavy truck drivers, 11 were bus drivers, 7 were motorcycle riders and 81 were other motor vehicle controllers.
 - (c) (i) Of the 1,028 pedal cycle injuries, there were:
 - 87 pedal cycle rider controller errors recorded (including five for pedal cycle rider decamping, 15 for avoiding another vehicle, three for avoiding an object, two for avoiding other, four for overtake left, three overtake right, 20 for disobeying traffic control, nine for braking hard, one for excessive speed, 24 for loss of control and one for other error factor).
 - 36 pedal cycle riders with a blood alcohol concentration of 0.05 or more.

- 78 pedal cycle riders with a distraction factor (including seven for sudden illness, 60 for outside distractions, two for emergency vehicles within earshot and nine for other distraction factors).
- (d) (i) Of the 852 motor vehicle controllers involved in a pedal cycle injury crash, there were 144 with controller error recorded (including 73 for motor vehicle controller decamping, three for manipulating the controls, three for avoiding a vehicle, two for overtaking left, four for overtaking right, one turning right into wrong lane, one turning left into wrong lane, 39 where the motor vehicle driver disobeyed a traffic control, 16 with braking hard and two for loss of control).

(ii) Of the 852 motor vehicle controllers involved in a pedal cycle injury crash, there were was one motor vehicle controller with an illegal blood alcohol concentration.

(iii) Of the 852 motor vehicle controllers involved in a pedal cycle injury crash, there were was one motor vehicle controller with a hand held mobile phone as a distraction factor.

*4203 NEEDLE AND SYRINGE PROGRAMS IN PRISONS—Mr Alex Greenwich asked the Minister for Health, and Minister for Medical Research—

Noting that the rate of infectious blood borne diseases of Australian prisoners is several times higher than the general population and the 2009 Health Inmate Survey found that 43 per cent of prisoners had used illicit drugs and nearly all those who injected reported sharing needles:

- (1) What programs and initiatives does the Government provide to prevent the spread of blood borne diseases between injecting drug users in prisons?
- (2) What progress has the Government made on considering a trial of a needle and syringe program in prisons?
- (3) Is the Government aware of the ACT Alexander Maconochie Correctional Centre needle and syringe program trial?
- (4) What assessment has the Government made of the ACT Alexander Maconochie Correctional Centre needle and syringe program trial?
- (5) What plans does the Government have to provide needle and syringe programs in prisons?

(6) What further action will the Government take to prevent the spread of HIV, Hepatitis B or Hepatitis C or other health conditions?

Answer-

I am advised:

(1) The NSW Justice and Forensic Mental Health Network (JFMHN) provides blood borne virus prevention education, testing and treatment in NSW prisons. The NSW Ministry of Health is aware and monitoring the progress of the ACT Alexander Maconochie Correctional Centre needle exchange trial, which is still in the consultation phase.

In addition to the work of the NSW JFMHN in prisons, the NSW Ministry of Health is committed to reducing the number of new HIV and hepatitis C infections attributed to injecting drug use in the general community through an improvement in the coverage of the public and pharmacy Needle and Syringe Programs across the State.

- (2) and (5) Questions two and five should be directed to the Attorney General and Minister for Justice.
- (3) to (4) and (6) The NSW JFMHN provides blood borne virus prevention education, testing and treatment in NSW prisons. The NSW Ministry of Health is aware and monitoring the progress of the ACT Alexander Maconochie Correctional Centre needle exchange trial, which is still in the consultation phase.

*4204 OMBUDSMAN RESOURCES-Mr Alex Greenwich asked the Premier, and Minister for Western Sydney-

Noting that NSW Police have re-opened investigation into the death of Scott Johnson and claim more than 50 other suspicious deaths during the 1980 and 1990 that could also have been gay hate crimes, but may not have been identified as such:

- (1) What resources does the Government provide to the Ombudsman to carry out inquiries into the investigation of these deaths?
- (2) How many staff does the Ombudsman have available for significant investigations of systemic problems?
- (3) How many major reviews does the Ombudsman have awaiting investigation?
- (4) How many staff does the Ombudsman have available for investigation of individual complaints?
- (5) How many individual complaints does the Ombudsman have awaiting investigation?
- (6) Will the Government provide additional resources for a full review of unexplained deaths or other cases that could have been gay hate crimes?

Answer-

I am advised that:

A new Coronial inquest in June last year made an open finding regarding Mr Scott Johnson's death in December 1988, and the NSW Police Force's Unsolved Homicide Team has formed Strike Force Macnamir to review Mr Johnson's case.

The Police are appealing to the public for assistance and are offering a \$100,000 Government reward for information in relation to Mr Johnson's death and possible murder.

If fresh evidence is found regarding suspicious deaths from the 1980s and 1990s, the Police have the option to re-open cases and investigate any leads.

The Ombudsman is an independent statutory office which reports directly to Parliament and is overseen by the Joint Parliamentary Committee on the Office of the Ombudsman, the Police Integrity Commission and the Crime Commission.

The functions of the office of the Ombudsman include the power to oversight the investigation of complaints about police conduct. The Government cannot, nor should it attempt to, direct the Ombudsman in the exercise of his functions.

Information about staffing and numbers of reviews and complaints processed and finalised by the Ombudsman's office is published in the Ombudsman's Annual Report. Information about the funding of the Ombudsman's office is published in the 2013-2014 Budget Papers.

It is a matter for the Ombudsman as to how he allocates the funding provided to his office in general for

his complaint resolution, investigation, oversight and scrutiny functions.

*4205 MOTOR CYCLE NOISE STANDARDS—Mr Alex Greenwich asked the Minister for Transport representing the Minister for Roads and Ports—

With regard to the offensive noise disturbance from motor cycles, particularly in densely populated inner city areas:

- (1) What advocacy has the New South Wales Government carried out with other States/ Territories and the Commonwealth Government to provide better noise standards for motor cycles?
- (2) What action is the Government undertaking with the National Transport Commission to reduce noise emissions from motor cycles?
- (3) What current plans does the Government have underway to prevent offensive noise impacts from motor cycles?
- (4) What further action will the Government take to better protect inner city residents from motorcycle noise impacts?

Answer—

I am advised:

(1) Transport for NSW is represented on all the key national vehicle standards setting committees. For new vehicles, the applicable safety and performance standards are the Australian Design Rules.

The principal forum is the Strategic Vehicle Safety and Environmental Group that identifies those standards that require attention. The Australian Motor Vehicle Certification Board and the Technical Liaison Group maintains and develops Australian Design Rules.

For in-service vehicles, Transport for NSW is on the Australian Vehicle Standards Rules Maintenance Group that sets standards for registered vehicles. The requirements for motorcycle noise are sufficient in both these sets of standards Australian Design Rules for new vehicles and the Australian Vehicle Standards Rules for in-service vehicles.

- (2) As the Australian Design Rules apply to new vehicles, and as state legislation requires vehicles to continue to comply with the Australian Design Rules once registered, it is appropriate that matters relating to motorcycle noise are dealt with by the Strategic Vehicle Safety and Environmental Group, the Australian Motor Vehicle Certification Board and the Technical Liaison Group, all of which are convened by the Federal Department of Infrastructure and Transport.
- (3) and (4) Currently in New South Wales, on-road enforcement through the NSW Police detect offensive noise from motorcycles. Additionally, NSW Police carry out strategic joint operations with the Environmental Protection Authority that targets areas where motorcycle noise has been a problem.

Further, annual safety checks are required for motorcycles more than five years old.

*4206 VACANT INNER CITY SOCIAL HOUSING PROPERTIES—Mr Alex Greenwich asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—

Noting that the Committee of Residents Elected (CORE) has identified 39 vacant social housing properties in Millers Point, Dawes Point and The Rocks:

- (1) As of 20 June 2013, are there:
 - (a) four vacant properties in Dalgety Terrace;
 - (b) one vacant property in Merriman Street;
 - (c) 14 vacant properties in High Street;
 - (d) four vacant properties in Kent Street;
 - (e) four vacant properties in Argyle Street;
 - (f) six vacant properties in Lower Fort Street;
 - (g) three vacant properties in Trinity Avenue;
 - (h) two vacant properties in Cumberland Street?
- (2) How many properties has the Government identified as vacant, and on which streets are they located?
- (3) How many of these properties:
 - (a) are considered suitable for letting;
 - (b) need minor repairs in order to be suitable for letting;
 - (c) are included in the review of public housing?
- (4) How does the Government ensure that properties do not fall in to further disrepair or suffer

vandalism, unauthorised occupation or theft of heritage fixtures while vacant?

- (5) What is the annual cost to the Land and Housing Corporation for securing and maintaining vacant properties in this area?

 - (c) All properties are being considered as part of the Government's evaluation of public housing.
- (4) NSW Land and Housing Corporation monitors the condition of vacant properties and a security service helps deter vandalism and unauthorised occupation.
- (5) Costs to maintain and secure the properties are minimal.
- (6) and (7) The vacant properties are considered unsuitable for renting. Housing NSW manages the allocation of tenants on the waiting list.
- *4207 INNER CITY SOCIAL HOUSING ALLOCATION—Mr Alex Greenwich asked the Minister for Family and Community Services, and Minister for Women—

With regard to the social housing allocations in Millers Point, Dawes Point and The Rocks:

- (1) Is Housing NSW not allocating empty homes in this precinct, including homes that are in letting condition?
- (2) What assessment has the Government given to providing homes that are in letting condition to those on the waiting list such as:
 - (a) temporary accommodation for homeless people;
 - (b) emergency accommodation for those at risk in their current home;
 - (c) rehousing local tenants whose homes are unsafe and need major repairs?
- (3) Over the past five years, how many tenants in this precinct have been asked to relocate temporarily or permanently because their home is unsafe or unliveable?
- (4) How many tenants in this precinct are currently being asked to relocate because their home is deemed unsafe or unliveable?
- (5) What action will the Government take to increase the effective use of vacant properties and allow current tenants to remain in this precinct?

Answer-

- (3) and (4) Since 2011, four households have been relocated due to unsafe/unliveable conditions.

- *4208 KINGS CROSS ADOLESCENT UNIT—Mr Alex Greenwich asked the Minister for Family and Community Services, and Minister for Women—

Noting that there has been coordinated action to prevent young people at risk from living rough in Kings Cross where they are at risk of drug use and drug dealing, street sex work and exploitation:

- (1) How long has the Kings Cross Adolescent Unit been operating?
- (2) How many caseworkers work from this centre?
- (3) How many clients are recorded for this service in the past five years?

- (4) What plans does the Government have for the future of this service?
- (5) How does the Government intend to provide these services in future?
- (6) What further action will the Government take to prevent young people ending up on the street in Kings Cross?

Answer-

Over recent years, there has been a steady reduction in the number of referrals of child protection reports to the Kings Cross and Central Sydney Adolescent Unit.

A review of reports received in the central metropolitan region relating to adolescents shows that there is significant need for a child protection adolescent response in areas across the region, rather than just focussed within the Kings Cross and Central Sydney area.

Caseworkers in the Kings Cross Team will transfer to a new Metro-Central Child Protection Adolescent Response Team, to work intensively with high-needs young people across the region, or to positions working with other vulnerable children and young people.

The 247 Child Protection Helpline After Hours Crisis Response Team provides an after-hours response to young people who are at immediate risk of harm in metropolitan Sydney, including those in Kings Cross.

The Department of Family and Community Services also funds a number of non-government organisations to deliver services to vulnerable young people in inner Sydney, including Kings Cross.

*4209 HOUSING NSW RENT ARREARS—Mr Alex Greenwich asked the Minister for Family and Community Services, and Minister for Women—

With regard to the constituents' reports of increasing problems with incorrect rent calculations and intrusive eviction notices:

- (1) How many tenants have been assessed with rent arrears in the last 12 months?
- (2) How many are in the Sydney electorate?
- (3) How many of these cases have been disputed or appealed?(a) How many of these were the result of incorrect rent calculations?
- (4) How many tenants in the Sydney electorate have been taken to the Consumer, Trader and Tenancy Tribunal (CTTT) for rent arrears?
 - (a) How many tenants have been evicted in the last 12 months?
- (5) How does Housing NSW:
 - (a) ensure rent calculations are accurate;
 - (b) inform tenants about dispute and appeal processes;
 - (c) provide early notice of potential rent problems and advise tenants of problems before formal action is taken;
 - (d) ensure prompt cancellation of eviction notices and CTTT action for rent arrears when disputes are resolved;
 - (e) ensure prompt suspension of eviction notices and CTTT action until appeals of decisions have been processed and outcomes notified to tenants in writing;
 - (f) ensure that rent and arrears payments do not exceed 30 per cent of gross income?
- (6) Do tenants who agree on arrears repayments in order to stop eviction proceedings forfeit their right to appeal the decision?
- (7) Does Housing NSW use the threat of CTTT proceedings to pressure tenants into making payments rather than disputing arrears?
- (8) What action will the Government take to ensure that tenants with alleged rent arrears are treated fairly?

Answer-

Housing NSW complies with the Residential Tenancies Act.

Public housing tenants must keep to the terms and conditions of their tenancy agreement and meet their responsibilities under Housing NSW's tenancy policies. These are available on the Housing NSW website.

Housing NSW only takes eviction action when all other reasonable options have been exhausted or if the breach of the tenancy agreement is extremely serious. Where possible, Housing NSW will assist tenants to rectify a breach and maintain their tenancy.

Rent arrears across the public housing portfolio is currently less than one percent of the total amount of

rent that is payable to Housing NSW.

Details about the number of matters determined by the Consumer, Trader and Tenancy Tribunal are listed in its Annual Report.

*4210 JUNK MAIL—Mr Alex Greenwich asked the Minister for the Environment, and Minister for Heritage—

Noting continuing levels of junk mail being distributed to residents, including large amounts dumped at apartment buildings:

- (1) What data does the Government have about levels of junk mail and unwanted advertising material?
- (2) What action has the Government taken to prevent unwanted junk mail?
- (3) How can junk mail breaches be reported to the Environment Protection Authority?(a) What action is taken following reports?
- (4) What liaison/advocacy has the Government carried out with the Commonwealth and State/Territory Governments to prevent junk mail?
- (5) What liaison/advocacy has the Government carried out with the Distribution Standards Board to ensure compliance with the industry's Code of Practice?
- (6) What further action will the Government take in response to ongoing problems with junk mail?

Answer-

I am advised as follows:

- (1) No data is available about levels of junk mail and unwanted advertising material.
- (2) Under the Protection of the Environment Operations Act 1997, it is illegal to put advertising material under car windscreen wipers, on top of letterboxes, on property gates or fences, in a public place, in open private places and in other inappropriate places where it could become litter. The laws do not cover newspapers, parking fines or material that is too big to fit into a letterbox, newspaper receptacle or under a door, e.g. phone books. Delivery of bulky advertising material should be made to a sensible place or where indicated by the householder, or in such a way that it won't become litter.
- (3) Reports of junk mail and unwanted advertising material can be made to the Environment Protection Authority's (EPA) Environment Line on 131 555 or to the Distribution Standards Board on 1800 676 136.
 - (a) The EPA will accept reports of junk mail and direct these complaints to the relevant local council and the Distribution Standards Board. Under the Protection of the Environment Operations Act 1997, local councils are responsible for enforcing the littering laws. Council officers are authorised to enforce all littering offences, including those for junk mail litter. A council officer can issue an on-the-spot fine of up to \$200 per offence if an individual is caught littering.
- (4) Nil.
- (5) The Environment Protection Authority encourages members of the public to report breaches of the Code of Practice to the Distribution Standards Board, which is the regulatory arm of the Australian Catalogue Association.
- (6) Under NSW 2021: A plan to make NSW number one, the NSW Government has set the target for NSW to have the lowest litter count per capita in Australia by 2016. To achieve this, the NSW Government has allocated \$20 million over the next 4 years under the Waste Less, Recycle More Initiative to reduce littering. The EPA is also working with local councils, Keep Australia Beautiful NSW and communities to develop and fund a new litter prevention toolkit.
- *4211 WOOLLOOMOOLOO SAFETY AUDIT—Mr Alex Greenwich asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—

Noting the response to Question 3595, the submission in December of the 2012 Safety Audit and that the Government owns many of the streets, walkways, footpaths and homes in Woolloomooloo:

*4212 DOMESTIC VIOLENCE—Mr Guy Zangari asked the Minister for Family and Community Services, and Minister for Women—

How does the Government plan to combat high rates of domestic violence in South Western Sydney? Answer—

Reducing all forms of violence, particularly domestic and family violence, is a priority for the Government.

The Government has delivered a robust Domestic and Family Violence Framework of reforms for public consultation. This ensures that community members can have their say about how they see the proposed framework working in their lives or in their community.

*4213 SUPPORT FOR LANGUAGE SERVICES—Mr Guy Zangari asked the Minister for Citizenship and Communities, and Minister for Aboriginal Affairs—

Which community groups have been affected by a reduction in the number of employees providing support for language services?

*4216 WAITING TIME IN EMERGENCY DEPARTMENTS—Mr Guy Zangari asked the Minister for Health, and Minister for Medical Research—

What is the Government doing to improve waiting times in public hospitals for patients requiring treatment in emergency departments?

Answer—

I am advised:

The recent Council of Australian Governments (COAG) Reform Council's report on elective surgery and emergency department performance found that NSW performs strongly compared to all other jurisdictions in relation to emergency department waiting times, with 74 per cent of patients seen within national benchmarks across all triage categories.

Since the signing of the National Health Reform Agreement on Improving Hospital Services, NSW has continued to invest in strategies to achieve the four hour National Emergency Access Target (NEAT).

Key initiatives and strategies have resulted in a revision of NSW 'Emergency Department Models of Care' and subsequent funding for emergency departments to review and improve their processes. NSW is also implementing the Australasian College for Emergency Medicine's Quality Framework for Emergency Departments to ensure that quality care is provided to emergency department patients as the health system moves towards achieving NEAT.

Funding has been provided to 15 or our largest emergency departments to ensure that patients are assessed by a senior doctor soon after their arrival. This is to ensure that tests are ordered quickly, a plan of management is developed and treatment is commenced; this approach significantly decreases the total time a patient spends in the emergency department.

NSW Ambulance plays a vital role in reducing the number of patients requiring transportation to emergency departments through the Extended Care Paramedic (ECP) Program. The ECPs manage patients in alternative care locations within the community and currently treat approximately 23,585 patients per annum.

In addition to this, the 'Whole of Hospital Program' commenced in 2013 and is designed to support Local Health Districts in driving the strategic change needed to improve access to care and patient flow across NSW Health. The fundamental feature of this Program is local leadership, where the Ministry of Health and other health agencies work together to support and facilitate local Program teams to deliver results. This approach will support long term sustainable change in the health system.

The Program will help deliver high quality, safe and efficient health care when people need access to the hospital system. It seeks to strengthen linkages between services to enhance continuity of care. It is about local hospital teams working together on the whole patient journey from when they come into hospital until they leave. By focusing attention on the transition of patients throughout the hospital, this will free up beds in the emergency department and minimise delays to patients receiving care.

*4217 CARRAMAR RAILWAY STATION-Mr Guy Zangari asked the Minister for Transport-

(1) Will Carramar Railway Station be included in this year's Transport Access Program to assist the elderly, disabled and parents with prams?

(2) If so, when will the lifts be installed?

Answer—

On 23 April 2012, the Government announced a new Transport Access Program which will deliver accessible, modern, secure and integrated transport infrastructure where it is needed most. This includes station upgrades, better interchanges, ferry wharf upgrades and commuter car parks.

The Transport Access Program includes funding of more than \$770 million over four years, which will see improvements at more than 60 locations, including a major interchange upgrade and commuter car park at Fairfield Station and a new commuter car park at Canley Vale.

More planning and design work will now occur to see which projects will come next and Carramar Station will be considered as a part of this process.

*4218 LEGAL ASSISTANCE FOR CHILDREN AND PEOPLE WITH DISABILITIES—Mr Guy Zangari asked the Treasurer, and Minister for Industrial Relations—

Under its published Guarantee of Service, NSW Fair Trading aims to finalise 85 per cent of disputes within 30 days of receipt.

Fair Trading is currently implementing the Better Trader Program, which provides an enhanced dispute resolution process that includes an increased focus on trader monitoring and education. Dispute resolution under the Better Trader Program involves a more thorough analysis of complaints and trader history and increased negotiation with traders. While this approach may involve increased resources, and therefore possibly longer time to finalise matters, it results in more effective outcomes for the consumer.

The Better Trader Program also provides quicker compliance response times for emerging issues enabling Fair Trading to act on intelligence earlier and more effectively. The Better Trader Program further enables Fair Trading to engage with traders through education and provide timely advice to the public.

What are the reasons for Fair Trading employing over 120 fewer staff now than since the 2011-2012 Budget?

As part of the Council of Australian Government's National Partnership Agreement to deliver a seamless national economy, seven of the 27 national regulatory reforms directly affected the operations of NSW Fair Trading. The final two reforms requiring Fair Trading involvement were finalised in 2012, with Business Registration Services and Registry of Encumbered Vehicles being transferred to the Commonwealth resulting in a reduction in Fair Trading positions.

Furthermore, as you may be aware, in 2011, the Premier made a commitment to introduce one-stop shops for the delivery of government services across the state. The intent of this commitment is to improve the delivery of government services to the people of NSW and in the first 18 locations, staffing levels are expected to be the same or higher than what currently exists given the extended hours and new roles within the service centres. To assist in achieving this, a budget transfer from Fair Trading to Service NSW was required, which resulted in a reduction in Fair Trading positions.

*4238 ROADS AND MARITIME SERVICES OFFICE AT BANKSTOWN-Ms Tania Mihailuk asked the Premier, and Minister for Western Sydney-

In light of Service NSW shop fronts opening up across NSW, will the Government commit to keeping the Roads and Maritime Services office at Bankstown?

Service NSW was created to deliver better government services in a way that suits our customers, including the delivery of Roads and Maritime Services. This includes one easy-to-use website, a 247 phone service answered by real people in NSW, and extended-hours service centres in regional and city locations. - *4241 CAPITAL EXPENDITURE FOR BANKSTOWN ELECTORATE—Ms Tania Mihailuk asked the Treasurer, and Minister for Industrial Relations—

What specific capital expenditure is there in the 2013-2014 Budget for the electorate of Bankstown? Answer—

Following the release of the 2013-2014 Budget, Members of the Legislative Assembly were provided with reports highlighting capital programs and projects in their electorates.

I am advised the Member for Bankstown was provided with such a report for the Bankstown Electorate.

- *4242 BANKSTOWN-LIDCOMBE HOSPITAL—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—
 - (1) Does the 2013-2014 Budget re-instate the \$1.49 million to Bankstown-Lidcombe Hospital that was cut in the 2012-2013 budget?
 - (2) If not, why not?

Answer-

- (1) and (2) I refer the Member to my response to her earlier LA Question 4041 on this issue.
- *4243 AEROMEDICAL (ROTARY WING) REVIEW—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the recent Ernst and Young review of NSW Aeromedical (Rotary Wing) Retrieval Services:

- (1) Does the Minister agree with the recommendation number 5.4 that NSW Health "increase the operating hours for the Orange service to 24x7 (On Base 10x7 Off Base after hours) by 2014"?
 (a) If so, where in the 2013-2014 budget papers are the funds for this service?
 (b) If not, why not?
- (2) When will the NSW Health response to this report be completed?
- (3) Will the NSW Health response be made publically available?
 - (a) If so, where?

Answer-

I am advised:

(1) to (3) The Reform Plan for Aeromedical (Rotary Wing) Retrieval Services in NSW was released on 17 July 2013 and is available at the NSW Health website at

http://www.health.nsw.gov.au/about/nswhealth/pages/new_helicopter_network.aspx.

The Reform Plan provides the following for the Orange helicopter base:

- 24 hours per day, 7 days per week operation.
- Medical and paramedical staff located on Base improving time to take off.
- New retrieval doctors (1.5 FTE) available for every flight.
- New paramedics (2 FTE) dedicated to helicopter retrieval.
- Improved training for staff.
- \$2.5 million in additional investment for helicopter retrieval services from the Orange helicopter Base from July 2014.

*4244 PARKES AND FORBES HOSPITAL PROJECT—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

- (1) Will the Parkes and Forbes Hospital project be completed as a Public-Private Partnership?
- (2) If so, when will the Government advertise for expressions of interest from private tenders?
- (3) If not, when will this project have its total budget allocated?

Answer-

I am advised:

- (1) to (3) \$2.3 million was provided in the 2012-2013 Budget for planning for the Parkes and Forbes Hospitals project. A further \$12.5 million was allocated in the 2013-2014 Budget to progress the project. When completed in late 2013 the project's business case will identify the Estimated Total Cost required to deliver the prioritised services for the refurbishment of Forbes Hospital and redevelopment of Parkes Hospital.
- *4245 BYRON SHIRE HOSPITAL PROJECT—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Will the Byron Shire Hospital project be completed as a Public-Private Partnership?
 - (2) If so, when will the Government advertise for expressions of interest from private tenders?
 - (3) If not, when will this project have its total budget allocated?

Answer—

I am advised:

- to (3) \$500,000 was provided in the 2012-2013 NSW Budget for planning for the Byron Shire Hospital Project. A business case is being prepared as a part of this commitment which will assess all possible service procurement options.
- *4246 MENTAL HEALTH BEDS IN PARKSIDE CLINIC—Dr Andrew McDonald asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

With regard to the eight publicly funded mental health beds located at the privately run Parkside clinic in Campbelltown Private Hospital:

- (1) Is the Minister aware that this unit is soon to close on 12 July 2013?
- (2) What arrangements have been made for these mental health beds to be re-opened elsewhere?

Answer-

I am advised:

(1) and (2) The Government is committed to improving mental health services across the State.

Eight mental health beds at Campbelltown Private Hospital were temporarily publicly funded until 30 June 2013, to cover the period until South Western Sydney Local Health District's new 20-bed subacute Mental Health Unit at Liverpool Hospital became operational. The new unit at Liverpool was officially opened on 30 May 2013 and became fully operational on 10 June 2013. It will provide services to patients across South Western Sydney Local Health District.

*4247 UPGRADE TO CAMPBELLTOWN ROAD—Dr Andrew McDonald asked the Minister for Transport representing the Minister for Roads and Ports—

With regard to the \$3 million spent in the 2012-2013 budget and \$2 million allocated in the 2013-2014 budget for the Campbelltown Road, Camden Valley Way to Denham Court upgrade (budget paper 4, page 4-49):

- (1) What is the expected total cost of this project?
- (2) What is the expected time of completion for this project?

- (3) Did Roads and Maritime Services conduct a cost benefit analysis of this project?
 - (a) If so:
 - (i) when;
 - (ii) where will it be publically available?
 - (b) If not, why not?

Answer—

I am advised:

- (1) The total strategic cost estimate for this proposal is approximately \$200 million (in 2012 dollars). This strategic cost estimate is being updated to ensure full alignment with the project scope included in the Review of Environmental Factors.
- (2) The upgrade would be phased with the first stage of the project due to start in 2014, subject to planning approval.
- (3) Roads and Maritime Services completed a preliminary cost benefit analysis based on the strategic cost estimate in July 2012. The benefit cost ratio will be reviewed as the estimated cost of the project is updated.
- *4248 EAST LEPPINGTON URBAN DEVELOPMENT—Dr Andrew McDonald asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW, Leader of the House—

With regard to the release of East Leppington as urban development and the rezoning of the surrounding area (Government Gazette, no. 108, 4 November 2011):

- (1) What is the time frame for future development of this area, stages 1A-1F and 1I?
- (2) Where does the development boundary end?
- (3) Is the planned upgrade of Campbelltown Road, Denham Court required for any of the stages 1A-1F of the East Leppington development to proceed?

- (1) The time frame for development is a matter for a developer.

- (3) No.
- *4249 NSW POLICE—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) What is the ratio of police to population in NSW?
 - (2) How does this ratio compare with other Australian states?
 - (3) How many NSW police have been hurt in the line of duty so far this year?
 - (4) How does this compare with the past five years?

Answer-

I am advised:

The Government is committed to providing the NSW Police Force with the resources it needs to keep the community safe and will add 859 officers to boost authorised strength to 16,665 in August 2015. In terms of the allocation of police resources, a range of factors are considered to determine police strength such as crime figures, categories of crime, population and demographics. These are reviewed as changes occur to ensure policing meets demand.

The NSW Police Force database has recorded 6,513 police injuries in the current financial year (to 25 June 2013). This is the lowest number of injuries recorded since 2007-2008.

*4250 REVISED HEALTH BUDGET - LONG SERVICE LEAVE 1—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the 2012-2013 Health Budget and the \$178 Million removed from the revised 2012-2013 Budget for long service leave provision responsibilities due to the change in 10 year Commonwealth bond rates (page 6-16, 2013-2014 Budget Paper 3):

Will the \$241 million projection for the same reason in 2013-2014 be removed from the \$17,871 million 2013-2014 Budget as part of the revised budget in next year's budget papers?

Answer-

I am advised:

The \$178 million was an accounting adjustment that was made to NSW Health's long service leave liability for 2012-2013 to reflect the Treasury's forecast of the 10 year Commonwealth Bond rate that is made available on 30 June each year.

The adjustment for the \$241 million for the 2013-2014 budget estimates has already been made and is not part of this year's \$17,871 million record health budget.

As stated in the Budget papers on page 6-16, this is an actuarial adjustment that has no impact on the level of operating budgets held by Local Health Districts or other NSW Health entities.

*4251 REVISED HEALTH BUDGET - LONG SERVICE LEAVE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the 2012-2013 Health Budget and the \$178 million removed from the revised 2012-2013 Budget for long service leave provision responsibilities due to the change in 10 year Commonwealth bond rates (page 6-16 Budget paper 3):

- (1) Was this money ever received by Health from the Treasury?
- (2) When was the decision taken to remove this money from the revised budget?

Answer-

I am advised:

This is an accounting arrangement to recognise an accrual for the future value of long service leave based on an actuarial assessment. There is no cash associated with this adjustment.

As stated in the Budget papers on page 6-16, this actuarial adjustment has no impact on the level of operating budgets held by Local Health Districts or other NSW Health entities.

The adjustment was undertaken to reflect the Treasury's forecast of what the Commonwealth Bond Rate would be at 30 June 2013.

*4252 REVISED HEALTH BUDGET - CANCER INSTITUTE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the 2012-2013 Health Budget and the \$70 million removed from the revised 2012-2013 Budget due to the establishment of the cancer institute as a pillar within NSW Health:

- (1) Was this money ever received by Health from the Treasury?
- (2) When was the decision taken to remove this money from the revised budget?

Answer-

I am advised:

The \$70 million was purely an accounting adjustment and did not involve any change in funds available to the Cancer Institute in its budget.

- *4253 TRANSFER TO SMALLER PUBLIC HOUSING ACCOMMODATION—Mr Richard Amery asked the Minister for Family and Community Services, and Minister for Women—
 - (1) How many residents of public housing in the Mount Druitt area have requested a transfer to smaller accommodation in the 12 month period ending 30 June 2013?
 - (2) How does this figure compare with each of the past three years?
 - (3) In relation to question (1) and (2) above, how many residents were approved and housed in their requested smaller accommodation?

Answer-

Since 2009-2010, a number of tenants with vacant bedrooms have applied for transfers in the Mt Druitt area. The majority of these have been rehoused.

*4254 AUSTRALIAN NATIVE LANDSCAPES COMPLAINTS—Mr Greg Piper asked the Minister for the Environment, and Minister for Heritage—

- (1) How many complaints, by phone or writing, has the Environment Protection Authority (EPA) received about the Australian Native Landscapes (ANL) bulk waste composting site at Deaves Road, Cooranbong, regarding odour, dust, noise emission or heavy-vehicle movements?
- (2) Has the EPA undertaken point-of-complaint emissions monitoring?
- (3) If so, what were the:
 - (a) dates of the monitoring;
 - (b) results of the monitoring?
- (4) Has ANL been fined for emissions of breach of licence conditions?
- (5) If so, what were the:
 - (a) reasons of the fines;
 - (b) dates of the fines;
 - (c) amounts of the fines?

Answer-

I am advised as follows:

- (1) Fom 1 January 2013 to 22 July 2013, the Environment Protection Authority (EPA) received 50 complaints regarding the Australian Native Landscapes (ANL) site at Cooranbong.
- (2) The EPA directed ANL to engage an independent expert to undertake emissions monitoring from its operations at the Cooranbong site.
- (3) As required by the EPA, ANL engaged an independent expert to undertake odour emissions monitoring at the Cooranbong site.
 - (a) Monitoring was undertaken between February and April 2013.
 - (b) The independent odour emission study identified the receipt of incoming green waste, compost windrows and the leachate ponds as having the potential to generate off-site odours.
- (4) Yes.
- (5) Since 2004, ANL has been issued with 5 on-the-spot fines for breaches of its licence conditions, each in the sum of \$1500. Since 2003, the EPA has conducted 71 site inspections of the ANL facilities, and required ANL to implement 10 separate Pollution Reduction Programs to improve on-site water management, odour and dust emissions. Further, on 13 April 2013, the EPA met with 6 local residents to provide feedback on its regulation of ANL.
- *4255 PARKING FOR MOTORCYCLISTS—Mr Ryan Park asked the Minister for Transport—

Given that the removal of the monorail will reduce the ability for motorcyclists to park:

- (1) What steps is the Government taking to increase spaces for motorcyclists to park?
- (2) How many additional spaces will be provided?
- (3) When will these new spaces be available?

Answer-

I am advised:

Allocation of on street parking within the Sydney CBD is predominantly a matter for the City of Sydney Council.

The City of Sydney will be responsible for the allocation of motorcycle parking in the Pitt Street and Market Street areas once the monorail is removed.
