*1478 SECURITY AUDIT OF DEPARTMENT OF HOUSING UNITS IN WILLMOT—Mr Richard Amery asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

In relation to the Department of Housing aged units in Van Dieman Avenue, Willmot:

- (1) Has a security audit been carried out?
- (2) What improvements to the security have been recommended?
- (3) What action is the department taking to improve the security for residents?

Answer_

- (1) Yes.
- (2) The audit recommended:
 - A review of lighting;
 - · removal of graffiti;
 - · repairs to fencing;
 - · consideration of removal of some brick walls surrounding; and
 - trimming of bushes and shrubs
- (3) The NSW Land and Housing Corporation has undertaken the following actions:
 - arrangements have been made to have the lighting reviewed;
 - removal of existing graffiti and monitoring and removing any new graffiti;
 - repair of the perimeter fencing;
 - examining the feasibility of removing the brick walls around the clothes drying areas; and
 - investigation of the extent to which bushes and shrubs need to be trimmed prior to engaging gardeners to undertake the required work.
- *1479 DEPARTMENT OF HOUSING MAINTENANCE LINE—Mr Guy Zangari asked the Minister for Family and Community Services, and Minister for Women—

In relation to the Department of Housing's Maintenance Line:

- (1) How many operators are available to answer calls to the Maintenance Line?
- (2) Are all operators specifically dedicated to answer calls to the Maintenance Line?
- (3) (a) Does the number of operators who answer Maintenance Line calls vary depending on the day of the week and the time of the day?
 - (b) If so how?

Answer—

- (1) and (2) Staff may deliver a number of different services offered through Housing Contact Centre by Housing NSW.
- (3) (a) and (b) Housing NSW's Housing Contact Centre forecasts the workload of the Centre. Staff are then scheduled to work according to the expected volume of calls.
- *1480 REJUVENATION OF CARDIFF CBD—Ms Sonia Hornery asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW—

When will the Government commence the \$2.5 million rejuvenation of Cardiff CBD, a March 2011 election commitment?

*1481 SCHOOL TRANSPORT FOR DISABLED CHILDREN—Ms Sonia Hornery asked the Minister for Education—

As a result of the unresolved contract dispute between the State Government and drivers of children with disabilities, making short runs for drivers uneconomical, how many Hunter children were unable to go to school during the first week of the school term?

*1482 HUNTER MEDICAL ONCOLOGY SERVICES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

What steps are being taken by the Minister to ensure that the Hunter is receiving the same level of services, and funding for medical oncology services as metropolitan Sydney, in order to achieve performance benchmarks?

A Review of Medical Oncology Services was recently undertaken in the Hunter New England Local Health District to examine service provision and make recommendations.

The Hunter New England Local Health District has accepted 21 of the 24 recommendations of the Review and is developing an implementation plan to ensure the recommendations are addressed.

The recommendations will feed into the new Cancer Services Strategic Plan that is currently being developed. The Plan will prioritise service requirements for the next five years and will form the basis for funding allocations over that time.

- *1491 COMMUNITY GROUPS AND STAKEHOLDERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

- *1492 TRANSIT OFFICERS—Mr Paul Lynch asked the Minister for Transport—
 - (1) What proposals or plans are you considering in relation to the future of Transit Officers?
 - (2) Why have you not discussed these proposals with representative of the Transit Officers?
 - (3) When will you announce the results of your consideration?

Answer—

(1) to (3) The media release below was issued 14 February 2012:

The NSW Police Force will take over security for the entire public transport network under a new dedicated Police Transport Command, NSW Premier Barry O'Farrell, Minister for Police Michael Gallacher, Minister for Transport Gladys Berejiklian and Commissioner of Police Andrew Scipione announced today.

The new command will see 610 dedicated police officers allocated to patrol trains, buses and ferries. Transit officers will focus on detecting fare evasion and minor compliance offences and their patrols will be expanded to cover buses and ferries.

"The NSW Government is getting on with the job of making our community safer and improving security on public transport is a key plank of that task," Mr O'Farrell said.

"As I travel on public transport and speak with commuters, safety is one of the main concerns, particularly at night," he said.

"There is nothing more reassuring than a high visibility, high profile police presence on trains, buses and ferries."

Mr Gallacher said the NSW Government is committed to improving safety and security as well as driving down crime on the public transport network.

"Police will be responsible for safety and security on our trains, buses and ferries to reduce crime," Mr Gallacher said.

"Police are trained to patrol in pairs, rather than transit officers who are routinely deployed in groups of three to five for safety reasons. Providing a strong police presence is the best way to prevent crime.

"Improving safety and security requires a fundamentally different approach, and a well-led dedicated police command with the full complement of police powers will increase our ability to combat crime on the public transport network.

"The NSW Liberals & Nationals Government is determined to give police the powers, the resources and the backing they need to keep our community safe, and that includes protecting public transport passengers." Mr Gallacher said.

Ms Berejiklian said commuters wanted a strong police presence on the transport network as it was the best deterrent against crime.

"We are committed to making our public transport network as safe as possible," she said.

"We understand that feeling safe and secure is important to our customers, and that it is crucial to attracting more people to use public transport.

"Just as a police car on our roads puts drivers on their best behaviour, police officers patrolling our public transport network will serve as a deterrent against crime.

"While police will take the lead, transit officers will have their roles expanded to focus on fare evasion on buses and ferries as well as trains.

"Having police take over security and increase their presence on the public transport network is a win for customers," Ms Berejiklian said.

Existing transit officers and STA revenue protection officers can either apply to be trained as a police officer, apply to be retained as a transit officer, apply for voluntary redundancy or apply for redeployment.

Commissioner Scipione said the new police command will be created to bolster the state's public transport network.

"The creation of the Police Transport Command will allow police to work more closely with the community to target those areas within our transport system where anti-social and criminal behaviour occurs," Commissioner Scipione said.

"We are focused on completing the recruitment processes by the end of 2014 when the PTC's ranks will have grown to more than 600 officers, while 300 existing police officers currently attached to the Commuter Crime Unit will be available immediately.

"The great value of this new command is that police officers will come into contact with people who may have committed other more serious crimes.

"It will enable the police to take into custody a lot of people wanted on other offences."

"Public transport, whether it's rail, buses or ferries, are well-known as crime corridors used by criminals to go to commit a crime or to return from a crime," Commissioner Scipione said.

Ms Berejiklian said the increased police presence will build on the existing security measures. Across the rail network alone there are:

- 9,300 CCTV cameras targeting crime and commuters safety;
- 750 customer help points visible on CCTV which allow a person to communicate directly with CityRail staff, and
- 7,000 high intensity lights.

The NSW Government also created a \$40 million Park and Travel Safety fund to further improve CCTV on station platforms, on trains and in car parks; improve lighting in and around train stations; and increase help point reliability.

*1493 INTERNATIONAL STUDENTS—Ms Clover Moore asked the Premier, and Minister for Western Sydney—

Noting the increasing warnings that the number of international students coming to study in NSW may drop substantially, and independent assessment that access to transport concessions is a factor in student decisions:

- (1) What assessment has the NSW Government made of projected numbers of international students coming to NSW for 2012 and the future;
- (2) What recommendations has the Premier's Council on International Education made about transport concessions for international students;
- (3) What action has the Government taken to improve transport access for international students;
- (4) What other action has the Government made to improve safety, housing and amenity for international students;
- (5) What other plans does the Government have to better help international students with transport;?
- (6) What other plans does the Government have to better support international students?

Answer-

I am advised:

Due to the strength of the Australian dollar and changes to Commonwealth Visa requirements, international student enrolments across Australia declined in 2011 and 2012. Recent projections predict an increase in the number of international student numbers arriving in Australia in 2013, with this trend expected to continue into 2014 and beyond.

Commonwealth initiatives arising out of the Knight Review of Student Visa Program, including post-study work Visas and streamlined Visa processing, are expected to assist in lifting international student numbers.

The NSW Government recognises the need to do more to make NSW, and Australia, more attractive for international students.

The majority of international students studying in Australia are based in NSW and Victoria. Given the importance of this sector to both States, the Premiers met in December 2011 and agreed to include international education in the Interstate Reform Partnership aimed at accelerating economy-based reforms between Australia's two largest states.

NSW and Victoria are committed to maximising opportunities for high-quality education providers and to supporting the highest possible quality education experience for international students.

The NSW and Victorian Governments will work together with the Commonwealth to extend streamlined visa processing and post-study work rights to international students at a broader range of high-quality, low-risk education providers, including VET providers.

In November 2011, the NSW Government announced an International Education and Research Industry Taskforce to develop, promote and address international student education industry issues, such as how to increase exports from the vocational education and training, university and secondary school sectors. This Taskforce has replaced the Premier's Council on International Education and has been provided the work undertaken by that former body to include in their development of an International Education and Research Industry Action Plan which will outline a vision and strategy for the international education and research industry over the next decade in NSW.

In continuing to support International Students, the NSW Government held the NSW International Student Festival on Sunday 4 March 2012 at Victoria Park, Broadway. The festival provided important information and assistance for international students as well as incorporating the NSW International Student Awards. The Festival and awards sought to recognise and celebrate international students and the contribution they make to communities in NSW.

*1495 PYRMONT AND ULTIMO ROAD SAFETY AND TRAFFIC—Ms Clover Moore asked the Minister for Transport representing the Minister for Roads and Ports—

With respect to major traffic junctions linking the ANZAC Bridge/Western Distributor with Fig Street, Harris Street, Pyrmont Bridge Road, Pyrmont Street, and noting residents' concerns about safety and amenity impacts of through traffic on Pyrmont and Ultimo:

- (1) What requests has the Government received for improvements to safety and traffic management on State roads and at signalised intersections in Pyrmont over the past three years;
- (2) What assessment has Roads and Maritime Services made of traffic and road safety in this precinct over the past three years;
- (3) What traffic accidents have been reported in this precinct over the past three years;
- (4) Which signalised intersections are the location of most traffic accidents in this precinct;
- (5) What traffic counts has Roads and Maritime Services carried out on traffic in this precinct over the past three years and what results were obtained;
- (6) What action has Roads and Maritime Services taken in response to concerns and road safety over the past three years;
- (7) What assessment has been made of the need for red light cameras at signalised intersections and what action has been taken based on these assessments; and
- (8) What further action will the Government take to improve road safety and traffic in this precinct?

Answer-

I am advised:

(1) Roads and Maritime Services (RMS) is aware that local residents in this precinct, as with other locations throughout Sydney and NSW, have provided comments on and suggestions about safety and traffic management over the past three years. Given the time constraints in providing an answer

- to this question, to collate and provide specific details of all requests has not, unfortunately, been practical as it would need too large an allocation of RMS resources.
- (2) RMS has monitored the performance of the road network, including traffic signals in this precinct, and considers the network is operating efficiently given the physical constraints of the road network.
- (3) From 1 July 2008 to 30 June 2011, 77 crashes were recorded for the precinct.
- (4) The signalised intersection at Fig Street and Harris Street had 23 reported crashes from 1 July 2008 to 30 June 2011. This was the highest number for all signalised intersections within the Pyrmont and Ultimo area. However, from January to June 2011 there were only two crashes reported at the intersection.
- (5) Traffic counts conducted by RMS in this precinct over the last three years have obtained the following average vehicles per day:
 - Pyrmont at Anzac Bridge: 2009 132,981; 2010 131,822; 2011 133,839.
 - Pyrmont-Fig Street on/off ramps: 2009 29,467; 2010 29,416; 2010 29,431.
 - Pyrmont west of Allen Street: 2009 50,526; 2010 48,730; 2009 37,297.
- (6) RMS has not implemented any safety improvement works in the precinct in the last three years.
- (7) Red light speed (safety) cameras are deployed across NSW at intersections that need them most. The selection criteria developed by the NSW Centre for Road Safety includes the number and severity of crashes at a location and suitable site conditions.

The identification of locations is based upon a Statewide review of crashes at signalised intersections, with locations based on the cost of crashes to the community. All signalised intersections in Pyrmont and Ultimo were assessed in the process of selecting the first 91 intersections where safety cameras have been installed.

- One of the first 91 intersections to have a safety camera installed was the intersection of Wattle Street and William Henry Street, Ultimo which is in close proximity to the area in question.
- (8) RMS will continue to monitor the performance of the road network in this precinct and will take remedial action as considered appropriate. RMS will also continue to monitor and evaluate the traffic signals in this precinct to ensure they are operating as safely and efficiently as possible.
- *1496 VOLUNTEER OCCUPATIONAL HEALTH AND SAFETY—Ms Clover Moore asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

With regard to community concern about the impact of new nationally aligned occupational health and safety requirements on volunteers working with community groups, charities and other organisations for community benefit:

- (1) What assessment has the Government made of the impact of new occupational health and safety requirements relating to volunteers;
- (2) What assessment has the Government made of the impact on NSW-based organisations that send volunteers on overseas aid projects;
- (3) What information, training and support about the new requirements is the Government providing to organisations that have volunteers;
- (4) What action has the Government taken to ensure that community organisations do not suffer additional insurance and administrative costs as a result of the new requirements;
- (5) What other support is planned; and
- (6) What further action will the Government take to support community organisations affected by occupational health and safety changes?

Answer-

(1) The work health and safety laws, which came into effect on 1 January 2012, maintain the same objective of the previous laws of ensuring health and safety while at work. If an organisation was complying with the previous New South Wales occupational health and safety laws then it will be largely complying with the new work health and safety laws.

For example, under the previous Occupational Health and Safety Act 2000, a volunteer organisation that employed staff was considered to be an employer for the purposes of the Act. The previous laws imposed a general duty on employers to ensure as far as is reasonably practicable that all persons at their workplaces, as well as their employees, were not exposed to risks arising out of the conduct of the employer's undertaking. This protection was extended to volunteers who may have been engaged in activities at a workplace for which an employer was responsible.

Under the new laws, where an organisation engages both paid employees and volunteers, that organisation has the same responsibilities for the health and safety of its volunteers as it does for its

employees. The only difference between the previous laws and the new work health and safety laws is that protection of these volunteers is now explicitly stated.

It is important to note that volunteer associations, that is, those community groups of volunteers who employ no-one, are excluded from all duties under the work health and safety laws.

- (2) The obligations under the New South Wales Work Health and Safety Act 2011 do not apply outside Australia. Organisations that engage volunteers to work overseas may have their own arrangements for safety, security and insurance for such workers.
- (3) To assist volunteers and volunteer organisations, the New South Wales Government has an extensive education program to inform volunteers and volunteer organisations of their obligations.

Specific assistance provided to volunteer groups includes:

- Public information seminars hosted by WorkCover.
- A webinar on the WorkCover website explaining how the new legislation will apply to volunteers.
- A web page and fact sheet on the work health and safety legislation and volunteers is available on the WorkCover website
- A presentation to the State's peak volunteering body, the New South Wales Centre for Volunteering.
- The provision of a substantial grant to the Surf Life Saving Association to provide training on the new legislation.
- · Meetings with government agencies that deal with volunteers.
- Meetings with non-government organisations to provide information about volunteers under the new work health and safety legislation.
- (4) It is important to note that compliance by individual volunteers will not be onerous and the duty imposed upon volunteers is not onerous in itself. Volunteers will not have to come up with safe systems of work and will not be weighed down with paper work.

Organisations that engage volunteers, as with all businesses or undertakings in New South Wales, have 12 months to review their consultation mechanisms and policies and procedures to ensure they are updated in line with the new laws. The Government does not expect this to be an onerous administrative burden, just a commonsense approach to ensuring the organisation makes any necessary changes.

Where there is an organisation of volunteers which does not engage anyone in any paid work, but rather relies solely on volunteer labour, such an organisation is exempt from the provisions of the work health and safety laws.

- (5) In addition to the comprehensive assistance outlined above, WorkCover will continue to work closely with this sector, and with all workplaces, to ensure workers are protected and policies comply with the new legislation.
- (6) In recognition of timeframes and concerns raised by stakeholders, the Work Health and Safety Regulation 2011 includes transitional arrangements for implementing and complying with some parts of the new legislation. These arrangements are currently being communicated widely through public forums across New South Wales.

WorkCover will continue to provide information, guidance, education and advice to assist customers to achieve compliance with new requirements contained in the work health and safety laws.

*1497 INDEPENDENT COMMISSION AGAINST CORRUPTION RECOMMENDATIONS—Ms Clover Moore asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW—

In response to Independent Commission Against Corruption (ICAC) recommendations following findings that former Sydney Harbour Foreshore Authority (SHFA) executive director Andrew Kelly engaged in corrupt conduct dealing with the Kazal family and tenancies at 91, 99, 100 and 135 George Street The Rocks:

- (1) What action has the Government taken in response to ICAC recommendation that SHFA should locate authority and accountability for heritage protection within a single independent role with a commensurate level of seniority?
- (2) To what extent does SHFA record the factors considered and the reasons for heritage decisions? How has SHFA improved the transparency of heritage decisions?
- (3) To what extend does SHFA now include heritage considerations in board papers and executive memoranda for property and leasing matters?
- (4) To what extent has SHFA established a formal process for tenants to follow when they apply for

- compensation for work carried out on SHFA properties and to what does this process require?
- (5) To what extent will recommendations to the general manager and board of SHFA that provide significant benefits to clients require a comprehensive written business case by the responsible director?
- (6) To what extent are processes within SHFA different to those prior to the ICAC's investigations?

Answer—

- (1) In 2010, the Authority structurally separated its commercial and heritage protection interests by assigning responsibility for the property and leasing function to the General Manager. The heritage and protection function remains under the responsibility of the Director, Asset Management Services.
- (2) In February 2012, the Authority's Lease Expiry Policy was strengthened to ensure each lease renewal proposal complies with heritage conservation and maintenance requirement
 - For heritage buildings, the determination to renew a lease must now be consistent with advice contained in the relevant Conservation Management plan for that property and other relevant statutory obligations.
 - The Heritage and Design Manager will also evaluate/consider and provide comment on the heritage impact of any proposed change of use for a building. The Authority will not accept any proposed change of use that would result in non-compliance with a Conservation Management Plan.
- (3) The Board paper template has been updated to require commentary on heritage issues in any property-related paper.
 - These measures are in addition to existing procedures which require heritage consideration and approval by the Heritage and Design Manager of all statutory approvals through the landowner's consent process. There is no record of landowner's consent having been granted contrary to significant heritage-related concerns about the proposed development.
- (4) In February 2012, the Lease Concessions and Compensation for Works Policy was updated to include a comprehensive process for tenants to follow when seeking compensation for works on the Authority's properties. Based on legal advice obtained by the Authority, the policy notes that tenants who carry out repairs without notifying the Authority have no automatic right to recover costs from the Authority.
 - The policy establishes criteria under which the Authority will consider claims for compensation and for claims in excess of \$50,000, as noted by the ICAC in its corruption prevention recommendations. It requires tenants to provide independent reports from qualified professionals, including legal advice, to justify the quantum of the claim.
- (5) The Lease Concessions and Compensation for Works Policy establishes criteria under which the Authority will consider claims by tenants for lease concessions and repayment plans, and compensation for building works.
 - All claims up to \$50,000 are to be approved by the Director, Business and Financial Services. Any claims in excess of \$50,000 must be submitted to the General Manager for approval, and claims in excess of \$100,000 must be submitted to the Board.
 - The policy has been updated to require all submissions for claims in excess of \$50,000 to be accompanied by a comprehensive written business case from the responsible director.
- (6) Sydney Harbour Foreshore Authority had already implemented a number of ICAC's recommendations before the report was released, and has now implemented changes to meet all four recommendations.

- *1501 DATA CENTRE IN THE ILLAWARRA—Mr Ryan Park asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
 - (1) Given the Department has been evaluating tenders for the establishment of a Data Centre in the Illawarra since June 2011, when will this evaluation process be completed?
 - (2) Will you guarantee that a Data Centre will be constructed in the Illawarra?

Answer-

- (1) and (2) The evaluation of tenders is underway and a decision by the Government will be made as soon as that process has been completed.
- *1502 WOONONA HIGH SCHOOL SCIENCE LABORATORY UPGRADES—Mr Ryan Park asked the Minister for Education—
 - (1) Given that planning work was underway in October 2011, where is the planning up to for the upgrades to science laboratories at Woonona High School?
 - (2) Approximately when will the construction works begin?
 - (3) Approximately how long will construction take?

Answer—

- (1) I am pleased to advise that work to upgrade 2 science laboratories and an adjoining preparation room at Woonona High School will soon commence. Planning work is continuing with project specifications due to be agreed with the Principal in early March 2012.
- (2) It is anticipated that the upgrade of the science laboratories and preparation room will commence in late March 2012.
- (3) It is anticipated that the project will be completed by 30 June 2012.
- *1503 WOONONA EAST PRIMARY SCHOOL BUILDING UPGRADES—Mr Ryan Park asked the Minister for Education—
 - (1) Is the Master planning for the building upgrades to Woonona East Primary School complete?
 - (2) Given the condition of the classrooms and administration block, when will this urgent building work commence?
 - (3) What is the approximate cost involved for this project?
 - (4) What is the estimated timeline for the completion of construction?

Answer—

- (1) Yes. A concept master plan for Woonona East Public School was completed and presented to the school in late 2008.
- (2) to (4) The project to upgrade facilities at Woonona East Public School has not been assessed as one of the top capital works priorities by the Illawarra and South East Region for 2012/13. I am unable to provide a specific timeframe for the project. Funding will be considered as part of future capital works programs. Cost estimates are not announced prior to the tender process due to their commercially sensitive nature.
- *1504 ALLOCATION OF TEACHERS IN ILLAWARRA—Mr Ryan Park asked the Minister for Education—

Given the Coalition made a commitment in 2010 to allocate an additional 60 teachers to the Illawarra to improve literacy and numeracy:

- (1) When will these teachers be allocated?
- (2) Approximately when will they commence in schools?
- (3) What schools will they be going to?
- (4) What selection criteria will be used to determine where these teachers will be allocated?

Answer—

- (1) The Ministerial Advisory Group on Literacy and Numeracy is due to submit its report on a proposed strategy for the implementation of the Government's Literacy and Numeracy Action Plan in March. Decisions regarding when the teachers will be allocated will be made after this report has been reviewed.
- (2) Decisions regarding the commencement of the additional teachers will be made on advice from the Ministerial Advisory Group.
- (3) Schools participating in the first year of the Literacy and Numeracy Action Plan, including those in the Illawarra area, will be identified following the submission of the report from the Ministerial Advisory Group.
- (4) Additional teachers will be allocated to schools so that those students most at risk of not reaching minimum standards in literacy and numeracy benefit.
- *1505 ALLOCATION OF PUBLIC SCHOOLS UPGRADE FUND IN KEIRA ELECTORATE—Mr Ryan Park asked the Minister for Education—

For schools in the electorate of Keira:

- (1) What schools applied for funding under the \$40 million Public Schools Upgrade Fund?
- (2) Wat schools were successful in securing funding?
- (3) What specific projects will be funded under this program for each school?

Answer—

- (1) All schools in the Keira electorate, except for Fairy Meadow Public School, made applications for funding in Round one of the Public Schools Upgrade Program.
- (2) and (3) Bellambi, Corrimal and Mount Ousley Public Schools and Figtree and Keira High Schools submitted and were approved for replacement of floor coverings; Corrimal High School for internal and external painting; Woonona High School for toilet replacement and renovation.
- *1506 MOUNT OUSLEY ROAD REST STOP UPGRADE—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) In relation to the Mount Ousley Road rest stop upgrade, has this planning work now been completed?
 - (2) What is the next stage of this project?
 - (3) When will funds be allocated to carry out this important work?

Answer-

I am advised:

- (1) The situation as outlined in my answer to Written Question 1217 remains unchanged. In 2011-12, no further funds are available to progress this work.
- (2) The next stage of the project is to finalise the concepts and obtain planning approval.
- (3) This project will continue to be assessed and to compete for funding on a Statewide priority basis.
- *1507 PRINCES HIGHWAY AND BELLEVUE ROAD UPGRADE AT FIGTREE—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

Will the upgrade to the Princes Highway and Bellevue Road at Figtree be complete by the end of 2012?

Answer-

I am advised:

The project to upgrade key intersections on the Princes Highway at Figtree is expected to be completed by the end of 2012, weather permitting.

- *1508 BULLI PCYC IMPROVEMENTS—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) In relation to improvements to Bulli PCYC, given that a contract was expected to be in place by the end of 2011, can you now inform me when this work will commerce?

Answer_

A commitment was made by the NSW Liberals and Nationals prior to the 2011 State Election to fund this much needed upgrade to Bulli PCYC.

I am advised that preliminary work to replace the asbestos roof and guttering system at the Bulli PCYC is scheduled to commence on 24 April 2012. The PCYC anticipates work will be completed by the end of July 2012.

 - (1) In relation to your previous answer to question 1467 can you please provide me a list of the addresses of the 270 properties in the Keira electorate that will undergo maintenance this financial year?
 - (2) For each property, can you provide me with a description of works that will be undertaken?

Answer-

- (1) Housing NSW has a policy of not releasing specific property addresses to protect the privacy of tenants.
- (2) Major work to be undertaken includes external and internal painting; roofing replacement; and full or part timber boundary fence replacement.
 - Minor works could include replacement of electrical fittings and/or tap washers; and repairs to individual walls, doors and windows.
- *1510 SPORT AND RECREATION FACILITY GRANT SCHEME IN ILLAWARRA—Mr Ryan Park asked the Minister for Sport and Recreation—

*1512 GREY NURSE SHARK PROTECTION REVIEWS—Ms Clover Moore asked the Minister for Primary Industries, and Minister for Small Business—

Following revocation last April of grey nurse shark protections at Fish Rock and Green Island on the New South Wales mid North Coast:

(1) Did the State Government carry out its promised three month community consultation on the

protections?

- (2) When did the consultation begin and end?
- (3) What was involved in the consultation?
- (4) When will results from the consultation be released?
- (5) Where will results from the consultation be available?
- (6) Did the State Government carry out its promised scientific review to ensure that conservation needs of the grey nurse shark are met well into the future?
- (7) When did the review begin and end?
- (8) What was involved in the review?
- (9) When will results from the review be released?
- (10) Where will results from the review be released?

Answer—

The NSW Government is committed to ensuring the conservation needs of the Grey Nurse Shark are met well into the future.

The Department of Primary Industries received a large number of submissions; however the views surrounding grey nurse shark protection measures remain highly polarised.

The summary of submissions on the Discussion Paper for Grey Nurse Shark Protection is available on the NSW DPI website.

While the majority of respondents supported Grey Nurse Shark protection, there remains a diverse and often diametrically opposed range of views about how this should be best achieved.

It is important to ensure that we get future management arrangements right through consultation and involvement of affected stakeholders.

A facilitated workshop took place recently which engaged and involved key stakeholders in the development of stakeholder-supported options for the future management of fishing and scuba diving activities at Grey Nurse Shark aggregation sites.

This Government is about long term, science-based, true triple bottom line outcomes - which we will achieve in partnership with the community.

*1513 INCREASED COST OF RAIL SERVICES—Ms Sonia Hornery asked the Minister for Transport—

What impact will a 6% increase in fares have on the numbers of commuters using public transport in the Hunter?

Answer—

I am advised that given this was the first increase in public transport fares since early 2010 and that the 5.4% increase is in line with CPI increases over the period there is not likely to be an impact on the number of commuters using public transport.

- *1514 POLICE ACTION IN WILLMOT DEPARTMENT OF HOUSING UNITS—Mr Richard Amery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Has the NSW Police been involved in the Security Audit for Department of Housing units in Van Dieman Avenue, Willmot?
 - (2) Did this action follow complaints of anti social behavior by youths against the aged residents of this complex?
 - (3) What issues have been identified by the Security Audit?
 - (4) How many persons have been detected by Police at this complex?
 - (5) Of the persons referred to in Question 4, how many of these persons were:
 - (a) Arrested and charged with an offence?
 - (b) Cautioned?
 - (c) Summonsed to appear at court?
 - (d) Any other action?

Answer-

The NSW Police Force has advised me:

- (1) Police conducted a Safety Audit at this location on 9 November 2011 in the presence of Department of Housing personnel.
- (2) Yes.

- (3) The Audit identified a number of issues including poor lighting, graffiti, vandalism, fencing, poor property maintenance and overgrown foliage.
- (4) and (5) Police records indicate that since 1 July 2011, 13 persons have been detected at the complex with five persons being charged with 15 offences and a number of others given warnings.

*1515 CARDIFF RAIL LIFTS—Ms Sonia Hornery asked the Minister for Transport—

Why has the Government stalled for a year the building of the Cardiff Rail easy access facilities?

Answer-

As part of this Government's commitment to improve the safety and accessibility of Cardiff Station, Transport for NSW is combining the planned station accessibility upgrade with works to lengthen the platform so that it can accommodate eight-car trains. This required a redesign of the originally planned accessibility upgrade.

Early works for the project are now underway. The project is scheduled for completion in 2013. The previous Labor Government had 16 years to deliver this project. All Labor left the long suffering commuters of Cardiff with was rough costings, a rough timeline, and a sign. The NSW Liberals & Nationals have been in Government less than 12 months, and work has commenced.

*1517 NEWCASTLE INNER CITY BYPASS—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—

Will the Government commence building the Newcastle Inner City bypass in 2012 to alleviate road traffic chaos?

Answer-

I am advised:

Stage 4 of the Newcastle Inner City Bypass between Shortland and Sandgate is currently being built and is expected to open to traffic by the end of 2013.

A route corridor for Stage 5 of the Newcastle Inner City Bypass has been identified and has been protected in the Newcastle City Council Local Environmental Plan.

Priority is being given to completing the Hunter Expressway and intersection upgrades between the F3 Freeway and Newcastle, as well as the planning of the duplication of Cormorant Road and Tourle Street in the longer term.

The NSW Government is also funding the Hunter Infrastructure and Investment Fund in the amount of \$350 million.

This represents a large investment in the Hunter Region over the first term of this government.

Funding for future road projects, like stage 5 of the Newcastle Inner City Bypass between Rankin Park and Jesmond, will be considered along with other infrastructure projects across the State.

*1518 FIXED SPEED CAMERA AT JESMOND—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—

What is the status of the fixed speed camera that was installed at Newcastle Road, Jesmond? Was it decommissioned? If so, will it be switched back on?

Answer-

I am advised that the fixed speed camera on Newcastle Road, Jesmond was decommissioned on 27 July 2011 following the release of the NSW Auditor-General's Performance Audit - Improving Road Safety: Speed Cameras.

The audit identified that overall the NSW fixed speed camera program has significantly reduced crashes. These results varied at some locations and 38 locations were identified where there had not been a consistent reduction in crashes, injuries and fatalities.

Newcastle Road, Jesmond is one of the 38 locations where it was found that the speed camera had not delivered the expected road safety benefits because crashes and injuries at the camera location increased after the camera was installed.

A safety review has been undertaken at this location to find alternative safety measures for the existing road safety risks that were not being addressed by the camera. The review findings and proposed program of works will be developed by the end of March 2012.

*1519 ROADSIDE LITTER IN THE HUNTER—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—

What steps are the Government taking to reduce roadside litter in the Hunter?

Answer-

I am advised:

Roads and Maritime Services (RMS) regularly collects litter along State roads. Priority is given to the removal of litter that is hazardous to vehicular traffic, cyclists or pedestrians or litter that produces an offensive smell or attracts pests. Local councils are generally responsible for litter control outside the road pavement along State roads.

RMS provides opportunities for motorists to dispose of litter with rubbish bins provided at rest areas.

*1520 NURSE POSITIONS IN THE HUNTER—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

Will the Minister make a commitment to provide the 49 nurse positions needed in the Hunter in addition to the 101 new graduate nurses to be provided (Minister's statement 31 January 2012)?

Answer-

I am advised:

In 2012, 201 new graduates were offered employment across the Hunter New England Local Health District, with 135 in the Hunter region.

In implementing the new staffing arrangements provisions of the Public Health System Nurses' and Midwives' (State) Award 2011, for the period up to 30 June 2012, approximately 94 full time equivalent nurses have been allocated to facilities in the Hunter geographic area (inclusive of John Hunter, Maitland, Belmont, and the Calvary Newcastle Mater Hospitals). This is part of the progressive rollout of the equivalent of an estimated 1,400 additional nurses across the State by 30 June 2013.

*1521 ASSISTED SCHOOL TRAVEL PROGRAM IN CABRAMATTA—Mr Nick Lalich asked the Minister for Education—

How many special needs school children use the Assisted School Travel Program in the electorate of Cabramatta?

Answer-

As at 22 February 2012, 120 students use the Assisted School Travel Program to attend schools in the Cabramatta electorate.

*1522 CARERS IN THE CABRAMATTA ELECTORATE—Mr Nick Lalich asked the Minister for Ageing, and Minister for Disability Services—

How many full-time and part-time carers operate in the electorate of Cabramatta?

Answer-

Ageing Disability and Home Care (ADHC) does not collate data on employment by electorate.

(1) to (7) The 2010-11 NSW Health Annual Report contains more comprehensive reporting of beds than in previous years, with specific categories for ED beds; other hospital beds; other beds including Hospital in the Home and Residential/Community Aged Care and Respite Beds; and treatment spaces, which include bassinets, transit lounges, same day therapy/dialysis. This is found on page 216.

Bed numbers also appear on the Federal Government's "My Hospital" website.

*1531 REDFERN RAILWAY STATION—Ms Clover Moore asked the Minister for Transport—

Following the response to Written Questions On Notice 12098/541, 7311/541, 7311/541, 0686/532 and 4670/531 about the long-awaited redevelopment of Redfern Railway Station, and noting that this station is the seventh busiest in the network but does not have disability access:

- (1) What community consultation was carried out in 2011; When will the approved station upgrade plans be public;
- (2) What action will be taken to provide disability access;
- (3) How will station capacity be expanded;
- (4) What pedestrian and bicycle access across the rail corridor will be provided;
- (5) How will links to precincts east and west of the railway lines be improved;
- (6) What public domain improvements will be included;
- (7) How will safety in the station precinct be improved;
- (8) How will the built, social and Indigenous heritage of the railway station precinct be protected;
- (9) What changes will be made to station entrance and concourse;
- (10) When will construction begin;
- (11) When will an accessible station be completed and in use?

Answer-

(1) to (11) The Government is in the process of determining where future upgrades to stations will take place and Redfern Station will be considered as part of this review.

- WILD GOAT RACES—Ms Clover Moore to ask the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
- *1533 POLICE STATION PHONE SYSTEM AT WOLLONGONG—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Will the NSW Police Force install a phone system at unmanned stations in the Wollongong Local Area Command that automatically redirects callers to the Wollongong Police Station?
 - (2) If so, when will this change take place to improve the service to local residents?
 - (3) If not, why not?

Answer—

The NSW Police Force has advised me that all of its facilities in the Wollongong Local Area Command are equipped with telephone diversion systems that redirect incoming calls to the Wollongong police station when stations are unattended. Eagle Phones at the stations also direct calls to the Wollongong police station.

- *1534 MAGISTRATES EARLY REFERRAL INTO TREATMENT—Mr Ryan Park asked the Attorney General, and Minister for Justice—
 - (1) Are there any plans to expand the Magistrates Early Referral Into Treatment (MERIT) Program to include offenders under the age of 18?
 - (2) If yes, can you detail these plans including the timing of when such a program will commence?
 - (3) If not, why not?

Answer-

I am advised:

Currently, there are no plans to expand the MERIT program to include offenders under the age of 18. This is due to a number of factors including the issue of consent to treatment for children aged under 16, resource implications and the suitability of the MERIT program for young people.

*1535 INTERSECTION AT F6 AND OLD MOUNT OUSLEY ROAD—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

Can you advise of any plans to improve the intersection of the F6 and Old Mount Ousley Road for traffic turning right from Old Mount Ousley Road onto the F6 (Mount Ousley Road)?

Answer-

I am advised:

At this stage, Roads and Maritime Services (RMS) has no plans to upgrade this intersection.

RMS will continue to monitor the existing traffic movements and characteristics at the intersection to determine what, if any, action would be required in the future.

*1536 PEDESTRIAN SAFETY IN THORNE STREET TORONTO—Mr Greg Piper asked the Minister for Transport representing the Minister for Roads and Ports—

Would traffic and pedestrian safety in Thorne Street, Toronto, be better served by encouraging vehicles to use The Boulevarde and discouraging the common use of Thorne Street as an arterial route?

Answer-

I am advised:

Lake Macquarie City Council is responsible for Thorne Street as it is a local road. Traffic management on Thorne Street is a council matter.

The council would need to undertake a traffic study if changes are proposed on Thorne Street, to assess any impacts on traffic on Cary Street (a State road).

Roads and Maritime Services is available to assist council if a study is undertaken.

*1537 PERMANENT TEACHER ALLOCATION IN SCHOOLS—Ms Carmel Tebbutt asked the Minister for Education—

At the commencement of the school year 2012, how many classes in NSW did not have a permanent teacher allocated and in which schools are these classes located?

Answer-

There are a number of temporary teachers in NSW classrooms. This is not new. Where positions are not yet permanently filled principals engage suitable casual or temporary teachers.

Temporary or casual teachers may also be engaged when permanent teachers are on approved leave, including maternity leave, sick leave and leave without pay.

The Department of Education and Communities implements a year-round rolling staffing process to ensure that all NSW public schools are staffed with quality teachers.

*1538 DEMOUNTABLE BUILDINGS ON SCHOOL SITES—Ms Carmel Tebbutt asked the Minister for Education—

How will demountable buildings on school sites be replaced now that the Demountable Replacement program has been axed?

Answer-

Replacement of long-term demountable buildings with permanent facilities will be considered for inclusion in future Statewide major and minor capital works programs based on regional priorities.

*1539 DEMOUNTABLE SCHOOL BUILDINGS OVER 5 YEARS—Ms Carmel Tebbutt asked the Minister for Education—

Which Government schools in NSW have had demountable buildings for more than:

- (1) 5 years;
- (2) 10 years;
- (3) 15 years?

Answer-

(1) to (3) The Department of Education and Communities has advised that at the end of January 2012, there were 4549 demountable buildings located on school sites.

Demountable buildings are removed from, and installed at, schools according to accommodation need, based on changing enrolment patterns, among other factors.

To provide a detailed list of which NSW government schools have had demountable buildings for more than 5, 10 and 15 years would involve considerable time and the diversion of resources away from the core responsibilities of the Department that cannot be justified.

*1540 TOTAL AMOUNT OF DEMOUNTABLE BUILDINGS IN NSW SCHOOLS—Ms Carmel Tebbutt asked the Minister for Education—

As at the end of January 2012, how many demountable buildings are there in NSW schools?

Answer—

At the end of January 2012, there were 4549 demountable buildings located on school sites.

- *1541 WASTE AND ENVIRONMENT LEVY—Mr Richard Torbay asked the Minister for the Environment, and Minister for Heritage—
 - (1) What is the Government's position on the future of the Waste and Environment Levy?

- (1) Traffic volumes for the M5 South West Motorway were published in quarterly releases to the Australian Stock Exchange (ASX) by Macquarie Infrastructure Group until 2005, Sydney Roads Group in 2006 and Transurban since 2007.
- (2) (a) and (b) No. Each corridor is subject to differing growth factors.
- (3) Traffic volumes for the M4 Western Motorway were published in quarterly releases to the ASX by Macquarie Infrastructure Group until 2005, Sydney Roads Group in 2006 and Transurban since 2007. Roads and Maritime Services (RMS) annual average daily traffic data for the M4 Western Motorway is published on the RMS website.
 - Transurban have published the traffic volumes for the M2 in quarterly releases to the ASX since 2007. Previously the M2 was operated by a private company and traffic information was not published and is not available.
- (4) The average daily traffic count for the M4 in 2011 was 93,155 at Homebush. Transurban have published the traffic volumes for the M2 in quarterly releases to the ASX since 2007.

- (3) No security breaches or significant security related incidents have occurred during February 2012.
- (4) Security processes in place at Maitland Hospital include:
 - a deck phone system that is implemented throughout the facility, and which includes a phone communication and duress service.
 - Code Black procedures, a formal escalation process used to respond to aggression and other serious safety incidents, are in place at the facility.
 - a formal lock down procedure which is activated according to specific criteria outlined within facility policies.
 - a closed circuit television system, which covers a number of critical areas throughout the hospital and its grounds.

- *1546 PROFESSIONAL CONDUCT BREACHES IN PRISONS—Mr Clayton Barr asked the Attorney General, and Minister for Justice—

In the past 12 months, how many breaches of professional conduct related to intimate contact between staff-prisoners have there been at:

- (1) Parklea Prison;
- (2) Junee Prison;
- (3) All other State run Corrective Services Prisons?

Answer-

I am advised:

- (1) Three investigations into suspected breaches of professional conduct arising from improper personal relationships between staff and inmates at Parklea Correctional Centre were conducted in the period in question. In one matter, the investigation found no evidence to support an allegation of an improper personal relationship; in a second matter, the investigation resolved to monitor the placement of an officer and an inmate; while the third matter remains with the Corrective Services NSW Investigations Branch for formal investigation.
- (2) One investigation into a suspected improper personal relationship between a staff member and an inmate at Junee Correctional Centre was commenced, however the staff member resigned before the investigation could be finalised, and it was discontinued.
- (3) One suspected improper personal relationship between a staff member and an inmate has been investigated. This matter is currently subject to a disciplinary process.
- *1547 HUNTER TAFE ELECTROTECHNOLOGY ELECTRICIAN COURSE—Mr Clayton Barr asked the Minister for Education—

With regard to the subject of Electrotechnology Electrician (Stages 1, 2 and 3) offered through Hunter TAFE:

*1548 TRANSPORT FOR SPECIAL NEEDS STUDENTS IN CESSNOCK—Mr Clayton Barr asked the Minister for Education—

With regard to the transport of special needs students at Cessnock High School:

- (1) Were 4 taxis offered for the daily transport of these students in 2011?
- (2) How many taxis are offered for the daily transport of these students in 2012?
- (3) Have the students transported in these taxis been late to school at any stage thus far in 2012? Have any students been required to travel in conditions or the company of other students, contrary to the express transport and travel needs prescribed by their condition?

Answer—

- (1) Yes.
- (2) Four taxis are currently engaged to provide assisted school travel services for students attending Cessnock High School in 2012.
- (3) There were 3 days where 1 taxi with 3 students was late arriving at school.

Students are allocated to runs according to their individual travel support needs, and adjustments are sometimes made to best suit their circumstances. For the 3 students on this particular run, an adjustment was made to better meet their particular travel requirements.

*1549 LOCAL ART AND CULTURAL EVENT SPONSORSHIP—Mr Clayton Barr asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the Arts—

What capacity is there within the Ministry to offer support and sponsorship of local art and cultural events and how would an interested community group apply for this funding?

Answer-

The Government's Art Funding Program, provides funding opportunities to support the arts and cultural organisations in NSW on an annual basis. Information on funding opportunities can be found under the 'Funding and Support' section of the Arts NSW website www.arts.nsw.gov.au

Applications for projects taking place in 2012 closed in June 2011. Applications for the 2013 Arts Funding Program will open in early 2012 and will be made available on the Arts NSW website.

*1550 SWEETWATER ACTION GROUP CAMPAIGN—Mr Clayton Barr asked the Attorney General, and Minister for Justice—

How much money and how many hours of work have been expended by Legal Aid in pursuing the Sweetwater Action Group (SWAG) campaign to defeat the proposed Huntlee (nee Sweetwater) Development scheduled for North Rothbury/Branxton?

Answer—

I am advised:

Legal Aid NSW approved two limited grants of aid totalling \$36,325 to the Environmental Defender's Office (EDO) to represent the Sweetwater Action Group in legal proceedings. The work was carried out by the EDO and not by Legal Aid NSW.

*1551 HYDRO ALUMINIUM—Mr Clayton Barr asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—

With regard to the financial difficulties being experienced by Hydro Aluminium in Kurri Kurri:

- (1) When did you last meet with representatives of Hydro?
- (2) Which of the currently Government owned and run Power Stations has the capacity to provide the electricity necessary to run Hydro Kurri Kurri?
- (3) Are you aware that a long term decision on the future of the plant to remain open, or, to shut down with the loss of 550 jobs is imminent?
- (4) What steps are you taking to prevent the complete shutdown of this facility?

Answer-

- (1) I met with representatives of Hydro last year.
- (2) This information is commercial in confidence.
- (3) and (4) The Government has been kept informed of developments by the company and by the relevant generating companies and is providing assistance when it is requested.
- *1552 CAMPSIE FIRE STATION—Ms Linda Burney asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Does the NSW Government have plans to close Campsie Fire Station and other stations across NSW?

Answer-

Fire & Rescue NSW has advised me that there are no plans to close Campsie Fire Station.

*1553 NOISE BARRIER IN RIVERWOOD—Mr Robert Furolo asked the Minister for Transport—

With regards to the noise barrier in William Road, Riverwood:

- (1) Is the Minister aware that my constituent, Ms Lesley Roberts, was given an assurance in writing by a representative of the Kingsgrove to Revesby Quadruplification project that a 2.5 metre high noise wall would be installed?
- (2) Is the Minister aware that contrary to the written advice a 1 metre wall was constructed?
- (3) Does the Minister think that this is an acceptable practice?
- (4) What will the Minister do to ensure that what was promised to my constituent is delivered?
- (5) When will the noise wall be fixed so that it is 2.5 metres high as promised?

Answer-

(1) to (5) I am advised that Ms Roberts was mistakenly advised by a member of the Kingsgrove to Revesby Quadruplication Alliance project team that the noise barrier at her property would be 2.5 metres high. While this is regrettable, I understand Ms Roberts was advised of the correct height in subsequent correspondence.

Construction of the Kingsgrove to Revesby Quadruplication Project is ongoing. Once the project is operational, noise levels will be monitored to ensure the noise goals outlined in the project's Operational Noise and Vibration Review are being met. If the noise levels exceed the criteria outlined, further noise mitigation measures will be considered.

*1554 FREIGHT TRAIN NOISE IN BELMORE—Mr Robert Furolo asked the Minister for Transport—

With regards to the noise from freight trains in Paxton Avenue, Belmore:

- (1) Is the Minister aware that noise monitoring reports conducted by RailCorp show that noise levels generated from freight trains regularly exceed the Government's own standards?
- (2) In light of this, can the Minister give an update on what progress has been made in providing noise attenuation measures for my constituents who have been affected by ongoing freight noise?
- (3) Has the Belmore area been identified for the Noise Abatement Program?
- (4) If so, when will this work be completed?
- (5) If not, why not?

Answer-

I am advised that despite Mr Furolo's letters to previous Transport Ministers on March 25 2009, 19 May 2009 and 9 September 2010, no action was taken by the previous Government except to request noise monitoring in January 2011, almost two years later.

The Government recognises that freight moved by rail plays an important role in supporting the NSW economy, reducing the number of trucks on our road, and improving the movement of goods and services.

We will continue to work with stakeholders to minimise the impact of rail noise on the community.

*1555 ACCIDENT SITE ON PACIFIC HIGHWAY AT URUNGA—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

With regards to the Pacific Highway at Urunga and the accident that occurred there on 8 January 2012:

- (1) What alternative road safety treatments were installed following the deactivation/ removal of the speed cameras at this site?
- (2) How many accidents were reported within 500 metres of the site following the deactivation removal of the speed camera?
- (3) How many accidents were reported within 500 metres of the site following the reactivation of the speed camera?
- (4) What advice did you or your office receive from the Roads and Maritime Services or the Centre for Road Safety about the site where this speed camera was removed?
- (5) What action was taken following receipt of this advice?
- (6) Given that it has been reported that alcohol appears to be a factor in the accident, what plans are there to reinforce the "don't drink and drive" message and improve safer driving practices?

Answer-

(1) Since the deactivation of the speed camera at Urunga, the speed camera location has been thoroughly reviewed and investigated by the Centre for Road Safety, TfNSW, to identify residual safety risks and alternative treatments.

Safety works at Urunga, as recommended by the safety review, have been accelerated and commenced early this year because of the high community concern. The works include the reactivation of the speed

camera to "warning mode", undertaking a speed zone review, updating the signage and markings on approaches to Urunga, and updating advisory signage throughout the review length of road.

A detailed assessment was carried out by the Centre for Road Safety to determine the suitability of point-to-point enforcement for heavy vehicles along a longer stretch of the Pacific Highway around Urunga. The assessment looked at the crash history and speed compliance in the area and the results showed point-to-point enforcement would be beneficial between Valla (Oyster Creek) and north of Urunga on the Pacific Highway. The point-to-point cameras will be installed by Roads and Maritime Services (RMS) by September 2012.

- (2) and (3) I am advised that the requested data are not available as the Centre for Road Safety crash data base for recent periods is incomplete, owing to the general 6 to 9 months required to finalise information from police investigations.
- (4) The Centre for Road Safety, TfNSW, in collaboration with Roads and Maritime Services, NSW Police Force, NRMA Motoring & Services and local government have formed an inspection team led by an independent accredited lead safety auditor to conduct a safety review of the decommissioned fixed speed camera location at Pacific Highway, Urunga. The inspection team also met with the local community to listen to their concerns.

I am advised that significant road improvement works were previously completed in this area addressing some of the road safety concerns. Continuing road work is expected to further improve the safety of the Pacific Highway near Urunga and that the safety review length is programmed to be bypassed within the next few years.

The Centre for Road Safety developed a program of works for Urunga, which are being implemented and are detailed in the response to question (1).

(5) I have approved the proposed safety works arising from the Centre's review of the Urunga camera location and the works have been accelerated and commenced in January 2012.

I also approved that the speed camera at Pacific Highway Urunga be switched back to "warning mode" in January 2012 whilst monitoring the effectiveness of the alternative road safety measures.

(6) I am advised that road safety marketing campaigns are an integral component of the government's approach to addressing drink driving.

I am also advised that in and around the Urunga area on the Pacific Highway, Roads and Maritime Services is putting in place visual message signs to promote road safety messages relating to speed, drink driving and seatbelt use. Radio advertising will be rolled out in the area in the last three months of 2011-12 financial year to reinforce drink driving messages and permanent breathalysers are installed at various venues in the area to raise awareness and provide a way for patrons to check their blood to alcohol levels.

Further, in partnership with the NSW Police Force, Transport for NSW funds the Enhanced Enforcement Program. This program enhances the level of visible police enforcement activity over and above normal operating requirements and targets road user behaviour known to contribute to road trauma. An Enhanced Enforcement operation called "National Route One" is planned from March to June 2012 for the whole Pacific Highway which will target speed, drink driving, occupant restraints and fatigue. This will see an additional police presence in targeted locations. This operation will be supported by local media advertising. The Coffs-Clarence Local Area Command, where Urunga is situated, will also be running an operation called "Coffs Roads" to target speed, alcohol and restraints.

*1556 NATURAL DISASTER RELIEF PROGRAM FUNDING APPLICATION—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

With regards to the Greater Taree City Council's application for funding under the Natural Disaster Relief Program for floods that occurred in June 2011:

- (1) What is the value of repairs to roads, bridges and other infrastructure that was applied for?
- (2) How much has been approved for payment to the Council as of 1 February 2012?
- (3) What will be the total amount approved and paid to the Council for the repair of roads, bridges and other infrastructure for this flood event?

- (1) \$19.1 million.

- (3) The total amount approved and paid to council will be dependent on the outcomes of geotechnical investigations and the designs required for the more significant items. Based on council estimates, it is expected that the total amount eligible for Natural Disaster funding assistance will be approximately \$10 million to \$11 million.
- (4) As soon as possible.
- (5) Representations have been received from the Member for Myall Lakes along with members of the local community.
- *1557 REPORT ON SPEED CAMERAS—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

With regards to the Auditor General's report Improving road safety: Speed cameras, released in 2011:

- (1) What progress is being made on implementing the recommendation that by March 2012, an overarching strategy is developed for speed cameras incorporating all camera types which:
 - (a) Includes criteria to determine the appropriate camera type for each road with a high safety risk;
 - (b) Prioritises potential sites based on death or serious injury;
 - (c) Defines how the effectiveness if each camera type will be assessed, including the analysis timeframe, and key performance indicators on vehicle speed, infringements, and crash severity;
 - (d) Includes its new focus on reducing speed across the network, as well as at specific locations?
- (2) What progress is being made on implementing the recommendation that by December 2011 existing site locations are annually reviewed to check if the speed cameras are still appropriate?
- (3) What progress is being made on implementing the recommendation that by September 2011:
 - (a) An assessment is made of the crash impact of existing fixed cameras for a minimum of five years post installation;
 - (b) Where there has been no significant impact consider an alternative camera site and other road safety treatments for that site?
- (4) What progress is being made on implementing the recommendation that by March 2012 the effectiveness of individual speed cameras should be annually monitored?

Answer-

I am advised:

- (1) (a) to (d) The NSW Centre for Road Safety is developing an overarching speed camera strategy incorporating all components of the NSW Auditor-General's recommendation. This strategy will be developed by the end of March 2012. An initial stakeholder consultation workshop was held in December to discuss key stakeholders' issues to be considered in the strategy.
- (2) A re-analysis of all fixed speed camera locations using five years of data has been completed.
- (3) (a) In September 2011 the NSW Centre for Road Safety completed a re-analysis of all speed camera locations using five years of data.
 - (b) Safety reviews and community engagement activities have been completed at the 38 locations where fixed speed cameras were deactivated. The review findings are currently being finalised and a proposed program of works will be developed by the end of March 2012.
- (4) The initial analysis of speed cameras was completed in March 2011 and it is proposed to repeat the analysis in March 2012, with results published in June 2012, as per the Auditor-General's recommendation to annually publicise trends in crashes, revenue and speeding or infringement data for each speed camera. This will provide a consistent annual comparison for fixed speed cameras.
- *1558 REMOVAL OF 38 SPEED CAMERAS—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

With regards to the decision to switch off and/or remove 38 speed cameras in NSW:

- (1) How many accidents have occurred within 500 metres of sites where cameras have been switched off and/or removed, since July 2011?
- (2) How many injuries have been recorded from accidents that have occurred within 500 metres of sites where cameras have been switched off and/or removed, since July 2011?
- (3) How many fatalities have been recorded from accidents that have occurred within 500 metres of sites where cameras have been switched off and/or removed, since July 2011?
- (4) Of the 38 sites where speed cameras were switched off and/or removed, how many of these sites have had alternative safety measures implemented?
- (5) If alternative safety measures have been implemented at any of the 38 sites, what are the safety

measures that have been implemented at each of the sites?

- (6) Of those that have not had safety measures implemented, how many accidents have occurred within 500 metres of the site since the cameras were switched off and/or removed?
- (7) Of those that have not had safety measures implemented, how many fatalities and injuries have been recorded from accidents within 500 metres of the site since the cameras were switched off and/or removed?
- (8) Will all 38 sites where speed cameras have been switched off and/or removed have alternative safety measures implemented?
- (9) When will all 38 sites where speed cameras have been switched off and/or removed have alternative measures implemented?

Answer—

- (1), (2) and (6) I am advised that the requested data are not available as the Centre for Road Safety crash data base for recent periods is incomplete, owing to the general 6 to 9 months required to finalise information from police investigations.
- (3) I am advised by the Centre for Road Safety that there have been no fatalities recorded within 500 metres of either side of the fixed speed camera where cameras have been switched off and/or removed since July 2011.
- (4) I refer you to my answer in the Legislative Council on 15 March 2012.
- (5)Police presence at these locations has been occurring as part of enhanced enforcement program operations on the major routes the cameras were located on. The NSW Government has long stated its preference for visible marked highway patrol cars.

Major works and road upgrades have been completed at Coolac, Alstonville, Tarcutta, Banora Point, Herons Creek, Bundagen.

At four sites (Epping, Gymea, Clunes and Urunga) the fixed speed cameras are operating in warning mode due to community concerns.

Implementation of additional safety works at decommissioned speed camera sites at Urunga and Clunes have commenced.

- (7) I refer you to my response to question (1) to (4).
- (8) Yes
- (9) I am advised that the findings of safety inspections and community engagement activities will be reported and a program of works for all locations will be developed by the end of March 2012.

Due to high community concerns, some locations have had their additional safety works accelerated. I am advised that four speed cameras have already been switched back to warning mode (Epping, Gymea, Urunga and Clunes) and the safety works for Urunga and Clunes have also been approved and commenced.

Roads and Maritime Services and local councils will be responsible for delivery of safety works.

times. Aligning school zone operation dates with gazetted school days ensures consistency across NSW.

- (1) How is the ammunition to be traced, once purchased, if a licensed shooter were to sell or give the ammunition criminals and it was used in a crime?

- (3) Any system developed as a result of the proposed legislation will contain security measures consistent with the sensitivity of the information contained within it.
