 - (b) The Chairperson of the NSW Dairy Industry Conference, who is a dairy farmer, reports directly to me as Minister for Primary Industries in relation to the issues and concerns experienced by NSW dairy farmers and the NSW dairy industry. I am advised that the milk price war has caused concern amongst the NSW dairy farmer community, due to uncertainty and speculation about impact on future farm gate milk pricing.

Is Hunter Water determining whether to resurrect the Tillegra Dam project?

Answer—

The planning process for the new Lower Hunter Water Plan is underway, with the Metropolitan Water Directorate within the Department of Finance and Services working in collaboration with Hunter Water and other government agencies.

The new Lower Hunter Water Plan will explore all available options, except the previously proposed Tillegra Dam, to provide a secure water supply for the Lower Hunter region, including demand management, recycling, surface and ground water sources, stormwater harvesting and desalination

The plan will be developed in close consultation with the community and a comprehensive community engagement plan is currently being developed.

The development of the new plan will be overseen by the Independent Water Advisory Panel, which currently oversees the development of the Metropolitan Water Plan for greater Sydney and will be expanded to include water experts with knowledge of the Hunter region.
