#### Answer-

- (1) In research undertaken by the University of Newcastle for the Department of Industry, 478 people reported using the Government supported Smart Work Hubs in the five locations over the pilot timeframe from May 2014 to May 2015.
- (2) The Department of Industry provided a one off \$1.5 million grant funding towards the establishment of five smart work hubs. Grant amounts varied across the five hubs.
- (3) The University of Newcastle prepared a report in October 2017 on the Smart Work Hubs Pilot Program for the Department of Industry. #### Answer-

(1) The Government is in the process of returning refunds to over 52,559 registered owners of motor vehicles in the Wollongong electorate, as part of \$300 million in refunds to the 4.2 million eligible vehicle owners in New South Wales who paid pre-reform prices.

(1) and (2) There is no standard methodology for defining a Local Government Area as metropolitan or regional. Agencies consider individual community needs and characteristics, as they relate to specific programs or projects.

  - (1) Are there subsidies available to primary producers for fodder to feed stock in areas of drought or severe and prolonged dry conditions?
  - (2) Are there subsidies available to primary producers for transport of fodder to feed stock in areas of drought or severe and prolonged dry conditions?
    - (a) If so, where do primary producers access the subsidies?

#### Answer-

On 9 April 2018 the Government announced additional support to farmers through the provision of low-interest loans of up to \$20,000 to cover costs to transport stock, fodder, or water to/from drought affected properties.

In addition this Government supports primary producers who are affected by drought or severe and prolonged dry conditions, by providing subsidies on the transport of donated fodder. The fodder needs to be coordinated by a community group or other organisation for the benefit of multiple primary producers.

#### Answer-

#### I am advised:

Roads and Maritime Services inspects the New England Highway, including road surface, drainage and signage between Thornton and Lochinvar twice a week. 16 items have been noted for action in the last two years, twelve of which have been rectified. The four remaining defects were identified in late 2017 and are classified as routine defects. They present no safety risk to road users and have no impact on traffic flow. Maintenance will occur in coordination with future work in the area.

#### I am advised:

The Government provided \$51 million, including \$45 million through the Hunter Infrastructure and Investment Fund, for upgrades on the New England Highway at Maitland to improve safety and traffic flow. Roads and Maritime Services upgraded the Railway Station roundabout and the Hospital roundabout on the New England Highway at Church Street and High Street.

The New England Highway between the Mercure Monte Pio and the Maitland Hospital roundabout is currently two lanes in each direction and there are no plans to upgrade it.
