- \*9104 PUBLIC AND COMMUNITY HOUSING IN THE CANTERBURY ELECTORATE—Ms Sophie Cotsis asked the Minister for Planning, Minister for Housing, and Special Minister for State—
  - (1) What percentage of new development in the Canterbury electorate will be allocated public housing under the priority precincts plan?
  - (2) What percentage of new development in the Canterbury electorate will be allocated community housing under the priority precincts plan?

Answer-

I am advised:

- (1) The question on public housing should be directed to the Minister for Social Housing.
- (2) The Greater Sydney Region Plan A Metropolis of Three Cities, prepared by the Greater Sydney Commission, includes affordable rental housing targets for very low to low income households in Greater Sydney that are generally in the range of 5 to 10 per cent of new residential floor space, subject to viability.

Inner West and City of Canterbury Bankstown councils will respond to the Greater Sydney Commission's 'targets when preparing their local housing strategies.

\*9115 DROUGHT AFFECTED CROP PRODUCERS—Mr Philip Donato asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—

What assistance is the Government providing to the many drought-affected crop producers of New South Wales?

Answer-

The Government has committed more than \$1 billion to support the farming community during the current drought period. As long as they meet the criteria, crop producers are eligible for all drought support measures outlined on the Drought Hub website.

Crop producers will receive a waiver on their Local Land Service rates for 2019.

In addition, crop producers will be eligible for a rebate on the entire amount of fixed water charges up to \$4,000 per licence.

Crop producers may be eligible for a Drought Assistance Fund loan, which would provide up to \$50,000 as an interest free loan to be repaid over seven years with the first two years repayment free. The Drought Assistance Fund could be used for the installation or repair of water infrastructure (like de-silting a dam, or installing a tank or silo), but crop producers should seek advice from the Rural Assistance Authority about making an application, by calling 1800 678 593.

Crop producers may also be eligible for a Farm Innovation Fund loan, which can be used for permanent on-farm infrastructure with a loan of up to \$250,000 and 20 years to repay the loan at a current low rate of 2.5 per cent.

  - (d) Woodville Road and William Street;
  - (e) Woodville Road and Crescent Street and the railway underpass;
  - (f) Woodville Road and Parramatta Road;
  - (g) Woodville Road and the M4 motorway onramp;
  - (h) Church Street and the M4 motorway offramp;
  - (i) Woodville Road, Hume Highway and Henry Lawson Drive?

#### Answer-

I am advised:

Interactive crash statistics with reports on road user deaths and injuries, locations and crash types up to 2017 are available on the Centre for Road Safety's website. Statistics for 2018 are being collated based on data from NSW Health, the State Insurance Regulatory Authority, icare and the NSW Police Force.

\*9118 MANAGING TYPE 1 DIABETES AFTER 21—Mr Edmond Atalla asked the Minister for Health, and Minister for Medical Research—

How is the Health Minister actively working towards helping sufferers of Type 1 diabetes (TID) who face extra challenges in managing their TID to access fully-subsided continuous glucose monitoring (CGM) technology past the age of 21?

#### Answer-

This is a matter for the Commonwealth Minister for Health, the Hon Greg Hunt MP.

- \*9119 COST OF LIVING OFFICERS—Mr Ryan Park asked the Minister for Finance, Services and Property—
  - (1) Considering the 'Cost of Living' officers announced in the 2018-19 NSW Budget, how many have been rolled out across New South Wales?
    - (a) Will every Service NSW office have one of these officers?
      - (i) If so:
        - (i) When will they all be in place?
        - (ii) Are any located in the Illawarra?
          - (i) Where are they located?
      - (ii) If not, why not?

#### Answer-

Information about the Cost of Living Service is available on the Service NSW website and at every Service NSW Service Centre across New South Wales. Customers can also contact 13 77 88 to access information and assistance with applying for New South Wales Government rebates and savings. Cost of Living Services will be available across the state online, in person at service centres and over the phone through the contact centre. Face to face appointments will be accessible to all citizens through selected service centres

I am advised that by 31 October 2018, Service NSW will have up to 87 Cost of Living Specialists conducting up to 6 appointments a day at 61 Service Centre locations across New South Wales. In addition, Service Centre staff across the State-wide network help inform customers about the Cost of Living service and can provide support to those customers needing assistance.

The Cost of Living appointment service will be available in the Illawarra –Shoalhaven region at Ulladulla, Nowra, Warrawong, Wollongong and Corrimal Service Centres by 30 September 2018.

- \*9120 NEWCASTLE RECREATION RESERVE—Mr Tim Crakanthorp asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) Why is the Newcastle Recreation Reserve 1, 1A, 3, 5A Ordance Street Newcastle still not listed on the State Heritage Register despite it being recommended by the NSW Heritage Council?
  - (2) When will consideration be given to the recommendation of the NSW Heritage Council as required

under section 34(1) of the Heritage Act 1997?

Answer-

I am advised:

- (1) On 28 June 2018, a land claim to King Edward Headland Reserve was granted. As the Reserve is in the recommended State Heritage Register listing boundary for the Newcastle Recreation Reserve, the Heritage Council is undertaking consultation with the future owner.
- (2) Once I have received further advice, I will consider the recommendation to list.
- \*9121 INTERCITY FLEET—Mr Paul Scully asked the Minister for Transport and Infrastructure—
  - (1) Will the planned roll-out of the new intercity fleet have carriages rolled out on the Newcastle Line first, Blue Mountains Line next, and then the South Coast Line?
  - (2) Is the current planned roll-out of the new intercity fleet expected to commence in 2019?
  - (3) Under its current roll-out plan, in which year does Transport for NSW expect to have new intercity fleet carriages commissioned on the South Coast Line?
  - (4) What factors could delay the roll-out of the new intercity fleet on the South Coast Line?

  - (3) Have any departments been relocated from the State Office Block at 84 Crown Street, Wollongong, since March 2011 (to 15 August 2018)?
    - (a) If so, where were the departments relocated to?

- (1) Seven government departments are currently located at the State Office Block at 84 Crown Street, Wollongong, as at 15 August 2018
- (2) Property NSW (PNSW) holds data from 2005 only. Therefore, PNSW can advise that nine departments have been located at the State Office Block at 84 Crown Street, Wollongong in each of the financial years since 2005 (to 15 August 2018).
- (3) Yes, one department has been relocated from the State Office Block at 84 Crown Street, Wollongong, since March 2011 (to 15 August 2018)
- (a) The Department of Family and Community Services (FACS) relocated to 11 Bridge St Coniston in 2015.

- \*9123 FUNDING FOR THE WOLLONGONG ELECTORATE—Mr Paul Scully asked the Treasurer, and Minister for Industrial Relations—
  - (1) Considering your answer in Question Time on 6 March 2018 where it was claimed that the Government had spent \$424 million in the Wollongong electorate since 2011, does the figure include spending on any of the following projects:
    - (a) The Illawarra Regional Cancer Care Centre;
    - (b) The Wollongong Hospital Elective Surgery Unit;
    - (c) The Western Grandstand at WIN Stadium;
    - (d) The development of the Port Kembla Inner Harbour;
    - (e) The development of the Port Kembla Outer Harbour;
    - (f) The tug fleet base at Port Kembla;
    - (g) The rail stabling yard at Wollongong?

## Answer-

Wollongong always does better under a Liberal and National Government. Comparative to the last seven years of the Labor Government, Wollongong has received \$201 million more in infrastructure investment from 2011.

- \*9124 COST OF LIVING OFFICERS IN SERVICE NSW CENTRES—Mr Paul Scully asked the Minister for Finance, Services and Property—
  - (1) What is the breakdown of the \$60,000 in "actual savings" of the 260 people who have met with Cost of Living Officers in Service NSW centres made during Question Time on 14 August 2018, including in:
    - (a) Compulsory Third Party insurance (CTP) refunds;
    - (b) Fuel Check;
    - (c) Energy rebate;
    - (d) Active kids vouchers;
    - (e) Free registration through the Toll Relief Program;
    - (f) Access to national parks?

(2) How is the "\$70,000 in anticipated savings" calculated?

Answer-

(1) The Cost of Living Service aims to increase awareness and uptake of NSW Government rebates and savings. As at 31 August 2018, customers have accessed actual savings of more than \$170,000 from over 40 NSW Government rebates and savings during a Cost of Living appointment.

In relation to the aforementioned breakdown of rebates and savings:

- (a) More than \$10,000 claimed through Compulsory Third Party insurance (CTP) refunds;
- (b) The Fuel Check app is discussed during an appointment, helping customers identify the cheapest fuel at a convenient location.
- (c) More than \$30,000 claimed through Energy and Water rebates;
- (d) More than \$5,400 accessed through Active Kids vouchers
- (e) The Toll Relief Program is discussed during an appointment, similar to the Fuel Check app, to increase customer awareness of the program. Since 1 July, more than \$8.5 million in free registration has been reimbursed
- (f) More than \$63,000 in benefits accessed through the National Parks concession during an appointment.
- (2) I am advised that rebates and savings identified during an appointment that are calculated as 'anticipated savings' are rebates and savings identified during the appointment service that a customer is eligible for but that they have chosen to apply for at another time. For example, a customer may be eligible for free registration on their vehicle under the toll relief program, but as their registration is not due until 2019 then they cannot 'claim' that saving until then.
- \*9125 PRIMARY EDUCATION IN THE GRANVILLE ELECTORATE—Ms Julia Finn asked the Minister for Education—
  - (1) In the Granville electorate, what is the combined capacity of:
    - (a) Government public schools:
    - (b) Private primary schools?
  - (2) How many students are projected to be enrolled in primary education in the Granville electorate by 2023?

Answer—

I'm advised that:

Every eligible student who wishes to attend a New South Wales government school will be given a place at their local school. Accordingly, the Department of Education does not have fixed enrolment capacities at New South Wales government schools. Schools have the capacity to adapt to fluctuating enrolments through the use of a combination of temporary and permanent teaching spaces.

The Government is delivering major upgrades to Merrylands Public School, Parramatta West Public School and Wentworthville Public School to meet future enrolment demand as part of its \$6 billion school building program over the next four years to deliver more than 170 new and upgraded schools. This is the largest investment int public school infrastructure by any state government in Australian history.

\*9126 DIRECT TRAIN ROUTE—Mr Edmond Atalla asked the Minister for Transport and Infrastructure—

Why is there no direct train route to and from Homebush and Mount Druitt in the timetable?

Answer-

I am advised:

Sydney is expanding and the Government is working hard to deliver an integrated transport system that meets the needs of customers now and in the future. Introduced on 26 November 2017, the new timetable is a step towards modernising the network in line with other major cities around the world. The new timetable delivers up to 1,500 new services and is an important part of Stage 1 of the Government's \$1.5 billion More Trains, More Services program. The program boosts network capability, provides better infrastructure and represents the single largest increase in capacity on the network. It is disappointing that the Labor party has committed to cutting train services to Western Sydney if it is elected in March 2019.

The new timetable has been developed using a combination of Opal card data and customer feedback, ensuring that services reflect demand across the broader network and may not suit every preference.

Transport for NSW will continue to monitor patronage across the network and, combined with Opal card data and customer feedback, make adjustments to the timetable in the future as necessary.

\*9127 MAINTENANCE PRACTICES—Mr Edmond Atalla asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

Is it now the standard practice of Family and Community Services when replacing a toilet to use a bed of silicon rather than a bed of concrete to secure it to the ground?

Answer-

I am advised the Department of Family and Community Services' (FACS) maintenance contractors operate under the terms and conditions of the Asset Maintenance Services contract. All maintenance work accords with relevant regulations.

\*9128 EMERGENCY AND TEMPORARY ACCOMMODATION—Mr Edmond Atalla asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—

What was the total spend for Housing NSW on emergency and temporary accommodation provided in Hotels and Motels in the Mount Druitt electorate from July 2017 to June 2018?

Answer-

- \*9129 HUNTER RAIL SERVICES—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—
  - (1) Are there any plans to change the number of services running between Newcastle and Dungog?
  - (2) Are there any plans to outsource the operation of train services between Newcastle and Dungog? Answer—

I am advised:

An extra Dungog - Newcastle return service was added on Sunday's following a timetable review and the implementation of the new timetable on 26 November 2017. Dungog customers continue to receive five, daily return services to Newcastle.

The Government's Future Transport 2056 is a strategic vision for transport over the next 40 years to meet the demands of predicted population growth. The Regional NSW Services and Infrastructure Plan recognises the key to the future success of the Hunter region is supporting efficient transport connections to, from and within the region.

We will work to develop improvements to public transport service availability and frequencies in Greater Newcastle, including the development of an integrated public transport network hierarchy to enable frequent connections between centres. This includes potential extensions to the Newcastle light rail and the potential electrification of the Hunter Line from the Newcastle Interchange to Telarah.

Journey times for intercity rail services between Greater Newcastle, the Central Coast and Sydney will be reduced. There will also be bus priority and bus head start programs on key corridors where growth is occurring, such as along the New England Highway growth areas.

We will also work with Councils and key stakeholders to develop and deliver a region-wide network of safe and connected cycling infrastructure.

The Government has no plans to outsource the operation of train services between Newcastle and Dungog.

- \*9130 NEWCASTLE INTERCHANGE—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—
  - (1) In the 2017-18 financial year how many passengers at the Newcastle Interchange:
    - (a) Arrived;
    - (b) Departed?

Answer-

I am advised:

Between 15 October 2017, when the Newcastle Interchange train station opened, and 30 June 2018 there were a total of 317,138 passengers who arrived and 307,574 passengers who departed the Newcastle Interchange.

\*9131 NEWCASTLE EDUCATION PRECINCT—Mr Tim Crakanthorp asked the Minister for Education—

Where will the new Newcastle Education Precinct be located?

Answer-

I'm advised that the Newcastle Education Precinct will be located within central Newcastle.

- \*9132 NEWCASTLE LOCAL ENVIRONMENT PLAN—Mr Tim Crakanthorp asked the Minister for Planning, Minister for Housing, and Special Minister for State—
  - (1) When will Schedule 1 be removed from the Newcastle Local Environment Plan?
  - (2) What has been the delay in removing Schedule 1 from the Newcastle Local Environment Plan?

Answer-

- (1) The entry in Schedule 1 of the Newcastle Local Environmental Plan 2012 in relation to 1 Ordnance Street Newcastle was removed on 24 August 2018.
- (2) The matter was required to be proceeded under the statutory requirements of the Environmental Planning and Assessment Act 1979.
- \*9133 COMMERCIAL KANGAROO HARVESTING—Mr Philip Donato asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
  - (1) Considering the recent drought package announcements supporting and facilitating our farmers culling kangaroos, what considerations have been given to protect the commercial kangaroo harvesting by professional shooters?
  - (2) What consultation was undertaken with the commercial kangaroo harvesting and professional shooting industries prior to the recent kangaroo culling announcements?
  - (3) Will consideration be given to supporting commercial kangaroo harvesters, who play an important part in kangaroo management, by waiving or significantly decreasing costs, which include:
    - \$1.17 for each tag
    - \$894.00 for annual licencing
    - \$322.00 for annual crate accreditation
    - \$255.00 every 5 years for accuracy testing
  - (4) Why is the Wallaroo now able to be culled by farmers but is still unable to be harvested by commercial harvesters?

Answer-

This question should be directed to the Minister for the Environment. Licensing of commercial kangaroo harvesters and the administration of fees for professional shooters' tags in New South Wales are matters that fall within the functions of the Office of Environment and Heritage.

\*9134 FIXED WATER CHARGE EXEMPTION—Mr Philip Donato asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—

Will drought-affected orchardists and other drought-affected water licence holders be exempt from fixed water charges on licences held as per your emergency drought relief package announced on 30 July 2018?

Answer-

A rebate on fixed water charges of up to \$4,000 will apply to water bills for all general security licence holders (and supplementary water access icences) in rural and regional New South Wales, across surface and groundwater systems.

Customers of Irrigation Corporation Districts (ICD) are also eligible, with the rebate to be passed on to them through their individual ICD.

\*9135 WIFI IN HOSPITALS IN THE ILLAWARRA AND SHOALHAVEN LOCAL HEALTH DISTRICT—Mr Paul Scully asked the Minister for Health, and Minister for Medical Research—

- (1) Considering that free WiFi has been made available at Wollongong Hospital, on what date will the same service be made available at hospitals across the Illawarra and Shoalhaven Local Health District, including at:
  - (a) Bulli;
  - (b) Shellharbour;
  - (c) Kiama;
  - (d) David Berry Hospital;
  - (e) Coledale;
  - (f) Port Kembla:
  - (g) Milton-Ulladulla:
  - (h) Shoalhaven District Memorial Hospital?

#### Answer—

Provision of Wi-Fi services in other hospitals in the Local Health District will be considered following assessment of the Wollongong Hospital Wi-Fi service.

- \*9137 NSW CLIMATE CHANGE FUND IN THE ILLAWARRA REGION—Mr Paul Scully asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) What is the total amount collected from the NSW Climate Change Fund from the Illawarra region during the 2016-17 financial year?
  - (2) What is the average amount paid by households in the Illawarra region to the NSW Climate Change Fund from:
    - (a) Endeavour Energy;
    - (b) Sydney Water?
  - (3) Have any projects been funded from the NSW Climate Change Fund since 2007(to 15 August 2018) in the electorates of:
