- *0543 MEALS ON WHEELS—TRANSFER OF OVERSIGHT—Ms Sonia Hornery asked the Minister for Ageing, and Minister for Disability Services—
 - (1) When will the oversight of Meals on Wheels be transferred from the State to the Federal Government?
 - (2) Will home-cooked meals be banned in the Hunter in favour of frozen meals?

Answer—

- (1) Under the Council of Australian Government's (COAG) national health reforms, NSW has agreed to a split of responsibilities for aged care and disability programs at age 65 (50 for Indigenous Australians) with the Commonwealth to assume full operational responsibility for aged care services under the Home and Community Care (HACC) Program from 1 July 2012. NSW will continue to retain operational responsibility for basic community care services, including Meals on Wheels, for people aged under 65 (Indigenous Australians aged under 50).
- (2) No. Hunter Meals on Wheels services will not be banned from serving any style of meals. Although the bulk of meals will be frozen or cook-chilled, there will be facilities to heat and provide hot meals where this is required by a client.
- *0544 MEALS ON WHEELS—BELMONT AND MORISSET BRANCHES—Ms Sonia Hornery asked the Minister for Ageing, and Minister for Disability Services—
 - (1) Have Belmont and Morisset Meals on Wheels branches been told to close their kitchens and source meals from warehouses on the Central Coast?
 - (2) Will other Meals on Wheels branches in the Hunter be forced to close their kitchens and sign an agreement stating they will stop cooking meals in favour of sourcing frozen meals?

Answer-

- (1) Two centralised locations for the distribution of meals will be operational in Newcastle and the Central Coast by early 2012. I am advised this arrangement will provide a broader range of meal choices for clients for example, meals can be delivered either hot, chilled or frozen depending on preference. Where a local Meals On Wheels provider has demonstrated the need to keep operating its kitchen this has been facilitated by Ageing, Disability and Home Care (ADHC).
- (2) With the exception of one service the remaining 14, of the 15 funded meal services in the Hunter Region, with the support of the peak body Meals On Wheels NSW, have stated that they will be happy to utilise the services offered by the two Distribution Centres and are working with ADHC on this transition.
- *0546 DEFENDED CRIMINAL MATTERS-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

What proportion of defended criminal matters in NSW have been commenced in the Local Court, rather than the District Court, because of an increase in the Local Court's jurisdiction since 1995 in the following periods:

- (a) 1 January 2000 to 31 December 2005;
- (b) 1 January 2005 to 31 December 2009;
- (c) 1 January 2010 to date?

Answer-

I am advised:

The Bureau of Crime Statistics and Research (BOCSAR) reports criminal court statistics at the time of finalisation, not commencement.

Of the defended criminal hearings/trials in Local and District Courts, the proportion of people having defended criminal hearings finalised in the Local Courts were:

- (a) 96.5 per cent.
- (b) 97.0 per cent.
- (c) 97.1 per cent (to 31 March 2011, the latest available data).

*0547 STANDARD OPERATING PROCEDURES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

- (1) When will police develop the Standard Operating Procedures referred to by you in debate in the House on 4 August 2011 concerning the Summary Offences Amendment (Intoxicated and Disorderly Conduct) Bill 2011?
- (2) What public consultation will be involved in the development of those procedures?
- (3) How will those procedures be publicly available?

Answer-

I am advised:

This question relates to operational matters of the NSW Police Force.

I note that you have asked an identical question on notice of my colleague, the Minister for Police and Emergency Services.

*0548 JUDGE-ALONE TRIALS-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

- (1) How many judge-alone trials have been commenced in the District and Supreme courts in the following periods:
 - (a) 1 January 2011 to 31 January 2011;
 - (b) 1 February 2011 to 28 February 2011;
 - (c) 1 March 2011 to 31 March 2011;
 - (d) 1 April 2011 to 30 April 2011;
 - (e) 1 May 2011 to 31 May 2011;
 - (f) 1 June 2011 to 30 June 2011;
 - (g) 1 July 2011 to 31 July 2011;
 - (h) 1 August 2011 to date?
- (2) Of the trials referred to above, how many were held without a jury without objection from the Crown and/or Director of Public Prosecutions?

Answer—

I am advised:

(1) The Department of Attorney General and Justice does not collect statistics on the total number of judge-alone trials commenced. However, the Supreme Court has advised that the number of judge-alone criminal trials, other than special hearings, that have commenced is as follows:

1 January 2011 to 31 January 2011	None
1 February 2011 to 28 February 2011	None
1 March 2011 to 31 March 2011	One
1 April 2011 to 30 April 2011	One
1 May 2011 to 31 May 2011	None
1 June 2011 to 30 June 2011	None

1 August 2011 to 12 August 2011	Three

The District Court does not maintain these statistics.

(2) All of the above mentioned Supreme Court trials had the consent of the prosecutor to proceed without a jury.

*0549 POLICE INTEGRITY COMMISSIONER—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Does the Attorney General propose to appoint a new Commissioner to the Police Integrity Commission and if so, when?

Answer-

I do not have responsibility for the Police Integrity Commission Act 1996 (NSW) or the appointment of the Police Integrity Commissioner. They are matters for which the Premier is responsible and your question should be directed to him.

*0550 CORRECTIVE SERVICES COMMISSIONER—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

- (1) When does the term of the current Corrective Services Commissioner expire?
- (2) Upon the expiry of the Commissioner's term, does the Minister propose to reappoint him?
- (3) Upon the expiry of the Commissioner's term, will the Minister consider any application by him to be reappointed?

Answer-

I am advised:

- (1) As reported in the Department of Justice and Attorney General 2009-10 Annual Report, the Commissioner's current contract period runs from 23 October 2006 till 22 October 2011.
- (2) and (3) An announcement will be made at the appropriate time.
- *0551 CORRECTIVE SERVICES NSW-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

How many employees are currently employed in Corrective Services NSW?

Answer-

I am advised:

On 17 August 2011, Corrective Services NSW employed 7,169.73 full-time equivalent (FTE) staff.

*0552 RESPITE CARE—EXTRA HOURS—Dr Andrew McDonald asked the Minister for Ageing, and Minister for Disability Services—

With regards to Kylie Brett of Carss Park, mother of Noah aged eight, who has severe cerebral palsy and who has been in contact with your office:

- (1) How much respite care is Noah receiving at present?
- (2) What plans does the Minister have to increase his hours of respite care?
- (3) When will these extra hours of care begin?
- (4) Will Noah be allowed to accompany Kylie in class at UNSW while she pursues her postgraduate studies?

Answer-

I have an open door policy for all members of the House who wish to raise a concern. However it is not appropriate to respond publicly regarding this person's details.

I can advise the member I have written directly to the individuals concerned.

- *0553 HOSPITAL SECURITY—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) What action has the Minister taken to ensure that the only security guards who work in the public hospital system are fully qualified?
 - (2) Who checks the qualifications of security guards if they are sourced from outside agencies?

Answer—

I am advised that:

(1) and (2) All security staff employed in NSW Health facilities are required to hold a Class 1 (A) security industry licence granted by the Commissioner of Police.

It is NSW Health policy that prior to making any offer of employment to security staff, Local Health Districts must verify their current licence status directly with the Security Licensing and Enforcement Directorate of the NSW Police.

- *0554 ORGAN DONATION—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) What steps has the Government taken since the election to increase the rate of organ donation?
 - (2) What enhancements for organ donation services will be introduced in the 2011-12 budget?

Answer-

 The NSW Government has identified increasing rates of organ and tissue donation as a priority. I will be releasing a discussion paper on future policy options to increase the rate of organ donation in NSW. (2) An additional \$1.3 million recurrent enhancement funding has been approved for tissue typing services in NSW. This will support the matching and allocation of solid organ and bone marrow donations across NSW.

The State contribution to organ donation coordination has also been enhanced by an additional \$930,000 recurrently to support expected increases in the donation and retrieval of solid organs.

In addition, a \$300,000 sponsorship grant has been allocated to Transplant Australia to host the Transplant Games in 2012 in Newcastle. This event provides opportunities for increased social marketing and raising awareness of the benefits of organ and tissue donation and transplantation

*0555 NEPEAN HOSPITAL CAR PARK—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the proposed upgrading of the car parking facilities for Nepean Hospital:

- (1) How many car spaces will be created?
- (2) Will there be a charge to staff or visitors?
- (3) What is the estimated final cost?
- (4) When will the works be commenced?
- (5) When will the works be completed?

Answer—

I am advised:

- (1) The proposed upgrade is currently in planning and the number of car spaces to be provided has yet to be confirmed.
- (2) There is currently a charge for both staff and visitor car parking and this will continue.
- (3) The estimated final cost for the upgraded car parking facilities at Nepean Hospital is yet to be determined.
- (4) Preplanning is currently under way. Subject to the planning approvals and confirmation of funding, construction is likely to commence in the second quarter of 2012.
- (5) The government will keep the community informed of progress and major milestones throughout the course of construction.
- *0556 WESTMEAD MORGUE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

In view of the Minister's assertion that the decision to close Westmead Morgue as a forensic facility "made absolutely no sense" (press release 9 October 2009):

- (1) Does the Minister have any plans to reopen Westmead Morgue as a forensic facility?
- (2) How much would this cost?
- (3) Would a funding enhancement be available to do this?
- (4) How many staff would need to be employed?
- (5) How many RCPA accredited forensic pathologists are employed in the NSW health system?
- (6) How many pathology registrar RCPA accredited training positions are available in the NSW health system?
- (7) How many are filled?
- (8) How many are vacant?
- (9) Where are these positions located?
- (10) What enhancements to these positions are planned in the 2011-12 budget?

Answer-

I am advised:

(1) to (4) NSW has a two hub model involving Glebe and Newcastle to provide forensic services for the state.

(5) There are an approximately equivalent number of forensic pathology staff employed across NSW as there were prior to the March 26 2011 election.

(6) There are 5 forensic pathology and anatomical pathology training positions distributed across Glebe and Newcastle DOFM sites.

(7) to (10) All training positions are filled.

*0557 HOSPITAL INFECTION RATE REPORTING—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

- (1) When does the Minister plan to commence publishing hospital acquired infection rates at individual ward level?
- (2) Will this be on a monthly or quarterly basis?
- (3) In what forum will these results be made publicly available?

Answer-

(1) to (3) Hospital infection rates are currently reported on the NSW Health website.

I remain committed to extending public reporting and transparency. I have established a Taskforce on Infection Control, chaired by a leading infectious diseases expert, which will be reporting later this year.

In addition to reviewing the current NSW Health policies on infection control, the Taskforce will also be recommending the scope of public reporting on healthcare associated infection rates.

- *0562 MEALS ON WHEELS FUNDING-Mr Ryan Park asked the Minister for Ageing, and Minister for Disability Services-
 - (1) What is the current funding arrangement by the Government to the Meals on Wheels service across NSW?
 - (2) What amount is provided by the Government to the Northern Illawarra Meals on Wheels service.
 - (3) What funding will be provided to this service in the 2011-12 financial year?

Answer-

- (1) Meals on Wheels services across NSW are funded through the Home and Community Care (HACC) program. HACC is a joint Commonwealth and State funded program with funding administered by the NSW Government. As agreed by the Council of Australian Governments, from 1 July 2012, funding for HACC services for people 65 and over (50 for Indigenous Australians) will be directly provided by the Australian Government with the NSW Government providing funding for younger clients.
- (2) In 2010-11, Northern Illawarra Meals on Wheels received funding of \$138,171. This was comprised of base funding of \$131,146 and additional one-off funds totalling \$7,025 provided to the organisation for service improvement activities.
- (3) Funding for Northern Illawarra Meals on Wheels in 2011/12, will be a minimum of \$131,146.
- *0563 FUNDING FOR FILM ILLAWARRA—Mr Ryan Park asked the Deputy Premier, Minister for Trade and Investment, and Minister for Regional Infrastructure and Services—
 - (1) What level of funding did the Government provide Film Illawarra over the following years:
 - (a) 2007-08:
 - (b) 2008-09:
 - (c) 2009-10:
 - (d) 2010-11?
 - (2) What level of funding did the Government provide to Film Illawarra in 2011-12?

Answer—

(1) (a) \$4,515 to Film Illawarra in 2007-08

(b) \$0 to Film Illawarra in 2008-09. Film Illawarra ceased operating as a production attraction and facilitation service in 2008.

- (c) Film Illawarra had ceased operating as a production attraction and facilitation service
- (d) \$20,000 to Screen Illawarra South East (new screen service provider established in 2010).
- (2) \$80,000 committed to Screen Illawarra South East.
- *0565 GARRAWARRA HOSPITAL—Mr Ryan Park asked the Minister for Health, and Minister for Medical Research—
 - (1) What is the Minister's plans for Garrawarra Hospital?
 - (2) How many beds are currently open?
 - (3) What is the annual budget?
 - (4) How many FTE staff are employed at Garrawarra Hospital?
 - (5) Will any of the site be sold?
 - (6) Will this hospital remain with NSW Health?

Answer—

I am advised that:

- (1) Garrawarra Centre is a NSW State Government Residential Aged Care Facility specialising in high care Dementia. Currently there are no plans to change this arrangement.
- (2) 120 adjusted-subsidy high aged care places.
- (3) Approximately \$6.69 million.
- (4) 184 full time equivalent staff.
- (5) and (6) The NSW Government (NSW Department of Health) will continue as Approved Provider of Garrawarra Centre for the foreseeable future.

*0566 GENERAL ASSISTANTS—Mr Ryan Park asked the Minister for Education—

Does the Government have any plans to reduce the number of general assistants in our local schools?

Answer—

The Government has no plans to decrease the numbers of General Assistants in schools.

*0567 ILLAWARRA INFRASTRUCTURE FUND—Mr Ryan Park asked the Deputy Premier, Minister for Trade and Investment, and Minister for Regional Infrastructure and Services—

Does the Government have any plans to establish an Illawarra Infrastructure Fund similar to that which has been established in the Hunter?

Answer—

Following the announced job losses at Bluescope, the NSW Government, in conjunction with the Federal Government and Bluescope Steel, recently announced a new \$30 million Illawarra Region Innovation and Investment Fund.

The Government is committed to fostering and developing economic activity in the Illawarra. We have already demonstrated this in our willingness to work with the Federal Government to deliver this important new Illawarra-specific fund.

(1) The NSW Government wants to ensure the energy industry has the flexibility to construct what is needed to ensure an ongoing, reliable and affordable supply of energy to the people of New South Wales. This includes allowing the industry to make the commercial decision about which fuel source to use.

This Government is committed to ensuring a sustainable future for renewable energy and is currently developing a Renewable Energy Action Plan for New South Wales.

Answer—

(1) and (2) I am advised that there has been a review of security in the Blacktown Hospital Emergency Department. The findings from the review are currently being considered by local hospital management in consultation with staff and relevant industrial bodies. In the interim, a 24 hour security presence is in place in the Emergency Department.

(3) The Government is committed to the expansion of Blacktown Hospital and will deliver \$125 million in the first term of the Government.

 and (2) There is no proposal to "introduce rifle shooting in schools". However, the Devolution of Decision Making to Schools memorandum (1991-020) enables school principals to manage and coordinate their school sport operations to suit the circumstances of the local school community and its students.

Schools electing to offer rifle shooting as a school sport carry out extensive risk assessment procedures. Schools known to participate do so at designated target shooting venues and clubs.

Answer—

The Government has commenced the delivery on its commitment to create a \$2.4 million General Assistants' training fund with an initial \$600,000 allocated in the 2011-12 State Budget.

- *0614 VACANT GENERAL ASSISTANT POSITIONS—Ms Carmel Tebbutt asked the Minister for Education—
 - (1) How many schools have chosen to not fill vacant General Assistant positions and instead use the equivalent funding to undertake maintenance through other means?
 - (2) What are the names of these chools?

Answer-

Schools do not currently have this option.

- *0615 SCHOOL FACILITIES STANDARDS-Ms Carmel Tebbutt asked the Minister for Education-
 - (1) What is the timeframe for the review of NSW School Facilities Standards?
 - (2) Who will be consulted as part of the review?
 - (3) When and how will this consultation take place?

Answer-

- (1) The review of the NSW School Facilities Standards will be undertaken in 2 phases. The first phase of the review will involve assessing the functionality and relevance of the School Facilities Standards within the context of the current and future directions of the NSW curriculum. Recommendations from the first phase will be used as the underlying principles to update the School Facilities Standards. It is anticipated that the first phase of the review will be completed by April 2012.
- (2) A full range of stakeholders including educators, students and the community as well as designers, developers, and maintenance and cleaning contractors will be consulted.

A wide range of programs and initiatives are provided to support the education of refugee and other students from similar conflict-torn backgrounds in NSW public schools.

English as a Second Language programs are provided to support the English language learning of migrant and refugee students. There are 15 Intensive English Centres within NSW Government schools that support newly arrived high school students, including a Centre at Fairfield High School. Fairfield Intensive English Centre has 1.4 full time equivalent school counsellor positions in 2011. Fairfield High School also has 0.8 full time equivalent school counsellor positions.

As well as having a specific role in providing psychological services, school counsellors work closely with other agencies that provide services to students and their families from conflict-torn countries who have been exposed to trauma to facilitate the healing process.

Newly arrived primary aged students generally receive initial intensive support in their school as part of the English as a Second Language program. In addition, intensive English programs are operating in 10 primary schools in 2011, including two schools in the Fairfield area.

Other programs that support refugee students as they move into mainstream education include transition programs, homework centres and tutoring programs.Fairfield High School has a Refugee Transition Program and an after school homework program for refugee students.

Additional support to schools is provided by specialist Refugee Support Officers and the provision of resources and training programs. These support programs assist all teachers to develop skills, knowledge and understanding for effective teaching of students from refugee backgrounds within mainstream classrooms.
