- *6482 WILCANNIA WEIR INVESTIGATION REPORTS—Mr Luke Foley asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) How much has been spent on feasibility investigation reports including a scoping study and business case for the Wilcannia weir?
 - (2) When were the feasibility investigation reports, including a scoping study and business case for the Wilcannia weir, received by the Government?

Answer—

The Government understands the need to provide long-term water security for regional communities. The Government will make an informed decision in due course.

The Government is investing records amounts in regional New South Wales communities.

In 2016, under the Government's Country Towns Water Supply and Sewerage Program, Central Darling Shire Council was awarded funding for broader investigation of water security and wastewater treatment within the Central Darling Shire. The study will assess Central Darling Shire Council's long-term water security and wastewater needs, including water supply from the existing Wilcannia Weir. These investigations are expected to be completed by Council in 2018.

Answer-

(1) The term English as an Additional Language or Dialect (EAL/D) has replaced English as a Second Language (ESL) across New South Wales public schools, in line with national curriculum developments.

I'm advised that all teachers in New South Wales public schools regularly provide support to students who are learning English as an additional language or dialect.

- (2) In relation to specialised English as an Additional Language or Dialect (EAL/D) class teachers at the listed schools, I'm advised:
- (a) Auburn Girls High School employs three teachers in 2.4 FTE EAL/D positions;
- (b) Auburn North Public School employs six teachers in 4.6 FTE EAL/D positions;
- (c) Auburn Public School employs seven teachers in 5.6 FTE EAL/D positions;
- (d) Auburn West Public School employs seven teachers in 4.9 FTE EAL/D positions;
- (e) Berala Public School employs six teachers in 5.4 FTE EAL/D positions;
- (f) Blaxcell Street Public School employs seven teachers in 5.2 FTE EAL/D positions;
- (g) Granville East Public School employs five teachers in 2.8 FTE EAL/D positions;
- (h) Granville South Creative and Performing Arts High School employs two teachers in 1.0 FTE EAL/D position;
- (i) Lidcombe Public School employs seven teachers in 6.2 FTE EAL/D positions;
- (j) Newington Public School employs four teachers in 3.0 FTE EAL/D positions;
- (k) Regents Park Public School employs three teachers in 2.0 FTE EAL/D positions.

I'm advised that to qualify as a specialised English as an Additional Language or Dialect (EAL/D) class teacher, an individual must be qualified as either a primary or secondary teacher and have approval to teach in New South Wales public schools. Teachers must also have completed an approved course of study in Teaching English to Speakers of Other Languages (TESOL).

- *6485 WILCANNIA WEIR—Mr Luke Foley asked the Premier—
 - (1) Do you expect to make a decision on funding for the Wilcannia weir this year?

Answer-

The Government understands the need to provide long-term water security to regional communities. The Government will make an informed decision regarding Wilcannia weir in due course.

The Government is investing record funding in regional New South Wales communities, which were starved of investment by the former Labor government, of which you were a member.

- *6490 REGIONAL CONFERENCING DEVELOPMENT PILOT GRANTS PROGRAM—Mr Paul Scully asked the Minister for Tourism and Major Events, and Assistant Minister for Skills—
 - (1) Is the Minister aware that organisations in the Wollongong Local Government Area are excluded from applying for the Regional Conferencing Development Pilot Grants Program?
 - (2) Is the Minister aware that organisations in the Shellharbour Local Government Area are included as eligible to apply for grants under the Regional Conferencing Development Pilot Grants Program?
 - (3) For the purposes of this funding program why does the Government make this distinction?
 - (4) Is the Minister aware that WIN Entertainment Centre, owned by the Government, is located in the Wollongong Local Government Area?

The Office of Environment and Heritage retains responsibility for regulating the management of protected fauna, including all species of kangaroos.

What is the average response time for Mount Druitt Police when attending to a 'call out' of a domestic violence incident?

A range of factors, including the number of calls being responded to at any time, the time of day, traffic density, weather conditions and the distance to travel, influences response times.

- *6494 OPAL CARD CONTRACT—Mr Edmond Atalla asked the Minister for Transport and Infrastructure—
 - (1) When was the contract for the Opal Card signed?
 - (2) Which Government Minister signed the contract?

Answer-

The Project Deed is available on the eTendering website.

Since April 2011, a number of variations to the Project Deed have been approved by the Government, including the introduction of top up and single trip machines, the inclusion of the Inner West Light Rail and most recently, the introduction of the Contactless Payment Trial.

*6495 RED TAPE REDUCTION IN NEW SOUTH WALES—Mr Ryan Park asked the Minister for Innovation and Better Regulation—

How may pieces of legislation have been introduced and removed since March 2011 under the Government's 'one on two off' policy?

Answer-

Reporting of red tape reforms commenced in September 2011, and was completed in June 2015. Legislation that was removed as part of those reforms is contained within the published red tape savings reports.

When will North Strathfield Railway Station be upgraded?

Answer-

I am advised:

The Government recently allocated a further \$200 million to the Transport Access Program, boosting our total investment to \$1 billion. Since the program began in 2012, more than 450 projects have been completed or are underway. This includes accessibility upgrades such as lifts and ramps, improved interchanges and commuter car parks. These improvements make it easier for customers to access public transport and provide a more comfortable travel experience.

Stations across the network are currently being assessed to see which ones are delivered under this program. This assessment process uses evidence-based criteria, including current and future patronage. It takes into account the needs and demographics of customers who use the station. It also considers the location of important services, such as hospitals or schools and the accessibility of other transport interchanges. North Strathfield Station will be considered as part of this process.

The Transport Access Program is part of the government's commitment to provide modern, accessible and integrated transport infrastructure across New South Wales.

Answer—

The Government uses the Australian Bureau of Statistics definitions of metropolitan and regional centres as the starting point for eligibility in terms of regional programs. This, however, is only a starting point and eligibility for each program is based on the policy objectives of the program and the needs of the NSW community as a whole.

The Government announced it would replace the entire regional train fleet, including the XPT, XPLORER and Endeavour fleets, with a new fleet. Modernising our fleet will significantly improve regional public transport and deliver customers unprecedented levels of comfort and reliability.

When the new fleet has been delivered, we will have the opportunity to review and revise the regional rail timetable. Community feedback will be considered as part of this process.

Public transport timetables are based on or determined by customer demand and travel patterns. They are assessed regularly to ensure services are developed and run when and where required. Customers are regularly surveyed about their travel experiences. Transport for NSW is working hard to deliver the best outcome for its customer.
