*6078 HUNTER CYCLEWAY NETWORK—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—

(1) Will the Minister commit \$75 million from the Hunter Port sale to a Hunter cycleway network, as proposed by Newcastle Cycleways?

(a) If not, why not?

Answer—

I am advised:

The Port of Newcastle remains the property of the NSW Government.

The 98 year lease of the Port of Newcastle commenced on 30 May 2014.

- *6079 PUBLIC TRANSPORT CONTRACTS IN THE HUNTER—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - Will the Minister be awarding contracts to Hunter rolling stock builders to construct any part of the \$2.8 billion spend on public transport?
 - (a) If not, why not?

Answer-

Contracts are issued by Transport for NSW. The contract will be awarded to the most successful tenderer following a rigorous evaluation process.

Australian-based companies, including those with operations in the Hunter, are being given every opportunity to bid for this work.

- *6080 PUBLIC TRANSPORT TO NEWCASTLE AIRPORT—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - (1) Does the Minister plan to improve public transport from Newcastle Railway Station to Newcastle Airport at Williamtown?
 - (a) If so, what are these plans?
 - (b) If not, why not?

Answer-

I am advised:

The Government's commitments to improve transport in the Hunter are detailed in the Hunter Regional Transport Plan released in March 2014.

- *6081 OPAL CARD USE IN THE HUNTER REGION—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - (1) When will commuters no longer be able to purchase paper tickets for public transport in the Hunter Region?
 - (2) How will commuters be made aware that paper tickets will no longer be available and that they must pre-purchase an Opal card?
 - (3) Where will Opal cards be available to purchase in the Hunter Region?

Answer—

(1) - (2) More than 20 paper ticket types, including single and return MyTrain, MyBus TravelTen and Pensioner Excursion Tickets, remain available across the network.

(3) Adult and Child/Youth Opal cards can be ordered at www.opal.com.au or by calling 13 67 25 (13 OPAL). Unregistered Adult and Child/Youth Opal cards are also available from more than 1,000 retail stores including select Woolworths supermarkets, newsagents, petrol stations and local corner stores. Opal retail stores can be found at www.retailers.opal.com.au. As the Opal card rollout continues, the number of Opal retailers continues to grow.

The NSW Police Force has advised me:

The allocation of police resources is determined by the Commissioner. New Probationary Constables are deployed in May, August and December each year to replace and add to existing police numbers. Local Area Commands in the Hunter region have been allocated 152 new police recruits since May 2011.

Some of this work has been completed. Work will continue until the obligations of the mine closure plan are finalised.
