(2) The Government did not provide financial support to the projects undertaken by GRNSW at Casino and Goulburn.

In relation to the Greyhound Racing Capital Grants Program (Grants Program), as part of its greyhound racing reforms the Government has committed \$30 million over the next five years to assist GRNSW and its clubs to improve animal welfare, including track upgrades to reduce injury rates for racing dogs.

The Greyhound Racing Act 2017 requires the development of minimum standards for the design and construction of greyhound racecourses. Access to grant funding for track upgrades is contingent on GRNSW developing these minimum standards, undertaking a gap analysis of its tracks against these standards, and working with its clubs to prepare business cases for individual tracks and a priority list.

The Government can also support more immediate infrastructure upgrades where serious safety or welfare risks have been identified.

Approval of funding from the Grants Program is determined by me as Minister for Racing.

- *9584 ONGOING PER- AND POLY-FLUOROALKYL SUBSTANCES TESTING IN RUTHERFORD—Ms Jenny Aitchison asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) What testing has the Environment Protection Authority (EPA) conducted in the Stony Creek, Fishery Creek and Wallis Creek catchments for per- and poly-fluoroalkyl substances (PFAS) contamination since rainfall on 27 September 2018 (as at 18 October 2018)?
 (a) What are the results of this testing?
 - (2) How do the results for the rainfall event between 27 September and 18 October 2018 compare with the published results for testing which has been conducted during 2018?
 - (3) Was there any overflow of PFAS from the former Truegain, Rutherford site as a result of rainfall between 27 September and 18 October 2018?
 - (4) Did the EPA issue any public warnings about potential PFAS contamination of the Stony Creek, Fishery Creek and Wallis Creek catchments between 27 September and 18 October 2018?
 - (5) Has the EPA's testing program yet been able to establish the source for high readings of PFAS within the Rutherford Industrial Estate?

Answer—

I am advised:

The Environment Protection Authority (EPA) is continuing to investigate the sources of per- and polyfluoroalkyl substances (PFAS) within the Rutherford Industrial Estate. The results of EPA's sampling in Stony, Fishery and Wallis creeks are available at:

www.epa.nsw.gov.au/your-environment/contaminated-land/pfas-investigation-program/pfas-investigation-sites/Truegain.

The EPA is not aware of any overflow from the Truegain Site between 27 September 2018 and 18 October 2018.

- *9585 GST REVENUE FROM THE CONTAINER DEPOSIT SCHEME—Ms Jenny Aitchison asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Is the Goods and Service Tax (GST) payable on the 10 cent refund component of the Container Deposit Scheme (CDS)?
 - (2) Is GST payable on the Return and Earn initiative Administration fee?
 - (3) What was the total amount of Goods and Services Tax generated by the CDS between 1 November 2017 and 30 June 2018?
 - (4) Does the Government require the scheme administrator, Exchange for Change, to provide a report on the estimated or actual figure of GST generated by CDS so the Government can assess the total impact of the scheme on consumers?
 - (5) Has the scheme administrator, Exchange for Change, provided a report that breaks down beverage industry contributions towards Return and Earn as well as the administration costs of the scheme for the seven months of CDS to 30 June 2018?
 - (6) What is the breakdown of the beverage industry contributions and the administration costs charged to consumers for CDS/Return and Earn?

Answer-

- (1) If GST is payable on a beverage and the supplier or retailer has included some component of the scheme cost into the price of that beverage, then the GST would apply to that component of the price.
- (2) No such fee exists under the Container Deposit Scheme (CDS).
- (3) This information is not collected by the Government.
- (4) No, there are no requirements for the Scheme Coordinator to report GST.
- (5) This question should be directed to Exchange for Change.

*9586 RETURN AND EARN COLLECTION POINTS—Mr Alex Greenwich asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—

- (1) Considering the response to LA Q7490, what requirements does the Government have of TOMRA Cleanaway to provide return or collection points across New South Wales?
- (2) Does the Government expect TOMRA Cleanaway to:

- (3) What requirements does the Government have for return or collection points to be operating in the CBD and inner city?

Answer-

I am advised:

(1) to (3) The Network Operator is required to meet the Schedule 1 Community Access Principles in the Waste Avoidance and Resource Recovery (Container Deposit Scheme) Regulation 2017.

(4) This is a matter for the Network Operator, TOMRA Cleanaway.

(5) The Scheme's primary objective is to reduce litter and to help achieve the Premier's priority to reduce the volume of litter by 40 per cent by 2020. Prior to the scheme, drink containers made up 49 per cent of the volume of litter across the state. The recent 2017-18 National Litter Index shows a 37 per cent reduction in overall litter volume from the baseline. The result also shows a 33 per cent reduction in the volume of littered drink containers eligible for a refund since the Return and Earn Scheme started in December 2017.

(6) The Government is not involved in the financial management of return point operators.

(7) The Government has and continues to closely monitor the scheme. The Government has worked closely with the Scheme Coordinator and Network Operator to continuously improve the scheme, including ensuring the effective deployment of the collection point network and the smooth running of the scheme.

(8) The Government will continue to monitor the scheme and look for opportunities for optimisation.

*9587 SHORE POWER—Mr Alex Greenwich asked the Minister for Roads, Maritime and Freight—

- *9588 PRESCHOOL PARTICIPATION IN NEW SOUTH WALES—Mr Alex Greenwich asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—
 - (1) Is it true that New South Wales has the lowest preschool participation rates in the country?
 - (2) What proportion of three and four year old children in New South Wales attend preschool?
 - (3) What assessment has the Government made of the evidence and recommendations of the December 2017 'Report of the Review to Achieve Educational Excellence in Australian Schools through Early Childhood Interventions', showing that children who participate in high quality early childhood education do better at school, in employment, health, income and financial security measures and reduced involvement in crime?
 - (4) Is the Government committed to ongoing, adequate funding of Universal Access to early childhood education in the year before school?
 - (a) What steps have been taken to achieve this?
 - (5) Is the Government committed to expanding access to quality early childhood education for all three year olds?
 - (a) What steps have been taken to achieve this?
 - (6) Is the Government committed to targeted extra support for vulnerable children and families to promote access, equity and inclusion?
 - (a) What steps have been taken to achieve this?
 - (7) Is the Government committed to improving service quality and providing a stable skilled workforce?(a) What steps have been taken to achieve this?
 - (8) Is the Government committed to transparent reporting and public information about access to early childhood education?
 - (a) What steps have been taken to achieve this?
 - (9) What further action will the Government take to improve access and outcomes in early childhood education?

Answer-

(1) and (2) This information is publicly available.

(3) The 2018-19 State Budget allocated a record \$474.3 million to further initiatives consistent with the report's recommendations, and New South Wales is making two years of universal access available in community preschools from 2019.

(4) The Government's 2017-18 budget allocated an additional \$217 million (over four years) for Start Strong reforms which aim to ensure all children in New South Wales can participate in 600 hours of quality early childhood education in the Year Before Full-time Schooling. The 2018-19 budget allocated \$197.8 million over four years to extend the Government's investment in preschool education under Start Strong.

The Government is working closely with the Commonwealth Government to support more sustainable and transparent funding arrangements for Universal Access to Early Childhood Education.

(5) From 1 January 2019 the extension of Start Strong will provide funding to support all three year old children in community preschools in accessing 600 hours of preschool.

(6) The Government provides funding and loadings for various equity groups as part of Start Strong. There are a number of targeted programs that enhance access, equity and inclusion for vulnerable children and families.

Start Strong loadings apply to:

- Children from low-income and Aboriginal families
- Children with disability and additional needs in community preschools
- Children with English language needs
- · Pre-school services in regional, remote and very remote areas.

(7) The Government is committed to building the capacity of the early childhood education workforce through professional development and training. The Quality Learning Environment program supports preschools to improve their service quality.

(8) The Government through the Department of Education collects and provides information on access which is used in combination with Australian Bureau of Statistics data and published in the Report on Government Services (ROGS).

(9) The Government funds initiatives and programs that support quality in early childhood education. The extension of Start Strong from January 2019 will ensure all three year olds have the opportunity to access two years of a quality preschool program.

- *9589 RESPONSE TIME TO ASSAULT RELATED EMERGENCY REPORTS IN THE DAPTO AND WEST DAPTO AREAS—Ms Anna Watson asked the Minister for Police, and Minister for Emergency Services—

A range of factors, including the number of calls being responded to at any time, the time of day, traffic density, weather conditions and the distance to travel influences response times.

The NSW Police Force publishes urgent response calls and the number of calls attended to within target time in its annual report.

- *9590 MANAGEMENT OF THE LAKE ILLAWARRA FORESHORE—Ms Anna Watson asked the Minister for Finance, Services and Property—
 - (1) Is the Minister aware of any obstacles or issues that have been encountered regarding the management of the Lake Illawarra foreshore, since the Lake Illawarra Authority (LIA) was disbanded in 2014, and in particular regarding lands that fall within the responsibility of Property NSW?
 - (2) Is the Minister aware of any complaints that have been made regarding the new disjointed management of the Lake Illawarra foreshore?
 - (3) How did the Government respond to calls from Wollongong City Councillors last year for the Government to transfer Lake Illawarra lands to Wollongong City Council?

Answer-

- (1) No.
- (2) No.
- (3) I am not aware of any formal request from Wollongong City Council to transfer NSW Government owned land adjacent to Lake Illawarra to the Council. I can confirm Property NSW has not received a written request from Wollongong City Council to acquire land it owns on the Lake Illawarra foreshore located at the corner of Northcliff Drive and King Street.

*9591 LANDS MANAGEMENT OF THE LAKE ILLAWARRA FORESHORE—Ms Anna Watson asked the Minister for Lands and Forestry, and Minister for Racing—

- (1) What obstacles or issues have been encountered regarding the management of the Lake Illawarra foreshore, since the Lake Illawarra Authority (LIA) was disbanded in 2014, and in particular regarding lands that fall within the responsibility of the Department of Primary Industries Lands?
- (2) Is the Minister aware of any complaints that have been made regarding the new disjointed management of the Lake Illawarra foreshore?
- (3) How did the Government respond to calls from Wollongong City Councillors last year for the Government to transfer Lake Illawarra lands to Wollongong City Council?

Answer—

(1) None of significance. Four agencies have a key role in the management of the Lake Illawarra foreshore, being Shellharbour City Council, Wollongong City Council, Government Property NSW and the Department of Industry Lands & Water (Crown Lands).

Management of some Crown lands where reserved for public recreation devolves to Shellharbour City and Wollongong City council's by virtue of s48 of the Local Government Act 1993. Crown Lands also participates in the Lake Illawarra Estuary Management Committee.

(2) None of significance.

Crown Lands is not aware of any recent request from Wollongong Council for the transfer of Lake Illawarra Crown lands within the Wollongong Local Government Area. Any approach from Wollongong City Council regarding the transfer of lands or management responsibilities is welcome and would be dependent on the outcome of discussions and funding requests.

- *9592 URBAN GREEN OPEN SPACE—Mr Alex Greenwich asked the Minister for Planning, Minister for Housing, and Special Minister for State—
 - (1) What land has the Government identified to purchase as a part of plans to expand urban public open space and children's playgrounds in the 2018-19 financial year?
 - (2) What land has the Government purchased to create new public open spaces and children's playgrounds in the 2018-19 financial year?
 - (3) How many trees has the Government planted, excluding any that were required as part of consent conditions for a project such as the CBD and South East Light Rail Project, in the 2018-19 financial year?
 - (4) To what extent has the Government undertaken an audit of existing urban open and green public spaces and green canopy in the 2018-19 financial year?
 - (5) What measures is the Government considering to protect existing urban open and green public spaces and tree canopy, including legislation in the 2018-19 financial year?
 - (6) What targets will the Government set to expand urban open and green public spaces and tree canopy in the 2018-19 financial year?

Answer-

- (1) As of 30 October 2018, the Department of Planning and Environment has identified 1,127.6 hectares of urban public space to be acquired.
- (2) As of 30 October 2018, the Department has purchased 10.8 hectares of public open space in the following suburbs: Fairfield and Blacktown.
- (3) Between 1 July and 30 October 2018, 69,123 new trees were registered on the Five Million Trees website (5milliontrees.nsw.gov.au).
- (4) The Department undertook an audit of existing urban tree canopy cover in the Greater Sydney Metropolitan area as part of its Five Million Trees for Greater Sydney Program.

(1) State Insurance Regulatory Authority (SIRA) has received three reports from workers about the behaviour of private investigators. SIRA contacted insurers in relation to all three matters.

(a) SIRA has not referred these complaints to the NSW Police. SIRA's practice is to refer the person making the complaint about private investigator behaviour to the insurer in the first instance. The person is also advised that private investigators (private inquiry agents) are licensed under the Commercial Agents and Private Inquiry Agents Act 2004 (CAPI). The licensing is managed through the Security, Licensing and Enforcement Directorate (SLED) of the NSW Police Force. The person contacting SIRA is supported by being provided with information how to contact SLED (telephone number and email address) if they are concerned about harassment by a private investigator.

(b) SIRA will contact an insurer when concerns about surveillance of a worker's family, children and colleagues have been raised to ensure that the insurer is aware and to obtain the insurer's actions to address the stated concerns. SIRA may investigate these matters if it appears that legislation or guidelines or licence conditions have been breached by an insurer. The responsibility for investigation of a breach of the CAPI is with the Police Commissioner of NSW.

Answer-

(2) Workers Compensation Independent Review Office (WIRO) has received five complaints from injured workers in the period from 1 January 2018 to 18 October 2018 in which the injured worker complained about alleged surveillance. In each case the Insurer denied any surveillance had been undertaken. WIRO was satisfied that there was no surveillance and no further action was required.

(3) SIRA's expectation is that private investigators would not contact the person under observation.

The CAPI provides the criteria that is used to determine whether an offence of harassment has occurred.

(4) As part of the SIRA Claims Administration Manual, SIRA will include a Standard of practice on surveillance. This Standard will seek to ensure that these services are only used when necessary, are conducted in an ethical manner and any information obtained is appropriately used and stored.

The Standards of practice are mandatory requirements for insurers. They set expectations for insurer claims handling and administration to standardise operational activity across all insurers and ensure system-wide fairness.

The Standards form directions to insurers with respect to claims procedures issued under Division 4 of Part 7 of the Workers Compensation Act 1987 (the 1987 Act). Contravention of a requirement required by the Standards may constitute an offence under section 209 of the 1987 Act. Section 194(2) makes compliance with a direction to insurers a condition of an insurer's licence issued under the Act.

SIRA is currently seeking feedback on the draft Claims Administration Manual Standards of practice. Public consultation commenced on 16 October 2018 and concludes on 16 November 2018.

- \$10,000 investor assistance
- \$15,000 for owners of rural properties that are larger than 2 hectares
- Stamp duty concession on a subsequent property purchased in New South Wales.

In October 2017, I referred to the Staysafe Committee an inquiry into heavy vehicle safety and the use of technology to improve road safety. On 24 May 2018, the Staysafe committee released its report following its inquiry and made a number of findings and recommendations, including the use of telematics, vehicle safety technology and exploring accreditation schemes.

The findings of the Staysafe Committee complement the work of the national Transport and Infrastructure Council which, in May 2018, approved a New South Wales-led program to improve heavy vehicle safety across Australia. The program aims to increase the uptake of safety technology, explore options for a heavy vehicle indepth crash study, and improve the education of other road users about how to share the road with heavy vehicles.

The Government launched the Be Truck Aware campaign in 2017 to create awareness among vulnerable road users of increased truck movements and promotes the safety of all road users including drivers, pedestrians, bicycle riders and motorcycle riders.

Transport for NSW's Centre for Road Safety regularly reviews new safety technologies to improve heavy vehicle safety and better protect vulnerable road users. The results are published on the Centre for Road Safety website. Roads and Maritime Services has in place the Safety, Productivity & Environment Construction Transport Scheme (SPECTS). Vehicles enrolled in SPECTS are fitted with a range of safety features including systems to improve visibility and detection of vulnerable road users.

The Government has invested record amounts in walking and cycling infrastructure, committing more than \$250 million worth of cycling and walking upgrades over the five years from 2013 to 2018, through walking and cycling programs. In addition, in the 2018-19 Budget, the Government announced a boost of \$600 million in additional funding for dedicated road safety improvements and enhanced police enforcement. This brings the total investment to reducing deaths and serious injuries on New South Wales roads over the next five years to \$1.9 billion. Priority areas include:

- \$640 million to save lives on country roads through infrastructure safety upgrades
- \$250 million for enhanced enforcement, including 50 additional highway patrol officers in regional areas, roadside alcohol testing and a doubling of mobile drug testing.
- \$180 million to increase liveability and safety in urban communities through infrastructure safety upgrades for pedestrians, cyclists and other road users.

This was attributed to "a large volume of cars entering and exiting at multiple intersections and frequent stopping and starting". What steps is the Minister taking to address these risks?

Answer-

The Government is easing congestion and reducing travel times on Sydney's busiest corridors, including:

- Funding proposed intersection upgrades on the Hume Highway at Hoxton Park Liverpool, as part of the \$300 million Urban Roads Pinch Point Program;
- Improving the intersection at Bigge Street and the Hume Highway, as part of the \$225 million Pinch Point Program; and
- Delivering intersection improvements for Stacey Street and Fairford Road, Bankstown, as part of the \$300 million Gateway to the South Pinch Point Program.

The Government's investment in WestConnex – around 30 kilometre in length, comprising of the New M4, New M5 and M4 to M5 Link – will deliver more than \$20 billion in economic benefits to New South Wales. Motorists are already benefiting from the widened New M4 with four lanes between Parramatta and Homebush easing congestion and saving motorists time. 10,000 trucks a day will be taken off Parramatta Road and overall traffic on sections of that road will be more than halved once the M4 East opens in 2019. By 2021, overall traffic volume on Parramatta Road will be reduced by 53 per cent.

The M4 Smart Motorway Project delivers a technology based solution to smooth the flow of traffic on the M4 Motorway and make the most of existing road space. Once this Project is completed in 2020, we expect travel time savings of up to 25 per cent for customers travelling from Lapstone to Parramatta. The Project will deliver ramp metering on most entry ramps onto the M4 to smooth traffic flows merging onto the M4, a key cause of congestion. The Project will also introduce Variable Speed Limit Signs and Lane Use Signs between Roper Road and Pitt St to manage traffic around incidents in this crash black spot.

Further, the Government is delivering NorthConnex, a \$3 billion, nine kilometre twin tunnel motorway linking the M1 Motorway at Wahroonga, to the M2 Hills Motorway at West Pennant Hills. NorthConnex will take 5,000 trucks a day off Pennant Hills Road – returning local streets to local communities. NorthConnex will improve motorists' safety, travel times and congestion along Pennant Hills Road.

In addition, the Government launched the Road Safety Plan 2021 in February 2018, which features targeted and proven measures to address the types of risk and crashes occurring on New South Wales roads.

To support the delivery of the Plan, the Government announced in the 2018-19 Budget a boost of \$600 million for road safety. This brings the total investment in road safety initiatives to \$1.9 billion over five years. Priority areas include:

- \$640 million to save lives on country roads through infrastructure safety upgrades.
- \$250 million for enhanced enforcement, including 50 additional highway patrol officers in regional areas, roadside alcohol testing and a doubling of mobile drug testing.
- \$180 million to increase liveability and safety in urban communities through infrastructure safety upgrades for pedestrians, cyclists and other road users.

licence can only be applied for if the Minister for Resources releases and invites applications for an area.

If an area were released in future, the applicants would have to meet the requirements of the Offshore Minerals Act 1999 and obtain all other relevant approvals, including development consent under the Environmental Planning and Assessment Act 1979. All development applications are considered and assessed on their merits.

There are no applications to extract sand from New South Wales waters.
