- *7423 MAMBO WETLAND—Ms Kate Washington asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Has the Minister met with the purchaser of the Mambo Wetlands which was sold by the Government in 2016?
 - (2) Has the Minister met with Port Stephens Council regarding the buyback of the Mambo Wetlands?
 - (3) Will the Government be supporting the buyback of the Mambo wetlands, either through voluntary sale or compulsory acquisition?

Answer—

I am advised that the Department of Planning and Environment have met with the landowner and Port Stephens Council about Lots 560-566 Port Stephens Drive, Salamander Bay.

*7424 NSW LITERACY AND NUMERACY STRATEGY—Mr Ryan Park asked the Minister for Education—

- (1) How many at-risk Kindergarten to Year 2 students were supported in the Illawarra under the Government's \$340 million NSW Literacy and Numeracy Strategy in 2017?
- (2) How many people will be employed under the NSW Literacy and Numeracy Strategy in the Illawarra during this Strategy?
- (3) Which education groups, experts or committees were consulted in the Illawarra before developing the NSW Literacy and Numeracy Strategy?

Answer-

(1) I'm advised in 2017, there were 18 government and two non-government schools selected for involvement in the Literacy and Numeracy Action Plan in the Illawarra. A total of 1,892 Kindergarten to Year 2 students were supported through this strategy.

(2) I'm advised resources equivalent to 16.8 full time equivalent (FTE) teachers have been allocated to government and non-government Action Plan schools in the Illawarra under the strategy.

(3) I'm advised experts from the Illawarra have been consulted on the development of one of the strategy's major deliverables – the National Literacy and Numeracy Learning Progressions. Experts consulted:

- Dr Pauline Jones and Dr Beverley Derewianka of Wollongong University
- Literacy and numeracy consultants from the Catholic Diocese of Wollongong

Schools from across New South Wales were invited to participate in a trial of the learning progressions. The following schools from the Illawarra participated:

- Cringila Public School
- Koonawarra Public School
- St John's Catholic Primary at Dapto
- · St Michael's Catholic Primary from Nowra
- · St Therese's Catholic Primary from West Wollongong.
- *7425 BEFORE AND AFTER SCHOOL CARE FUND—Ms Kate Washington asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—
 - (1) How many additional places have been created through the Before and After School Care Fund, as of 30 January 2018?
 - (2) What is the total amount spent as part of the Before and After School Care Fund, as of 30 January 2018 ?

Answer—

- *7426 LOWER HUNTER FREIGHT CORRIDOR—Ms Kate Washington asked the Minister for Roads, Maritime and Freight—
 - (1) Has the feasibility study into the construction of the Lower Hunter Freight Bypass between Hexham and Fassifern been completed?
 - (a) If not, when is it due for completion?

Answer—

I am advised:

*7427 COASTAL MANAGEMENT ACT 2016—Ms Kate Washington asked the Minister for Planning, Minister for Housing, and Special Minister for State—

When does the Minister intend to proclaim the Coastal Management Act 2016 which was passed by the Parliament on 31 May 2016 and assented to by the Governor on 7 June 2016?

Answer-

The Coastal Management Act 2016 will be proclaimed by the Minister for the Environment.

- *7428 BEFORE AND AFTER SCHOOL CARE FUND—Ms Kate Washington asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—
 - (1) Who was consulted regarding the policy change, published on 27 October 2017, which removed the requirement for applicants for tenders to operate before and after school care services to fulfil the requirements of a pre-qualification scheme?
 - (2) Did the Minister, or staff from the Minister's office or Department, discuss this change with Camp Australia prior to its announcement?

Answer-

- (1) The Department of Education changed its approach to ensuring the quality of Out of School Hours Care providers from a pre-qualification scheme to a more robust tender process following consultation with OSHC providers, its legal representatives and members of the Early Childhood Education Directorate.
- (2) Camp Australia was consulted and provided a submission to the department as part of the consultation process.
- *7429 SCHOOL BUSES—Ms Kate Washington asked the Minister for Transport and Infrastructure—
 - (1) According to school Opal card data, how many high school students caught a bus from the suburb of Medowie to a school outside of Medowie, in the week beginning 5 February 2018?
 - (2) According to school Opal card data, how many high school students caught a bus from the suburb of Tanilba Bay to a school outside of Tanilba Bay, in the week beginning 5 February 2018?
 - (3) According to school Opal card data, how many high school students caught a bus from the suburb of Lemon Tree Passage to a school outside of Lemon Tree Passage, in the week beginning 5 February 2018?

Answer-

I am advised:

Due to the School Student Transport Scheme moratorium, Opal data is inaccurate for this period.

*7430 NELSON BAY ROAD—Ms Kate Washington asked the Minister for Roads, Maritime and Freight—

When will construction commence on the promised \$67 million full duplication of Nelson Bay Road? Answer—

I am advised:

Construction will commence after all relevant statutory approvals have been achieved.

- *7431 NEW SOUTH WALES COASTAL COUNCIL—Ms Kate Washington asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Has the New South Wales Coastal Council held a meeting since its appointment?(a) If so, are the minutes of any meetings publicly available?
 - (2) On what date did members of the New South Wales Coastal Council commence being paid for their role?

Answer—

The Coastal Panel remains in effect until such time as the Coastal Management Act 2016 commences.

- *7432 CONTAINER DEPOSIT SCHEME—Ms Kate Washington asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Are there any plans for a container deposit reverse vending machine or storefront collection site in the Tea Gardens Hawks Nest area?
 - (a) If so, what are the plans?

Answer-

I am advised:

The network operator, TOMRA Cleanaway, is responsible for determining the location of collection points and deployment of the scheme.

- *7433 NEWCASTLE RECREATION RESERVE HERITAGE RECOMMENDATION—Mr Tim Crakanthorp asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Is the Minister aware of the Heritage Council of NSW recommendation to list Newcastle Recreation Reserve, 1, 1A, 3, 5A Ordnance Street, Newcastle on the State Heritage Register?
 - (2) When will the Newcastle Recreation Reserve be placed on the State Heritage register in line with the recommendation?

Answer-

I am advised:

- (1) The Heritage Council recommended I list the Reserve on the State Heritage Register, however, I am advised there was a discrepancy in the supporting documentation provided by the Heritage Council. The Heritage Council will consider this matter at its next meeting.
- (2) Once I receive a recommendation from the NSW Heritage Council I will consider it as required under section 34(1) of the Heritage Act 1977.
- *7434 NEWCASTLE BUS SERVICE—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—
 - (1) How many bus services in Newcastle have since the introduction of the new timetable on 14 January 2018 (to 8 February 2018):
 - (a) Not run on time
 - (b) Been cancelled?
 - (2) How many school bus services in Newcastle have since the introduction of the new timetable on 14 January 2018 (to 8 February 2018):
 - (a) Not run on time;
 - (b) Been cancelled?

Answer-

I am advised:

Bus on time running data is reported by calendar month and published on the Transport for NSW website.

Since the new timetable for Newcastle Transport commenced on 14 January 2018 and up to 8 February 2018, three services, including two school services, or 0.01 per cent of all services were cancelled.

- *7435 STOCKTON FERRY—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—
 - (1) Is the Minister aware of Keolis Downer's obligation to refurbish the Stockton Ferry?
 - (2) When will the Stockton Ferry seating be upgraded to ensure compliance with the Disability Discrimination Act?
 - (3) Will the upgrades be completed by 1 July 2018 as stipulated in the service contract between Keolis Downer and Transport for NSW?

Answer—

I am advised:

(1) Yes.

(2) and (3) Scoping work has commenced for the vessel refurbishment, upgraded seating and Disability Discrimination Act compliance.

*7436 FORMER STOCKTON SERVICE STATION SITE—Mr Tim Crakanthorp asked the Minister for Lands and Forestry, and Minister for Racing—

What is the current status of the former Stockton Service Station Site?

Answer—

The Department of Industry – Crown Lands has engaged a contractor to undertake the final remediation of the former Stockton Service Station site, including removal of the concrete slabs and underground fuel tanks.

The site will be remediated to a standard compatible with public open space.

It is expected that these remediation works will commence in late March 2018 and be completed by the end of June 2018 (subject to weather and contractor availability).

The site will remain fenced off to the public during this time.

- *7437 LANDCOM, URBANGROWTH NSW AND URBANGROWTH NSW DEVELOPMENT CORPORATION—Mr Michael Daley asked the Premier—
 - (1) How many staff were transferred from Landcom, trading as UrbanGrowth NSW, to the UrbanGrowth NSW Development Corporation in 2017?
 - (2) How many staff have resigned from the UrbanGrowth NSW Development Corporation as at 8 February 2018?

(a) What reasons have been given for the resignation of staff?

Answer-

Staffing levels within New South Wales Government agencies are reported regularly in agency annual reports.

*7439 HARD COPY TIMETABLES—Ms Anna Watson asked the Minister for Transport and Infrastructure—

(1) Does the Government still provide hard copy paper versions of the New South Wales train timetable for commuters upon request?(a) If not, why not?

Answer—

I am advised:

Yes.

- *7440 UPGRADE AT SHELLHARBOUR PUBLIC HOSPITAL—Ms Anna Watson asked the Minister for Health, and Minister for Medical Research—
 - (1) Does the Government remain committed to the redevelopment of Shellharbour Public Hospital?(a) If so, will the funds for the redevelopment of the hospital be provided in the next budget?
 - (2) What is the total figure the Government currently believes to be necessary to properly fund and complete the upgrade at Shellharbour Public Hospital?

Answer-

The Government remains committed to the redevelopment of the Shellharbour Hospital with \$250.6 million approved for the upgrade as part of the 2017-18 State Budget.

- *7441 ACQUISITION OF PROPERTIES FOR THE ALBION PARK RAIL BYPASS—Ms Anna Watson asked the Minister for Roads, Maritime and Freight—
 - (1) Has all property required for the Albion Park Rail Bypass' construction now been acquired by the Government?
 - (a) If not:
 - (i) What properties are yet to be acquired?
 - (ii) How much has the Government currently budgeted for these properties?
 - (iii) When will all property acquisitions for the Albion Park Rail Bypass project be complete?

Answer-

I am advised:

The acquisition and negotiation of property purchases for the Albion Park Rail bypass project are ongoing. Property acquisition is planned to be complete by the end of 2018.

*7442 DEMOUNTABLE CLASSROOMS IN THE SHELLHARBOUR ELECTORATE—Ms Anna Watson asked the Minister for Education—

- (1) What is the total number of demountable classrooms which will be used in each of the following schools in Term 1, 2018:

- (2) How long has each demountable in each classroom been in place?
- (3) In which year does the Government expect these demountable classrooms will either be replaced by permanent classroom structures or no longer needed? Please answer per school per demountable.

*Dapto Public School is subject to a major capital works project that will provide new permanent teaching spaces and the removal of demountables.

(2) Demountable movements to and from school sites continue throughout the year in response to changing enrolment patterns and temporary accommodation needs of the school.

(3) The department constantly monitors the use of demountables. Where a long term need for additional school accommodation is established and funding is available, this is provided by expanding existing schools and/or building new schools as necessary.

*7443 DEMOUNTABLE CLASSROOMS—Mr Jihad Dib asked the Minister for Education—

- (1) How many demountable classrooms (not on school sites) did the Department of Education have in stock as at 7 February 2018?
- (2) What is the purchase cost of a standard non-specialist demountable classroom?
- (3) Which schools had security guards respond to security intrusions, and how many times, during the 2017-18 holiday period?

Answer—

I'm advised that:

- (1) The Department of Education has 268 demountable teaching spaces in stock as at 7 February 2018.
- (2) The average cost of a standard, non-specialist demountable classroom is \$131,000.
- (3) During the December 2017/January 2018 school holiday period, 840 schools received security guard responses to alarm activations. These can be triggered by individuals who were on school sites including staff, community users, cleaners and various contractors.
- *7444 RETURN AND EARN SCHEME CONTAINER DEPOSIT SCHEME—Mr Jihad Dib asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) How many premises did the Return and Earn implementation body approach to gauge interest in participating in the scheme in the Lakemba electorate?
 - (2) How many Return and Earn facilities were in the Lakemba electorate as at 7 February 2018?
 - (3) How many Return and Earn kiosk operators in the Lakemba electorate asked to opt out of the scheme after initially agreeing to participate?
 - (4) Where will additional Return and Earn kiosks be placed in the Lakemba electorate before June 2018?

Answer—

I am advised:

The network operator, TOMRA Cleanaway, is responsible for determining the location collection points and deployment of the scheme.

- *7447 ADDITIONAL PALLIATIVE CARE NURSES IN THE WESTERN NSW LOCAL HEALTH DISTRICT—Mr Philip Donato asked the Minister for Health, and Minister for Medical Research—
 - (1) In relation to the response to LA Q6998, when will the Western NSW Local Health District be able to employ additional nurses dedicated to palliative care announced in the \$100 million funding?
 - (2) How many specialist palliative nurses will be employed by Western NSW Local Health District within the announced funding?

Answer—

The first round of palliative care nurse recruitment was undertaken in late 2017 with the successful appointment of a clinical nurse consultant. Another position was re-advertised and the appointment is pending.

- *7448 DROUGHT ASSISTANCE FOR PRIMARY PRODUCERS—Mr Philip Donato asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) Does the Government still provide drought assistance funding to primary producers?(a) If so, what is the threshold for drought declaration?
 - (2) What are the criteria for financial assistance to drought affected primary producers?

Answer-

(1) The Government has a \$300 million drought package with the focus being to assist farmers prepare

for drought.

- (a) These support measures are always available to those who meet the relevant criteria.
- (2) There are multiple support measures with each having its own criteria. Information on the various support measures is available on DroughtHub https://www.dpi.nsw.gov.au/climate-and-emergencies/droughthub.
- *7449 BELLS LINE CORRIDOR-Mr Philip Donato asked the Minister for Roads, Maritime and Freight-

What is the daily cost to New South Wales while the Bells Line corridor is not fully secured?

Answer-

I am advised:

Since 2014, the Government has invested \$37.7 million on the Bells Line of Road, including \$8.4 million in last year's budget for upgrades and safety improvements.

Community feedback from the Future Transport 2056 consultation process on potential improvements to the connections from the Central West through to Sydney and Newcastle is also under consideration.

- *7450 SCHEDULED TRACKWORK POSSESSIONS—Mr Ryan Park asked the Minister for Transport and Infrastructure—
 - (1) Is there a maximum amount of scheduled trackwork possessions that is in place for each line per year?
 - (a) What is this amount?
 - (2) How many times have these planned trackwork possessions caused partial or full closure of the South Coast Line in each year from 2014 to 2018 (as at 7 February 2018)?

Answer—

I am advised:

- (1) Track possessions are granted based on access required for maintenance or capital works and are generally limited to four per year for each line. However, in the case of a significant project additional access may be provided.
- (2) 19 times.
- *7451 BARDIA PUBLIC SCHOOL FACILITIES—Mr Anoulack Chanthivong asked the Minister for Education—

Considering the release from School Infrastructure NSW stating that Bardia Public school will be a 21st century school, with first class facilities and equipped with the latest technology, why has air conditioning not been included in the recent significant upgrade of Bardia Public School?

Answer-

I'm advised public schools that are eligible for air cooling under the Department of Education's Air Cooling Policy are identified by the department and prioritised in a program of necessary works.

The department cools all habitable spaces in New South Wales public schools located in areas that have a mean maximum January temperature of 33 degrees Celsius or higher. In addition to this, air cooling is provided in schools with students that have special needs, in all demountable teaching spaces, and in those areas where temperature combined with humidity is likely to cause heat stress.

I'm advised that Bardia Public School has a mean maximum January temperature of 29 degrees Celsius.

Any public school below the policy threshold may make a local decision to install air-conditioning at their cost.

The department has a set of design standards that recommend sustainable and cost effective approaches to improving thermal comfort in schools via passive measures such as insulation, sunscreens, improved ventilation and appropriately designed landscaping. These measures have been included in the design for the upgrade of this school.

- *7452 CLOSED BUS STOPS IN NEWCASTLE—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—
 - (1) How many bus stops were closed as part of the new network that started on 14 January 2018?(a) What are the locations of these bus stops?

Answer-

I am advised:

Information about bus stop locations is available on the Newcastle Transport website.

*7453 KEOLIS DOWNER ACCREDITATION—Mr Tim Crakanthorp asked the Minister for Transport and Infrastructure—

Is Keolis Downer as the operator of Newcastle Transport fatigue accredited?

Answer-

I am advised:

Keolis Downer, as the operator of Newcastle Transport, is accredited under the Government's Bus Operator Accreditation Scheme. The Accreditation Scheme requires operators to implement fatigue management programs in line with the Heavy Vehicle (Fatigue Management) National Regulation (NSW) 2013.

- *7454 REBUILDING OF EXISTING STADIA IN SYDNEY BUSINESS CASE—Mr Tim Crakanthorp asked the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
 - (1) Can the most recent business case for the rebuilding of existing stadia in Sydney be provided?(a) If not, why not?

Answer-

We will release a summary of the final business case when it is completed.

*7457 CONSULTATION WITH RESIDENTS-Ms Tania Mihailuk asked the Minister for Transport and Infrastructure-

What consultation took place with residents before the rerouting of the 941 and 946 bus services?

Answer-

I am advised:

An opportunity to comment on the rerouting of the 941 and 946 bus services was provided in October 2017 by the local bus operator, Punchbowl Bus Company. This involved a letter that was distributed between 6-9 October 2017 to residences in the vicinity of where the rerouting would occur on Greenacre Road and Sir Joseph Banks Street, Bankstown.

The community feedback received by the bus operator was provided to the City of Canterbury-Bankstown Council for its consideration as the local roads authority. Advice was provided by the Council in November 2017 that the Council supported the rerouting of the 941 and 946 bus services along Green acre Road and Sir Joseph Banks Street, Bankstown.

*7458 REROUTE OF THE 941 AND 946 BUS ROUTES—Ms Tania Mihailuk asked the Minister for Transport and Infrastructure—

Considering the recent decision to reroute the 941 and 946 bus routes along Sir Joseph Banks Street and Greenacre Road, what measures have been put in place to ensure the impact on the residents of these streets is kept to a minimum?

Answer-

I am advised:

A route assessment was conducted by the local bus operator, Punchbowl Bus Company, to ensure that buses could travel safely and reliably on Sir Joseph Banks Street and Greenacre Road.

Local impacts were taken into account by the local Council, the City of Canterbury-Bankstown, which is the relevant roads authority that supported the change.

- *7459 FAMILY AND COMMUNITY SERVICES DATABASE GLITCHES—Ms Tania Mihailuk asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) Considering the recent technical glitches in the overhaul of the Family and Community Services database titled 'ChildStory', were any banned foster carers accidentally displayed as being authorised to care for children?
 - (a) If so, how many?

Answer-

ChildStory was launched late last year. I am advised ChildStory replaces more than 15 disconnected and manual IT solutions and reporting systems. I am advised in the early weeks, there were some technical glitches with the system and with data migration. I am advised that each of these problems are being addressed or have already been fixed.

*7460 ROADS MAINTENANCE FUNDING—Ms Tania Mihailuk asked the Minister for Roads, Maritime and Freight—

What extra funding will be allocated for maintenance and upkeep of Sir Joseph Banks Street and Greenacre Road, following the recent decision to reroute bus routes 941 and 946 along these streets?

Answer—

I am advised:

Local impacts were taken into account by the local Council, the City of Canterbury-Bankstown, which is the relevant roads authority that supported the change.

- *7462 ADVOCACY SERVICES FOR PEOPLE WITH A DISABILITY—Mr Edmond Atalla asked the Minister for Multiculturalism, and Minister for Disability Services—
 - (1) What provisions will the Government put in place to ensure the continuation of advocacy services for people with a disability when state funding for these services ceases from July 2018?
 - (2) Will the Government commit to funding disability advocacy services after the National Disability Insurance Scheme has been fully rolled out?

Answer—

New South Wales has committed every dollar of the specialist disability support budget to meet the individual needs of people with disability. Funding for next year's disability budget will be \$3.2 billion and will go directly to the National Disability Insurance Scheme (NDIS). This will be matched by \$3.3 billion from the Commonwealth, for a total of \$6.5 billion in funding for people with disability in New South Wales.

To prepare the advocacy and information sector for the arrival of the NDIS, the NSW Council of Social Services has been provided with a \$1.5 million one-off grant for the Skilled to Thrive project. Around 95 per cent of disability advocacy and information service providers are actively engaged with Skilled to Thrive. This project has assisted advocacy and information providers to develop skills in applying for funding grants such as the Information Linkages and Capacity (ILC) or Disability Sector Scale Up.

Over 50 per cent of Family and Community Services funded specialist disability advocacy and information service providers are registered with the NDIS.

When the NDIS is fully operational around Australia, \$130 million each year will be provided for ILC supports. The latest New South Wales round of ILC grants closed on 30 November 2017 with up to \$46 million available to New South Wales for projects commencing from 1 July 2018. This represents an investment of around four times the existing New South Wales specialist disability advocacy funding under the current system.

Independent, systemic and legal advocacy is available to all people with disability outside of the NDIS through the Commonwealth funded National Disability Advocacy Program (NDAP). The Commonwealth Government recently announced \$60 million in funding to extend NDAP and other advocacy programs to 30 June 2020.

After the full NDIS rollout, the Government will retain a strong focus on promoting community inclusion. The 2014 New South Wales Disability Inclusion Act ensures that the NSW Disability Council and its supporting groups will continue to represent people with disability and provide advice to the Government on emerging issues impacting on community access and inclusion.

*7463 ASSISTANCE TO DISADVANTAGED STUDENTS—Mr Edmond Atalla asked the Minister for Education—

What assistance is the Government providing to school aged children and young people growing up in poverty in order to prevent them from being disadvantaged at school?

Answer-

I'm advised:

The Government made a commitment to allocate school funding based on student need and our 2018 Resource Allocation Model (RAM) announcement is proof that we continue to deliver on that.

In 2018, the Government is continuing to transform the funding of New South Wales public schools through its RAM, which began in 2014. The RAM methodology enables New South Wales public schools to have certainty of funding to address the needs of our most vulnerable students immediately.

In 2018, about \$80 million in additional needs based funding is being provided to New South Wales public schools through the RAM methodology. This funding is incorporated into the seven loadings the RAM distributes: the equity loadings - socio-economic, Aboriginal, English language proficiency and low level adjustment for disability and the base loadings - location, professional learning and per capita.

In addition to the funding delivered through the seven loadings, \$50 million is being distributed to support New South Wales public schools to enable principals to focus on core duties such as curriculum planning, student progress, teaching quality and student wellbeing.

The equity funding delivered to schools through the RAM translates into learning support for:

- 391,000 students in 2,183 schools through the socio-economic background loading
- 173,000 students in 1,476 schools through the English language proficiency loading
- 60,000 Aboriginal students in 2,022 schools
- all students in regular public schools with additional learning and support needs who will receive flexible funding support through the low-level adjustment for disability loading. An estimated 110,000 students would be in this group.

The Government also recognised that principals, in partnership with their local school community, are best placed to decide how to use their resources effectively to meet their students' needs and improve their learning outcomes.

This means our schools are able to provide quality teaching in every classroom for every student.

*7464 BULLS HILL UNDERPASS-Ms Liesl Tesch asked the Minister for Roads, Maritime and Freight-

The Government funds major capital works and this information is available in Budget Papers.

Service NSW operates two contact centres located at Parramatta and Newcastle.

On 31 January 2018, there were 325 Service NSW employees at the Parramatta and Newcastle Contact Centres. Depending on customer demand, there are approximately 15 team members at the Parramatta Contact Centre and between 55 and 85 team members at Newcastle Contact Centre that are trained to handle icare enquires.

Service NSW began providing contact centre support services on behalf of icare from March 2017 for workers compensation enquiries. Between March 2017 and February 2018, Service NSW handled over 300,000 calls. Team members are trained to handle complex enquiries and calls can be escalated to a team leader if needed.

In 2017-18, the Government invested a record \$210 million in palliative care services.

In the 2017-18 State Budget, the Government announced an additional \$100 million funding over four years for palliative care services, including \$17.4 million in 2017-18. This investment includes:

- palliative care training for 300 nurses and allied health staff (\$900,000)
- 300 scholarships for rural and regional staff to enhance palliative care skills (\$300,000)
- an additional nine palliative care specialists in rural and regional areas (\$3.06 million)
- two specialist positions to provide relief to other specialists in rural and regional areas (\$795,000)
- an additional 30 palliative care nurses providing care in hospitals, homes and nursing homes (\$5 million)
- developing and implementing comprehensive and integrated palliative care services, in linewith community expectations and need.
- improving medication management for palliative care patients through community pharmacy initiatives (\$200,000)

Specialist palliative care services are delivered in a range of settings including public and private hospitals, hospices, community clinics, residential aged care facilities and in the home.

Palliative care services are provided in a networked arrangement, by specialist palliative care services which support and complement the care provided by primary care

The arrangement allows patients to have their palliative care needs met in a range of locations and settings.

As noted in response to LA Q4792, the Government is committed to ensuring that everyone in New South Wales is treated equally and fairly under the law.

The Government has already implemented measures that comply with the majority of the recommendations in the Sexual Orientation, Gender Identity & Intersex Rights report, 'A road map for inclusion'. For example, under the Anti-Discrimination Act 1997, it is currently unlawful to discriminate against, or vilify homosexual and transgender people.

While intersex people are not covered by the Anti-Discrimination Act 1997, it is open to people who identify as intersex, and who experience discrimination, to make a claim under the Commonwealth Sex Discrimination Act 1984.

There are currently no plans to amend the Births, Deaths and Marriages Registration Act 1995 to change the requirements for a person to alter the record of their sex.

*7490 CONTAINER DEPOSIT SCHEME: RETURN AND EARN COLLECTION POINTS—Mr Alex Greenwich asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—

 - (1) Considering your response to LA Q2069, what assessment did the recent statutory review into the Residential Tenancies Act 2010 make on the practice of owners corporations deactivating renters' building access cards in response to alleged by-law breaches?

Answer-

(1) The recent statutory review of the Residential Tenancies Act 2010 (the Act) examined the issue of tenants' building access cards being deactivated for by-law breaches. The review determined that this issue was more appropriately addressed under the Strata Scheme Management Act 2015 (the Strata Act).

(2) I am advised that Fair Trading has received a low level of complaints on this practice. Access card deactivation appears to be relatively infrequent and is generally resolved by Fair Trading's tenancy service.

(3) I am advised that when a sub-tenant enters into a residential tenancy agreement with a head-tenant, the head-tenant automatically becomes a landlord and must fulfil the obligations of a landlord under the Residential Tenancies Act 2010 (the Act) and associated Regulations. Should the Owners Corporation deactivate the sub-tenants access card, the sub-tenant has the following options for redress:

- Report the issue to the landlord (head-tenant), The landlord can address the issue with the Owners Corporation (OC) themselves or through the Owner or Property Manager to have the matter resolved.
- Failing that, the sub-tenant may lodge a tenancy complaint with NSW Fair Trading. Our complaint service may assist with all parties negotiating a successful outcome.
- Should a satisfactory outcome not be achieved they may have the option to lodge an application with the NSW Civil and Administrative Tribunal. However, it will be the responsibility of the sub-tenant to demonstrate supporting evidence to the Tribunal member that they are a tenant under the Act.
- Should this be unsuccessful the sub-tenant will need to seek legal advice.

In the case where the subtenancy is considered unlawful, the tenant cannot apply for mediation under the Strata Act, as the Strata Act defines an occupier of a lot as a person in lawful occupation of the lot.
