*0652 ADMISSION AND REJECTION RATE FIGURES—Mr Richard Amery asked the Minister for Health, and Minister for Medical Research—

- (1) Does the Department of Health keep admission and rejection rate figures for mental health facilities under the control of the department?
- (2) If so, what are the admission figures for:
 - (a) Bungarribee House at Blacktown;
 - (b) Pialla at Nepean?
- (3) What are the rejection rates for people refused admission because of lack of beds and other reasons for the two facilities mentioned in question (2) above?

Answer—

The following answer was provided by the Minister for Mental Health.

I am advised:

- (1) The NSW Department of Health does not keep or regularly report admission figures for mental health units. This data is, however, centrally available and can be extracted on an 'as required' basis from the NSW Health Information Exchange (HIE).
- (2) (a) and (b) The admission figures for Bungarribee House and Pialla for the 2010-11 financial year are:

Bungarribee House - 774 and Pialla Unit - 840 (NB: This data was provided by InforMH and was extracted from the NSW State Health Information Exchange on 12 September 2011. It includes all admissions to the Ward as well as transfers from other Wards).

- (3) The Western Sydney and Nepean Blue Mountains Local Health Districts advise that no patients have been refused admission due to lack of beds at either Bungarribee House or the Pialla Unit. Patients are only ever "refused admission" if their clinical need does not warrant inpatient care and they can be safely and effectively cared for in the community with community mental health follow-up.
- *0654 COMMUNITY BUILDING PARTNERSHIPS PROGRAM—Ms Linda Burney asked the Premier, and Minister for Western Sydney—

Will the Government maintain the Community Building Partnerships Program?

Answer-

As shown in Budget Paper Number Three, the Government has committed funds to conduct the Community Building Partnership program. Applications are now open and the closing date for applications is 31 October 2011.

*0665 PUBLIC SERVICE JOB CUTS IN RESEARCH FACILITIES—Ms Sonia Hornery asked the Minister for Primary Industries, and Minister for Small Business—

Will there be any cuts to public service jobs in research facilities in the Hunter, including the following:

- (a) CSIRO;
- (b) Hunter Medical Research Institute (HMRI);
- (c) John Hunter Hospital;
- (d) Calvary Mater Hospital?

Answer-

The CSIRO is administered by the Commonwealth Government, and the Hunter Medical Research Institute, John Hunter Hospital, and Calvary Mater Hospital fall under the responsibility of the Minister for Health.

*0667 FUNDING CUTS TO CORRECTIVE SERVICES AND THE VICTIMS COMPENSATION SCHEME—Ms Sonia Hornery asked the Attorney General, and Minister for Justice—

Will the Minister be cutting funding to Corrective Services and the Victims Compensation Scheme in the Hunter?

Answer-

I am advised:

An independent review of the Victims Compensation Scheme will be carried out to determine how it can improve its effectiveness and make it easier for victims to access the financial assistance they need. The Victims Compensation Scheme is a statewide scheme that is not funded on the basis of regions or electorates.

Corrective Services NSW plans to conduct a statewide assessment and review of the most appropriate allocation of custodial resources and facilities. This process will not be identifiable to any particular region, at this stage.

*0668 FUNDING CUTS TO HUNTER HOSPITALS—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

Will the Minister be cutting funding to Hunter hospitals by 30%, as reported by NSW hospital administrators?

Answer-

There has been no cut in funding to Hunter Hospitals, in fact additional funding has been provided for more beds, more nurses and more planned surgery.

*0673 POLICE INTEGRITY COMMISSION EMPLOYEES—Mr Paul Lynch asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

How many ex-Australian Federal Police or ex-Federal Agency employees work for the Police Integrity Commission?

Answer—

I am advised:

Twelve former Australian Federal Police officers and 14 former officers of other Federal Agencies (Australian Crime Commission, National Crime Authority, Australian Customs and Australian Security Intelligence Organisation) work for the Police Integrity Commission.

The Police Integrity Commission also employs a further 11 former Commonwealth public servants.

*0674 POLICE INTEGRITY COMMISSION EMPLOYEES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many ex-Australian Federal Police or ex-Federal Agency employees work for the Police Integrity Commission?

Answer-

I do not have responsibility for the Police Integrity Commission Act 1996 (NSW) or the employees of the Police Integrity Commission. They are matters for which the Premier is responsible and your question should be directed to him.

- *0675 LIVERPOOL COUNCIL CHAMBERS FIRE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) Has the coroner commenced an inquiry into the fire at Liverpool Council chambers in 2010?
 - (2) If so, when will the inquiry be completed?
 - (3) If not, when will the inquiry commence?
 - (4) Does the coroner propose to call public hearings as part of any inquiry?

Answer—

I am advised:

(1) The fire was reported to the State Coroner and an investigation has commenced.

(2) and (3) Once all the evidence has been obtained, reviewed and considered, the Deputy State Coroner, will decide whether or not an inquiry into the fire will be conducted in accordance with Section 30 of the Coroners Act 2009.

(4) If an inquiry is held, it will be conducted in public.

- *0676 SEXUAL ASSAULT MATTERS-Mr Paul Lynch asked the Attorney General, and Minister for Justice-
 - (1) What percentage of matters before (i) the Local Court and (ii) the District Court consisted of sexual assault matters in the following periods:

- (a) 1 July 2009 to 31 December 2009;
- (b) 1 January 2010 to 30 June 2010;
- (c) 1 July 2010 to 31 December 2010;
- (d) 1 January 2011 to 30 June 2011?
- (2) In relation to the categories above, how many:
 - (a) resulted in a plea of guilty;
 - (b) were discontinued;
 - (c) resulted in an acquittal after a plea of not guilty;
 - (d) resulted in a conviction after a plea of not guilty?

*0677 DUST DISEASES TRIBUNAL-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

- (1) What has been the impact of changes to the Claims Resolution Process in the Dust Diseases Tribunal?
- (2) How many claims have been resolved in the following periods:
 - (a) 1 July 2009 to 31 December 2009;
 - (b) 1 January 2010 to 30 June 2010;
 - (c) 1 July 2010 to 31 December 2010;
 - (d) 1 January 2011 to 30 June 2011?

Answer—

I am advised:

- (1) A report is currently being prepared on the most recent review of the Claims Resolution Process (CRP). Of the 14 submissions received by the review, 13 have evaluated the CRP positively.
- 2) Claims have been resolved through CRP as follows:
 - (a) 154 claims and 55 cross claims
 - (b) 126 claims and 76 cross claims
 - (c) 168 claims and 95 cross claims
 - (d) 125 claims and 72 cross claims.

*0680 ADDITIONAL SCHOOL FENCING-Mr Ryan Park asked the Minister for Education-

- (1) What plans does the Government have for additional school fencing in the Keira electorate?
- (2) Which specific schools in the Keira electorate are being considered for additional fencing?
- (3) Is there a timeframe for when these works will commence?

Answer-

- (1) There are currently no plans for additional school fencing in the Keira electorate.
- (2) Not applicable.
- (3) Not applicable.
- *0682 OPERATION VISION—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Is "Operation Vision" still taking place on the South Coast rail line in partnership with transit officers?
 - (2) When was the last time it took place?
 - (3) When is it planned to take place again?

Answer—

The NSW Police Force has advised me that Operation Vision was the name given to a statewide operation that last ran in March 2010. While this particular name is no longer used, the Wollongong Local Area Command Commuter Crime Unit conducts high visibility policing of transport networks including the South Coast rail line on an ongoing basis. The Unit's operations are supported by Command and Region resources as well as specialist units such as the Dog Squad.

- *0683 EYE WATCH TRIAL—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) What criteria was used to select the local area commands for the new "eye watch" trial?
 - (2) Will the Minister agree to include the Wollongong Local Area Command in this trial?
 - (a) If so, when will this commence?
 - (b) If not, why not?

Answer-

The NSW Police Force has advised me:

- (1) Ten Local Area Commands were selected to pilot eyewatch on the basis of various criteria, including the presence of an active Community Safety Precinct Committee or Neighbourhood Watch Group, both urban and rural localities and varied demographics.
- (2) A further five Commands, including Wollongong, have been included in an extended trial and this is currently running, with the Wollongong Local Area Command page activated on 26 August 2011.

*0684 SPEECH THERAPISTS-Mr Ryan Park asked the Minister for Health, and Minister for Medical Research-

- (1) How many speech therapists are there in the Wollongong Local Government Area?
- (2) Are there plans to increase this number given the growing demand in the region for their services?
- (3) Does NSW Health use video conferencing as a way to deliver these services in the Illawarra?
- Answer—

I am advised:

(1) and (2) Speech therapists are not counted by Local Government Area. Within the Illawarra Shoalhaven Local Health District there are 13 speech pathologists (including adult and paediatric services) and a further 1.6 FTE has recently been approved for adult speech pathology services in cancer, outpatient and palliative care services.

(3) Video conferencing is available to access specialist clinicians in the Illawarra Shoalhaven Local Health District, however is not considered optimal in place of face to face interactions when services are available in close geographical proximity to the client. Speech pathology services in the Local Health District are, in most cases, easily accessible and within 10-25 minutes of travel.

*0685 KOKODA ABORIGINAL SERVICEMEN'S COMMITTEE—Mr Ryan Park asked the Minister for Citizenship and Communities, and Minister for Aboriginal Affairs—

- (1) Is the Minister aware of the work that the Illawarra-based Kokoda Aboriginal Servicemen's Committee is doing to raise money to send Mr Richard Archibald and his family to visit the Kokoda Track to perform Aboriginal burial rites on his late uncle, Private Frank Archibald?
- (2) How may the Government be able to support this campaign?

Answer-

(1) Yes.

(2) Aboriginal Affairs NSW and the NSW Office for Veterans' Affairs can develop options in support of the Kokoda Aboriginal Servicemen's Committee.

*0686 SOUTH COAST LINE—CRIMINAL OFFENCES—Mr Ryan Park asked the Minister for Transport—

- (1) (a) Does RailCorp keep statistics on the number of criminal offences at train stations on the South Coast line?
 - (b) If so, what train station in the Keira electorate has the highest level of crime?
- (2) What specific strategies for the South Coast line is the Government implementing to reduce crime on the network?

Answer-

I am advised:

- (1) (a) and (b) No. RailCorp relies on statistics provided by the NSW Bureau of Crime Statistics and Research (BOSCAR).
- (2) The Government has established a \$40 million Park and Travel Safety Fund to provide additional safety measures at rail stations and commuter car parks. These measures include safety improvements to platforms, stations and car parks through additional CCTV cameras, better lighting and additional help points.

*0689 AMY STREET OVERBRIDGE—Mrs Barbara Perry asked the Minister for Transport—

With respect to the construction of the concrete barrier proposed by RailCorp for the Amy Street overbridge:

- (1) Is the money still allocated for these works?
- (2) Why have works not yet commenced?
- (3) When can the community expect works to begin?

I am advised:

- (1) to (3) This project has been put on hold pending a decision by Auburn City Council regarding the possible replacement/duplication of the Amy Street overbridge. The intersection currently has steel Armco traffic barriers in place. Detailed design works for the new barriers have been completed, should Council choose not to proceed.
- *0690 APPLICATIONS UNDER SECTION 11 OF THE GUARDIANSHIP ACT—Mrs Barbara Perry asked the Minister for Ageing, and Minister for Disability Services—
 - (1) How many applications has Ageing, Disability and Home Care (ADHC) made under section 11 of the Guardianship Act for residents of Grand Western Lodge, Millthorpe, NSW (licensed premises located at 5 Kingham Street and 27 Victoria Street)?
 - (2) What were the concerns that led ADHC to apply to the Guardianship Tribunal for powers under section 11 of the Guardianship Act for removal of residents from Grand Western Lodge?
 - (3) When were these applications made?
 - (4) How many people continue to reside at Grand Western Lodge?
 - (a) Why, if any, do these persons continue to reside at Grand Western Lodge?
 - (b) Were alternative accommodation and support services offered?
 - (5) (a) Can you confirm reports that one resident subject to a section 11 Guardianship order has gone missing?
 - (b) What action has ADHC taken to locate this person?
 - (6) (a) How is ADHC using the Youth and Community Services Act (1973) and Youth and Community Services Regulation (2010) to address the obligations on the licensee and licensed manager in relation to Grand Western Lodge including standards and requirements relating to :
 - (i) medication;
 - (ii) safety and health;
 - (iii) residents not to be abused or neglected;
 - (iv) protection of financial affairs of residents;
 - (v) protection of interests of residents;
 - (vi) complaint handling;
 - (vii) staffing;
 - (viii) sexual assault;
 - (ix) criminal acts?

(b) If not, why not?

- (1) The member would be aware that the Ombudsman had made three reports into the issues raised in her question and that the previous Government failed to act in addressing the areas of concern raised.
- (2) The member may also be aware that this matter is currently before the courts and therefore I do not wish to comment further.
- *0691 GRAND WESTERN LODGE, MILLTHORPE—Mrs Barbara Perry asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) (a) Have any events been recorded by the NSW Police Force in relation to persons who have resided or worked at Grand Western Lodge, 27 Victoria Street or 5 Kingham Street, Millthorpe, New South Wales?
 - (b) What was the nature of these events and the dates recorded for these events?
 - (2) How many allegations of alleged assaults or incidents been reported to NSW Police about incidents of violence, abuse or exploitation relating to persons who may have resided at Grand Western Lodge, 27 Victoria Street or 5 Kingham Street, Millthorpe, New South Wales?
 - (a) What was the nature of these alleged assaults or incidents?
 - (b) How many alleged individual victims are there?
 - (c) How many alleged perpetrators are there?
 - (3) What was the date of the first report as per question (2) made to NSW Police?
 - (4) Is the Minister aware of any allegations of violence, abuse or exploitation being made to any other agency or body?
 - (5) Has NSW Police liaised with any other agencies regarding Grand Western Lodge?
 - (a) If so, which agencies?

- (b) What were the dates of these meetings?
- (c) What was the outcome of these meetings?
- (6) Is this matter currently under consideration by the NSW Police?
 - (a) (i) If so, has a special taskforce been established to investigate these allegations?(ii) If not why?
 - (b) If so, are there specialist officers employed within this taskforce with expertise in supporting victims who are persons with disabilities?
 - (c) What adjustments or special considerations have been made by the investigating officers given the victims are vulnerable persons with disabilities?

Answer-

The NSW Police Force has advised me:

A number of events have been recorded in relation to the Grand Western Lodge. These comprise a variety of incident types, including missing and located persons, alleged assaults, attempted suicides and fire.

A number of allegations received by police are currently under investigation by the Chifley Local Area Command. Strike Force Calendo has been created to manage the investigation.

Ageing, Disability and Home Care (ADHC), as the agency responsible for oversight of the Great Western Lodge, is aware of these allegations. Meetings have taken place between the NSW Police Force, ADHC and the NSW Ombudsman. There remains ongoing liaison between police and these agencies in relation to the investigation of these allegations and meeting the needs of alleged victims and witnesses.

The primary investigating officer in this matter is trained and experienced in obtaining victim statements from vulnerable groups. Officers also adhere to Guidelines for Interviewing People with Impaired Intellectual Functioning as required.

Alleged victims and witnesses are interviewed electronically in surroundings that assist them to feel comfortable and secure. A support person, usually a carer from ADHC, is present during the entire interview process.

*0692 FREE SHUTTLE BUS SERVICE—Mr John Robertson asked the Minister for Transport—

Does the Minister have any plans to expand the free shuttle bus service operating within Blacktown, or to provide new similar services in the Blacktown area?

Answer-

Not at present.

*0693 BUS SERVICE TO WOODCROFT PLAZA-Mr John Robertson asked the Minister for Transport-

Does the Minister have any plans to deliver a bus service from Lakewood Drive, Woodcroft to the local shopping centre at Woodcroft Plaza?

Answer-

I am advised that the existing local services are considered sufficient to meet demand.

This issue has been recently reviewed and there are no plans to alter the network structure.

*0695 BLACKTOWN HOSPITAL—EMERGENCY DEPARTMENT SECURITY—Mr John Robertson asked the Minister for Health, and Minister for Medical Research—

Does the Minister have any plans to provide 24-hour on site security in the Blacktown Hospital emergency department as demanded by the NSW Nurses' Association?

Answer-

I refer the Member to my response to Question No. 0590 in the Legislative Assembly.

*0696 UPGRADE TO BLACKTOWN AND MOUNT DRUITT HOSPITALS—Mr John Robertson asked the Minister for Health, and Minister for Medical Research—

- (1) Does the Minister have any plans to complete the \$245 million upgrade to Blacktown and Mount Druitt hospitals that has been approved by the Department of Health?
- (2) If the Minister provides less funding than this, which services will not be delivered?
- (3) Will the Minister commit to providing a new radiology unit at Blacktown Hospital?

Answer-

(1) to (3) The 2011-12 Budget includes funding to progress planning, design and documentation for

stage 1 of the Blacktown Mount Druitt Hospital Expansion Project.

I am advised that the scope of the stage 1 expansion project remains as identified in late 2010, including a comprehensive cancer centre, including radiotherapy; additional acute bed capacity; expanded critical care; in-centre renal dialysis; ambulatory care; redesign and expansion of the emergency department; and expanded clinical support services at Blacktown.

*0698 INTERACTIVE WHITEBOARDS—Mr John Robertson asked the Minister for Education—

- (1) How many interactive whiteboards have been funded by the Government for schools within the Blacktown electorate?
- (2) Does the Minister have plans to deliver more interactive whiteboards to schools within the Blacktown electorate?

Answer—

- (1) 113 interactive whiteboards have been funded by the NSW Government for schools within the Blacktown electorate.
- (2) Yes.
- *0699 SOCIAL HOUSING—Mr Guy Zangari asked the Minister for Family and Community Services, and Minister for Women—
 - (1) What direction does the Government envisage for social housing in NSW?
 - (2) Will the Government continue the implementation of the Planning for the Future: New Directions for Community Housing in NSW policy?

Answer—

- (1) The previous Government left social housing with 43,000 people on the waiting list and a \$300 million maintenance backlog.
- (2) The Government is committed to addressing NSW's social housing deficit.
- *0700 DEPARTMENT OF HOUSING STOCK—FAIRFIELD AREA—Mr Guy Zangari asked the Minister for Family and Community Services, and Minister for Women—
 - (1) What number of Department of Housing stock in the Fairfield area is over 20 years old?
 - (2) What plan does the Government have in place to upgrade and refurbish Department of Housing stock in the Fairfield area?

Answer-

- (1) Housing NSW has properties in the Fairfield LGA which are over 20 years old.
- (2) In 2011-12, Housing NSW will carry out planned maintenance and upgrading works on approximately 500 properties.
- *0701 RESTORATION OF THE LINNWOOD ESTATE—Mr Guy Zangari asked the Premier, and Minister for Western Sydney—

Can the Premier confirm the receipt of a letter from Councillor Peter Monaghan, Mayor of Holroyd City Council seeking a firm commitment that funding would become available for the restoration of the Linnwood Estate?

Answer-

Fairfield City Council, along with all other Councils in NSW, is empowered under the Protection of the Environment Operations Act 1997 to issue a Notice of Clean-Up Action to the occupier of a premises for the removal of unlawful waste from a premises, at their own cost.

If the occupier does not comply with the Notice, Council can arrange for the clean-up to occur and claim the cost of the work back from the occupier.

Where the person responsible is not able to be identified, the NSW Environmental Trust has a program that provides funding for eligible emergency pollution clean-ups or for the removal of hazardous 'orphan waste', which in some circumstances may include the waste from clandestine drug labs, to remove any immediate risk of harm to human health or the environment.

*0705 CLANDESTINE DRUG LABORATORIES—Mr Guy Zangari asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

The NSW Police Force has advised me that the Drug Squad (Chemical Operations) follows Standard Operating Procedures for the processing of clandestine drug laboratories, with regard to the safety of attending officers and the public as well as the collection of evidence. It is the responsibility of the local government authority to ensure that the site is remediated. The cost of remediation rests with the owner of the property.

*0706 FIREARM OFFENCES—Mr Guy Zangari asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

What strategy does the Government have in place to address the growing instances of firearm offences in the South West Sydney area, especially in areas under the jurisdiction of the Rosehill Local Area Command, Bankstown Local Area Command and Fairfield Local Area Command?

Answer—

The NSW Police Force has advised me that it is conducting a coordinated campaign against firearms offences via a range of proactive measures, including firearms compliance and licensing enforcement operations. Local Area Commands are employing a range of media strategies and liaising with local councils, community groups, schools and businesses to build relationships and encourage the reporting of crime.

A number of recent, related shooting offences are being investigated by officers from South West and North West Metropolitan Regions and State Crime Command investigators, under Strike Force Restore. Three persons were arrested on 31 August 2011 in relation to a shooting incident at Greenacre on 29 August and investigations are continuing on a number of other matters.

Under the current guidelines, participants are able to travel by taxi at a 50% subsidy, up to a maximum allowance of \$30.00 per trip. The subsidy was last increased in April 1999, when the maximum half fare subsidy cap increased by 20% from \$25.00 to \$30.00. In 2010-11 the average trip subsidy was just over \$12.00, well below the current \$30.00 maximum subsidy cap.

*0725 MACARTHUR HEALTH SERVICE—EXPANSION OF SERVICES—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

In view of your comment that "The funding should go to those hospitals, like Campbelltown and Camden, where the clinical need is greatest" and the comments of the Member for Wollondilly about the "Macarthur region missing out on its fair share of health funding" (press release 1 October 2010):

- (1) Will the minister commit to matching the previous Labor Government's funding of \$194 million for an expansion to the inpatient general and mental health bed numbers?
- (2) If not, will she inform the residents and staff of the Macarthur Health service that any inpatient, outpatient or mental health redevelopment is not going ahead, and that the only plans your government has are for enlargement of the Emergency Department (ED).
- (3) When will the ED redevelopment commence?

Answer-

(1) to (3) The 2011-12 State Budget delivered a record \$17.3 billion allocation to Health, in order to return quality health services to the people of New South Wales.

This is an increase of \$953 million over the last 2010-11 State budget, and sees a record \$4.7 billion capital investment over four years, which is a 50% increase on the previous four years.

New Capital Works in 2011-12 includes \$7 million to commence the Campbelltown Macarthur Hospital Redevelopment at an estimated total cost of \$139 million.

The Project will deliver additional beds, including space for future growth; expanded emergency department; additional capacity for birthing; expanded ambulatory, outpatient and allied health services; and additional space for pathology and clinical information.

I am advised that the project is currently in early Schematic Design. It would be anticipated that construction would commence in 2013, with completion in 2016.

*0726 HOSPITAL PARKING FEES—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to parking fees in hospitals:

(1) to (3) The provision of car parking at hospitals is a necessary service for patients, their family and friends and for hospital staff. NSW Health through Health Infrastructure is continuing to review options for improving car parking services at major hospitals in the most effective way.

Car parking prices are subject to increases in line with the Consumer Price Index (CPI) for that year. It is the choice of an individual facility and/or Local Health District to seek approval from the District Board as to whether or not they exercise this option to increase car parking in line with the approved rate of CPI.

- *0727 SUTHERLAND HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) What were the bed occupancy rates for the Sutherland Hospital for June 2010 and June 2011?
 - (2) What enhancements to Sutherland Hospital are planned in the 2011-12 financial year?

Answer-

I am advised that:

(1) Occupancy rates will vary according to the type of clinical service, time of the year, geographical location and models of clinical care for the particular service.

For June 2010 the bed occupancy rate for the Sutherland Hospital was 92%. The rate for June 2011 was 94%.

(2) As announced in the State Budget, a record \$17.3 billion has been allocated to health to return quality health services to the people of New South Wales.

Specific enhancements from the 2011-12 budget for Sutherland Hospital include \$2.5 million for 8 additional acute care beds to be opened during 2011-12 at Sutherland Hospital and \$1 million for the specialty Joint Centre at Sutherland Hospital to improve planned surgery waiting times for patients.

- *0728 ADULTS ACCOMMODATED IN CHILDREN'S WARDS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Since the 2011 election, what action has the Minister taken to stop adults being accommodated in children's wards?
 - (2) How is his situation being monitored?

Answer-

This Government supports the provision of separate accommodation for children and young people from adults when they stay in hospital.

This Government is committed to improving the provision of health care for children and adolescents as outlined by Commissioner Garling. To achieve this, I have established an Expert Taskforce to advise on the implementation of Garling Recommendations which relate to the development of a robust, safe and sustainable systemic framework for children and young people's health care services.

*0730 SCHOOL TRANSPORT-Ms Clover Moore asked the Minister for Transport-

With regard to transport for high school students who must travel from their homes in Woolloomooloo to the Sydney Secondary College, including campuses in Glebe and Balmain:

I am advised:

- (1) Sydney Secondary College students who reside in Woolloomooloo may travel on a regular passenger bus service on Routes 311, 461, 480 or 483 to Railway Square in Sydney CBD, then transfer to a Route 633, 634, 645, 659 dedicated school special bus service for travel to the Sydney Secondary College campuses at Balmain and Glebe.
- (2) The estimated travel times, including the single connection at Railway Square, are around 25 minutes to Glebe and 30 minutes to Balmain.

(3) In the first eight weeks of each school year State Transit undertakes a review of school services.

The review caters for movement of school students within the bus network and any significant change in student demographics. Any changes to services which are necessary are first submitted to the Department of Transport for approval.

- (4) The State Transit Authority and private bus operators have arrangements in place which allow for direct communication between nominated school representatives and the designated point of contact with bus operators.
- (5) Information about transport options is available to parents and schools from the Sydney Buses website and from the Transport Info website or by calling 131500 Transport Info.
- (6) Currently there are multiple services from Woolloomooloo to the CBD which connect with services to the Sydney Secondary College's campuses and no changes to services are intended at this time.

Destination NSW invests in Business Events Sydney to drive national and international conventions and other key business events, as well as securing and investing in sporting and cultural events, to deliver a year-round events calendar for our international and domestic visitors. Wollongong has the opportunity to work with Destination NSW on the acquisition of events for the region, and provide more opportunities for our visitors to visit or extend their stay in the Illawarra. Examples of events already supported by Destination NSW in the Wollongong include Wave Warriors and The Australian Surf Rowers Leagues - Navy Australian Open Surf Boat Championships.

(1) to (5)The Cancer Institute NSW advises that five-year survival rates for all cancer patients in NSW was 49.2% in 1982-86, increasing to 64.4% in 2002-2006. Trends indicate that survival 5 years after diagnosis for all cancers except non-melanoma skin cancer was higher in women. Almost all cancers showed a decrease in five-year survival with increasing age at diagnosis.

Advances of note in NSW include, an increase in five-year survival for men diagnosed with prostate cancer from 59.1% in 1982-86 to 89.9% in 2002-06. Survival from breast cancer improved from 70.1% for women in 1982-86 to 88.3% for women diagnosed in 2002-06. Five-year survival for large bowel cancer increased from 41.9% in 1982-86 to 65.3% in 2002-06.

National figures showing trends in all-cancer five-year relative survival by age, diagnoses from 1982-1986 to 1998-2004 is available from the National Cancer Statistics Clearing House, Australian Institute of Health and Welfare (AIHW).

*0755 EXPLORATION LICENCE—DART ENERGY—Ms Kristina Keneally asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—

Given that Dart Energy announced at a community meeting on Tuesday 16 August in St Peters that they plan to apply for a renewal of their current licence, due to expire in October 2011, for the exploration drilling of coal seam gas in the area, and given the strong opposition of the local community to the project:

Noting that the former Government committed \$31.5 million for the construction of a new Comprehensive Cancer and Blood Disorder Centre at Prince of Wales Hospital:

Answer-

The State Budget was handed down on 6 September 2011 and \$2 million dollars has been committed in 2011-12 to commence the Comprehensive Cancer and Blood Disorder Unit at Prince of Wales Hospital. Budget Paper 4 indicates completion of the Centre in 2015 at an estimated total cost of \$47.2 million.

When will the Minister announce the identity of the person to head the inquiry into the Crime Commission under the Special Commissions of Inquiry Act?

Answer-

Distinguished retired judge Mr David Patten was appointed on 3 September 2011 as Commissioner of a Special Commission of Inquiry into the NSW Crime Commission.

- *0760 INTERN POSITIONS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) How many interns will be employed by NSW Health in 2012?
 - (2) How many applications were received?
 - (3) Are any positions for 2012 vacant?
 - (4) How many of the interns employed for 2012 are:
 - (a) NSW-based Commonwealth grant supported places (CGSPs);
 - (b) interstate CGSP students;
 - (c) full fee paying NSW graduates;

 - (e) international graduates:
 - (f) others?
 - (5) What planning for intern positions for future years is occurring?

Answer-

I am advised:

(1) to (6) NSW Health is offering 846 intern training positions for commencement in 2012. This represents an increase of 76 positions from 2011. The 2012 intern allocation is currently in progress, and as such, a final breakdown of offers made and vacant positions cannot be provided.

As part of the 2011-12 State Budget, the Government has committed new funding of \$11.2 million over four years to support the establishment of additional intern training opportunities. This funding will assist Local Health Districts to support training and supervision of Australian medical graduates to meet their medical workforce requirements.

NSW made a commitment under the COAG process to guarantee intern training opportunities for all Commonwealth Grant Supported Place (CGSP) graduates trained in NSW Universities. NSW has expanded this guarantee to include domestic full fee paying graduates of NSW Universities.

*0761 TRAINEE ENROLLED NURSE (TEN) PROGRAM—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

(1) and (2) The Government supports national standards of registration, as required by the Nursing and Midwifery Board of Australia, to ensure the highest standards of patient care and professional practice. TAFE continues to offer enrolled nurse education programs.

The Government plans to deliver on its election commitment to provide 2,475 more nurses, midwives and enrolled nurses over the next four years. This includes funding for more than 900 nurses in 2011-12.

*0762 ADDITIONAL NURSING POSITIONS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the proposed additional 25 nursing positions proposed for south western Sydney (press release 14 March 2011):

- (1) Are these positions intended for Nurse Educators, for Clinical Nurse Consultants/Specialists or for other nursing roles?
- (2) How many of these positions have been advertised by 31 July 2011?
- (3) How many of these positions have been filled by 31 July 2011?
- (4) In which hospitals and units are they located?
- (5) If these positions are not advertised or filled, when will this occur?

Answer-

(1) to (5) The 2011-12 State Budget includes funding of \$80 million to employ 900 extra nurses as part of the delivery of the Government's election commitment to employ an additional 2,475 extra nurses over four years.

The Budget also includes \$4 million towards employing 275 extra clinical nurse and midwife educators and specialists over four years.

All Local Health Districts are recruiting additional staff.

*0763 PREVENTATIVE HEALTH FIGHTING FUND—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the proposed \$120 million preventative health fighting fund (press release 2 March 2011):

- (1) How much of the funding has commenced by 31 July 2011?
- (2) Is there any budget allocation for the year 2011-12?
- (3) In which building(s) will the offices for preventative health be located?

Answer—

(1) The preventative health fighting fund will incorporate \$120 million of existing allocations for preventive health initiatives from the NSW and Australian Governments.

- (2) The Australian Government allocation to NSW under the National Partnership Agreement on Preventive Health in 2011-12 is \$24.1 million. NSW Health is currently in the process of determining the final allocation to the preventative health fighting fund for 2011-12.
- (3) The Office of Preventive Health is to be located in existing NSW Health accommodation in South Western Sydney in accordance with the NSW Government's commitment.
- (4) The governance arrangements for the Office of Preventive Health are currently being considered.
- (5) Recruitment actions are expected to commence shortly.

*0764 EARLY CHILDHOOD EDUCATION-Mr Ryan Park asked the Minister for Education-

The National Quality Framework is a new regulatory system which includes improved minimum standards for early childhood education and care services and introduces a new quality assessment and rating system to promote continuous improvement in the quality of services.

- (2) Under the Early Childhood Teacher Costs Contribution Scheme a licensed provider can receive a one-off payment in 2011-12 of up to \$6,000 toward the cost of employing a 3-year university qualified early childhood teacher, up to \$8,000 towards the cost of employing a 4-year university qualified early childhood teacher, and an additional \$1,000 per early childhood teacher if the service is in a designated remote area.
- (3) The NSW Government grants substantial funding to providers of early childhood education and care services

The wages and conditions of teachers and other workers in these services are the responsibility of employers and are generally negotiated through Fair Work Australia.

As announced in the State Budget, a record \$17.3 billion has been allocated to health to return quality health services to the people of NSW.

This includes funding to employ 104 more nurses at hospitals in the Hunter New England Local Health District by June 2012.
