- \*7958 COMPULSORY THIRD PARTY INSURANCE REFUND SCHEME—Ms Yasmin Catley asked the Minister for Finance, Services and Property—
  - (1) How many motorists/policy holders would not receive a refund under the compulsory third party (CTP) insurance refund scheme?
  - (2) How many motorists/policy holders would receive a refund under the CTP insurance refund scheme of between:
    - (a) \$0.01 and \$25.00;
    - (b) \$25.01 and \$50.00;
    - (c) \$50.01-\$75.00;
    - (d) \$75.01 and \$100.00;
    - (e) \$100.01 and above?
  - (3) For each of the bands listed in (2), please indicate the percentage of drivers in the following regions:
    - (a) Metropolitan;
    - (b) Outer Metropolitan;
    - (c) Newcastle;
    - (d) Wollongong;
    - (e) Country New South Wales?
  - (4) Did businesses have to pay an administration fee to receive a CTP refund?
  - (5) Were businesses automatically refunded?
    - (a) If so, why did ordinary motorists/policy holders have to apply for a refund?

#### Answer—

- (1), (2) and (3) Approximately 3.5 million vehicle owners in New South Wales are entitled to a compulsory third party (CTP) refund. Refunds are generally between \$10 and \$120, depending on how close to 1 December 2017 the vehicle owner renewed their CTP premium. Average refund amounts vary between the five geographical zones. Indicative refund amounts, based on region and month of renewal, are available on the State Insurance Regulatory Authority website.
- (4) Yes, business customers paid an administration fee to receive their CTP refund.
- (5) No.
- \*7959 NEW TRAINS IN 2018—Ms Julia Finn asked the Minister for Transport and Infrastructure—
  - (1) Considering the Government has ordered an additional 24 new eight-car suburban trains due from late 2018, how many of the trains will be scheduled on the:
    - (a) T2 Inner West line;
    - (b) T5 Cumberland line?
  - (2) Will the new trains be running from late 2018?
  - (3) When will all trains be air-conditioned on the:
    - (a) T2 Inner West line;
    - (b) T5 Cumberland line?

#### Answer-

#### I am advised

- (1) The new trains will be scheduled to operate on a number of lines including the T2 Inner West & Leppington Line. As the Member would no doubt be aware, all timetabled services on the T5 Cumberland Line are already serviced by air-conditioned trains.
- (2) This information is available on Transport for NSW's website.
- (3) The Government was faced with unprecedented growth in patronage across the Sydney Trains network and was forced to make a tough decision. We could either continue with the existing number of services which were not meeting customers' needs or temporarily put the S-sets back on the network to provide additional services. As the Member is aware, the government is replacing these with 24 new Waratah-style trains which will start rolling onto the tracks from late 2018. I remind the Member that when Labor was in government 72 per cent of the Sydney Trains network was air-Today 97 per cent of the network is air-conditioned.

- \*7961 DEMOUNTABLE CLASSROOMS AT SCHOOLS IN THE ENTRANCE ELECTORATE—Mr David Mehan asked the Minister for Education—

#### Answer—

The Department of Education uses demountable buildings to manage changing enrolment patterns; provide accommodation to meet emergency needs arising from incidents such as fires, storms or flooding; and provide temporary accommodation needs as a result of capital works and maintenance projects.

The use of demountables allows the department to be highly responsive to changing needs in schools across the State. All demountable classrooms are air-conditioned and receive regular maintenance.

The department constantly monitors the use of demountables. Where a long-term need for additional school accommodation is established and funding is available, this is provided by expanding existing schools and/or building new schools as necessary.

- \*7963 SOUTH COAST LINE COMPLAINTS—Mr Ryan Park asked the Minister for Transport and Infrastructure—
  - (1) How many complaints have Transport for NSW and the Minister received about overcrowding on the South Coast Line from 1 January 2018 to 31 March 2018?
  - (2) What immediate steps is the Government taking to address the issue of overcrowding on the South Coast Line?

Answer-

I am advised:

Customer satisfaction across the Sydney Trains network has improved from 79 per cent in 2012 to approximately 90 per cent.

- \*7965 GLENDALE TAFE FULL TIME EQUIVALENT TEACHERS—Ms Sonia Hornery asked the Minister for Tourism and Major Events, and Assistant Minister for Skills—
  - (1) What was the number of Full time Equivalent (FTE) teachers employed at Glendale TAFE NSW at 10 April 2011?
  - (2) What is the number of FTE teachers employed at Glendale TAFE NSW at 10 April 2018?

Answer-

\*7967 FOOTBALL INFRASTRUCTURE IN NEW SOUTH WALES—Ms Sonia Hornery asked the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—

According to figures from Football NSW 863,210 people in New South Wales play football making it the premier club-based sport in the country. What steps is the Government taking to ensure there is sufficient infrastructure at the community level for football players as the sport grows?

#### Answer-

The Government has and will continue to invest in sporting facilities, including football facilities that benefit community sporting clubs through grant programs such as:

- Greater Sydney Sports Facility Fund-\$100 million
- Regional Sports Infrastructure Fund- \$100 million
- Stronger Country Communities Fund- \$100 million
- NSW Asian Cup 2015 Legacy Fund \$4.1 million
- Local Sport Grant Program- \$50,000 available per electorate
- Infrastructure Grants Program (CiubGrants Category 3 Fund)
- · Community Building Partnership Program

Office of Sport is also undertaking the Future Needs of Sport Infrastructure Study which will provide the framework for future Government investment and policy decisions relating to community sport and recreation infrastructure, including football facility projects, in New South Wales.

\*7968 WOMEN IN FOOTBALL—Ms Sonia Hornery asked the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—

According to figures from Football NSW 229,917 people in New South Wales play outdoor football, 23 per cent of whom were female. What steps is the Government taking to encourage women to engage with football?

#### Answer—

The Government has grant programs available for State Sporting Organisations and local clubs to apply for projects including to increase participation.

Office of Sport is also currently developing a Women in Sport Strategy that will aim to increase participation of women and girls in sport, including Football. Further information is available at: sport.nsw.gov.au/sectordevelopment/women-sport.

- \*7969 PARKING CONCESSIONS AT WOLLONGONG HOSPITAL—Mr Paul Scully asked the Minister for Health, and Minister for Medical Research—
  - (1) Further to the answer to LA Q7507, why doesn't Wollongong Hospital record the number of parking concessions received?
  - (2) Do other hospitals measure the number of parking concession applications they receive?
    (a) If not, why not?
  - (3) How many parking concessions have been issued at Wollongong Hospital?
  - (4) What is the total value of parking concessions provided to date since the introduction of the parking concession scheme on 1 July 2017?
  - (5) How much has been spent by the Department of Health and local health districts on advertising and awareness of the parking concession scheme?

#### Answer—

The majority of New South Wales Hospitals do not charge fees for hospital parking.

I am advised that over 30,000 concessions for parking have been issued from 1 July 2017 to 31 March 2018 at Wollongong Hospital, with the total value of parking concessions provided estimated at approximately \$295,000.

New South Wales public hospitals promote parking concessions through a number of ways. These hospital costs are not recorded by the Ministry of Health.

- \*7970 WIN ENTERTAINMENT CENTRE—Mr Paul Scully asked the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
  - (1) Has an examination of the capacity of the WIN Entertainment Centre to meet contemporary safety, security, compliance and amenity standards been conducted?
    - (a) If so, when was this conducted, what were the findings and will the report be made public?
      - (i) If not, why not?
  - (2) Does Venues NSW consider the WIN Entertainment Centre to meet contemporary operational

efficiency?

(a) If not, why not?

#### Answer-

Venues NSW conducts regular internal audits or reviews on the operational effectiveness, efficiency and performance of their venues including the WIN Entertainment Centre.

WIN Entertainment Centre is subject to a monthly preventative maintenance schedule, and complied with its Annual Fire Safety Certification in 2017.

An internal audit of Workplace Health and Safety Management Systems, Environmental Management Systems, Asset Maintenance Systems, Crisis and Emergency Plans and a Review of Operations and Business Model have all been undertaken.

#### \*7971 TUGGERAH PUBLIC SCHOOL—Mr David Mehan asked the Minister for Education—

- (1) Is the Minister aware of vacant crown land next to Tuggerah Public School designated Lot 7019 DP 1076631?
- (2) Is the Minister aware of the petition of more than 500 signature dated 8 March 2016 asking that the school be granted the rights to the crown land to allow the school grounds to expand?
- (3) Is the Minister aware of the letter dated 15 January 2004 from Ms Ruth Ferguson, Sites Officer at the Department of Education and Training to the Department of Lands (now the Department of Industry) seeking to acquire part of the crown land?
- (4) Is the Minister aware of the Aboriginal Land Claim #17440?
- (5) What steps has the Minister taken to ensure the crown land is acquired for the benefit of the school?
- (6) What information has the Minister or your Department provided to the Department of Industry regarding plans to use the crown land for the benefit of the School?
- (7) Will the Minister advise the Department of Industry that the crown land is needed for the school?

#### Answer—

I'm advised that the Department of Education is undertaking planning for the Wyong area, which will consider various options including the use of part of Lot 7019 if available.

The department is working closely with the Aboriginal Land Claim Investigation Unit regarding its interest in the site so that the land claim may be resolved appropriately.

- \*7972 STUDENTS ENROLLED AT GLENDALE TAFE—Ms Sonia Hornery asked the Minister for Tourism and Major Events, and Assistant Minister for Skills—
  - (1) What was the number of students enrolled at Glendale TAFE at 10 April 2011?
  - (2) What is the number of students enrolled at Glendale TAFE at 10 April 2018?

#### Answer-

\*7973 PARAMEDIC POSITIONS IN THE ILLAWARRA—Mr Paul Scully asked the Minister for Health, and Minister for Medical Research—

Considering your response to LA Q7504, how many full-time equivalent paramedic positions were in the Illawarra in each year from 2011 to 2017?

## Answer-

The full-time equivalent (FTE) Paramedic positions in the Illawarra Zone Stations have increased by over 10 FTE during this period.

- \*7974 CONSULTATION FOR THE INSTALLATION OF LIFTS AT UNANDERRA STATION—Mr Paul Scully asked the Minister for Transport and Infrastructure—
  - (1) Were consultants engaged to prepare plans for the installation of lifts at Unanderra Station? (a) If so, who was engaged?
  - (2) What was the cost of developing the plans for the lifts to be installed at Unanderra station, construction of which was deferred in 2011?
  - (3) What was the total cost of modifying the toilets at Unanderra station?

(4) What was the total cost of installing additional disabled parking at Unanderra station?

Answer-

I am advised:

In 2009, the then Minister for Transport David Campbell announced an upgrade of Unanderra Station. Regrettably, and in typical fashion of the previous Labor Government, planning was rushed and ill-conceived.

Construction works at Unanderra began in May 2010 and were subsequently suspended in September 2010 due to significant conflicts between proposed works and in-ground services, which required additional concept design work and halt to the work in October 2010.

In August 2012, approval was given to remediate Unanderra Station platform and conduct maintenance work on the overbridge stair treads. Improvements to Unanderra Station included installation of lighting and CCTV, remediation of the platform and replacement of stair treads. All works were completed in March 2013.

\*7975 NEW MARYLAND FIRE STATION STAFFING—Ms Sonia Hornery asked the Minister for Police, and Minister for Emergency Services—

Why is the new Maryland fire station staffed only by retained personnel as opposed to both retained and permanent personnel?

Answer—

I am advised:

The new Wallsend Fire Station, near Maryland, is staffed by the same firefighters who were stationed at the previous Wallsend Fire Station.

The Wallsend area is also serviced by stations at Lambton, Mayfield West and Cardiff, which are staffed by both permanent and retained firefighters, as well as Minmi, which is staffed by retained firefighters.

FRNSW constantly reviews service needs for the community and current arrangements meet those needs.

\*7976 TEMPORARY TEACHERS AT GLENDALE TAFE—Ms Sonia Hornery asked the Minister for Tourism and Major Events, and Assistant Minister for Skills—

\*7978 STORAGE AND USE OF RECYCLED GLASS—Ms Sonia Hornery asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—

What are the Government's policies for the storage and use of recycled glass in New South Wales?

Answer-

I am advised:

The storing or processing of recycled glass in New South Wales over a certain amount needs to be licensed under the Protection of the Environment Operations Act 1997. The supply or use of crushed glass for pipe bedding or in road making is also required to meet a resource recovery order and exemption conditions. Development consent and industry specification compliance are also critical in the processing and use of recycled glass.

- \*7979 WORKERS' COMPENSATION—Ms Sonia Hornery asked the Treasurer, and Minister for Industrial Relations—
  - (1) How many workers in New South Wales are currently covered by workers' compensation (as at 10 April 2018)?
    - (a) What is the average income of these workers?

- \*7981 MOUNT OUSLEY MOTORWAY INTERCHANGE—Mr Ryan Park asked the Minister for Roads, Maritime and Freight—
  - (1) Considering that the Government has finished community consultation on the Mount Ousley interchange, when will the Government announce the timing and funding for the construction of the interchange?
  - (2) After consultation, what new measures is the Government considering to reduce the noise from vehicles on residents surrounding the interchange?

Answer-

I am advised:

- (1) A business case is currently being prepared. Timing and construction of the interchange upgrade will be subject to the business case.
- (2) Information about the Mount Ousley interchange is available on the Roads and Maritime Services website.
- \*7982 SUBLIME POINT WALKING TRACK FUNDING—Mr Ryan Park asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) Considering the rapid increase in popularity of the Sublime Point Walking Track in the Illawarra Escarpment Conversation Area and the close proximity of residential properties to the lower access point to the walk, when will funds be made available to establish:
    - (a) A car park for visitors;

- (b) Public amenities, specifically a toilet block?
- (2) Will the car park be located in an appropriate location away from private residential properties?

Answer-

I am advised:

- (1) and (2) There are no suitable sites within Illawarra Escarpment State Conservation Area for a car park or toilet block due to steep terrain susceptible to land instability.
- \*7983 MEMORIAL DRIVE EXTENSION—Mr Ryan Park asked the Minister for Roads, Maritime and Freight—
  - (1) What allocation of funds will the Government be making to extend Memorial Drive and link it to the base of Bulli Pass (as at 10 April 2018)?
  - (2) Will this project be prioritised in the 2018-19 Budget?

Answer-

I am advised:

Information will be available in the 2018-19 Budget.

- \*7984 BANNING PLASTIC BAGS—Mr Ryan Park asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) Considering that South Australia, the Australian Capital Territory, the Northern Territory and Tasmania all have bans in place for single use plastic bags and with Queensland, Western Australia and Victoria indicating they will act this year, what plans does the Government have to ban single use plastic bags?
  - (2) Is the Government resisting calls to act on this policy?
    - (a) If so, why?

Answer-

Major retailers, who account for around half of all plastic bags, have committed to phasing out single use plastic bags in New South Wales. The Government welcomes this proactive step.

The Government has also committed over \$800 million over nine years through the Waste Less, Recycle More initiative to drive waste reduction and increased recycling.

This is the largest waste and recycling funding program in Australia and supports local communities, councils and businesses.

- \*7985 REVENUE FROM THE RETURN AND EARN SCHEME—Ms Sonia Hornery asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) Does the Government generate any additional revenue from the Return and Earn scheme?
    - (a) If so, has this revenue been earmarked for any particular spending outlays?

Answer—

I am advised the Government does not generate revenue from the scheme.

\*7986 REGISTER OF COWS AT HURLSTONE AGRICULTURAL HIGH SCHOOL (GLENFIELD)—Mr Anoulack Chanthivong asked the Minister for Education—

Was a register maintained on the number of cows in the herd at Hurlstone Agricultural High School (Glenfield) from 1 March 2014 to 1 March 2018?

Answer-

The number and class of animals is monitored and recorded through the use of a number of recording instruments.

As the railway line does not yet exist, the current timetable is not applicable.

- \*7988 UPDATE ON THE FIRE SAFETY AND EXTERNAL WALL CLADDING TASKFORCE—Ms Yasmin Catley asked the Minister for Innovation and Better Regulation—
  - (1) In relation to the Department of Finance, Services and Innovations' media release dated 22 March 2018 'Update on the Fire Safety and External Wall Cladding Taskforce', where are the 412 buildings identified as requiring further assessment located?
    - (a) What plans are there for the stripping off of external cladding samples from these buildings and testing them for fire safety/combustibility?
    - (b) What is occurring in relation to communication to owners and occupiers of these buildings as to the necessary and urgent testing to be undertaken?
  - (2) Considering the statement in the release: "It is important to remember that just because the buildings requiring further assessment have cladding does not mean that they are unsafe."
    - (a) On what fire safety grounds has the statement been made?
    - (b) Why specifically do they require further assessment?
    - (c) As at 10 April 2018 how many properties are known to the Taskforce to have the Grenfell type of combustible aluminium cladding and insulation on them?
  - (3) Is a program of testing available for owners and occupiers in relation to these properties?
  - (4) In light of findings in the Grenfell Tower fire that lower floor doors failed fire resistance testing, what measures are in place in New South Wales to ensure that all property doors are fire resistant?
  - (5) Have any of the following products been found to exist at any of the buildings thus far identified by the Taskforce:
    - (a) Reynobond polyethylene (PE);
    - (b) Alucoil
    - (c) Alucobond?
  - (6) If any of the products in (5) have been found:
    - (a) Which buildings are affected (by product)?
    - (b) Are the occupiers aware?
    - (c) What action, if any, is planned at these locations?
  - (7) Have members of the Taskforce personally viewed any testing of cladding taken from any of the buildings thus far assessed?
  - (8) Are minutes of their meetings and reports of their activity available to members of the public?
  - (9) Has the Taskforce discovered any breaches of building regulations at any of the buildings thus far assessed?
  - (10) Does the Taskforce consider that all the buildings thus far assessed are perfectly safe in relation to fire safety and fully adhere to legislation?
  - (11) Considering that public buildings other than private residential apartments have come under scrutiny in the United Kingdom following the Grenfell tragedy, for example certain hospitals and university halls of residence for students, is the Taskforce examining public buildings of this nature in New South Wales?
    - (a) If not, who is examining public buildings of this nature in New South Wales?
  - (12) In its assessment of buildings has the Taskforce identified any potential criminal acts at any locations resulting in information being passed on to the NSW Police Force?

### Answer-

(1) (a), (2), (5), (6), (7) and (10) Responding to the issue of cladding requires co-operation between local, State and Commonwealth Governments.

The Government is currently auditing buildings in New South Wales to identify if they have cladding which may pose a safety risk to the building's occupants. That audit is being conducted by the cladding taskforce, comprised of officials from across relevant New South Wales Government Departments. The taskforce has:

- Conducted a data audit of records from approximately 180,000 building projects to identify buildings that may have cladding.
- Asked local councils to provide the taskforce with a list of buildings that may have cladding within their local government area.
- The Department of Planning has been reviewing its records for buildings in respect of which it was the consent authority to identify any that may have cladding.
- Engaged in a public advertising campaign, asking the public to inform Fair Trading of any concerns they may have regarding cladding on specific buildings.

NSW Fire & Rescue has been inspecting buildings that are identified as possibly having cladding. In that process, it has identified additional buildings that also require assessment. In the first instance, Fire & Rescue NSW has been assessing buildings to see if the building has cladding in a quantity or configuration that may give rise to a fire safety risk. As at March 2018, in total, Fire & Rescue NSW had assessed over 1.500 sites.

If a building is assessed to have cladding in that quantity or configuration, the Commissioner of Fire & Rescue NSW has requested the local council (where the council is the consent authority) to assess the building's safety, having regard to the cladding. Local council assessments are needed to determine if the cladding on those buildings is combustible, whether it is present in a quantity or configuration that poses a fire risk, considering all other aspects of the building's fire safety systems, and what steps are needed to ameliorate any risks that may be identified. Such assessments are the responsibility of local councils where the council is the consent authority because councils have the power to order buildings to be rectified.

As at 12 March 2018, a total of 412 buildings have been identified as requiring further assessment.

The Department of Planning is following a similar process with respect to any buildings in respect of which it is the consent authority.

- (1) The buildings are located throughout New South Wales, and mostly in the Greater Sydney Metropolitan Area.
- (b) The Taskforce has written, and continues to write, to owners and occupants of identified buildings, provided information online via dedicated pages on the Fair Trading website and conducted a state-wide advertising campaign (during February 2018).
