#### Answer-

(1) and (2) A Major Project Application was lodged for the proposal in November 2007 and the Department issued Director-General's Requirements to the Proponent. The Director-General's Requirements outline the issues the Proponent is required to address in its Environmental Assessment of the proposal.

In February 2011, the Director-General's Requirements were updated at the request of the Proponent in order to broaden the area that the assessment of the proposal applies to.

However at this stage, an Environmental Assessment for the proposal has not been lodged and therefore has not been publicly exhibited.

- (3) When the Environmental Assessment is lodged and is deemed adequate for public exhibition, public comment will be sought on the proposal.
- (4) The proposal will be dealt with as expediently as possible whilst ensuring that all issues are properly and fully addressed.
