\*1975 ADOPTION BY SAME SEX COUPLES—Mr Richard Amery asked the Minister for Family and Community Services, and Minister for Women—

Since the introduction of laws permitting the adoption of children by same sex couples:

- (1) How many children have been adopted in this State?
- (2) How many of those children were adopted by parents of the same sex?
- (3) Of the children being adopted, how many of them were unknown to the adopting parents prior to the adoption being approved?
- (4) Of the parents referred to in question (3) above, how many of these adopting parents were same sex couples?

Answer-

- (1) 264
- (2) 7
- (3) 120
- (4) None.
- \*1976 NEW LIFE NSW CAMPAIGN—Mr Michael Daley asked the Deputy Premier, Minister for Trade and Investment, and Minister for Regional Infrastructure and Services—
  - (1) How much is the approved advertising budget for the Government's "New Life NSW" campaign to entice people to take up the Government's regional relocation grants?
  - (2) How much has been spent on this campaign as at 22 February 2012?

Answer-

- (1) \$520,000.
- (2) \$750,000 was spent on the campaign as at 22 February 2012, which includes \$520,000 advertising costs. The remaining \$230,000 was spent on other work supporting the campaign such as research, production, printing and website development.
- \*1978 CARERS IN THE ELECTORATE OF WALLSEND—Ms Sonia Hornery asked the Minister for Ageing, and Minister for Disability Services—

How many full-time and part-time carers operate in the electorate of Wallsend?

Answer-

Ageing Disability and Home Care (ADHC) does not collate data on employment by electorate.

ADHC do not hold data on carer workforce from non-government organisations (NGO's).

\*1979 HUNTER DRUG AND ALCOHOL SERVICES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

What support is the Minister providing to drug and alcohol services in the Hunter towards a world first trial to help people addicted to cannabis?

Answer-

I am advised:

Hunter New England Local Health District Drug and Alcohol Services is working in collaboration with the National Cannabis Prevention and Information Centre (NCPIC) in a world first inpatient trial examining the safety and efficacy of a specific treatment for the management of cannabis withdrawal. The study is being funded by a National Health and Medical Research Council grant to NCPIC, a division of the University of NSW.

\*1981 LAKE MACQUARIE LOCAL AREA COMMAND—POLICE NUMBERS—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Given that four new probationary constables will be allocated to Lake Macquarie Local Area Command, how many more police need to be allocated to Lake Macquarie to have the command at 100% capacity?

Answer—

This Government is determined to provide police with the numbers and resources they need to keep the community safe.

The Lake Macquarie Local Area Command was at 102% operational capacity as at 4 May 2012.

\*1982 YOUTH CRIME IN JESMOND PRECINCT—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

In relation to youth crime in the Jesmond precinct:

- (1) What steps is the Government taking to reduce youth crime in the area?
- (2) Will additional police be employed to tackle this ongoing issue?

Answer—

The NSW Police Force has advised me:

- (1) Officers from Newcastle City Local Area Command have met with the Member and discussed issues surrounding youth crime in Jesmond and Wallsend, including a range of policing strategies and activities currently in place. These include a criminal investigation strike force targeting street robberies in the area, youth case management by a Youth Liaison Officer and Police Boys Club, and the Hour of Power initiative which delivers proactive, high visibility policing to targeted locations.
- (2) Police deployment is based on intelligence reports and crime trends. The area is receiving regular patrols and current deployment levels are considered sufficient.
- \*1983 FUNDS RAISED FROM SALE OF CARDIFF POLICE STATION—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Will the funds raised from the sale of the Cardiff Police Station go back into building the Glendale Police Station, as the Government has committed and demonstrated in the 2011-2012 budget?

Answer-

Funds from the sale of police properties are directed to the ongoing NSW Police Force capital works program. I have already announced that the Government has committed to a \$21.5 million redevelopment of police stations in the Lake Macquarie Local Area Command.

\*1984 REPLACEMENT OF TRANSIT OFFICERS—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Given that more than 450 Railcorp transit officers will be sacked and replaced by 300 new police officers, how will the shortfall of 150 officers be addressed?

Answer-

I am advised:

The allocation of police and transit officers recognises that police have greater powers and capability which will result in enhanced operational capacity. Police also patrol in pairs whereas Transit Officers patrol in larger groups for safety reasons.

The new Police Transport Command commenced operations on 2 May 2012 with 301 officers from local community crime units. The Command will increase its numbers until its target authorised strength of 610 officers is reached by December 2014.

The Police Transport Command is committed to promoting safety and reducing crime on the NSW transport network.

\*1985 FINANCIAL ASSISTANCE TO GARARD PTY LTD—Mr Paul Lynch asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

Since 27 March 2011 what financial assistance has been provided to Garard Pty Ltd operating at Warwick Farm and Liverpool?

Answer-

The Office of State Revenue (OSR) provides assistance in the form of various grants and rebates. Confidentiality provisions prevent details of arrangements in respect of recipients being disclosed. Accordingly, OSR is unable to advise whether or not any assistance has been provided to any individual or organisation.

Otherwise, the Department of Finance and Services has not provided assistance to Garard Pty Ltd.

- \*1986 LICENSING OF SEX WORKERS AND BROTHELS—Mr Paul Lynch asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—
  - (1) Does the Minister or the Government have any proposals to regulate, license or alter the regulation on licensing of sex workers and/or brothels?
  - (2) If so, when will such plans be released?

Answer-

As per the election commitment, the Government is committed to the establishment of a Brothel Licensing Authority to eliminate illegal brothels and to ensure legal brothels comply with the law.

\*1987 SKILLS TRAINING AUSTRALIA GROUP PTY LTD—FINANCIAL ASSISTANCE—Mr Paul Lynch asked the Premier, and Minister for Western Sydney—

Since 27 March 2011, what financial assistance, in which categories and for what purposes has been provided by or on behalf of the Government and/or State agencies to Skills Training Australia Group Pty Ltd?

Answer-

I am advised:

The Government has not provided financial assistance to the Skills Australia Group Pty Ltd in the period 27 March 2011 to 7 May 2012. However, over that period the Department of Education and Communities purchased 467 training places from Skills Training Australia Group Pty Ltd to the value of \$457,874.24.

\*1988 SKILLS TRAINING AUSTRALIA GROUP PTY LTD—FINANCIAL ASSISTANCE—Mr Paul Lynch asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

Since 27 March 2011, what financial assistance, in which categories and for what purposes has been provided by or on behalf of the Government and/or State agencies to Skills Training Australia Group Pty Ltd?

Answer—

The Office of State Revenue (OSR) provides assistance in the form of various grants and rebates. Confidentiality provisions prevent details of arrangements in respect of recipients being disclosed. Accordingly, OSR is unable to advise whether or not any assistance has been provided to any individual or organisation.

Otherwise, the Department of Finance and Services has not provided assistance to Skills Training Australia Group Pty Ltd.

- \*1989 SUICIDE NUMBERS—Mr Paul Lynch asked the Minister for Health, and Minister for Medical Research—
  - (1) (a) Does the Minister's department maintain statistics on the number of suicides last year?
    - (b) If so, where may the figures be accessed?
  - (2) Do records reveal whether the deceased were victims of sexual assaults?

Answer—

I am advised:

(1) and (2) The Australian Bureau of Statistics (ABS) produces annual mortality data, where a legal and official determination of the cause of death by suicide has been made by the Coroner/s.

The ABS annual publication of Causes of Death data (Catalogue No. 3303.0) reports deaths by all causes including suicide by Australian States and Territories. The latest available ABS Causes of Death data is for the year 2010 and can be accessed at www.abs.gov.au

This data does not reveal the underlying causes or risk factors for suicide deaths, such as sexual assault or other forms of violence or abuse.

- \*1990 BUSINESSLINK REDUNDANCIES—Mr Paul Lynch asked the Minister for Family and Community Services, and Minister for Women—
  - (1) How many redundancies are expected or planned for at Businesslink arising from the invitation for voluntary redundancies made on or about 20 April 2012?
  - (2) Does the Minister propose to merge Businesslink and ServiceFirst?

(3) Does the Minister propose to privatise the IT component or any other component of Businesslink or ServiceFirst?

#### Answer—

- (1) NSW Businesslink helps its clients to serve their clients better. Every dollar Businesslink saves can be used to deliver better services to vulnerable people in the community such as people with a disability, older people and children in need of protection.
  - NSW Businesslink announced a Voluntary Redundancy Program for officers occupying non-leadership roles on 24 April 2012. Expressions of Interest were invited from all eligible staff.
  - There is no specific number of redundancies either expected or planned. The number of voluntary redundancies ultimately approved for officers will depend on the result of business unit reviews.
- (2) and (3) The Minister for Finance and Services is currently undertaking a review of the sector wide Corporate and Shared Services Reform. As part of that review several options are being considered to improve services and save taxpayers money with respect to the services provided by Businesslink and Service First and indeed other service providers within the sector.
- \*1991 JUDICIAL APPOINTMENT COMMISSION—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) Will the Attorney General establish a Judicial Appointment Commission?
  - (2) If so, when?
  - (3) If not, why not?

#### Answer-

- (1) to (3) I refer to my comments published in the Law Society Journal in May 2011 where I noted that judicial vacancies in the Local and District Court are now advertised and selection panels recommend suitable people.
- \*1992 JOHN MORONY CORRECTIONAL CENTRE—INTENSIVE DRUG TREATMENT FACILITY—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

In relation to the intensive drug treatment facility to be located in John Morony Correctional Centre:

- (1) What criteria will apply to those admitted to the facility/scheme?
- (2) What is the shortest period of time a person will participate in the scheme?
- (3) What is the projected average length of time a person will participate in the scheme?
- (4) What is the projected average length of sentence for those who will participate in the scheme when they commence?
- (5) What post-imprisonment monitoring and support are proposed for those who participate in the scheme?

#### Answer-

#### I am advised:

- (1) The current eligibility criteria for the Intensive Drug and Alcohol Treatment Program (IDATP) are: sentenced male inmates with a documented history of drug/alcohol use in the community and/or in custody, with a non-parole period of at least 1 year to serve and a medium or minimum security classification. Sentenced female inmates with similar histories and equivalent non-parole periods and security classifications will be eligible in a later phase of the program.
  - Factors that may restrict an inmate's suitability for the program include conviction(s) for serious sex offences (for whom alternative treatment pathways are available), low cognitive functioning, acute mental illness, recent suicide attempts or ideation, serious and regular institutional misconduct and a requirement for non-association with others currently on the program. All factors are considered on a case by case basis in consultation with relevant Corrective Services NSW (CSNSW) specialist areas to determine appropriate treatment pathways.
- (2) The shortest possible time to complete the treatment program and commence a maintenance program before release is nine months. The preferred model, however, is for participants to also complete a period of time in a minimum security facility and participate in pre-release programs before release into the community.
- (3) The projected average time to complete the IDAPT is approximately twelve months.
- (4) The total length of sentence is not a factor for consideration for eligibility for the IDATP. It is expected that inmates will have 1-2 years remaining on their sentence at the time they commence the program. This timeframe will allow for completion of the treatment program and progression to maintenance and pre-release programs prior to release.

(5) Participants who are subject to supervision by the Probation and Parole Service will be monitored in the community and will be required to attend a Self Management and Recovery Training (SMART) Maintenance Program (an alcohol, drug and addictions program) as a condition of their supervision. They will also have a structured support framework developed to assist in their resettlement, covering accommodation, employment, connections with family, and linkage to external government and non-government agencies.

Participants who are not subject to post-release supervision by the Probation and Parole Service will be provided with a structured support framework developed by IDATP staff, linking the participant with external government and non-government agencies in the community prior to release from custody, including linkage to accommodation services, employment agencies, appropriate self-help and support groups (e.g. SMART, Narcotics Anonymous, Alcoholics Anonymous). If the participant consents, IDATP staff will monitor their progress in the community and provide joint case management with the participating agencies.

\*1993 CUBIT PROGRAM—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

In relation to the CUBIT program running at Metropolitan Special Program Unit at Long Bay Correction Centre:

- (1) Why have funding cutbacks been imposed on this program?
- (2) Why are participants in this scheme subjected to frequent lock downs and, on many days, allowed only 7.5 hours out of cells?
- (3) Why are inmates classified C1 and C2 subjected to such a regime?
- (4) Is such a regime likely to prevent the rehabilitative aims of the CUBIT program being achieved?

Answer-

I am advised:

- (1) There have been no funding cutbacks to the CUBIT program. Staffing at CUBIT has been maintained to make sure that all 4 treatment groups run continuously.
- (2) Inmates at all correctional centres are subject to a Variable Operational Routine (VOR), which enables the daily routine of a correctional centre to be varied to take account of the circumstances affecting a correctional centre on a particular day, such as critical incidents, security searches, staff training, staff absences, hospital escorts etc. Metropolitan Special Programs Centre management makes every effort to lessen the impact of the VOR on the CUBIT program, however the needs of this program are balanced against the needs of competing programs, education courses and inmate employment.
- (3) Variable Operational Routines operate at all correctional centres regardless of inmate classification.
- (4) No. Irrespective of the VOR, the CUBIT program is still being delivered in full.
- \*1994 JUDGEMENT BY MCLAUGHLIN ASJ—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Has the Attorney General or his department responded to or taken any action in relation to the judgement by McLaughlin AsJ in the case of MacDonald v Public Trustee, delivered in the Supreme Court on 25 June 2010?

Answer-

I am advised:

The NSW Trustee and Guardian has implemented a number of improvements that are designed to address the issues raised in that case.

These improvements include establishing a Genealogy Unit in 2004 to undertake extensive searches for next of kin and to establish entitlement on intestacy. This Unit is located in the Legal Branch and is managed by a solicitor with specific training and expertise in intestacy and genealogy. Guidelines have been developed for the Unit to ensure that a review of each file is undertaken every three months and action is taken where documents are not submitted within allotted timeframes. Only when there is no prospect of establishing entitlement would the estate be paid to the Treasury. The process of remitting unclaimed money to the Treasury has also improved to allow for easier recovery of money in the event that next of kin are found at a later stage.

In addition, since the initial administration of the estate significant technological improvements have been made in the area of genealogical searches.

Due to these improved processes and operational changes, many of the issues that arose in this case are

highly unlikely to occur again.

\*1995 PROSECUTIONS FOR OFFENCES UNDER SECTIONS 80D AND 80E OF CRIMES ACT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many prosecutions have there been in NSW courts for offences under sections 80D and 80E of the Crimes Act in the following periods:

- (a) 1 January 2009 to 31 December 2009;
- (b) 1 January 2010 to 31 December 2010;
- (c) 1 January 2011 to 31 December 2011;
- (d) 1 January 2012 to date?

#### Answer—

#### I am advised:

The Bureau of Crime Statistics and Research (BOCSAR) has no record of any finalised charges under sections 80D(1) or 80E(1) of the Crimes Act 1900 in any NSW court from 1 January 2009 to 30 September 2011. A finalised charge is one that has been fully determined by the court and for which no further court proceedings are required. Finalised court data is not yet available for the period 1 October 2011 to date.

\*1996 AUSTRALIAN TERTIARY ADMISSION RANK—Dr Andrew McDonald asked the Minister for Education—

With reference to confidentiality of reporting ATAR ratings of greater than ninety at Castle Hill High School in 2011 (Question 1764):

- (1) How is the Minister able to report increases as a percentage, "a 50% rate of ATAR scores of greater than 90 in 2011, a 100% increase on the previous year", yet not the actual numbers on which these reported percentages were based?
- (2) In view of this, how many individual students received an ATAR of greater than 90 at Castle Hill High in:
  - (a) 2010;
  - (b) 2011?

#### Answer—

(1) With reference to your quote, "a 50% rate of ATAR scores of greater than 90 in 2011, a 100% increase on the previous year", which is incorrect, I therefore refer you to my speech as recorded by Hansard on 13 March 2012:

Mr ADRIAN PICCOLI: The blue folder. Castle Hill High School implemented some key initiatives. It created an additional year adviser position to support student attendance across the school. Some of those changes led to over 50 per cent of students achieving an Australian tertiary admission rank [ATAR] of 90 in the 2011 Higher School Certificate. Over 50 per cent of students who achieved a ranking over 90 were boys. That is an increase of 100 per cent on the previous year. Castle Hill High School also created a head teacher mentor position. [Extension of time granted.]

#### [Interruption]

I thought members opposite would be silent to listen to this good news. The Auditors-General who are in the gallery today may wish to take this reform back to their jurisdictions. Castle Hill High School created a head teacher mentor position to assist senior boys with their learning, specifically targeting boys with obvious capacity who were not achieving. That school achieved a 100 per cent increase in the number of boys who achieved an Australian tertiary admission rank of over 90. These are great results. These reforms have achieved great results in schools for special purposes, public schools, primary schools and high schools. The most important thing about any reform in education is that it leads to improved student outcomes, and that has been the focus of this reform. There are about 30 elements to this reform, at least half a dozen of which would be major reforms on their own.

(2) ATAR scores are confidential. Following the Review of the HSC by the previous government, they amended the then FOI Act to make the UAI (now ATAR) confidential to the individual and separate from the HSC.

Information which may result in the identification of students, including the number of students in schools receiving various ATAR scores, is therefore not released.

\*1997 SUICIDES AT STAR CASINO PREMISES—Dr Andrew McDonald asked the Premier, and Minister for Western Sydney—

With regards to suicides on the Star Casino premises:

- (1) How is the Government informed of suicides at the Star Casino?
- (2) How many suicides occurred at the Star Casino in:
  - (a) 2009;
  - (b) 2010;
  - (c) 2011?

#### Answer-

I am advised that:

- (1) There is no formal obligation under the Casino Control Act 1992 or the Internal Controls of The Star, for The Star Casino to report any deaths that occur at the Casino, whether suspected suicides or otherwise, to the Independent Liquor and Gaming Authority.
  - However, Government inspectors at the Casino have access to detailed internal reports prepared by The Star, which would ordinarily include reference to deaths that occur at the Casino and the broader Casino precinct.
- (2) The Star's internal reports provided to the Independent Liquor and Gaming Authority make no reference to any deaths, suspected suicide or otherwise, occurring at the casino in 2009, 2010 or 2011
- \*1998 PUBLIC HOSPITAL DENTAL CARE SERVICE DELIVERY—Dr Andrew McDonald asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

With regards to public hospital dental care service delivery:

- (1) Which areas are the responsibility of the Minister for Health?
- (2) Which areas are the responsibility of the Minister for Healthy Lifestyles?

#### Answer-

The Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales is responsible for the service delivery of public hospital dental care services.

- \*1999 AUSTRALIAN VACCINATION NETWORK FUNDRAISING—Dr Andrew McDonald asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the Arts—
  - (1) Why has the Minister reinstated authority for charitable fundraising for the Australian Vaccination Network?
  - (2) Have other reasons for declining such an authority, such as alleged fraud, been taken into account during his considerations to reinstate this charitable fundraising authority?
  - (3) Given the questionable nature of the aims of this organisation, does the Minister have plans to further review their authority for charitable fundraising?

### Answer-

(1) The Office of Liquor, Gaming and Racing received legal advice that as a result of related legal developments the revocation of the Australian Vaccination Network's charitable fundraising authority cannot be sustained.

In 2010 the then Minister for Gaming and Racing revoked the Australian Vaccination Network's previous charitable fundraising authority. The revocation was based substantially on a public warning issued by the Health Care Complaints Commission that it "posed a risk to public health and safety" for failing to publish a recommended disclaimer on its website. Earlier this year the Australian Vaccination Network successfully challenged the public warning in the Supreme Court.

An investigation by the Office of Liquor, Gaming and Racing in 2010 also detected some compliance issues in regard to charitable fundraising laws. The organisation took immediate action to rectify these breaches.

The Network also lodged an application in the Administrative Decisions Tribunal challenging the revocation of its charitable fundraising authority. On 18 April 2012 the application was dismissed by consent. The organisation's charitable fundraising authority had expired on 1 June 2011.

- (2) The Office of Liquor, Gaming and Racing issued the Australian Vaccination Network a new charitable fundraising authority after assessing a fresh application on its merits in accordance with applicable laws.
- (3) OLGR has a role in monitoring AVN fundraising activities to ensure compliance.
- \*2000 MENTAL HEALTH BEDS AT CAMPBELLTOWN HOSPITAL—Dr Andrew McDonald asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

With regards to the Minister's statement about the need for more mental health beds at Campbelltown Hospital (Macarthur Chronicle 16 April 2012):

- (1) What planning is underway to expand mental health services?
- (2) What funding enhancement is planned?
- (3) How many more beds are required?
- (4) When will the plans be released?
- (5) When did the Minister last visit:
  - (a) Waratah House:
  - (b) Gna Ka Lun Adolescent Mental Health Unit?

#### Answer-

- (1) to (4) The South West Sydney Local Health District, in partnership with Health Infrastructure, has been actively planning for an enhanced Mental Health Precinct at Campbelltown Hospital. The scope and capital funding requirements will be considered following the completion of planning later this year.
- (5) I will be visiting Waratah House and GnaKaLun Adolescent Mental Health Unit in 2012 as part of my regular schedule of meetings with mental health service staff across NSW.
- \*2001 PLANNED MENTAL HEALTH UNIT—SHOALHAVEN HOSPITAL SITE—Dr Andrew McDonald asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

With regards to the planned Mental Health Unit on the Shoalhaven Hospital site:

- (1) When will construction start?
- (2) What is the total cost?

#### I am advised:

- (1) Construction is scheduled to begin late 2012.
- (2) The project funding is \$10.6 million through the COAG National Health and Hospital Reform Funding program.
- (3) The project will deliver 20 sub acute mental health beds.
- (4) The facility is scheduled to be open in early 2014.
- (5) I will be visiting the Shoalhaven Hospital site in 2012 as part of my regular schedule of meetings with mental health service staff across NSW.
- \*2002 COAL SEAM GAS MINING—HEALTH EFFECTS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
  - (1) What investigations have been carried out by NSW Health with regards to the possible population health effects of coal seam gas (CSG) mining?
  - (2) What studies are planned?
  - (3) In future, will NSW Health provide submissions into the possible health effects of CSG mining, when they are called for as part of the development application process for new exploration or mining leases?

#### Answer-

I am advised:

- (1) to (3) NSW Health is a member of an inter-departmental working group currently assessing a range of issues associated with coal seam gas. NSW Health will provide submissions to Department of Planning and Infrastructure into possible health effects of Coal Seam Gas mining during the development application process for new explorations or mining leases.
- \*2003 GUNNING WATER SUPPLY—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
  - (1) What investigations have been undertaken by NSW Health into the safety of the water supply at Gunning?
  - (2) How are water borne infections in the Gunning area monitored by NSW Health?
  - (3) Have there been any notifications of Giardia or Cryptospiridium in the area around Gunning in the 12 months from April 2011 to April 2012?
  - (4) Has there been an increase in any notifications of other diseases that may be attributable to contamination of the water supply?
  - (5) Are studies by NSW Health of the health of the people of Gunning planned because of their concerns about the safety of their water supply?

Answer—

I am advised:

- (1) Weekly bacteriological samples have not indicated the presence of Escherichia coli in the reticulated water and chlorine levels have been within normal range. Chemical analysis was conducted on the reticulated water. The results of water testing do not indicate a bacteriological threat to human health.
- (2) Water borne infections are monitored via the provision in the Public Health Act 1991 which specifies a range of diseases that are notifiable upon diagnosis, to the Public Health Unit. These diseases include giardiasis and cryptosporidiosis.
- (3) No.
- (4) No.
- (5) NSW Health has supported the Upper Lachlan Shire Council to undertake weekly monitoring of water quality for a period of three months. Results will be available to both NSW Health and the Upper Lachlan Shire Council. Ongoing monitoring of disease notifications will occur. A boil water alert was issued as a precaution, following flooding in the Lachlan River.
- \*2004 MOOREBANK INTERMODAL TERMINAL—HEALTH EFFECTS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
  - (1) What investigations have been carried out by NSW Health with regards to the health effects of the planned Intermodal Terminal at Moorebank?
  - (2) Are any future studies planned?
  - (3) Will NSW Health be making submissions to the environmental review as part of the approval process for this terminal, specifically in regards to concerns about air quality and noise pollution?

Answer-

I am advised:

- (1) to (3) As part of the normal planning process, NSW Health has received the Environmental Assessments in relation to the planned Intermodal Terminal development at Moorebank for review and comment. NSW Health will be making submissions to the environmental review as part of the associated approval process, specifically in regards to concerns about air quality and noise pollution.
- \*2005 HOUSING NSW MAINTENANCE ISSUES—Ms Tania Mihailuk asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
  - (1) How many outstanding Housing NSW maintenance issues are there in the electorate of Bankstown?
  - (2) What is the average waiting period for Housing NSW to address maintenance issues?

Answer—

- (1) As at 10 May 2012, 226 work orders were outstanding.
- (2) The waiting period for maintenance work is prioritised by assessing urgency or risk. The large majority of works orders are completed within contracted timeframes, which are as follows:

Urgent - 4 hours

Priority 1 - 24 hours

Priority 2 - 48 hours

Priority 3 - 72 hours

Responsive Work - 20 days

- \*2007 COST TO RECONSTRUCT HEADLAND AND COVES AT BARANGAROO—Mr Jamie Parker asked the Premier, and Minister for Western Sydney—
  - (1) What is the current estimate of the cost to reconstruct the headland and coves and to partially demolish the seawall at Barangaroo?
  - (2) (a) Are the coves and the area between the seawall and the headland defined as public space?
    - (b) If not, how are these areas defined?

    - (b) If so, how will this be managed?
  - (4) (a) Are the previously designed deep water coves now shallow ornamental concrete ponds inaccessible to leisure to boats?

- (1) The Headland Park budget will be published on 12 June in the State Budget.

- (3) The Northern Cove will accommodate small craft and water taxis at all times and larger craft subject to tidal conditions.
- (4) No.
- (5) The total public space at Barangaroo, excluding water, is 13.13 hectares.
- (6) Approximately 62 percent.
- (7) (a) The first two buildings at Barangaroo South, the Headland Park and waterfront promenade will open in 2015.
  - (b) N/A.
- \*2008 PAYMENTS TO SYDNEY HARBOUR FORESHORE AUTHORITY—Mr Jamie Parker asked the Treasurer—
  - (1) How much was paid by Lend Lease to Sydney Harbour Foreshore Authority as an upfront one-off fee for the 99-year lease of Darling Quarter?
  - (2) What are the annual land lease fees payable this financial year for the car park, bus terminus and the offices at the Macquarie Bank site?
  - (3) What amount was paid by the developer for the 99-year lease of the KPMG site?

#### Answer—

- (1) This question would be more appropriately directed to the Minister for Planning and Infrastructure, the Hon Brad Hazzard MP.
- (2) and (3) These questions would be more appropriately directed to the Minister for Roads and Ports, the Hon Duncan Gay MLC.
- \*2009 COMMUTER CRIME UNIT—Mr Guy Zangari asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

In relation to the Government's plan to abolish Railcorp Transit Officers, when will all 300 police officers earmarked for the Commuter Crime Unit be activated?

Answer-

I am advised:

The new Police Transport Command commenced operations on 2 May 2012 with 301 officers from local community crime units. The Command will increase its numbers until its target authorised strength of 610 officers is reached by December 2014.

The Police Transport Command is committed to promoting safety and reducing crime on the NSW transport network.

\*2010 VISIONCARE PROGRAM—Mr Guy Zangari asked the Minister for Family and Community Services, and Minister for Women—

How many people living in the electorate of Fairfield were provided with glasses under the VisionCare program in the 2010-11 period?

Answer—

People living in the Fairfield electorate were provided with more than 5,000 optical appliances in 2010-2011.

- \*2011 ASSAULTS ON STAFF AT CUMBERLAND HOSPITAL—Mr Richard Amery asked the Minister for Health, and Minister for Medical Research—
  - (1) How many staff members of the Cumberland Hospital Parramatta have been assaulted requiring medical attention during the 12-month period ending 30 April 2012?
  - (2) Of this number, how many were:
    - (a) medical/nursing staff;
    - (b) security guards;
    - (c) other staff?
  - (3) Of the staff mentioned above, how many required hospitalisation?

Answer-

I am advised:

(1) to (3) NSW Health has zero tolerance to any form of violence towards staff.

In the data provided by the LHD, 36 staff required medical treatment which includes "first-aid". This may include actions such as supplying a band-aid where a staff member was scratched during a restraint procedure. Of the 36 staff, 29 were medical/nursing staff, 5 were security guards and 2 were other staff. One staff member required hospitalisation.

- \*2012 CRIMINAL INFRINGEMENT NOTICES ISSUED—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
  - (1) How many Criminal Infringement Notices have been issued to repeat offenders since they were introduced?
  - (2) How many Criminal Infringement Notices can police issue a person before a summons is issued for that person to appear before a court?
  - (3) What action is the Minister for Police taking to ensure that repeat offenders of minor criminal offences are not repeatedly issued with Criminal Infringement Notices?

Answer—

The NSW Police Force has advised me:

- (1) The COPS database is operational, not statistical, and is not configured to provide an answer to this question.
- (2) and (3) Standard Operating Procedures and training material give guidance to NSW Police Force officers in relation to when it is appropriate for a Criminal Infringement Notice to be issued. Police officers consider the circumstances of each particular case and take into consideration a number of factors, such as the individual's criminal record and the nature of the offence.
- \*2013 UNPAID FINES FOR CRIMINAL INFRINGEMENT NOTICES—Ms Sonia Hornery asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
  - In relation to unpaid fines for Criminal Infringement Notices of minor offences, including stealing, that are referred to the State Debt Recovery Office:
  - (1) How many Criminal Infringement Notices are on record as being unpaid in the past twelve months?

- (2) How many Criminal Infringement Notices are on record as being unpaid since this system was introduced?
- (3) What is the total of unpaid fines for Criminal Infringement Notices?

#### Answer—

A pilot of the Criminal Infringement Notices scheme was introduced in September 2002. The scheme was expanded state-wide in November 2007. As at 4 May 2012:

- (2) 16,066
- (3) \$3,584,550.

#### \*2014 INNER CITY CHILDCARE—Ms Clover Moore asked the Minister for Education—

With respect to inner city childcare and noting dramatic increases in the number of families with babies and small children in the inner city:

- (1) What data does the Government have about current and predicted numbers of children in the inner city?
- (2) What data does the Government have about current and predicted childcare demand for:
  - (a) long day care for 0-2 year olds;
  - (b) long day care for 2-3 year olds;
  - (c) long day care for 3 year olds up to school age children?
- (3) How does the Government assess childcare needs for individual localities across the inner city and what does this assessment show about local childcare needs?
- (4) What plans does the Government have to provide or support increased childcare services for under 2 year olds in the inner city?
- (5) What plans does the Government have to provide or support childcare services for under 2-3 year olds in the inner city?
- (6) What plans does the Government have to provide or support childcare services for under over 3 year olds in the inner city?

#### Answer—

The funding, planning and provision of child care are predominantly responsibilities of the Commonwealth Government.

The NSW Government does not have responsibility for regulating or determining the supply of child care places. The primary role of the NSW Government is to grant approval to operate these services and to ensure that services comply with the relevant legislation.

\*2015 HOUSING PATHWAYS EVALUATION—Ms Clover Moore asked the Minister for Family and Community Services, and Minister for Women—

Noting the streamlined Housing Pathways scheme for all social housing applications:

- (1) What evaluation has the Government made of the Housing Pathways scheme since its introduction in July 2010?
- (2) What benefits and weaknesses of Housing Pathways have been identified?
- (3) What impact has Housing Pathways had on assessments and allocations?
- (4) What is the average time for assessment of housing applications?
- (5) How many housing applications are waiting to be processed for applications in the inner city?
- (6) Is the waiting time increasing or decreasing?
- (7) What action has the Government taken to reduce waiting times for processing applications?
- (8) What further action will the Government take to reduce waiting times for processing social housing applications?

#### Answer\_

(1) to (3) A post implementation review was undertaken in late 2010 and an evaluation will be undertaken in 2012.

- (4) to (6) When an application is received under Housing Pathways, an immediate initial assessment is undertaken to determine whether the person applying is in need of immediate temporary accommodation. The time taken to fully assess an application is determined by the complexity of the case and whether supporting documentation has been submitted or further information is required.
- (7) and (8) Housing NSW has an ongoing program to review and improve all client related processes.
- \*2018 HARRIS STREET ULTIMO—Ms Clover Moore asked the Minister for Transport representing the Minister for Roads and Ports—

Noting residents' repeated reports about pedestrian safety risks, poor road surface, large volumes of fast-moving through traffic and the recent tragic death of a small child:

- (1) What assessment has the Government made of traffic noise, speed and safety risks in Harris Street Ultimo between Broadway and Union Street?
- (2) What is the accident record over the past five years for Harris Street between Broadway and Miller Street, and what are the trends in accidents?
- (3) What action has been taken to encourage through traffic to use the Western Distributor rather than Harris Street?
- (4) What assessment has the Government made of speed cameras, protective barriers or other measures to improve pedestrian safety?
- (5) What assessment has been made of the road surface in Harris Street Ultimo, when does the Government plan to resurface this road and will low noise road surface be used?
- (6) What other action does the Government plan to improve pedestrian safety, reduce through traffic, and reduce traffic speed and noise?

#### Answer-

#### I am advised:

- (1) The permanent speed limit for Harris Street, Ultimo is 50 km/h.
  - The City of Sydney Council has an RMS approved proposal to convert Quarry Street from one way to two way traffic flow. The council has indicated that the project is not in the current program of works and will not occur for some time. In light of this, RMS is investigating the provision of a right turn arrow at this intersection to improve safety for pedestrians crossing Harris Street.
- (2) There were 203 crashes, with one fatality, over the finalised period of 2006 to 2010.
  - Crashes involving pedestrians made up 14.3 per cent of the total crashes. This is higher than the Sydney region total of 5.5 per cent for the same period. Crashes involving speeding made up 3.9 per cent of the total crashes. This is lower than the Sydney Region total of 11.7 per cent for the same period.
  - Intersection crashes made up 84.2 per cent of the total crashes, which is higher than the Sydney region total of 52.8 per cent for the same period.
  - 40.4 per cent were night time crashes, which is higher than the Sydney region total of 26 per cent for the same period.
- (3) Harris Street is an important north south route linking Pyrmont to South Sydney and, along with the Western Distributor, forms part of the state road network. The Western Distributor runs in an east-west direction and it would not be practical to travel along the Western Distributor from the South Sydney area to Pyrmont.
- \*2019 NOISY VEHICLES—Ms Clover Moore asked the Minister for the Environment, and Minister for Heritage—

Noting that the Environment Protection Authority is primarily responsible for noisy vehicle enforcement and that there are ongoing problems from noisy vehicles impacts in many places including Bondi, Botany, Coffs Harbour, Dubbo, Grafton, Liverpool, Newcastle, Penrith, St Marys, Wagga Wagga and Wollongong, as well as inner city areas such as Kings Cross, Potts Point and Woolloomooloo:

- (1) What data does the Government keep on reports and complaints about noisy vehicles and the action taken?
- (2) What trends does this data show about noisy vehicles for the inner city and across NSW?
- (3) What action has been taken to develop a statewide response that would prevent these impacts?
- (4) What action has been taken to develop a statewide response that would focus enforcement action to increase effectiveness?
- (5) What action has the Government taken with other States and Territories and the Commonwealth Government to address these concerns?

(6) What further action will the Government take to address these problems at a statewide level?

Answer-

I am advised:

The EPA conducts a state wide compliance and assurance program, in line with Federal government standards including the Australian Design Rules (ADR). The EPA also conducts a Noise Testing and Anti-Tampering Inspection Scheme to identify noisy vehicles.

The EPA works with NSW Police to focus enforcement action in areas where noisy vehicles are impacting on local amenity. The EPA also provides training to council officers to enable them to identify and report noisy vehicles to the EPA for regulatory follow-up.

The EPA works with Roads and Maritime Services to identify opportunities to increase the number of officers reporting noisy vehicles in areas where noisy vehicles are impacting on local amenity.

Data generated through noisy vehicle reports and complaints, the results of EPA noise testing and inspections and other regulatory action, indicates that the number of reports received relating to noisy vehicles has been decreasing both within the City of Sydney LGA and outside the Sydney metropolitan area.

\*2020 OXFORD STREET—Ms Clover Moore asked the Minister for Primary Industries, and Minister for Small Business—

Noting the vital role of small businesses in the economy and employment, long-term decline of high street shopping, impacts of the global financial crisis, and ongoing concern about regional traffic impacts in Oxford Street Darlinghurst and Paddington:

- (1) What practical support has the NSW Government provided for small businesses in Oxford Street?
- (2) What financial support has the NSW Government provided for small businesses in Oxford Street?
- (3) What programs does the NSW Government provide to help small businesses in high street shopping streets?
- (4) What practical and financial support does the Government provide for business associations to help them promote and develop their precincts?
- (5) What practical and financial support has the Government provided for the Paddington Business Partnership, the 2010 Business Partnership and the Three Saints Square Project Group to support small businesses?
- (6) What further action will the Government take to support small businesses in Oxford Street?

#### Answer—

In 2011 and 2012, the NSW Small Business Commissioner assisted Oxford Street retailers to address their concerns about the impact that infrastructure work along the street, which was threatening to interrupt their business during the peak Christmas trading period. The Commissioner attended a number of group meetings with Oxford Street traders to find a way forward and then arranged a meeting with the organisation carrying out the upgrade works and obtained an agreement to cease works in October and delay further works until February, allowing an unimpeded Christmas trading period. In February 2012 the Commissioner brokered an agreement for the infrastructure works to be conducted in less disruptive manner.

The NSW Government also provides a range of practical support services such as the business advisory service and the NSW small business website. The Office of the Small Business Commissioner provides low cost dispute resolution and mediation services for small businesses and for retail lease matters. The Office also has an assistance phone line (1300 795 534) to help small businesses work through disputes and issues associated with unfair market practices. The Commissioner advocates on behalf of small businesses subjected to unfair market practices in their dealings with other businesses and government agencies or local councils.

The Small Business Commissioner met multiple times with the Paddington Business Partnership to discuss the impact of infrastructure work in the precinct and assist them to progress their business precinct development plans.

The Small Business Commissioner has undertaken a review of programs and services offered to small businesses to ensure that support offered is practical and relevant to the needs of the sector.

- \*2021 COMPENSATION FOR INJURED WORKERS—Mr Ryan Park asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
  - (1) (a) Is the Government going to cap the period of compensation for injured workers?

- (b) If yes, what are the details about this cap?
- (2) (a) Is the Government going to reduce the payments available to injured workers?
  - (b) If so, by how much?

#### Answer-

The New South Wales Government has released an Issues Paper detailing some of the Workers Compensation Scheme's failings when compared to its key aims, and outlines options for consideration. The Government has also established a Parliamentary Inquiry into the New South Wales Workers Compensation Scheme. The Joint Selection Committee will inquire and report on:

- the performance of the Scheme in the key objectives of promoting better health and return to work outcomes for injured workers;
- the financial sustainability of the Scheme and its impact on the New South Wales economy, current and future jobs in New South Wales and the State's competitiveness; and
- the functions and operations of the WorkCover Authority.

The Issues Paper is available on the WorkCover website www.workcover.nsw.gov.au. The Parliamentary Inquiry is due to complete its report on 13 June 2012.

- \*2022 FITTING OF SPRINKLERS TO AGED CARE HOMES—Mr Ryan Park asked the Minister for Ageing, and Minister for Disability Services—
  - (1) What plans does the Government have to introduce requirements for aged care homes to be equipped with sprinklers?
  - (2) What is the time frame for implementing these plans?
  - (3) Will there be assistance and support provided to local organisations who provide aged care accommodation?

#### Answer—

These issues relate to the administration of the Minister for Planning and Infrastructure.

- \*2024 ROLE OF TEACHER LIBRARIANS—Mr Ryan Park asked the Minister for Education—
  - (1) Is the Government participating in a dialogue through Ministerial Council for Education, Early Childhood Development and Youth Affairs (MCEECDYA) regarding:
    - (a) the role of teacher librarians in schools today and into the future;
    - (b) ways to improve the partnerships to provide better support to school libraries and teacher librarians?
  - (2) If so, what are the outcomes of such discussions?

#### Answer-

- (1) No. The Commonwealth Minister has not yet raised these issues formally on the agenda for Ministerial Council for Education, Early Childhood Development and Youth Affairs.
- (2) Not applicable.
- \*2025 STAFFING OF SCHOOL LIBRARIES WITH PROFESSIONAL TEACHER LIBRARIANS—Mr Ryan Park asked the Minister for Education—
  - (1) Will the Government support the continued core staffing of school libraries with professional teacher librarians outside of the establishment formula?
  - (2) Will there be any impact to specialist teaching staff, such as teacher librarian, in NSW schools under the proposed Local Schools Local Decisions policy?

#### Answer-

- (1) There are no changes to the status of teacher librarians or other specialist teaching staff under the Local Schools, Local Decisions reforms. All teachers, executive and principals in permanent positions will retain tenure.
- (2) Schools will be funded directly by a Resource Allocation Model which will reflect school complexity as well as student numbers. This budget will separate staffing and non-staffing funding. Schools will not be able to use staffing funding for non-staffing purposes.
  - Should a vacancy occur, the principal, in consultation with staff and the community, will choose the number and roles of staff to best meet local needs.
- \*2026 MEMORIAL DRIVE—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—

In relation to the final stage of Memorial Drive:

- (1) Has the Government made any property acquisitions to enable a future road to be built?
- (2) (a) Is any planning underway for this project?
  - (b) If so, what stage is this planning up to?

#### Answer-

#### I am advised:

- (1) Since the mid 1950s, the NSW Government has acquired a substantial part of the corridor. In recent years, more land was acquired by the former Roads and Traffic Authority (RTA) before proposed residential development was about to occur.
  - The RTA acquired the whole Old Bulli Mine site from Multiplex Bulli Pty Ltd in 2010 to provide land for the future road to travel up towards the Illawarra Escarpment. In December 2011, Roads and Maritime Services also acquired some strips of land from the Old Bulli Tile and Brick factory site to widen the corridor.
- (2) (a) Two potential corridors for the extension of Memorial Drive toward and along Bulli Pass have been gazetted in Wollongong City Council's Local Environmental Plan. The future road corridor is shown zoned as SP2 Road Infrastructure on the Wollongong Local Environmental Plan 2009.

There are no current plans to commence studies examining the potential extension of Memorial Drive.

- (b) No planning is currently underway for this project.
- \*2027 DENTAL HEALTH TASKFORCE REPORT—Mr Ryan Park asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—
  - (1) When will the Government release the NSW Ministerial Dental Health Taskforce report and the Government's response?
  - (2) Will the Government increase funding to the levels proposed by the National Council of Social Service of NSW to ensure that those who are most disadvantaged have access to adequate dental health care?

## Answer—

- (1) I refer the member to my response to the Member for Liverpool's Written Question No. 1741 in the Legislative Assembly of 17 April 2012.
- (2) The Government is examining the implications of the Federal Budget on dental services in NSW.
- \*2029 BARANGAROO DELIVERY AUTHORITY—VALUE SHARING PAYMENTS—Mr Jamie Parker asked the Premier, and Minister for Western Sydney—
  - (1) What is the updated cost forecast for the headland park at Barangaroo?
  - (2) What is the estimated revenue that the Barangaroo Delivery Authority will receive as value sharing payments for the Barangaroo development?
  - (3) How is the Barangaroo Delivery Authority calculating value sharing payments?
  - (4) What is the current real value of the value sharing payments?
  - (5) What payments is the Barangaroo Delivery Authority budgeting to receive after 31 March 2018?

#### Answer-

#### I am advised:

- (1) The Headland Park budget will be published on 12 June in the State Budget.
- (2) The total revenue including fixed value, value payments and other revenue forecast is estimated at \$1 billion.

There are no speed cameras installed on the Balmain peninsula which is currently zoned at 40 km/h. There have been a number of traffic calming treatments installed to support this speed limit.

The Auditor-General's review of speed cameras recommended that an overarching speed camera strategy be developed that identifies the most suitable camera type to address the crash risk at a location.

I announced the NSW Government's speed camera strategy on 1 June. Roads across NSW, including in Balmain, will be assessed for the suitability of speed camera enforcement based on the speed camera criteria in the strategy. As part of the speed camera strategy the community is invited to nominate locations for speed cameras through the safer roads website.

- \*2034 SPEEDING INFRINGEMENT NOTICES ISSUED—Mr Jamie Parker asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

- \*2035 LOW SOCIO-ECONOMIC STATUS SCHOOL COMMUNITIES NATIONAL PARTNERSHIP—Mrs Barbara Perry asked the Minister for Education—
  - (1) Given that under the Low Socio-economic Status School Communities National Partnership the Federal Government's investment of \$437 million to support schools in disadvantaged communities was matched by the former NSW Government with \$175 million of State funding, is the Minister aware that schools benefiting under the NSW Government's share of the National Partnership do not yet have certainty about whether the investment in their schools will be continued?
  - (2) What have been the benefits at Auburn North Public School of the investment by the former NSW Government in the Low Socio-economic School Communities National Partnership?

#### Answer-

- (1) All Low Socio-economic Status School Communities National Partnership schools are funded by a combination of State and Commonwealth dollars.
  - The Gonski Review recommends that a baseline level of funding become the resource standard and that "the Australian Government should roll in, to the maximum possible extent, all general recurrent funding for schools as well as targeted funding programs for non-government schools and National Partnerships". The NSW Government strongly supports this recommendation.
  - If it is not accepted, this Government will continue to argue for a sustained and credible mechanism to provide additional funding to Australia's most disadvantaged school communities.
- (2) Initiatives that Auburn North Public School has implemented with National Partnership funding will have sustainable benefits for students, including improved student learning outcomes, enhanced teacher practice and increased parent participation in the learning development of their children.
  - Auburn North Public School will sustain its achievements through its enhanced school leadership, in combination with significant ongoing Department of Education and Communities funding through equity programs such as the Priority Schools Program.

## \*2044 SCHOOL BUDGETS-Mr Clayton Barr asked the Minister for Education-

With regard to individual school budgets:

- (1) What line items typically make up a budget?
- (2) Which of these are "fixed" costs?

## Answer-

(1) School budgets include amounts funded from school and community sources as well as global budget and tied funds allocated centrally by the Department of Education and Communities. These funds are used by schools to meet recurrent expenditure on items such as:

The budget allocation for the Spectacles Program was overspent consistently and unsustainably under the previous Government. As a result approximately \$3.2 million was not available for other Community Services clients, including vulnerable children and young people, between 2007-2008 and 2010-2011.

The Government made the right decision to hold the program to budget in 2011-2012 and reform the contract when it comes due in 2012. The overspend in 2011-2012, still building, reflects the Vision Care administration fee still payable under the terms of the contract approved by the previous Government, despite services being put on hold in February 2012.

\*2047 SECURITY FOR AMBULANCE OFFICERS—Mr Clayton Barr asked the Minister for Health, and Minister for Medical Research—

What strategies are being put into place to ensure greater security and safety for ambulance officers?

Answer-

I am advised:

The Ambulance Service of NSW has a zero tolerance to any form of violence towards Paramedics and will refer offenders to Police.

It is Ambulance Service procedure to contact Police when there is a threat or potential threat to the safety of Paramedics. The Service has an automated system in place where a warning about known hazards, such as chemicals or potential violence can be relayed to responding crews. In the most serious cases, Ambulance crews are advised to "stand off" and await the arrival of Police.

Ambulance vehicle radios and portable radios carried by Paramedics for when they leave the vehicle have a "duress button" that when activated alerts the Control Centre of a crew or Paramedic in danger. The Control Centres then alert the Police and other crews to provide assistance.

A training program is in place for Ambulance Paramedics to assist them in dealing with potentially volatile client situations and to enable them to minimise the risk of assault. The program, Violence Prevention and Safe Practices in High Risk Environments is part of the occupational health and safety education program for all Ambulance Paramedics.

Following amendments to the Health Services Act 1997 in June 2010, new offences were created to provide better protection to paramedics and their patients. Under this legislation, it is an offence to intentionally obstruct or hinder an ambulance paramedic who is providing services to a person, which attracts a maximum penalty of two years imprisonment. A more serious level of offence of intentionally obstructing or hindering a paramedic by an act of violence attracts a maximum penalty of five years imprisonment.

I am advised:

(1) Through its Diversity Services Unit, the Attorney General's Division of the Department of Attorney General and Justice (DAGJ) operates a community engagement program to enhance DAGJ's cultural competence and CALD communities' understanding of the justice system. It employs Community

Liaison Officers for the Vietnamese, Chinese, Pacific and African communities and is currently recruiting an officer for the Iraqi community. In the past few years the Division has:

- provided community information sessions
- developed a court support program
- held open days at court
- translated brochures into community languages (a full list is available on the department's website)
- · provided alternative dispute resolution training
- produced a DVD on the law "The law and you, legal information for African communities in NSW".

Juvenile Justice has two funded CALD programs for young people. One delivers services to young people from Pacific communities through Relationships Australia. The other is Anglicare's Post Release Support Program, which is directed at young people from diverse cultural backgrounds. Juvenile Justice also has six identified multicultural positions within its community offices.

CSNSW provides a range of programs to CALD offenders. This includes certificate courses to CALD students through the Adult Education and Vocational Training Institute (AEVTI) to improve their English skills. For community based CALD offenders CSNSW offers the Pacific Islander Readiness Program, the Transitions Project (a post-release program for Vietnamese offenders), the Getting SMART (Self Management and Recovery Training) Program for Vietnamese community based offenders and the SMART Recovery Program for Vietnamese offenders in custody and the community.

The Department provides for the cost of on-site and telephone interpreter services, as required across all divisions. Bi-lingual and multi-lingual staff members who are paid CLAS allowance also provide assistance to CALD clients.

(2) and (3) The cost of all DAGJ CALD programs are not separately identified in the budget, however, estimated costs are as follows:

## Answer—

(1) The NSW Department of Education and Communities provides a range of programs to assist clients from culturally and linguistically diverse communities to access and more equitably participate in Department programs at school and TAFE.

In NSW government schools, these programs include English as a Second Language (ESL) education in primary schools, secondary schools and Intensive English Centres to support the English language learning of ESL students, including newly arrived students and students in rural and regional areas.

They also include refugee student support programs to address the settlement, English language, literacy and numeracy needs of refugee students.

In addition, a range of Community Languages programs assist students to maintain their background or heritage languages.

Community relations and parent support programs are implemented to encourage the participation of parents and community members from culturally and linguistically diverse backgrounds in school

activities and decision making, and to support their children's learning. These programs include interpreting and translation services to facilitate access to information about the Department's services.

Anti-Racism and Multicultural Education programs are implemented to develop all students' and teachers' understanding of cultural diversity, discrimination and racism and skills in recognising and countering prejudice and racism in the learning environment.

Links to Learning programs assist students from culturally and linguistically diverse backgrounds at risk of disengaging from education and training to access accredited training and/or further education.

TAFE NSW enrols individuals from a non-English speaking and culturally diverse background in all TAFE NSW programs.

- (2) The value of these programs in government schools for the 2011-2012 financial year is:
  - \$136 million for the provision of specialist English as a Second Language Education teachers in primary and secondary schools and Intensive English Centres
  - \$4.56 million to support refugee support programs, anti-racism and multicultural education and strategies to foster community harmony and positive community relations with culturally and linguistically diverse communities
  - \$884,000 for Links to Learning programs to assist students from culturally and linguistically diverse backgrounds to access accredited training and/or further education
  - approximately \$3.6 million for Community Languages programs
  - \$505,034 to support the use of interpreters in schools (July 2011 to 15 May 2012).

TAFE NSW enrolments are reported on a calendar year basis. In 2011, there were 127,196 (23%) enrolments by students from language backgrounds other than English, at an overall value of \$395,956,000.

  - \$133 million for the provision of specialist English as a Second Language Education teachers in primary and secondary schools and Intensive English Centres
  - \$4.6 million to support refugee support programs, anti-racism and multicultural education and strategies to foster positive community relations and links with culturally and linguistically diverse communities
  - \$884,000 for Links to Learning programs to assist students from culturally and linguistically diverse backgrounds to access accredited training and/or further education
  - approximately \$2.2 million for Community Languages programs
  - approximately \$637,000 to support the use of interpreters in schools.

The value of these programs in government schools for the 2009-2010 financial year was:

- \$124 million for the provision of specialist English as a Second Language Education teachers in primary and secondary schools and Intensive English Centres
- \$4.6 million to support refugee support programs, anti-racism and multicultural education and strategies to foster positive community relations and links with culturally and linguistically diverse communities.
- \$860,666 for Links to Learning programs to assist students from culturally and linguistically diverse backgrounds to access accredited training and/or further education
- Approximately \$2 million for Community Languages programs
- Approximately \$633,000 to support the use of interpreters in schools.

In the 2010 calendar year there were 130,175 (23.4%) enrolments by students from language backgrounds other than English in TAFE NSW at an overall value of \$400,249,000.

  - maximises the financial return for the State
  - minimises ongoing financial risks and liabilities for the State
  - reduces and if possible eliminates any potential conflicts of interest caused by the Government being both owner and regulator of the Port Botany facility
  - treats public sector employees fairly and equitably
  - ensures that any activities that remain with the public sector (commercial and non-commercial) are managed in an efficient manner
  - would complete the Project efficiently and in accordance with appropriate probity and accountability standards.
- (3) The scoping and strategy study is due to be completed in June 2012.
- (4) The scoping and strategy study is a Cabinet document and contains commercially sensitive information so it will not be publicly released in full.
- (5) The study is not yet complete so the cost is indeterminate at this stage.
- (6) The Government's indicative timeline to complete the lease is the middle of 2013.
- \*2080 NEWCASTLE RAIL LINE—Ms Sonia Hornery asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW—

Given the comments by Infrastructure NSW chairman Nick Greiner in the Newcastle Herald on 3 May 2012, how is the retention of the rail line holding back development in Newcastle city?

I note the contribution of the Australia 21 roundtable to the national debate on drug use. My Department will continue to closely monitor any developments arising from this debate. These developments inform the NSW response to illicit drugs.

The Government is aware of the strong link between illicit drug use and crime and has made a number of commitments to measures aimed at reducing recidivism of drug offenders. These include increasing the availability of and access to diversionary programs and creating the Intensive Drug and Alcohol Treatment Program, a dedicated program for incarcerated offenders (other than sex offenders) convicted of drug related crimes. The Government is also providing additional funding for drug and alcohol rehabilitation programs in prisons to help people end their addiction.

There are currently a number of innovative court-based programs available in NSW designed to discourage reoffending by addressing drug use problems. These include the Magistrates Early Referral Into Treatment (MERIT) program, the Court Referral of Eligible Defendants Into Treatment (CREDIT) program (currently being trialled at Tamworth and Burwood Local Courts) and the NSW Drug Court.

(1) to (5) The subject room was closed on the evening of 15 April 2012 after a VRE (Vancomycin resistant enterococcus) patient was discharged. It is standard practice in the hospital that once a room that has contained a VRE patient has been cleaned it is swabbed to ensure that the cleaning was effective and that VRE is no longer present in the environment.

Testing takes a minimum of two days, and may take up to one week depending on the test results and the need for additional treatment and testing. A room is vacant for this time to ensure that other patients are not exposed to VRE.

The room was reopened for general use on 19 April 2012 after consultation with Infection Control. There were no delays in having this room cleaned.

Because of the nature of the job, taxi drivers are warned in their training to always be alert to the presence of cyclists.

The Roads and Maritime Services (RMS) provides public information on safe cycling in brochures such as Safe Riding - A Guide to Safe Cycling and What the Law Says and Safety Advice for Bicycles, Rollerblades, Scooters and Skateboards. These publications are available in motor registries and via the RMS's website.

The RMS's Road Users' Handbook includes driver education information relating to cyclists to raise driver awareness of cyclists and their needs. In addition, the RMS has produced a brochure, Sharing the Road, advising all road users of their responsibility to obey the road rules and to share the road with other road users.

To further increase driver awareness, the message "Watch for Cyclists - The Road is there to Share" is displayed on electronic variable message signs across Sydneyto remind motorists of the presence of cyclists.

Funding is also being provided under the Boarding House Financial Assistance (BHFA) program to support the delivery of new generation boarding house rooms which provide low cost rental accommodation. In addition, financial assistance is provided through the Rentstart scheme for eligible applicants to access the private rental market by providing assistance in meeting rental bonds and advance rent payments.

- (3) Under the NRAS and the BHFA program, the NSW Government provides incentives for developers to deliver affordable rental accommodation.

Professional groups such as occupational therapists, physiotherapists, speech pathologists and optometrists screen or assess health and development covered by their respective professional disciplines after a child has been referred.

NSW Early Childhood Health Services and general practitioners provide child health and development checks that include surveillance and screening activities designed to identify children who require a specialist assessment and service, such as occupational therapy, physiotherapy, speech therapy and optometry.

Consistent with current evidence, NSW Health recommends that routine health and development surveillance checks of children occur from birth to age 5. These checks include any age appropriate screening that complies with National Health and Medical Research Council (NHMRC) standards.

Screening tests that meet NHMRC criteria are incorporated into these checks, commencing with newborn blood spot screening for a range of rare disorders, SWISH (Statewide Infant Screening – Hearing) Program at birth, and StEPS (Statewide Eyesight Preschooler Screening) Program at 4 years available statewide to screen the vision of children before they start school.

A child health surveillance and screening program is detailed in the child Personal Health Record given to all NSW parents at the birth of their baby. From 6 months of age, these checks also incorporate the validated parent completed tool the Parent Evaluation of Developmental Status (or PEDS) which has been shown to improve the accuracy of clinical assessments in Australia and overseas.
