*4562 EXTENDED SUPERVISION ORDERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many of the applications made for Extended Supervision Orders since March 2011 relate to:

- (a) Sex offenders;
- (b) Violent offenders?

Answer-

I am advised:

As at 9 October 2013, there have been 15 applications made for Extended Supervision Orders that cover sex offenders and violent offenders under the Crimes (High Risk Offenders) Act 1996 (as it is now known).

*4563 GRAFFITI CONTROL ACT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many orders have been made concerning driving licences or applications for licences under the Graffiti Control Act since amendments were made to the Act in 2012?

Answer-

I am advised:

None.

Police use of the Crimes Act rather than the Graffiti Control Act, has limited the application of these provisions.

The Government is encouraging greater use of the Graffiti Control Act by police through our reforms that are currently being debated in Parliament.

*4564 JOHN PAGET-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

What dealings has the Attorney General had with John Paget since 1 January 2008?

Answer-

I am advised:

I first met Dr Paget at a conference when I was the shadow minister and was impressed with his level of expertise. Dr Paget has volunteered for me in Opposition and has worked as a Corrective Services NSW consultant in my office on a part time basis, and has also worked with Labor governments in NSW, South Australia and the ACT.

- *4565 LIVERPOOL HOSPITAL OPERATING THEATRES—Mr Paul Lynch asked the Minister for Health, and Minister for Medical Research—
 - (1) How many operating theatres are there at Liverpool Hospital?
 - (2) How many of these operating theatres are in use?

Answer-

I am advised:

- (1) Liverpool Hospital has 23 operating theatres.
- (2) Decisions regarding use of specific facilities, such as operating theatres, are matters for the Local Health District and made according to patient demand.
- *4566 LIVERPOOL HOSPITAL ELECTIVE SURGERY—Mr Paul Lynch asked the Minister for Health, and Minister for Medical Research—

How many elective surgery operations were performed at Liverpool Hospital in the period from 1 July 2012 to date?

Answer-

I am advised:

*4567 FINIAN EGAN-Mr Paul Lynch asked the Minister for Fair Trading-

What discussions has the Minister had concerning Finian Egan with the Member for Epping since 1 January 2010?

Answer—

I am not aware of any such discussions.

*4568 LIVERPOOL PUBLIC SCHOOLS VANDALISM-Mr Paul Lynch asked the Minister for Education-

How many incidents of vandalism on public school property within the electorate of Liverpool have been reported since 1 July 2012?

Answer-

Questions regarding the number of incidents of vandalism reported to police should be referred to the Minister for Police.

*4569 MOTOR VEHICLE ACCIDENTS ON THE M5 MOTORWAY—Mr Paul Lynch asked the Minister for Transport representing the Minister for Roads and Ports—

How many motor vehicle accidents were reported on the M5 motorway in the period from 1 July 2012 to date?

Answer—

I am advised:

Roads and Maritime Services reports crashes where one or more people were killed or injured, or at least one vehicle was towed away.

From 1 July 2012 to 18 September 2013, there were 269 reported crashes on the M5 Motorway. Figures are provisional and subject to change.

*4570 HOUSING NSW MAINTENANCE LIVERPOOL ELECTORATE—Mr Paul Lynch asked the Minister for Family and Community Services, and Minister for Women—

How many unsatisfied requests have been made by tenants for maintenance in Housing NSW properties in the electorate of Liverpool since 1 July 2012?

Answer—

Timeframes for responsive repairs vary depending on the urgency of the matter.

Approximately 90% of works orders issued are completed within these timeframes, with the balance being resolved shortly after. Delays may be a result of property access issues and unforeseen site conditions.

*4571 COMMUNITY DEVELOPMENT LEVIES-Mr Paul Lynch asked the Minister for Finance and Services-

How much, and in respect of which developments, have community development levies been paid by Local Aboriginal Land Councils from 1 April 2011 to date?

Answer-

The Office of State Revenue (OSR) collects community development levies from Local Aboriginal Land Councils as an agent of the NSW Aboriginal Land Council.

Between 1 April 2011 and 1 October 2013, OSR collected \$688,536 in levies relating to 20 separate transactions. OSR does not capture information about the specific developments to which the levies apply.

*4572 AT RISK CHILDREN IN THE WALLSEND ELECTORATE—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—

- (1) How many children in the Wallsend electorate were reported to the Department of Family and Community Services as being at serious risk in the period 1 July 2012 to 30 June 2013?
- (2) How many of those children reported to the Department were seen by caseworkers?

Answer—

Data concerning Risk of Significant Harm reports is published in Community Services' Annual Statistical Reports and on the Caseworkers Dashboard. Both are published online.

*4573 UNAUTHORISED OCCUPANTS OF PUBLIC HOUSING—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—

In relation to the amnesty on 'unauthorized occupants" of public housing properties announced by the Minister in February 2013:

- (1) How many departmental properties in the Wallsend electorate had "unauthorized occupants" residing in them?
- (2) How many of those "unauthorised occupants" were adult children of the head tenant?

Answer-

Over 2,800 public housing tenants across New South Wales declared over 3,600 additional occupants during the amnesty period.

Public housing tenants declaring additional occupants, and third parties submitting allegations about other public housing tenants, were not required to identify a relationship status to the tenant.

*4575 COMMUNITY COMPLIANCE AND MONITORING GROUP MERGER WITH PROBATION AND PAROLE—Ms Sonia Hornery asked the Attorney General, and Minister for Justice—

How many jobs in the Hunter region were removed due to the merger of the Community Compliance and Monitoring Group within Probation and Parole?

Answer—

I am advised:

Following the merger of the Community Compliance and Monitoring Group (CCMG) with Community Offender Services to create the Community Corrections Division (CCD) there was a net increase of two Community Corrections positions in the Hunter region. While 11 positions were deleted from the Newcastle CCMG Office, 13 positions were created within the CCD.

- *4576 JOHN HUNTER HOSPITAL CAR PARK—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) What is the current ratio of hospital beds to car park spaces at the John Hunter Hospital?
 - (2) Does the Government have a policy or guidelines on the ratio of hospital beds to car park spaces in New South Wales?
 - (3) If so, what is the policy?
 - Answer-

I am advised:

The Rankin Park Campus (where John Hunter Hospital is located) has 2,700 car park spaces for patients and their visitors.

As with any service planning, car parking requirements are considered along with service requirements and relevant local council planning processes.

*4577 SPEED CAMERAS IN THE HUNTER REGION—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—

Regarding the review of three speed cameras in the Hunter region:

- (1) What issues were revealed concerning the cameras' operation?
- (2) What issues were revealed concerning the cameras' reliability?

Answer-

I am advised:

This information is available in the 2013 Annual NSW Speed Camera Performance Review on the Centre for Road Safety website.

*4578 WALLSEND CAPITAL WORKS SCHOOL FUNDING—Ms Sonia Hornery asked the Minister for Education—

Which schools in the Wallsend electorate have applied for capital works funding for the 2014-15 period?

Answer-

The process of Government schools identifying and nominating their priority capital works projects is ongoing. Each year, local schools and Assets representatives from the Department of Education and

Communities meet to assess the major and minor capital works priorities for all Government schools and recommend projects for inclusion in the annual capital works program.

Proposals for new capital works funding are considered through the Budget process and are announced as part of the annual State Budget.

*4579 WOONONA TO CENTRAL TRAIN TRIP—Mr Ryan Park asked the Minister for Transport—

- (1) How many people use Woonona Train Station each day?
- (2) Is the corridor between the Illawarra's northern suburbs and Sydney one of the busiest for communters in Australia?
- (3) Why was the travel time between Woonona and Central extended by nearly 20 minutes in the proposed timetable?
- (4) Why was the number of morning peak services that arrive at Central from Woonona between 8:00am and 9:00am reduced from three to one?
- (5) Will the Minister meet with the local community and the member for Keira to discuss these concerns?
 - (a) If so, when;
 - (b) If not, why not?

Answer-

I am advised:

The Government will implement a new train timetable on 20 October 2013. It's a major rewrite and has been designed to improve the customer experience.

The new timetable will deliver more than 1,000 additional services, improve connections between different modes of public transport and reduce many journey times. The timetable will also be easier for customers to use, with fewer stopping patterns and more consistent service times, particularly in peak periods.

The new timetable extends the local Port Kembla service to Waterfall. This hourly service will provide improved connections between local centres and schools, and connect customers at Woonona with intercity services at Helensburgh and suburban services at Waterfall.

- *4580 M5 EAST TUNNEL CLOSURES—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) How many times has the M5 tunnel been closed since 1 April 2011?
 - (2) How long was the average closure time of the tunnel?
 - (3) What action is the Government taking to reduce the number of instances the tunnel is closed?

Answer—

I am advised:

- (1) For the period 1 April 2011 to 19 September 2013 the M5 East Tunnel was closed 194 times, including 143 planned maintenance closures.
- (2) Planned overnight closures for routine maintenance and cleaning have a duration of seven hours. The average duration of closures for emergency maintenance and unplanned incidents was less than two hours.
- (3) Roads and Maritime Services reduced the number of monthly maintenance closures from five to four nights, from December 2011. Advanced notice of planned closures are displayed on the permanent variable message signs along the M5 East and approaches to the motorway.

The Live Traffic NSW website provides live updates and traveller information for NSW roads, including access to live traffic cameras. Live Traffic NSW mobile apps are available for iPhone, iPad and Android devices. Roads and Maritime Services provides advance notice of planned closures on the Roads and Maritime Services website.

*4581 FIREARMS REGISTRY—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

In relation to the recent concerns regarding the management of the Firearms Registry:

- (1) Is there a file containing duplicate information of firearm owners details stored in a less secure network drive available across police stations in New South Wales?
- (2) Why is the Firearms Registry information duplicated on this less secure network drive?

- (3) Can Firearms Registry information be printed as required from more secure databases?
- (4) What measures are NSW Police taking to maintain integrity of encryption of the Firearms Registry database?
- (5) How do police secure the information obtained from firearm owners when they carry out an audit of a firearm owner's property?
- (6) Where is this information stored to ensure it can only be accessed appropriately?
- (7) Does Roads and Maritime Services have a secure database to ensure firearm owners details are appropriately stored?
- (8) What improvements is the Government going to make to the Firearms Registry?

Answer-

I am advised:

Firearms licence details may be accessed by authorised personnel from three secure police systems; the Integrated Licensing System, the Safe Storage Database and the Computerised Operational Policing System. All systems are appropriately secured and audited. Questions regarding Roads & Maritime Services should be addressed to the appropriate Minister.

- *4582 MITOCHONDRIAL DISEASE—Mr Richard Amery asked the Minister for Health, and Minister for Medical Research—
 - (1) How many cases of Mitochondrial disease have been identified in New South Wales over the past 12 months?
 - (2) What are the age groups of persons identified with Mitochondrial disease?
 - (3) In what regions of New South Wales did persons identified with Mitochondrial disease reside?

Answer-

I am advised:

Mitochondrial disease refers to a group of conditions arising from mutations in mitochondrial DNA. Information on the number of cases of mitochondrial disease in New South Wales is not centrally collected by NSW Health. Research from Australia and overseas suggests prevalence rates varying from 1 in 200 to 1 in 700 population, with the prevalence varying according to the number of mutations studied.

- *4583 WORKERS COMPENSATION BENEFITS—Mr Richard Amery asked the Minister for Finance and Services—
 - (1) Since the introduction of the new workers compensation laws, how many workers in New South Wales have been notified that their workers compensation benefits are to be reduced or removed?

 - (b) 2766;
 - (c) 2761?

- (1) In the period to 31 July 2013, 9,059 work capacity assessments took place across the Scheme. Of this total, 3,958 received a work capacity decision notice that may result in them having their weekly benefits reduced or ceased.

I am advised:

(1), (2), (3) and (5). Under the Department of Attorney General and Justice (DAGJ) 2012-14 Strategic Framework which is linked to the Government's 10 year plan, "NSW 2021", one of Corrective Services NSW's (CSNSW) key goals for offender management relates to effective arrangements during times of transition from community to custody and from custody to community.

CSNSW provides funding to non-government organisations through its Funded Partnership Initiative (FPI) to assist offenders exiting custody with finding suitable accommodation. Under the FPI there is a more than \$16 million available over a three year period. Of this, more than \$13 million is dedicated to strengthening support and accommodation options for parolees.

The NSW Premier's Council on Homelessness is the peak advisory body to the Government in relation to homelessness in New South Wales. The Council consists of government and non-government members including a representative from the Community Restorative Centre who provides expertise in relation to people leaving custody. CSNSW and Housing NSW have established a Policy and Practice Working Group to address a range of cross-agency issues, focusing on key areas of action arising from the Premier's Council on Homelessness.

CSNSW Community Corrections plays an important role in identifying accommodation solutions for people who are leaving custody to supervised parole. Supported accommodation is available at a number of non-government organisation operated centres including emergency accommodation, if required.
