#### (Paper No. 91)

\*4188 PROGRAMS OF WORK TO IMPROVE ASSET REGISTERS—Mr Chris Minns asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—

Has Sydney Water commenced programs of work to improve asset registers to achieve business needs as recommended by IPART in its operational Audit of Sydney Water?

Answer—

Yes.

- \*4190 WORKS TO SEWERAGE PUMPING STATIONS IN NEW SOUTH WALES—Mr Chris Minns asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—
  - (1) What specific improvements/upgrade works, by description and location, have been undertaken at all of the sewerage pumping stations in New South Wales since 2011 (as at 6 October 2016)?
    - (a) What were the individual costs of these works?

Answer—

Details of specific improvements and upgrades to individual sewerage pumping stations across New South Wales are not available from the Department of Primary Industries Water.

- \*4192 CONSULTANTS AND CONTRACTORS FOR THE INTERNAL SURCHARGE IMPROVEMENT PROGRAM—Mr Chris Minns asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—
  - (1) What consultants or contractors have been engaged by Sydney Water in the last five years (to 6 October 2016) to advise on the Internal Surcharge Improvement Program?
  - (2) What was the cost of these consultants/contractors?
  - (3) What recommendations or advice was presented by these advisors?

Answer-

- (1) MWH, Aurecon, AECOM, GHD, Jacobs, Parsons Brinckerhoff and Manidis Roberts.
- (2) This information is available on Sydney Water's website.
- (3) The consultants provided engineering, environmental and communications advice to help residents who experience sewage discharges inside and outside their homes. They investigated the severity of the problem and developed and assessed solutions.

#### (Paper No. 92)

- \*4196 MANAGEMENT OF HOUSING—Ms Jenny Aitchison asked the Minister for Family and Community Services, and Minister for Social Housing—
  - (1) How many properties are currently managed by community housing providers in both the Maitland electorate and the Hunter New England area (excluding Newcastle and Lake Macquarie Local Government Areas (LGAs)?
  - (2) How many properties are currently managed by Housing NSW in both the Maitland electorate and the Hunter New England area (excluding Newcastle and Lake Macquarie LGAs)?

Answer—

- (1) 334 in the Maitland electorate and 2,783 in the Hunter New England area (excluding Newcastle and Lake Macquarie Local Government Areas) as at 30 September 2016.
- (2) 1,406 in the Maitland electorate and 5,715 in the Hunter New England area (excluding Newcastle and Lake Macquarie Local Government Areas) as at 30 September 2016.
- \*4197 HYDROTHERAPY POOL IN GOULBURN—Ms Jenny Aitchison asked the Minister for Health—
  - (1) How will rehabilitation services work in Goulburn without a hydrotherapy pool for the next five years (from 11 October 2016)?

(2) With a possible increase in demand on nursing home beds, what is the Government doing to address the lack of a hydrotherapy pool?

Answer-

Proposed service changes at the Bourke Street Health Service in Goulburn are the subject of continued evaluation. The scope of relocation of services from BSHS to Goulburn Base Hospital is to be determined in the next stage of planning.

\*4198 ASSET SALES IN THE MACQUARIE FIELDS ELECTORATE—Mr Anoulack Chanthivong asked the Minister for Education—

Apart from selling Hurlstone Agricultural High School, what other asset sales does the Minister have planned for the Macquarie Fields electorate?

Answer-

The Department of Education only sells land where it is deemed surplus to current or future educational use.

- \*4200 FACILITIES AT GLENFIELD RAILWAY STATION—Mr Anoulack Chanthivong asked the Minister for Transport and Infrastructure—
  - (1) What facilities exist at Glenfield Railway Station for the storage of push bikes?
  - (2) What plans are in place to build a bike shed at Glenfield Railway Station?

Answer-

- (1) Transport for NSW has installed 12 bike lockers on Roy Watts Road at Glenfield Station for hire. There are also free bike racks at the station.
- (2) In July 2015, Transport for NSW announced the roll-out of more than 40 Opal-activated bike sheds at transport interchanges around Sydney and surrounding regions. The roll-out is underway. The provision of a secure bike shed at Glenfield Station will be considered as part of the Transport Access Program's ongoing prioritisation process
- \*4201 TEACHING AND OPERATIONAL STAFF AT NEW SOUTH WALES PUBLIC SCHOOLS—Mr Anoulack Chanthivong asked the Minister for Education—

Does the Minister have any plans to privatise the teaching and operational staff at New South Wales public schools?

Answer-

No.

\*4202 HURLSTONE AGRICULTURAL HIGH SCHOOL—Mr Anoulack Chanthivong asked the Minister for Education—

Why have you not visited Hurlstone Agricultural High School on your visits to the Macquarie Fields electorate?

Answer—

I have visited Hurlstone Agricultural High School.

- \*4203 RESPONSIBLE SERVICE OF ALCOHOL AND RESPONSIBLE CONDUCT OF GAMBLING COURSES—Ms Jenny Aitchison asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—
  - (1) Does the Government play any role in the cost of Responsible Service of Alcohol (RSA) and Responsible Conduct of Gambling (RCG) course costs?
    - (a) If so, why is the cost of these courses more than double in New South Wales than in some other states?
  - (2) What is the Government doing to make courses like RSA and RCG more accessible to the unemployed?

Answer—

The cost of RSA and RCG courses is determined on a commercial basis by individual training providers.

The Government has introduced online RSA training which makes accessing the course potentially cheaper and easier, including for unemployed people. Liquor & Gaming NSW has also introduced RSA and RCG refresher training. Both refresher courses can be completed online for \$35.

#### \*4204 SPEECH PATHOLOGY—Ms Jenny Aitchison asked the Minister for Health—

- (1) What is the average wait time for someone to get access to a public funded speech pathologist following release from hospital after suffering a stroke?
- (2) How many public funded speech pathologists are available to provide a service from any Maitland area health facility?
- (3) How many people have requested the services of a public funded speech pathologist from each of the Maitland, Upper Hunter, Cessnock and Port Stephens electorates?

Answer-

Speech Pathologists work in local services across the Hunter New England Local Health District and manage requests on an individual service basis.

- \*4205 WAITING TIMES AT GOULBURN BASE HOSPITAL—Ms Jenny Aitchison asked the Minister for Health—
  - (1) What is the current number of people awaiting surgery at Goulburn Base Hospital?
  - (2) What is the expected waiting time compared to state averages?

Answer-

Quarterly information on patients awaiting surgery is routinely available on the Bureau of Health Information website via their interactive portal, Healthcare Observer at www.bhi.nsw.gov.au/healthcare\_observer.

#### \*4206 LOCAL GOVERNMENT ADMINISTRATORS AND INTERIM GENERAL MANAGERS—Ms Julia Finn asked the Minister for Local Government—

- (1) In relation to forcibly amalgamated councils, what formal or informal or specific or general guidance, advice, key performance indicators, guidelines, directions or requirements, targets or budget-related expectations were given to the:
  - (a) Sydney region Administrators;
  - (b) Administrator of Cumberland Council;
  - (c) Administrator of City of Parramatta Council;
  - (d) Sydney region Interim General Managers;
  - (e) Interim General Manager of Cumberland Council;
  - (f) Interim General Manager of City of Parramatta Council?

Answer-

The Government is supporting the creation of stronger, more efficient councils equipped to provide the services and infrastructure needed by residents and ratepayers for generations to come. This support and associated guidance is consistent with each merger proposal, the proclamations establishing new councils, and the Local Government Act 1993. Guidelines have also been provided to support the implementation of publicly announced initiatives such as the Stronger Communities Fund and the New Council Implementation Fund.

## \*4207 SOCIAL HOUSING IN NEW SOUTH WALES—Ms Jo Haylen asked the Minister for Family and Community Services, and Minister for Social Housing—

- (1) What is the average age of tenants living in social housing in New South Wales?
- (2) What support is available to assist elderly and frail tenants of social housing properties?
- (3) What is the total number of properties in the social housing stock deemed to be fully accessible?
- (4) What was the total number of properties in social housing stock deemed to be fully accessible five years ago (from 12 October 2016)?

Answer-

(1) 58.1 years (for tenants living in social housing managed by the Department of Family and Community Services).

(2) Support for elderly and frail social housing tenants includes:

- Affordable rent and secure lease terms
- \$5 per week rent charges when elderly tenants have periods away from home due to a hospitalisation or nursing home stay
- Home modifications where needed
- Regular telephone contact or home visits to allow opportunities for tenants to raise any concerns about their tenancy or maintenance requests.

(3) and (4) FACS builds and refurbishes homes so tenants with disabilities are able to live safely and comfortably in accommodation suitable to meet their needs. The number of fully accessible social housing properties changes regularly.

\*4209 LOCAL GOVERNMENT DUPLICATION-Ms Julia Finn asked the Minister for Local Government-

- (1) In relation to an answer by the Minister for Local Government to a question without notice on 20 September 2016, what examples are there of "reducing duplication, getting rid of red tape, putting in place new contracts, consolidating systems and making savings that will be passed back onto residents" by:
  - (a) Cumberland Council?
  - (b) City of Parramatta Council?

Answer-

Cumberland and the City of Parramatta councils have released their 2016-17 Operational Plans, which include examples of how each is consolidating the operations of their former councils to implement consistent and improved services for residents across a larger area.

- \*4210 HOUSING COMPLEX IN MARRICKVILLE—Ms Jo Haylen asked the Minister for Family and Community Services, and Minister for Social Housing—
  - (1) What is the total number of dwellings at the property owned by Housing NSW at 438-454 lllawarra Road, Marrickville?
  - (2) What is the total number of people residing in the dwellings at 438-454 lllawarra Road, Marrickville?
  - (3) How many complaints about anti-social behaviour have been recorded at this property in the past two calendar years (to 12 October 2016)?
  - (4) What is the total maintenance backlog for dwellings at 438-454 llawarra Road, Marrickville? Answer—
  - (1) Information regarding public housing properties is available in the Department of Family and Community Services (FACS) Annual Report at www.facs.nsw.gov.au.
  - (2) The number of people residing in social housing changes on a regular basis.
  - (3) Data prior to February 2016 is not available. Since February 2016, no antisocial behaviour incidents under the FACS Antisocial Behaviour Management Policy have been recorded against residents at this address in FACS managed tenancies.
  - (4) The number of properties undergoing maintenance in any location varies. FACS routinely carries out maintenance through responsive maintenance requests and planned maintenance programs to keep its properties in good condition and to ensure consistent maintenance standards across the state.

On 24 February 2015, then Treasurer Andrew Constance and the Minister for Small Business put out a media release which "launched a campaign against Labor's new Business Tax", claiming that Labor had "secretly lumped a \$5.1 billion tax on business" and that as a result "over ten years, each business will be paying the extra tax three times, and lose \$7,500". In relation to that release:

(1) Did the Government collect these same taxes for the last five years and only introduce legislation to remove the taxes in the 2016 Budget?

(a) If so, how could the Government claim that they were "new" and not "secret"?

- (2) Given the claim that "each business will be paying the extra tax three times and lose \$7,500", does the Government have evidence that each business in New South Wales will enter into a mortgage or transfer shares or business assets three times every year?(a) If so, where is this evidence located?
- (3) Please advise the number of Mortgage Duty transactions and the average payment per transaction in each financial year from 2013-14 to 2015-16?
- (4) Please advise the number of Non-Real transfer Duty transactions and the average payment per transaction in each financial year from 2013-14 to 2015-16?
- (5) Please advise the number of Share Transfer Duty (Duty in Unlisted Securities) transactions and the average payment per transaction in each financial year from 2013-14 to 2015-16?

Answer—

The number of customers served that reside in the postcode areas listed is not available.

As at 16 October 2016, the average customer wait time at the Auburn and Parramatta service centres was under 8 minutes.

As at 30 September 2016, there were 23 staff members (19.56 FTE) at Auburn Service Centre, 33 staff members (24.98 FTE) at Parramatta Service Centre and a total of 1149.36 FTE across all service centres. In accordance with the Service NSW (Salaries and Conditions) Employees Award 2016, all staff work a rotating roster which may include Saturdays.

The Auburn Service Centre opened on 20 November 2015. Up to 31 August 2016, the total number for the specified transactions including the percentage compared to the total number of transactions completed were:

- Driver and rider licence renewals over 12,800 (8 per cent)
- New (first time) car registrations over 5,200 (3 per cent)
- Car registration transfers over 16,200 (10 per cent)

Answer—

- (1) This question should be referred to the Minister for Planning.
- (2) Refer to the response to question 1.

(3) The International Convention for the Prevention of Pollution from Ships (MARPOL) is the principal convention covering prevention of pollution of the marine environment by ships from operational or accidental causes. The convention is implemented in Australian waters by the Commonwealth Protection of the Sea (Prevention of Pollution from Ships) Act 1983, which currently includes a 3.5 per cent limit on the sulfur content of fuel to minimise air pollution impacts. The International Maritime Organization has recently agreed to implement a global sulfur cap of 0.5 per cent in 2020 for fuel oil used by ships.

In September 2015 the Government introduced a regulation requiring cruise ships in Sydney Harbour to use low sulfur fuels. For cruise ships berthed in Sydney Harbour this took effect from 1 October 2015. For cruise ships operating in Sydney Harbour this was to take effect from 1 July 2016. On 8 January 2016 these low sulfur fuel requirements were inadvertently rendered inoperative due to changes to the Commonwealth Protection of the Sea (Prevention of Pollution from Ships) Act 1983.

Cruise lines whose ships visit Sydney Harbour have agreed to comply voluntarily with a 0.1 per cent low sulfur fuel requirement while at berth. The major cruise line company operating in New South Wales has

also agreed to an inspection program with the EPA to confirm the use of low sulfur fuel while berthed in Sydney Harbour. This inspection program is underway.

The Protection of the Environment Operations (Clean Air) Regulation 2010 includes requirements relating to the opacity of emissions from cruise ship funnels.

(4) This question should be referred to the Minister for Planning, and the Minister for Roads, Maritime and Freight.

(7) I have written to the Hon Darren Chester, the Federal Minister for Infrastructure and Transport, and the Hon Josh Frydenberg, the Federal Minister for the Environment and Energy, asking the Commonwealth Government to amend the Commonwealth Protection of the Sea (Prevention of Pollution from Ships) Act 1983, to allow for the operation of NSW's low sulfur fuel laws. I am continuing to pursue the matter.

Answer-

(1) Ausgrid has an outage management system that records details of events, including vegetation contact, that cause power supply interruptions.

(1) (a) Ausgrid estimates that between 10 and 20 per cent, which amounts to 260 supply interruptions per annum over the past five years, have been caused by street trees in the portion of their supply area covering the City of Sydney, and the Eastern, Inner West and Southern suburbs.

(2) There is an obvious significant foreseeable risk of injury under these circumstances. I am not aware of any data that is collected about every incident that does not result in injury or death. The New South Wales Industry Safety Steering Committee receives quarterly reports of serious incidents relating to electricity networks. These include tree related matters.

(2) (a) Since July 2001, which is the earliest date from which records are available, there have been no reported incidents of members of the public, adults or children, being

injured or killed while climbing trees and contacting power lines. Ausgrid reports related incidents include the 2010 death of a member of the public who contacted overhead mains climbing a streetlight, and the 2011 death of a member of the public who contacted overhead mains after climbing on top of a vehicle.

(3) Ausgrid has advised it is not aware of any instances where its tree pruning near power lines has resulted in tree death. I am not aware of any other data that is collected

about tree failure as a result of pruning.

(6) (a) Ausgrid has a legal obligation to keep the public and its staff safe and maintain a reliable power supply. This includes maintaining safety clearances between its electricity infrastructure and nearby vegetation, in accordance with the Electricity Supply Act 1995 and the Industry Safety Steering Committee Guideline for Managing Vegetation near Powerlines (ISSC3). Subject to this overriding safety obligation, Ausgrid has advised its tree pruning policies are in accordance with the arboricultural practices defined in AS 4373-2007 to minimise the risk of hazard development, branch failure, pathogen infection and premature tree death.

(7) (a) and (7) (b) Ausgrid has advised it has not changed any policy regarding the pruning of vegetation relative to a branch collar or growth point. This approach minimises the likelihood of vigorous epicormic regrowth. If epicormic regrowth does occur, Ausgrid's current practice is to 'hedge' the epicormic growth mid-limb instead of reducing the limb completely back to its original growth point. Using this approach, regrowth will slow down after about three years of cutting in this style. This is the current best practice and is endorsed and taught by TAFE NSW to all arborists. Monitoring by Ausgrid has confirmed a slowing down of regrowth. This approach also allows for a greater amount of foliage to remain within a canopy.

(8) Following representations from my office, Ausgrid has increased monitoring of its vegetation management contractors to ensure strict compliance with its established policies for clearances. Ausgrid has also agreed to trial requests to promote epicormic growth in some cases to provide foliage infill.

(9) The Industry Safety Steering Committee is continuously reviewing its vegetation management guidelines to ensure an adequate balance between public safety and preservation of street trees. Ausgrid continues to liaise with councils, customers and other stakeholders on its vegetation management program and is working with a number of councils on tree replanting and replacement programs to reduce the need to trim trees around the electricity network.

Answer-

(1) to (3) The Australian Energy Market Operator (AEMO) is responsible for the national market operations including maintaining power system security across the national grid. AEMO operates in accordance with the National Electricity Law and National Electricity Rules and other subordinate legislative instruments.

AEMO has comprehensive processes and plans which are developed in conjunction with each jurisdiction and Network Operators, to manage network and market risk. Over time, New South Wales has experienced numerous examples of weather related and other events that challenge the ability to maintain network stability including the loss of transmission towers in extremely violent windstorms. While recognising it is almost impossible to prevent localised areas of problems, history has demonstrated that the systems and processes in place are capable of handling these situations and lessons from those events continue to shape responses for the future.

With respect to the South Australian system blackout, multiple reviews are under way to find any additional issues we may need to address as an industry in the future.

(4) Emergency Services are guided by the State Emergency Rescue Management Act 1989 (SERM Act) and NSW Emergency Management Plan (EMPLAN).

The Energy & Utility Services Supporting Plan (EUSPLAN) has been prepared as a supplementary document to the NSW State Emergency Management Plan (EMPLAN).

The EUSPLAN sets out the arrangements for the coordination of planning, preparation for, response to and recovery from a declared State Emergency resulting in disruptions to energy and utility supply within New South Wales .

(5) All networks in New South Wales are required to meet minimum reliability standards which are set by the Independent Pricing and Regulatory Tribunal (IPART). In addition, network operators must report on network areas that are underperforming. These requirements incentivise network operators to develop their networks in a manner

that is cost efficient, while meeting requirements. These options include alternatives to traditional network development, such as distributed generation.

IPART has recently published a supplementary report on electricity transmission reliability standards which is open for consultation. Interested parties can make a submission until 28 October 2016.

(6) Over the past six years, the share of renewable energy generation in New South Wales' supply mix has more than doubled. In September the Australian Renewable Energy Agency (ARENA) announced

funding for five new large-scale solar farms in New South Wales. At present there are about 8,000 megawatts (MW) of renewable energy projects that are either approved or progressing through the New South Wales planning system.

This progress under the Renewable Energy Action Plan demonstrates the State's continued commitment to increasing renewable energy at least cost to the energy customer and with maximum benefit to New South Wales.

(7) to (9) New South Wales has an excellent track record for supply reliability to its electricity consumers. Its transmission system has a high level of redundancy, particularly along the eastern seaboard and is of a size that is highly unlikely to see one weather event impact the entire grid.

Over time, New South Wales has experienced weather events that have resulted in the loss of transmission lines, similar to the South Australian experience. During these historical events, the New South Wales network operators involved minimised the impact on customers from those incidents, and importantly, the lessons learned from those incidents have been applied into the industry, through line design standards to system redundancy planning.

The Government is also conscious that continued investment in further resilience would translate directly to increased customer bills, meaning a balance needs to be struck between prices and some degree of expected system failure. Part of this trade-off is the recognition that response times need to be kept at reasonable levels, an area monitored through licence conditions.

New South Wales is an active participant in the National Electricity Market working with AEMO and market participants in industry planning for major electrical incidents and subsequent exercises to test those plans.
