- *1059 MOUNT DRUITT HOSPITAL DENTAL CLINIC—Mr Richard Amery asked the Minister for Health, and Minister for Medical Research—
 - (1) How many procedures have been carried out at the Mount Druitt Hospital dental clinic for the nine month period ending 30 September 2011?
 - (2) How do these figures compare to the same period in:
 - (a) 2010;
 - (b) 2009?

Answer-

I am responding to this question as it falls within my portfolio as Minister for Healthy Lifestyles, rather than that of the Minister for Health.

I am advised:

17,266 procedures have been carried out at Mt Druitt Hospital Dental Clinic during the nine month period from 1 January to 30 September 2011. For the same period in 2010 it was 19,215; and 18,754 in 2009

*1060 MILLFIELD PUBLIC SCHOOL—FLASHING LIGHTS—Mr Clayton Barr asked the Minister for Transport representing the Minister for Roads and Ports—

With respect to the election commitment made by the Member for Oxley and the Nationals candidate Alison Davey for funding to install 40 kph flashing lights at Millfield Public School:

- (1) Was the commitment contingent on the election of Alison Davey?
- (2) Will the Minister confirm that the Government will fulfil this commitment?
- (3) Will the money be available in the 2011-2012 budget?
- (4) If the funding is not forthcoming in the 2011-2012 budget, when will the funding be committed and available?

Answer-

I am advised that:

- (1) to (4) The Government will fulfil this commitment. Millfield Public School will receive flashing lights by the end of November 2011.
- *1061 FLASHING LIGHTS FOR PUBLIC SCHOOLS—Mr Clayton Barr asked the Minister for Transport representing the Minister for Roads and Ports—

With respect to 40 kph flashing lights for public schools:

- (1) How many schools will have the flashing lights installed in 2012?
- (2) Will any of them be in the Cessnock electorate?
- (3) What is the timeframe for completion of flashing lights at all NSW public schools?
- (4) What is the cost to complete all remaining flashing lights installations at NSW public schools?

Answer-

I am advised:

(1) to (4) Approximately 144 school zones will have flashing lights installed in 2012. The number of schools that will receive flashing lights will vary, as some school zones apply to more than one school, and some schools may have more than one school zone.

The school zones to receive flashing lights in 2012 and beyond have not yet been identified.

The sites for additional flashing lights to be rolled out between 2012 and 2015 will be selected by assessing school zones against set criteria including crash risk, traffic and pedestrian volumes, approach speed limits, number of travel lanes, existing crossing facilities, sight distance requirements, road environment and geometry.

All schools, including those in the Cessnock electorate, will be assessed against these criteria.

The Government has committed \$13 million over four years for the installation of flashing lights in school zones. This will lead to flashing lights being installed at 540 additional school zones by the end of June 2015.

*1062 PUBLIC SERVICE JOB CUTS IN RESEARCH FACILITIES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

Will there be any cuts to public service jobs in research facilities in the Hunter, including the following:

- (a) Hunter Medical Research Institute (HMRI);
- (b) John Hunter Hospital;
- (c) Calvary Mater Hospital?

Answer-

I am advised:

There are no plans to cut public service jobs in research facilities at either John Hunter Hospital or Calvary Mater Newcastle Hospital.

The Hunter Medical Research Institute is an independent institute and not part of the public service.

*1063 CORRECTIVE SERVICES NSW—PENALTIES IMPOSED—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What penalties have been imposed by Corrective Services NSW on the private operators of Junee and Parklea Correctional Centres in the following periods:

- (a) 1 July 2010 to 31 December 2010;
- (b) 1 January 2011 to 30 June 2011:
- (c) 1 July 2011 to date?

Answer-

I am advised:

GEO Australia Ltd has been penalised \$10,000 in respect of the escape of a Parklea Correctional Centre inmate from a hospital escort on 27 November 2010. The inmate was recaptured within the hospital grounds.

*1064 AIRFLIGHT EXPENDITURES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What have been the airflight expenditures by your Department since 27 March 2011?

Answer—

I am advised:

As at 17 October 2011, expenditure on airflights by staff during this period was \$ 1,093,782 (excluding GST). This amount also includes airflights undertaken by judicial officers, tribunal members and court administration officers.

In addition Juvenile Justice expended \$292,839 on the air transport of clients (as at 11 October 2011).

*1065 NSW TRUSTEE AND GUARDIAN—ASSAULTS ON STAFF—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many assaults on staff have occurred at which offices of the NSW Trustee and Guardian in the periods:

- (a) 1 July 2010 to 31 December 2010;
- (b) 1 January 2011 to 30 June 2011;
- (c) 1 July 2011 to 30 September 2011?

Answer—

- (a) One physical assault was reported at the Clarence Street office. In addition, staff reported a total of eight incidents of verbal threats, two at Clarence Street, one at Liverpool, one at Burwood and four at the Parramatta Justice Precinct office. Seven incidents of telephone threats were also reported, one at Lismore and six to the specialist intensive team at the Parramatta Justice Precinct.
- (b) One physical assault was reported at the Clarence Street office. In addition, staff reported 17 incidents of verbal threats, four at Clarence Street, four at Gosford, two at Hurstville, five at the Parramatta Justice Precinct office, one at Lismore and one at Liverpool. Five incidents of telephone threats were reported, two at the Liverpool office and three at the Parramatta Justice

Proginat office (including one to the specialist intensive teem and one to the long term

- Precinct office (including one to the specialist intensive team and one to the long term residential team).
- (c) Three physical assaults were reported, one at the Clarence Street office and two at the Sydney Central office. In addition, staff reported 12 incidents of verbal threats, two at the Clarence Street office, three at Gosford, three at the Parramatta Justice Precinct office and four at Sydney Central office. Sixteen incidents of telephone threats were reported, two at Lismore, two at Liverpool, two at Newcastle and ten at the Sydney Central office.
- *1066 CORRECTIONAL CENTRES—EXTRA BEDS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) (a) How many and which correctional centres have had extra beds placed in them since 1 July 2008? (b) Do they remain there?
 - (2) How many such beds contravene the minimum space allowed under the Public Health Regulation?

I am advised:

- (1) (a) Since 1 July 2008, four correctional centres, being Wellington Correctional Centre, Mid North Coast Correctional Centre, South Coast Correctional Centre and Parklea Correctional Centre have each had extra beds placed in them.
 - (b) Yes.
- (2) Nil.
- *1067 CORRECTIONAL CENTRES—WALL MOUNTED RINGS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) How many and which correctional centres have wall mounted rings used to attach inmates by their handcuffs?
 - (2) How often and which ones have been utilised in the periods:
 - (a) 1 July 2010 to 31 December 2010;
 - (b) 1 January 2011 to 30 June 2011;
 - (c) 1 July 2011 to 30 September 2011?

Answer-

- (1) and (2) I am advised that there are no wall-mounted rings in correctional centres in New South Wales. Consequently, no wall-mounted rings have been utilised in these periods.
- *1068 NEEDLE EXCHANGE PROGRAM—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
 - (1) Does the Attorney General propose a needle exchange program in any correctional centre?
 - (2) If so, in which ones and in what circumstances?

Answer-

As I advised the General Purpose Standing Committee No 4 during the Budget Estimates Hearing on 26 October 2011, I have considered a trial needle exchange program and I am not impressed. I will not change the current system.

*1069 FORUM SENTENCING—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

I am advised:

Prior to 2011, the Department maintained statistics on the number of forums held and not on the number of individual offenders dealt with by way of Forum Sentencing.

*1070 INTENSIVE CORRECTION ORDERS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many people are subject to Intensive Correction Orders as at:

- (d) 1 July 2011;
- (e) 1 September 2011?

Answer-

I am advised:

Corrective Services NSW collates this data on the last day of the month. The following numbers of offenders were subject to intensive correction orders on the dates indicated:

- (a) On 30 November 2010: 28
- (b) On 31 January 2011: 105
- (c) On 31 March 2011: 198
- (d) On 30 June 2011: 339
- (e) On 31 August 2011: 432.
- *1071 OUTSTANDING BENCH WARRANTS—Mr Paul Lynch asked the Attorney General, and Minister for Instice—

How many outstanding bench warrants are there in NSW as at 1 October 2011?

Answer-

I am advised:

The Department of Attorney General and Justice does not maintain data on outstanding warrants. Bench warrants (now known as arrest warrants) are issued by courts and referred to the NSW Police Force. The question should therefore be directed to the Minister for Police and Emergency Services. I note that you have already asked a similar question of the Minister for Police and Emergency Services.

*1072 OUTSTANDING WARRANTS—Mr Paul Lynch asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

As at 1 July 2011, how many outstanding warrants are there to apprehend and detain/imprison people in NSW?

Answer-

The NSW Police Force has advised me:

As at 1 July 2011, there were 28,556 outstanding arrest warrants in NSW, a decrease of approximately 7,000 since 1 July 2009.

*1073 REPRESENTATIONS FROM THE NSW CRIME COMMISSION—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Given that there were two matters that were not proceeded with as a result of representations from the NSW Crime Commission (Question 0769):

- (1) Which are the two matters that were not proceeded with as a result of representations from the Crime Commission?
- (2) Who is/are the person(s) not proceeded against?

Answer-

I note that questions of this nature were asked of me during Budget Estimates. I refer you to my answers given there. Apart from those answers, I am advised that it would not be appropriate for me to disclose the names of the relevant individuals or any information that would allow these individuals to be identified.

*1074 COMMUNITY OFFENDER SUPPORT PROGRAM CENTRES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many offenders are located within which Community Offender Support Program (COSP) Centres as at:

- (a) 1 December 2010;
- (b) 1 February 2011;

- (c) 1 April 2011;
- (d) 1 July 2011?

Answer-

I am advised:

Corrective Services NSW collates this data each Sunday. The following numbers of offenders resided at Community Offender Support Program Centres on the dates indicated:

- (a) On 5 December 2010: 91
- (b) On 30 January 2011: 84
- (c) On 3 April 2011: 99
- (d) On 3 July 2011: 87
- (e) On 4 September 2011: 91.
- *1075 RIFLE SHOOTING IN PUBLIC SCHOOLS—Ms Tania Mihailuk asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Regarding the proposal to introduce rifle shooting into NSW public schools:

- (1) What action will the Minister take to prevent this proposal from negatively impacting communities such as Bankstown?
- (2) What factors will the Government consider when determining whether such classes are appropriate for suburban schools?

Answer-

(1) and (2) I note that the lead Minister for this issue is my colleague, the Hon Adrian Piccoli MP, Minister for Education.

There is no proposal to "introduce rifle shooting in schools". However, I am advised that the Devolution of Decision Making to Schools memorandum (1991-020) enables school principals to manage and coordinate their school sport operations to suit the circumstances of the local school community and its students.

- *1076 OFFERS OF VOLUNTARY REDUNDANCY—Mr Ryan Park asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) How many people located in the Wollongong Local Government Area and employed by your agency will be offered voluntary redundancy?
 - (2) What is the timeline for this process?
 - (3) What information will be used to determine the positions identified as eligible for redundancy?

Answer-

I am advised:

Roads and Maritime Services (RMS) has no immediate plans to offer any staff in the Wollongong Local Government area voluntary redundancy.

Voluntary redundancies are offered in accordance with the NSW Government's 'Managing Excess Employees' policy which was implemented on 1 August 2011. The policy outlines the circumstances under which a voluntary redundancy offer can be made, i.e. an employee is declared excess by their agency when they no longer have a substantive position.

- *1080 OFFERS OF VOLUNTARY REDUNDANCY—Mr Ryan Park asked the Minister for Ageing, and Minister for Disability Services—
 - (1) How many people located in the Wollongong Local Government Area and employed by your agency will be offered voluntary redundancy?
 - (2) What is the timeline for this process?
 - (3) What information will be used to determine the positions identified as eligible for redundancy?

Answer-

Ageing, Disability and Homecare currently has no plans for a program of voluntary redundancies in the Wollongong Local Government Area.

*1081 OFFERS OF VOLUNTARY REDUNDANCY—Mr Ryan Park asked the Minister for Family and Community Services, and Minister for Women—

- (1) How many people located in the Wollongong Local Government Area and employed by your agency will be offered voluntary redundancy?

- (3) What information will be used to determine the positions identified as eligible for redundancy?

Answer-

- (1) At this stage, there are no plans to make offers of voluntary redundancy in 2011-12 to permanent employees employed within the Wollongong Local Government Area.

- *1083 OFFERS OF VOLUNTARY REDUNDANCY—Mr Ryan Park asked the Minister for the Environment, and Minister for Heritage—
 - (1) How many people located in the Wollongong Local Government Area and employed by your agency will be offered voluntary redundancy?
 - (2) What is the timeline for this process?
 - (3) What information will be used to determine the positions identified as eligible for redundancy?

Answer-

I am advised as follows:

At 11 October 2011 there were no planned voluntary redundancies for staff employed by the Office of Environment and Heritage based in the Wollongong Local Government Area.

- *1085 INQUIRY INTO LYSAGHT OVAL—Mr Ryan Park asked the Minister for Sport and Recreation—
 - (1) What are the terms of reference for the inquiry into Lysaght Oval?
 - (2) Who will be undertaking the inquiry?
 - (3) Will the Government transfer the \$2.5 million that they announced earlier this year into Wollongong City Council Trust Fund?

Answer—

- (1) The inquiry was commissioned by the Director-General of the Department of Premier and Cabinet. This question should be directed to the Premier.
- (2) The Internal Audit Bureau.
- (3) \$2.5 million was granted by the previous government specifically for the upgrade of Lysaght Oval. It was conditional on funding both the purchase of the land from the private owner, and the required work to complete the project. The allocation was not carried forward in the budget as \$2.5 million is not sufficient to fund both the land purchase and the required upgrade.
- *1086 BULLI HOSPITAL URGENT CARE CENTRE—Mr Ryan Park asked the Minister for Health, and Minister for Medical Research—
 - (1) What funding will be provided to Bulli Hospital to implement the Government's proposal for an Urgent Care Centre at the hospital?
 - (2) Will the Government now commit to an Integrated Primary Health Facility adjacent to the hospital?
 - (a) If so when will this commence?
 - (b) If not why?

Answer-

I am advised:

The Illawarra Shoalhaven Local Health District Board is commencing a comprehensive clinical service planning process for the Illawarra and Shoalhaven, which will include extensive community consultation. Priorities for future capital developments and other service expansions will be identified in this process.

The Local Health District is in the early stages of the planning and consultation phase for proposed changes at Bulli Hospital, including the reconfiguration of the Emergency Department to an Urgent Care Centre. I also refer the Member to my response to his question without notice on Tuesday 18 October 2011 concerning the Bulli Hospital.

- *1087 BULLI PCYC—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) What additional funding will be allocated to the Bulli PCYC to replace its asbestos roof?

- (2) When will this work commence?
- (3) How long is the work expected to take?

Answer-

I am advised that remediation costs for Bulli PCYC have been estimated at \$295,437 and this work is expected to be undertaken, along with similar work at Lake Illawarra and Wollongong PCYCs, between January - June 2012.

- *1091 STAMP DUTY CONCESSION—Mr Richard Amery asked the Treasurer—
 - (1) During the financial year ending 30 June 2011, how many persons received a stamp duty concession for buying their first home in the following postcode areas:
 - (a) 2770;
 - (b) 2761;
 - (c) 2766?
 - (2) What was the total value of these concessions

Answer-

This question would be more appropriately directed to The Hon Greg Pearce MLC, Minister for Finance and Services.

*1093 CARDIFF RAILWAY STATION—EASY ACCESS UPGRADE—Ms Sonia Hornery asked the Minister for Transport—

Given a July 2011 CityRail publication which stated that the upgrade to Cardiff Railway Station is expected to be completed towards the middle of 2012, and the Minister's answer to my question No. 0579 that the upgrade is expected to be completed in late 2013:

What transpired between July 2011 and 7 September 2011 to delay the expected completion date of the upgrade of Cardiff Railway Station from the middle of 2012 to late 2013,

Answer—

I am advised:

The previous government announced the upgrade would be complete by December 2012. However, the detailed design phase which began in late 2010 revealed that more work would be needed than previously thought, in order to make both platforms level and safe for accessible use.

- *1094 BUS SERVICES PATRONAGE—Ms Sonia Hornery asked the Minister for Transport—
 - (1) Do State Transit Authority figures indicate that bus services patronage is down more than a quarter of a million passenger boardings over the past two years?
 - (2) What is the Minister doing to ensure a cessation of this trend, in terms of offering better, more efficient services?
 - (3) What is the Minister doing to address the surge in malicious damage, vandalism and offensive behaviour incidents which are hampering efforts to attract passengers?

Answer-

- (1) and (2) State Transit reports on Newcastle bus services in its Annual Report.
- (3) All buses in the Newcastle Buses fleet have modern security CCTV cameras to provide security for passengers and drivers. Newcastle Buses continues to work with the local community and other agencies in a multi-pronged approach to making Newcastle bus services a safe and pleasant experience for passengers.
- *1096 HUNTER CRIME STATISTICS—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Do Hunter crime statistics for 2010 and 2011 indicate a surge in sex offences, in thefts from vehicles

and in fraud offences?

(2) Will the Minister be addressing this increase in crime with a corresponding increase in police numbers to ensure the safety and well-being of Hunter residents?

Answer-

The NSW Police Force has advised me that Local Area Commands in the Hunter are working with partner agencies to reduce sexual assault through close monitoring of repeat offenders and persons on the Child Protection Register; educating the community on sexual assault prevention, including staging the Love Bites Program to reduce the number of sexual assaults involving youth; and ensuring that reports of indecent/sexual assault are appropriately investigated.

There is active targeting of steal from motor vehicle offending via increased patrols at peak times and hotspot locations with a focus on high risk and recidivist offenders. Major contributors in the fraud related category are computer related fraud and fail to pay for petrol, which are difficult to target with proactive policing. Nonetheless, Hunter police are monitoring and investigating these types of crime wherever they occur.

- *1097 DNA BACKLOG—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) What is the Minister doing to address the current crisis in DNA processing and matching backlog?
 - (2) Has a young woman in Newcastle been waiting for her assailant, who is out in the community, to be identified so she can resume her life without fear.

Answer-

The NSW Police Force has advised me:

- (1) There has been a significant reduction in the DNA backlog in recent months as a result of collaboration between the Forensic Services Group and the Division of Analytical Laboratories as well as the implementation of a range of initiatives in this area.
- (2) The specific case referred to cannot be identified on the information given. However, should the young woman to whom the Member refers have concerns for her safety, she should make contact with local police.
- *1098 CALVARY MATER HOSPITAL—CANCER TREATMENT AND RESEARCH CENTRE—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) What has the Minister done to secure the vital cancer treatment and research centre at the Calvary Mater Hospital, given its election promise to purchase land next to the Calvary for the centre?
 - (2) Has the community identified this centre as a priority given the region's long waits for cancer treatment and the need for more medical oncologists?

Answer-

I am advised:

(1) and (2) The Government is meeting its commitment through an allocation of \$1 million included in the 2011/12 budget to commence the process of examining the land development opportunities, acquisition processes and identification of priorities as well as consultation and service planning. Land has been secured by NSW Health with a five year call Option.

A study of the site and the Mater Campus is being undertaken to determine the optimum development opportunities for the precinct inclusive of the development needs for cancer treatment, a research centre, public and private health services generally and the necessary support facilities.

An initial report is scheduled to be available in December 2011 and the overall study will include community consultation to identify community concerns and priorities as well as the strategic directions for future development of the health precinct.

- *1099 METHADONE PHARMACOTHERAPY TREATMENT—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Which unit or units of Hunter New England Area Health Service denies methadone pharmacotherapy treatment to released ex-prisoners who are referred to Hunter New England Area Health by the Justice Department?
 - (2) What is the reason for this injustice to released prisoners?

Answer-

I am advised:

(1) and (2) Hunter New England Local Health District Drug and Alcohol Clinical Services provides opiate substitution services (methadone and buprenorphine) across the Hunter New England Local Health District. Dosing services are provided in Newcastle, Cessnock, Taree and Tamworth.

These dosing services are subject to high demand and referred clients are accepted on the basis of clinical urgency, such as pregnant women and seriously ill patients. All other referrals are placed on a waiting list and provided with a list of alternative treatment options.

People who are transferred to Justice Health from Hunter New England Local Health District public programs and incarcerated for less than three months are able to rejoin the program on release. People who are incarcerated for longer than three months are assessed to ascertain whether they meet the criteria for the most clinically urgent referrals.

- *1101 2017 INTERNATIONAL EXPOSITION—Ms Sonia Hornery asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the Arts—
 - (1) What is the Government doing to secure a bid for Newcastle to host the 2017 International Exposition, given its election promise of \$1 million for Newcastle to fund a bid to host the 2017 event?
 - (2) Is the Government aware that it has until 10 December to lodge its interest, to showcase Newcastle and continue its revitalisation?

Answer—

- (1) The Government has this under active consideration.
- (2) Yes.
- *1102 NORTH COAST AREA HEALTH SERVICE JOB CUTS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the previous "axing of 400 jobs" in the North Coast Area Health Service:

- (1) In which hospitals were these job cuts made?
- (2) In which positions?
- (3) Were the deleted positions permanently funded positions?
- (4) Were any services closed as a result of these cuts?

Answer—

I am advised:

(1) to (4) Between July 2009 and December 2010 the former NSW Labor Government reduced full time equivalent staff numbers at Grafton Base, Lismore Base, Murwillumbah District, Port Macquarie Base, Coffs Harbour Base, The Tweed, Maclean District, Kempsey District, Bellingen District, Wauchope District, Byron Bay District, Mullumbimby District and Casino District Hospitals and Dorrigo and Kyogle Multipurpose Services - including permanently funded positions.

Reductions occurred in positions such as Health Manager, Administration Assistant, Wardsperson, Hospital Assistant, Cleaner, Physiotherapy Aide, Registered Nurse, Nurse Unit Manager, Senior Nurse Manager, Clinical Nurse Consultant, Anaesthetic Assistant, Business Manager, Trades Assistant, Trades, Ward Clerk, Radiographer, Media Manager, Enrolled Nurse, Linen Officer, Sterilisation Technician, Medical Registrar, Patient Transport Driver, Clinical Risk Analyst and Volunteer Co-ordinator.

Hardworking staff ensured that no services were closed as a result of these reductions.

*1103 PORT MACQUARIE HOSPITAL—FOURTH POD—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the proposed "fourth pod" at Port Macquarie Hospital:

- (1) What is the latest estimate of the final cost?
- (2) Which sources (i.e. Federal and NSW Government contributions) of funding will be used?
- (3) When will construction commence?
- (4) What facilities will be constructed?
- (5) When will construction end?

Answer-

I am advised:

- (1) and (2) The estimated total cost of the project is \$110 million (\$96 million Federal; \$14 million State funding).
- (3) Early works will commence mid 2012. The main building construction will commence early 2013.
- (4) The "Expansion Project" at Port Macquarie Base Hospital will include a new and expanded Emergency Department, a new 8 bed Emergency Medical Unit, a new 30 bed Medical Inpatient Unit, an additional 12 Surgical beds, a new 15 Bed Paediatric Inpatient Unit (relocation only not additional beds), a new Operating Theatre complex consisting of 7 new build operating rooms, one shell theatre (for future expansion) currently there are 4 operating theatre rooms, 2 new procedure rooms and a 32 bed perioperative (recovery) unit. The building will also include a new Sterilizing Department, new Stores and Linen Handling services. A Cardiac Catheterisation Laboratory will also be included in a new 24 bed Critical Care complex for Intensive Care and Coronary Care inpatients.
- (5) Construction is expected to be completed in mid-2015.
- *1104 SUTHERLAND HOSPITAL EMERGENCY DEPARTMENT—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) What enhancements to the Sutherland Hospital Emergency Department are planned in the 2011-12 financial year?
 - (2) What staffing enhancements have been approved for the 2011-12 financial year?

Answer-

I am advised:

(1) and (2) Refurbishment and expansion plans for the Sutherland Hospital Emergency Department will be progressed in line with the South Eastern Sydney Local Health District's strategic and capital plan. There are no plans for capital enhancement during this financial year.

Nurse staffing levels are determined and adjusted as required by local management in line with patient need and the specified award and benchmark tool, in negotiation with the NSW Nurses Association representatives.

As part of the Nursing Hours per patient day award provision the Emergency Department received a staffing increase of 2.2 FTE. Recruitment is currently underway.

*1105 NATIONAL BOWEL CANCER SCREENING—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

In regard to National Bowel Cancer screening and follow up:

- (1) How many colonoscopies were performed in NSW public hospitals for the year 2010-11?
- (2) How many patients are on the waiting list for colonoscopy in NSW in category 1, 2 and 3?
- (3) For the months April to June 2011, what were the median wait times for colonoscopy in categories 1, 2 and 3?
- (4) What enhancements for colonoscopy services in response to bowel screening will be approved in the 2011-12 financial year?

Answer-

- (1) 20,425 colonoscopy procedures were performed on admitted patients in NSW public hospitals during the 2010/2011 financial year.
- (2) As at June 2011 there were 10,387 "ready for care" patients on the medical waiting list for colonoscopy: 1,132 Category 1; 4,502 Category 2; and 4,753 Category 3.
- (3) For the periods in question: 21 days for Category 1; 60 days for Category 2; and 114 days for Category 3.
- (4) The NSW Endoscopy Information System (EIS) is currently being implemented across NSW. The EIS is a data collection and reporting tool, which will:
 - Provide accurate state-wide information on endoscopy procedures carried out in NSW public hospitals.
 - Facilitate the comparison of services against critical safety and quality benchmarks.
 - · Inform on issues of productivity, activity, costs and access to services.
 - Facilitate electronic reporting to the National Bowel Cancer Screening Program's Register.
 - Integrate with other IT systems, such as the Electronic Medical Record (eMR).

In total, the EIS will be implemented at 84 hospitals across NSW, with all sites due to "go live" by June 2013.

- *1106 RENAL DIALYSIS—FORBES AREA—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) How many patients in the Forbes area are on home dialysis?
 - (2) How many are on hospital-based dialysis?
 - (3) How many chairs for hospital-based dialysis are currently available in Forbes?
 - (4) What is the total annual budget?
 - (5) (a) Are there any patients who are required to travel from Forbes to (a) Orange or (b) other hospitals for dialysis?
 - (b) If so, for what reasons(s)?

Answer-

I am advised:

- (1) 4 in the Condobolin, Parkes and Forbes area. All are on peritoneal dialysis.
- (2) 12.
- (3) 6 chairs.
- (4) \$324,615 for 2011-2012.
- (5) No.
- *1107 TOMAREE COMMUNITY HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to Tomaree Community Hospital:

Given your answer to Question 0145 and your commitment to an upgrade that would "include the provision of a day surgery centre, residential aged care, hostel type units and a comprehensive community health care centre":

What enhancements for Tomaree Community Hospital are planned for:

- (a) the 2011-2012 budget year;
- (b) the following two financial years?

Answer-

I am advised:

Hunter New England Local Health District is currently undertaking a planning process of service needs for the Greater Newcastle region which includes the Port Stephens area. This planning process is considering the health services required and the optimal location of services to best meet the needs of communities across the Greater Newcastle region, and ensure safe and sustainable health services into the future. The possibility of further enhancements to Tomaree Community Hospital will be considered in the context of the outcomes of this planning process when complete.

*1108 MORISSET AMBULANCE STATION—Mr Greg Piper asked the Minister for Health, and Minister for Medical Research—

What are the dates and hours of any occasions on which Morisset Ambulance Station has been unmanned since its administration was transferred to the Central Coast Zone?

Answer-

I am advised:

Since the transfer on 1 January 2011 to the Central Coast Zone there has been no occasion that Morisset Ambulance Station has been left without staff. The zone change is administrative and does not involve a reduction in service provision to the local community, staffing levels or working conditions. There has been no change to the number or location of ambulances rostered at Doyalson and Morisset, or any change to the method of dispatching ambulances to Doyalson, Morisset and surrounding areas.

*1109 JENOLAN CAVES TRUST—Mr Greg Piper asked the Minister for the Environment, and Minister for Heritage—

Will the Government initiate an independent investigation of the validity of the administrator's appointment to the Jenolan Caves Trust?

Answer—

No.

- *1113 WINMALEE PUBLIC SCHOOL HALL—COVERED WALKWAY—Ms Carmel Tebbutt asked the Minister for Education—
 - (1) How much funding has been allocated in the 2011-12 financial year to construct a covered walkway to Winmalee Public School hall?
 - (2) When will the project begin and when will construction be completed?

Answer-

- (1) Funding in the order of \$119,050 (inc. GST) has been allocated for the provision of covered walkways to Winmalee Public School.
- (2) The project commenced in September 2011 and was completed on 26 October 2011.
- *1114 SCHOOL ZONE FLASHING LIGHTS—Ms Carmel Tebbutt asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) How much funding has been allocated in the 2011-12 financial year for the installation of school zone flashing lights?
 - (2) How much funding has been allocated across the forward estimates period for the installation of school zone flashing lights?
 - (3) When will the following schools have school zone flashing lights installed:
 - (a) East Hills Boys' Technology High School;
 - (b) Arthur Phillip High School;
 - (c) Parramatta Public School;
 - (d) William Stimson Public School;
 - (e) Kiama High School;
 - (f) Roland Hassall Public School?

Answer-

I am advised:

- (1) and (2) The Government has committed \$13 million over four years for the installation of flashing lights in school zones.
- \$3.25 million has been allocated for the installation of flashing lights in the 2011-12 financial year.
- (3) The NSW Government will fulfil its election commitment to install school zone flashing lights at these sites. The installation at all these sites will be complete by November 2011.
- *1115 BLAXCELL STREET PUBLIC SCHOOL AIR-CONDITIONING—Ms Carmel Tebbutt asked the Minister for Education—
 - (1) How much funding has been allocated in the 2011-12 financial year for the installation of air-conditioning in classrooms at Blaxcell Street Public School?
 - (2) How much funding has been allocated across the forward estimates period for the installation of air conditioning in classrooms at Blaxcell Street Public School?
 - (3) How many classrooms does Blaxcell Street Public School have and how many of these will be airconditioned?
 - (4) When will this project commence and when will it be completed?

Answer-

- (1) to (4) Under the current Department of Education and Communities policy Blaxcell Street Public School is not eligible for air-conditioning.
- *1116 HOMOPHOBIC BULLYING IN SCHOOLS—Ms Carmel Tebbutt asked the Minister for Education—
 - (1) How much funding has been allocated in the 2011-12 financial year for programs to combat homophobic bullying in schools?
 - (2) How much funding was allocated in the 2010-11 financial year to combat homophobic bullying in schools?
 - (3) How much funding has been allocated across the forward estimates period for programs to combat homophobic bullying in schools?
 - (4) How much funding is allocated to each Government program to combat homophobic bullying in schools?

Answer-

(1) to (3) The Department of Education and Communities employs specialist staff at school, region and state levels to support the welfare and wellbeing of students. These officers support statewide and local initiatives which includes developing resources, providing professional learning and support for teachers, and providing policies and related advice. As these officers provide such a broad range of support to schools it is not possible to estimate the percentage of time that these officers specifically spend on preventing homophobic bullying.

Furthermore, each school plans its strategies based on local circumstances and community needs. The time that each school allocates to key issues related to preventing homophobic bullying therefore varies and it is not possible to estimate how much funding is being spent by individual schools.

- (4) The Department is delivering the Proud Schools pilot program to assist high schools to address homophobia, transphobia and heterosexism. It is estimated that \$250,000 will be expended on the pilot during the implementation phase (2011–2013). Twelve schools are involved in the pilot.
- *1117 DEVELOPMENT AT KAMIRA COURT, VILLAWOOD—Mr Guy Zangari asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

Can the Minister provide the status of the Department of Housing development at Kamira Court, Villawood?

Answer-

WATPAC was selected as a project partner following a competitive EOI process. WATPAC is currently undertaking high-level market analysis to test various options with the community and private housing sectors.

- *1118 PROPOSED TRIAL TO ADDRESS GRAFFITI DAMAGE—Mr Richard Amery asked the Attorney General, and Minister for Justice—
 - (1) Was a trial to be facilitated by the Department of Attorney General and Justice with the local government areas of Mosman and Blacktown announced to address the problem of graffiti damage in those communities?
 - (2) Was this proposal designed to make the councils a "One Stop Shop" for the reporting and removal of graffiti in certain areas?
 - (3) Why has this proposal been cancelled?

Answer—

I am advised:

- (1) A Graffiti Shared Services Trial was implemented as a component of the previous NSW Government's response to graffiti management in the Mosman Local Government Area (LGA) and in Dawson Mall, Mt Druitt, which is part of the Blacktown LGA.
- (2) The trial was designed to test if the cost of graffiti removal on State and Local Government assets could be reduced by having it carried out by a limited number of contractors and coordinated by a single agency. The trial program was intended to operate within existing NSW Government agency graffiti removal standards and financial resources.
- (3) The trial was discontinued due to a number of reasons including cost inefficiency and the low incidence of graffiti vandalism on public property that were within the scope of the trial.
 - While this particular graffiti initiative was cancelled, this Government maintains a strong commitment to reducing graffiti vandalism in NSW. My Department has recently met with Blacktown Council to discuss graffiti management and other crime issues in the area.
 - The shared services agreement is an issue that will be on the agenda of the next NSW Graffiti Management Strategy Group meeting.
- *1119 CAR WEIGHT TAX—Ms Sonia Hornery asked the Minister for Transport representing the Minister for Roads and Ports—

Given the Premier described the car weight tax a "monstrous motor tax" while he was in Opposition:

- (1) Will the Minister withdraw the car weight tax?
- (2) If not, will the Government commit to spend in the Hunter, the taxes paid by Hunter motorists?

Answer-

I am advised:

Legislation to increase the car weight tax was introduced by the former NSW Labor Government.

The NSW Government inherited a \$5.2 billion budget blackhole from the former State Labor Government, meaning difficult fiscal decisions had to be made. Despite the \$5.2 billion budget black hole left by Labor, the NSW Liberals and Nationals are delivering on our commitment to improve frontline service delivery and infrastructure in the Hunter region.

On 6 September of this year the Premier announced that \$888 million will be invested in roads projects across the Hunter in the 2011-2012 State Budget. This represents an increase of \$276 million or 45% from the 2010-11 allocation of \$612 million for roads projects in the Hunter region.

The NSW Government has also made a clear commitment with the allocation of \$350 million over four years to establish the Hunter Infrastructure and Investment fund. This money will be used to invest in essential Hunter infrastructure projects.

*1121 GLENDALE POLICE STATION—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Further to my previous question to the Minister on land purchase for the Glendale Police Station:

- (1) Can the Minister update the information on where the purchase of land is up to?
- (2) Are there any hold-ups in the process?
- (3) If so, what are these and what is the timeline for the project?

Answer—

I am advised that the plan to build a new police station at Glendale was first announced in the State Budget in 2008. However, since that time the NSW Police Force has experienced great difficulty in identifying a suitable site in Glendale to build the station, with the police preferred site being rejected by Lake Macquarie Council due to zoning issues. The Council's preferred site has in turn been rejected by the NSW Police Force, due to site restrictions such as flooding, contamination and bushfire zoning.

I have asked the NSW Police Force to come back to me with a detailed plan to progress capital works in Lake Macquarie as a matter of urgency.

*1122 MAINTENANCE WORKS—DOBELL BUILDING—Ms Kristina Keneally asked the Minister for Family and Community Services, and Minister for Women—

Noting your answer to Written Question 0757 regarding the Housing NSW building known as Dobell at 33 John Street, Waterloo:

- (1) What is the actual amount that the 2011-12 budget has allocated to undertake building repairs?
- (2) What repairs are being carried out?
- (3) What is the timeline of work in calendar month's and year's?
- (4) What other upgrade works are planned for the Dobell Building?

Answer-

These questions should be referred to my colleague the Hon. Greg Pearce MLC, Minister for Finance and Services who has responsibility for public housing assets including maintenance.

*1123 AUSTRALIAN OPEN—TRAFFIC AND PARKING ARRANGEMENTS—Ms Kristina Keneally asked the Minister for Tourism, Major Events, Hospitality and Racing, and Minister for the Arts—

Given that the Australian Open will be held from 10-13 November 2011 in the Heffron electorate:

- (1) What, if any, arrangements has the Government put in place to manage traffic and parking to ease the effect it will have on residents in the suburbs of Rosebery, Eastlakes, Mascot, Daceyville and Pagewood?
- (2) What, if any, additional public transport services have been put in place to assist people to access the event and to leave their cars at home?

Answer-

NSW Government agencies have worked with the event organiser to minimise the risk of congestion in the area. Strategies include implementing a road closure, special event clearways, and key messages on the RTA, 131500, events.nsw.gov.au and Australian Open websites. The RTA's Variable Message signs are also being used to communicate to drivers about the event.

Spectators are being encouraged to catch the train to Mascot station and take a free shuttle bus to The Lakes Golf Course. The shuttle bus is operating all day on a continuous loop.

The event organiser has arranged for a public event car park to be available at Moore Park from Tuesday to Sunday at a cost of \$20 per day. From Moore Park, there is a complimentary shuttle bus service on a continuous loop between the car park and the Lakes Golf Course.

*1124 AUSTRALIAN OPEN—TRAFFIC AND PARKING ARRANGEMENTS—Ms Kristina Keneally asked the Minister for Transport representing the Minister for Roads and Ports—

Given that the Australian Open will be held from 10-13 November 2011 in the Heffron electorate:

- (1) What, if any, arrangements has the Government put in place to manage traffic and parking to ease the effect it will have on residents in the suburbs of Rosebery, Eastlakes, Mascot, Daceyville and Pagewood?
- (2) What, if any, additional public transport services have been put in place to assist people to access the event and to leave their cars at home?

Answer—

I am advised:

(1) The Australian Golf Open 2011 was held at The Lakes Golf Club from Tuesday 8 November to Sunday 13 November. The event ran from 5.00 am to 8.30 pm each day.

The traffic and transport arrangements put in place were successful. There were no major impacts to local residents and businesses, who were able to access the roads at all times during the event.

The volume of traffic in the local area was not significantly increased and there were no additional delays to local road users.

(2) There were some road closures in place in Eastlakes during the event. However, local residents, buses and taxis were still permitted to access the closed roads. There were no road closures or special event clearways in Rosebery, Daceyville or Pagewood.

Special event clearways were put in place in Eastlakes and Mascot during the event to assist with public transport shuttle drop off and pick up areas. Local residents and other road users were not permitted to park in these areas from 5.00 am to 8:30 pm for the six days of the event.

To reduce the number of vehicles using local roads and impacting on residents, spectators were encouraged to travel to and from the event by public transport.

Variable Message Signs (VMS) and media alerts encouraged people to take regular train services to Mascot Train Station then a courtesy shuttle bus from there to the golf course.

Those spectators who did drive to the event were advised to use public car parking facilities located at Moore Park then catch a courtesy bus shuttle from there to the golf course.

These shuttle bus services were well utilised.

This year there was also a second entrance gate to the golf course on Slattery Place near Gardeners Road. Shuttle buses from Mascot Train Station arrived and departed from the Gardeners Road gate while shuttles from Moore Park picked up and dropped off at the Vernon Avenue gate.

The additional gate channelled people arriving and departing the venue from two points, reducing crowding and moving people more efficiently. It also meant fewer shuttle buses on local roads.

*1125 HEALTH DIRECT TELEPHONE SERVICE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the Health Direct telephone service.

In view of your previous opinion that "this hotline has potential to be dangerous and akin to an internet diagnosis" and that "a phone number cannot replace face-to-face diagnosis and that anything which discourages seriously ill people from attending hospital or seeing the doctor could cost lives" and "unfortunately that could be the consequence of this phone number" (press release 24 August 2008):

- (1) Will the Minister commit to continuing the Health Direct service?
- (2) Does the Minister still hold the same views regarding the Health Direct service?

Answer-

- (1) Yes. NSW has committed to continuing to work with the Australian Government, and the governments of ACT, NT, SA, Tasmania and WA, to ensure the ongoing provision of the "healthdirect Australia" service.
- (2) "healthdirect Australia" does not provide diagnostic advice. Registered Nurses provide callers with health triage and advice and encourage them to seek health care most appropriate to their needs.
 - Health care options recommended by "healthdirect Australia" nurses could include transfer to triple zero to activate an ambulance response, attendance at a hospital emergency department, or a visit to a general practitioner within a certain timeframe.
- *1126 BRAIN INJURY RECOVERY CENTRE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to your previous call for funding and establishment of a dedicated brain injury recovery centre, such as in the Victorian program (press release 4 December 2007):

- (1) (a) Does the Minister have plans to construct and fund such a centre?
 - (b) If so, where?
- (2) What funding enhancements would be provided by the Government?

Answer—

I am advised:

(1) and (2) While there are no current plans to fund a dedicated brain injury recovery centre in NSW, services for people with Acquired Brain Injury are currently being examined through a collaborative partnership between the Ministry of Health and the Department of Family and Community Services, Ageing, Disability and Home Care.

The model of brain injury rehabilitation in NSW is different from Victoria. In NSW, the Brain Injury Rehabilitation Program is funded for severe Traumatic Brain Injury (TBI), and is integrated with health services and available to both public and compensable clients. In Victoria, specialised TBI rehabilitation is generally only available to people in receipt of compensation and occurs separately to the public health system or is project funded as a one-off program.

- *1127 ABORIGINAL HEALTH—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) What plans does the Government have to expand access to health care services for the Aboriginal community, particularly in rural areas, to reduce avoidable hospital admissions?
 - (2) How much funding has been allocated in the 2011-12 budget?
 - (3) In which areas will these projects be located?

Answer-

I am advised that:

(1) to (3) Specific funding is allocated towards the provision of supplementary health services to Aboriginal people with a focus on health promotion, health education and disease prevention. This encompasses building regional partnerships to provide health services, raising the health status of Aboriginal people and promoting a healthy lifestyle within Aboriginal communities.

Funding in the 2011-12 State Budget is included in Budget Paper 3, page 6-16, and includes over \$97 million specifically allocated for Aboriginal Health Services. This reflects an increase of more than \$8 million over expenditure incurred in 2010-11 on Aboriginal Health Services.

This includes funding for the following specific initiatives:

"Living Well: the NSW Aboriginal Health Chronic Care Initiative" The "NSW Health Chronic Care for Aboriginal People Program"

"One Deadly Step"

The "NSW Connecting Care Program"

*1128 REEFWAY ENVIRONMENTAL SERVICES—Ms Clover Moore asked the Minister for the Environment, and Minister for Heritage—

With respect to ongoing complaints about air pollution from Reefway Environmental Services, which collects and recycles construction waste in Alexandria:

- (1) What assessment has the Government carried out on air pollution from this activity?
- (2) What review has been carried out of the licence conditions for this activity to operate in the inner

city?

- (3) What measures have been imposed or agreed to prevent future pollution, and how effective have these measures been?
- (4) What further plans does the Government have to ensure that adjacent residents and businesses do not experience air pollution from this activity?

Answer-

I am advised as follows:

(1) An assessment of potential issues relating to air emissions at the site was undertaken during the initial development consent approval process by South Sydney City Council. Further assessment was undertaken by the Environment Protection Authority (EPA) upon receipt of an application for an environment protection licence lodged by Reefway Environmental Services in 1997.

Since the environment protection licence was issued in 1997, ongoing monitoring of the site has been undertaken through announced and unannounced site inspections by authorised officers of the EPA, used to assess compliance with licence conditions and environment protection legislation.

- (2) Statutory licence reviews are undertaken by the EPA every five years. The last licence review was completed in 2008. A pollution reduction program requiring a reduction of stockpile heights and an upgrade of the dust suppression system was placed on Reefway's licence in September 2011 as a result of EPA's review of the ongoing environmental performance of this activity. A recent inspection of the facility has confirmed that Reefway has complied with the pollution reduction program.
- (3) The following measures have been imposed by the EPA to prevent pollution from the site:
 - (i) issuing of a penalty notice on 22 September 2011 for \$1,500 to Cardinal Group for inadequate controls in place to manage dust and contaminated wash water at the premises;
 - (ii) a requirement to upgrade the dust suppression spray system at the facility; and
 - (iii) a requirement to limit the height of materials stockpiled at the facility to 3 metres.

These requirements were due for completion by 7 November 2011. Recent inspections have confirmed that Reefway has complied with the pollution reduction program.

Reefway has also undertaken to employ a street sweeper to operate on O'Riordan Street each workday and to repair the windbreak fencing around the facility boundary line.

The EPA's environment line has not received any reports of air pollution from the facility since 12 October 2011.

(4) The EPA will continue to undertake both announced and unannounced inspections of the site to assess compliance with licence conditions and environment protection legislation.

Answer-

Answer-

No decision has been made to privatise Cessnock Correctional Centre.

- *1137 CESSNOCK HOSPITAL—Mr Clayton Barr asked the Minister for Health, and Minister for Medical Research—
 - (1) What future improvements are planned for Cessnock hospital?
 - (2) Will the Government deliver any new resources to the hospital?

Answer-

I am advised:

- (1) and (2) In 2011-12 the Government has committed:
 - A total of \$500,000 for the purchase of 60 new electric beds for the Cessnock and Kurri Kurri hospitals.
 - \$500,000 to commence planning for the announced \$2 million redevelopment of the Cessnock Emergency Department.

*1139 HOUSING NSW AND COMPASS—Mr Clayton Barr asked the Minister for Family and Community Services, and Minister for Women—

For public housing in the Electorate of Cessnock, managed by both Housing NSW and Compass:

- (1) How many houses are currently unoccupied?
- (2) Why are they unoccupied?

Answer-

(1) and (2) The number of properties managed by Housing NSW that are vacant in any area changes on a daily basis as properties are vacated by tenants, cleaned and repaired ready for the next tenant, as is required under the Residential Tenancies Act and are then re-occupied. Generally, the vacancy rate of public housing is lower than that of the private rental sector at any given time.

The number of vacant properties managed by Compass is unavailable as this community housing provider is a non government organisation, independent of government.

Planning is currently in progress for a 14 bed new build ortho-geriatric rehabilitation unit at Kurri Kurri Hospital scheduled for completion in February 2013. The 14-bed unit will focus on rehabilitation for patients who have undergone orthopaedic surgery, particularly elderly patients and is part of the COAG subacute program. The Kurri Kurri unit is part of the 30 new subacute beds for the Hunter to assist patients recovering from surgery or who need extra care before returning home. Eight interim beds are scheduled to open in November 2011 following minor capital works within the main hospital building.

(1) and (2) The Government's 2.5% public sector wages policy is not a cap, but a minimum. A 2.5% increase in wages is not a reduction. The Government's 2.5% public sector wages policy is the same as the 2.5% public sector wages policy of the former Government.

There have been no cuts to teaching positions or wages and the recruitment of quality teachers to NSW public schools continues to be a high priority of the NSW Government.

- *1147 TASKFORCE ON ABORIGINAL AFFAIRS—Ms Linda Burney asked the Minister for Citizenship and Communities, and Minister for Aboriginal Affairs—
 - (1) What priority issue does the Taskforce on Aboriginal Affairs intend to examine first?
 - (2) Is there a budget attached to the Taskforce?

Answer-

- (1) The Ministerial Taskforce on Aboriginal Affairs (the Taskforce) has been established to produce a new Aboriginal affairs strategy. It will include concrete reforms around the following Terms of Reference:
 - 1. to improve service delivery and accountability in Aboriginal affairs, with particular consideration of the recommendations of the Auditor General's report on Two Ways Together, and other arising reports;
 - 2. to improve educational outcomes for Aboriginal people in NSW; and
 - 3. to improve employment outcomes for Aboriginal people in NSW.

Critical issues such as juvenile detention rates, health and housing will be considered through the framework of education and employment, as these are the two areas that have been identified as vital to achieving generational change. Effective reform in education and employment will help to reduce many of these problems.

The new strategy will be finalised by the end of 2012.

- (2) The operating expenses of the Taskforce are being met from within existing resources.
- *1148 CUTS TO THE OFFICE OF ABORIGINAL AFFAIRS—Ms Linda Burney asked the Minister for Citizenship and Communities, and Minister for Aboriginal Affairs—

Which important programs and support services will be cut or reduced because of the \$8 million cut in the budget of the Office of Aboriginal Affairs?

Answer-

There will be no cuts or reductions to the programs and services of Aboriginal Affairs as a result of this year's budget.

The 2010-2011 NSW Treasury allocation to the Aboriginal Affairs was \$27 million. This was subsequently supplemented by an additional amount of \$1.5 million carried over from 2009-2010 for precommitted activities relating to the Safe Families program.

The NSW Treasury allocation for 2011-12 is \$21.23 million which is approximately \$5.8 million less that the initial allocation for 2010-2011.

The reduction is predominantly the result of the completion in 2010-2011 of the ten-year \$240 million Aboriginal Community Development Program. The completion of this program results in a reduction to the annual budget allocation to the Office of Aboriginal Affairs of \$5.281 million.

All of the budget of the ACDP was expended at the end of June (with some carry-over funds still to be spent in 2011-12 to allow previous ACDP commitments to be met).

Other programs, including Commonwealth programs, are in place to continue to address significant housing, infrastructure and other needs in Aboriginal communities.

In NSW, these new initiatives are currently worth more than \$40 million per year. Replacement programs include the Aboriginal Communities Water and Sewerage Program and Remote Indigenous Housing National Partnership (RIHNP). As these programs are not delivered through Aboriginal Affairs the budgets are allocated to the responsible departments.

In addition, the completion of funding for components of the Commonwealth funded COAG Data Gaps programs, and the Commonwealth Department of Education, Employment and Workforce funded Economic Development Officer network resulted in a further reduction to the 2011-2012 allocation of \$0.788 million. Escalation and other minor adjustments account for all other differences.

- *1153 HIGHWAY SAFETY AUDIT—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—
 - (1) What was the outcome of the highway safety audit?

Capricorn Corner safety work of \$3.4 million was completed in January 2010, Gounyan Curves safety work of \$22 million is expected to be completed in early 2012, and further safety work is being planned for 2012 and 2013.
- (5) The federal funding is for planning and safety works only. The timing for the start of constructing a dual carriageway has not been determined.
- *1155 BEGA BYPASS—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

- *1162 SCHOOL ZONE FLASHING—Mr Robert Furolo asked the Minister for Transport representing the Minister for Roads and Ports—

With regards to the School Zone Flashing Lights program:

- (1) What is the total number of school zone flashing light devices installed and operating in NSW as at 26 March 2011?
- (2) What is the total number of school zone flashing light devices installed in 2010-2011 financial year?
- (3) What was the total cost of purchasing and installing school zone flashing light devices in 2010-2011?

- (4) What is the total budget for purchasing and installing school zone flashing light devices in 2011-2012?
- (5) What is the total number of school zone flashing light devices to be installed in 2011-2012?

Answer-

I am advised:

(1) to (4) As at 26 March 2011 there were 570 school zones with flashing lights installed and operating in New South Wales. This includes 411 school zones with flashing lights installed from 24 March 2007 to 26 March 2011 in the last four years of the previous Government.

The NSW Government made a four-year \$13 million commitment to fast track the installation of school zone flashing lights. This will result in the installation of approximately 540 flashing lights in school zones, or 135 sets per year, at an approximate cost of \$3.25 million per year.

In addition, the NSW Government oversaw the installation of an additional 119 sets of school zone flashing lights since the March 2011 state election to 30 June 2011.

This means in the four years of the current Government it is expected an additional 659 school zones will have flashing lights installed, more than doubling the number of school zones with flashing lights in one term of Government.

These numbers are Government funded installations only. Some schools have had flashing lights installed independently.

- *1163 TILLEGRA DAM—Ms Sonia Hornery asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
 - (1) What does the Government intend to do with the land it is refusing to sell back to a former landowner on the Tillegra Dam site?
 - (2) Is the Government intending to resurrect the Tillegra Dam project.

Answer-

(1) The management and future use of Hunter Water owned land in the Williams River Valley requires a long term strategy.

Hunter Water has contacted former land owners with first right of refusal clauses in their sales contracts to discuss their intentions to purchase land at a time when the property is offered for sale.

Hunter Water will continue to develop a strategy for the land, in conjunction with Dungog Shire Council, relevant government planning authorities and stakeholders, with further announcements to be made in due course.

- (2) The previously proposed Tillegra Dam was refused planning approval because of unacceptable environmental impacts and insufficient justification. It will not be considered among the range of options being investigated to secure Lower Hunter's water supply.
- *1164 REGISTERED DENTAL PROFESSIONALS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to registered dental professionals in NSW:

- (1) How many FTE dentists are employed in the NSW public health system?
- (2) How many positions are vacant?
- (3) How many FTE dental therapists are employed in the NSW public health system?
- (4) How many positions are vacant?
- (5) What enhancements for dental services are provided by the minister in the 2011 budget?

Answer-

I am advised:

(1) to (5) Dental workforce data will be available in the NSW Health Annual Report which is scheduled for release in late November 2011.

Three enhancements of services are planned for the expansion of Aboriginal oral health services delivered via Katungal Aboriginal Medical Service, Orange Aboriginal Medical Service, and via the Bila Muuji group of Aboriginal Medical Services.

*1165 DENTAL WAITING LISTS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

Data requested for 30 June 2010 is not available as the Local Health Districts were not in existence at this time.

*1166 HYDROTHERAPY POOL—ROYAL NORTH SHORE HOSPITAL SITE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

What plans does the Minister have for a hydrotherapy pool on the Royal North Shore Hospital site?

Answer-

I am advised:

An expert panel chaired by Dr Peter Kennedy, Deputy Chief Executive of the Clinical Excellence Commission recommended that a hydrotherapy service should be provided within each health service (now known as Local Health Districts), and that such a service should be provided on the lower north shore

The redevelopment of Ryde Hospital, including Graythwaite, is part of the North Shore Ryde Health Service and includes a substantial hydrotherapy pool.

Clinical hydrotherapy outpatients currently receive treatment at nearby Greenwich Hospital and inpatients requiring hydrotherapy receive treatment at the Royal Rehabilitation Centre, Sydney.

I have asked the Chair of the Northern Sydney Local Health District to provide me with advice with respect to the establishment of another Hydrotherapy Pool at Royal North Shore Hospital.

*1167 GRAFFITI—ALTERNATIVE SOLUTIONS—Ms Tania Mihailuk asked the Attorney General, and Minister for Justice—

Given that the Graffiti Amendment Bill has not been passed by Parliament, will the Government consider alternate solutions to the graffiti problem such as providing funds to local councils?

Answer-

I am advised:

The Graffiti Amendment Bill was introduced by the Government to enact measures which were designed to effectively combat the scourge of graffiti in our community and to deliver on an election promise. The Government remains committed to enacting the Graffiti Amendment Bill.

The Department of Attorney General and Justice has in place measures to combat graffiti described below. These measures are not considered by the Government as alternate solutions but as part of an overall strategy which includes the measures proposed in the Graffiti Amendment Bill.

The measures in place to combat graffiti include:

The grant process under Part 4 of the Children (Protection and Parental Responsibility) Act 1997. This allows any council with an endorsed Crime Prevention Plan to request funding for crime prevention programs that aim to target identified problems within their Local Government Area (LGA) including graffiti vandalism.

The Crime Prevention Through Environmental Design (CPTED) Graffiti Hotspot Program. This program provides funds to local councils that have a high incidence of graffiti vandalism to develop initiatives to aid in the removal of graffiti and to prevent its reoccurrence. In 2011, funding is being targeted towards local councils that have not been previously funded under the scheme but have a demonstrated graffiti problem.

For the past two years, the Department has provided funding for the annual Graffiti Action Day. This event provides an opportunity to local councils and local community members to become actively involved in removing graffiti from their local environment.

*1168 RIFLE SHOOTING IN PUBLIC SCHOOLS—Ms Tania Mihailuk asked the Minister for Education—

In reference to your previous answer to Written Question 0601 - Rifle Shooting in Public Schools:

Will the Minister commit to ensuring that rifle practice is not introduced into any school in the Bankstown electorate?

Answer-

I refer to the answer provided in Written Question 0601, which clearly states that the Devolution of Decision Making to Schools memorandum (1991-020) enables school principals to manage and coordinate their school sport operations to suit the circumstances of the local school community and its students.

*1169 HENRY LAWSON DRIVE UPGRADE—Ms Tania Mihailuk asked the Minister for Transport representing the Minister for Roads and Ports—

In reference to your previous answers concerning Henry Lawson Drive and given that the then Liberal candidate for East Hills committed to upgrading Henry Lawson Drive in the election pamphlet "Glenn Brookes Real Change for East Hills":

- (1) Why did you state in your answer to Written Question 0409 regarding Henry Lawson Drive "Delivering any projects outside the current capital program and our election commitments is extremely difficult"?
- (2) When will the Government commit to upgrading this vital arterial road?

Answer-

I am advised:

- (1) The NSW Government inherited a \$5.2 billion blackhole from the former State Labor Government making it very difficult to deliver any projects outside the current capital program and our election commitments. The Member for East Hills is fighting for an upgrade to Henry Lawson Drive as he promised to do and has met with me to discuss funding options.
- (2) The performance of Henry Lawson Drive will continue to be monitored and if any upgrades are considered these projects will be considered in future budgets.
- *1170 ADDITIONAL RAIL SERVICES—Ms Tania Mihailuk asked the Minister for Transport—

In reference to the Government's recent announcement of 63 additional rail services on the Western, South Coast, North Shore, Illawarra and Blue Mountains lines:

- (1) What was the basis for increasing services to these particular lines?
- (2) What advice or recommendations did you receive from the Department of Transport concerning the need for increased services throughout the CityRail network?

Answer-

- (1) I am advised that the basis for providing additional services on these lines was increasing passenger demand.
- (2) Transport for NSW worked with RailCorp in analysing demand and operational data in developing

the new timetable.

*1171 BANKSTOWN LINE SERVICES—Ms Tania Mihailuk asked the Minister for Transport—

In reference to the Government's recent announcement of 63 additional rail services on the Western, South Coast, North Shore, Illawarra and Blue Mountains Lines, why was there no increase of services on the Bankstown Line?

Answer-

I am advised:

Patronage and reliability data and customer feedback relating to the Bankstown Line is being further considered as part of the fundamental review of the CityRail timetable.

- *1172 RESTRICTIONS ON TEMPORARY ACCOMMODATION—Ms Tania Mihailuk asked the Minister for Family and Community Services, and Minister for Women—
 - (1) Has the Minister or any member of her staff issued instructions to regional Housing NSW Offices to enforce restrictions on temporary accommodation to an absolute maximum of 28 days?
 - (2) What action will the Minister take to prevent vulnerable residents in Bankstown currently residing in temporary accommodation from being forced to live on the streets?

Answer-

(1) and (2) There has been no change to Housing NSW's Private Rental Assistance Policy in regard to Temporary Accommodation.

The length of Temporary Accommodation assistance offered is based on an assessment of a client's immediate housing needs. There is no automatic entitlement to a specific period of assistance.

The total assistance provided will not exceed 28 days in a 12-month period other than in exceptional circumstances, and in this instance, a maximum of 14 days may be approved at any one time. Each extension is subject to assessment.

It is a condition of receiving Temporary Accommodation that clients assist themselves by seeking accommodation, whether longer term housing or alternative short term accommodation.

Under the Rentstart scheme, Housing NSW provides a range of financial assistance for eligible clients including those facing homelessness to help them set up or maintain a tenancy in the private rental market.

*1173 STRONGER TOGETHER TWO—Ms Tania Mihailuk asked the Minister for Ageing, and Minister for Disability Services—

When do applications for "Stronger Together Two" funding open?

Answer-

The 2011-12 Budget has allocated a total of \$2.8 billion to Ageing, Disability and Home Care (ADHC), an increase of \$341.6 million over the previous year.

This will fund the continued increase in existing services, such as therapy, respite, supported accommodation, case management, post school programs and development of new programs to help support people with a disability, their carers and families. This also includes a range of community support services to frail older people, younger people with a disability and their carers.

Funding will be available as ST2 programs and services are delivered. Applications for funding will be managed by program areas or by ADHC regions. Information about applications for program funding, including timeframes will be made available in line with ADHC's procurement framework.

- *1174 BANKSTOWN HOSPITAL—RADIOTHERAPY FACILITIES—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—
 - (1) How many patients within the Bankstown and East Hills electorates presently travel to Liverpool Hospital or other facilities to receive radiotherapy treatment?
 - (2) Will the Government install radiotherapy facilities at Bankstown Hospital?

Answer-

- (1) and (2) NSW Health does not allocate resources or provide services on the basis of electorates. A new private centre with two linear accelerators at Hurstville is understood to be scheduled to become operational early in 2012.
- *1175 FUNDING FROM GRANTS PROGRAMS—Ms Tania Mihailuk asked the Minister for Ageing, and Minister for Disability Services—

In reference to your answer to Written Question 0605 - Recreation Sports and Aquatics Club:

Given that applications for the Sport and Recreation Participation Program have now closed and applications for Stronger Together Two are yet to open, what other grants programs exist from which the RSAC might be eligible to receive funding?

Answer—

Funding under Stronger Together Two will provide an additional 4,500 flexible respite places over the next five years. Stronger Together Two has a focus on increasing flexible respite options that maximise social inclusion, including delivering new recreation and leisure focused respite options.

Implementation of the additional flexible respite places is commencing in early 2012. Stronger Together Two provides increased opportunities for people to exercise more choice and control over their supports and funding arrangements. The Recreation Sports and Aquatic Centre is one provider that families and carers may choose to access services from.

*1176 ELECTION FUNDING EXPENDITURES AND DISCLOSURES BILL 2011—Ms Tania Mihailuk asked the Attorney General, and Minister for Justice—

With respect to the Election Funding Expenditures and Disclosures Bill 2011, what advice have you received regarding the Bill's impact on restricting the constitutionally implied freedom of political communication in NSW?

Answer-

I am advised:

As these matters fall within the portfolio responsibilities of the Premier, this question should be directed to the Premier.

*1178 ELECTION FUNDING EXPENDITURES AND DISCLOSURES BILL 2011—Ms Tania Mihailuk asked the Premier, and Minister for Western Sydney—

Has the Premier or his office received any advice suggesting that the Election Funding Expenditures and Disclosures Bill 2011 might be unconstitutional or have an adverse impact on democracy in our State?

Answer-

As stated in the Premier's Agreement in Principle speech on 12 September 2011:

"[The Premier] believe[s] that a ban on donations other than those by individuals does not place unreasonable restrictions on the implied freedom of political communication mandated by the Commonwealth Constitution. The measures in this bill are designed to rid this State of the risk, reality and perception of corruption and undue influence. To this end, they are consistent with the principles endorsed by the High Court in the Lange case".

*1179 LOCAL GOVERNMENT AMENDMENT BILL 2011—Ms Tania Mihailuk asked the Premier, and Minister for Western Sydney—

Given that you invited all Councils to your Destination 2036 Forum and asked for submissions from these councils concerning the outcome of the forum to be provided to your office by 4 November, why did you introduce the Local Government Amendment Bill 2011 on 12 October?

Answer-

I am advised:

The proposals in the Local Government Amendment Bill 2011 are designed to assist councils to improve both their efficiency and standards of service.

*1180 ANTI-SOCIAL BEHAVIOUR—Ms Clover Moore asked the Minister for Family and Community Services, and Minister for Women—

Noting that an increasing proportion of Housing NSW tenants have high levels of complex needs that may sometimes be linked with neighbour disputes, and Anti-Social Behaviour Officers have been

appointed to work with these tenants to provide support and prevent impacts on neighbours and the community:

- (1) How many Anti-Social Behaviour Officers were available in the inner city in 2005, and how many are available in 2011?
- (2) What is the average caseload for each Anti-Social Behaviour Officer?
- (3) What training do these officers provide to Client Service Officers and other Housing NSW officers?
- (4) How many training programs have been run in the inner city over the past five years, and how many Housing NSW staff have been trained?
- (5) How many complaints did Housing NSW receive each year for the past three years from inner city tenants about safety and amenity impacts from neighbours' anti-social behaviour?
- (6) What strategies does Housing NSW use in the inner city to prevent and minimise neighbour disputes?
- (7) What allocation policies does Housing NSW have to prevent these concerns?
- (8) How does Housing NSW use these allocation policies to prevent anti-social behaviour between neighbours?
- (9) What plans does the Government have to increase the number of Anti-Social Behaviour Officers and increase support to tenants with high levels of complex needs?

Ancwer_

- (1) to (4) In 2005, there were no dedicated anti-social behaviour officers in the Inner City Area. Currently, in 2011 there are staff who are dedicated to Anti-Social Behaviour management. Caseload is on average around 10 cases at any one time. The Anti-Social Behaviour staff run training sessions with front line staff and a large number of staff have attended these sessions over the past five years.
- (5) Housing NSW does not keep data in this form.
- (6) to (8) Housing NSW has a "During a Tenancy" policy which is available on its website and includes details about "Being a Good Neighbour". Housing NSW also regularly liaises with NSW Police and other community stakeholders to prevent and minimise neighbour disputes.
- (9) Housing NSW has no plans to increase the number of anti-social behaviour officers in the inner city area.
- *1181 HOUSING AND MENTAL HEALTH AGREEMENT—Ms Clover Moore asked the Minister for Family and Community Services, and Minister for Women—

Noting the NSW Ombudsman's 2009 recommendations that the "Joint Guarantee of Service for People with Mental Health Problems and Disorders: Living in Aboriginal, Community and Public Housing" (JGOS) being redeveloped into a "Housing and Mental Health Agreement":

- (1) What action has been taken in response to the 2009 report and its recommendations?
- (2) What changes have been made to:
 - (a) Governance and links with the Human Services Accord;
 - (b) Data collection and analysis;
 - (c) Information, training and support to agency officers;
 - (d) Operating procedures and systems;
 - (e) Information sharing amongst agencies;
 - (f) Links and relationships at local level;
 - (g) Discharge planning;
 - (h) Developing a "supportive tenancy management" approach?
- (3) What has the data collection from this agreement shown about community need and service gaps for people with a mental illness living in social housing?
- (4) What further plans does the Government have to improve the operations of this agreement and achieve better outcomes?

Answer-

- (1) and (2) A new Housing and Mental Health Agreement has been finalised between the Department of Family and Community Services and NSW Health and will be available on the Department's website shortly.
- (3) The Agreement is based on research that people with mental health problems and disorders often have difficulty accessing and maintaining affordable housing without appropriate mental health and accommodation support.
- (4) Plans for the implementation of the Agreement are currently underway.

*1182 ASSISTANCE ANIMALS—Ms Clover Moore asked the Minister for Ageing, and Minister for Disability Services—

Noting that assistance animals include companion animals that help with sight impairment, hearing impairment, limited mobility and mental illness including anxiety and depression:

- (1) What registration system does the NSW Government operate to provide authorisation that companion animals are assistance animals?
- (2) What rules apply about access to public space, public transport, taxis, shops and service providers etc?
- (3) How does the Government promote the value of assistance animals and relevant regulations?
- (4) What assessment has the Government made of an expanded scheme for registration of assistance animals?
- (5) What action has the Government taken to coordinate a national scheme for assistance animals?
- (6) What plans does the Government have to increase community knowledge, use and acceptance of assistance animals?

Answer—

The legal basis for allowing people to be accompanied by assistance animals comes primarily from the Disability Discrimination Act 1992 (Cth) (the Act). The Act defines assistance animals as animals accredited under a law of a State or Territory that provides for the accreditation of animals trained to assist a person with a disability or accredited by an animal training organisation prescribed by the regulations (none prescribed to date). The Act also allows occupiers of premises or facilities to require identification of an assistance animal.

(1) Assistance animals are recognised in NSW under the Companion Animals Act 1998 for the purposes of registration, and to entitle people with an assistance animal to enter certain public premises. Although it covers the issue of lifetime registration for such animals, the principal object of the Companion Animals Act 1998 is to provide for the effective and responsible care and management of companion animals.

Assistance animals are registered by Local Councils. The Division of Local Government has issued a Guideline on the exercise of functions under the Companion Animals Act 1998 to provide advice to Local Councils.

- (2) As a mobility aid, an assistance animal (Guide Dog/Seeing Eye Dog) is permitted by law to accompany their owners in all public places including shops, hotels, motels, pubs and clubs, restaurants, places of worship, and in taxis, buses and trains. These rights are covered by the following legislation:
 - Disability Discrimination Act 1992 (Cth)
 - Anti-Discrimination Act 1977 (NSW)
 - Companion Animals Act 1998 (NSW)
 - Passenger Transport Act 1990 (NSW)
 - Rail Safety Act 1993 (NSW)

NSW Transport does issue Assistance Animal Permits for free travel on public transport (buses, trains, taxis and ferries) but requires applicants to produce a certification for their assistance animals. People travelling with a Guide Dog, a Hearing Dog (accredited by Lions Australia Hearing Dogs) or a Police Dog, are not required to obtain an Assistance Animal Permit as these animals are assumed to be easily recognisable as being highly trained and not posing any risks to other passengers or staff. However, if the owner is requested by a transport officer to provide proof of the dog's status as an assistance animal, they will need to provide a copy of the animal's certification.

- (3) and (6) The NSW Government endorses the excellent work of voluntary organisations such as the NSW Guide Dogs Association, Vision Australia and the Lions Club Hearing Dogs in training and providing assistance dogs for people with a disability and in promoting the awareness and acceptance of assistance animals in the community. The Government does not at this stage plan to undertake any public awareness campaigns focusing on the use of assistance animals. The NSW Government however is about to conduct an extensive public awareness campaign the Don't DIS My ABILITY campaign starting in November to grow awareness about the achievements, diversity and aspirations of people with a disability.
- (4) and (5) The NSW Government is aware of the changes to the Disability Discrimination Act 1992 (Cth) that have strengthened the definition of assistance animals and appropriate changes have been made to NSW legislation such as the Companion Animals Act 1998 and the Rail Safety (Offences) Regulation 2008 and Passenger Transport Regulation 2007, amongst others. Information about the recognition of

assistance animals under the Companion Animals Act 1998 is provided through the website of the Division of Local Government, Department of Premier and Cabinet at

Information about Assistance Animal Permits is available at

NSW has been working with other States and Territories and the Australian Government to develop a consistent approach to the identification of appropriately trained guide, hearing and assistance dogs. The development of an agreed consultation paper is progressing and it is anticipated that further work on this Project will be undertaken in 2012.

*1184 ELECTRIC BUSES—Ms Clover Moore asked the Minister for Transport—

- (1) What assessment has the Government carried out on the feasibility and benefit of using electric or hybrid electric buses?
- (2) What other jurisdictions use these buses, how long have they been operating, and what evaluation have they carried out about the value of this type of vehicle?
- (3) What support or help has the Government provided to bus operators to buy or operate electric buses?
- (4) How does the Government ensure that bus operators include criteria about green house gas emissions, and noise and air pollution when choosing buses to buy?
- (5) What further plans does the Government have for introducing and supporting the use of electric or hybrid electric buses?

Answer-

I am advised:

(1) to (5) Information on the hybrid bus trial is available on the Transport for New South Wales website at http://www.transport.nsw.gov.au/content/hybrid-bus-trial

An assessment program for the hybrid bus trial has been initiated with an independent expert company, RARE Pty Ltd. This assessment will review both the operational and economic viability of the hybrid bus.

*1186 PLATFORM 70 PROJECT—Ms Clover Moore asked the Minister for Family and Community Services, and Minister for Women—

With respect to the Platform 70 Project, which will provide supported accommodation for homeless people sleeping rough in the Woolloomooloo precinct:

- (1) What action has been taken to establish and operate this project?
- (2) How many people have been listed for housing with built-in support?
- (3) How many places remain for homeless people needing accommodation with support?
- (4) How many people have been placed into housing to date?
- (5) When does the Government expect that all places will be filled and people housed?
- (6) What plans does the Government have to evaluate this project?

Answer-

- (1) Bridge Housing Limited, a community housing provider, has been contracted by Housing NSW whilst Way2Home, a non-government organisation, will be the primary support partner for the project.
- (2) to (4) 70 private rental tenancies will be made available. To date, approximately 60 clients have been identified for assessment and one client has been housed.
- (5) This is subject to suitable private rental properties being available to Bridge Housing that meet the needs of clients.
- (6) Options for evaluation of this project are being considered.
- *1187 PRISONERS WITH MENTAL ILLNESS—Ms Clover Moore asked the Attorney General, and Minister for Justice—

Noting the Australian Institute of Health and Welfare's report "The health of Australia prisoners 2010" does not include any data from NSW prisons:

- (1) What proportion of NSW prisoners:
 - (a) report having a mental illness;
 - (b) seek psychological and clinic health for mental health concerns;
 - (c) currently take medication for a mental illness;

- (d) who are new to the prison system are referred for mental health assessment or treatment?
- (2) How does the Government ensure that prisoners have access to necessary mental health care and what waiting times apply for treatment?
- (3) How does the Government ensure that all prisoners with a mental illness receive treatment from mainstream mental health services after release?
- (4) Will the Government take part in future National Prisoner Health Census counts and research?
- (5) What plans does the Government have to improve and expand mental health services for prisoners and ex-prisoners?

I am advised:

- (1) to (5) The health (including mental health) of inmates in correctional centres is the responsibility of Justice Health. The question should be directed to my colleague the Minister for Health.
- *1188 WILDLIFE INFORMATION, RESCUE AND EDUCATION SERVICE (WIRES)—Ms Clover Moore asked the Minister for the Environment, and Minister for Heritage—

With regard to the volunteer organisation WIRES, which rescues and rehabilitates native animals:

- (1) What practical support does the Government provide for WIRES, including funding, promotion, training, equipment and facilities?
- (2) How does the Government promote and educate the community about WIRES?
- (3) What further action does the Government plan to support the work of WIRES?

Answer-

I am advised as follows:

(1) The Government provides financial and in-kind support to WIRES and other licensed fauna rehabilitation groups.

For example, in 2010, approximately \$20,000 was provided to local WIRES branches. WIRES branches are also provided with access to other services, such as the use of office photocopiers, phone services, equipment and training room access in local Office of Environment and Heritage (OEH) offices.

In addition, a grant of \$25,000 is provided to the NSW Wildlife Council, the peak body for wildlife carer groups, of which WIRES is a member.

Collectively, WIRES receives funding from OEH, the Environment Trust and the Department of Primary Industries.

- (2) The NSW Government provides information and contact details for WIRES and other wildlife carers through the OEH website. Local OEH officers also promote the work of WIRES and other licensed rehabilitation groups through regular interaction with community groups and members of the public.
- (3) The NSW Government will continue to provide financial and in-kind assistance to WIRES and other licensed wildlife carer groups.

The new Code of Practice for Injured, Sick and Orphaned Protected Fauna, sets benchmark standards for wildlife carer groups and supports the existing training programs run by WIRES and other licensed wildlife carer groups.

- *1189 352 BUS SERVICE—Ms Clover Moore asked the Minister for Transport—
 - (1) What are the monthly patronage numbers for this bus service for 2011?
 - (2) What patterns in patronage has State Transit identified over the past five years?
 - (3) What proportion of 352 bus services are currently accessible?
 - (4) What assessment has the Government made of demand for 352 services outside existing operating hours?
 - (5) What plans does the Government have for improving the 352 bus, including providing a full time bus service?

Answer-

I am advised:

- (1) Route 352 carried 413,004 passengers during the year ended June 2011. Monthly patronage ranged from a low of 25,968 in January 2011 to a high of 45,882 in March 2011. The average monthly patronage figure was 34,417.
- (2) Annual patronage has grown 12,978 (3.2%) from 400,026 (year ending June 2007) to 413,004 (year

ending June 2011) - or an average of 0.5 per cent per annum.

- (3) The street geometry of the route precludes the operation of wheelchair accessible buses.
- (4) and (5) Patronage and operational data and customer feedback is reviewed on a regular basis.
- *1190 HOUSING NSW GUTTERS—Ms Clover Moore asked the Minister for Family and Community Services, and Minister for Women—

With respect to the need for regular cleaning of gutters on Housing NSW buildings in order to prevent blockages and water ingress:

- (2) There are 46 primary school aged children from Murrumbateman, Jeir, Wallaroo, Spring Range and surrounding areas attending NSW public schools in 2011.
- (3) This data is not held by the NSW Department of Education and Communities.
- (4) Despite population growth in the areas of Murrumbateman, Jeir, Wallaroo and Spring Range, there are not sufficient numbers of primary school aged students to justify a new primary school, without jeopardising the viability of existing public schools in Yass.
- (5) Yass Public School and Berinda Public School have sufficient spare capacity to meet current and foreseeable demand for school places in Murrumbateman and surrounding areas. The Government therefore has no plans for reopening Murrumbateman Public School, or for opening a new school at Murrumbateman.
- *1193 GLENMORE PARK HIGH SCHOOL AIR-CONDITIONING—Ms Carmel Tebbutt asked the Minister for Education—
 - (1) How much funding has been allocated in the 2011-12 financial year for the installation of air-conditioning in classrooms at Glenmore Park High School?

*1200 TEACHER RATIOS—FAIRFIELD ELECTORATE—Mr Guy Zangari asked the Minister for Education—

What is the ratio between the number of migrant students and the number of English as a Second Language teachers in the public schools in the Fairfield electorate?

Answer-

In the Fairfield electorate, 8,671 students from language backgrounds other than English are enrolled currently in government primary and high schools. Of these, 5,779 students require English as a Second Language (ESL) support. This support is provided by a total of 82.3 (equivalent full-time positions) specialist ESL teachers. This is a ratio of 1 teacher to 70 ESL students.

The 82.3 specialist ESL teachers provide English language support to students in government primary schools and high schools as well as 2 intensive English Centres, Holroyd and Fairfield Intensive English Centres, located in the Fairfield electorate.

- *1202 ESTIMATE OF QUARTERLY ELECTRICITY CHARGES—Mr Guy Zangari asked the Minister for Resources and Energy, Special Minister of State, and Minister for the Central Coast—
 - (1) Are electricity providers allowed to estimate quarterly electricity charges?
 - (2) If so, what guidelines are in place to regulate the practise?

Answer—

- (1) and (2) The circumstances under which an electricity retailer can estimate a small customer's bill are governed by regulations which require, amongst other things, that:
 - If an estimate is used to calculate an electricity bill, this must be clearly written on the bill.
 - The meter has to be read at least once every six months. This means that generally the next bill following an estimated quarterly bill should be based on an actual meter reading.

The next time the meter is read, the ensuing bill will be adjusted to balance any differences between estimated usage and actual usage. This means there will be no discrepancies overall between the amount of electricity the customer uses and the amount of electricity they are billed for.

When estimating a bill, metering providers (who read the meters or estimate meter reads on behalf of retailers and network businesses) must follow procedures made in accordance with national energy legislation and administered by the Australian Energy Market Operator (AEMO). Non-compliance with these procedures can result in the metering provider losing its accreditation granted by AEMO.

Under new requirements to be in place by 1 July 2012, in some instances, retailers will be required to obtain customer permission prior to estimating electricity bills.

*1203 SAFETY OF WOMEN TENANTS—Mr Guy Zangari asked the Minister for Family and Community Services, and Minister for Women—

What procedures are in place to ensure the safety of women housed in the Department's bed sitter

facilities which have a predominantly male population?

Answer—

Housing NSW works to provide a safe and secure environment for all tenants housed in its properties. A Memorandum of Understanding between NSW Police and Housing NSW ensures close cooperation for the safety of tenants.

Housing NSW tenants are also able to contact NSW Police in the case of an immediate threat of danger to themselves or their property.

Certifiers are agents conducting certifications on behalf of the Government – the Independent Commission against Corruption Act 1988 deems them to be public officials. As such, RMS has a responsibility to ensure that its agents are both competent and fit and proper to hold a licence. The entry criteria for the new scheme have been set to a level commensurate with that responsibility.

(4) The fees for becoming a licensed agent of RMS have been determined in accordance with the normal cost recovery principles of government. As part of the design of the scheme, these costs have been minimised wherever possible.

What is the Government doing to help carers and parents of children with autism in the Cabramatta electorate?

Answer—

In 2011-12 the NSW Government, through Ageing, Disability and Home Care, will invest over \$51 million for families and carers of children and young people with a disability. This investment includes \$4.7 million specifically for autism services.

Examples of supports available to families in the Cabramatta electorate include:

- Learning Links, which, in consortium with Koorana, provides the Early Start Diagnosis Support Program. This program operates in south-west Sydney, including Cabramatta. The diagnosis support worker provides support to families at the time of the child's diagnosis.
- The Early Childhood Intervention Program run by CatholicCare, operates from Cabramatta West. This service aims to assist children reach their potential, and to support families to aid their child's development.
- Learning Links at Mount Pritchard provides services for children from birth up to six years of age, including those who have been diagnosed with autism spectrum disorder.
- CatholicCare provides an intensive family support program in the south west Sydney local planning area (LPA). This service is a short, intensive in-home program to assist families who have a child with a disability where there is a risk of family break-down or of the child being placed out of the home.

Other services funded by the Government include:

 Autism Behavioural Intervention NSW (ABI) Footprints program, is available across Sydney specifically for children with autism. It is a home-based, behaviour intervention program which aims to improve skills and promote positive behaviour across home, child care and community settings.

- Parent Line a counselling, referral and information service for all parents and carers of children from birth to 18 years. This service is staffed by a team of highly qualified counsellors, and is available state-wide 24 hours a day, seven days a week.
- The Family Assistance Fund provides one-off funding for items such as household appliances needed for children with a disability or for access to parenting skills training.

Additionally, the NSW Department of Education and Communities provides services and support for families and carers of children with a disability.

The Australian Government, through Helping Children with Autism, also provides individual funding packages for families who have a child with autism.

Finally, the NSW Government is committed to the expansion of respite opportunities for children with a disability and their families and carers. Additional Stronger Together 2 funding will increase the number of flexible respite options by 4,500 places across the state, at a cost of \$32.2 million. As part of this growth funding, approximately \$3.5 million will be invested in the south west Sydney LPA over the next five years.

Dubbo Base Hospital operates 24 hour counseling and medical service and a telephone counselling service to victims in outlying centres. The staff based at Walgett Hospital are provided with telephone support by the 24 hour counselling service at Dubbo Base Hospital.

Early works and detailed design are anticipated to be coordinated in parallel to this approval process and work is due to commence early in 2012 with completion of all works scheduled by June 2012.

The project is a partnership between the Southern NSW Local Health District and the local community. On site an electric sliding door has been installed to separate the acute area from the high care area and to assist in keeping the residents safe. An update to the existing Nurse Call system has also been completed.

*1237 UNOCCUPIED PROPERTIES—Mr Ryan Park asked the Minister for Family and Community Services, and Minister for Women—

In relation to public housing in the Keira electorate:

- (3) Carers are encouraged to ensure they are receiving full entitlements available through Commonwealth income supports and services.

This change to care allowances will encourage young people's financial independence as they transition from out-of-home care.

As part of this broader focus on leaving care planning, carers are encouraged to negotiate a contribution from the Youth Allowance towards household expenses.

Funding for the construction of a new special needs school at Bass Hill, the George Bass Special Needs School, was approved in the NSW Government 2011-12 Budget. The estimated cost of the project is commercial in confidence. The actual cost of the project will not be known until the tender process is completed.

Construction of the new George Bass Special Needs School is expected to start in late 2012.

*1242 MAJOR EVENTS—Ms Clover Moore asked the Premier, and Minister for Western Sydney—

With respect to the expanding range of major events using public roads, parklands and other public space in the inner city; and the increasing residential population in the same precincts:

- (1) How does the Government consult with inner city residents and businesses adjacent to major event sites who experience traffic, noise and other amenity impacts, in order to prevent and reduce impacts?
- (2) How does the Government ensure that local residents are informed about major events that may

cause traffic and noise impacts?

- (3) What controls for bump-in and bump-out apply to major events to protect adjacent residential amenity?

Answer-

I am advised:

All events in New South Wales are subject to legislation and regulation and event organisers are responsible for meeting the conditions attached to the event under these controls by the various consent authorities, such as local government and various NSW Government agencies.

Consent conditions can include communications strategies to minimise traffic and other disruption to local residents and businesses likely to be impacted by an event, limitations on noise, timeframes to conduct bump-in and bump-out, and requirements to provide additional temporary infrastructure such as temporary toilets.

With regard to strategies for sharing the benefits of major events, this industry sector is a significant contributor to the NSW economy, generating more than half a billion dollars in economic activity annually. Major events bring more visitors to the State and showcase the very best of Sydney and NSW to national and international audiences, providing significant benefits to the state's tourism industry, which supports 165,000 jobs and contributes more than \$28 billion to the economy each year.

The Government works with event organisers, local government and major event stakeholders, including other government agencies and landholders, to ensure whole-of-government coordination for major public events, and as much as possible, to maintain the normal functioning of the city. This includes appropriate communications strategies to minimise the impacts on the non-event public of events likely to have a significant impact on the Sydney CBD and its road network.

*1243 HOUSING NSW MAINTENANCE IN THE INNER CITY—Ms Clover Moore asked the Minister for Family and Community Services, and Minister for Women—

- Housing NSW properties in inner Sydney are some of the oldest and highest density housing in NSW:

With respect to the updated regulations for party boats in order to prevent alcohol-related crime and antisocial behaviour, and noting recent incidents where intoxicated patrons have disembarked at inner city whatves:

- (2) What resources have been allocated to enforcement to ensure responsible management of these operators?
- (3) How are Responsible Service of Alcohol standards enforced on vessels while on water?

Answer-

I am advised:

In November 2010 NSW Maritime, in collaboration with the Commercial Vessels' Association, released the "Code of Conduct for Charter Vessels Managing Passengers and Alcohol" which sets out the guidelines to assist owners and masters of charter vessels used for functions on Sydney Harbour. The code provides specific guidance to vessel operators on managing passengers and alcohol consumption and on reducing antisocial behaviour, including the behaviour of passengers as they embark and disembark.

Roads and Maritime Services conduct night patrols, including joint operations with Water Police and other agencies to identify and remind vessel operators of their obligations. There is increased enforcement during the Christmas and New Year period each year. These patrols have led to fines for non compliance with various regulatory requirements.

In addition Roads and Maritime Services works closely with the commercial vessel industry and individual operators to manage the impact of party boats around residential areas. Industry representatives have been reminded of their obligations with behaviour of party boat customers after disembarking. Operators have also been advised that access to wharves could be denied if such disturbances continue.

Enforcement of Responsible Service of Alcohol standards is a matter for NSW Police and the Office of Liquor, Gaming and Racing.

There has been no formal evaluation of the Hassle Free Nights strategy by Roads and Maritime Services. Compliance activity conducted by Roads and Maritime Services as well as joint operations conducted with other agencies demonstrates the majority of charter boat operators do comply with legislated requirements.

*1245 RTA PROPERTY WOOLLOOMOOLOO—Ms Clover Moore asked the Minister for Transport representing the Minister for Roads and Ports—

- (3) The short-term use of the site involves ongoing operational and maintenance requirements.
- (4) Long-term use of the site is dependent on finalising the stratum survey and future Cross City Tunnel operational and maintenance requirements.

- (5) There are no current plans to carry out any visual amenity improvements, including landscaping.
- (6) There are no current proposals for the land and, accordingly, no consultation has been programmed.
- (7) A decision will be made following completion of the stratum survey and further consultation with the Cross City Tunnel operator.

- *1247 RECOGNITION OF PRIOR EXPERIENCE—Ms Anna Watson asked the Minister for Education—

To attract accomplished professionals into the teaching vocation, will the Minister give a commitment to reinstate recognition for prior experience when it comes to teachers' salaries?

Answer—

The current provisions relating to the policy for determining the commencing salary of teachers were introduced in 2005 under the previous Labor Government.

These provisions streamlined and simplified conditions of employment relating to determining the commencing salary for teachers and were implemented as part of a package of changes discussed with the NSW Teachers Federation.

The NSW Government is committed to attracting and recruiting quality teachers, including teachers with industry and professional experience.

The Department of Education and Communities undertakes assessments of prior service so that each teacher is paid at the salary level appropriate to the range of qualifications and experience that they bring to the role.

In assessing prior service, consideration is given to academic qualifications, previous teaching service, periods of child rearing and service with the Australian Defence Forces during hostilities or peace-keeping.

In addition, recognition of prior non-teaching service is provided for teachers who are employed through specified targeted recruitment strategies, such as the Teacher Education Scholarship program and teachers who identify as Aboriginal or Torres Strait Islanders.
