*2107 HUME FREEWAY FROM ETTAMOGAH TO NSW BORDER—Mr Greg Aplin asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

In relation to the Hume Freeway from Ettamogah to the NSW border:

- (1) What action is the Government taking to address Albury residents' concerns about noise pollution levels created by this road?
- (2) Are there any plans to address the repeated requests from the Albury Chamber of Commerce to provide more adequate signage for town services provided in Albury and Lavington?
- (3) What measures are being taken to reduce traffic congestion and increase safety on and near exit and entry ramps?

Answer—

The Australian and New South Wales governments are committed to upgrading the entire length of the Hume Highway to a four lane divided carriageway by 2012.

I am advised:

The Albury Wodonga Hume Freeway opened to traffic in March 2007.

As part of the project's conditions of approval, a draft noise monitoring report has been prepared by the project contractor. The RTA is currently confirming future traffic predictions for the freeway to use in conjunction with the draft noise monitoring report. The final report will be discussed with the Department of Environment and Climate Change prior to its release expected in by mid 2008.

The RTA advises an additional sign was installed 2 km north of the Jindera exit on 15 March 2008. Another sign was erected on 30 March 2008 at a location 2 km south of the South Albury exit. The signs indicate to motorists services are available from the three Albury exits.

At a meeting on 17 March 2008 the RTA confirmed with the Mayor and council officers that work was underway to address traffic and safety concerns. Some of these enhancements included an additional traffic signal detector loop at Borella Road, roundabouts at Thurgoona Drive off ramps and roundabout at Union/Racecourse Roads intersection.

- *2109 MENTAL HEALTH PATIENT BEDS—CONCORD HOSPITAL—Mr Greg Aplin asked the Minister for Local Government, Minister for Aboriginal Affairs, Minister Assisting the Minister for Health (Mental Health)—
 - (1) How many beds are currently provided for mental health patients at Concord Hospital?
 - (2) Is there a plan to increase the number of beds provided for mental health patients at Concord Hospital?

Answer-

I am advised:

While beds are not specifically provided for mental health patients at Concord Hospital, the newly constructed Concord Centre for Mental Health (collocated with Concord Hospital) will have 174 beds.

- *2110 BUS RAPID TRANSIT SYSTEM—Mr Mike Baird asked the Deputy Premier, Minister for Transport, Minister for Finance—
 - (1) Has the Minister considered the feasibility of a Bus Rapid Transit system on the Northern Beaches?
 - (2) When will a public transport plan for the Northern Beaches be released?

*2111 STAFF TURNOVER—RAILCORP—Mr Mike Baird asked the Deputy Premier, Minister for Transport, Minister for Finance—

What was the staff turnover rate (defined as the percentage of staff who resigned, were terminated or moved to a different department in the NSW public service) at RailCorp every year between 2002 and 2007?

Answer—

I am advised:

Staff turnover data is prepared on a financial year basis and is available to 30 June for each year.

Between 2002 and 2003 the State Rail Authority (SRA) was the supervising authority.

- in the 12 months to 30 June, 2002 the staff turnover rate was 5.13%; and
- in the twelve months to 30 June, 2003 the staff turnover rate was 5.23%.

There is crossover between SRA and RailCorp data in the financial years 2004 to 2006 due to the merger between the SRA and Rail Infrastructure Corporation.

- the staff turnover rate for the period to 30 June 2004 is 5.16%;
- the staff turnover rate for the twelve months to 30 June 2005 is 7.06%; and
- in the 12 months to 30 June, 2006 SRA and RailCorp data has been combined and the turnover rate was 6.01%.

In the twelve months to 30 June, 2007 the staff turnover rate for RailCorp was 5.81%.

*2112 STAFF TURNOVER—DEPARTMENT OF COMMUNITY SERVICES—Mr Mike Baird asked the Minister for Community Services—

What was the staff turnover rate (defined as the percentage of staff who resigned, were terminated or moved to a different department in the NSW public service) at the Department of Community Services every year between 2002 and 2007?

I am advised:

The NSW Department of Premier and Cabinet (DPC), Public Sector Workforce Office, conducts an annual census of all public sector employees of NSW Government agencies. Data is collected from all public sector agencies, including NSW Health, on over 50 employee related items including demographics, employment arrangements and patterns, leave, remuneration and earnings and is published in the Overview Report for the NSW Public Sector Workforce Profile. Annual profiles are available through the DPC web site.

Similarly, information about Area Health Service staffing is published each year in the Area Health Service's Annual Report. I refer the Member to the Northern Sydney and Central Coast Area Health Service annual reports.

*2114 NORTHERN AREA HOSPITAL PLAN-Mr Mike Baird asked the Minister for Health-

When will the Northern Area hospital plan, which the Minister said on 29 November 2007 would be going to Cabinet imminently, be made available?

Answer-

The document is known as the Northern Beaches Health Services Plan.

It is scheduled to be considered by Cabinet shortly. Any advice regarding the release of that document will be determined subsequent to that Cabinet process.

- (1) When will the Roads and Traffic Authority respond to the submissions received in relation to its discussion paper on the Licensing of Older Drivers?
- (2) Does the Minister support a mandatory 10-km restriction for drivers once they turn 85?

*2116 STAFF TURNOVER—DEPARTMENT OF COMMERCE—Mr Mike Baird asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

What was the staff turnover rate (defined as the percentage of staff who resigned, were terminated or moved to a different department in the NSW public service) at the Department of Commerce every year between 2002 and 2007?

Answer-

I am advised:

The Department of Commerce was established on 2 April 2003. The staff turnover rate (defined as the percentage of staff who resigned, were terminated or moved to a different department in the NSW public service) since 2003 is:

2003-04 - 11% 2004-05 - 18% 2005-06 - 10% 2006-07 - 11%

On 2 April 2007 the Office of NSW Businesslink was transferred to Commerce. On 20 April 2007, certain corporate services staff from the former Department of Natural Resources were also transferred to Commerce.

- *2117 DISBANDING OF PUBLIC WORKS DEPARTMENT—Mr Mike Baird asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—
 - (1) What efficiencies have been gained from disbanding the NSW Public Works Department and having projects managed by each Department?
 - (2) What was the total number of people managing infrastructure projects before the Public Works Department was disbanded?
 - (3) How many people currently manage infrastructure projects?

Answer—

I am advised:

The Department of Public Works and Services was incorporated into the newly formed Department of Commerce. The Office of Public Works and Services undertakes the same functions as those carried out by the former Department of Public Works and Services.

This amalgamation was undertaken to deliver greater efficiencies in the delivery of corporate services support to the agencies involved. Savings generated by the amalgamation amount to:

- \$21.9 million in its first year;
- \$41.9 million up until 2005; and
- further savings of \$39 million since 2005.

The Department of Commerce, which includes the Office of Public Works and Services, allocates staff to project management tasks on a needs basis, dependent on the number and scope of projects underway at any one time.

*2118 SPIT-MILITARY ROAD WORKING GROUP—Mr Mike Baird asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

- (1) Has the Spit-Military Road working group made any recommendations to the Government on the corridor?
- (2) Has the Government provided the working group with a deadline?
- (3) How many times has the working group met since it was established in May 2007?

*2121 STA BUSES—EPPING ROAD—Ms Gladys Berejiklian asked the Deputy Premier, Minister for Transport, Minister for Finance—

In relation to STA buses travelling along Epping Road:

- (1) How many services to the city via the freeway currently service the morning peak?
- (2) How many of these services were introduced following the opening of the Lane Cove tunnel?
- (3) How many additional services will be introduced to service the needs of residents in Lane Cove North, heavily reliant on freeway buses to the city?

Answer-

I am advised:

(1) and (2) Information regarding Sydney Buses timetables and services is available on the Sydney Buses website, www.sydneybuses.info.

(3) State Transit will closely monitor demand on this corridor and adjust the level of services as appropriate.

*2122 CHATSWOOD RAILWAY STATION—SIGNAGE—Ms Gladys Berejiklian asked the Deputy Premier, Minister for Transport, Minister for Finance—

What provision is there for signage at Chatswood Railway Station when lifts or escalators are not operational to save the less mobile from further inconvenience?

Answer—

I am advised:

In the event that lifts or escalators are out of service, standard signage is placed on the lift or escalator in order to inform passengers.

In addition, where these services for less mobile passengers are not available at Chatswood Station, the station manager will alert train guards and surrounding stations through the Rail Management Centre, so that passengers can then be advised of any changes to station facilities.

*2123 267 BUS SERVICE—Ms Gladys Berejiklian asked the Deputy Premier, Minister for Transport, Minister for Finance—

In relation to the 267 bus service from Crows Nest to Chatswood (via Northbridge):

- (1) How frequent is this bus service both in peak time and off-peak time?
- (2) What is the on-time running record of the service?
- (3) What action has the Government taken to make the service more reliable?
- (4) Is the Government considering increasing the frequency of the service?

Answer—

I am advised:

(1) to (4) State Transit constantly monitors all bus services to ensure passenger demand is being met.

As demand for services change, appropriate consideration is given to making adjustments to frequency, routes, timetables and stopping patterns.

State Transit is continuing to progress a Service Review Program, to identify routes requiring amendment and provide service levels commensurate with demand.

In addition to the Service Review Program, the Integrated Network plans for all regions are being undertaken, in conjunction with the Ministry of Transport.

Information regarding State Transit's on-time running is reported on as required in its annual report.

- *2136 UNANSWERED CORRESPONDENCE—Ms Katrina Hodgkinson asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—
 - (1) What was the percentage real increase in funding for main roads rehabilitation and construction that Cootamundra Shire Council received from the NSW Government in:
 - (a) 2000-01;
 - (b) 2001-02;
 - (c) 2002-03;
 - (d) 2003-04;
 - (e) 2004-05;
 - (f) 2005-06;
 - (g) 2006-07;
 - (h) 2007-08?
 - (2) What is the actual amount of funding provided by the NSW Government to Cootamundra Shire Council for main roads rehabilitation and construction during 2007-08?
 - (3) Why, despite many calls from my office seeking a response, have you not answered my correspondence 07K014 dated 24 May 2007 (your reference M07/3556)?
 - (4) When will you reply to this letter?

Answer-

I am advised by the RTA the annual allocation for State Roads, including Regional Roads, rehabilitation and construction, varies year by year according to network needs across the State.

Cootamundra Shire Council has recently received a special allocation as a result of additional capital funds being made available in early 2008. In 2007/08 Council received \$1.553 million in funding from the State Government towards its regional road network.

I am advised a response to your correspondence has been sent.

*2137 HOSPITAL FOOD-Ms Katrina Hodgkinson asked the Minister for Health-

- (1) Which hospitals in the Burrinjuck electorate were part of the recent safety audit conducted by the NSW Food Authority?
- (2) If no hospitals in the Burrinjuck electorate took part in this audit, why were they excluded?
- (3) Which of the hospitals participating in the audit met all of the standards covered in the audit?
- Answer—

The NSW Food Authority falls within the Ministerial responsibility of the Minister for Primary Industries and the question should be re-directed accordingly.

*2138 LEGAL COSTS—Ms Katrina Hodgkinson asked the Minister for Community Services—

What was the total legal cost incurred by the Department of Community Services in opposing the Government And Related Employees Tribunal Appeal No. PSD/287/06 heard on 23 January 2007?

Answer—

I understand that the matter was arbitrated on behalf of the Department by staff from NSW Businesslink as part of the shared service agreement between the agencies. No legal fees were incurred by the Department of Community Services.

*2139 MARY GILES WARD—AIR-CONDITIONING—Mrs Judy Hopwood asked the Minister for Health—

- (1) Is cost-cutting the reason the air-conditioning in Mary Giles Ward at Hornsby Hospital is not operational at all times?
- (2) If not, what is the reason the air-conditioning is not working, or turned off for part of the day?
- (3) Are there other wards operating air-conditioning in this manner?
- (4) If so, which wards?

Answer-

I am advised by the Chief Executive of the Northern Sydney and Central Coast Area Health Service:

- (1) The air-conditioning on Mary Giles Ward is operational at all times and there are no periods where it is turned off as a cost cutting measure.
- (2) The air-conditioning system in Mary Giles Ward is being upgraded as part of a scheduled upgrade program. The air-conditioning system is susceptible to malfunction due to lightning strikes which have occurred recently. If the air-conditioning is non-operational due to a lightning strike, it is rectified promptly.
- (3) and (4) There are no wards at the hospital where air-conditioning is operated in the manner suggested in the member's question.

*2140 MARY GILES WARD-BLINDS-Mrs Judy Hopwood asked the Minister for Health-

- (1) Are the blinds in some of the ward areas of the Mary Giles Ward at Hornsby Hospital broken?
- (2) If so, when will the blinds be repaired or replaced?

Answer-

I am advised by the Chief Executive of the Northern Sydney and Central Coast Area Health Service:

(1) and (2) There are no broken blinds in the Mary Giles Ward at Hornsby Ku-ring-gai Hospital. At times some blinds can be difficult to retract from the fully extended position.

All blinds in the ward are part of an ongoing maintenance program and, where necessary, blinds will be resprung or replaced to ensure ease of use for patients.

*2141 AUDIOLOGY CLINIC—HORNSBY HOSPITAL—Mrs Judy Hopwood asked the Minister for Health—

- (1) What is the current status of the Audiology Clinic at Hornsby Hospital?
- (2) Will it reopen?

Answer-

I am advised by the Chief Executive of the Northern Sydney and Central Coast Area Health Service:

(1) and (2) The audiology service provided at Hornsby Ku-ring-gai Hospital has been temporarily closed while a review is conducted to determine the most appropriate model of service delivery for the Hornsby Ku-ring-gai community.

Hornsby Ku-ring-gai Health Service Management are analysing the review data with key stakeholders to determine the preferred model of service delivery. In the interim, all enquiries requesting audiology services are provided with details of other service providers within the region.

- *2144 UPGRADE OF CAPTAIN COOK'S LANDING SITE—Mr Malcolm Kerr asked the Minister for Climate Change and the Environment, Minister for Women, Minister for Science and Medical Research, and Minister Assisting the Minister for Health (Cancer)—
 - (1) How much of the \$5.8 million promised in 2004 has been spent on the upgrade of Captain Cook's Landing Site at Kurnell?
 - (2) What projects have been completed to date?
 - (3) What projects are yet to be completed?

Answer-

- (1) I am advised that approximately \$2.14 million has been spent to date on the completion of a wide range of projects.
- (2) To date a number of projects have been completed, including:
 - new car parks, road and access improvements for the main visitor area;
 - new toilet facilities in the main visitor areas;
 - installation of power to the festival area for ceremonies and special events;
 - picnic area enhancements;
 - a detailed history of the Kurnell precinct of Botany Bay National Park;
 - assessment of the heritage values of the site and completion of a Conservation Management

Plan to ensure heritage protection;

- vegetation history, survey and mapping project, including preparation of a definitive list of plant specimens collected by Banks and Solander;
- restoration of the Endeavour cannon and return of this item to display;
- assessment and recommendations for the historic ferry shelter shed;
- a community oral history project, for use in interpretation of the site;
- feasibility analysis for a catering outlet and meeting facilities; and
- interpretation, landscape and architectural design for the next stage of works.
- (3) Projects to be completed in the next stage include:
 - an interpreted walking track (the Burrawang Walk) with historical information about the site;
 - the 'Meeting Place' at the start of the Burrawang Walk, which will comprise a sandstone seating and gathering area, along with introductory information about the site;
 - the restoration of pre-1770 vegetation on the dune traversed by the Burrawang Walk;
 - construction of a new timber jetty and viewing platform on the site of the early 1900s jetty, including seating and information panels about the site's history;restoration of the c1912 shelter shed associated with the old ferry wharf to provide a covered seating and gathering space for visitors;
 - restoration of the freshwater stream, including opening the stream to the Bay as it was when Cook arrived in 1770, along with construction of a pedestrian bridge, seating and information panels about the site's history;
 - interpretation of the monuments and memorials; and
 - various improvements to the visitor centre, including a new forecourt, incorporation of the Environmental Education Centre, and the creation of a new multi-purpose theatrette and meeting room.
- *2146 PARTY BUSES—Ms Clover Moore asked the Deputy Premier, Minister for Transport, Minister for Finance—

With respect to "party buses" that convey groups of people around the city, particularly in the evening:

- (1) Is the Minister aware of patrons of these bus services vomiting and urinating in public areas where these buses stop?
- (2) How many "party buses" operate in Sydney?
- (3) How does the Government accredit and monitor these bus services?
- (4) What requirements do these bus operators have to apply Responsible Service of Alcohol?
- (5) What requirements do these bus operators have to provide toilets or toilet breaks where toilets are available?
- (6) What is the Government's inspection program for these bus services?

Answer—

I am advised:

(1) to (6) Various bus operators provide "party bus" services in Sydney. There are approximately 650 accredited bus operators in the Sydney metropolitan area.

All accredited bus operators are required to comply with the Passenger Transport Act and associated legislation. Under the bus operator accreditation scheme, all operators are required to submit an annual self assessment, and submit to an independent audit once every three years.

In addition, the Ministry of Transport conducts bus audits to ensure that bus operators comply. The Ministry of Transport also monitors complaints about operators, and can take action if an operator is found not to be fit and proper, or failing to demonstrate sufficient responsibility in operating a service.

Matters regarding passenger behaviour are the responsibility of the Minister for Police.

*2149 REPORT OF THE LEGAL FEES REVIEW PANEL—Mr Jonathan O'Dea asked the Minister for Police, Minister for the Illawarra representing the Attorney General, and Minister for Justice—

- (1) Regarding the December 2005 Report of the Legal Fees Review Panel into legal costs in New South Wales, how many of the 37 recommendations have been implemented?
- (2) Is the Government considering any future changes to the current system for cost assessment of legal bills?

Answer-

The National Model Legal Profession Laws, enacted in NSW in the Legal Profession Act 2004, include uniform national standards on costs disclosure and assessment.

I also refer the member to the amendments to the Legal Profession Act 2004 that commenced on 1 July 2007 which implemented a number of recommendations.

Given the National Model Legal Profession Laws, other recommendations arising from the report will be considered in future reviews of the model laws, rather than being implemented unilaterally.

*2150 REFERRALS TO LEGAL SERVICES COMMISSIONER—Mr Jonathan O'Dea asked the Minister for Police, Minister for the Illawarra representing the Attorney General, and Minister for Justice—

- (1) Mindful of the obligation in Section 393 of the Legal Profession Act (Part 3.2) with respect to cost assessors, how many legal professionals have been referred to the Legal Services Commissioner for disciplinary action since the start of 2005?
- (2) Mindful of the obligation in Section 393 of the Legal Profession Act before it was reviewed in 2004 with respect to cost assessors, how many legal professionals have been referred to the Legal Services Commissioner for disciplinary action since the Act was gazetted in 1994?

Answer-

The question is incorrect. Matters are referred for to the Legal Services Commissioner for investigation in the first instance. The Commissioner may then determine if any disciplinary action is warranted.

- *2151 WSN ENVIRONMENTAL SERVICES—Mr Jonathan O'Dea asked the Minister for Fair Trading, Minister for Youth, Minister for Volunteering—
 - (1) What plans are being considered to sell WSN Environmental Services?
 - (2) What plans are being considered specifically to sell the WSN Belrose landfill site?

Answer-

The Office of Fair Trading advises me that matters relating to the sale of WSN Environmental Services and the WSN Belrose landfill site should be addressed to my colleague, the Hon Michael Costa MLC, Treasurer.

*2152 DRINK DRIVING OFFENCES—TWEED ELECTORATE—Mr Geoff Provest asked the Minister for Police, Minister for the Illawarra—

What is the number of drink driving offences committed in the Tweed electorate by:

- (a) Drivers residing in the Tweed electorate:
 - (i) during 2006;
 - (ii) during 2007 year-to-date?
- (b) Drivers from Queensland:
 - (i) during 2006;
 - (ii) during 2007 year-to-date?
- (c) Drivers residing in any other part of NSW other than the Tweed electorate:
 - (i) during 2006;
 - (ii) during 2007 year-to-date?

Answer—

The Bureau of Crime Statistics and Research (BOCSAR) analyses NSW recorded crime statistics. I suggest the Honourable Member's questions are more appropriately addressed to the Attorney General, within whose portfolio the bureau resides.

*2155 FTE AGENCY NURSES IN THE GREATER SOUTHERN AREA HEALTH SERVICE—Mrs Jillian Skinner asked the Minister for Health—

How many FTE agency nurses are employed at each hospital in the Greater Southern Area Health Service?

Answer—

I am advised:

As the Member has not specified a time period for the data in this question it is not possible to provide accurate data and any interpretation of the question would be subjective.

However, the Department of Health reports agency nursing staffing data on a monthly basis on the NSW Health internet site at www.health.nsw.gov.au/nursing/dohrs. Additionally, information about Health Service staffing is published each year in the Area Health Services Annual Report.

*2156 FTE AGENCY NURSES IN THE HUNTER NEW ENGLAND AREA HEALTH SERVICE—Mrs Jillian Skinner asked the Minister for Health—

How many FTE agency nurses are employed at each hospital in the Hunter New England Area Health Service?

Answer-

I am advised:

The Roads and Traffic Authority (RTA) controls and maintains Martin Bridge.

The RTA undertakes periodic inspections to monitor the condition of the asphalt surface of the bridge deck. Rehabilitation of the deck joints was completed in late 2007, and the final surfacing of the bridge is planned for May 2008. Maintenance work is currently in progress.

The bridge is experiencing minor flaking of lead-based paint. The Department of Environment and Climate Change has written to Greater Taree City Council, which has investigated the issue and determined that the environmental impact on the Manning River is not significant.

Some rust locations have been identified that do not affect the integrity of the bridge. Repairs will be done as part of normal maintenance works on the bridge.

The re-painting of the Martin Bridge is included in the RTA's bridge program.
