- *0929 MOUNT DRUITT COURT HOUSE—Mr Richard Amery asked the Attorney General, and Minister for Justice—
 - (1) What was the date that the Mount Druitt Court House commenced operations?
 - (2) What is the full range of services provided to the local community from the court?
 - (3) (a) Has the workload from this court increased since it first opened?
 - (b) If so, what are the details of this increased workload?

Answer-

I am advised:

- (1) 1 May 2006.
- (2) Services include:
 - Registry assistance with procedural information and preparation of necessary court forms (generally criminal jurisdiction only).
 - Chamber Registrar Service procedural advice and preparation of the following documents:
 - applications to commence proceedings (including Statements of Claim for civil proceedings)
 - apprehended domestic and personal violence applications
 - defences, notices of motion to stay proceedings and set aside judgment in civil actions
 - Family Law applications.
 - Witnessing of Enduring Guardianship forms and Powers of Attorney.
 - Justice of the Peace service (Wednesdays only) signing of statutory declarations and affidavits and certifying documents as true copies of originals.
 - Mediation referral to the Community Justice Centre on site.
 - Aboriginal Client Service Specialist to assist Aboriginal clients.
 - Court Support Program support and assistance to people appearing before the court (Thursdays).
 - Domestic Violence Court Assistance program provides information and support to victims of domestic violence appearing before the court (Mondays). There is also a secure safe room for victims
 - The following programs are available:
 - Traffic Offenders Program referral to an education program for traffic offenders
 - MERIT Program Magistrates Early Referral Into Treatment for drug and alcohol related matters
 - Drug Court referral of appropriate offenders to the Drug Court program at Parramatta
 - Circle Sentencing Court referral of appropriate Aboriginal defendants in to the program.
 - · Audio visual facilities in both court rooms.
 - · Remote witness room for protected or vulnerable witnesses giving evidence before the court.

Outreach programs operating from the court include:

- "Men's Shed" outreach program to provide legal information and assistance to males appearing before the court in relation to domestic violence applications (Mondays)
- Legal Aid NSW Pilot outreach program for males appearing before the court in relation to applications for apprehended violence orders.

- *0931 JUSTICE ACCESS CENTRE—WALLSEND—Ms Sonia Hornery asked the Attorney General, and Minister for Justice—
 - (1) Why has the lease for the Justice Access Centre at Wallsend not been renewed since it expired on 30 June 2011?
 - (2) When will it be renewed?
 - (3) If it is not going to be renewed, why not?

Answer—

I am advised:

- (1) The lease is currently renewed on a month to month basis.
- (2) A date for long term renewal has not been established.
- (3) With the approval of the Newcastle Justice Precinct, an assessment will be made as to the impact on surrounding locations and the future needs at the Wallsend location.

*0933 HIGHER FEES FOR PUBLIC PRESCHOOLS—Ms Sonia Hornery asked the Minister for Education—

- (1) What are the names of the public preschools in the Wallsend electorate?
- (2) What provision will the Government make to ensure low wage earners will be able to afford to pay higher fees?

Answer-

- (1) Public preschools operate at Elermore Vale Public School and Waratah Public School.
- (2) This Government is committed to providing low income and disadvantaged families with access to high quality early childhood education.

DEC preschools charge the low income and disadvantaged families of a child between \$0 and \$20 per day.

*0934 CABRAMATTA WEST PUBLIC SCHOOL—Mr Nick Lalich asked the Minister for Education—

Does the 2011-2012 NSW Budget contain any funding for maintenance at Cabramatta West Public School, and if so, what are the items that require maintenance?

Answer—

Yes. The 2011-2012 Budget contains funding for maintenance at all NSW public schools.

Priorities for maintenance at Cabramatta West Public School are currently being assessed in consultation with the Principal.

*0935 CABRAMATTA PUBLIC SCHOOL—Mr Nick Lalich asked the Minister for Education—

Does the 2011-2012 NSW Budget contain any funding for maintenance at Cabramatta Public School, and if so, what are the items that require maintenance?

Answer_

Yes. The 2011-2012 Budget contains funding for maintenance at all NSW public schools.

Priorities for maintenance at Cabramatta Public School are currently being assessed in consultation with the Principal.

*0936 TECHNOLOGY INFRASTRUCTURE STRATEGIES UPGRADE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What progress has been made in Corrective Services in the year ending 30 June 2011 in implementing the Technology Infrastructure Strategies Upgrade?

Answer-

I am advised that the Technology Infrastructure Strategies Upgrade is being undertaken in Corrective Services NSW (CSNSW) by way of the Remediation Enhancement and Architectural Lifecycle (REAL) Program. The REAL Program is a major information, communication and technology initiative to ensure that frontline applications and their supporting infrastructure fulfil business needs on a continuing basis.

As at 30 June 2011, all CSNSW locations have access to high speed broadband links through the Wide Area Network (WAN); remedial work associated with Local Area Networks (LAN) at many correctional centres has been completed; the CSNSW data centre environment at the Australian Technology Park and the Global Switch facility has been extensively remediated and is nearing completion; and the user desktop environment, including mobile access has been completely remediated through lifecycle management and upgraded to the Microsoft platform.

These initiatives through the REAL Program provide confidence that the availability, performance and redundancy of CSNSW computer systems will be maintained into the future.

*0937 UPGRADE OF CELL CALL AND DURESS SYSTEMS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What upgrading has occurred of the cell call and duress systems at the Lithgow, Goulburn and Bathurst Correctional Centres and the Metropolitan Remand Centre in the periods:

- (a) 1 July 2010 to 31 December 2010;
- (b) 1 January 2011 to 31 March 2011;
- (c) 1 April 2011 to date?

Answer-

I am advised that for Lithgow Correctional Centre, Bathurst Correctional Centre and the Metropolitan Remand and Reception Centre, no physical or infrastructural upgrading to the cell call and duress system has occurred for these periods. I am further advised that Goulburn Correctional Centre has had no upgrade to the cell call system, however, the duress system was upgraded during these periods with an additional 26 receivers.

*0938 LEGAL-E-SERVICES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What development of the Legal-E-Services system has occurred in the year ending 30 June 2011?

Answer-

I am advised:

The Legal eServices Project has delivered the NSW Online Registry website, incorporating online registry functions and processes for the NSW Supreme, District and Local Courts, across both criminal and civil jurisdictions.

The Online Registry also provides a gateway to the existing services provided by JusticeLink eServices and the Online Court facility.

In April 2011, the Legal eServices Project also delivered the online Searchable Court List, an innovative and user-friendly search facility that is available 24 hours a day, seven days a week.

*0939 TECHNOLOGY UPGRADES-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

What technology upgrades have been carried out in the Registry of Births, Deaths and Marriages in the year ending 30 June 2011?

Answer-

I am advised:

In December 2010, the Births, Deaths and Marriages database was updated with the Solaris 10 operating system and the web server and applications server were migrated. Minor upgrades were also made to the Certificate Validation System (CertValid) in June 2011 to improve functionality.

*0940 DEVELOPMENT OF A JUSTICE PRECINCT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What progress has been made in the development of a Justice Precinct in Newcastle?

Answer-

I am advised:

The Department of Attorney General and Justice has purchased the site for the new court complex which is the core element of the Justice Precinct.

A contract was recently awarded for the design of the new courthouse. Consultation is now taking place with stakeholders and the design brief is expected to be finalised by the end of 2011.

*0941 LAW COURTS BUILDING, QUEENS SQUARE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

When is it proposed that refurbishment works at the Law Courts Building in Queens Square be completed?

Answer-

I am advised:

Works are expected to be completed in mid 2013.

*0942 RATE OF ASSAULT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What was the rate of assault on Correctional Services staff in the following periods:

- (a) 1 July 2010 to 31 December 2010;
- (b) 1 January 2011 to 30 June 2011?

Answer-

I am advised:

- (a) 0.40 assaults per 100 inmates per year.
- (b) 0.28 assaults per 100 inmates per year.
- *0943 INMATE TRANSPORT VEHICLE FLEET—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What was the size of the inmate transport vehicle fleet in Corrective Services as at the following dates:

- (a) 1 January 2010;
- (b) 1 July 2010;
- (c) 1 January 2011;
- (d) 1 July 2011?

Answer—

I am advised that the size of the inmate transport vehicle fleet is 80 vehicles and that number applies to all dates.

*0944 MAGISTRATES EARLY REFERRAL INTO TREATMENT PROGRAM—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many people were accepted into Magistrates Early Referral into Treatment Programs in the year ending 30 June 2011?

Answer-

I am advised:

In the 12 months ending 30 June 2011, 2033 people were accepted into the MERIT program. Of these, 1039 completed the program in this period and a further 466 remained in the program.

*0945 ACTION TAKEN AGAINST NIGEL HADGKISS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Has any action been taken against Nigel Hadgkiss in relation to his employment in the Office of the Director of Public Prosecutions following complaints lodged by a co-worker?

Answer-

I am advised:

Yes. The complaint was dealt with in accordance with the relevant policies and procedures of the Office of the Director of Public Prosecutions and appropriate action has been taken.

*0946 SEXUAL ASSAULT COMMUNICATIONS PRIVILEGE REFERRAL PROJECT—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What is the status of the Sexual Assault Communications Privilege Referral Project?

Answer-

I am advised:

Legal Aid NSW commenced the statewide service on 4 October 2011.

*0947 NSW TRUSTEE AND GUARDIAN—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

To how many and which regional offices of the NSW Trustee and Guardian have financial management functions been devolved?

Answer-

I am advised:

There are currently six NSW Trustee and Guardian offices delivering financial management functions: Chatswood, Bathurst, Gosford, Lismore, Newcastle and Sydney Central.

*0948 TRANSITION TASK FORCE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the transition task force to establish consistent definition of beds in the NSW health

system:

- (1) Will the report, available by the end of the year, be publicly released?
- (2) In which forum will this be released?
- (3) (a) Will this report include the total number of beds in the hospital system as of 1 April 2011?
 - (b) If not, what were the total bed numbers in the NSW health system as of 1 April, 2011?

Answer—

- (1) to (3) The report is currently under consideration.
- *0949 WAGGA WAGGA BASE HOSPITAL INTERNS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) How many interns have been appointed to Wagga Wagga Base Hospital in 2012?
 - (2) How many first preference applications were made to this unit?
 - (3) How many interns, residents or registrars are employed at Wagga Wagga Base Hospital?
 - (4) (a) Has Wagga Wagga Base Hospital requested more junior or senior medical house staff?
 - (b) If so, in which area(s)?
 - (5) What enhancements in 2013 will be provided for:
 - (a) interns;
 - (b) other medical staff?

Answer-

(1) to (6) The Government is committed to enhancing the provision of front line health services. This commitment has been further demonstrated through significant frontline workforce investments announced in the NSW State Budget.

Staffing levels are determined and adjusted as required by local management in line with budget, patient need and the specified award and benchmark tools.

*0950 ANTENATAL CLASSES—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

Given your statement "A NSW Liberals & Nationals Government will make accessible antenatal classes for mothers a priority" (press release 18 February 2010):

- (1) How has the Government increased funding for antenatal classes since the 2011 Election?
- (2) What funding enhancements for antenatal classes will occur in the 2011-12 Budget?

Answer—

I am advised that:

- (1) and (2) Antenatal classes are a component of maternity care provided by Local Health Districts. Funding of \$48.2 million over four years has been allocated to enhance maternity services.
- *0951 STATEWIDE NSW PAIN MANAGEMENT PLAN—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regard to the promised "Statewide NSW Pain Management plan" (press release 9 March 2011):

- (1) (a) Has this plan been released?
 - (b) If not, when will this plan be released?
- (2) What work on developing this plan has been carried to date?
- (3) Who is the lead person responsible for developing and publishing this plan?

Answer-

I am advised:

- (1) and (2) A Ministerial taskforce has been appointed to advise on and support the development of a state-wide NSW Pain Management plan. The Taskforce is due to submit the plan to Government on 30 September 2011. The NSW Department of Health and the Agency for Clinical Innovation is providing secretariat support to the Taskforce.
- (3) The Executive Sponsor is Dr Nigel Lyons, the Acting Deputy Director-General Strategic Development, NSW Health. The taskforce is chaired by Prof Richard Chye. The Acting Director, Primary Health Community Partnerships & Chronic Disease is responsible for ensuring the Taskforce has the necessary resources and support to develop the Plan.

*0952 SCHOOL MINOR WORKS PROGRAM—Ms Tania Mihailuk asked the Minister for Education—

In reference to the School Minor Works Program in this year's Budget:

- (1) How much of the \$180 million allocated to this project will be spent in the electorate of Bankstown?
- (2) Will school principals be given the opportunity to submit for grants under this program?

Answer_

- (1) The estimated cost of projects identified to be undertaken in schools in the Bankstown electorate in the 2011-12 Minor Capital Works Program is \$167,000.
- (2) No. The funds are fully allocated to projects already identified in the 2011-12 Minor Capital Works Program.
- *0953 DEMOUNTABLE REPLACEMENT PROGRAM—GEORGES HALL PUBLIC SCHOOL—Ms Tania Mihailuk asked the Minister for Education—

In reference to the ongoing State Wide Demountable Replacement Program in this year's Budget:

- (1) Will the Government consider allocating part of this fund to Georges Hall Public School to assist the school in purchasing two second-hand demountables?
- (2) If not, why not?

Answer-

- (1) No.
- (2) The Demountable Replacement Program was designed to upgrade existing schools by replacing longer term demountable classrooms, libraries and administration facilities with permanent facilities. It was not designed to facilitate the provision of extra demountables.
- *0954 DEMOUNTABLE REPLACEMENT PROGRAM—BANKSTOWN NORTH PUBLIC SCHOOL—Ms
 Tania Mihailuk asked the Minister for Education—

In reference to the ongoing State Wide Demountable Replacement Program in this year's Budget:

- (1) Will the Government consider allocating part of this fund to Bankstown North Public School as the school has five demountables that are in need of replacement?
- (2) If not, why not?

Answer-

- (1) No.
- (2) Funding for projects to be undertaken in 2011-12 has already been allocated. Consideration will be given to replacing demountables at Bankstown North Public School as part of a future capital works program.
- *0955 BANKSTOWN GIRLS HIGH SCHOOL—AUDIT OF SCHOOL FACILITIES—Ms Tania Mihailuk asked the Minister for Education—
 - (1) When will the proposed audit of school facilities at Bankstown Girls High School commence?
 - (2) When will the school be advised of the audit?
 - (3) How will the audit be undertaken and by whom?
 - (4) Will the school Principal be asked to submit their view on the status of the school's facilities?

Answer-

- (1) The condition assessment at Bankstown Girls High School commenced in September 2011.
- (2) Bankstown Girls High School was advised one week before the condition assessment commenced.
- (3) The condition assessment of the buildings and grounds will be undertaken by the South Western Sydney Asset Management Unit, assisted by contract assessors. This will involve a review of the school buildings, roofs and grounds to measure the gap between the actual condition of the building and grounds elements and the adopted maintenance standards for the elements.
- (4) Yes.
- *0956 PUNCHBOWL BOYS HIGH SCHOOL—AUDIT OF SCHOOL FACILITIES—Ms Tania Mihailuk asked the Minister for Education—
 - (1) When will the proposed audit of school facilities at Punchbowl Boys High School commence?

- (1) The condition assessment at Punchbowl Boys High School will be undertaken at the end of November 2011.
- (2) Punchbowl Boys High School will be advised one week before the assessment commences.
- (3) The condition assessment of the buildings and grounds will be undertaken by the South Western Sydney Asset Management Unit, assisted by contract assessors. This will involve a review of the school buildings, roofs and grounds to measure the gap between the actual condition of the building and grounds elements and the adopted maintenance standards for the elements.
- (4) Yes.

*0957 BASS HILL HIGH SCHOOL—AUDIT OF SCHOOL FACILITIES—Ms Tania Mihailuk asked the Minister for Education—

- (1) When will the proposed audit of school facilities at Bass Hill High School commence?
- (2) When will the school be advised of the audit?
- (3) How will the audit be undertaken and by whom?
- (4) Will the school Principal be asked to submit their view on the status of the school's facilities?

Answer—

- (1) The condition assessment at Bass Hill High School will be undertaken at the end of November 2011.
- (2) Bass Hill High School will be advised one week before the assessment commences.
- (3) The condition assessment of the buildings and grounds will be undertaken by the South Western Sydney Asset Management Unit, assisted by contract assessors. This will involve a review of the school buildings, roofs and grounds to measure the gap between the actual condition of the building and grounds elements and the adopted maintenance standards for the elements.
- (4) Yes.

*0958 COMMUNITY BUILDING PARTNERSHIP PROGRAM—Mr Ryan Park asked the Treasurer—

- (1) Why was the popular Community Building Partnership Program cut by \$47 million in the recent Budget?
- (2) Will the Treasurer reconsider this decision given the large number of community groups who have benefited from the funds this program provided?

Answer-

I am advised:

- (1) The Community Building Partnership Program was not cut by \$47 million in the recent Budget. The program has been extended with additional funding of \$35 million over two years of which \$11 million is provided in 2011-12.
- (2) As the program has not been cut by \$47 million, reconsideration is not necessary.

*0959 HIGHLY ACCOMPLISHED TEACHERS—Mr Ryan Park asked the Minister for Education—

- (1) How many teachers working in schools within the electorate of Keira, are "Highly Accomplished Teachers" as defined by the teaching standards?
- (2) What specific strategies are in place within the Illawarra to increase the number of Highly Accomplished Teachers?

Answer-

- (1) There is one Highly Accomplished Teacher in the Keira electorate, appointed to Keiraville Public School, which is a Centre for Excellence.
- (2) Schools participating in the Low Socio-Economic Status School Communities National Partnership can choose to appoint a Highly Accomplished Teacher using their National Partnership funding as a strategy to attract high performing teachers. The Department supports and encourages these schools to employ a Highly Accomplished Teacher through awareness raising workshops and case studies demonstrating the benefits of the Highly Accomplished Teacher position.

*0960 SCHOOL BASED MANAGEMENT PILOT—Mr Ryan Park asked the Minister for Education—

- (1) What schools in the electorate of Keira will be involved in the review of the School Based Management Pilot?
- (2) What is the full list of schools involved in this pilot?

Answer-

(1) Towradgi Public School is in the Keira electorate and is involved in the review.

- *0961 POLICE CITIZENS YOUTH CLUBS—Mr Ryan Park asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) What additional funding will be provided to Police Citizens Youth Clubs (PCYC) located in the Illawarra?
 - (2) When will they receive this additional funding?

Answer-

I am advised:

- (1) Bulli, Lake Illawarra and Wollongong PCYCs are to receive funding totalling approximately \$593,000 for remediation work. Additionally, Wollongong PCYC is to receive \$1 million for a major upgrade of the club.
- (2) A tender for the remediation work is currently being finalised. A contract is expected to be in place by the end of 2011, which will allow work to take place in the first half of 2012. Consultation has commenced with Wollongong Council on the major upgrade project at Wollongong PCYC, with planning and construction work expected to take place during the 2011-12 and 2012-13 financial years.
- *0963 AIR QUALITY MONITORING SITES—Mr Ryan Park asked the Minister for the Environment, and Minister for Heritage—
 - (1) How many air quality monitoring sites are in the Illawarra?
 - (2) What information was used to determine the creation of additional air quality sites in the Hunter and Central Coast?
 - (3) In relation to the air quality monitoring sites in the Illawarra, how many times since 26 March 2011 has the standard been breached?
 - (4) Are there plans to establish additional air quality monitoring sites in the Illawarra?

Answer-

I am advised as follows:

- (1) Three.
- (2) The locations of air quality monitoring stations were chosen following a comprehensive assessment of optimal placement based on the network's ability to characterise regional air quality.
- (3) There have been no exceedences of any of the National Ambient Air Quality Standards in the Illawarra from 26 March 2011 to 12 September 2011.
- (4) There are no plans currently before me, however future sites may be considered following the Upper Hunter Air Quality Monitoring Network pilot program.

- 0966 ACCESS AND PARKING AT FUTURE NEWCASTLE UNIVERSITY—Ms Sonia Hornery to ask the Minister for Education—
