Can the Minister outline Hunter Infrastructure Funds plans for 2013, including funding costs, for the Wallsend electorate?

Answer—

There are two projects of relevance to the Wallsend electorate:

- (1) \$8 million land acquisition at Waratah for new cancer research and treatment facility with \$7 million allocated in 2012-13;
- (2) \$15 million contribution towards Lake Macquarie Transport Interchange project with \$2 million allocated for 2012-13 and a further \$5 million forecast for 2013-14.

A third project is immediately adjacent to the electorate of Wallsend:

- (1) \$2.5 million Cardiff Main Street upgrade
- (2) \$2.5 million allocated in 2012-13.

Each of these projects is in varying stages of planning and delivery and therefore expenditure of funds.

With regards to the Barangaroo construction:

- (1) Construction hours have not been extended for the commercial towers. The approved hours are 7.00am to 7.00pm on weekdays which are consistent with City of Sydney Council's standard hours for work in the CBD.
- (2) The approvals allow Lend Lease to request an extension to the standard hours if required. However, such requests would be considered on a case by case basis. City of Sydney Council also permits extended construction hours in the CBD, subject to prior approval.
- (3) If construction works are undertaken outside of the terms of the approvals, my department would consider appropriate compliance action.
