*4162 LEGISLATIVE PROVISIONS OF THE GOVERNMENT INFORMATION (PUBLIC ACCESS) ACT—Mr Paul Lynch asked the Minister for Family and Community Services, and Minister for Social Housing—

Why do the legislative provisions of the Government Information (Public Access) Act not apply to social housing providers?

Answer-

The Government Information (Public Access) Act 2009 (NSW) applies to social housing providers that are Government agencies or State-owned corporations, namely the Land and Housing Corporation and Aboriginal Housing Office. The Act does not apply directly to private organisations and therefore does not apply to non-government community housing providers.

*4163 RESPONSE TO THE APPOINTMENT OF MAGISTRATES TO THE CHILDREN'S COURT—Mr Paul Lynch asked the Attorney General—

What is your response to the submission of the President of the Children's Court that he have a greater role in the appointment of magistrates to the Children's Court?

Answer-

I refer you to the response to question 11 of the questions taken on notice during the supplementary Budget Estimates General Purpose Standing Committee No 4 hearing.

*4164 LEGISLATIVE PROVISIONS—Mr Paul Lynch asked the Minister for Family and Community Services, and Minister for Social Housing—

Why do the legislative provisions of the NSW Privacy regime not apply to Community Housing Providers?

Answer-

The Privacy and Personal Information Protection Act 1998 (PPIPA) and the Health Records Information Privacy Act 2002 (HRIPA) apply to New South Wales public sector agencies. The HRIPA also applies to health service providers. As community housing providers are neither public sector agencies nor health service providers, these laws do not apply to them.

However, under the Community Housing Agreement between community housing providers and the Department of Family and Community Services, community housing providers agree that they will comply with the privacy principles under PIPPA and HRIPA and, to the extent applicable, Commonwealth privacy law.

- *4165 VACANCIES ON THE BOARD OF THE ANTI-DISCRIMINATION BOARD—Mr Paul Lynch asked the Attorney General—
 - (1) Do you propose to fill the current vacancies on the Board of the Anti-Discrimination Board?
 - (a) If so, when?
 - (b) If not, why not?

Answer-

I refer you to the response to questions 1 0 and 13 of the questions taken on notice during the supplementary Budget Estimates General Purpose Standing Committee No 4 hearing.

- *4166 GREENWAY PROJECT—Ms Jo Haylen asked the Minister for Transport and Infrastructure—
 - (1) What is the construction timeline for the GreenWay project?
 - (2) How will local residents and community groups be consulted around the planning and construction for the GreenWay project?
 - (3) What is the timeline for this consultation?

Answer-

The Government has committed \$7 million to the GreenWay project, which is being delivered by Inner West Council.

Questions regarding consultation and construction should be directed to Council.

- *4167 PENALTY NOTICES FOR FAILING TO VOTE—Ms Jo Haylen asked the Minister for Finance, Services and Property—
 - (1) What is the total number of penalty notices to be issued to residents as a result of failing to vote in the recent local government elections?
 - (2) Will you waive fines to residents who did not vote in local government elections given the confusion caused by the Government's amalgamations and staggering of local government elections over the next year?
 - (3) What was the total number of penalty notices issued for failing to vote in the 2012 local government elections and 2008 local government elections?
 - (4) What was the total number of these fines waived in 2012 and 2008?

Answer—

The Electoral Commission is required by law to issue a penalty notice when someone fails to vote. The notice gives the option to give a reason in writing for not voting. Any request for a waiver of the penalty notice to the Office of State Revenue would be based on the individual circumstances and in consultation with the Electoral Commission.

The Office of State Revenue does not hold the total numbers of failure to vote penalty notices issued or the total numbers waived

*4168 WOMEN'S CRISIS ACCOMMODATION CENTRES—Ms Sonia Hornery asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—

What are the current turn-away rates of women's crisis accommodation centres in the Wallsend, Shortland, and Newcastle areas?

Answer-

This question should be referred to the Hon Brad Hazzard MP, Minister for Family and Community Services and Minister for Social Housing, who has responsibility for specialist homelessness services.

*4169 CARPENTRY POSITION IDENTIFIED IN HERITAGE SERVICES—Mr Paul Lynch asked the Minister for Finance, Services and Property—

Why will you not appoint Brian Waxham, a carpenter by trade, to the carpentry position identified in the new Heritage Services structure?

Answer—

Employees who have accepted voluntary redundancy may still apply for roles advertised externally, now or in the future. Direct appointment to a new role would not only be improper but unfair to all staff concerned. Applicants for new roles must be appointed through a fair process

*4172 ROLE OF ADRIAN MCKENNA—Mr Paul Lynch asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

What is the role of Adrian McKenna within the NSW Department of Justice?

Answer—

Mr McKenna is the Executive Director, Office for Police in the Justice Strategy and Policy Division of the Department of Justice.

*4174 JOHN HUNTER HOSPITAL EYE CLINIC—Ms Sonia Hornery asked the Minister for Health—

As of July 2016, was the John Hunter Hospital Eye Clinic operating at full capacity?

Answer-

Yes.

*4175 SPEED CAMERAS IN THE WALLSEND ELECTORATE—Ms Sonia Hornery asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

Where are the speed cameras currently located in the Wallsend electorate?

Answer-

This question should be directed to the Minister for Roads, Maritime and Freight.

*4176 IMPROVEMENTS TO SAFETY AND SERVICE ACCESS AND PROVISION—Ms Sonia Hornery asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—

In the time since their implementation, what improvements to safety and service access and provision have the 'It Stops Here' initiative, the 'Going Home, Staying Home' policy, and the 'Staying Home, Leaving Violence' policies had for women fleeing domestic violence and people facing homelessness?

Answer-

It Stops Here: Standing together to end domestic and family violence in New South Wales launched in 2014 as the Government's Domestic and Family Violence Framework for Reform. It Stops Here established Safer Pathway, the new assessment, referral and service coordination framework to support effective responses to all victims of domestic and family violence. Services work together and share information to create a coordinated, holistic response to victims and their children, where tailored support is offered to meet their safety, health and wellbeing needs.

Safer Pathway commenced in September 2014 (Orange and Waverly) and was rolled out to a further four sites in July 2015 (Bankstown, Parramatta, Broken Hill and Tweed Heads). Safer Pathway Safety Action Meeting sites will be established in a further 21 new locations across New South Wales in 2016-17. \$53 million over four years has been allocated for a state-wide rollout of Safer Pathway.

- *4177 INVESTMENT INTO EARLY CHILDHOOD EDUCATION—Ms Sonia Hornery asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, and Assistant Minister for Education—
 - (1) Will the \$115 million dollar recently announced investment into early childhood education overlook lower-income working families?
 - (a) If so, will you be releasing the rest of the \$350 million earmarked for the sector to meet its continuing short falls?

Answer-

Under Start Strong, the base rate funding for Aboriginal children and children from low income families attending community preschool will increase to \$6,600 per eligible child enrolled in 600 hours of preschool. This is a 22% increase compared to the existing base rate of \$5,402.

All funding received from the Australian Government under the National Partnership Agreement on Universal Access to Early Childhood Education has been fully allocated.

- *4178 HUNTER INVESTMENT FUND—Ms Sonia Hornery asked the Treasurer, and Minister for Industrial Relations—
 - (1) How much money has been invested from the Hunter Investment Fund for projects in the Wallsend electorate in each financial year from 2012-13 to 2015-16?
 - (2) What are the names of the projects funded?
 - (a) How much was invested for each project?

Answer-

Since establishing the Hunter Investment Fund in 2012 the Government has allocated over \$450 million to projects throughout the Hunter that would not have been possible without this initiative.

- *4179 GREYHOUND RACING COMPENSATION—Ms Sonia Hornery asked the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—
 - (1) How will the Government compensate The Gardens Greyhound Racing Track for the loss of revenue from Wallsend Greyhound Breeders, Owners and Trainers after the closure of the greyhound industry from 1 July 2017?
 - (2) When will the greyhound racing compensation package be announced?
 - (3) Will this extend to businesses that relied on the greyhound industry to support their trade, for example pet produce, vets, equipment to transport greyhounds?

Answer-

(1) to (3) On 11 October the Government announced that it would give the greyhound racing industry one more chance in New South Wales, subject to it agreeing to the strictest regulations to clamp down on animal cruelty.

The Government has established the Greyhound Industry Reform Panel to determine a new regime that will ensure greyhound racing in New South Wales prioritises animal welfare, has a robust governance structure and a tough independent regulator to monitor the industry. The Panel, chaired by former Premier the Hon Morris Iemma, includes representatives from RSPCA NSW, the greyhound industry and government.

Subject to the report of the Panel, legislation will be introduced repealing the racing ban and establishing the new regulatory regime. The Panel will also determine the timing and criteria for a statutory review of the new legislation and regulatory regime.

*4180 POSITION OF THE PRIVACY COMMISSIONER—Mr Paul Lynch asked the Attorney General—

- (1) What steps will you take to ensure that the position of Privacy Commissioner continues beyond November 2016?
- (2) Do you propose to reappoint the current Privacy Commissioner?
 - (a) If not, why not?

Answer-

The Privacy Commissioner is a statutory office holder under the Privacy and Persona/Information Protection Act 1998. The process for appointment of the Privacy Commissioner is set out in Part 4 Division 1 of that Act.

*4181 CAMPBELLTOWN HOSPITAL—Mr Greg Warren asked the Minister for Health—

- (1) How many operating suites or theatres exist at Campbelltown Hospital?
- (2) In which areas of Campbelltown Hospital are these operating suites theatres located?
- (3) How many operating theatres or suites at Campbelltown Hospital are in use during business hours, between 9am and 5pm on Monday to Friday?
- (4) How many operating theatres or suites are in use outside of business hours, including during the evening and on weekends?
- (5) Does the Government have any plans to increase the number of operating suites or theatres within the next 12 months (from 11 October 2016) at Campbelltown Hospital?

Answer-

There are seven operating theatres at Campbelltown Hospital, located in the perioperative area/theatre suite. Theatres operate as per NSW Health and Royal Australian College of Surgeons guidelines.

- (1) What representations have the Sydney Airport Corporation made to the Minister or Department in favour of reducing the Station Access Fee on the Sydney Airport Line?

Answer-

- (1) Transport for NSW and my office have not received any representations from the Sydney Airport Corporation on this matter.
- (2) Sydney's Bus Future identifies improvements for bus access to Sydney Airport, and this is being considered as part of broader transport planning for the precinct.

What is the current waiting period for non-urgent repairs and/or maintenance to be carried out in Family and Community Services properties across the Fairfield electorate?

Answer—

Response times for maintenance requests vary depending on the nature of the problem reported.

Services?

Answer-

The Gillard Government announced that it would work with states and territories to build the foundations for a National Disability Insurance Scheme (NDIS) after receiving the Productivity Commission's Disability Care and Support report dated 31 July 2011.

On 7 December 2012, COAG signed an Intergovernmental Agreement for the NDIS Launch.

Commonwealth, state and territory governments established the National Disability Insurance Agency to administer and fund the NDIS.

The important position of Minister for Disability Services will of course remain

The value of penalty notices issued for camera detected offences in the Fairfield electorate from 25 August 2015 to 25 August 2016 is \$4,996,459.00.
