*11755RATING AGENCY ASSESSMENTS—Mr Richard Amery asked the Minister for Police, and Minister for Finance representing the Treasurer, Minister for State and Regional Development, Minister for Ports and Waterways, Special Minister of State, Minister for the Illawarra—

- (1) Which rating agencies have done an assessment on the financial management of the Government in recent times?
- (2) What has been the result of these assessments?
- (3) How do these assessments compare with similar assessments over the past 20 years?

Answer—

I am advised:

- (1) Moody's and Standard & Poor's have done assessments in 2009. Fitch has also provided an unsolicited assessment in 2009.
- (2) These assessments have reaffirmed the State's triple-A credit rating.
- (3) Previous assessments have also reaffirmed the State's triple-A credit rating.
- *11757RESPITE SERVICES—Mr Greg Aplin asked the Minister for Education and Training representing the Minister for Ageing, Minister for Disability Services, Minister for Volunteering, and Minister for Youth—

In the ADHC Western Region, how many home-based respite days are currently funded in the electorates of:

- (a) Albury;
- (b) Wagga Wagga;
- (c) Dubbo;
- (d) Orange;
- (e) Bathurst?

Answer-

Ageing, Disability and Home Care (ADHC) funds its services based on Local Planning Areas or Regions rather than state electorates. The above electorates are all located within the ADHC Western Region.

Data for funded home-based respite in ADHC Western Region for the 2009/10 financial year is as follows:

Flexible Respite (Combination/Own Home/Host Family) - 120,361 hours*

HACC Respite - 53,228 hours*

Home Care Respite - 19,315 hours**

* Based on contracted hours (or planned outputs)

** Based on actual hours (contracted hours not available)

*11758PARKING SPACES AT NEPEAN HOSPITAL—Mr Stuart Ayres asked the Deputy Premier, and Minister for Health—

With regards to the need for more car parking spaces at Nepean Hospital:

- (1) What are the final plans to expand parking at Nepean Hospital?
- (2) When can patients (their families, friends and carers), doctors, nurses and other health professionals expect these plans to be approved and funded by NSW Treasury?
- (3) What representations have you or your department made to NSW Treasury to support the need for more parking at Nepean Hospital?
- (4) When will additional parking spots be delivered and available for patients (their families, friends and carers), doctors, nurses and other health professionals?

Answer-

I am advised that:

(1) to (4) As part of the approved Department of Planning Project Application for the New East Block at Nepean Hospital, a total of 155 car parking spaces have been included as part of the project. The new car parking spaces will replace 76 spaces occupied by the new development and add an additional 79 new spaces to cater for the increased demand relating to the development. The additional spaces would be available at the completion of the project, scheduled for the first quarter of 2012.

- *11760MAITLAND STATE DEBT RECOVERY OFFICE—Mr Mike Baird asked the Minister for Police, and Minister for Finance representing the Treasurer, Minister for State and Regional Development, Minister for Ports and Waterways, Special Minister of State, Minister for the Illawarra—
 - (1) Is the Government in the process of relocating any part of the Maitland State Debt Recovery Office from Maitland to Sydney?
 - (2) If so, will the jobs of Maitland employees be lost?
 - (3) Have employees within the Police Infringement Processing Bureau been re-employed on temporary contracts?
 - (4) Did these contracts take seven months to finalise whereas equivalent positions in Sydney took only 1 month?
 - (5) Have desks been removed from the Maitland office after a recent refurbishment?
 - (6) What measures are in place to ensure the job security of those employees in the Maitland office?

Answer—

I am advised:

The State Debt Recovery Office is primarily located in Maitland and Lithgow. Due to overcrowding in the Maitland Office in 2009, a second building was leased in Maitland to accommodate the number of staff required.

Options to create permanent positions in Maitland are regularly explored by OSR.

*11761ECONOMIC MODELLING—ACCESS ECONOMICS—Mr Mike Baird asked the Minister for Police, and Minister for Finance representing the Treasurer, Minister for State and Regional Development, Minister for Ports and Waterways, Special Minister of State, Minister for the Illawarra—

Will the Treasurer provide a copy of all economic modelling undertaken by Access Economics regarding the impact on electricity prices following the coal price negotiations?

Answer-

Access Economics were not engaged by the Government in this regard.

*11762CANCELLATION OF THE CBD METRO—Mr Mike Baird asked the Premier, and Minister for Redfern Waterloo—

In relation to outstanding business claims for compensation regarding the cancellation of the CBD Metro:

- (1) Will the Government finalise all outstanding claims before 15 November 2010:
- (2) Will the Government ensure that no more liability caps are introduced, but rather fair compensation be paid for all revenue and capital value lost by small businesses?

Answer-

I am advised:

The NSW Government has completed the assessment of claims which it has received. Some additional claims may be received, and it is not possible to provide a date for the finalisation of all claims as some claimants may choose to pursue court action. These matters would therefore be settled in accordance with timelines determined by the Court.

The NSW Government established an independent process for the management of claims for reimbursement to ensure that all businesses were treated equally and fairly.

*11763BETTER SERVICES AND VALUE TASKFORCE—Mr Mike Baird asked the Minister for Police, and Minister for Finance representing the Treasurer, Minister for State and Regional Development, Minister for Ports and Waterways, Special Minister of State, Minister for the Illawarra—

Will the Treasurer provide a copy of any summary report by the Better Services and Value Taskforce?

Answer—

I am advised:

The Better Services and Value Taskforce do not produce summary reports.

*11764UNFAIR DISMISSAL CASE—Ms Gladys Berejiklian asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer) representing the Minister for Transport, Minister for the Central Coast—

How much has the Government spent to date on legal and court costs in relation to the former Sydney Ferries skipper Stephen Morton's unfair dismissal case?

Answer-

I am advised that in the actions where Sydney Ferries defended its decision to terminate Mr Morton's employment, Sydney Ferries has incurred costs of \$788,456.07.

- *11765PACIFIC HIGHWAY ROAD SURFACE—Mr Peter Besseling asked the Minister for Roads, and Minister for Western Sydney—
 - (1) Why is the road surface on the Moorland stretch of the Pacific Highway different to the road surface that by-passes the communities of Kew and Johns River?
 - (2) Does the choice of materials used for the Pacific Highway's road surface have an impact on the noise generated by passing traffic, and if so will the RTA continue to assess amelioration measures to address Moorland residents' concerns?
 - (3) Will the surface "patching" that occurs on the Pacific Highway near the Camden Haven River bridge be resurfaced in the near future?

Answer-

I am advised:

(1) and (2) Low noise pavements are generally used in built up urban areas, where operational traffic noise levels may exceed the relevant criteria for Road Traffic Noise. This was the case at Johns River, Kew and Herons Creek.

The wearing surface of pavements can influence the operational noise levels. For the recently completed Coopernook to Herons Creek upgrade, post-construction noise monitoring and modelling will be carried out to assess the effectiveness of noise reduction measures and compliance against the project noise goals and the Environmental Criteria for Road Traffic Noise.

If the predicted noise levels are found to exceed the project noise targets, further consultation will be undertaken with those residents affected and additional noise reduction measures will be implemented where reasonable and feasible.

The section in question was scheduled to be resealed as part of completion of the Coopernook to Herons Creek upgrade. However, unfavourable weather conditions in the area have impacted on the original timing. The section is now expected to be resealed in early 2011.

*11766NORTH COAST AREA HEALTH SERVICE JOB CUTS—Mr Peter Besseling asked the Deputy Premier, and Minister for Health—

Following the decision by North Coast Area Health Service last financial year to cut 400 jobs in a bid to reel in a \$30 million budget overrun, does the health service now intend to cut more positions, as many as 63, from across the region?

Answer—

I am advised that:

Providing high quality patient care throughout the North Coast remains the priority for the North Coast Area Health Service.

The demand on public health dollars is constantly increasing, therefore the Area Health Service continues to look for ways to be more effective and efficient, and provide the highest quality of patient care.

North Coast Area Health Service will continue to work with staff to ensure that where change is necessary, the best possible decisions are made.

*11767STEPS PROGRAM-Mr Peter Besseling asked the Deputy Premier, and Minister for Health-

- (1) Has the STEPS program, an initiative of NSW Health that offers all four-year-old children free vision screening, been rolled out in the Hastings Macleay health network?
- $(2) \ \ If not, why not?$

Answer-

I am advised that:

- (1) and (2) The StEPS Program was rolled out in the Hastings/Macleay Network in December 2009. Invitation letters were sent to all Preschools and Long Day Care Centres across North Coast Area Health Service in December 2009 inviting them to participate in the Program.
- *11768PLAZA CAR PARK REDEVELOPMENT—Mr Peter Besseling asked the Minister for the State Plan, and Minister for Community Services representing the Minister for Planning, Minister for Infrastructure, Minister for Lands—

Prior to consideration of any redevelopment plans for the Plaza car park, will LPMA call for Expressions of Interest for the site, which is identified for redevelopment under the draft Plan of Management for Hastings Regional Crown Reserve Precinct A, referred to by locals as the Port Macquarie foreshore?

Answer-

If development consent has been obtained the Land and Property Management Authority, in conjunction with adjoining property owners, intends to then move toward an open EOI process to carry out the project.

- *11769GRAFTON BASE HOSPITAL MENTAL HEALTH UNIT—Mr Steve Cansdell asked the Deputy Premier, and Minister for Health—
 - (1) What was the funding for Grafton Base Hospital Mental Health Unit for the period:
 - (a) 2008:
 - (b) 2009;
 - (c) 2010?
 - (2) If the mental health unit does not treat children, what is the process and advice put in place for parents of these children who are turned away?
 - (3) Is the minister aware that recently people that have been turned away have gone on to carry out serious assaults on the same day of being rejected, in one case just hours after being turned away?
 - (4) If people that need immediate mental health help are being turned away, is mental health underfunded at Grafton Base Hospital?
 - (5) Why are adults that need immediate mental help being turned away from Grafton Base Hospital Mental Health Unit?
 - (6) Has the Minister been advised of recent incidents that suggest failing procedures at Grafton Base Hospital Mental Health Unit?
 - (7) (a) Does the Government have any plans to close this mental health unit?

(b) If not, will funding be increased so that patients are not turned away?

Answer-

I am advised that:

(1) and (7) There is no Mental Health Unit at Grafton Base Hospital. The Community Mental Health Service provides the following services:

- Child & Adolescent Mental Health services for young people aged 12 yrs 18 yrs;
- Adult Mental Health Service provides services to people aged 18 yrs 65yrs
- Specialist Mental Health Services for older People provides services to people aged 65 yrs and older.

In addition, there is an Aboriginal Mental Health Worker who provides services to Aboriginal clients and consultation to other members of the Community Mental Health Service.

Funding for Grafton Community Mental Health for the past three years has been:

2008 - \$1.8 million 2009 - \$2.0 million 2010 - \$2.2 million

There are no plans to close the service. Funding has increased over the past three financial years. The Department of Health continues to work with North Coast Area Health Service to align budgets with current and forecasted activity.

(2) Children are not turned away. Advice regarding options for crisis treatment is provided and a safety plan developed. This will usually involve presentation to the local Emergency Department and assessment by the Acute Care Service and input from the Psychiatrist on-call if required.

Children aged under 12 years are normally seen by a Child and Family Health Service. If a child presents with acute suicidal ideation the child will be seen by the Mental Health Service.

Children who are case managed by Child and Family Health Staff are able to be referred to a Child and Adolescent Psychiatrist.

(3) I understand there was a recent report of a serious assault that occurred a year ago and led to a senior service review (called a Root Cause Analysis) making two recommendations for systems practice improvement within the Grafton Base Hospital Emergency Department, which have now been implemented.

(4) and (5) People who require immediate help are not being turned away. Grafton Community Mental Health Service work in close collaboration with Grafton Base Hospital to provide a timely response to people presenting with immediate mental health needs.

(6) Yes, and recommended systems practice improvements have been implemented within the Grafton Base Hospital Emergency Department and the Community Mental Health Service.

*11770CLIENT COST OF CRIMINAL JUSTICE PROGRAM—Mr Andrew Constance asked the Minister for Education and Training representing the Minister for Ageing, Minister for Disability Services, Minister for Volunteering, and Minister for Youth—

Noting that in 2007-08 the client cost of the criminal justice program was \$49,351 per head, why has it jumped to \$97,000 per head in 2008-09?

Answer—

The figures quoted from Ageing, Disability and Home Care Annual Reports include the part year effect of services for clients as they come into the program.

In 2007-08 the unit cost for most clients reflects a part year effect.

In 2008-09 the unit cost reflects the full year effect of clients who entered in 2007-08 and the part year effect of clients who entered in 2008-09.

- *11771TATHRA WHARF—Mr Andrew Constance asked the Minister for the State Plan, and Minister for Community Services representing the Minister for Planning, Minister for Infrastructure, Minister for Lands—
 - (1) What research was undertaken by the Lands and Property Management Authority in conjunction with Bega Valley Shire Council to improve safety at Tathra Wharf following the tragedy involving the O'Neill family?
 - (2) When did this occur?
 - (3) When was the research completed?
 - (4) What did the research indicate?
 - (5) Did, at any point, the Bega Valley Shire Council request funding for further upgrades at the wharf as a result of this research and in light of this tragedy?
 - (6) Will the Government provide funding for these vital safety upgrades?
 - (7) Why has it taken so long for the council to act and is it the fault of the department for this delay?

Answer-

- (1) I am advised an independent risk assessment was commissioned by Council and a safety liaison group established to consult with the community and to consider the consultant's recommendations.
- (2) I am advised the risk assessment was commissioned shortly after the release of the Coroner's report.
- (3) A draft report was received by Bega Valley Shire Council in November 2009.
- (4) The report made a number of recommendations including safety signage, rescue aids, lighting, safety barriers and education and awareness programs.
- (5) Yes.
- (6) Yes.
- (7) The Land and Property Management Authority has dealt with all matters relating to risk minimisation at the Tathra Wharf in a timely manner.

*11772CHILDREN (PROTECTION AND PARENTAL RESPONSIBILITY) ACT 1997—Mr Peter Debnam asked the Premier, and Minister for Redfern Waterloo—

Given advice the Children (Protection and Parental Responsibility) Act 1997 gives courts the discretion to require parents of children involved in criminal proceedings to attend court, where courts make use of this provision where appropriate in the circumstances (Question 7797), in what circumstances have courts required parents of children involved in criminal proceedings to attend court?

Answer-

I am advised:

Section 6 of the Children (Protection and Parental Responsibility) Act 1997 specifies guiding principles for the courts in determining whether to require a parent or parents of a child to attend proceedings.

The Member is otherwise referred to previous answers to questions in relation to the courts' use of the above discretion and the availability of information on that use.

- *11778REAL ESTATE AGENT TRUST ACCOUNTS—Mr Victor Dominello asked the Minister for Fair Trading, Minister for the Arts—
 - (1) As at 23 September 2010, how many real estate agent trust accounts does the Office of Fair Trading (OFT) currently administer?
 - (2) How many real estate agent trust accounts did the Office of Fair Trading administer during:
 - (a) financial year ending 2007;
 - (b) financial year ending 2008;
 - (c) financial year ending 2009?
 - (3) What rate of interest did the OFT receive from the real estate agent trust accounts it administers at:
 - (a) 30 June 2007;
 - (b) 30 June 2008;
 - (c) 30 June 2009;
 - (d) 30 June 2010;
 - (e) 23 September 2010?
 - (4) Does the OFT negotiate with individual banks to ensure interest is paid on accounts commensurate with current Reserve Bank rate?

Answer—

NSW Fair Trading advises me that:

(1) and (2) Fair Trading does not administer trust accounts under the Property, Stock and Business Agents Act 2002 and the Conveyancers Licensing Act 2003. These accounts are administered by the authorised deposit-taking institutions approved by the Director General, Department of Services, Technology and Administration.

(3) Authorised deposit-taking institutions are required to calculate and lodge with NSW Fair Trading a prescribed proportion of interest earned on agents' trust accounts. The proportion of interest is 60% of the Reserve Bank of Australia's cash rate target:

- (a) 30 June 2007 3.69%
- (b) 30 June 2008 4.10%
- (c) 30 June 2009 2.84%
- (d) 30 June 2010 2.21%
- (e) 1 July to 30 September 2010 2.70%

(2) When the Reserve Bank of Australia changes the cash rate target, Fair Trading notifies all approved authorised deposit taking institutions of the new interest rate to be applied to trust accounts.

- *11779REAL ESTATE AGENT TRUST ACCOUNTS—Mr Victor Dominello asked the Minister for Fair Trading, Minister for the Arts—
 - (1) As at 23 September 2010, what is the current average monthly balance of real estate agent trust accounts?
 - (2) As at 23 September 2010, what is the total combined balance of all real estate agent trust accounts?
 - (3) What was the total value of revenue the Office of Fair Trading received from the real estate agent trust accounts it administered during:
 - (a) financial year ending 2007;
 - (b) financial year ending 2008;
 - (c) financial year ending 2009?
 - (4) For what purposes is this revenue used?

Answer—

NSW Fair Trading advises me that:

(1) and (2) Since trust accounts required under the Property, Stock and Business Agents Act 2002 and the Conveyancers Licensing Act 2003 are not administered by Fair Trading, I cannot answer these questions.

(3) Total value of for statutory interest revenue is as follows:

- (a) financial year ending 30 June 2007 \$41,427,727.11;
- (b) financial year ending 30 June 2008 \$44,679,586.38; and
- (c) financial year ending 30 June 2009 \$30,942,487.08

(4) Statutory Interest revenue is used for those purposes outlined in sections 189 and 190 of the Property, Stock and Business Agents Act 2002:

189 APPLICATION OF MONEY IN STATUTORY INTEREST ACCOUNT

- (1) Money in the Statutory Interest Account may be applied for any purpose for which it is required or permitted to be applied by or under this or any other Act.
- (2) The Director-General may, with the consent of the Minister, apply money held in the Statutory Interest Account for all or any of the following purposes:
 - (a) supplementing the Compensation Fund by such amount as may be needed to enable the current liabilities of the fund to be met,
 - (b) providing grants or loans for providing or undertaking education or research programs relating to the property services industry (as defined in section 25I of the Fair Trading Act 1987) and approved by the Minister,
 - (c) providing money for the establishment or administration of rental advisory services,
 - (d) meeting the costs of administering this Act, the Conveyancers Licensing Act 2003, the Valuers Act 2003 and any other Act prescribed by the regulations for the purposes of this paragraph (or the prescribed provisions of any other Act),
 - (e) meeting the costs of the administration of the Property Services Advisory Council,
 - (f) meeting the costs of operating a scheme or schemes for resolving disputes arising between consumers and providers of property services,
 - (g) investing in schemes that relate to the provision of residential accommodation or, subject to such terms and conditions as may be prescribed by the regulations, in loans to authorised deposit-taking institutions.
- (3) The Treasurer may determine whether any such money is to be invested in any such scheme or loan and the amount to be invested in a scheme or loan.
- (4) In this section: property services means services provided in the property services industry as defined in section 251 of the Fair Trading Act 1987.

190 APPLICATION OF MONEY FOR PURPOSES OF CERTAIN ACTS

- (1) The following amounts are also payable from the Statutory Interest Account:
 - (a) such contributions towards the costs, charges and expenses of administration of the Landlord and Tenant (Rental Bonds) Act 1977, the Residential Tenancies Act 1987 and the Residential Parks Act 1998 as may be agreed from time to time by the Minister and the Ministers administering the Landlord and Tenant (Rental Bonds) Act 1977, the Residential Tenancies Act 1987 and the Residential Parks Act 1998,
 - (b) such contributions towards half the costs and expenses incurred in the administration of the Consumer, Trader and Tenancy Tribunal Act 2001 as are agreed annually by the Minister, the Minister administering the Landlord and Tenant (Rental Bonds) Act 1977 and the Minister administering the Consumer, Trader and Tenancy Tribunal Act 2001, but only to the extent to which those costs and expenses relate to the exercise of the Consumer, Trader and Tenancy Tribunal's jurisdiction in relation to matters arising under the following Acts:

(i) the Community Land Management Act 1989,

- (ii) the Residential Parks Act 1998,
- (iii) the Residential Tenancies Act 1987,
- (iv) the Retirement Villages Act 1999,

(v) the Strata Schemes Management Act 1996.

- (c) such contributions towards the costs, charges and expenses of the administration of the Retirement Villages Act 1999 as may be authorised by the Director-General with the consent of the Minister,
- (d) such contributions as may be agreed by the Minister and the Minister administering the Fair Trading Act 1987 towards the costs, charges and expenses of the administration of that Act,
- (e) such contributions as may be agreed by the Minister and the Minister administering the Strata Schemes Management Act 1996 and Community Land Management Act 1989 towards the costs, charges and expenses of the administration of those Acts,
- (f) such additional contributions for the purposes set out in paragraphs (a)-(e) as the Ministers

referred to in those paragraphs may at any time agree.

- (2) Contributions referred to in this section are to be paid in the manner determined by the Treasurer.
- *11780REAL ESTATE AGENT TRUST ACCOUNTS—Mr Victor Dominello asked the Minister for Fair Trading, Minister for the Arts—
 - (1) How does the Office of Fair Trading (OFT) ensure that all real estate agent trust accounts opened at NSW bank branches are properly registered and monitored?
 - (2) How many unregistered accounts did the OFT uncover during:
 - (a) financial year ending 2007;
 - (b) financial year ending 2008;
 - (c) financial year ending 2009?
 - (3) How much bank interest revenue was lost as a result of accounts being unregistered during:(a) financial year ending 2007:
 - (b) financial year ending 2007;
 - (c) financial year ending 2009?

(4) What steps is the OFT taking to address this problem?

Answer—

(1) The Property, Stock and Business Agents Act 2002 requires licensees to hold clients' funds in a trust account kept at an authorised NSW deposit-taking institution and approved by the Director General of the Department of Services Technology and Administration. When opening the account, licensees must notify the institution in writing that it is a trust account.

Deposit-taking institutions are required to:

- report the amount held in agents' trust accounts;
- advise the Director General of any overdrawn accounts or dishonoured cheques; and
- provide the Director General with an annual audit certificate provided by a registered company auditor.

Licensees must also have their records in relation to the handling of trust money audited, and submit these to the Director General no later than 30 September each year.

In addition, Fair Trading conducts real estate agency compliance programs and annual trust account audits.

(2) I am advised that in 2009 NSW Fair Trading became aware that a number of trust accounts had been established incorrectly in previous years. Fair Trading worked closely with the institutions to rectify these errors, which resulted in a total of 67 accounts being corrected during the 2009 financial year.

(3) Fair Trading entered into negotiations with financial institutions to recover the bank interest revenue lost as a result of the account errors. NSW Fair Trading has reached agreements with the entities concerned in relation to the amount of interest revenue required to be reimbursed.

(4) All accounts that were found to be established incorrectly have been corrected.

Fair Trading has held high level meetings with bank representatives in order to improve procedures for opening and maintaining trust accounts, with internal reviews to ensure the accounts have been set up correctly and the appropriate level of interest is being paid to Fair Trading. In addition, institutions are required to provide electronic reports on trust accounts.

The migration to the Government Licensing System will increase Fair Trading's ability to identify noncompliant trust accounts and take appropriate action.

Budgets for construction are being refined prior to going to tender in the next 12 months. As a result of many years of stevedoring use, the Barangaroo site requires redefining the interface between the land and the water, which will result in an overall increase in harbour waters being incorporated into the site. The public pier and hotel will be suspended on piles in the harbour, as is the case with other harbour pier structures. The area has not been valued separately from the rest of Barangaroo South.

*11800UNLAWFUL REPRISAL ACTIONS AGAINST WHISTLEBLOWERS—Mr Jonathan O'Dea asked the Premier, and Minister for Redfern Waterloo—

- (1) How many prosecutions have been brought in NSW over the last 15 years for unlawful reprisal actions against whistleblowers?
- (2) What relevant penalties have been imposed, if any?
- (3) Are any prosecutions currently being considered, including in relation to NSW Maritime staff?

Answer—

I am advised:

It is an offence under section 20 of the Protected Disclosures Act 1994 for a person to take detrimental action against another person that is substantially in reprisal for that person making a protected disclosure.

In November 2009, the Parliamentary Committee on the Independent Commission Against Corruption released a report entitled "Protection of Public Sector Whistleblower Employees."

In that report, the Committee refers to the Deputy Ombudsman's advice that five proceedings had been initiated by August 2008 under the Protected Disclosures Act or the relevant provisions of the Police Act 1990.

The Committee also notes that it had received evidence that there have been no successful prosecutions for unlawful reprisal action since the enactment of the Protected Disclosures Act.

Concerned with this, the Committee recommended that the Office of the Director of Public Prosecutions be the nominated prosecuting authority for unlawful reprisal actions and that these matters be referred to the Office of the Director of Public Prosecutions to undertake or supervise any prosecutions. The Committee considered that this may result in more consistency in dealing with these offences and thus may result in more successful prosecutions.

The Government has introduced the Protected Disclosures Amendment (Public Interest Disclosures) Bill 2010 which implements this recommendation.

As recommended by the Committee, the Bill also provides for new remedies for whistleblowers by enabling them to seek compensation should reprisal action be taken against them.

The Government supports the Committee's view that whistleblowers should have an avenue available to them other than criminal proceedings if reprisal action is taken against them.

- *11802WEST WYALONG HIGH SCHOOL-Mr Adrian Piccoli asked the Minister for Education and Training-
 - (1) Given that West Wyalong High school has been allocated \$1.3 million to build a trade centre, how much has the project management cost for this project?

- (2) Is the DET responsible for the project management?
- (3) What are the other fees associated with this trade school (administration, management, etc.)?(4) (a) Is the kitchen in this trade school a completely new kitchen?
- (b) If not, where did it come from, who constructed this kitchen and was it recycled from another school?

Answer-

- (1) The project management cost allocated is determined by the guidelines of the Commonwealth Government's Trade Training Centres in Schools Program. Under the guidelines, the overall design, engineering, and management cost for the project has an allocation of 15%. This includes a project management element of approximately 1.5%
- (2) The NSW Department of Education and Training allocates a Project Director to each project, who is directly responsible for the delivery of the project.
- (3) There are no additional fees. The Department of Education and Training's Project Director must manage all fees from the maximum 15% allocation.
- (4) (a) and (b) The kitchen designed for this school is a part of a refurbishment of an existing facility at the school. The refurbishment proposed is extensive and will provide a state of the art hospitality facility.
- (5) The original request included approximately 10 new machines at West Wyalong High School and 4 new machines at West Wyalong TAFE.
- (6) Currently, there are no machines included in the project for the workshops at the school and TAFE. Funding has been allocated to provide all the detailed equipment for the hospitality facility.
- *11804WHEELCHAIR ACCESSIBLE CABS—Mr Greg Piper asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer) representing the Minister for Transport, Minister for the Central Coast—

Why, since 4 July 2010, have there been no wheelchair accessible cabs available in the Morisset/Toronto area to transport Ms Christine Rosenthal's disabled sister from Morisset Hospital's Kanangra Centre to Ms Rosenthal's home for scheduled weekly family visits?

Answer-

I am advised that the owner of the only licensed wheelchair accessible taxi in the Morisset area is currently in the process of placing a new vehicle into service following the de-commissioning of the previous vehicle, which had reached its life expectancy of 10 years of age.

I am further advised that Transport NSW understands the new vehicle has not yet been placed into service due to extenuating circumstances facing the owner of the vehicle. Should it become apparent that the owner is not able to continue to provide the wheelchair accessible taxi service in Morisset, Transport NSW will advertise for interested parties to operate such a service.

I understand that the Kanangra Centre has made arrangements to transport Ms Heather Rosenthal to visit with her sister, Christine Rosenthal at least once a fortnight.

*11805TILLEGRA DAM-Mr Greg Piper asked the Minister for Water, and Minister for Corrective Services-

Why is the Minister using the 1979-1981 drought as a justification for Tillegra Dam when user pays water pricing commenced in 1982 lowering water demand by 30% and the Grahamstown Dam upgrade in 2005 increased Hunter water storage by 50%?

Answer-

The effective implementation of demand management strategies by Hunter Water started with the introduction of user pays pricing in the early 1980s and progressed through a suite of other demand management initiatives. However this is now being overtaken by the increasing demand for water in the Lower Hunter due to population growth, with an additional 160,000 people expected to be residing in the Lower Hunter region in the next 25 years.

The 2005 Grahamstown dam upgrade increased its effective storage from 131,800 megalitres to 190,000 megalitres. However, the Grahamstown dam is extremely volatile, with 30,000 megalitres lost from its storage every year to evaporation. The Hunter's storages can deplete rapidly during a drought due to these high evaporation rates.

Tillegra Dam, which can store up to 450,000 megalitres and has a smaller surface area to storage ratio,

will not be subject to such rapid rates of depletion.

(1) MyZone tickets are sold to stockists under contract arrangements with State Transit.

(2) As at 25 September 2010, there were 14 MyZone ticket stockists suspended from ordering MyZone tickets pending payment of overdue invoices.

(3) (a) to (c)Terms of payment and method of payment vary between individual contracts with ticket resellers.

As at 25 September 2010, cheque payment on delivery was the most common method of payment by MyZone ticket stockists, with 785 choosing this payment method. 426 stockists chose electronic funds transfer at time of delivery, and 419 chose to pay on account.

(4) A number of steps were taken to encourage businesses to become MyZone resellers and to assist those resellers already on board the PrePay network to transition to MyZone. These arrangements included:

- An initial supply of MyZone tickets delivered to all MyZone ticket stockists at the end of March 2010.
- Extended ordering arrangements during the transition period, and an extended payment term offer for all orders placed between 3 April 2010 and 3 May 2010.

- Individual contact by State Transit staff to encourage all registered MyZone ticket stockists to start placing their orders for MyZone tickets and to advise them of the offer of extended payment terms during the transition period.
- Mobile rapid response teams during the launch and transition period to personally deliver emergency ticket orders to ticket stockists.

(5) and (6) The transition to MyZone went smoothly. The government put in place strategies to quickly identify and resolve issues, for example:

- The mobile rapid response teams delivered emergency supplies of tickets to any reseller that had higher than anticipated demand and needed urgent replenishing;
- Mobile ticket sellers on key bus corridors and train stations across the network to ensure commuters could easily purchase their MyZone ticket;
- Treating the MyZone launch like a major event, with the Transport Coordination Group closely monitoring the change over, launch and transition from the Transport Management Centre;
- Additional customer service staff to assist the public transition to MyZone, with teams located at key locations across the public transport network.

(7) and (8) There are more than 1600 MyZone resellers across greater Sydney. This is an increase of more than 600 since the Premier announced MyZone. Resellers are responsible for deciding how many tickets they want to stock, and transport staff are in regular contact with retailers to make sure they are restocking and familiar with the ordering process.

State Transit continues to work closely with MyZone ticket stockists to achieve the best possible arrangements for their business. This includes MyZone ticket stockists being able to place emergency ticket orders for next business day delivery and/or twice a week ordering arrangements to ease any cash flow pressures. In addition, State Transit has appointed a relationship manager to proactively contact and call on ticket stockists at their premises to provide assistance as required.

- (1) Seasonal outbreaks of mosquitoes in Port Stephens are well documented, with local and state government authorities having been involved in managing the issue for many years. The region has very large areas of habitat (both natural and man made) used by mosquitoes, that immediately adjoin urban developments.
- (2) The Government's approach is documented in the 'Living with Mosquitoes Strategy', which was launched in December 2006 by the then Minister for the Hunter, the Hon Michael Costa MLC. The Strategy is the first of its kind in NSW and provides a solid basis for mosquito management with a strong focus on education, supported by sound information. Local communities benefit from education on personal protection strategies and local councils and schools are encouraged to play a big part in the implementation of these programs.

It is also intended that the information in the strategy will be used to ensure that mosquito issues are considered in urban planning and development, and wetland management plans, and that the community is informed of personal protection strategies to minimise exposure to mosquitoes.

 - (1) Given the recent announcement of a study into expanding Tourle Street Bridge, what evidence is there to show the current two-lane bridge is not coping with current traffic demands?

Answer—

I am advised:

(1) The Roads and Traffic Authority (RTA) has advised that traffic across Tourle Street Bridge and Cormorant Road has grown significantly since 2004.

While higher volumes of traffic are expected to continue while building activity related to the expansion of coal loading and other facilities on Kooragang Island is carried out, it is timely that the Government, as promised, begins planning for road and bridge improvements both for the short and longer term.

(2) Funding of \$100,000 has been made available to develop options, which include:

- The extension of the southbound merging lane for traffic near the railway level crossing to the west of the Cormorant Road roundabout.
- A possible lane extension for Tourle Street's southbound approach to the intersection with Industrial Drive to improve traffic flow.

The RTA will also start planning for the provision of a second two lane bridge and the duplication of Cormorant Road and Tourle Street. The duplication of Cormorant Road will obviously need to take into consideration the wetland area, therefore, it is important to start planning the new road and bridge now.

The RTA's planning activities will include consultation with stakeholders, survey, traffic assessments, environmental and geotechnical investigations and preliminary road design.

Further funding will be made available in 2011-12 to progress this work.

(3) Work to develop short term improvements will be completed in early 2011 and planning for the provision of a second two lane bridge and the duplication of Cormorant Road and Tourle Street will continue over the coming years.

(4) The preferred RTA option was to construct a replacement two lane bridge immediately downstream of the existing bridge, with a second two lane bridge to be constructed in the longer term. This enabled the old bridge to remain in service while the new bridge was constructed, maintaining access across the Hunter River.

The new \$44 million Tourle Street bridge was opened to traffic in May 2009, three months ahead of schedule. The completion of the new bridge ensures long term access to both sea and air ports and tourist and residential areas to the north and will form part of an ultimate four lane road across the river and across Kooragang Island.

The new bridge has been constructed about five metres downstream from the old bridge and the site of the old bridge will be used as the alignment for a second bridge and road in the future, enabling the RTA to connect a second bridge along the existing road alignment on the southern side of the bridge without encroaching on the industrial sites on either side of the road. The RTA considered the old bridge site provided the best site for a second bridge in the future.

Answer-

(1) to (6) Ageing, Disability and Home Care (ADHC) Metro North Vacancy Management process was followed as below:

- A vacancy was identified in the group home and the non government service provider forwarded a profile of the vacancy to the ADHC Metro North region.
- The client's support needs were matched as identified in the Client Profile against the identified capacity of the service to meet the needs. The Client Profile indicated that the placement was suitable to the client group.
- Prior to the offer of the placement, ADHC officers and the Executive Director of the nongovernment accommodation service provider agreed on the sustainability of the placement.
- A transition plan was developed to support the person to move into the group home. The transition process enabled the new resident and the existing residents to get to know one another, and for house staff to access relevant training and support as required to meet the needs of the new resident.

A resident of the house has been temporarily relocated to another group home with the same service provider. ADHC has been supporting the provider to put in place behaviour support strategies so that all residents feel safe.

ADHC has responded to several representations from this family. Additionally, in May 2010, ADHC also responded to the NSW Ombudsman regarding a complaint made by the family of this resident. On 5

August 2010, the NSW Ombudsman advised ADHC that the complaint did not warrant further action (see Question 2 regarding current accommodation arrangements).

ADHC's Allocation of Places in Supported Accommodation Policy and Procedures August 2009 requires a consistent and transparent process in allocating places across the State. ADHC ensures that people with a disability, their family and guardians are provided with sufficient information to make an informed decision on a proposed placement before an offer is made. Matching clients to a suitable accommodation option is a complex process. An Allocation Committee considers factors such as maintaining the individual's access to day time activities and the profiles of other residents in the supported accommodation unit.

With regard to the restoration of the Comrie Memorial Fountain and its relocation outside the Centennial Park Robertson Gate after it was removed from Moore Park in 1995 for the construction of the Eastern Distributor:

Answer-

(1) The Centennial Park and Moore Park Trust (Trust)'s proposed location for the restored Comrie Memorial Fountain is in a prominent position along Federation Way within Moore Park and within the City of Sydney's boundaries.

(2) The Trust worked with the Heritage Branch of the NSW Government Architect's Office to determine the most appropriate location for this heritage Fountain. Its original location was in the city and its second location in Moore Park is no longer available. Nine sites were considered.

The proposed location for the Comrie Memorial Fountain is on a prominent pedestrian and cycle route within Moore Park (Federation Way), near a major entry to Centennial Park, and close to the Centennial Parklands Equestrian Centre. This site best meets the requirements of the bequest by Mrs Comrie in 1895, to erect "an ornamental public drinking fountain within the boundaries of City of Sydney for the use of Man and Beast". This site offers, for the first time in Moore Park, a fully functioning fountain for people, dogs and horses.

The location assessment also considered heritage, architectural and multi-function considerations, access to utility services and minimising of vandalism or environmental damage.

The public consultation ran for two weeks via reception display and Trust website. Only six submissions were received requesting an alternate location be considered.

- (1) The species has been regularly monitored since 1998, and in 2004, a locked gate was installed over the Genowlan Point access track with a sign outlining the site's importance. In 2007, goat-proof cages were built over the remaining plants and advisory signs were applied to some of the cages. Two small water sources were filled-in to limit their use by goats. Plant cuttings of the species were taken and propagated at the Royal Botanical Gardens without success, and to date no seed has become available for collection. In 2008, targeted surveys of potential habitat were undertaken, however no new populations were identified.
- (2) Recreational 4WD clubs have not accessed the area beyond the gate, and no damage to plants has been observed. Given the remote and rugged terrain, the cost of erecting and maintaining a goat-proof exclusion fence is extremely high. Continued installation of cages over new and recovering plants is planned in conjunction with regular monitoring.
- (3) The NSW Threatened Species Priorities Action Statement describes relative priorities for each listed species. Establishing that the plant is a distinct species and investigating the conditions that will lead to seed production will guide management and ensure that strategies are implemented cost-effectively. The high cost of a goat-proof exclusion fence requires careful consideration. In addition, monitoring and research are the highest priority for this species given a lack of information regarding its biology and threats. As noted above, important protective measures have been implemented, which are proving effective and continue to be assessed for improvements.
