- *6097 REDEVELOPMENT OF FAIRFIELD HOSPITAL—Mr Nick Lalich asked the Minister for Health, and Minister for Medical Research—
 - (1) What progress has been made on the plans to redevelop the emergency department at Fairfield Hospital, including the potential for a separate paediatric treatment space?
 - (a) When will these redevelopments be completed?
 - (2) How many children attended the Fairfield Hospital Emergency Department in the 2013-14 financial year?

Answer-

I am advised that:

(1) - (2) Planning will be completed by 2014.

During the 2013-14 financial year, 8,783 children aged between 0-16 years presented to the Fairfield Hospital Emergency Department.

- *6098 EMERGENCY DEPARTMENTS TRANSFERS—Mr Nick Lalich asked the Minister for Health, and Minister for Medical Research—
 - (1) How many patients waited longer than 15 minutes to be transferred from ambulances to Emergency Departments at Fairfield and Liverpool Hospitals from 1 January 2014 to 1 September 2014?
 - (2) On average, how long did these patients have to wait before being transferred from the ambulance stretchers to Fairfield and Liverpool Hospital Emergency Departments?
 - (3) What were the reasons for the delays in transferring patients from trolleys to Fairfield and Liverpool Hospital Emergency Departments?

Answer-

I am advised that:

(1) - (3) Liverpool and Fairfield Hospitals follow the NSW Ministry of Health State-wide benchmark for ambulance transfer of care which is 90 per cent transferred with 30 minutes.

Delays in transferring patients from ambulance stretchers to the Emergency Department at Liverpool and Fairfield Hospitals are typically associated with peak periods of patient demand.

- *6099 CRIME IN BONNYRIGG, EDENSOR PARK AND GREENFIELD PARK—Mr Nick Lalich asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
 - (1) How many crimes were committed in Bonnyrigg, Edensor Park and Greenfield Park in each of the financial years 2012-13 and 2013-14?
 - (2) What is the NSW Police Force doing to reduce crime and improve safety in Bonnyrigg, Edensor Park and Greenfield Park?

Answer-

This Government, the NSW Police Force and NSW Crime Commission are working hard to ensure that people living in Western Sydney feel safe on the streets and in their homes. Under this Government, police numbers are at record highs. Authorised strength is currently 16,396, and the Government has committed to raising this to 16,665 officers in August 2015.

The Commissioner of Police determines the allocation of officers and since May 2011 has allocated almost 700 probationary constables to west and southwest Sydney commands. 590 additional positions have been brought online since December 2011, including 62 in western and south western Sydney commands. These officers are supported by special region based squads and taskforces, Street Crime Units and Operation Talon targeting gun crime.

The Bureau of Crime Statistics and Research (BOCSAR) is the official source of crime information in New South Wales and is the appropriate agency to provide crime statistics. BOCSAR falls within the portfolio of the Attorney-General and Minister for Justice.

*6100 CABRAMATTA LOCAL AREA COMMAND DISCIPLINARY ACTION—Mr Nick Lalich asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—

How many officers at the Cabramatta Local Area Command faced disciplinary action or suspension in each of the years from 2012 to 2014?

Answer-

The NSW Police Force has advised me:

A search of police records concerning police officers at Cabramatta Local Area Command has revealed no actions taken against police officers under section 173(2) of the Police Act 1990 in response to complaints received between 1 January 2012 and 30 August 2014.

There was also no record of Cabramatta officers being suspended, either with or without pay, in the same period.

- *6101 LIVERPOOL-PARRAMATTA TRANSITWAY SERVICE—Mr Nick Lalich asked the Minister for Transport, and Minister for the Hunter—
 - (1) What suburbs will the Liverpool-Parramatta Transitway service?
 - (2) What progress has been made in planning the Liverpool-Parramatta Transitway?
 - (3) When will the Liverpool-Parramatta Transitway commence operation?

Answer—

I am advised:

The Liverpool-Parramatta Transitway has been in operation since 2003.

Future plans for the Liverpool-Parramatta Transitway are available in Sydney's Bus Future, 2013, available on the Transport for NSW website.

*6102 COMMUNITY SUPPORT PROGRAM CHANGES—Mr Nick Lalich asked the Minister for Family and Community Services—

Has the Government made any representations to the Federal Government about the impact of the recent changes to the Community Support Program on childcare availability, costs and flexibility for families in New South Wales?

Answer-

This question should be redirected to the Minister for Education.

- *6103 ONE-STOP-SHOP IN WETHERILL PARK—Mr Nick Lalich asked the Minister for Finance and Services—
 - (1) Why has the Government decided to establish a Service NSW one-stop-shop in Wetherill Park over other nearby centres including Cabramatta and Fairfield?
 - (2) What infrastructure will the Government put in place to ensure the public have easy access to the Service NSW one-stop-shop in Wetherill Park?

Answer-

In the next 12 months the Government is planning to roll out a further 18 one-stop shops to add to the 18 already trading. This network of one-stop shops will continue to grow and, with improved online access, will break down the barriers to doing business with the Government.

Service NSW evaluates service centre locations against a strict set of criteria including population catchment, estimated population growth, geographic spread, availability of suitable sites, and maximising overall access for communities across the State.

Underpinning this evaluation is detailed analysis of public transport links, travel distance, duplication of services, customer volumes/population shift, increasing use of digital services and continuity of existing services.

Service NSW is making sure that customer service centres are located in the right spot.

- *6104 ARBORIST ASSESSMENTS IN CABRAMATTA—Mr Nick Lalich asked the Minister for Education—
 - (1) Which schools in the Cabramatta electorate have had or will have arborist assessments?
 - (2) Which schools in the Cabramatta electorate have been recommended to have trees lopped or

removed?

Answer-

- (1) All schools in the Cabramatta electorate have had tree safety assessments completed by Level 5 qualified consulting arborists.
- (2) Arborists have recommended work to remove or lop trees that present an unacceptable safety risk at all schools in the electorate.
- *6105 MOTOR VEHICLE ACCIDENTS AND TRAFFIC OFFENCES—Mr Nick Lalich asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, and Vice-President of the Executive Council—
 - (1) How many motor vehicle accidents and traffic offences were recorded in Edensor Park, Greenfield Park and Bonnyrigg Heights in each of the financial years 2012-13 and 2013-14?
 - (2) What roads and streets recorded the most motor vehicle accidents and traffic offences in the 2013-14 financial year?

Answer-

I am advised:

Crashes where at least one person was killed or injured, or at least one motor vehicle was towed away:

Edensor Park:

- 30 crashes in 2012-13 and 35 crashes in 2013-14.
- Allambie Rd, Arrowhead Rd, Bingham PI, Boomerang Rd, Busby Ave, Condello Cres, Coonawarra St, Cowpasture Rd, Cusak Cl, Edensor Rd, Eldershaw Rd, Elizabeth Dr, Furci Ave, Kalang Rd, Smithfield Rd, Timothy PI and Weeroona Rd.

Greenfield Park:

- 40 crashes in 2012-13 and 37 crashes in 2013-14.
- Blacksmith St, Cherokee Ave, Cheyenne Rd, Devenish St, Edensor Rd, Greenfield Rd, Mimosa Rd, Mistral Stand Smithfield Rd.

Bonnyrigg Heights:

- 28 crashes in 2012-13 and 20 crashes in 2013-14.
- Aplin Rd, Auckland St, Borojevic St, Brown Rd, Delgarno Rd, Dowland St, Elizabeth Dr, Glucester St, Marriott Rd, Middlehope St, Minto Cl, Mount St, Northumberland St, North Liverpool Rd, Simpson Rd and Wilson Rd.

Data for 2013 and 2014 is preliminary and subject to change.

Information about traffic offences is a matter for the Minister for Finance and Services responsible for the State Debt Recovery Office.

- *6106 PARKES AND FORBES HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Will any of the funds for the planned \$113.4 million redevelopment of Parkes and Forbes Hospitals come from the Federal Government?
 - (2) Will any of these funds come from the private sector as a Private-Public Partnership?
 - (3) Will the nursing, medical, and allied health staff at Parkes and Forbes Hospitals continue to be employed by NSW Health once the reconstruction is complete?
 - (4) Will any NSW Health staff who currently work at the hospitals be transferred to a private contractor in the future?

Answer—

I am advised:

(1) - (3) The Government is funding the full cost of this project.

The nursing, medical and allied health staff at Parkes and Forbes Hospitals will continue to be employed by NSW Health once the reconstruction has been completed.

- *6107 PARKING AT BLACKTOWN HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Is the three-day parking ticket for \$10 and the seven-day ticket for \$20 at Blacktown Hospital (Ref Q.5620) now available?

- (a) If so, when did this ticket become available?
- (b) If not, when will this ticket be available?
- (2) What other hospitals plan to introduce this ticket?

Answer—

I am advised:

(1) - (2) The three-day and seven-day concessional parking tickets have been available at Blacktown Hospital since 14 July 2014.

Charges for existing staff and public car parking will continue to be determined by the Local Health District.

- *6108 NURSING BUDGET AT SHOALHAVEN HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) What is the total nursing budget for the maternity unit at Shoalhaven Hospital for the 2014-15?
 - (2) What was the total cost of nursing for July 2014 and August 2014?
 - (3) Did any nurses work shifts longer than 14 hours from January 2014 to August 2014?
 - (a) If so, how many shifts of 14 hours or more were there?

Answer-

I am advised:

- (1) (2) Local Health District Chief Executives and Boards are responsible for managing their budget in accordance with the requirements of the annual Service Agreement between the Ministry of Health and Districts
- (3) There are no rostered shifts of 14 hours. Staff may work additional hours to their rostered shift to cover unexpected shortfalls. From January 2014 to August 2014 there were a total of 14 shifts that were 14 hours or more in the Shoalhaven Hospital Maternity Unit.
- *6109 MATERNITY SERVICES UNIT AT SHOALHAVEN HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Are any trainee midwives employed in the maternity services unit at Shoalhaven Hospital?
 - (a) If so, how many?
 - (2) Is there a nurse educator currently employed in the maternity services unit at Shoalhaven Hospital?
 - (a) If so, what is this employee's full-time equivalent value?
 - (b) If not, what criteria is used to determine whether a nurse educator is employed in any given unit?
 - (c) If not, are there plans to employ a nurse educator in the future?

Answer—

I am advised:

(1) - (2) Shoalhaven Hospital currently employs one 0.8 FTE student midwife in the Maternity Service.

Shoalhaven Hospital Maternity Service has a full time Clinical Midwifery Consultant as well as eight Clinical Midwifery Specialists all of whom have responsibilities for the education and supervision of less experienced staff.

- *6110 MIDWIVES AT SHOALHAVEN HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) What is the full-time equivalent midwife establishment at Shoalhaven Hospital?
 - (2) How many midwives are employed at Shoalhaven Hospital as at 9 September 2014?
 - (3) How many midwife vacancies are there at Shoalhaven Hospital as at 9 September 2014?
 - (a) What plans exist to fill these vacancies?

Answer-

I am advised:

(1) - (3) Present staffing satisfies the requirements determined by the Birthrate Plus staffing methodology of the Public Health System Nurses' and Midwives' (State) Award.

At any one time hospitals operate with a degree of staff vacancies. Where vacancies exist, qualified temporary staff are employed as required, pending recruitment.

- *6111 NATIONAL PATIENT TRANSPORT GROUP—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Has the Minister or her office met with the National Patient Transport Group or their representatives?
 - (a) If so, when?
 - (b) If so, what was discussed at any such meeting?

Answer-

- (a) Yes in 2012; (b) Non-Emergency Patient Transport.
- *6112 CONRAD CAPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Has NSW Health or your office contracted the services of Conrad Capital?
 - (a) If so, did this occur in 2014?
 - (b) If so, for which projects?
 - (c) If so, what was the total cost of services provided?

Answer-

I am advised:

Please refer to the previous responses to questions in relation to this matter (ref Q.4672, Q.5066 and Q.5327).

The NSW Ministry of Health has not contracted the services of Conrad Capital during 2014.

- *6113 SMOKING AT THE BEACH—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) Is it legal to smoke between the flags on New South Wales beaches?
 - (a) If so, are there any plans to ban it?

Answer—

I am advised:

The smoke-free outdoor provisions in the Smoke-free Environment Act 2000 do not affect any smoking bans put in place by Local Councils.

- *6114 SMIRNOFF ADVERTISEMENTS ON BUSES—Dr Andrew McDonald asked the Minister for Transport, and Minister for the Hunter—
 - (1) Are the Smirnoff Double Black vodka "arrive boldly" advertisements still advertised on the side of Sydney buses?
 - (a) If so, on how many buses?
 - (b) If not, when was the final advertisement removed?
 - (2) Did the Minister, or her office, take steps to expedite removal of these advertisements?

Answer-

I am advised:

APN Outdoor was contracted in 2006 to manage the advertising space on State Transit buses. All advertising must comply with the standards set by the Advertising Standards Bureau.

The advertisements have not been displayed on State Transit buses since December 2013.

- *6115 HEALTH CARE CENTRE AT WEST DAPTO—Ms Anna Watson asked the Minister for Health, and Minister for Medical Research—
 - (1) Can the Minister provide more details of the Illawarra Shoalhaven Health District's plan to establish a health care centre at West Dapto?
 - (2) Where will the planned health care centre be located?
 - (3) What services will be available at this health care centre?
 - (4) How much capital funding has been allocated for the construction of this health care centre?
 - (5) On what date will building of the health care centre commence?
 - (6) What is the estimated completion date of the health care centre?
 - (7) How much capital funding has been allocated to implement phase 1 and phase 2 of the Shellharbour Hospital redevelopment?

Answer—

I am advised:

(1) - (7) As part of a forward planning process, the Illawarra Shoalhaven Local Health District identified the need to expand the range of primary and community health care services available in Dapto.

The detailed planning required for the provision of such a service is yet to commence.

Funding of \$3.76 million was allocated in the June 2014 Budget to continue the planning for the redevelopment of Phase One of the Shellharbour Hospital.

- *6116 MATERNITY UNIT SERVICES AT SHELLHARBOUR HOSPITAL—Ms Anna Watson asked the Minister for Health, and Minister for Medical Research—
 - (1) Why were maternity unit services at Shellharbour Hospital discontinued?
 - (2) Why hasn't the Government re-introduced maternity unit services at Shellharbour Hospital since being elected in March 2011?

Answer-

I am advised:

(1) - (2) When obstetricians and anaesthetists withdrew their services to Shellharbour Hospital in December 2003, birthing services at the hospital ceased in the interests of patient safety. Birthing services were consolidated at Wollongong Hospital to enable a greater number of women in the Illawarra to safely deliver their babies.

The factors that contributed to the consolidation of birthing services to Wollongong Hospital remain relevant. Maintaining a single public birthing service remains the most appropriate action to sustain access to high quality and safe birthing services in the Illawarra region.

The number of public hospital births across the Illawarra has not increased over the period 2000-01 to 2012-13 and is not projected to increase significantly to 2027.

- *6117 TREATING EATING DISORDERS IN THE ILLAWARRA—Ms Anna Watson asked the Minister for Mental Health, Assistant Minister for Health—
 - (1) Has the Illawarra Shoalhaven Local Health District commenced development of a local service plan for eating disorders in the Illawarra region (ref Q.5068)?
 - (a) If so, when did the development of this plan start, which stakeholders are involved and what type of community consultation will be held?
 - (b) If not, why not?

Answer-

I am advised:

The initial development of the Illawarra Shoalhaven Local Health District Eating Disorders Service Plan commenced in January 2014.

The Eating Disorders Service Plan will support better access, innovation and improvement in care for people with eating disorders within the Illawarra Shoalhaven Local Health District.

An Eating Disorders Project Forum is occurring on 15 October 2014 with local stakeholders to further develop the Plan.

- *6118 SHELLHARBOUR HOSPITAL MENTAL HEALTH SERVICES—Ms Anna Watson asked the Minister for Mental Health, Assistant Minister for Health—
 - (1) Are there currently 49 adult acute/high dependency mental health beds at Shellharbour Hospital?
 - (a) Has the number of these beds been reduced or beds closed?
 - (i) If so, why?
 - (2) Does the Illawarra Shoalhaven Local Health District Asset Strategic Plan 2013-14 to 2023-24 propose to increase the number of adult acute/high dependency mental health beds at Shellharbour Hospital to 103?
 - (a) How does the Government intend to meet this target?

Answer—

I am advised:

(1) - (2) There are 49 acute adult mental health beds at Shellharbour Hospital. Three of these beds are currently closed following an incident in the Eloura West Mental Health Unit on 31 July 2014.

Since the beds have been temporarily closed there have been no delays in admitting patients into Mental Health beds.

It is not proposed that these beds be re-opened until reports and recommendations of investigations into the incident have been received and considered.

Additional beds will be the subject of future planning.

- *6119 ILLAWARRA REGIONAL GROWTH PLAN—Ms Anna Watson asked the Minister for Planning, and Minister for Women—
 - (1) When will the Government release the Illawarra Regional Growth Plan?
 - (2) What are the reasons for the delay in releasing the Plan, given the Department of Planning and Environment's website indicated that it would be released in mid 2014?
 - (3) When the Plan is released, will it be as a draft plan or the final plan?

Answer-

I am advised:

- *6120 ILLAWARRA INSTITUTE OF TAFE—Ms Anna Watson asked the Minister for Education—
 - (1) Did the Illawarra Institute of TAFE remove or relocate any Illawarra campus services at Dapto TAFE?
 - (a) If so, which services?
 - (2) Has the Illawarra Institute of TAFE or TAFE NSW been approached by any private training provider or registered training organisation to buy or lease any of the buildings and land at the Dapto TAFE campus?
 - (a) If so, which person or organisations made those approaches?
 - (3) Is the Government committed to ensuring the buildings and land at the Dapto TAFE campus remain an asset owned and managed by TAFE NSW?
 - (a) If not, why not?

Answer-

- (1) Yes; (a) TAFE NSW Illawarra Institute Finance Unit.
- (2) No; (a) Not applicable.
- (3) Facilities at Dapto campus will be retained as a TAFE NSW asset while ever they are required for the delivery or support of approved educational and training programs.
- (a) Not applicable.
- *6121 NEW SENIOR ENGLISH SYLLABUS—Mr Barry Collier asked the Minister for Education—
 - (1) Were there only two face to face consultations with teachers in New South Wales schools regarding the proposed new senior English syllabus?
 - (a) If so, why?
 - (2) Where did the proposals for amending the syllabus originate?
 - (3) How does the proposed new senior syllabus build on the 7-10 syllabus currently being implemented in New South Wales schools?

Answer-

(1) No.

The initial phase of consultation has involved 13 face to face meetings across the four subject areas of English, Mathematics, Science and History, including four meetings in regional centres. Board of Studies, Teaching and Educational Standards (BOSTES) officers have also met with university academics for feedback and input.

To date over 270 teachers have attended BOSTES meetings and the BOSTES has received over 300 surveys.

In the next phase of consultation there will be a greater number of face to face meetings in regional and metropolitan areas. There will also be the usual other opportunities for formal feedback. These broad and thorough consultation processes will be repeated again when the syllabuses are drafted.

(2) The feedback and advice the BOSTES received from teachers and key stakeholders during consultation on the Australian curriculum was analysed by a Reference group to develop a series of broad proposals for syllabus development.

The proposals were published to raise discussion and were not intended to limit the full scope of options that could be considered.

- (3) A report which outlines the research that shaped the development of past New South Wales syllabus design is available on the BOSTES website. The report makes explicit the importance of ensuring that the new senior secondary syllabus for English will strengthen the learning continuum in New South Wales from Year 10 into the Preliminary years and HSC courses.
- *6122 SCHOOL SPEED ZONE FLASHING LIGHTS—Mr Barry Collier asked the Minister for Transport, and Minister for the Hunter representing the Minister for Roads and Freight, and Vice-President of the Executive Council—

When will flashing warning signals marking 40 kilometre per hour speed zones be installed outside the following schools:

- (a) Jannali East Public School;
- (b) Kareela Public School;
- (c) Kirrawee Public School; and
- (d) Grays Point Public School?

Answer-

I am advised:

The Government is delivering school zone flashing lights to all eligible schools in the state by the end of 2015. The rollout schedule is available on the Centre for Road Safety website.

- *6123 ALCOHOL RELATED OFFENCES AT DAWSON MALL—Mr Richard Amery asked the Minister for Police and Emergency Services, Minister for Sport and Recreation, and Minister Assisting the Premier on Western Sydney—
 - (1) How many persons were arrested by Police in the Dawson Mall, Mount Druitt and surrounding areas from 1 September 2013 to 31 August 2014?
 - (2) How many of these arrests were for alcohol related offences?
 - (3) How do these figures compare to previous years?

Answer—

The NSW Police Force has advised me that its databases are operational, not statistical. The information requested by the Member is not readily available from current systems and its extraction, even if possible, would entail an unreasonable diversion of policing resources.

- *6124 DISABILITY PAYROLL TAX REBATES—Mr Alex Greenwich asked the Minister for Family and Community Services representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—
 - (1) What rebates or exemptions does the Government provide for employers to employ people with a disability?
 - (2) What plans does the Government have to expand on existing help to employers?
 - (3) What further action will the Government take to support people with a disability through payroll tax relief?

Answer-

- (1) (3) Information relating to employment enablement strategies are available in the 2014-15 Budget Papers and on the Department of Family and Community Services website.
- *6125 INNER WEST LIGHT RAIL—Mr Jamie Parker asked the Minister for Transport, and Minister for the Hunter—
 - (1) When will the report into noise and vibration on the Inner West Light Rail that was commissioned by Transdev and dated July 2014 be made public?
 - (2) Is the Minister aware that the Environment Protection Authority (EPA) advised that exceedances of the noise goals outlined in the Department of Planning and Environment's Conditions of Approval for the project were identified in the report?
 - (3) When will affected residents in Glebe have the opportunity to discuss the results of the report?

- (4) Why has the Minister not kept her commitment to discuss the findings in the report?
- (5) Why did the Minister claim via correspondence that the noise and vibration assessments at the Glebe light rail stop did not exceed the goals set out in the environmental licence when both the EPA and Transport for NSW have now confirmed in writing the goals were exceeded?

(1) - (25) I met with Mr Jamie Parker MP and three residents of Glebe on Wednesday 17 September 2014 to discuss these matters.

I am advised:

A number of initiatives have been undertaken in response to residents' concerns, and further measures are planned over coming months.

The Environmental Protection Authority is satisfied with the mitigation initiatives proposed to correct the minor noise criteria exceedance.

Further noise and vibration tests will be carried once all planned maintenance and mitigation works have been completed.

The maximum operating speed is 80 kilometres per hour. Lower speeds are in place along sections of the network, for example at station approaches and curves.

Noise and vibration measurements were taken at the relevant operational speeds at various locations across the network.

Vibration testing is undertaken on the walkway adjacent to the Lombard Street Apartments and above the Glebe Tunnel.

Under the 1999 Inner West Light Rail Extension (Westex) approval, there is no requirement for the testing point to be on the facade of the building or within residences.

Due diligence including testing is undertaken on vehicles procured for service.
