- *12197PRESSURE SEWERAGE SYSTEMS—Mr Stuart Ayres asked the Minister for Water, and Minister for Corrective Services—
 - (1) (a) Will NSW Water bear the electricity cost for Western Sydney residents, for example in Appin, of running the grinder pump required by the pressure sewerage system?
 - (b) If not, will the property owner bear the cost?
 - (2) What considerations determined the installation of pressure sewerage systems in some properties, for example at Appin, rather than the more common gravity fed sewerage systems?
 - (a) Was any consultation with property owners undertaken?
 - (b) Was the shorter working life of pressure sewerage systems taken into account?
 - (3) Has any agreement been made between NSW Water and developers of new housing estates regarding sewerage systems?

Answer—

- (1) and (2) I note the Member's reference to "NSW Water" in his question. Since it is not clear to which agency he refers it is difficult to provide the information he seeks.
- *12198DVPASS PROGRAMS—Mr Stuart Ayres asked the Minister for Tourism, Minister for the Hunter, Minister for Science and Medical Research, and Minister for Women—
 - (1) What criteria determined the funding of the five DVPASS programs in Sutherland, the Inner West, Wollongong, Redfern, and Canterbury?
 - (2) What criteria determined the expansion of DVPASS programs to Coffs Harbour, Rockdale/Kogarah, the Eastern Suburbs, Parramatta and Armidale?
 - (3) Was any consultation undertaken with police, community health care, local government, indigenous communities, or other potential stakeholders?
 - (4) What criteria excluded the Penrith DVPASS program, the Bridges Project, from future funding?
 - (5) How many DVPASS programs throughout the State will, like Penrith's DVPASS program, not receive ongoing funding?

Answer—

As part of the NSW Government's \$50 million, five-year Domestic and Family Violence Action Plan, the NSW Government has allocated \$3.7 million in funding to support and expand Domestic Violence Proactive Support Services, or DVPASS as they are known, to a total of 10 locations across NSW.

I am advised the Action Plan was prepared with reference to information received from consultation forums held across NSW with over 300 individuals representing key Government and non-Government stakeholders. 68 written submissions were also received. The NSW Police Force and other key Government agencies were also consulted on initiatives in the Action Plan.

The decision in relation to funding DVPASS projects under the Action Plan was based on a number of factors, including local domestic violence statistics, availability of other services in the area and the ability of the projects to reach women at greater risk of violence, such as Aboriginal women, culturally and linguistically diverse women and women in rural areas.

- (1) and (2) Since my appointment as Minister for Education and Training in September 2008, I have shown a strong commitment to quality education and made regular visits to schools, TAFEs and other learning institutions across the state.

 - (1) How many times has a NSW Minister for Emergency Services visited the Port Stephens electorate since April 2007 in an official capacity?

Answer—

The Government continues to deliver for the people of the Port Stephens electorate.

Recently, the \$44 million Tourle Street Bridge was completed, and opened to traffic on 7 May 2009.

In September this year, the Minister announced the NSW Regional Homelessness Action Plan for the Hunter. This plan identified \$9.3 million dollars worth of initiatives for the Hunter, which includes the electorate of Port Stephens. This is a tailored response to homelessness in the region.

Answer_

As Minister for Planning, Minister for Infrastructure and Minister for Lands, I have visited many electorates across the State and met with various local MPs, local councils, government and non-government agencies, community groups and individuals, to discuss a range of issues.

*12209"L" AND "P" PLATE DRIVERS—Mr Peter Debnam asked the Minister for Roads, and Minister for Western Sydney—

Given your advice the Government will not advise parents or guardians of "L" and "P" plate drivers (under 18 years of age) of any speeding or other traffic offences committed by teenage drivers (Question 11180):

Is the Government aware parents and guardians would expect to be advised of any police or RTA action taken against minors in their care?

Answer-

I am advised:

The RTA has received few, if any, comments from parents or guardians requesting that they be notified of a driving offence. Furthermore, the RTA does not hold information regarding a parent or guardian relationship as this is not a requirement to obtain a learner or provisional licence.

*12211STRICKLAND HOUSE ESTATE—Mr Peter Debnam asked the Minister for the State Plan, and Minister for Community Services representing the Minister for Planning, Minister for Infrastructure, Minister for Lands—

In relation to Strickland House Estate and given your advice discussions with Woollahra Council representatives on 22 April and 20 May 2010 centred on the heritage conservation and public access objectives of any future use proposals, and the updating of the site's 2003 Conservation Management Plan (Question 11265):

What are the nature of the public access objectives discussed in those meetings?

Answer-

The State Property Authority, in keeping with its commitment to maintain long term public access to the foreshore, and to Strickland House heritage buildings and grounds, discussed improvements to the condition of the buildings and grounds, community concerns, requirements and future consultation with residents in the planning process, and sustainable funding and management arrangements.

*12215FAMILY AND CARER MENTAL HEALTH PROGRAM—Mr Victor Dominello asked the Deputy Premier, and Minister for Health—

In relation to the Family and Carer Mental Health Program:

- (1) How many people accessed these services during: a) 2007, b) 2008, c) 2009 and d) 2010 to date?
- (2) How many full-time equivalent staff were employed to deliver the program during: a) 2007, b) 2008, c) 2009 and d) 2010 to date?
- (3) How much funding did ARAFMI (North Ryde) receive from the Northern Sydney Central Coast Area Health Services during: a) 2007, b) 2008, c) 2009 and d) 2010 to date?
- (4) On what date does NSCCAHS funding for the service cease?
- (5) Have all clients been given written notification of the closure of the service?
- (6) If so, on what date was the notification sent?
- (7) On what date does Uniting Care take responsibility for delivering the service?
- (8) How many people attended Macquarie Hospital Peer Support Group meetings during: a) 2007, b) 2008, c) 2009 and d) 2010 to date?
- (9) Will these meetings continue at Macquarie Hospital once Uniting Care takes over responsibility for delivering the services?

Answer—

I am advised:

(1) There is no data available on the number of people who accessed these services for 2007 and 2008. In 2009, there were 22,984 contacts with carers through the Family and Carer Mental Health Program NGO service providers state-wide. From January to June 2010, there have been 15,975 contacts with carers through the Family and Carer Mental Health Program. There is currently no data available from July 2010.

(2) The following table provides the number of FTEs funded for the Family and Carer Mental Health Program for the years 2007, 2008, 2009 and 2010 to date:

(3) to (9) ARAFMI (North Ryde) did not receive any direct funding from Northern Sydney Central Coast Area Health Service in the period 2007-2010. ARAFMI NSW head office received funding from Northern Sydney Central Coast Area Health Service for the years 2006-07 and 2007-08. Responsibility for this payment was transferred to the NSW Department of Health from 2008-09 as shown in the table below.

ARAFMI NSW's funding for the Family and Carer Mental Health Program was paid directly from NSW Health. This funding was to provide services to families and carers of people with a mental illness in the Northern Sydney Central Coast Area Health Service. The funding was as follows:

While funding paid to ARAFMI NSW to deliver Family and Carer Mental Health Program Funding ceased on 30 September 2010, the Program will continue to be delivered through Uniting Care Mental Health who took responsibility for delivering this service in the Northern Sydney Central Coast Area from 1 October 2010.

Uniting Care Mental Health provided a letter of introduction, consent for the transfer of information form and reply paid envelopes to ARAFMI NSW on 20 September 2010, for inclusion in the letters to be mailed out to ARAFMI clients.

Monthly peer support groups are held at Macquarie Hospital by a Non Government Organisation. Data on attendees is not held by NSW Health.

The decision as to whether or not any particular support groups continue at Macquarie Hospital or elsewhere within Northern Sydney Central Coast Area Health Service will be an operational decision made through negotiations between ARAFMI NSW, Uniting Care Mental Health and Northern Sydney Central Coast Area Health Service.

*12216UNPAID MEDICAL FEES—Mr Victor Dominello asked the Deputy Premier, and Minister for Health—

In relation to the Parliamentary Secretary for Health's response (Ref: eA1599745 M10/5422) to my letter of 11 August 2010 regarding the cost of unpaid medical fees from international visitors at Ryde Hospital:

- (1) In reference to the NSCCAHS estimate that \$52,000 had been lost during the period January-September 2010, what steps are being taken to recoup the outstanding fees?
- (2) How much was lost in unpaid medical fees incurred by non-Australian residents during: a) financial year ending 2006, b) financial year ending 2007, c) financial year ending 2010?
- (3) Of all the incidents of unpaid medical fees incurred by non-Australian residents, how many involved student visa holders?
- (4) Of all the incidents of unpaid medical fees incurred by non-Australian residents, how many involved student visa holders who did not have private health insurance or whose cover had expired?

Answer-

I am advised:

(1) All accounts representing the \$52,000 owed by international visitors at Ryde Hospital are followed up in accordance with the NSW Department of Health policy directive. Follow-up actions include the sending of reminder letters, final notices, and communicating with the debtor to secure payment, or to enter into an arrangement to pay by instalments. Where the follow-up actions undertaken by Northern Sydney Central Coast Area Health Service have been exhausted, the account will be referred to a debt collection agency to instigate recovery action.

As at the end of October 2010, a total of \$26,270 has been paid; \$4,222 has been referred to a collection agency; \$16,837 is under an arrangement to pay by instalments; \$4,498 is currently being negotiated with the debtor; and \$445 has been written off as irrecoverable.

- (2) Amount lost in unpaid medical fees was as follows:
 - (a) Financial year ending 2006: \$26,141
 - (b) Financial year ending 2007: \$10,248
 - (c) Financial year ending 2008: \$30,762
 - (d) Financial year ending 2010: \$8,749
- (3) and (4) Information that identifies a non-Australian resident as a student visa holder is not recorded.
- *12218BUS LANES—Mr Brad Hazzard asked the Minister for Roads, and Minister for Western Sydney—

What has been the total expenditure on consideration of, and installation of, 24 hour bus lanes on the Condamine Street/Pittwater Road corridor?

Answer-

I am advised:

Three 24 hour bus lanes have been installed on the Condamine Street / Pittwater Road corridor as part of the Strategic Bus Corridors Program:

- Condamine Street southbound from Pittwater Road, Brookvale to Campbell Parade at Manly Vale.
- Pittwater Road, northbound, from Condamine Street to Cross Street at Brookvale.
- Pittwater Road, southbound, from Garden Street to Wakehurst Parkway at North Narrabeen, as part of the bus priority project at the Pittwater Road and Wakehurst Parkway intersection.

The total expenditure on these projects was \$11.6 million.

- *12219MEDICAL STAFF VACANT POSITIONS—Mr Brad Hazzard asked the Deputy Premier, and Minister for Health—
 - (1) What medical staff positions are currently vacant at:
 - (a) Mona Vale Hospital;
 - (b) Manly Hospital?
 - (2) For how long has each position been vacant?

Answer—

I am advised:

(1) and (2) At any one time most hospitals operate with a degree of staff vacancies. However, where vacancies exist, temporary qualified staff are employed where required pending recruitment to these positions.

The Northern Sydney Central Coast Area Health Service continues to actively recruit for one Visiting Medical Officer (VMO) in Orthopaedics and a 0.5 full time equivalent (FTE) Staff Specialist Director of Medical Assessment Unit for Mona Vale Hospital; and two VMOs Neurology/Stroke, one FTE Advanced Trainee in General Medicine and one FTE Paediatric Unaccredited Registrar for Manly Hospital.

*12221POLICE AREAS OF OPERATIONS—Ms Katrina Hodgkinson asked the Minister for Police, and Minister for Finance—

Given statements by NSW Police Officers to residents of Wallaroo and Spring Range (located adjacent to the Barton Highway close to the NSW ACT border) that it is the responsibility of the Queanbeyan Police Station to respond to their requests for police assistance:

- (1) Are NSW Police Officers permitted to transit through the ACT when responding to requests for assistance without prior consultation or authorisation from the ACT government or Federal Police?
- (2) If not, how long does this consultation or authorisation generally take?
- (3) Has any consideration been given to transferring responsibility for responding to callouts from these

localities to the Yass Police Station?

- (4) If so, what was the outcome of these considerations and the reason for retaining Queanbeyan as the responsible police station?
- (5) In the past 12 months how many requests for the NSW Police to attend incidents in Spring Range and Wallaroo have been received?
- (6) How many of these requests did NSW Police attend?
- (7) Of the requests attended, what was the maximum, minimum and median response time?

Answer—

The NSW Police Force has advised me:

- (1) and (2) Yes. No notification is required for non-urgent transit. If transit is in response to urgent duty, where police may exceed speed limits or otherwise contravene normal traffic rules, the ACT Police Communications Centre is notified by radio and permission is normally immediate.
- (3) and (4) No. In emergency situations, the nearest police will attend regardless of Local Area Command boundaries.
- (5) In the 12 months to end October 2010, 20 calls were received from members of the public in the nominated areas.
- (6) 18 out of the 20 calls resulted in police attendance and two minor matters were referred to the Police Assistance Line. Of the 18 calls responded to, 13 were attended by Queanbeyan police and five by Yass police.
- (7) Response times were recorded for 13 of the recorded calls. The minimum response time recorded was 30 minutes with a maximum of 208 minutes, with a median of 80 minutes. It should be noted that the calls covered both urgent and non-urgent matters.
- *12222SYDNEY WATER METER READING—Ms Katrina Hodgkinson asked the Minister for Water, and Minister for Corrective Services—

Given recent media reports about Sydney Water customers being issued with water bills that reflect significantly higher water usage than actually occurred and the admission by Sydney Water that in these cases the residential meters were not read:

- (1) Does Sydney Water keep records of whether individual water meters were read or not read before the issuing of a water bill?
- (2) In what specific circumstances are Sydney Water employees permitted to not read a meter before a water bill is sent?
- (3) With reference to the incident reported in the Hornsby Advocate on 27 October, why was this water meter not read?
- (4) On average, how many water meters are not read by Sydney Water before issuing water bills?

Answer—

I am advised:

- (1) Sydney Water maintains records of when water meters are read, and if not, the reason(s) why the meters were not read.
- (2) Meter readers do not read meters if the meters are inaccessible, such as behind locked gates and walls, in backyards, buried in gardens or undergrowth or if considered unsafe to access the area of the property where the meter is situated. In these cases, courtesy cards are left at the property for the customer to supply the reading.
- (3) Sydney Water has confirmed that the meter was read, however, the meter reading was incorrectly recorded by the meter reader.
- (4) Sydney Water issued approximately 98 percent of its bills in the last quarter based on actual meter readings. Where it was not possible to obtain an actual reading, the customer's water use was estimated.
- *12223GLENDALE ROAD/RAIL INTERCHANGE—Ms Sonia Hornery asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer) representing the Minister for Transport, Minister for the Central Coast—

What progress has been made on the development/planning/funding of the Glendale Road/Rail Interchange?

Answer—

Transport NSW and RailCorp have worked with the Transport Construction Authority to finalise the

Glendale Transport Interchange Strategic Appraisal Report.

NSW Transport and Infrastructure will continue to work with Lake Macquarie Council in relation to the town centre, and associated transport access.

- *12224PALLIATIVE CARE BEDS—Mr Daryl Maguire asked the Deputy Premier, and Minister for Health—
 - (1) How many palliative care beds are included in the new Wagga Wagga Base Hospital plan?
 - (2) How many are available now?
 - (3) Will the new palliative care ward have accommodation available for families of terminally ill patients to stay?
 - (4) When can the community expect delivery of a new unit?
 - (5) In what phase of the development will the palliative care wing be built?
 - (6) How many palliative care nurses are in the GSAHS (Wagga electorate)?

Answer-

I am advised:

(1) to (6) Planning is underway for the construction of a \$90 million Stage 1 redevelopment of Wagga Wagga Base Hospital. This includes a Master Plan for the entire site. The Master Plan is being developed with a focus on providing clinical priorities and improved health outcomes, and will ensure that the hospital can be built in stages to respond to future capital funding.

A community based palliative care service is provided by Wagga Wagga Health Service in line with the National Pallative Care Strategy.

- *12226BUSINESSES DEALING WITH GOVERNMENT AGENCIES—Mr Donald Page asked the Deputy Premier, and Minister for Health representing the Attorney General, Minister for Citizenship, Minister for Regulatory Reform, Vice President of the Executive Council—
 - (1) Given the ABS recently released figures showing there was a net loss of businesses of 17,623 in NSW between June 2007 and June 2009, why is the Government merely conducting another review into identifying ways of saving time and cutting costs for businesses dealing with Government agencies in NSW?
 - (2) Will the Government consider taking some action rather than conducting yet another review?
 - (3) What action, other than the recently announced review, is the Government taking to introduce policies to ensure that business dealings with Government agencies are less time consuming and more cost effective?

Answer-

This question is grossly misconceived. The Government is cutting red tape across the board to make it easier for business to interact with the Government. The Government has a \$500 million red tape reduction target, and the Government is well on its way to meeting this target. As at end June 2010 we had implemented reforms contributing \$400 million to the target and in 2009-10 167 red tape reforms were implemented. In fact as at end June 2010 we had implemented reforms cutting \$340 million worth of red tape specifically for business. This includes the introduction of joint regional planning panels, removing duplications in native vegetation requirements, reducing regulatory burden in the banana industry and simplified project developments and grants, to name a few. The business interface review is yet another initiative of this Government to make it easier to do business in NSW and stimulate business growth. The review will enable us to determine the best way forward and will be completed within a few months early next year. Reforms can then be implemented.

- 12227 TRAFFIC OFFENCES COMMITTED BY QUEENSLANDERS—Mr Geoff Provest to ask the Minister for Police, and Minister for Finance representing the Treasurer, Minister for State and Regional Development, Minister for Ports and Waterways, Special Minister of State, Minister for the Illawarra—
- *12228ILLEGAL ACCESS TO CATCHMENT LAND—Mr Michael Richardson asked the Minister for Water, and Minister for Corrective Services—

What were the names of the two corporations fined in the first 12 months of covert camera trial and surveillance operations after they were caught illegally accessing restricted drinking water catchment land?

Answer-

The Sydney Catchment Authority has not issued any penalty infringement notices to corporations for the offence of illegally accessing restricted drinking catchment land.

However two corporations were fined for polluting waterways.

- *12229TREE VANDALISM BANNER—Mr Michael Richardson asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer)—
 - (1) (a) Is the 8-metre "Tree Vandalism" banner at Chowder Bay still in place (Question 8746)?
 - (b) If not, when did it come down?
 - (2) Was spending \$346 a day for the six days that the previous 6-metre banner was in place a good way to shame vandals?
 - (3) Why is the penalty for anyone caught interfering with a banner in a national park (\$3,300) less than the value of the banner itself (\$4,040)?
 - (4) When will Clause 25c in the National Parks and Wildlife Regulation 2009 be updated to reflect this?
 - (5) Is spending \$6,157.80 on banners a cost effective way to deter people from damaging native vegetation in Sydney Harbour National Park?

Answer-

I am advised as follows:

- (1) (a) No.
 - (b) 16 March 2010.
- (2) Yes, the banner was a cost effective method to raise the issue directly with the affected community and bush walkers, and to seek information to assist with the investigation. It compares favourably to other methods such as door knocking or putting a public notice in the local paper, and it clearly communicates that such illegal activity is not acceptable.
- (3) The application of the maximum penalty under the National Parks and Wildlife Regulation 2009 is applied as appropriate. However, the court may also, if satisfied, order an offender to pay for costs and expenses incurred or compensation for loss or damage suffered.
- (4) This would not be necessary.
- (5) Yes, it appears so as no further damage has been reported.
- *12230DUNPHY WILDERNESS FUND PROPERTIES—Mr Michael Richardson asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer)—
 - (1) How many properties owned by the Dunphy Wilderness Fund have not been declared as wilderness areas?
 - (2) Which properties are they?
 - (3) Which 15 of these have no substantial impediments to wilderness status?
 - (4) Why have they not been declared?

Answer-

I am advised as follows:

- (1) The Dunphy Wilderness Fund does not own properties. The Fund was used to purchase properties to add to the Department of Environment, Climate Change and Water's national parks reserve system.
- (2) The Department is working through a systematic process to declare properties where appropriate as wilderness areas.
- (3) Eight of the properties that have not yet been declared as wilderness have no substantial impediments to wilderness declaration. These are additions to Guy Fawkes River National Park and Wadbilliga National Park.
- (4) Wilderness declaration gazettal notices are in preparation for the eight properties that have no substantial impediments to declaration.
- 12231 CROWS NEST CENTRE—Mrs Jillian Skinner to ask the Deputy Premier, and Minister for Health—
- *12232GRIEVANCE ADVISORY SERVICE—Mrs Jillian Skinner asked the Deputy Premier, and Minister for Health—
 - (1) In what month was the state-wide grievance advisory service established?
 - (2) On a month-by-month basis, how many complaints has this service received since its establishment?
 - (3) How many complaints has this service resolved since its establishment?
 - (4) What are the top ten causes of complaints to this service?

Answer-

I am advised:

(1) to (4) The Anti-Bullying Advice Line was established in April 2010. The Advice Line does not manage workplace complaints. It is a free, confidential, state-wide telephone advice line for all NSW Health staff.

Due to privacy and confidentiality reasons, the Advice Line does not issue data on the number or nature of the calls received.

- *12233CLINICAL INITIATIVES NURSE POSITIONS—Mrs Jillian Skinner asked the Deputy Premier, and Minister for Health—
 - (1) How many additional Clinical Initiatives Nurse positions have been created and dedicated to emergency departments in NSW since 1 March 2009?
 - (2) How many of these positions are filled with full time equivalent staff?

Answer-

(1) and (2) On 5 July 2010, I released the second six-monthly report of the Independent Panel, Caring Together: The Health Action Plan for NSW, set up to monitor the implementation of NSW health reform. Details on progress on the recruitment of Clinical Initiatives Nurses are included in this report.

- *12234ACTION AGAINST EMPLOYERS—Mr Richard Amery asked the Minister for Police, and Minister for Finance—
 - (1) When was legislation first introduced to allow trade unions to take action against employers in relation to work safety breaches?
 - (2) Has this provision existed in any other State of Australia?
 - (3) Is there any evidence to suggest that this provision has any adverse effect on companies employing workers in this State?

Answer—

- (1) The 2007 Inquiry into the Review of the NSW Occupational Health and Safety Act 2000 conducted by the Hon Paul Stein AM, QC, found that unions in New South Wales have had the right to prosecute since the 1940s. The availability of union prosecutions applies to any breach of the occupational health and safety legislation, not just in relation to employers.
- (2) Yes, the Australian Capital Territory also has a provision allowing for both union and employer prosecutions of breaches of its Work Safety Act 2008.
- (3) I am not aware of any evidence suggesting that the availability of union prosecutions has any adverse effect on companies employing workers in New South Wales. In his 2007 report, the Hon Paul Stein found that union prosecutions are relatively few in number and are subject to the supervision of the Court. He concluded that "despite its very long history, the right to prosecute does not appear to have been abused by unions", and recommended that no change should be made to the union right to prosecute under the NSW Occupational Health and Safety Act 2000.
- *12235NEW SOUTH WALES INDUSTRIAL LAWS—Mr Richard Amery asked the Minister for Police, and Minister for Finance—
 - (1) Do New South Wales industrial laws have a reverse onus of proof on employers in relation to court action on work place safety breaches?
 - (2) If so, when was this provision first introduced into State law?
 - (3) Is New South Wales the only State that has this provision?

Answer-

- (1) The onus is on the prosecution to establish, on the criminal standard of proof, that there has been a breach.
 - Once this onus is established, section 28 of the Act provides that it is for the defendant to establish that it was not reasonably practicable to comply with the provision, or that the breach occurred due to causes over which the defendant had no control and against the happening of which it was impracticable for the defendant to make provision. The onus of establishing the defence is on the defendant on the civil standard of proof.
- (2) Section 28 was introduced into New South Wales in section 53 of the Occupational Health and Safety Act 1983.

- (3) No. Section 37 of the Queensland Workplace Health and Safety Act 1995 sets out the defences available for contraventions of that Act. It also provides that the onus of proving those defences is on the defendant. The position in New South Wales and Queensland is therefore similar.
- *12237ALCOHOL-RELATED ARRESTS—Mr Greg Aplin asked the Minister for Police, and Minister for Finance—

Answer-

I am advised:

(1) and (2) NSW Health has been implementing a shared services program since 2007 to deliver shared corporate and business services across the public health system. This shared service arrangement is designed to achieve economies of scale, and cost savings which can be re-directed towards the delivery and consistency of standards in frontline healthcare services.

Staff affected by the shared services program are generally offered priority access to positions in the consolidated service or opportunities for redeployment within the Area Health Service. For non-frontline positions, if redeployment opportunities are not available, counselling has been offered along with change management and outplacement workshops.

Consultation with staff and their relevant representative bodies will continue as the Local Health Networks become operational and as the shared services program continues.

*12240COMMONWEALTH FUNDING—NEW REGIONAL HOSPITAL AT BEGA—Mr Andrew Constance asked the Deputy Premier, and Minister for Health—

- (1) What involvement have local clinicians, nurses and Allied Health professionals had in the completion of a submission for Commonwealth funding to build the new regional hospital at Bega?
- (2) Why will the Government not make public this submission for Commonwealth funding by Health Infrastructure?
- (3) When will the land acquisition be complete?

Answer-

I am advised:

- (1) and (2) The NSW Government's bid to the Commonwealth's Health and Hospitals Fund for funding for a new regional hospital at Bega is based on the Project Definition Plan and Scheme Design, which were developed through extensive stakeholder engagement and consultation. Given the short timeframe for submissions to the Fund, the application reflects the high level planning and stakeholder consultation previously undertaken. Submissions will be provided to the Health and Hospitals Fund by Friday 3 December 2010, after which the Commonwealth may choose to disclose some aspects, such as the project and applicant name for each submission received.
- (3) The land acquisition will be completed upon finalisation of the preferred site and negotiations with relevant landowners.
- *12241BUS SERVICE BETWEEN BERMAGUI AND NAROOMA—Mr Andrew Constance asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer) representing the Minister for Transport, Minister for the Central Coast—

Will the Government issue a contract for a private bus operator to run a service between Bermagui and Narooma to link up with the Narooma/Canberra service?

Answer-

I am advised that new arrangements for the delivery of bus services in rural and regional NSW were progressively implemented across NSW during 2008/09.

The Rural and Regional Bus Service Contracts allow for greater flexibility when planning transport services and give the Government tighter control on service standards. Any changes to bus networks will be undertaken in consultation with the community and will need the prior approval of Transport NSW before implementation.

Nowra Coaches, trading as Premier Motor Service, provide bus services along the Princess Highway between Nowra and Eden. This service diverts from the Princess Highway via Bermagui to Narooma on a daily basis.

In addition, LA and LG Symons operate three designated school services between Bermagui and Narooma.

The public is able to access these school bus services, however access is subject to the availability of spare capacity on the buses.

Premier Motor Services also provides long distance bus services between Sydney and Melbourne, via the Princess Highway. Bermagui residents can join this bus service on the Princess Highway.

Matters such as the route taken, destinations, service delivery, fares and timetables are regulated by market forces as this service is not regulated due to its long distance nature.

- *12243FUNDING OF LIFEGUARD—Mr Andrew Constance asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer)—
 - (1) Will National Parks and Wildlife Service fund a lifeguard at Dalmeny on a beach within a national park where thousands of visitors will visit over the summer months?
 - (2) In light of Eurobodalla Shire Council's decision to not fund this position anymore due to the costs, will the State Government support the community?

Answer-

I am advised as follows:

- (1) No.
- (2) Eurobodalla Shire Council is funding a lifeguard at Dalmeny. The Council issued a press release on 2 November 2010 advising that sponsorships had been received from a number of local businesses so that Council could provide lifeguards for all seven patrolled beaches within its council area, including Dalmeny.

- *12244FIRSTNET CERNER—Mr Andrew Constance asked the Deputy Premier, and Minister for Health—
 - (1) Why are doctors expressing concern about FirstNet Cerner?
 - (2) What is being done by GSAHS to address these concerns given the serious nature of the impact on emergency department patients?
 - (3) Which sites have expressed concern about eMR throughout GSAHS?
 - (4) Why are doctors not being listened to?

Answer-

I am advised:

(1) to (4) Electronic Medical Records (eMR) have been rolled out to around 80 per cent of hospital beds across NSW. The majority of feedback from clinicians about the implementation of Cerner FirstNet associated with eMR has been positive.

Training for the implementation of eMR in Greater Southern Area Health Service began in April 2010. This involved more than 1,850 clinicians taking part in 32 training sessions. Of these clinicians, at least 152 Visiting Medical Officers received individual coaching with an average of 4-5 hours each. By the end of October 2010, all major sites had been trained and implementation completed.

Clinicians have also been consulted as part of the implementation process. In November 2010 members of the implementation team conducted face to face meetings with clinicians in Bega, Bateman's Bay and Moruya to provide clinicians with the opportunity to raise any concerns. Future meetings with clinicians will be held if necessary.

The project is also supported 24 hours a day from the eMR Support Team via a statewide service desk. In addition, there is in house support at Wagga Wagga Base Hospital until 31 January 2011 to assist with queries about the new system.

- 12245 NEW JETTY—CLYDE RIVER—Mr Andrew Constance to ask the Minister for Police, and Minister for Finance representing the Treasurer, Minister for State and Regional Development, Minister for Ports and Waterways, Special Minister of State, Minister for the Illawarra—
- *12246DANGEROUS DRIVING BY HEAVY VEHICLE—Mr Peter Debnam asked the Minister for Police, and Minister for Finance—

*12248DRUNK AND DISORDERLY OFFENCE—Mr Peter Debnam asked the Minister for Police, and Minister for Finance—

Given your advice no legal action was taken against the 7,346 people detained in NSW in the 12 months to 31 May 2010 under the section of the Law Enforcement (Powers and Responsibilities) Act 2002 relating to the detention of intoxicated persons (Questions 11651, 11097):

- (1) Of the 7,346 people detained, how many were charged with any other offence when detained?
- (2) Of the 5,959 detained in 2006-07; 7,022 detained in 2007-08; and 7,266 detained in 2008-09, how many were charged with any other offence when detained?

Answer-

The NSW Police Force has advised me that Section 206(2) of the Law Enforcement (Powers and Responsibilities) Act 2002, which deals with the detention of intoxicated persons, states: "A police officer is not to detain a person under this section because of behaviour that constitutes an offence under any law."

Therefore, no individuals detained as intoxicated persons in the nominated periods were charged with any offence.

*12249REBEL MOTORBIKE CLUB—Ms Pru Goward asked the Minister for Police, and Minister for Finance—

Noting that on 7 October 2010, NSW Police congregated at the Marulan Heavy Vehicle Checking Station on the Hume Highway to apprehend members of the Rebel Motorbike Club who were travelling in convoy to Melbourne:

- (1) How many police officers were involved in this operation?
- (2) From which Local Area Commands were these police drawn?
- (3) What is the cost of such an operation?
- (4) How many arrests were made?
- (5) Given that the Rebel Motorbike Club is supposedly "outlawed" and no arrests were made, why not?

Answer—

The NSW Police Force has advised me:

- (1) 150
- (2) There were 24 Commands involved, including Local Area Commands from the South West Metropolitan and Southern Regions as well as a number of specialist Commands including Traffic Services, the Public Order & Riot Squad and the Random Drug Testing Unit.
- (3) This operation was cost neutral, as it was conducted using normal rostered shifts.
- (4) One arrest was made due to a person being identified as wanted for assault. Random breath testing, drug and vehicle/licence compliance checks were also conducted, resulting in 31 Traffic Infringement Notices and four Suspension Notices being issued, as well as one Court Attendance Notice for possession of a knife.
- (5) See (4) above. It should also be noted that while the Rebels are considered an outlaw motorcycle gang, the Rebels Motorcycle Club is not 'outlawed'. No application has been made to declare the Rebels as a criminal organisation under the Crimes (Criminal Organisation Control) Act 2009.

 - (3) When will the South Coast Correctional Centre be completed in its entirety?

- (1) and (2) The Member is referred to the Budget Estimates Papers for Corrective Services NSW.

- *12257PRINCES HIGHWAY PARKING AREAS—Mrs Shelley Hancock asked the Minister for Roads, and Minister for Western Sydney—

Regarding parking areas on the Princes Highway

- (1) (a) Did the Roads and Traffic Authority enter into consultation with the South Coast transport industry concerning the closure of two parking areas at South Nowra and Berry on the Princes Highway?
 - (b) If so, what consultation did the Roads and Traffic Authority enter into?
- (2) How much did the erection of new signage at the parking areas cost?
- (3) Does the Roads and Traffic Authority have any plans to replace the two, now closed, parking areas on the Princes Highway?

Answer-

I am advised:

(1) (a) and (b) The RTA is liaising with Shoalhaven Council to address road safety concerns at both locations.

A road side vendor has been operating at the intersection of the Princes Highway and Victoria Street at Berry. This has resulted in safety issues with vehicles accessing the vendor turning onto the highway. The concern is with the traffic implications rather than the vendor itself.

People often use the shoulder of the Princes Highway between Hillcrest Avenue and Browns Road at South Nowra to sell vehicles on the side of the road. It is also used by the RTA's Heavy Vehicle Inspectors to conduct safety operations.

The RTA installed "No Parking" signs on the Princes Highway at both Berry and South Nowra in response to increasing road safety concerns.

- (2) Approximately \$7,000.
- (3) The RTA replaced the 'No Parking' signs on the shoulder of the Princes Highway at Berry at the intersection of Victoria Street with a 'One Hour' parking restriction from 7 am to 7 pm. This

alteration allows heavy vehicle drivers to use the site at night, but discourages its use by vendors during the day.

The RTA has also recently constructed well equipped heavy vehicle rest facilities about 25 kilometres north of the Berry location. At South Nowra there is still a significant unrestricted area available for trucks to pull over.

As part of the federal government's \$70 million Heavy Vehicle Safety and Productivity Program the RTA has committed to the development of five new heavy vehicle rest areas, at 100 kilometre intervals, along the Princes Highway. The first of these, a heavy vehicle rest area at Jerrawangala (southbound), is scheduled to be open by late 2011.

*12259PROPOSED CANCER CARE CENTRE—Mrs Shelley Hancock asked the Deputy Premier, and Minister for Health—

Regarding the proposed Cancer Care Centre to be located at the Shoalhaven District Memorial Hospital:

- (1) How much has the Government committed to the Cancer Care Centre to be based at Shoalhaven District Memorial Hospital?

(1) The former Katoomba/Leura gasworks has been a complex contaminated site. As the polluter (the Katoomba and Leura Gas Company Ltd) no longer exists, responsibility for clean up falls upon a number of parties, including the former landowner, AGL (now known as Jemena), a current landowner, Elgas, and the owner of the adjacent road, Blue Mountains City Council.

A network of bores for monitoring the quality of the groundwater at land adjacent to the gasworks site was installed in 2003. Approximately 1,500 cubic metres of tar and tar impacted soils has been removed from the site, and effective off-site disposal undertaken.

The Hodgkinson site (part of the former gasworks site) has been capped. A report into the installation of a groundwater diversion trench was prepared in 2008. Blue Mountains City Council engaged a contractor in 2010 to install the diversion trench. These works will be carried out in early 2011.

- (3) (a) and (b) The originally identified tar and tar impacted soils (priority material) were excavated and removed from the site for off site disposal in 2006. Written notification was received from AGL on 10 December 2003 that the deadline would not be met. The NSW Government negotiated with the proponents for remediation of the site, which resulted in most of the originally identified tar and tar impacted soils (priority material) being excavated and removed in 2006. The NSW Environmental Trust has also contributed towards the remediation of the site through the Innocent Owners program.

AGL notified that the 2004 deadline would not be able to be met in December 2003.

A working group, comprising representatives of the Department of Environment, Climate Change and Water, Sydney Catchment Authority, and Council, was convened by the then Minister for the Environment, to develop a plan for further remediation works, which included the installation of a diversion trench.

Following this detailed work, the Hodgkinson site was capped in August 2010, and the Department of Environment, Climate Change and Water will require the Tunks site to be capped following installation of a groundwater interception trench.

However, the proponents (Blue Mountains City Council, AGL and Elgas) advised that the costs of the high priority remediation was approximately \$400,000 greater than expected, resulting in the design and installation of the groundwater trench, and capping of the Tunks and Hodgkinson sites being delayed.
- (2) The Department of Environment, Climate Change and Water is regulating the Elgas site and the priority is for Elgas to undertake the investigation of the site to determine the necessary remediation steps. This is to be followed by remediation plans once the investigation is complete. AGL made a significant contribution to the first stage of remediation. In 2010, Emergency Medicine Training Networks were established to co-ordinate emergency medicine training including the distribution of trainees to NSW facilities. These Networks will identify any future need for emergency trainees.

Health services are funded for clinical service delivery, which includes funding for workforce requirements. There is no separate budget for emergency medicine training positions.

In 2009 in NSW there were 231 Advanced Trainees and 209 Basic or Provisional Trainees registered with the Australasian College for Emergency Medicine. The Junior Medical Officer recruitment process for 2011 is currently underway, with trainees taking up positions in Training Networks in January 2011. The Training Networks will provide data on trainee numbers from 2011.

The councils have partnered in implementing a range of measures to improve water quality, including gross pollutant traps, creek bank remediation and bush regeneration works.
 - In 2007, the NSW Environmental Trust provided a grant of \$1.996 million to the councils towards the rehabilitation of the lagoon. The project is due to finish in April 2011.
 - Pittwater and Warringah Councils are able to apply for further grants. Applications are now open for the 2011-12 Estuary Management Program, for studies and works that improve estuary health.

- (4) The upgrade of Mona Vale Road is currently at a preliminary planning stage and a cost figure is not yet available.
- (5) As noted in (1), the upgrade of Mona Vale Road is included as an infrastructure commitment within the period of the Government's State Infrastructure Strategy (SIS).

 - 2010 data is provisional and incomplete and will not be finalised until the NSW Coroner confirms the cause of each road fatality.
- (2) The RTA has undertaken a number of initiatives to reduce crashes on Mona Vale Road, including:
 - The speed limit was reduced from 70 km/h to 60 km/h on Mona Vale Road between Pentecost Avenue and Telegraph Road at St Ives on 30 May 2007.
 - The intersection of Mona Vale Road and Foley Street was signalised in 2009.
 - The RTA has recently installed an additional signalised pedestrian phase across Pittwater Road at the intersection of Mona Vale Road.
 - The NSW Police Force conducts regular enforcement on Mona Vale Road, which is ongoing with targeted campaigns. The RTA supports these police operations with behavioural messages for motorists using variable message signs on Mona Vale Road and advertising on bus and taxi backs.
 - The RTA has a proposal to install a 200 metre safety barrier on the southern side of Mona Vale Road at the west of Forest Way, Terry Hills in the 2010-11 program.
 - The RTA is assessing options at the signalised intersection of Mona Vale Road and Link Road at St Ives to address right turn crashes. Options will also be discussed with Ku-ring-gai Council as part of the St Ives Town Centre Development.
 - The RTA is investigating the intersection of Mona Vale Road and Douglas Street at St Ives to address right turn crashes.
- *12282ANTI-SOCIAL BEHAVIOUR ON STA BUSES—Mr Rob Stokes asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer) representing the Minister for Transport, Minister for the Central Coast—
 - (1) Is the Minister aware of the increased incidents of violence and anti-social behaviour on STA buses operating throughout the northern beaches?

- (1) and (2) The safety of passengers and bus drivers is of paramount importance to the NSW Government. I am advised that State Transit has invested considerable time, effort and money in making bus travel safer, including on the Northern Beaches, and places the highest priority on safety and security. In this regard I understand that:
 - The fleet of Sydney Buses is continually being upgraded with the latest in driver and passenger safety, security, and vehicle monitoring systems, including the latest in digital CCTV security and vehicle tracking systems. Evidence from CCTV cameras is used by the NSW Police Force in finding and prosecuting offenders.
 - State Transit contracts security guards who patrol buses at particular times and along particular routes. Security guards are additional to State Transit's own Revenue Protection Officers.
 - State Transit undertakes ongoing and regular monitoring and adjustment of security resources to meet the needs of the network, including targetting of high risk parts of the network, including high risk parts of the Northern Beaches network.
 - State Transit works closely with the NSW Police Force on strategies to boost safety and security on the Sydney Buses network, including on the northern beaches, and to improve incident response times.
 - State Transit visits schools to provide information sessions for students with the aim of reducing anti-social behaviour on buses by school children.
 - State Transit liaises regularly with local councils and hotel groups to improve safety and reduce antisocial behaviour.
 - Ongoing training of State Transit drivers is provided in safety/ emergency response procedures, self defence techniques, and in how to deal with aggressive persons.
 - On-the spot fines of \$300 now apply for anyone drinking alcohol on a bus.
 - The Government's tough legislation to protect public transport workers, including bus drivers, makes any attack on them an "aggravating" factor in sentencing.

The total number of signs installed was 11 and all are the property of the RTA. These electronic bus arrival display signs have been deactivated and are no longer in use due to outdated technology. As part of the Government's commitment to provide comprehensive transport information and make using public transport as easy and convenient as possible, from 30 November 2010 bus passengers are able to receive up to the minute "next bus" information with the launch of a new SMS service trial. The trial service, rolled out by Transport NSW in conjunction with the RTA and State Transit, is linked to the Public Transport Information and Priority System bus tracking and traffic signal priority system, which tracks vehicles by satellite. The system will be trialled on a number of Sydney's Metrobus routes. The service will provide details via an SMS of predicted arrival times of buses at a respective bus stop, for up to the next 30 minutes. The SMS service will be trialled for six months, and the service will be assessed to gauge its potential for rollout to other bus services in the future. The trial SMS 'Next Bus' service will be available on the following routes:
 - M10 Kingsford Maroubra Junction;
 - M20 Gore Hill Mascot;
 - M30 Spit Junction Sydenham;
 - M40 Chatswood Bondi Junction;
 - M50 Drummoyne Randwick;
 - M52 Parramatta Circular Quay; and
 - M54 Parramatta Macquarie Park.

- (1) Currently there is no specific cause of action for invasion of privacy in NSW. However there are both criminal and civil law remedies that may assist in some cases of inappropriate CCTV use. These include a range of criminal offences. To successfully prosecute for many of these offences it is necessary to prove an element of sexual gratification or arousal on the part of the accused person. It may also be possible for an affected person to institute civil proceedings for the tort of nuisance on the basis of unreasonable interference with the enjoyment of their property.
- (2) to (4) Both the New South Wales Law Reform Commission and the Australian Law Reform Commission have recommended that a statutory cause of action for the invasion of privacy be created. However, such a reform would be complex and contentious. It must be carefully considered, and stakeholders must be consulted, before any reforms proceed. The Commonwealth Government is currently leading developments towards nationally consistent privacy laws. The New South Wales Government will consider reform in this area as part of the national process.

I am advised as follows:

- (1) A risk assessment has been carried out based on information provided by the Department of Defence and public access restrictions are in place. Visitors are required to keep to designated tracks, digging and campfires are prohibited and no camping is permitted except at two designated locations. In addition, special operating procedures have been endorsed by the local Bushfire Management Committee to minimise risk to fire fighters. These procedures have been developed based on specialist ammunition advice from the Department of Defence.
 - Information about the unexploded ordnance and use restrictions is on the Department of Environment, Climate Change and Water website, topographic maps and large signs at the entrances to the area. Letters advising of the restrictions have been sent to key user groups and are detailed in the widely circulated Budawangs Walking and Camping Strategy.
- (2) The occurrence of unexploded ordnance was known prior to addition of the former Tianjara Military Training Area to Morton National Park in 1970.
- (3) A number of restrictions are placed on bushwalking, fire suppression and park management activities to address risks associated with unexploded ordnance. See answer to question (1).
- (4) In 2009 and 2010, the Department of Environment, Climate Change and Water contracted a private company to clear part of the road system and a designated camping area. In addition to these operations, Army unexploded ordnance disposal staff are requested about once per year to deal with newly detected ordnance. Broad area unexploded ordnance detection would not be technically feasible without large scale vegetation removal over the affected 12,000 hectares of national park.

- (1) The national park associated with the Evans Head Defence Air Weapons Range is Bundjalung National Park. Air weapons training has been undertaken in the Evans Head Defence Air Weapons Range since 1949, which pre-dates the establishment of the park.
 - The Department of Defence and the Royal Australian Air Force are yet to submit a formal proposal for the proposed changes to military training activities at the weapons range.
- (2) The Atlas of NSW Wildlife lists for Bundjalung National Park, incorporating the Evans Head Defence Air Weapons Range, 33 vulnerable bird species, eight endangered bird species, 15 vulnerable mammal species and one endangered mammal species.
- (3) Any proposed change in operation at the Evans Head Defence Air Weapons Range would be accompanied by an environmental impact assessment, which would include an assessment of the impact on wildlife.
- (4) and (5) Until a formal proposal is received from the Department of Defence, it is not possible to determine what endangered species may be affected by the proposed Super Hornet capability training in the Evans Head Defence Air Weapons Range. (a) and (b) There are no plans for further upgrades on the route to alleviate localised flooding from Middle Creek.

The RTA constructed a levee in 2004, which has significantly reduced the frequency of road closures. The RTA also implemented electronic signs to provide motorists with advance warning of closures and improve traffic flow during these periods.

Road closures due to flooding in the past three years have ranged from one to eight incidents per

year with duration of a few hours to half a day.

(1) Enforcement aims to ensure the safety of all road users, the productivity of road transport, the protection of the road asset and the environment.

The loading and transportation of wool bales is covered by the Road Transport (Mass, Loading and Access) Regulation 2005.

- (2) Wool bales are a divisible load and are able to be loaded in a manner that prevents loads extending beyond the 2.5 metre width limit.
- (3) Compliance and enforcement action is ongoing and undertaken by the RTA in accordance with NSW State legislation and regulations which have been in place since 2005.
- (4) (a) and (b) The Road Transport (Mass, Loading and Access) Regulation 2005 covers the loading dimensions of wool bales and is based on the federally agreed cross border approach. Therefore the width limit in each jurisdiction is the same.
- (5) Offences relate to all types of loads, wool bales being only one type of load. The RTA monitors and records information about categories of offences, but not the type of load itself. The RTA does not retain information specifically related to wool bale offences.
- (6) The Load Restraint Guide 2004 provides the restraint required to withstand forces of at least:
 - 80 per cent of its weight in the forward direction;
 - 50 per cent of its weight sideways and rearwards; and
 - an additional 20 per cent of its weight vertically.
- (7) The RTA regularly meets with the NSW Farmers Association and Road Transport Associations to raise and discuss issues of concern.

A wool bales workshop to explore the issue of safe transportation of wool bales is planned for early 2011 and will involve industry stakeholders.
