#### (Paper No. 116)

\*2868 FRESH START RECOVERY PROGRAM—Mr Richard Amery asked the Minister for Health, and Minister for Medical Research—

- (1) What assessments have been made by the NSW Government of the naltrexone program known as the Fresh Start Recovery Program?
- (2) Are there any plans to match the actions of the Western Australian Government to grant funding for this program?

Answer-

I am advised:

(1) and (2) At this time subcutaneous naltrexone implants are not registered for any indication in Australia and their use carries significant medico-legal risks for the medical practitioner. No other country with a comparable regulatory framework has registered a naltrexone implant device.

The Ministry of Health notes the findings of a literature review regarding naltrexone implants, published in 2010 by the National Health and Medical Research Council which concludes that naltrexone implants are an experimental product and as such should only be used in the context of a well conducted randomised controlled trial with sufficient sample size, appropriate duration of treatment and follow up, regular robust monitoring, provision of a comprehensive psychological treatment program, and with comparison to current best practice.

The Australian National Council on Drugs believes that given the very limited Australian data and evidence on the efficacy of sustained release naltrexone preparations, their authorised use through the Therapeutic Goods Administration Special Access Scheme is ethically problematic as it puts patients at risk of unknown harms, for an unknown benefit.

\*2870 CUTBACKS TO EDUCATION FUNDING-Ms Sonia Hornery asked the Minister for Education-

- (1) Will any school in the electorate of Wallsend have resources to special needs students cut as a result of the Minister's recent announcement of cutbacks to the education funding for public and private schools?
- (2) If so, what schools and what positions will be affected?

Answer-

- and (2) NSW public schools will continue to have access to funds for essential resources for special needs programs and support for students with disabilities and additional learning and support needs including public schools in the Wallsend electorate.
- \*2871 FUNDING FOR NON-GOVERNMENT SCHOOLS—Ms Sonia Hornery asked the Minister for Education—
  - (1) How many non-Government schools in the electorate of Wallsend receive State Government funding?
  - (2) What are the names of the schools?
  - (3) How will the funding of these schools be affected by proposed alterations to funding of non-Government schools?
  - (4) (a) Has the Government carried out an assessment on the impact that these changed funding arrangements will have on the fees parents will have to pay for students attending these schools?

(b) If so, what are the findings of this assessment?

Answer—

- (1) 11.
- (2) ASPECT Hunter School, Bishop Tyrrell Anglican College, Holy Cross Primary School, Macquarie College, Margaret Jurd College, Newcastle Waldorf School, Our Lady of Victories Primary School, St Columba's Primary School, St John's Primary School, St Patrick's Primary School, St Pius X High School.
- (3) The Government is working with the non-government sector to ensure that this change can be implemented with the least impact on teaching and learning.
- (4) (a) No. The level of fees set by non-government schools is a matter for the individual schools themselves.

(b) Not applicable.

\*2872 LOSS OF SPECIALIST FUNDING-Ms Sonia Hornery asked the Minister for Education-

In relation to the Hunter Region of schools:

Which 69 public schools in the Hunter will lose specialist funding under State Government changes and the abolition of the Priority Schools Program?

Answer—

Schools are not losing funding as a result of the Government's decision to discontinue the Priority Schools Program. The total amount of funding allocated to Priority Schools in 2012 will be provided to schools in 2013 as Transitional Equity Funding for socio-economic background.

Schools receiving funding in 2013 have been identified based on their relative socio-economic disadvantage. Some schools have moved on to the list for the first time. Other schools have been retired from the list.

In the Hunter/Central Coast region 20 schools currently participating in the Priority Schools Programs will not receive Transitional Equity Funding for socio-economic background in 2013. They are:

Argenton Public School, Broke Public School, Callaghan College Waratah, Cameron Park School, Carrington Public School, Chertsey Primary School, Edgeworth Heights Public School, Fern Bay Public School, Francis Greenway High School, Glendon School, Glenvale School, Gorokan High School, Hunter River High School, Kotara School, Marks Point Public School, Mayfield East Public School, Merewether Public School, Plattsburg Public School, Swansea Public School, Tighes Hill Public School.

#### \*2873 JOINT GROUP TRAINING SCHEME-Ms Sonia Hornery asked the Minister for Education-

- (1) Why has the Minister abolished the Joint Group Training Scheme under the Government's \$1.7 billion education cuts?
- (2) How much does this scheme cost per year?
- (3) (a) Will the Minister prevent any increase in apprentice fees for small businesses?
  - (b) If so, how?
- (4) How will the Minister ensure apprentice uptake in skills shortage areas will not decrease as a result of these cuts?

Answer—

(1) to (4) The Commonwealth Government traditionally funds labour market programs and provides extensive employment incentives for group training organisations.

In NSW there were almost 169,000 apprentices and trainees in training in 2012. Less than 5 per cent of these (just over 7,900) were employed by Group Training Organisations.

Group training was introduced in the early 1980s to manage apprentice training by rotating them through different workplaces to ensure they gained the full range of skills.

The NSW Government will keep investing in training delivery for apprentices and trainees through TAFE NSW and private training organisations. In 2011 we invested more than \$270 million in training.

Fees paid by apprentices to training providers are reviewed annually. From 1 January 2013 apprentice fees will be \$478.

- \*2874 CUTS TO EDUCATION FUNDING—Ms Sonia Hornery asked the Minister for Education—
  - (1) Will class sizes increase as a result of the Government's \$1.7 billion cuts to the State's education system?
  - (2) Will the reduced operating budget result in students having diminished access to essential resources?
  - (3) How will the Minister attract students to undertake TAFE courses after he has increased course fees, increased student concessions fees and cut funding from courses?
  - (4) How will the Minister address the State's skills shortage?
  - Answer—
  - (1) Teachers in government schools will be quarantined from savings measures being implemented to meet budget requirements. For NSW public schools, the state wide class size policy will continue under Local Schools, Local Decisions. The proposed new Staffing Agreement (recommended by the Teachers Federation's Executive for consideration by its Council in late October 2012) also maintains the class size policy.

- (2) Schools will continue to have access to funds for essential resources for students.
- (3) TAFE NSW fees for government subsidised enrolments will continue to be lower than fees that are charged in many other States and Territories. TAFE NSW has the most generous fee exemption and concession policy for disadvantaged students compared to other States and Territories.

Courses in Fine Arts including sculpture, visual arts and ceramics, while valued by the community, are areas of low employment growth. These courses will be offered by TAFE NSW on a fee for service basis from 1 January 2013.

TAFE NSW will continue to focus on areas of high skill needs and provide government subsidies to these skill areas. TAFE NSW will continue to promote the high quality, flexibility and value of its courses and services to individuals and employers.

(4) Through labour market research and industry consultations, we will identify areas which support employment growth and which are vital to the NSW economy. Resources will be strategically allocated to support training in those skills shortage areas.

\*2875 JOINT GROUP TRAINING SCHEME—Ms Sonia Hornery asked the Minister for Education—

- (1) Now that the Government has abolished the Joint Group Training Scheme, and therefore discontinued the \$150 incentive to training groups to administer and manage apprentices at the end of this year, how will training groups afford to provide training to apprentices ?
- (2) (a) Will this mean an increase in fees for apprentices to undertake training?

(b) If so, how much?

Answer-

(1) Funding to registered training organisations for the delivery of training to apprentices and new entrant trainees has not changed and will continue as normal. In 2011 we invested more than \$270 million in training.

The Commonwealth Government traditionally funds labour market programs and provides extensive employment incentives for group training organisations.

In NSW there were almost 169,000 apprentices and trainees in training in 2012. Less than 5 per cent of these (just over 7,900) were employed by Group Training Organisations.

- (2) (a) and (b) The cost of fees will increase from next year and will be kept to a minimum. Fees paid by apprentices to training providers are reviewed annually. From 1 January 2013 apprentice fees will increase from \$436 to \$478.
- \*2876 MANDATORY SEATBELTS ON SCHOOL BUSES—Ms Sonia Hornery asked the Minister for Transport—
  - (1) When will the findings of the advisory committee on bus safety, established 18 months ago, be released?
  - (2) Will the Minister implement mandatory seatbelts on school buses in response to the tragedy that occurred in Singleton on 10 September 2012?
  - (3) Why has industrial traffic been permitted to take over Singleton's road network?

Answer—

(1) to (3) I was deeply saddened to hear about the incident in Singleton on 10 September 2012.

My deepest sympathy goes out to the young boy's family and friends, classmates, and the Singleton community for their terrible loss. My thoughts are also with all others involved in the accident.

Last year the NSW Government formed the School Bus Safety Community Advisory Committee to independently examine the safe transportation of children in rural and regional NSW.

The committee comprises road safety experts, transport operators and parent and school associations. The committee is independently chaired by Carolyn Walsh, a Commissioner of the Australian Transport Safety Bureau.

I understand the independent committee will be in a position to hand its final report to the Government in the near future.

- \*2878 LIVERPOOL COUNCIL ROAD RULES ENFORCEMENT—Mr Paul Lynch asked the Minister for Transport representing the Minister for Roads and Ports—
  - (1) Does Liverpool Council have a discretion in determining whether to enforce the NSW road rules, especially relating to motor vehicles parking on footpaths and nature strips?

(2) Does the council in such instances have discretion to issue a warning, or must it proceed to the issuing of a notice in every case?

Answer—

I am advised:

- (1) Under Schedule 2 of the Road Transport (General) Regulation 2005, local government council enforcement officers are one of 16 classes of authorised officers that may issue penalty notices for breaches of the Road Rules 2008.
- (2) Enforcement of parking rules and any discretion that may be used by local government enforcement officers in the issuing of warnings are procedural matters contained in the enforcement policies, wholly the responsibility of each local council.

\*2879 CUBIT PROGRAM-Mr Paul Lynch asked the Attorney General, and Minister for Justice-

- (1) Is the Attorney General still running and funding the CUBIT Program in NSW Corrective Services?
- (2) How many participants are there currently in the scheme?
- (3) How many participants were there in the scheme as at the following dates?
  - (a) 1 May 2011;
  - (b) 1 September 2011;
  - (c) 1 December 2011;
  - (d) 1 May 2012;
  - (e) 1 September 2012?

Answer—

I am advised:

- (1) The Corrective Services NSW operated CUBIT program is still running and funding for the program has remained constant.
- (2) As at 27 September 2012 there were 42 participants in the program.

\*2880 CLASSIFICATION (PUBLICATIONS FILMS AND COMPUTER GAMES) ENFORCEMENT AMENDMENT ACT 2010—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

Since the introduction of the Classification (Publication Films and Computer Games) Enforcement Amendment Act 2010, how many prosecutions have been instituted and against what categories of defendants?

Answer—

I am advised:

According to the latest statistics available from the NSW Bureau of Crime Statistics and Research, there have been no charges finalised by the NSW criminal courts under any offence provisions introduced by the Classification (Publication Films and Computer Games) Enforcement Amendment Act 2010 between the commencement of that Act and 30 June 2012.

However, there have been 60 finalised charges, 37 of which were proven, under the Principal Act, the Classification (Publication Films and Computer Games) Enforcement Act 1995, between 1 November 2010 and 30 June 2012.

The NSW Bureau of Crime Statistics and Research has provided the following table, which shows the breakdown of these charges by sections of the Principal Act between 1 November 2010 and 30 June 2012.

- \*2881 CORRECTIVE SERVICES NSW—EMPLOYEE CONCERNS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) When were concerns relating to Corrective Services employee Pene Te Hira referred by Corrective Services NSW to ICAC?
  - (2) When did Corrective Services NSW first become aware of those concerns?

Answer-

I am advised:

- Corrective Services NSW (CSNSW) first notified the Independent Commission Against Corruption (ICAC) of concerns regarding Officer Pene Te-Hira on 12 April 2009. CSNSW forwarded further details of concerns regarding Officer Te-Hira to the ICAC on 5 August 2011.
- (2) April 2009.
- \*2882 TELEPHONE ADVICE LINE TRIAL—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) When will the trial of the telephone advice line referred to by the Attorney General in answer to a Question on 12 September commence?
  - (2) How many solicitors will be retained as part of the trial and for what hours?
  - (3) From which police stations will the trial be able to be accessed?
  - (4) How much funding has been provided for this trial?

Answer—

I am advised:

The Government released the Exposure Draft of the Evidence Amendment (Evidence of Silence) Bill 2012 and is currently considering submissions. The form and cost of providing legal advice will be settled prior to the Bill being introduced into Parliament.

- \*2883 GAS BOTTLES AT HOXTON PARK ROAD—Mr Paul Lynch asked the Treasurer, and Minister for Industrial Relations representing the Minister for Finance and Services, and Minister for the Illawarra—
  - (1) Have the gas bottles recently reinstated at the BP Service station in Hoxton Park Road, Liverpool near the intersection with Flowerdale Road been inspected by Workcover?
  - (2) Do the gas bottles comply with relevant regulations, rules and standards?
  - (3) Does their proximity to each other comply with relevant regulations, rules and standards?

Answer—

- (1) Yes, WorkCover's inspected the site on 17 September 2012, when the four replacement cylinders were reinstated. A further inspection was carried out on 27 September 2012.
- (2) WorkCover has been consulting and working with Council and Fire and Rescue NSW to secure compliance with all the relevant regulations, rules and standards.

- (3) WorkCover continues to liaise with the relevant agencies and the owner of the service station to ensure the final location of the gas bottles is compliant with the relevant regulations, rules and standards.
- \*2884 M5 SPEED LIMITS—Mr Paul Lynch asked the Minister for Transport representing the Minister for Roads and Ports—
  - (1) Who made the determination to alter the speed limits on the M5 near the Toll Plaza in the vicinity of Moorebank?
  - (2) What was the basis for this determination?

Answer—

I am advised:

- (1) A speed limit assessment was undertaken and determined by Roads and Maritime Services.
- (2) The changes will improve safety for motorists and motorway staff (toll collectors) around the cash lanes and improve the flow of traffic in the electronic toll collection (cashless) lanes.

I am advised:

Fifteen people are employed in the Ministerial Liaison Units of the Department of Attorney General and Justice as follows:

- 10 in Corrective Services NSW (with one person seconded as the Departmental Liaison Officer)
- 5 in the remainder of the Department (Attorney General's Division and Juvenile Justice).

The functions undertaken in Ministerial Liaison Units across the Department vary due to the structure and operational requirements of each division.

- \*2888 MIDWIFERY COURSE AT UNIVERSITY OF WOLLONGONG—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
  - (1) Is the Minister aware that University of Wollongong has suspended the 2013 Midwifery course?
  - (2) If this has occurred, why was the course terminated?
  - (3) What alternative actions has the Minister taken to train midwives in the Illawarra if this course is no longer available?

Answer-

I am advised:

(1) to (3) The Master of Midwifery Course is accredited until 2013. While this is a matter for the education provider, the course was suspended to consider re-accreditation in accordance with the requirements of the Australian Qualifications Framework. The Illawarra Shoalhaven Local Health District is committed to providing midwifery services which meet the needs of the local community.

## \*2889 AUBURN HOSPITAL GRADUATE NURSING PROGRAM—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

- (1) Is the Minister aware of the new graduate program for nursing at Auburn Hospital for 2013?
- (2) How many positions are available?
- (3) How many applications were received?
- (4) Were interviews for these positions held on 20 August?
- (5) How many positions were filled?
- (6) Are these positions due to start in January 2013, as originally planned?

Answer—

(1) to (6) Local Health Districts and Speciality Health Networks employ newly graduated nurses and midwives each year following a state-wide recruitment process. In doing so Districts and Networks consider their local workforce requirements.

Recruitment action is currently underway and will be finalised shortly to allow newly graduated nurses and midwives to commence their careers in NSW Health in early 2013.

## \*2890 CEDAR COTTAGE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

(1) to (9) Cedar Cottage provides therapeutic counselling and support services for child victims of sexual assault, their siblings, non-offending parents and extended family, and treatment and intervention services for offending parents who have sexually abused their, or their partner's, children. The program has been running for 23 years, accepting its first clients in July 1989.

The program is accepting referrals for potential clients who were charged with relevant intrafamilial child sexual assault offences prior to 1 September 2012, the date the Pre-Trial Diversion of Offenders Regulation 2005 ceased to have effect.

NSW Health is committed to providing services which will assist children, young people and their families to recover from the harm caused by child sexual assault.

#### \*2891 CAFE PLATYPUS—Dr Andrew McDonald asked the Minister for Education—

- (1) Is the Minister aware of the Cafe Platypus at Lurnea High School?
- (2) Will the Minister guarantee that this cafe is safe from any planned funding cuts?

Answer-

- (1) Yes.
- (2) As the Cafe was developed as a student engagement initiative, Priority Schools Program funds were used to partly fund the construction along with contributions from the Intensive English Centre and Support Unit. Tied grants were used to cover the establishment costs.

The Cafe is now self-funded. Students and staff pay for \$2 coffee/tea/hot chocolate. All running costs are covered by this small charge. All improvements and assets within the cafe are also funded by the small cost charged for beverages.

(1) to (3) I am advised that the Land and Housing Corporation is the sole owner of public housing in the suburbs listed. As at 31 August 2012, I am further advised that the Land and Housing Corporation owned a total of 3,334 dwellings in the suburbs of: Hebersham, Blackett, Dharruk, Emerton, Lethbridge Park, Shalvey, Willmot and Bidwill.
