- *9551 AIR CONDITIONED TRAINS ON THE T8 AIRPORT LINE TRAINS—Mr Anoulack Chanthivong asked the Minister for Transport and Infrastructure—
 - (1) What percentage of the T8 Airport Line trains are air-conditioned in the:
 - (a) Morning peak hour;
 - (b) Afternoon peak hour?
 - (2) Are there any instances where four non-air conditioned trains in a row have operated on the T8 Airport Line during the afternoon peak hour?
 - (a) If so, what action is being taken to ensure this does not happen in the future?

Answer-

Under the former Labor government, 59 per cent of all train services on what is now the T8 Airport and South Line were air-conditioned. Today, under the Government, 96 per cent of train services on the T8 Airport and South Line are air-conditioned.

Following the arrival early next year of all the Waratah Series 2 trains, which are being delivered as part of Stage 1 of the More Trains, More Services program, 100 per cent of services on the line will be airconditioned.

New South Wales already invests heavily in improving waste and recycling outcomes. The \$802 million Waste Less, Recycle More initiative is the largest waste and recycling program in Australian history, and it has included unprecedented funding for local government waste programs.

- *9565 RESPONSE TO THE COMMONWEALTH MINISTER FOR CITIES, URBAN INFRASTRUCTURE AND POPULATION—Ms Jo Haylen asked the Minister for Multiculturalism, and Minister for Disability Services—
 - (1) How does the Government respond to claims from the Commonwealth Minister for Cities, Urban Infrastructure and Population that up to 45 per cent of permanent migrants could be required to spend years in regional areas or small states?
 - (2) How does the Government support new migrants settling in regional communities in New South Wales?
 - (3) In response to the Commonwealth Minister's proposal, will the Government provide greater support to newly arrived migrants settling in regional New South Wales?

- *9566 INCREASING ENROLMENTS IN EARLY CHILDHOOD EDUCATION AND PRESCHOOLS—Ms
 Jo Haylen asked the Minister for Education representing the Minister for Early Childhood Education,
 Minister for Aboriginal Affairs, Assistant Minister for Education—

How does the Government work to increase enrolments in early childhood education and preschools for families from non-English speaking backgrounds and multicultural communities?

Answer-

The 2018-19 State Budget extended the Start Strong subsidies to all three year olds in community preschools in New South Wales from January 2019. Start Strong aims to improve affordability of early childhood education and increase the number of children participating for 600 hours in a quality early childhood education program in the year before school. Children with English language needs receive an additional language loading per eligible child per annum regardless of service location. The loading is not dependent on 600 hours enrolments.

The Bicultural Support program has been developed to support community preschools to assist with the inclusion of children from culturally and linguistically diverse, refugee or Aboriginal backgrounds.

- *9567 TARGETS OUTLINED IN THE 2018 CLOSING THE GAP PRIME MINISTER'S REPORT—Ms Jo Haylen asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—
 - (1) How has the Government acted to meet the targets outlined in the 2018 Closing the Gap Prime Minister's Report, particularly in the areas of:
 - (a) Life expectancy;
 - (b) Reading and numeracy;
 - (c) Employment;
 - (d) Attendance in school?

Answer-

(1) (a) This question should be referred to the Minister for Health.

(b) The NSW Department of Education has a comprehensive plan (The Literacy and Numeracy Strategy) to address the learning needs of all New South Wales school students, including Aboriginal students, in relation to Reading and Numeracy. The Literacy and Numeracy Strategy 2017-2020 (https://education.nsw.gov.awliteracy-and-numeracy-strategy) is a four year plan to ensure all students have the essential literacy and numeracy skills they need for success in learning and in life. There is a focus on the early years of school extending into secondary school.

The proportion of New South Wales Aboriginal students at or above national minimum standards for reading and numeracy remained above the national average for Aboriginal students across all year levels tested in NAPLAN 2017. The proportion of New South Wales Aboriginal students at or above national minimum standards has significantly increased from 2008 to 2017 by 4.5 percentage points for Year 3 reading, 5.1 percentage points for Year 5 reading, 7.8 percentage points for Year 5 numeracy and 7.8 percentage points for Year 9 numeracy.

(c) Growing NSW's first economy is the Government's framework to promote the economic prosperity of Aboriginal people and communities in New South Wales. It recognises that improving economic outcomes for Aboriginal people cannot happen in isolation from the broader New South Wales economy.

The current Aboriginal Participation in Construction (APIC) policy requires government construction contracts over \$1 million (and/or contracts specifically for Aboriginal communities), to include a target for expenditure on Aboriginal participation. This target is currently set at 1.5 per cent of project design and construction spend.

The Government released a new Aboriginal Procurement Policy (APP) in May this year, which will leverage government expenditure on general goods and services to support the growth of the Aboriginal business sector and Aboriginal employment. In conjunction with the existing Aboriginal Participation in Construction policy, the APP will support an average of 1000 Aboriginal jobs a year over the next three years.

The Government is also actively seeking to increase the diversity of the NSW Public Service, including setting a target of 2.8 per cent Aboriginal employment across all bands, and increasing Aboriginal representation in the Senior Executive Service.

(d) A range of initiatives are in place that support Aboriginal students in the areas of attendance, reading and numeracy, and Year 12 attainment. Addressing the targets is being assisted by the implementation of initiatives to achieve the New South Wales State Government priority to increase the proportion of Aboriginal students in the top two NAPLAN bands by 30 per cent by 2019.

From the start of the 2018 school year, all public schools in New South Wales have access to a centralised system to capture student attendance. This centralised system allows for enhanced reporting capabilities and analysis of trends and patterns of attendance by school and across multiple schools. The centralised storage of attendance information provides the opportunity to further develop metrics to inform and support planning by schools and across the department to better understand and address school attendance for Aboriginal students in New South Wales public schools.

Under the Resource Allocation Model, schools are provided with an equity loading to address the additional learning needs of Aboriginal students. In 2018, the loading is being allocated to New South Wales schools to support the learning needs of approximately 60,000 Aboriginal students across 2,022 New South Wales public schools.

- *9568 SUCKLING PIG MARKET—Mr Philip Donato asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) Is the Minister aware that the suckling pig industry (pigs less than 25 kilograms in weight and approximately 6-8 weeks in age) has been significantly and adversely affected by the introduction of compulsory ear-tagging each pig, due to the buyers not wanting to purchase carcasses with damaged ears (from tag removal)?
 - (2) Is the Minister aware that the sales of suckling pigs at the Forbes Sale Yards has drastically reduced over the last six months, from several hundred per week to approximately 20 to 30 per week, since the introduction of the ear-tagging regulation?
 - (3) Has consideration to the introduction of some other form of marking/branding that does not involve ear-tagging been given?
 - (4) How many suckling pigs are being sold in New South Wales which originated from interstate, that are not ear-tagged?
 - (5) How many suckling pigs were sold in New South Wales saleyards in each year from 2016 to 2018

(to 17 October 2018)?

(6) What consultation was conducted with the pig farming industry before the introduction of compulsory ear-tagging pre market sale?

Answer—

- (1) The Minister is aware that drought, including lack of water and high feed prices, has played a major part in the downturn in production of pigs generally in New South Wales. This includes the suckling pig market. NSW Department of Primary Industries (NSW DPI) has been working with stakeholders, including those who buy suckling pigs, so they understand why pigs less than 25 kilograms live weight must have an ear tag.
- (2) Available data from Forbes pig saleyard indicates that the number of suckling pigs sold during the week 5 May 2018 was 254 compared with 116 on 27 August 2018 and, 126 on 19 October 2018. Advice received suggests that the drought has affected suckling pig numbers.

Advice from the Camden pig saleyard is that during 2018 about 100 suckling pigs have been sold each week and that the requirement to tag suckling pigs has not affected sale numbers.

(3) Small pigs, less than 25 kilograms live weight, are identified with a small National Livestock Identification System (NLIS) ear tag. The use of ear tags on small pigs was introduced on the advice of Australian Pork Limited, the major peak industry body for pig producers. The requirement for small pigs to be identified emanated from SAFEMEAT the national partnership between the livestock industry and Commonwealth, state and territory governments.

Identification of small pigs with ear tags has minimal animal welfare implications. A swine slaptattoo brand could break bones if applied to a small pig. Tagging is also quicker and easier to do, compared with a small ear tattoo. Identification with an NLIS ear tag is consistent with sheep and goats and brings small pigs into line with other species which are part of the NLIS.

- (4) None. NSW DPI advises all suckling pigs sold at New South Wales saleyards are identified with an NLIS ear tag.
- (5) Data is not available on the numbers of suckling pigs sold for 2016 and 2017. Total number of suckling pigs sold at Forbes this year from 4 May 2018 to 19 October is 1,612. Camden pig saleyard advises about 100 suckling pigs are sold at each of their weekly sales.
- (6) Australian Pork Limited is the peak industry body for the pork industry and helped to develop the NLIS Pig Standards upon which the NSW Biosecurity (NLIS) Regulation 2017 is based. Agriculture Ministers from each jurisdiction approved the NLIS Pigs Standards in July 2017 which included that small pigs were to be identified by an NLIS ear tag so that there is consistency with other species (cattle, sheep and goats). Large pigs over 25 kilograms live weight have been identified with a swine slap/tattoo brand for many years. Note that pigs in Victoria have been identified using ear tags since 2003.

It is critical pigs and other livestock can be traced using the NLIS database in the event of a serious disease outbreak such as Foot and Mouth Disease. Not having small pigs identified poses a serious risk to the pig and other livestock industries in Australia.

- *9569 DROUGHT ASSISTANCE PACKAGES—Mr Philip Donato asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) Is there specific drought assistance packages designed to support small intensive farmers who occupy farming enterprises of less than 100 acre properties with financial support under drought assistance?
 - (2) Is there any funding or support for farmers who may not have an Australian Business Number or Property Identification Code (PIC)?

Answer-

(1) Farmers of small intensive properties of less than 100 acres are not excluded from accessing drought support and are welcome to apply. Like all other landholders, they will need to meet eligibility criteria including requirements that they earn more than 50 per cent of their gross income from the primary production enterprise under normal seasonal conditions and that they cannot have more than \$5,000,000 in gross off-farm assets.

Small intensive farmers are also welcome to apply for the Emergency Drought Relief Transport Subsidy, which provides a subsidy of up to 50 per cent of total freight costs to eligible primary producers to a maximum of \$5 per kilometre to a maximum eligible distance of 1,500 kilometres. Applicants will need

to meet usual eligibility requirements. The only exclusion for the Drought Transport Subsidies is that commercial feedlots are not eligible for a subsidy.

- (2) Rural Assistance Authority assistance requires that applicants have an Australian Business Number (ABN). The Rural Assistance Authority does not take Property Identification Codes into account.
- *9570 RESPONSE TO SOCIAL HOUSING MAINTENANCE—Ms Sonia Hornery asked the Minister for Family and Community Services, Minister for Social Housing, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) When a social housing tenant reports a maintenance issue to Housing NSW and the Land and Housing Corporation (LAHC), how long on average does it take for the maintenance issue to be fixed?
 - (2) What is the current property maintenance backlog for social housing in the Wallsend electorate?

I am further advised that the number of properties undergoing maintenance in any location varies. FACS routinely carries out maintenance through responsive maintenance requests and planned maintenance programs to keep its properties in good condition and to ensure consistent maintenance standards across the State.

- *9571 SEX OFFENDERS IN THE NEWCASTLE CITY POLICE DISTRICT—Ms Sonia Hornery asked the Minister for Police, and Minister for Emergency Services—
 - (1) How many registered sex offenders are in the Newcastle City Police District?
 - (a) How many officers are assigned to monitoring them?

*9573 ALLEVIATING THE COST OF LIVING FOR LOW INCOMER EARNERS—Ms Sonia Hornery asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

Considering the increasing cost of living pressures on Wallsend residents, especially electricity prices, what steps is the Government taking to alleviate these costs for low-income earners?

Answer-

I am advised:

The Government is committed to reducing the costs of living pressures for low income households and provides a wide range of assistance to vulnerable customers for energy costs. We have introduced a range of programs and tools to assist customers with energy affordability, increase their energy efficiency, and to assist customers find the best offer to suit their needs.

The Government launched the Cost of Living program to make it easier for people to access more than 40 rebates and savings which NSW residents could be eligible for from more than 12 New South Wales government agencies. Customers can go to www.service.nsw.gov.au/campaign/cost-living which has bundled together all of the rebates and savings in one place.

It is also providing a free one-hour face-to-face or telephone appointment for those who may need help with the application process.

The Cost of Living campaign is underway and is raising awareness of rebates across New South Wales by TV, radio, Service NSW emails, and social media platforms.

In 2017-18 the Government also launched an energy affordability campaign that:

- communicated information about energy rebates to consumers through multiple platforms;
- · removed paper bill fees, and fees for paying an energy bill at Australia Post. We also removed exit

fees for most energy contracts, making it easier for customers to switch to a better deal; and

• increased all energy rebates by 20 per cent, including for low-income households and families.

To assist with energy efficiency:

- This Government offers lighting upgrades to help eligible households replace old lights (such as halogen downlights) with new LED bulbs.
- The Home Energy Action Program delivers energy efficiency improvements to low-income households across the state by helping them access energy-saving appliances and home improvements.
- These upgrades can help renters save up to \$400 a year on their energy bills and since 1 July 2016, more than 465 households in the Wallsend electorate have received new energy efficient appliances.

To improve access to information on energy programs this Government has redesigned its Energy NSW website to make it easier for consumers to find information and get the help they need.

We are also developing a new way for customers to find a better deal - Energy Switch. This is a free service, which helps customers find a better energy deal, as well as initiating the request to switch retailers. The state-wide roll out of the service is expected later this year.

*9575 COMPLAINTS ABOUT BILLING ISSUES TO THE ENERGY & WATER OMBUDSMAN—Ms Sonia Hornery asked the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—

What steps is the Government taking to address the increasing number of complaints about billing issues being made to the Energy & Water Ombudsman?

Answer—

I am advised:

The cost of bill are the main issue raised in these complaints.

The Government is implementing a range of measures to assist households and businesses reduce their energy costs. This includes:
