- \*11935LEGAL REFERRAL SERVICE FOR CANCER PATIENTS—Mr Richard Amery asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer)—
  - (1) Has the Cancer Council established a Legal Referral Service to assist cancer patients with various legal matters arising from a cancer diagnosis?
  - (2) If so, does this service advise patients of ways of managing the high cost involved in treatment and related expenses?
  - (3) What is the Minister's response to Australian research that shows patients can be hit with up to \$47,000 in expenses, lost wages and travel expenses?
  - (4) Has there been a suggestion that medicine pools be established in palliative care facilities to assist people with the provision of medicines during treatment?
  - (5) What is the Minister's response to the establishment of such medicine pools to use unused medicines to offset the cost of medication to cancer patients?

#### Answer-

(1) The Cancer Council NSW has established a Legal Referral Service to assist cancer patients with various legal matters arising from a cancer diagnosis. I participated in the launch of the Service at Parliament House.

I am advised as follows:

- (2) The Cancer Council Legal Referral Service works with lawyers across Sydney to offer free legal services, including:
  - (a) wills, powers of attorney and enduring guardianship:
  - (b) early access to superannuation and disability benefits;
  - (c) mortgages, credit and debt;
  - (d) welfare rights and Centrelink;
  - (e) tenancy;
  - (f) employment; and
  - (g) discrimination.
- (3) In 2007, The Cancer Council NSW published a report it commissioned from Access Economics into the costs of cancer. As with any other illness, there are a range of costs associated with cancer. In NSW, there are several support services available to patients, to help to ameliorate costs to patients and families, including:
  - (a) The Cancer Institute of NSW is contributing \$500,000 to the Isolated Patients Travel Allowance and Accommodation Scheme. The NSW Health Department also contributes to the scheme.
  - (b) Can Assist offers patients living in country NSW help with a range of costs, including travel, accommodation for treatment, wigs, prosthetics, pharmaceutical bills, and in some cases, general financial assistance.
  - (c) The Cancer Council NSW provides small grants to assist patients with the payment of urgent bills

Provision of income support for people who are unable to work due to illness falls within the jurisdiction of the Commonwealth Government, administered by the Department of Human Services through Centrelink.

- (4) and (5) Medicine pooling is a complex issue which requires further advice from the Commonwealth Department of Health and Ageing and NSW Health. While these matters fall outside my portfolio responsibilities, I undertake to obtain a detailed response for the Member from the Minister for Health.
- \*11937SALE OF SURPLUS LAND IN ALBURY ELECTORATE—Mr Greg Aplin asked the Deputy Premier, and Minister for Health—

Further to the response to Question 11451 on the sale of NSW Health land in Albury:

- (1) How many land allotments at NSW Health's Diggers Road site in Lavington have been sold?
- (2) What price was achieved for the land sold?
- (3) How many allotments remain unsold?
- (4) When will those remaining allotments be sold?
- (5) Of the allotments already sold, can you advise where the funds received from the sale were expended

locally in Albury on health service improvements?

Answer-

I am advised that:

(1) to (5) Proceeds will not be realised until settlement. Settlement will not occur until registration of Title, which is dependent upon registration of the plan of subdivision. When received, the funds will be retained by Greater Southern Area Health Service for capital improvements.

In line with NSW Health protocols all potential revenue in the first instance is expended on assets from where the funds are generated.

### \*11938SCHOOL SECURITY FENCING—Mr Stuart Ayres asked the Minister for Education and Training—

- (1) Is Samuel Terry Public School scheduled to receive security fencing in the 2010-11 program?
- (2) On what criteria is it decided which schools will receive security fences in the 2010-11 program?
- (3) How many unauthorised entries and incidents that resulted to damage in school property have occurred at each of the following schools in the last 3 years:
  - (a) Blaxland High School:
  - (b) Emu Heights Public School;
  - (c) Emu Plains Public School:
  - (d) Glenbrook Public School;
  - (e) Kingswood High School;

  - (f) Kingswood Public School;
  - (g) Lapstone Public School;
  - (h) Leonay Public School;
  - (i) Nepean High School;
  - (i) Penrith Lakes Environmental Education Centre?

#### Answer-

(1) to (3) The NSW Government is committed to maximising the level of security that is provided to all Government schools throughout the State. This is achieved through a range of strategies that have been proven to minimise the levels of risk at our schools. The provision of security fencing is one of those strategies.

Schools are provided with security fences on the basis of security risk assessments undertaken by the Department's Safety and Security Directorate. This process ensures that the schools in greatest need are the first to receive security fencing.

Samuel Terry Public School has not been recommended for inclusion in the 2010-11 security fencing program as the risk assessment process has not identified the school to be a greater priority than other schools throughout the State.

During the three year period from 22/10/07 to 21/10/10 the following incidents were reported to the Department of Education and Training:

- (a) Blaxland High School 83 incidents
- (b) Emu Heights Public School 36 incidents
- (c) Emu Plains Public School 32 incidents
- (d) Glenbrook Public School 14 incidents
- (e) Kingswood High School 85 incidents
- (f) Kingswood Public School 19 incidents
- (g) Lapstone Public School 12 incidents
- (h) Leonay Public School 35 incidents
- (i) Nepean High School 54 incidents
- (i) Penrith Lakes Environmental Education Centre 0 incidents

The extent of damage involved in these incidents varies greatly and this tally includes incidents where damage was caused by a student of the school during school hours, meaning there was no unauthorised

Blaxland High School and Kingswood High School, the schools from this selection that incurred the greatest number of incidents, have both been included in the 2010-11 security fencing program.

- \*11939NEPEAN HIGH SCHOOL—Mr Stuart Avres asked the Minister for Education and Training—
  - (1) Will Nepean High School receive extra specialist staff to assist them in their role as a Creative and

Performing Arts High School?

- (2) What facilities are being planned for the Creative and Performing Arts High School and when will construction commence?
- (3) What Creative and Performing Arts resources will be allocated to Nepean High School to support the increased number of Creative and Performing Arts students in 2011?

#### Answer\_

- (1) The allocation of teaching staff in NSW public schools is determined by formulae based on student enrolments to ensure that resources are distributed equitably across the State. Nepean High School will be staffed in accordance with the staffing formulae. When a teacher vacancy occurs, the principal provides Staffing Services with the staffing requirements for the position on the basis of the needs of the school.
  - In addition to the teacher staffing entitlements allocated by Staffing Services, each year, Regional Directors are provided with an allocation of flexible teacher and school administrative and support staffing to distribute to schools with unique and emergent circumstances. Nepean High School can apply to the Regional Director for additional support from these resources.
- (2) Funds have been allocated for planning and consultation on a project to construct a Performing Arts Centre at the school.
- (3) The school has established an audition process to select highly talented students for the creative and performing arts stream and offers dance and drama classes.
- \*11943EXPANSION OF HIGH SCHOOLING IN WEST PORT STEPHENS—Mr Craig Baumann asked the Minister for Education and Training—
  - (1) When will the Minister respond to the working party report into the expansion of high schooling in west Port Stephens?
  - (2) When will the Minister make public the working party report into the expansion of high schooling in west Port Stephens?
  - (3) When will the Minister respond to the 1300 local residents who signed a petition for a middle or high school in Medowie?

#### Answer—

- (1) to (3) The report has been received and is under consideration.
- \*11944NEWCASTLE INNER CITY BYPASS—SANDGATE TO SHORTLAND—Mr Craig Baumann asked the Minister for Roads, and Minister for Western Sydney—
  - (1) Has the Government conducted any studies on the impact the Newcastle Inner City Bypass Sandgate to Shortland could have on traffic congestion at Sandgate?
  - (2) If so, what are the outcomes of these studies?
  - (3) What is the Government doing to minimise traffic congestion at this intersection when the bypass is complete?

### Answer-

### I am advised:

(1) and (2) Yes. As part of the project development the RTA undertook detailed traffic modelling, including intersection analysis.

Traffic flow on the Pacific Highway at Sandgate will be improved between Industrial Drive and Old Maitland Road. It is predicted that traffic delays on the Pacific Highway will be substantially reduced with the turning traffic spread over two intersections, that is, the existing intersection at Wallsend Road and the new bypass intersection. It is expected that the majority of right turn traffic will use the new intersection with the bypass.

- (3) The operation of the intersection at Wallsend Road and the Pacific Highway will be significantly improved when the Shortland to Sandgate project is opened. This is because traffic currently turning right into and left out of Wallsend Road will use the new intersection with the bypass.
- \*11945STUDENTS MISBEHAVING ON SCHOOLS BUSES—Mr Craig Baumann asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer) representing the Minister for Transport, Minister for the Central Coast—

What provisions, if any, are in place to assist bus drivers in controlling students misbehaving on schools buses?

Answer-

I am advised that information regarding the School Student Transport Scheme Guidelines for Managing School Student Behaviour on Buses and an associated Code of Conduct is available on Transport NSW's website at: http://www.transport.nsw.gov.au/ssts/school-bus-guide.html

- \*11946HEAVY VEHICLE SPEEDING—Mr Steve Cansdell asked the Minister for Police, and Minister for Finance—
  - (1) What strategies are in place to police speeding by interstate heavy vehicles on the Pacific Highway at Ulmarra between 8 pm and 6 am?
  - (2) Does NSW Police utilise unmarked police vehicles to deter tailgating and speeding by overnight interstate heavy vehicles on the Pacific Highway between 8 pm and 6 am?
  - (3) Will the Minster support the placement of a speed camera on the northern approaches of Ulmarra?

Answer-

The NSW Police Force has advised me:

- (1) The Pacific Highway at Ulmurra is regularly patrolled by Highway Patrol police in various shifts extending from 6am up to 4am. General Duties officers also patrol this section of road regularly from 5am. This location has been the site of numerous speed enforcement operations over the past two years.
- (2) Yes. Deterrence is principally addressed via high visibility patrolling by marked police vehicles, however this is supplemented by unmarked vehicles.
- (3) The placement of speed cameras is a Roads and Traffic Authority responsibility and this question should therefore be addressed to the Minister for Roads.
- \*11947NEW REGIONAL HOSPITAL—Mr Andrew Constance asked the Deputy Premier, and Minister for Health—
  - (1) Will the State Government fund the construction of the new regional hospital at Bega?
  - (2) Has the campaign run by the community at Merimbula, to save services at Pambula Hospital, stopped the Government building the new hospital?
  - (3) Has the State Government presented a submission to the Commonwealth for funding to build the new regional hospital?

Answer-

I am advised:

- (1) The redevelopment of the Bega Valley Health Service is reflected in the Department's forward capital works planning. Commencement of projects can only be undertaken within the capacity of the available NSW Health Capital Works Budget.
- (2) Planning for the redevelopment of Bega Hospital is based on the endorsed 2007 Clinical Services Plan, which will inform all components of a future redevelopment of Bega Hospital.
- (3) The redevelopment of Bega Hospital, as scoped in the endorsed 2007 Clinical Services Plan for Bega Valley Health Service, was submitted in the first round of Health and Hospitals Funding in early 2009.
- \*11950COMMUNITY CYCLEWAY/FOOTPATH—Mr Andrew Constance asked the Minister for the State Plan, and Minister for Community Services representing the Minister for Planning, Minister for Infrastructure, Minister for Lands—

What funding programs exist for the Government to acquire property along the Clyde River at Surfside, Batemans Bay for the purposes of connecting a community cycleway/footpath, in light of the land being undeveloped?

Answer-

NSW Coastal Lands Protection Scheme.

\*11951WILLIAM STREET TRAFFIC MANAGEMENT—Mr Peter Debnam asked the Minister for Roads, and Minister for Western Sydney—

In relation to William Street, East Sydney traffic management and given your advice a decision to increase the traffic capacity of William Street would not be based on traffic demand alone and consideration would be given to many factors including current traffic demand and predicted growth (Question 11404):

In RTA planning, what is the predicted growth of traffic demand on the William Street, East Sydney road network?

Answer-

I am advised:

The average modelled growth of traffic on William Street is a total of two per cent over the period until 2021. This growth is low due to assumed major bus network upgrades. Over the following decade, traffic volumes are projected to rise by a further 12 per cent. Over the same timeframe land use forecasts for the William Street catchment (Sydney East, Waverley and Woollahra) are indicating a 0.5 per cent per annum growth in population and employment. These growth estimates assume no major intervention to current traffic patterns.

- \*11954UNFLUED GAS HEATERS IN SCHOOLS—Mr Victor Dominello asked the Minister for Education and Training—
  - (1) Under the Department's Asset Maintenance Contract, how often must maintenance work on unflued gas heaters be carried out?
  - (2) When did Spotless conduct the latest maintenance work on unflued gas heaters in the Ryde electorate?
  - (3) On how many occasions has maintenance work on unflued gas heaters been carried out in schools in the Ryde electorate in:
    - (a) 2006;
    - (b) 2007;
    - (c) 2008;
    - (d) 2009;
    - (e) 2010?

#### Answer—

- (1) The Asset Maintenance Contract requires the servicing of gas heaters to be carried out in autumn of each year as part of a preventative maintenance program. Every in-service heater is made fully functional as part of this program. If a school identifies a heater as malfunctioning or inoperative, the maintenance contractor can be called out to carry out 'reactive maintenance' on the heater, at no cost to the school.
- (2) The 2010 annual inspection/servicing of heaters was carried out between 3 March 2010 and 31 May 2010.
- (3) The current Asset Maintenance Contract has been in place from 2005 to present, as such the preventative maintenance program and reactive maintenance as outlined in question one (1) has been carried out each year from 2006 to 2010.

- \*11959CENTRAL COAST PRIORITY CALLS—Mr Chris Hartcher asked the Minister for Police, and Minister for Finance—

In reference to the (i) Brisbane Water Local Area Command and (ii) Tuggerah Lakes Local Area Command:

What percentage of urgent (Priority 1 and Priority 2) calls were attended by police within 10 minutes for the period of:

- (a) 2007;
- (b) 2008;
- (c) 2009?

### Answer-

The NSW Police Force has advised me that the significant distances involved in policing the Central Coast have an impact on response times. Nonetheless, both nominated Local Area Commands have indicated that, regardless of the distances involved, police have responded within ten minutes to approximately half of all urgent calls received from 2007 to 2009.

- \*11964KAREELA COMMUNITY PRECINCT WATER FLOWS—Ms Katrina Hodgkinson asked the Minister for Water, and Minister for Corrective Services—
  - (1) Why is Sydney Water promoting a program to reduce water pressure to the Kareela Peninsula precinct, but has consistently refused to answer questions by the Kareela Community Precinct Association about the degree to which water flow has, or will be, reduced?
  - (2) Is the water flow into the Kareela Precinct in the process of being reduced by 80%?
  - (3) If not, what will be the final percentage water flow reduction?
  - (4) Will you confirm that this degree of water flow reduction will result in additional costs being incurred by residents of the Kareela Precinct to:
    - (a) remove water saving devices currently in use:
    - (b) remove pressure limiting devices already installed;
    - (c) replace instantaneous systems;
    - (d) replace lawn and garden irrigation systems;
    - (e) replace hot water systems, valves and pipes;
    - (f) rectify toilets that are not flushing correctly;
    - (g) installing, operating and maintaining water pumps for houses taller than two storeys?
  - (5) Will you also confirm that this degree of water flow reduction will result in:
    - (a) the exacerbation of problems for properties with existing low water pressure below 400kpa;
    - (b) insufficient flow to the Kareela Peninsula during peak demand periods;

- (c) increased time required filling washing machines and toilet cisterns?
- (6) Will you confirm that the need to introduce a WPMP on the Kareela Peninsula is due to a failure to adequately maintain water infrastructure in this area?
- (7) Given that Sydney Water has refused to provide a written response to the community precinct association's request for information about the effect of a power or communications failure, will you direct the corporation to provide this information?
- (8) Why will Sydney Water not provide a guarantee to the community precinct association that as a result of the WPMP there will be no further problem with the water supply to the peninsula in the future?

#### Answer-

- (1) to (8) Sydney Water's Water Pressure Management Program is an important part of the NSW Government's Metropolitan Water Plan. The program has the following benefits:
  - meet water conservation targets by reducing demand and leaks;
  - improve reliability and continuity of supply as a result of reduced main breaks;
  - reduce pressure fluctuations to achieve more consistent pressure across the water supply system;
     and
  - extend the life of Sydney Water's water mains and assets.

It is the water pressure that is being reduced in the Kareela Precinct, not the water flow. The average water pressure in Kareela is currently 75 metres head and at the completion of the program's implementation, the average water pressure in the area will be 45 metres head. This is substantially greater than the required minimum pressure of 15 metres head as contained in Sydney Water's Operating Licence.

Generally, it is not expected that any additional costs will be incurred by residents in the Kareela Precinct as a result of Sydney Water's program.

Sydney Water has been consulting with the Kareela Community Precinct Association since February 2010. This has included two site meetings, numerous emails and a three hour community meeting on 16 March 2010 to discuss the concerns of the Association. Both Sydney Water and I have responded in writing to the Association's concerns.

- \*11966HUNTHAWANG PROPERTY—Ms Katrina Hodgkinson asked the Minister for Climate Change and the Environment, and Minister Assisting the Minister for Health (Cancer)—
  - (1) Has the Hunthawang property in the Hillston district been purchased by, or is it in the process of being purchased by, the National Parks and Wildlife Service?
  - (2) If so, how many staff employed on the property have been told to look for alternative employment?
  - (3) Has the water entitlement owned by this property also been purchased by NPWS or any other State Government department or agency?
  - (4) If so, how much water is attached to this entitlement and to what use will this water be put?

- \*11967WATER SHARING PLANS—Ms Katrina Hodgkinson asked the Minister for Water, and Minister for Corrective Services—
  - (1) Which Water Sharing Plans (WSP) in the Murray Darling Basin are currently suspended?
  - (2) On what date was each of these WSP suspended?
  - (3) For each of these suspended WSP, what are the specific requirements that need to be met before they are reintroduced?
  - (4) Has a confirmed date for the reintroduction of any of these suspended WSPs been set?
  - (5) On what date does each of the WSP within the Murray Darling Basin expire?

#### Answer-

- (1) Four water sharing plans in the NSW Murray Darling Basin are currently suspended:
  - Macquarie/Cudgegong Regulated Rivers;

- · Lachlan Regulated River;
- · NSW Murray Lower Darling Regulated River; and
- Murrumbidgee Regulated River.
- (2) The WSPs for the Lachlan, NSW Murray-Lower Darling and Murrumbidgee were suspended on 10 November 2006, with the Macquarie/Cudgegong suspended on 22 December 2006.
- (3) and (4) The reintroduction of suspended WSPs is generally related to a number of considerations, including provision for the current and following year's high security allocations to be delivered, and in the case of the Murrumbidgee and Murray areas, the reliability of the Snowy Mountains Hydro-electric Scheme.
- (5) The WSPs in place within the NSW Murray-Darling Basin currently expire around 10 years after commencement. However plans that commenced after 25 January 2007 will be deemed interim plans under the Commonwealth Water Act 2007 and will require replacement from 31 December 2014 or five years from commencement, whichever is the later. The earliest date NSW Murray-Darling Basin WSPs will expire will be 30 June 2014, including the four plans referred to in 1 above.

#### Answer-

Leave management within a Local Area Command is a matter for the Commander. Commanders routinely explore a range of options to provide the most effective policing response. - \*11973HUNTER WATER LEVY—Ms Sonia Hornery asked the Minister for Water, and Minister for Corrective Services-
  - (1) What consultation occurred with the community about the impost of a Hunter Water Levy for the building of the Tillegra Dam to Hunter citizens' water bills?
  - (2) Per annum, how much is the levy per household?

The setting of the price for water sold to Hunter Water customers is a matter for the Independent Pricing and Regulatory Tribunal (IPART).

IPART undertakes a consultation process with stakeholders and the public before determining its final prices.

I am advised the Tribunal released a draft report and determination in April 2009, and received 69 submissions in response. This followed the release of an issues paper in July 2008, which received 75 submissions, and the holding of a public hearing in Newcastle in December 2008.

The determination and final report for Hunter Water was released in July 2009 and is available on the IPART website. The determination and new prices came into effect on 17 July 2009.

There is no levy imposed for Tillegra Dam.

IPART has developed an approach to cover the cost of Tillegra Dam that recognises the significant benefit of the dam to future generations. This is a fair and equitable approach which means Tillegra Dam will add up to \$32 per year, or 60 cents per week, to a typical existing customer's bill by 2012/13.

I note IPART acknowledged in its determination that "Tillegra Dam is not the major driver of Hunter Water's costs and therefore price increases".

The Government is committed to a \$1 billion investment in water and sewerage infrastructure in the Hunter, and Tillegra is just one component of this investment.

### I am advised:

Although the provision of aggregated EEO data by agencies is compulsory, individuals are not obliged to provide this information. The Department of Premier and Cabinet therefore uses a statistical model to weight indigenous EEO results to account for this discrepancy. The following data are derived from this model.

The percentage of Indigenous employees across the whole public sector, each year for the past five years was: 2.5% in 2009-10; 2.4% in 2008-09; 2.2% in 2007-08; 2.1% in 2006-07; and 1.9% in 2005-06.

The total number of Indigenous women employed (new starters) each year for the past five years was: 746 in 2009-10, 677 in 2008-09; 1,015 in 2007-08; 1,063 in 2006-07; and 831 in 2005-06.

The specific rate of Indigenous employment per Government agency is listed below.

While Indigenous employees represent a significant proportion of the workforce in Aboriginal Affairs NSW and Aboriginal Housing Office they are not the largest employers of Aboriginal people in the NSW public sector.

\*11975NSW ABORIGINAL MENTAL HEALTH AND WELL BEING POLICY 2006-2010—Mr Kevin Humphries asked the Minister for Local Government, Minister for Juvenile Justice, Minister Assisting the Minister for Planning, and Minister Assisting the Minister for Health (Mental Health)—

Given a specific initiative of the NSW Aboriginal Mental Health and Well Being Policy 2006-2010 is to develop specific clinical and community support programs for children, families and young people, older people and people in the criminal justice system who are at risk of, or experiencing, mental illness or disorder:

- (1) What programs have been developed and what is the function of each program?
- (2) When did each program start and when did it finished (if applicable)?
- (3) What is the number of participants of each program each year between the life of the program, including to date, if still running?
- (4) What are the results of each program and its failures/successes?
- (5) Which programs were terminated and why i.e. funding shortages, low participation, etc?

#### Answer-

### I am advised:

- (1) to (5) A range of programs and activities have been implemented at a local level across NSW Mental Health Services to support the mental health and emotional wellbeing of Aboriginal communities. The implementation of such initiatives and the number of participants in these initiatives is managed by each Area Health Service and are based on the needs of local Aboriginal communities; as such NSW Health does not routinely collect this information. The programs include:
  - The Aboriginal Mental Health Workforce Program, which aims to increase the Aboriginal health workforce, and encompasses the Aboriginal Health Worker Training Program and Aboriginal Clinical Leadership Program. This Program commenced in 2007, is ongoing and recurrently funded. The Program is making a significant contribution to building an Aboriginal Mental Health Workforce across the state. The Worker Training Program has produced 10 graduates to date. The Implementation Review of the first 12 months of the Program is available online at www.crcah.org.au/publications/downloads/NSW-Aboriginal-Mental-Health-Worker-Training-Program-Impl-Review.pdf. Funding is also provided for a full time position for an Aboriginal Child and Adolescent Mental Health and Wellbeing Manager to ensure the development and implementation of the Aboriginal Child, Adolescent and Family Social Emotional and Well Being Policy.
  - An Aboriginal Older Peoples' Mental Health Project was conducted in 2010 to support priorities identified in the NSW Service Plan for Specialist Mental Health Service for Older People 2005-2015, and in the NSW Aboriginal Mental Health and Well Being Policy 2006-2010. This project involved consultations with both Aboriginal people and service providers, and has provided information to inform the key principles of care needed to improve responses to the social and emotional needs of older Aboriginal people.
  - For people in the criminal justice system, Justice Health screens all people who are in custody with a mental illness and provides a court liaison service for people with a suspected mental health and/or drug and alcohol concerns. Justice Health has recruited Aboriginal Mental Health Trainees to further strengthen the provision of services to Aboriginal people, and additionally has three current projects specifically related to the NSW Aboriginal Mental Health and Well Being Policy 2006-2010:
    - Aboriginal Youth Health Access Workshop Program This 3 week group program seeks to encourage Aboriginal young people in custody to identify their health issues early, and provides them with information to manage their health. A trial of the Program was held in March 2010 and the second roll out of the Program commenced in November 2010. The Program has resulted in an increase in understanding of Aboriginal young people's expectations of care when attending a health service. For example 15 of the 24 Aboriginal young men participating in the program were able to apply for a Medicare card for the first time.
    - Community Integration Teams aim to coordinate integrated ongoing care for young people, aiding their integration into the community. This Program commenced in May 2008 and remains ongoing. This Program is effective in encouraging young people who have a mental illness and/or problematic drug and alcohol use or dependence in accessing

health care in the community following their release from custody. This initiative is also having positive influence on reduced rates of recidivism.

• Adolescent Court and Community Teams aim to divert young offenders with mental health issues from the criminal justice system and into treatment. This Program commenced in 2007. Due to the high number of Aboriginal young people being referred to the Team, funding to expand the service was received during 2010 which will soon make this initiative operational in 11 courts across NSW. Since this Program commenced there have been 1610 court referrals to the Team. Of these, 30.4% referrals identified themselves as being of Aboriginal background. Of the total number, 17.7% were diverted from custody; and 56.7% were referred on to health or other services for assistance.

# \*11976LEAKING OR BURST WATER MAINS—Mr Malcolm Kerr asked the Minister for Water, and Minister for Corrective Services—

- (1) How many incidents of leaking or burst water mains were reported in the Cronulla electorate during:

### Answer-

(1) and (2) I am advised Sydney Water collates these forms of data by local Government Area, not electorate boundaries.

By investing over \$100 million a year Sydney Water has reduced leaks significantly. Since 2003 they have reduced leaks by over 33 billion litres per year. This has been achieved through active leak detection and repair, reducing pressure in the pipes, placing meters on the pipe system to detect leaks, improving response time to main breaks and replacing old pipes.

- \*11977CALLS FOR AMBULANCES—Mr Malcolm Kerr asked the Deputy Premier, and Minister for Health—

#### I am advised:

- (1) and (2) NSW Ambulance Service does not collect data on response times on the basis of NSW State electorates.
- \*11979NIMBO CREEK CHOKE—Mr Daryl Maguire asked the Minister for Water, and Minister for Corrective Services—
  - (1) Is it correct that you were informed by Save Nimbo Creek Inc (SNC) by letter dated 9 July 2009 that SNC claimed to "have substantive evidence that (a) the choke on Nimbo Creek was not originally built to the REF design drawing, and (b) does not presently conform with the REF design drawing, so that choke was and remains illicit"?
  - (2) Do you acknowledge receiving three photographs with captions on the reverse, enclosed with the letter from SNC dated 9 July 2009?
  - (3) Do you acknowledge that the caption on photo No. 2 in this batch of three photographs sent to you stated in part: "A cursory examination of this photograph and the original design drawing will convince you that the present choke does not conform with the original design and specifications. No reasonable person who compared photos numbers 1 and 2 could maintain that as a consequence of the choke, more water flows into Nimbo Creek since the choke was installed than before"?
  - (4) Do you acknowledge that the caption on photo number 3 in this batch of three photographs sent to you also stated in part: "A cursory examination of this photograph and the original design drawing

will convince you that the present choke does not conform with the original design and specifications. No reasonable person who compared photos numbers 1 and 3 could maintain that as a consequence of the choke, more water flows into Nimbo Creek since the choke was installed than before"?

- (5) Did you seek Departmental advice on these issues?
- (6) After receiving the letter from SNC dated 9 July 2009, did you receive Departmental advice that the choke on Nimbo Creek conformed with the original design?
- (7) After receiving the letter from SNC dated 9 July 2009, did you receive Departmental advice that the choke on Nimbo Creek did not conform with the original design?
- (8) From whom, and in what form, did you receive that advice?
- (9) Will you table or supply me a copy of that advice?
- (10) Why did you not respond to SNC?
- (11) Is it correct that during the week of Monday, 10 August 2009, almost precisely one month after the date of the SNC letter, the then Department of Water and Energy completely demolished the choke on Nimbo Creek and built a new choke at the same location, to a new design?
- (12) When, how, and by whom were you advised that the choke on Nimbo Creek had been demolished?
- (13) Will you table or provide me with a copy of that advice?
- (14) Why was the choke on Nimbo Creek demolished during the week of Monday 10 August 2009?
- (15) What was the cost of the work involved in demolishing the choke on Nimbo Creek and building a new one during August 2009?
- (16) Have you been advised that the Environmental Defender's Office (EDO), acting on behalf of Save Nimbo Creek Inc. wrote to Mr David Harriss, Commissioner for Water by email on 21 June 2010, advising him that the EDO is "of the opinion that the regulator built in August 2009 ('new regulator') was constructed in breach of the Environmental Planning and Assessment Act 1979 ('EP&A Act') and that a full environmental assessment of the impacts of the proposal should have been conducted, including preparation of a new Review of Environmental Factors ('REF') and Environmental Impact Statement ('EIS')"?
- (17) Have you been advised that, although the NSW Office of Water Principal Legal Officer, Mr Nathan Laird, undertook in a letter to the EDO dated 7 July 2010, he would "seek to provide you with a response as soon as possible", no such letter has been received at this date, twelve weeks later?
- (18) Have you been advised that the EDO, acting on behalf of SNC wrote again to Mr David Harriss, Commissioner for Water by email on 21 September 2010, advising him that the EDO had not received a response from Mr Laird, and advising the Commissioner of their opinion that certain aspects of the work carried out during August 2009 on the Nimbo Creek are in breach of the EP&A Act, s120 of the Protection of the Environment Operations Act 1997, and that the work carried out in August 2009 "does not appear to have an approval under s90 of the Water Management Act 2000"?
- (19) Can you explain the inordinate delay by the NSW Office of Water in responding to the EDO about these obviously important matters?

#### Answer-

I am advised by the NSW Office of Water the following:

- (1) to (4) I confirm that I received a copy of Save Nimbo Creek Inc (SNC) correspondence of 9 July 2010, which included three photographs with captions on the reverse.
- (5) to (10) SNC has raised issues surrounding those contained in this correspondence on a number of previous occasions, including correspondence to the Ombudsman, former Ministers and Director-Generals, and staff of the Office of Water and its predecessors. I asked the Commissioner to seek Departmental advice on the issues raised by SNC in its correspondence of 9 July 2009 and respond directly to SNC. The Commissioner subsequently received a letter from the NSW Ombudsman's Office, advising of a complaint they had received from Dr Brian Wild regarding the agency's handling of his concerns with the Nimbo Creek offtake structure, and requesting that six specific questions asked by Dr Wild be answered. The Commissioner wrote to Dr Wild on 13 April 2010, providing the information sought, and provided a copy to the Ombudsman's Office.
- (11) to (15) The Nimbo Creek is an Anabranch of the Tumut River. For a number of years prior to 1995, willows in the Nimbo were impeding flow and causing overland flooding and bank erosion problems. The landowners along the Nimbo petitioned the then Department of Land and Water Conservation (DLWC) to remove the willows so that their adjoining lands would no longer be flooded. The Tumut River Management Strategy 2000 (TRMS), which was developed and adopted after public consultation

by DLWC in 1996 was the first significant Management Plan for the Tumut and its associated anabranch streams.

The TRMS identified that Nimbo Creek, as well as needing willow removal, also needed an offtake structure from the Tumut River. The purpose of this structure was to ensure that the current flow distribution was maintained, reduce the risk of erosion and prevent Nimbo Creek becoming the main channel for the Tumut River.

The rock offtake structure that was constructed in 2002 was based on option 3 considered in the Nimbo Creek Works Report (2000), Department of Land and Water Conservation, Applied Resources Technology. This report was the basis for the Nimbo Creek Regulator Works Review of the Environmental Factors (REF) that was prepared by the then Department of Land and Water Conservation in April 2000. The report recommended that option 2 be constructed. However, when the then Department was preparing to build the structure and having re-examined the proposed site, it was determined that a variant of option 3 was preferable. The reason option 2 had been preferred over option 3 was because the report had concluded that "the structure could become unstable during flood conditions, causing the weir failure, associated with additional flooding and erosion". To minimise these issues to an acceptable level the Department built the offtake structure using larger size rocks of approximately 300-1000mm in size, which were placed across the mouth of the creek. The rocks were not physically joined together. The final design that was built was also assessed by the then Department as having less environmental impact than option 2 because the area of construction was smaller. The structure was designed to control the flow of water entering Nimbo Creek so that the existing distribution of flows could be maintained. A clear opening in the base of this structure was always maintained to allow normal low flows to pass down the Creek. Flow rates in Nimbo Creek had changed in the years during the drought and the resultant need to reduce flows down the Tumut River to conserve water, as well as reductions in the unregulated inflows into the Creek from other sources like Killimicat and Brungle Creeks.

The offtake structure was refurbished in August 2009, following environmental and hydraulic assessments by the NSW Office of Water. Option 2 was revisited but was considered not to be appropriate because it would not restrict maximum flows in the Creek to the required level, in contrast to the original report. The refurbishment works were designed to be an improved version of the original structure, that is, a revised form of option 3. These works included widening the bed of the structure such that it would be less likely to be jammed with debris, and the erosive forces would be further restricted to help prevent land loss to Nimbo Creek landholders.

The volume of water at low flows was maintained as per the original design, but alternative materials and techniques were used, including geofabric reinforcing, cement block abutments, an inverted culvert and bank filling and revegetation. Energy dissipating rocks were maintained within the bed of the creek to reduce the potential for downstream scouring. These rocks also provide rest areas for native fish under certain flow conditions.

These works are standard works that are regularly carried out by the NSW Office of Water. Given the nature of the works there was no need or requirement to inform me that they were occurring.

It is worth noting that the works report stated that a benefit of the proposed rock offtake structure was that it could be easily modified in the future if the requirements for the structure changed. Monitoring of the operation of the structure has been ongoing since the structure was constructed.

DECCW is closely monitoring the operations of the facility. A total of 18 announced and unannounced inspections and odour surveys of the site have been carried out this year to monitor compliance with the company's environment protection licence.

DECCW is ensuring Australian Native Landscapes is taking ongoing action to improve its environmental performance, including:

- trialling covers for compost windrows to reduce odour generation;
- upgrading the entry/exit road;
- · upgrading site drainage and ponds; and
- reconfiguring the site to ensure operational activities are further away from the property boundary.

DECCW is also working with Australian Native Landscapes to put an operational limit on its licence restricting the amount of raw material, active compost and finished product on site at any one time. This will ensure that its activities operate at a scale that minimises potential for environmental impacts.

DECCW will continue to work with and regulate Australian Native Landscapes to improve its environmental performance and will continue to conduct announced and unannounced inspections to monitor the site.

The pilot study seeks to gather information on the effect of existing in-stream development on river health and to use this information to develop improved processes and guidelines that can be implemented river-wide.

The Office will be seeking broad community input on the project's findings before any final recommendations are made about future approval processes. The Office will also be developing a communication strategy to help inform landholders of the important role that riparian vegetation plays in maintaining river health and to remind landholders of their responsibilities and obligations before commencing any in-stream development work.

Landholders are required to apply to their local council for approval before undertaking any in-stream development in the Hawkesbury-Nepean River. The Office has not issued any fines for unauthorised instream development and has no compliance powers under its legislation. Compliance is a matter for local councils or the relevant government agency.

"Under the Public Health (Tobacco) Act 2008, all tobacco retailers are required to notify the NSW Department of Health of tobacco retailing activities on the online Government Licensing Service.

The Government Licensing Service provides comprehensive information on tobacco retailing activities in NSW, including the type, location and relative size of retailing premises.

The associated retailer notification scheme supports improved compliance monitoring and enforcement of the legislation by providing that retailers who are convicted of a series of tobacco-related offences to be prohibited from retailing tobacco products for specified periods.

Since the Act commenced on 1 July 2009, more than 7,000 businesses covering over 12,000 tobacco retailing premises have notified the Department through the online Service. Retailers must notify the Department prior to commencing any tobacco retailing.

Notification on the Government Licensing Service is currently free for tobacco retailers and at present, there are no plans to charge a fee to general tobacco retailers for a licence to cover the costs of administering and enforcing the scheme."
