- *1189 PUBLIC HOSPITALS IN WESTERN SYDNEY—Mr Richard Amery asked the Minister for Health—
 - (1) In relation to the building of public hospitals in Western Sydney, in what year did the Federal Labor Government initiate the construction of Westmead Hospital?
 - (2) In what year did a State Labor Government initiate the construction of:
 - (a) the current Blacktown Hospital;
 - (b) Mount Druitt Hospital;
 - (c) the current Fairfield Hospital;
 - (d) the original Bankstown Hospital;
 - (e) the current Bankstown Hospital;
 - (f) Liverpool Hospital; and
 - (g) the current Nepean Hospital?

Answer-

I am advised:

- (1) Following a report on Hospitals in Australia completed in April 1974, the Commonwealth Government budgeted for a five-year program of capital assistance to construct public hospitals in outer urban areas. New South Wales was awarded a 'seeding grant' of \$4 million for the establishment of a hospital at Westmead in 1973. The hospital opened in 1978.
- (2) (a) The current Blacktown Hospital was included as a New Work in the 1998/99 Budget papers.
 - (b) The need for a hospital at Mount Druitt was first set out in detail in the report "Planning Hospitals for the West of Sydney" December 1975.
 - (c) The current Fairfield Hospital was included as a New Work on the 1983/84 Budget papers.
 - (d) Planning for Bankstown Hospital began in the early 1950's and the hospital was completed in 1957.
 - (e) The current Bankstown Hospital (known as Bankstown/Lidcombe Redevelopment) was included as a New Work in the 1993/94 Budget papers.
 - (f) The redevelopment of Liverpool Hospital was included as a New Work in the 1991/92 Budget papers.
 - (g) The current Nepean Hospital (Stage 2) was included as a New Work in the 1997/1998 Budget Papers.
- *1199 PUBLIC TRANSPORT—RUGBY LEAGUE GRAND FINAL—Ms Gladys Berejiklian asked the Deputy Premier, Minister for Transport, Minister for Finance—

In relation to the 2007 Rugby League Grand Final:

- (1) What public transport options were given to spectators to get to the game?
- (2) What public transport options were given to spectators to get home from the game?

Answer-

I am advised:

- (1) and (2) Public transport arrangements for the 2007 NRL Grand Final were advertised in the Sydney metro newspapers, on the CityRail website and via the 131 500 Transport Infoline and website.
- *1201 E10 TASKFORCE—Mr Peter Debnam asked the Premier, Minister for Citizenship—

In relation to the E10 Taskforce and the Minister's response to Question No 0212:

- (1) What "technical, economic, environmental, health, marketing, policy, legal and transitional issues" are being considered by the E10 Taskforce?
- (2) When will the final report be released to the public?

Answer-

- (1) The issues being considered by the E10 Taskforce are outlined in its Terms of Reference. These issues are:
 - (a) The sources and adequacy of supplies to meet the requirements of an ethanol mandate;

- (b) The extent to which investment in new infrastructure would be needed in the NSW fuel supply chain;
- (c) The economic costs and benefits of an ethanol mandate on industry and consumers (including the NSW Government);
- (d) The impact of ethanol blends on vehicle operability and performance;
- (e) The environmental and health impacts of ethanol blends;
- (f) The use of public education to improve consumer understanding of ethanol blends;
- (g) The legal issues associated with the introduction of a State-based mandate for the use of ethanol, including the impact of Mutual Recognition legislation; and
- (h) An appropriate timeframe (and ethanol content) for the phase-in of an ethanol mandate.

In examining these issues, the Taskforce is to have regard to the status of other biofuels and alternative fuels such as LPG, CNG, hydrogen, liquid fuels from coal, and electricity.

- (2) The final report of the E10 Taskforce will be released to the public in the near future.
- *1203 MACQUARIE-CUDGEGONG WATER SHARING PLAN—Ms Pru Goward asked the Minister for Climate Change Environment and Water—

How were the requirements in Part 9 Section 48 (4) of the Macquarie-Cudgegong Water Sharing Plan met in the 2006-07 water year before expressions of interest for supplementary water were called by State Water on 9 June?

Answer-

Clause 48 of the Macquarie-Cudgegong Water Sharing Plan (Plan) describes the rules for the taking of water under supplementary water access licences. The specific subclause (4), to which the Member for Goulburn referred, requires certain criteria to be met before such water can be taken.

The first criterion refers to the environmental provisions of Part 3 of the Plan. These provisions apply to environmental water held in, and released from, either Windemere or Burrendong Dams. The flows that occurred in June 2006 were in tributaries downstream of Burrendong Dam so this first criterion was not relevant.

The second criterion relates to the supply of stock and domestic and native title rights. Stock and domestic requirements (basic landholder rights) are met from normal river operations from the two dams. The flows in June 2006 provided enhanced access in some streams but, because of the location of the rainfall the benefits were limited. At this point in time, there are no native title rights within the area covered by the Plan.

The third criterion relates to the supply of higher priority licence requirements. Licences are provided with an allocation from the stored water in Windemere and Burrendong Dams. If there are legitimate orders for water from these licences, then those orders can be supplied from tributary inflows. It must be understood that these tributary inflows cannot create additional allocation to that which has already been announced. It is simply another source from which those allocations can be supplied. In June 2006, at the end of the water year, there were no orders for water downstream of the point of inflows. The fourth criterion relates to the supply of replenishment flows in those streams specified in Clause 59. In June 2006, these requirements were added to the threshold for triggering the consideration of supplementary access.

The next subclause (5) in Clause 48 requires that a flow of at least 5,000 megalitres per day [ML/d] must be achieved at Warren in excess of the requirements of subclause 4 described above. In June 2006, the calculated threshold at Warren was 5,400 ML/d to meet the requirements of the Plan. The flow actually peaked at 8,800 ML/d at Warren.

In this process, the State Water Corporation undertakes the analysis of the flows and makes a recommendation to the Department of Water and Energy. The Department reviews the information and, if it agrees, will then approve the supplementary access on my behalf.

The estimated volume of the articular tributary flow event was 38,000 megalitres [ML], of which 4,600 ML was made available for extraction under supplementary licences. The remaining flow was directed to give the best environmental benefits in accordance with the advice obtained from the Macquarie-Cudgegong Environmental Flows Reference Group established under the Plan.

*1204 ENVIRONMENTAL PROTECTION OF WATER SUPPLY—Ms Pru Goward asked the Minister for Emergency Services, Minister for Water Utilities representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—

- (1) Has longwall mining cracked the rocky beds of the Wongawilli Creek, Native Dog Creek and the Waratah Rivulet in the Special Area catchments so that the affected reaches of these streams do not flow in dry conditions when previously regular flows occurred?
- (2) Have Drillhole Swamp, Flat Rock Swamp, Swamp 18 and Swamp 19 in the Special Area catchments been severely damaged by longwall mining?
- (3) Does the interest of the Department of Primary Industries in royalty payments obtained by maximum coal extraction from longwall mining been to the detriment of adequate environmental protection to guarantee on-going supplies of clean drinking water for Sydney and Wollongong for future generations?
- (4) Given the past damage to Special Area catchments, will the Minister allow the Department of Primary Industries to continue to approve mining operations that further damage the ability of catchments to collect, hold and transfer essential water supplies for Sydney and Wollongong?
- (5) Does the Minister for Primary Industries instead support the development of a new regulatory framework for future coal mining in Special Area catchments so that all future damage to swamps and streams is prevented?
- (6) Will the Minister for Primary Industries hold himself accountable for any further loss of water supply security if the inappropriate regulation of coalmining in the Southern Coalfield continues or will you continue to trade off protection of water supply catchments to enhance coal production?
- (7) (a) If the damage to water supply catchments continues, how will the Minister for Primary Industries ensure that the coal industry adequately compensates the Sydney Catchment Authority for the damage, and how can Sydney and Wollongong's most reliable water supply catchments be replaced?
 - (b) Does the Minister intend the mining industry to fund another desalination plant?

Answer-

- (1) Longwall mining has had some impact on the surface flow of these creeks. I am advised however that the surface cracking has had no identified impact on either the quality or quantity of drinking water supplied from the Woronora Reservoir. Remediation trials have been carried out to reinstate the water holding capacity of the affected areas.
- (2) It is inconclusive as to whether or not the damage was caused by longwall mining. The cause of damage to the swamps cannot be positively determined.
- (3) No.
- (4) Should mining proposals be deemed to have an unacceptable impact on the environment, the proposal will either be modified or refused.
- (5) An independent inquiry into the impacts of longwall mining in the Southern Coalfield is currently being undertaken. The report from this inquiry will be available in 2008.
- (6) The ultimate goal is to achieve a balance between resource recovery and minimal surface impacts while ensuring that valued natural surface features are not adversely affected.
- (7) (a) There is no damage to water supply catchments that is limiting the provision of water to Sydney or Wollongong.
 - (b) No.
- *1205 PURCHASE OF CROWN LAND—Ms Katrina Hodgkinson asked the Minister for Climate Change Environment and Water representing the Minister for Lands, Minister for Rural Affairs, Minister for Regional Development—
 - (1) On what date did the Department of Lands receive the application to purchase Crown Land Lot 2328 DP 754611 in Young by Allied Grain Storage?
 - (2) As Department of Lands staff has informed Mr J White of Allied Grain that there is no concern about the sale of the land to Allied Grain, when will the formal approval for this sale be issued?
 - (3) As Allied Grain is unable to make use of its new warehousing facilities on land adjacent to Lot 2328 because they cannot lay connecting sewerage and water services across the Crown land, costing them considerable financial expense, will you assist Allied Grain by speeding the approval of this sale?

Answer-

- (1) An enquiry to purchase lot 2328 DP 754611 was made on behalf of Allied Grain on 24 February 2006. The Department of Lands has completed its investigations and has now invited a formal application to purchase the land.
- (2) My delegate under the Crown Lands Act has given approval in-principle to sell lot 2328 to the adjoining owners.
- (3) I have directed that the sale be expedited once a formal application to purchase is received. In the interim I am prepared to consider a Licence Application to allow sewerage and water services to be

laid across the affected Crown land so that Allied Grain can occupy its warehousing facility while the sale is being finalised.

- *1206 BARTON HIGHWAY—Ms Katrina Hodgkinson asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—
 - (1) How many properties along the route of the Barton Highway Murrumbateman Bypass has the RTA already acquired?
 - (2) How many property owners has the RTA contacted, or entered into negotiations, about the purchase of their land?
 - (3) What is the projected start date for construction towards which the RTA is working?

Answer-

I am advised:

Barton Highway is part of the Auslink national network.

\$3 million of federal funding has been allocated in 2007/08 for planning of the Barton Highway, ACT to Murrumbateman Bypass.

The RTA has been in discussion with 6 landholders regarding property acquisition for the Murrumbateman Bypass.

The NSW Government looks forward to working cooperatively with the Federal Government regarding timing of construction and funding of the project.

*1208 NEW LINE ROAD CRASH AND TRAFFIC FLOW DATA—Mrs Judy Hopwood asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

When will the RTA provide crash and traffic flow data for New Line Road, Dural, as requested in September and October for the electorate office staff of Hornsby electorate?

Answer-

I am advised:

Information relating to traffic crash statistics is provided annually by the RTA in the publication, Road Traffic Crashes in NSW, which is publicly available on the RTA website at www.rta.nsw.gov.au

*1209 BURST WATER PIPE—CHERRYBROOK—Mrs Judy Hopwood asked the Minister for Emergency Services, Minister for Water Utilities—

In relation to a burst water pipe (adjacent to 4 Torrens Place, Cherrybrook) which was reported to Sydney Water in mid-April 2007:

- (1) What sequence of dates, times and events led to the solution of this issue?
- (2) How long did Sydney Water take to fix the water loss?

Answer-

(1) and (2) Sydney Water has advised it renewed the water main in Gumnut Place, Cherrybrook, near Torrens Place, because of the main's poor performance earlier this year.

Prior to this the main had been operating satisfactorily, with maintenance records back to 2001 showing no previous break or leak history.

The performance of the main began to deteriorate in March of this year until it was replaced on 11 October 2007. There were seven reports of a fault. The responses varied from eight days, which included a number of visits to the site before repairs were complete, to three hours to get on site and complete repairs.

Another adjoining section of main in nearby New Line Road, Cherrybrook is also scheduled for renewal during February 2008. Both renewals will total \$240,000.

Sydney Water's Water Main Renewal Program specifically targets poorly performing mains for renewal. During 2006-07 Sydney Water renewed over 140 kilometres of water main at a cost of \$75 million, and expects a similar level of investment this financial year to improve the water supply network.

*1210 MINISTRY OF TRANSPORT MEETINGS—Mrs Judy Hopwood asked the Deputy Premier, Minister for Transport, Minister for Finance—

When will the next statewide meetings, arranged by the Ministry of Transport, be held in the northwest

area of Sydney to address local transport needs?

Answer-

I am advised:

The next round of Regional Planning forums will be held during the first half of 2008.

*1211 JOHN HUNTER HOSPITAL—FUNDRAISING—Ms Sonia Hornery asked the Minister for Health—

Since the John Hunter Hospital at New Lambton was opened in January 1991:

- (1) What is the total amount of funds raised by the hospital volunteers known as the Kookaburra Carers for the Hospital?
- (2) What has been the annual amounts received by the hospital from:
 - (a) the KC gift shop;
 - (b) other sources?
- (3) In general terms, for what purposes are these funds used?

Answer-

I am advised:

- (1) Through the amalgamation of the Royal Newcastle Hospital's 'Pink Ladies' and the 'Kookaburra Carers' from John Hunter Hospital in 2006, the 'John Hunter Site Carers' was formed. The total amount of funds raised since 1991 by these combined groups is \$2,232,925.65.
- (2) (a) and (b) Data prior to 2003/04 financial year are not available. It is therefore not possible to respond to this specific question.
- (3) The John Hunter Hospital utilises the funds raised by the carers to purchase equipment for the hospital.
- *1217 BURWOOD LOCAL AREA COMMAND—Ms Virginia Judge asked the Minister for Police, Minister for the Illawarra—

How many new police officers have joined the Burwood Local Area Command during 2007?

Answer—

The NSW Police Force has advised me that 35 Probationary Constables have been assigned to Burwood Local Area Command since January 2007. A further 6 Constables have transferred to the Command from other locations during the same period, for a total of 41 officers.

*1218 MIDDLE EASTERN ORGANISED CRIME SQUAD—Ms Virginia Judge asked the Minister for Police, Minister for the Illawarra—

What are the latest results from the Middle Eastern Organised Crime squad?

Answer-

- (1) The NSW Police Force has advised me that in the 9 months to 30 September 2007, the Squad had arrested 396 people and laid 1,069 charges including violence, firearms, traffic, fraud, theft and drug related offences.
- (2) I provided a summary of the key results of the Squad during my appearance before the Budget Estimates Committee on 22 October.
- *1219 2007-2008 BUDGET—ALLOCATION TO WAGGA WAGGA—Mr Daryl Maguire asked the Minister for Health representing the Minister for Roads, and Minister for Commerce—

How much, listed under the heading "Various" in the latest Budget 2007-2008, was allocated to Wagga Wagga and to which project?

*1220 2007-2008 BUDGET—ALLOCATION TO WAGGA WAGGA—Mr Daryl Maguire asked the Minister for Emergency Services, Minister for Water Utilities representing the Minister for Primary Industries, Minister for Energy, Minister for Mineral Resources, and Minister for State Development—

How much, listed under the heading "Various" in the latest Budget 2007-2008, was allocated to Wagga Wagga and to which project?

Answer-

NSW DPI has advised that \$27,000 has been allocated for new data network equipment, \$10,000 to upgrade of potable water supply and \$6,653,000 allocated for the project "Plantation Establishment-Softwoods Growing Stock" in the Wagga Wagga electorate.

The NSW Food Authority budget allocations for resources and programs are regionally and capability-based, and do not align with electorate-based allocations.

*1221 2007-2008 BUDGET—ALLOCATION TO WAGGA WAGGA—Mr Daryl Maguire asked the Minister for Climate Change Environment and Water representing the Minister for Lands, Minister for Rural Affairs, Minister for Regional Development—

How much, listed under the heading "Various" in the latest Budget 2007-2008, was allocated to Wagga Wagga and to which project?

Answer_

The Department of Lands has no current plans to spend any of its 2007/8 capital works allocation within the Wagga Wagga area.

- *1223 GOVERNMENT OVERSEAS POSTINGS—Mr Jonathan O'Dea asked the Premier, Minister for Citizenship—
 - (1) How many people are employed by the NSW Government in overseas postings of four months or longer?
 - (2) In which countries are they located?
 - (3) How many people are employed in each country?

Answer-

Ministers were advised of New South Wales Government expectations in relation to agency involvement in overseas projects in Premier's Memorandum 2002-03 Guidelines on Overseas Projects, and more recently, in Premier's Memorandum 2006-12 Involvement of the Department of State and Regional Development.

Additionally, Government businesses covered by the Commercial Policy Framework are also to ensure overseas projects are consistent with New South Wales Treasury's Guidelines on Projects of State Significance. Overseas projects are approved by the Minister responsible for the agency.

Details on the information sought can be found in Annual Reports completed by agencies under the Annual Reports (Departments) Act 1985 and Annual Reports (Statutory Bodies) Act 1984 (NSW), which contain both financial and non-financial information on agencies' operational activities. (NSW)

- *1224 HSC INDONESIAN LANGUAGE EXAM—Mr Jonathan O'Dea asked the Deputy Premier, Minister for Transport, Minister for Finance representing the Minister for Education and Training, Minister for Industrial Relations, Minister for the Central Coast, and Minister Assisting the Minister for Finance—
 - (1) How many students have sat for the Indonesian language HSC exam in each of the last five years?
 - (2) How does the Government rate the importance of teaching the Indonesian language in NSW schools compared to other world languages?

Answer-

(1) There are four Higher School Certificate courses in Indonesian, one for background speakers and three for non-background speakers, being Beginners, Continuers and Extension. The total Higher School Certificate entries for these four courses over the past five years were as follows:

2007 - 239

2006 - 249

2005 - 269

2004 - 275

2003 - 254

(It should be noted that students who sat the Extension course examination are also represented in the Continuers course entries.)

- (2) The NSW Government encourages and supports languages learning in NSW. Currently there are 59 Higher School Certificate languages courses in 34 languages. Indonesian is a language of regional significance and is well catered for in the New South Wales school curriculum. In addition to the four Higher School Certificate syllabuses, the Board of Studies recently revised the former Years 7 to 10 Indonesian syllabus as a Kindergarten to Year 10 syllabus. The Board has also developed detailed syllabus support materials on CD-ROM for teachers of this syllabus.
- *1225 ASSESSMENT OF ENVIRONMENTAL SIGNIFICANCE—Mr Adrian Piccoli asked the Minister for Climate Change Environment and Water representing the Minister for Lands, Minister for Rural Affairs, Minister for Regional Development—
 - (1) What is the waiting time for an Assessment of Environmental Significance to be conducted from the Dubbo office of the department?
 - (2) What number of staff would carry out the assessments?
 - (3) What geographical area would be covered by staff from this office?
 - (4) (a) What applications are currently being processed?
 - (b) What is the date the applications were received by the department for the requested assessments?

Answer-

- (1) to (4) Now that the assessment criteria have been established and the covenant framework finalised, approximately 660 purchase applications requiring assessment are being processed in order of receipt. These applications date from October 2004 to the present.
- (2) There are two staff undertaking assessments for the Dubbo District. Assistance is provided by staff from other districts when available.
- (3) The Dubbo District extends to the Western Division boundary on the west, the State border on the north, and includes Tenterfield, Walcha, Quirindi and Lithgow on the east, and Cowra, Grenfell and Condobolin on the south.
- *1226 SICK LEAVE—Mr Adrian Piccoli asked the Minister for Police, Minister for the Illawarra—
 - (1) How many police officers in the Griffith Local Area Command are on sick leave as at 23 October 2007?
 - (2) How many of those officers have been on sick leave for more than three months?
 - (3) How many have been on sick leave for more than six months?
 - (4) How many have been on sick leave for more than 12 months?

Answer-

- (1) to (4) Staffing allocations and leave management within a Local Area Command are matters for the Local Area Commander.
- *1227 SPRING WATER EXTRACTION LICENCES—Mr Geoff Provest asked the Minister for Climate Change Environment and Water—

In relation to the issuing of licences to extract spring water for bottling:

- (1) What is the total number of licences granted for commercial spring water extraction in the electorate of Tweed?
- (2) What is the total volume of spring water extracted under the issue of these licences in the electorate of Tweed?

Answer—

- (1) There are 13 groundwater licences in the electorate of Tweed which authorise commercial water abstraction for water bottling with a volumetric allocation totalling 146 megalitres.
- (2) 146 megalitres is the total volume that may be legally extracted in any year for water bottling.
- *1229 CIVILIAN STAFFING OF LOCAL AREA COMMANDS—Mr Geoff Provest asked the Minister for Police, Minister for the Illawarra—

In relation to civilian staffing of the Tweed-Byron Local Area Command (LAC) and as the NSW Government intend to reduce or has begun reducing civilian staffing of LACs across the State by 240 positions:

- (1) How many civilian positions will be lost as a result of this reduction in the Tweed-Byron LAC?
- (2) How many of these civilian positions that are being lost will be replaced by police officers in the Tweed-Byron LAC?

(3) How many of these civilian positions that are being lost in the Tweed-Byron LAC were already vacant before this decision was made, and how much of the budget for the Tweed-Byron LAC do these unfilled positions represent?

- *1232 RAIL TRANSFORMATION PROGRAM—Mr Michael Richardson asked the Deputy Premier, Minister for Transport, Minister for Finance—

Will your \$10 million Rail Transformation Program examine the fall of nearly 30 per cent in passenger numbers on the Carlingford line since 2001-02?

Answer-

I am advised:

The \$38 million Carlingford Line Passing Loop forms part of the NSW Government's Rail Clearways Program and will also help improve services for families in North Western Sydney.

The project, which involves construction of a train passing loop at Rydalmere Station, will allow the concurrent running of services in both directions on the Carlingford Line and will allow for more flexible and reliable train operations.

This will include greater service frequency between Carlingford and Clyde, with half hourly services throughout the day and improved connections at Clyde.

Planning for the project is scheduled to commence in early 2008, and I am advised that patronage on the Carlingford Line will be considered when drafting future timetables.

*1233 BREACHES OF LEVEL 3 WATER RESTRICTIONS—Mr Michael Richardson asked the Minister for Emergency Services, Minister for Water Utilities—

How many people have been fined in Postcode 2154 (Castle Hill) for breaches of Level 3 water restrictions in each of the following years:

- (a) 2003-04?
