*9223 BUDGET FUNDING FOR BANKSTOWN-LIDCOMBE HOSPITAL—Ms Tania Mihailuk asked the Minister for Health, and Minister for Medical Research—

Considering the expected population growth in South Western Sydney and Bankstown-Lidcombe Hospital being one of the busiest hospitals in Sydney seeing about 55,000 patients a year, a record 1,857 babies born there last year and a car park that is consistently at capacity, why was only \$25 million allocated to the Bankstown-Lidcombe Hospital in the 2018-19 NSW Budget?

Answer—

In addition to the \$25 million committed to the Bankstown-Lidcombe Hospital Emergency Department, the 2018-19 NSW Budget also allocated Bankstown-Lidcombe Hospital a share in the \$15 million announced to undertake planning at a number of NSW Health sites across the state.

With regard to closure of the Broken Hill Proprietary (BHP) site at Newcastle in the 1990's and efforts to stimulate the economy and create jobs:

 - (ii) Are the duty exemptions still in place?

I am advised that this question is more appropriately directed to the Commonwealth Government.

The Local Court does not distinguish between proceedings that have previously been subject to a penalty notice from other proceedings commenced by court attendance notice. As a result, the court statistics requested are not available.

The Government has committed to an additional 700 extra paramedics and 50 call centre staff over the next four years, which will further support implementation of the Committee's recommendations.

The Western Harbour Tunnel is a key initiative for Sydney's integrated transport network. It will create a western bypass of the CBD and take pressure off the Sydney Harbour Bridge, Cahill Expressway, Anzac Bridge and Western Distributor. It will relieve congestion, improve access by public transport to jobs and services, and increase the efficiency of the freight network. The project has been identified as an infrastructure priority by both the New South Wales and Commonwealth Governments.

The Government is committed to reducing domestic violence by protecting victims and holding perpetrators to account.

Tragically, 18 women were killed as a result of domestic violence in New South Wales between July 2017 and June 2018 (according to the latest data available from the NSW Bureau of Crime Statistics and Research (BOCSAR)).

BOCSAR has advised 10 women were killed by an intimate partner, five were killed by another family member, one was killed by a carer and in two instances the relationship was unknown.

I am advised:

The Commissioner of Police allocates resources based on operational needs. All police positions attached to Police Districts or Police Area Commands are flexible resources available to respond to incidents across the region. Local resources are supplemented by specialist police who are managed centrally but can be deployed to meet the changing community needs and emerging issues.

In recognition of growth in South West Sydney, the new Liverpool Police Station became operational in June 2016.

- *9238 LIGHT TO LIGHT WALK PROJECT—Mr Ryan Park asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Considering the announcement by the Member for Bega in June 2018 that the Light to Light Walk project would receive \$8 million as part of the Government's \$1.9 billion investment to protect and improve the state's environment and heritage, is the Minister aware of a partnership in 2013 between National Parks and Wildlife Service and Auswide Projects which also involved the Eden Local Aboriginal Land Council to develop environmentally sensitive infrastructure and run guided tours from Ben Boyd Tower to Green Cape Lightstation known as the Light to Light Walk?

(1) to (4) The Light to Light Great Walk is an opportunity to educate visitors about Aboriginal culture, and the Aboriginal community is best placed to provide this knowledge. As part of developing the walk's masterplan, the National Parks and Wildlife Service will consult closely with Eden LALC and other Aboriginal organisations.

The proposed expansion of the existing Light to Light Great Walk provides a range of Aboriginal training and employment opportunities. These include cultural storytelling, environmental and cultural assessments during project development, training during construction and ongoing employment, including in cultural tourism.
