- *6198 HUNTER HEALTH COUNSELLING SERVICES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) Will the Government reopen Hunter Health Counselling Services?
 - (a) If not, why not?

Answer-

I am advised:

Refer to my previous response provided for Q.6006.

*6199 PATIENT WAITING TIMES IN THE HUNTER—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

What will the Minister do to reduce waiting times, which have doubled since last year, for patients in the Hunter?

Answer-

I am advised:

NSW Health is working towards all patients being treated within their clinical priority timeframes.

John Hunter Hospital recorded a significant improvement in patients receiving their elective surgeries within clinically-recommended timeframes. In April to June 2014, 95 percent of patients were treated within clinically-recommended timeframes, a four percent improvement on the same quarter last year.

- *6200 AGED CARE FACILITIES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) How will the National Disability Insurance Scheme Act 2013 and the National Disability Insurance Scheme (NSW Enabling) Act 2013 apply to those with a disability living in aged care facilities like Wallsend Aged Care Facility?
 - (2) Will young people with a disability living in a state run aged care facility be unable to remain in this facility due to legislation removing care for those with a disability from State run services?

Answer—

I am advised:

(1) - (2) Under the Commonwealth's National Disability Insurance Scheme Act 2013 a person may become a participant of the National Disability Insurance Scheme when they meet certain criteria related to age, residence, disability and early intervention.

The National Disability Insurance Scheme (NSW Enabling) Act 2013 does not apply to people with disability residing in aged care facilities like Wallsend.

A young person under the age of 65 who has been admitted formally to a residential aged care facility following eligibility approval by an Aged Care Assessment Team will continue to have permanent tenure.

*6201 SAFETY FOR PARAMEDICS—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

What is the Government doing to improve safety for paramedics?

Answer-

I am advised:

The Government has zero tolerance for any form of violence against paramedics.

The Health Services Act 1997 provides an offence of intentionally obstructing or hindering a paramedic that is providing services to a person, with penalties of up to two years imprisonment – or five years if combined with an act of violence.

In December 2013, NSW Ambulance commenced an ongoing campaign to eliminate assaults on paramedics. The first phase, aimed at raising community awareness was the 'If You Hurt a Paramedic' poster campaign. In conjunction with Clubs NSW, over 3500 posters have been distributed in pubs, clubs, emergency departments, and ambulance vehicles throughout New South Wales.

The second phase of the campaign is an Anti-violence Training package for paramedics. The package assists with situational awareness, de-escalating difficult situations, understanding patterns of behaviour and equipping paramedics with the skills to avoid verbal or physical assault.

This training was rolled out to all operational staff across New South Wales and a supplementary package was designed for all new recruits. In the most serious cases, ambulance crews are advised to "stand off" and await the arrival of police before approaching or entering an address.

Work Health and Safety training is also provided for all staff from trainees to qualified paramedics in Work Health Safety Induction, Hazardous Manual Tasks, Risk Management, Risk Assessment, and Responding to Challenging Behaviour.

Work Health and Safety Committees have been formed around the state and provide a forum for discussion and recommendations to management regarding health and safety issues in the workplace.

Paramedics can access duress alarms on their portable radios and in their vehicles to alert the control centres and allows them to call for urgent police assistance without alerting perpetrators.

NSW Ambulance also has a comprehensive support program in place to assist paramedics when they experience stressful or traumatic situations in their work, including assault. In addition to support provided by on-duty managers, other services are available to all staff 24 hours, seven days a week, including peer support officers, chaplains and an Employee Assistance Program.

Work Health and Safety Educators continue to provide training on fatigue including understanding contributing factors, how to report fatigue and what to do if they are suffering from fatigue.

All new equipment is subject to formal trials and an assessment process to ensure it meets Australian standards and protects paramedics from injury.

NSW Ambulance launched the 'THINK' campaign at the start of 2014. The campaign looks at the most prevalent injuries sustained by paramedics and uses short videos, messages and face to face training to reduce the prevalence of these injuries.

- *6202 DISPLACED RAIL STAFF—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - (1) Will staff who are displaced from railway stations between Wickham and Newcastle stations following the truncation of the rail line be offered permanent positions elsewhere within State rail?
 - (2) Will the jobs of displaced staff be guaranteed following the implementation of the light rail?

Answer-

I am advised:

Staff will be kept fully informed of any decisions that may affect them.

- *6203 SAFETY ON NEWCASTLE BUSES—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - (1) Is the Government taking action to improve the safety of passengers and drivers on Newcastle
 - (a) If so, what is being done to improve safety?
 - (b) If not, why is no action being taken?

Answer-

I am advised:

The Government takes the safety of its customers and staff very seriously. Security for the entire public transport network is now overseen by the NSW Police Force's Police Transport Command. Transport for NSW works closely with the Police Transport Command and transport operators in Newcastle on programs to ensure safety of customers and drivers on services.

Transport for NSW meets with Newcastle Buses regularly to discuss and implement operational matters. Safety is a key standing item on the agenda.

- *6204 NEWCASTLE LIGHT RAIL—Ms Sonia Hornery asked the Minister for Transport, and Minister for the Hunter—
 - (1) What public transport options will be available to commuters between Wickham and Newcastle while the proposed light rail is being constructed?
 - (2) How long will this temporary transport option be in place?

- (3) What is the time frame for completion of the light rail construction?
- (4) What is the cost of the light rail construction?

Answer-

I am advised:

- (1) (2) Buses will be in place while light rail is under construction.
- (3) (4) Detailed planning is now underway to determine the exact timeframe and cost of the project.

*6205 TAFE NSW COUNSELLORS—Ms Sonia Hornery asked the Minister for Education—

- (1) Is the Government committed to supporting TAFE NSW meet its responsibilities under the Children and Young Persons (Care and Protection) Act 1998 by providing fully registered psychologists as TAFE counsellors?
- (2) What is the Government's response to the existing counselling cuts caused by the threat of privatisation, including those in New England, the Hunter, the Illawarra, and South West Sydney?

Answer—

- (1) The Children and Young Persons (Care and Protection) Act 1998 does not require fully registered psychologists to be employed as TAFE Counsellors.
- (2) The Government is not privatising TAFE. TAFE NSW Institutes review their staffing requirements and services to students regularly.
- *6207 HOUSING OF PEOPLE WITH DISABILITIES—Ms Sonia Hornery asked the Minister for Family and Community Services representing the Minister for Ageing, Minister for Disability Services, and Minister for the Illawarra—

Will the Department of Ageing, Disability and Home Care retain ownership of properties currently used to house people with a disability, in light of the transfer of the management of people with a disability to the non-government sector under the National Disability Insurance Scheme Act?

Answer-

As you are aware, the Government is committed to a disability service system that increases choice and control for people with disability. For this reason, in December 2012 the Government became the first state to sign a historic agreement with the Commonwealth to implement the National Disability Insurance Scheme (NDIS).

These reforms mean the budget to support people with disability will increase from \$2.7 billion to a \$6.4 billion partnership between the New South Wales and Federal Governments. Importantly, the NDIS will benefit around 140,000 people with disability in New South Wales alone.

The Government has commissioned a scoping and strategy study to examine the issues associated with transferring disability and community care assets and services to the non-government sector.

*6208 SPEECH THERAPISTS IN SCHOOLS—Mr Ryan Park asked the Minister for Education—

- (1) How many speech therapists, employed by NSW Health, currently work in schools?
- (2) Does the Department of Education and Communities fund any additional speech therapists?

 (a) If so, how many?
- (3) For each speech therapist working in schools in New South Wales, can you provide a breakdown of the schools they are currently attached to?

Answer-

- (1) The Department does not hold information centrally about the number of speech pathologists, employed by NSW Health currently working in schools.
- (2) Yes; (a) The NSW Department of Education and Communities employs three speech pathologists through the NSW Centre for Effective Reading.
- (3) Three speech pathologists are employed through the NSW Centre for Effective Reading, supporting students referred to the Centre.

Individual schools may engage the services of registered speech pathologists. The Department does not hold information centrally about speech pathologists engaged by individual schools.

*6209 NEWCASTLE EAST PUBLIC SCHOOL—Mr Ryan Park asked the Minister for Education—

What specific support will the Minister offer to Australia's oldest school, Newcastle East Public School,

to celebrate its Bicentenary in February 2016?

Answer-

Mr John Beach, Principal of Newcastle East Public School, with the support of the Department of Education and Communities, is leading and managing the bicentenary celebrations in consultation with the community.

- *6210 BULLI HOSPITAL UPGRADE—Mr Ryan Park asked the Minister for Health, and Minister for Medical Research—
 - (1) When will construction on the upgrade to Bulli Hospital commence?
 - (2) What is the estimated completion date for these works?
 - (3) Has the project received all of the funding it was allocated under the Illawarra Infrastructure Fund?
 - (a) If not, how much funding has the project received?
 - (b) If not, when will the rest of the funding be allocated?

Answer-

I am advised:

Planning is ongoing for the Restart NSW Illawarra Infrastructure project at Bulli Hospital. A timetable for the project will be announced in due course.

Funding will be made available to the project from the Illawarra Infrastructure Fund based on a claim for expenditure basis.

- *6211 NSW HEALTH SPEECH THERAPISTS—Mr Ryan Park asked the Minister for Health, and Minister for Medical Research—
 - (1) How many speech therapists are employed by NSW Health and currently work in schools?
 - (a) Can you list each of the schools that each of the speech therapists work in?
 - (b) How many of these speech therapists worked in schools in each year from 2008 to 2013?
 - (2) How much funding does the Government allocate to the provision of speech therapists in schools?

Answer—
I am advised:

- (1) (2) The employment of speech therapists in schools is a matter for the Minister for Education. I note the member has asked a question of the Minister for Education (ref Q.6208) concerning speech therapists currently working in schools and I refer the member to that response.
- *6214 SHELLHARBOUR JUNCTION SIGNAGE—Ms Anna Watson asked the Minister for Transport, and Minister for the Hunter—
 - (1) What is the total cost of erecting new signage that says "Shellharbour Junction" for the new station under construction between Dunmore and Flinders?
 - (2) Why was signage erected prior to the formal meeting of the Geographical Names Board of New South Wales meeting scheduled for the 16 September 2014?
 - (3) Who was responsible for instructing the erection of the signage?

Answer—

I am pleased to advise that the Geographical Names Board has determined that the new station will be named Shellharbour Junction. The name reflects the station's intended role as a gateway to Shellharbour's city centre.

As you are aware, signs showing the new name were erected by contractors during the station's construction.

 - (c) What was the cost for hosting the induction session?
- (4) When was the inaugural meeting of the Illawarra Community Advisory Panel new membership held?
 - (a) What issues were on the agenda for the inaugural meeting?
 - (b) What was the outcome of the issues discussed on the agenda?
- (5) What was the cost of holding previous meetings of the Illawarra Community Advisory Panel since it was first established?

Answer—

- (1) Panel members were selected in their capacity as individual community members in accordance with the selection criteria outlined in the Expression of Interest document. All Illawarra local government areas are represented on the Panel.
- (2) Applicants were not asked to disclose political party membership in the Expression of Interest process as it does not relate to the selection criteria.
- (3) The induction session was hosted by the Department of Premier and Cabinet at the State Office Block in Wollongong. There was no venue cost associated with holding the meeting at the Government offices. One Panel member was an apology and was inducted by the Department of Premier and Cabinet on 20 August 2014.
- (4) The meeting was held on 3 September at the State Office Block in Wollongong. A wide range of topics relating to the Illawarra region were discussed.
- (5) Panel meetings are currently held at the State Office Block in Wollongong. There is no venue cost associated with holding meetings at the Government offices.
