#### Answer-

The NSW Government has committed to increasing Community Transport Program funding by \$12 million over four years, to provide people with special transport needs with access to vital services. This represents a 100 per cent funding increase over the period, and is the first boost to the program since 1998.

Transport for NSW administers funding for 122 community transport organisations, which provide around 1.4 million trips annually under the Community Transport Program and the Home and Community Care Transport Sub-Program.
