What was the number of student enrolments at Glendale TAFE in each of the school years from 2011 to 2015 (including the beginning of Semester One, 2015)?

*0972 UNIVERSITY OF NEWCASTLE—Ms Sonia Hornery asked the Minister for Transport and Infrastructure—

(1) Is the Government taking steps to improve public transport options for students and staff at the University of Newcastle?

(a) If so, what action is the Government taking to ease traffic congestion, improve transport times and ensure reliability of public transport at the University of Newcastle?

(b) If no action is being taken, why is this the case?

Answer—

I am advised:

The Government is committed to improving public transport in Newcastle and the Hunter region. The Government will deliver a modern and accessible transport interchange at Wickham and introduce light rail to Newcastle. Light rail will form part of an integrated transport solution for Newcastle.

Wickham Transport Interchange will enable customers to easily connect with trains, light rail, regional buses, taxis and cars.

Light rail will improve connections between the city centre and the waterfront, and better connect residents and visitors to Newcastle's beaches.

Planning and design of the light rail will consider the University's proposed new campus in the Civic precinct. Consultation on light rail is expected to occur later this year.

*0973 HUNTER NEW ENGLAND LOCAL HEALTH DISTRICT—Ms Sonia Hornery asked the Minister for Health—

How is money received from parking fees at hospitals in the Hunter New England Local Health District spent, considering the number of new parking facilities is expected to rise in the near future?

Answer—

I am advised:

The revenue raised from parking fees in the Hunter New England Local Health District is reinvested into frontline clinical services.

*0974 SHAKTI PROPOSAL—Ms Jodie Harrison asked the Minister for Mental Health, Minister for Medical Research, Assistant Minister for Health, Minister for Women, and Minister for the Prevention of Domestic Violence and Sexual Assault—

(1) Has the Minister received a copy of the Shakti proposal for a specialist domestic violence intervention service package for Asian, African, and Middle Eastern women and children in New South Wales?

(a) Has the Minister provided a response to the proposal?

(b) Will the Minister be supporting this proposal?

Answer—

I am advised:

Representatives from my office, Minister Hazzard's office and Minister Ajaka's office have met with Shakti.

*0975 JOHN HUNTER HOSPITAL SHUTTLE BUS—Ms Jodie Harrison asked the Minister for Health—

- (1) What was the annual cost of the John Hunter Hospital shuttle bus service from Hunter Stadium for the 2013-14 and 2014-15 financial years?
- (2) What arrangements will be put in place to assist visitors with mobility issues who will have to park a great distance from the entrance once this shuttle bus service ceases?

Answer—

I am advised:

- (1) and (2) I refer you to LA QoN 783.

*0976 PERCENTAGE OF LOCAL CONTENT—Ms Jodie Harrison asked the Minister for Transport and Infrastructure representing the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

- (1) What percentage of local content was included in the recently completed Hunter Expressway?
- (2) What percentage of local content has been included in projects funded by the Hunter Infrastructure and Investment Fund?
- (3) What percentage of local content was included in the Wyong to Newcastle Freight Rail Development?

Answer—

I am advised:

- (1) Procurement of goods and services is undertaken in line with NSW Government procurement guidelines. Australian-based companies are given every opportunity to tender for Government contracts through a fair and transparent process. Roads and Maritime Services has processes in place to encourage competitive tendering to get the best value for money for the people of New South Wales while creating opportunities for local suppliers.

Roads and Maritime encourages its suppliers to source materials locally where possible.

- (2) This is a matter for the Treasurer.
- (3) No construction work has been undertaken as part of the Wyong to Newcastle Coal Rail Enhancement Program. As such, the percentage of local content is not available.

*0977 PENSIONER EXCURSION TICKETS—Ms Julia Finn asked the Minister for Transport and Infrastructure—

- (1) How many pensioner excursion tickets were sold at railway stations in the Granville electorate in the 2013-14 and 2014-15 financial years?
- (2) How many pensioner excursion tickets were sold on buses in the Granville electorate in the 2013-14 and 2014-15 financial years?
- (3) How many pensioner excursion tickets were sold by retailers in the Granville electorate in the 2013-14 and 2014-15 financial years?

Answer—

I am advised:

- (1) In the 2013-14 financial year, 562,886 Pensioner Excursion Tickets (PETs) were sold at train stations in the Granville electorate. In the 2014-15 financial year, 446,247 PETs were sold at train stations in the Granville electorate.
- (2) This data is not available.
- (3) In the 2013-14 financial year, 80,015 Pensioner Excursion Tickets (PETs) were sold by resellers in the Granville electorate. In the 2014-15 financial year, 103,840 PETs were sold by resellers in the Granville electorate.

*0978 SENIORS CARDS—Ms Julia Finn asked the Minister for Finance, Services and Property—

- (1) How many Seniors Cards have been issued to residents of the Granville electorate?
- (2) What is the average monthly number of new applications for Seniors Cards from residents of the Granville electorate for the period 12 August 2014 to 12 August 2015?

Answer—

This matter is the responsibility of the Minister for Ageing and Minister for Disability Services.

- *0980 PROCUREMENT OF AUSTRALIAN STEEL—Mr Ryan Park asked the Minister for Finance, Services and Property—

- (1) Will the Minister establish a mandatory percentage of Australian steel to be used in New South Wales infrastructure projects?

- (a) If so, what would that percentage be?
(b) If not, why not?

Answer—

NSW Government procurement is bound by free trade rules.

While there are exemptions permitting policies to promote local small and medium enterprises in current free trade agreements, any proposal to mandate the use of Australian made steel could have only limited application to largescale infrastructure projects.

A law requiring the use of Australian made steel on all Government infrastructure projects would breach the terms of those free trade agreements, which would allow other countries to place tariffs on Australian exports. In many cases, the markets our exporters gain access to through free trade agreements are much larger than what is available in Australia.

For example, the Australian-United States Free Trade Agreement gives Australian exporters the opportunity to supply to the US federal government, which spends at least US\$535 billion annually, an amount approximately 50 times the size of the NSW Government's expenditure. Therefore a proposal to mandate the use of Australian made steel on infrastructure projects may end up hurting a lot more NSW businesses and NSW jobs than it would ever protect.

It should be noted that over the past three years, the NSW Government has paid approximately \$26 billion to 97,000 suppliers for goods and services in the construction and facilities maintenance industry. Of the \$26 billion, NSW-based businesses were paid \$17.2 billion, which equated to 68 percent of these payments. Virtually all of the remainder is paid to businesses based in the other Australian states and territories.

- *0981 CLEANING OF TRAINS—Mr Ryan Park asked the Minister for Transport and Infrastructure—

- (1) How often is each train carriage cleaned (on average)?
(2) How often are the windows on train carriages cleaned (on average)?

Answer—

I am advised:

- (1) All Sydney Trains and NSW Trains carriage interiors are cleaned daily.
(2) Sydney Trains carriage windows are washed externally once a fortnight. They are washed internally twice per week or daily if required. There is also a monthly internal deep clean on all Sydney Trains carriage interiors which includes the windows. NSW Trains carriage windows are cleaned internally daily.

- *0982 CHINA NORTH RAILWAY—Mr Ryan Park asked the Minister for Transport and Infrastructure—

- (1) Was the Minister aware of the recent disqualification of China North Railway from the Israel Railways locomotives tender?
(2) Does the disqualification of China North Railway have any impact on the current Intercity Trains tender?
(a) If so, what is the impact?

Answer—

I am advised:

Transport for NSW procurement is undertaken in line with NSW Government procurement guidelines.

- *0983 MAITLAND HOSPITAL—Mr Clayton Barr asked the Minister for Health—

- (1) What medical services are currently offered at the Maitland Hospital as core to the hospital functions?

- (2) What medical services are operated at the Maitland Hospital as supplementary and additional to the core hospital functions?
 (a) Is there a plan to move any of these additional services to an off-site location?
 (i) If so, which ones and when?
- (3) Is there a plan to move any new services onto the Maitland Hospital site to support the core functions of the hospital?
- (4) How many 'beds' are on the Maitland Hospital site?
 (a) What is the breakdown of each category of 'beds'?

Answer—

I am advised:

(1) to (4) Maitland Hospital provides a range of hospital functions including:

- Medical
- Rehabilitation
- Surgical
- Mental health
- Dental
- Renal
- Maternity and child services
- Coronary care/high dependency unit
- 24-hour emergency department.

*0984 TRAIN SUPPORT FACILITY AT HEXHAM—Mr Clayton Barr asked the Minister for Planning—

With reference to the Train Support Facility at Hexham that has been constructed jointly by Aurizon and ARTC:

- (1) Has a development contribution been paid to the Government and/or Newcastle Council?
 (a) If so, what quantum has been paid to each?
- (2) What projects or works have been identified as being directly linked to any such development contributions?
- (3) In the event that unexpected or unintended consequences arise from these projects, does the Government or Newcastle City Council have any capacity to call back either developer to make good on the impact that they have caused?
 (a) If so, what time limits apply to this ability?

Answer—

I am advised that the Train Support Facility at Hexham is being constructed by Aurizon.

With respect to the specific questions asked, I am advised that no development contribution was required to be paid to the NSW Government, and that Aurizon is required to operate in accordance with the conditions of the development approval. In the event that any potential breaches of these conditions are identified, the Department of Planning and Environment will investigate these matters and undertake any relevant compliance action.

*0985 LOWER HUNTER HOSPITAL AT METFORD—Mr Clayton Barr asked the Minister for Health—

With reference to the proposed new Lower Hunter Hospital at Metford:

- (1) What services which are not currently available at Maitland Hospital will be provided?
 (2) What current services at Maitland Hospital will be retained?
 (3) What currently available services at Maitland Hospital will be made unavailable?

Answer—

Hunter New England Local Health District has advised that the new Maitland Hospital will continue to work alongside John Hunter Hospital as part of the broader clinical service network, which is the case with the current Maitland Hospital.

*0986 NEW LOWER HUNTER HOSPITAL AT METFORD—Mr Clayton Barr asked the Minister for Health—

With reference to the proposed site of the new Lower Hunter Hospital at Metford:

- (1) During the Hunter storms of 20-23 April 2015, was the chosen site still accessible by road?
 - (a) If so, which road/s leading to the hospital were not, at any time during this storm event, cut, shut or blocked?
- (2) What roads that would typically be used to access this hospital site were cut, shut or blocked during the April 2015 storm event for either short or extended periods?
- (3) Is the new site located within the controlled airspace of Williamtown RAAF Base?
 - (a) If so, will this have an impact on the ability of emergency helicopter flights to enter or depart the hospital?

Answer—

I am advised:

(1) and (2) The Metford Road site of the New Maitland Hospital was accessible by road during the April 2015 storms.

(3) A specialist Helicopter Consultant, engaged throughout the planning of the New Maitland Hospital Development, has advised that the site is not located within the controlled airspace of Williamtown RAAF Base.

*0987 STAFFING IN EMERGENCY DEPARTMENTS ON PUBLIC HOLIDAYS—Mr Clayton Barr asked the Minister for Health—

With reference to staffing in emergency departments on public holidays:

- (1) As a general rule, are more staff rostered to work on a public holiday than on an ordinary work day?
- (2) As a general rule, at Cessnock District Hospital Emergency Department, are more staff rostered to work on a public holiday than on an ordinary work day?
- (3) If a rostered member of the Emergency Department medical staff is unable to attend his or her shift on a public holiday, are arrangements made to have that shift filled by an on-call staff member?
 - (a) If so, is the vacancy filled for the entire and full shift, or is it filled for a shorter period of several hours for the busy times?

Answer—

I am advised:

(1) to (3) Staffing in Emergency Departments is determined by the Public Health System Nurses' and Midwives' (State) Award emergency department staffing arrangements and by nursing managements' assessment of staffing requirements based on a range of factors including patient safety and clinical needs.

*0990 CESSNOCK AND KURRI KURRI TAFE—Mr Clayton Barr asked the Minister for Regional Development, Minister for Skills, and Minister for Small Business—

- (1) With reference to the answer provided for LA Q.0672, it appears that the website provided in the answer does not make any reference to the information sought; can the Minister provide the direct web link where information can be accessed for the following:
 - (a) When student enrolments by campus ceased being published and why?
 - (b) Why is this information now considered 'commercial in confidence'?
 - (c) Has the Minister taken advice as to whether or not the 'commercial in confidence' decision contravenes the Government Information Public Access Act?
 - (d) How many Full-Time Equivalent (FTE) staff positions currently exist at the Cessnock and Kurri Kurri TAFE campuses?
 - (e) What is the total 2015 calendar year budget for the Cessnock and Kurri Kurri TAFE campuses?
- (2) If information is not available on the website, can the Minister provide the answers to 1(a) to 1(e)?

(1) (a) Information on student enrolments by campus by campus is not published on the internet. TAFE NSW has not consistently published this information. TAFE NSW now operates in a competitive environment.

*0991 SEPTIC PUMP-OUT SUBSIDY—Ms Trish Doyle asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—

(1) Will the payment of the septic pump-out subsidy remain in place and linked to the title of the relevant and respective properties in the Blue Mountains at least until:

- (a) Residents have been connected to mains sewage infrastructure; or
- (b) Residents have installed an onsite wastewater management system?

Answer—

There are no plans to withdraw the subsidy at this time.

*0992 SEWERAGE INFRASTRUCTURE—Ms Trish Doyle asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—

Will the Government honour its commitment dating back to the Liberal Government of former Premier Nick Greiner to connect remaining households in the Blue Mountains to mains sewerage infrastructure?

Answer—

As a Government, it is important that a fair and equitable approach is applied to services across Sydney Water's area of operations and there is prudent and efficient expenditure of taxpayers' funds.

As such, this Government has asked that Sydney Water continue to monitor advancements in technologies that would enable a financially viable permanent solution to be implemented for those who remain on pump out systems.

*0993 ADMINISTRATION OF THE SEWERAGE PUMP-OUT SUBSIDY—Ms Trish Doyle asked the Minister for Industry, Resources and Energy representing the Minister for Primary Industries, and Minister for Lands and Water—

- (1) How will the sewerage pump-out subsidy be administered?
- (2) Will the sewerage pump-out subsidy be paid directly to the service contractor/s?
- (3) Will annual Sydney Water increases be consistent with sewerage charges for the greater Sydney Water customer base?
- (4) Will Sydney Water liaise and consult with impacted residents and Blue Mountains City Council?

Answer—

(1) Customers send their private pump-out invoices to Sydney Water four times a year. In the June quarter, Sydney Water takes off the annual sewer service charge and credits the customer with the balance. Each subsequent quarter the customer receives the full invoice amounts back as a credit.

(2) Service contractors receive payment from their customers at the time the service is pumped-out. Sydney Water nor the NSW Government are privy to the details of private contracts between customers and their respective service providers.

(3) The pump-out customers pay the same as other Sydney Water sewer customers. The sewer price is determined by The Independent Pricing and Regulatory Tribunal (IPART) and could increase or decrease.

(4) Yes.
