\*4256 INNER CITY SOCIAL HOUSING ALLOCATION—Mr Alex Greenwich asked the Minister for Family and Community Services, and Minister for Women—

With regard to the social housing allocations in Millers Point, Dawes Point and The Rocks:

- (1) Is Housing NSW not allocating empty homes in this precinct, including homes that are in letting condition?
- (2) What assessment has the Government given to providing homes that are in letting condition to those on the waiting list such as:
  - (a) temporary accommodation for homeless people;
  - (b) emergency accommodation for those at risk in their current home;
  - (c) rehousing local tenants whose homes are unsafe and need major repairs?
- (3) What action will the Government take to increase the effective use of vacant properties and allow current tenants to remain in this precinct?

Answer—

See response to LA Question 4206.

\*4257 NEEDLE AND SYRINGE PROGRAMS IN PRISONS—Mr Alex Greenwich asked the Attorney General, and Minister for Justice—

Noting that the rate of infectious blood borne diseases of Australian prisoners is several times higher than the general population and the 2009 Health Inmate Survey found that 43 per cent of prisoners had used illicit drugs and nearly all those who injected reported sharing needles:

- (1) What progress has the Government made on considering a trial of a needle and syringe program in prisons?
- (2) What plans does the Government have to provide needle and syringe programs in prisons?

Answer-

I am advised:

The Government has no plans to trial a needle and syringe exchange program in correctional centres. Corrective Services NSW (CSNSW) however, continues to provide a comprehensive and multi-faceted strategy to reduce the risk of transmission of communicable diseases in New South Wales correctional centres. CSNSW will monitor the outcomes from the planned trial of a needle and syringe program in the Alexander Maconochie Centre in the Australian Capital Territory.

\*4258 BANKSTOWN ELECTORATE PUBLIC HOUSING—Ms Tania Mihailuk asked the Minister for Family and Community Services, and Minister for Women—

What is the breakdown of public housing dwellings by number of:

- (a) bed sitters:
- (b) units (with bedroom composition);
- (c) duplexes;
- (d) villas;
- (e) free-standing houses?

Answer-

Responsibility for the Land and Housing Corporation has been transferred to the Family and Community Services portfolio.

- 1. Refer to previously published answer to LA Question 4146.
- 2. Over 50 per cent of social housing properties in the Bankstown allocation zone are cottages, villas and townhouses, and the balance are units.
- \*4259 REGIONAL RELOCATION GRANT—Ms Tania Mihailuk asked the Minister for Finance and Services—

Since the Regional Relocation Grant was established, how many people have taken up the grant from:

- (a) Metropolitan Sydney;
- (b) Newcastle;

- (c) Wollongong;
- (d) The Electorate of Bankstown?

#### Answer—

Between 1 July 2011 and 31 July 2013 the number of regional relocation grants provided was:

- (1) 1715.
- (2) 294.
- (3) 216.
- (4) 67. This data is based on the local government area, not electorate, which is consistent with the Office of State Revenue reporting on the Regional Relocation Grant scheme.
- \*4260 HOUSING NSW MAINTENANCE—Ms Tania Mihailuk asked the Minister for Family and Community Services, and Minister for Women—

Over the past 6 months, how many outstanding Housing NSW maintenance issues have there been in the Bankstown Electorate?

#### Answer-

Responsibility for the Land and Housing Corporation has been transferred to the Family and Community Services portfolio.

Timeframes for responsive repairs vary depending on the urgency of the matter.

Approximately 90% of works orders issued are completed within these timeframes, with the balance being resolved shortly after. Delays may be a result of property access issues and unforseen site conditions.

\*4261 LOCAL INFRASTRUCTURE RENEWAL SCHEME—Mr Clayton Barr asked the Minister for Local Government, and Minister for the North Coast—

With regard to the Local Infrastructure Renewal Scheme (LIRS):

- (1) When did the LIRS begin?
- (2) What is the annual funding budget?
- (3) Since April 2011, what funding has been provided to the:
  - (a) Cessnock City Council;
  - (b) Lake Macquarie City Council;
  - (c) Newcastle City Council;
  - (d) Singleton Council?

#### Answer—

- (1) The Local Infrastructure Renewal Scheme (LIRS) first opened applications in January 2012.
- (2) For detailed information on the annual LIRS budget, please refer to the Budget papers.
- (3) For an up to date list of all funded projects, please refer to the "Local Infrastructure Renewal Scheme" page on Division of Local Government's website at www.dlg.nsw.gov.au.
- \*4262 NSW NOW: WELCOME TO THE NEW STATE OF BUSINESS CAMPAIGN—Mr Clayton Barr asked the Premier, and Minister for Western Sydney—

With regard to the 'NSW NOW: Welcome to the new state of business' campaign:

- (1) What businesses is the campaign being aimed at?
- (2) Are there incentives being offered to entice businesses to NSW?
  - (a) If so, will these incentives be available to existing businesses?
- (3) What is being done to retain businesses in NSW who are offered opportunities interstate and overseas?
- (4) Are you aware that previous decisions, such as the removal of the cellar door subsidy, led directly to the interstate move of Cellar Masters from Sydney to South Australia, costing 300 NSW jobs?

#### Answer\_

- (1) I refer you to my answer to the House on 25 March 2013.
- (2) NSW Trade & Investment offers a range of services to businesses including advisory and facilitation support for establishing or expanding business operations in New South Wales.

In select circumstances, NSW Trade & Investment will consider financial support to businesses looking to establish or expand operations in New South Wales via the State Investment Attraction

Scheme; and, where the business is establishing or expanding into regional New South Wales, through the Regional Industries Investment Fund.

Further financial support is available to businesses liable for payroll tax that employ new staff in New South Wales through the Jobs Action Plan.

- (3) NSW Trade & Investment works closely with businesses across the State to build their capability and productivity as well as working to remove barriers to business growth. Through advisory and facilitation services, as well as selective financial support, the Government seeks to retain and grow the number of businesses and jobs in the state.
  - The Government also actively seeks trade and investment opportunities for New South Wales companies in international markets through our Investment & Export Services team in NSW Trade & Investment. These opportunities can help New South Wales businesses become more internationally competitive, sustainable and successful.
- (4) No. However the Government supports regional tourism and employment in the Hunter by providing funding of \$420,000 for 10 projects under the Regional Tourism Product Development Program.
  - This program is designed to develop tourism experiences in the Hunter and help support Tourism Hunter, the regional tourism organisation. The Government is also providing \$21.6 million over the next three years through the Regional Visitor Economy Fund to help promote regional tourism.
- \*4263 LEGAL ASSISTANCE FOR CHILDREN AND PEOPLE WITH DISABILITIES—Mr Guy Zangari asked the Attorney General, and Minister for Justice—

How will the Government help children and people with disabilities to secure legal assistance in compensation matters in light of funding cuts to Legal Aid NSW?

Answer-

I am advised:

Legal Aid NSW provides free advice and minor assistance services to assist children and people with disabilities in compensation matters. These services, which are not means tested, are available at Legal Aid NSW offices and at over 114 civil law outreach locations across New South Wales.

Young people and people with disabilities can also access the services provided by LawAccess NSW, Legal Aid NSW and the Law Society of NSW to obtain referrals to private solicitors who act on the basis of conditional costs agreements in civil claims for compensation.

The introduction of the Victims Services Scheme (VSS) has simplified the system for support and payments to victims of crime. Accordingly, victims of crime do not require legal assistance to make a claim for a recognition payment under the VSS. However the Victims Access Line, Community Legal Centres or LawAccess NSW can provide guidance or information on making a claim.

- \*4264 CYCLISTS ROAD SAFETY—Ms Linda Burney asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
  - (1) What are the current statistics for prosecution/enforcement for motorists who do not overtake safely, and do not leave enough space when overtaking a bicycle rider?
  - (2) How do current statistics compare with the previous year?

Answer-

The NSW Police Force has advised me that there are no offences that specifically relate to the driver of a motor vehicle compromising the safety of, or colliding with, a bicycle rider. It is therefore not possible to provide a response in the terms requested.

\*4265 DEPARTMENT OF HOUSING MODIFICATIONS—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—

How many public housing properties in the Hunter Region have modifications for people with mobility problems?

Answer-

Responsibility for the Land and Housing Corporation has been transferred to the Family and Community Services portfolio.

The Corporation is currently undertaking an assessment of all public housing properties in the Hunter region. Approximately one third of those properties surveyed to date have been noted as being modified for people with a disability.

\*4266 PUBLIC HOUSING SHORTFALL—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—

How does the Government plan to address the Auditor-General's estimate of a shortfall of 20,000 public housing properties in the Lower Hunter by 2021?

Answer-

The former Government left New South Wales with an unsustainable public housing system. Since coming to government, this Government has started real reforms to improve services and lives.

The Government has:

- · Introduced new incentives to fill vacant bedrooms in public housing:
- · Published and made the waiting list for social housing transparent;
- · Cracked down on tenants not declaring additional occupants in their taxpayer funded homes; and
- · Ended the previous Government's policy of allowing households to inherit public housing tenancies which entrenched intergenerational welfare dependency.
- \*4267 GIPA APPLICATION BACKLOG—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
  - (1) In the last 12 months, what percentage of applicants under the Government Information (Public Access) Act 2009 (GIPA) have had their payment refunded because the decision of the NSW Police Force was not within 20 working days as stipulated by the act?
  - (2) Is there an approximate 12 month backlog on GIPA requests within the NSW Police Force Information Access Unit & Subpoena Unit?
    - (a) If so, what are the reasons that led to this backlog?
    - (b) If so, what is the Minister doing to rectify this problem?

Answer-

I am advised:

Detailed statistical information on handling of GIPA applications, including the timeliness of decisions, is contained in the NSW Police Force Annual Report.

- \*4268 UNMANNED RAILWAY STATIONS—Ms Sonia Hornery asked the Minister for Transport—
  - (1) Which railway stations in New South Wales are unmanned for part of the day?
  - (2) How long are these stations unmanned?

Answer—

I am advised:

Information about station facilities is provided on the NSW and Sydney Trains websites.

- \*4269 REVIEW OF COUNSELLING SERVICES—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
  - (1) Is there a review of generalist health services within Hunter New England Area Health Service?
    - (a) If so, is there a review of counselling services?
    - (b) If so, are there any plans to reduce counselling services currently operating from Wallsend Community Health Centre or from any other Community Health Centre?

Answer-

Hunter New England Local Health District is undertaking a review of counselling services, relating to services and positions, where general counselling is the focus of the role, to ensure the Local Health District is using its Generalist Counselling Service resources as efficiently and as effectively as possible.

The review is still underway and is expected to be completed by the end of December 2013.

The findings from the review, when completed, will be assessed by the Local Health District. Any recommendations arising from the review that will impact current services, including staff, will be the subject of consultation with affected staff and the Health Services Union.

\*4270 SUNFLOWER CENTRE COMMUNITY DEVELOPMENT PROGRAM—Ms Sonia Hornery asked the Minister for Mental Health, Minister for Healthy Lifestyles, and Minister for Western New South Wales—

Why did the Newcastle based Sunflower Centre not have its Community Development Program grant rolled over following the closure of NSW Health's NGO Grant Program in July 2013?

Answer-

I am advised:

For internal reasons within the Schizophrenia Fellowship, NSW Health did not receive a 2013-14 Grant Application on this matter.

The Chief Executive of Schizophrenia Fellowship recently met with the Director of Mental Health and Drug and Alcohol Programs in the Ministry of Health.

As indicated at the 2013 Estimates Hearing for Mental Health on 12 August 2013, this matter is now being resolved.

The NSW Health NGO Grant Program has not closed. The Program is transitioning to a new contestable and transparent approach under the Partnerships for Health program.

\*4271 FISHERIES NEW SOUTH WALES STAKEHOLDER COMMENT—Ms Sonia Hornery asked the Minister for Primary Industries, and Minister for Small Business—

In the recently released discussion paper 'Review of NSW recreational saltwater and freshwater fishing rules', the following statement is included on page 1 of the submission form:

"Fisheries NSW is interested in the quality, type and nature of stakeholder comments not just the number of submissions expressing a particular view on an issue."

- (1) What criteria does Fisheries NSW use to classify the quality of a stakeholder comment?
- (2) Does Fisheries NSW take into account the quantity of submissions expressing a view as well as the quality of submissions when reviewing stakeholder comments?

Answer-

- (1) Quality of the comment relates to the clarity of the comment and the detail supporting the position taken. It is relative to the question.
- (2) Yes. Both quantity and quality provide information into the issue and the position held by those making the submission.
- \*4272 COAL DUST ANALYSIS—Ms Sonia Hornery asked the Minister for the Environment, and Minister for Heritage—

Has the Environmental Protection Agency contracted a statistical expert to re-analyse the data collected by the Australia Rail and Track Corporation in regards to coal dust levels from freight trains in the Hunter Region, as the original analysis of the data was found to be flawed?

(a) If not, why not?

Answer-

I am advised as follows:

The Environment and Protection Authority (EPA) has engaged Professor Louise Ryan from the School of Mathematical Sciences at the University of Technology Sydney to undertake a thorough analysis, and if required, a re-analysis of ARTC's data.

- \*4273 CHILDREN AT RISK OF ABUSE—Ms Sonia Hornery asked the Minister for Family and Community Services, and Minister for Women—
  - (1) In 2012, how many children in the Hunter Region were reported to the Department of Community Services as being at serious risk of abuse?
  - (2) Of those children reported, how many were visited by a government caseworker?

Answer\_

Data concerning Risk of Significant Harm reports is published in Community Services' Annual Statistical

Reports.

\*4274 COMMUNITY DEVELOPMENT LEVIES—Mr Paul Lynch asked the Treasurer, and Minister for Industrial Relations—

How much, and in respect of which developments, have community development levies, been paid by Local Aboriginal Land Councils from 1 April 2011 to date?

Answer—

This question would be more appropriately directed to the Minister for Finance and Services.

- \*4275 HOXTON PARK BP SERVICE STATION—Mr Paul Lynch asked the Minister for Finance and Services—
  - (1) How often has Workcover inspected the BP Service Station on Hoxton Park Road, Liverpool since 1 January 2013?
  - (2) Has the Improvement Notice issued by Workcover for this site, with an expiry date of 10 June 2013, been complied with?
    - (a) If not, why not?
  - (3) What prosecutions, if any, resulted from earlier fires and explosions on this site?
    - (a) If there were no prosecutions, why not?

Answer-

- (1) I am advised WorkCover has been monitoring the BP service station on Hoxton Park Road, Liverpool since August 2012 and has visited the site five times since 1 January 2013, with the most recent event taking place on 12 September 2013.
- (2) I am advised that it has been complied with.
  - (a) N/A
- (3) The investigation into the explosion and ensuing fire has been completed and the report sent to the Coroner on 10 July 2013. No decision regarding prosecution has been made as yet, with the matter scheduled for hearing by the Coroner on 1 November 2013.
  - (a) N/A
- \*4276 FIRE STATION CLOSURES—Mr Paul Lynch asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Since 1 July 2013 on which dates and for how long have the following been closed:

- (1) Macquarie Fields Fire Station;
- (2) Cabramatta Fire Station;
- (3) Liverpool Fire Station?

Answer-

Fire & Rescue NSW has advised me:

Fire & Rescue NSW firefighters and fire engines are mobile resources, operating 24 hours a day, seven days a week.

The practice of taking fire stations offline temporarily has a minimal impact on the response times or fire services to the community and are no different to arrangements that have been standard practice for over 100 years.

\*4277 FIRE STATION CLOSURES—Mr Paul Lynch asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

- (a) Busby Fire Station;

Answer-

Fire & Rescue NSW has advised me:

Fire & Rescue NSW firefighters and fire engines are mobile resources, operating 24 hours a day, seven

days a week.

The practice of taking fire stations offline temporarily has a minimal impact on the response times or fire services to the community and are no different to arrangements that have been standard practice for over 100 years.

### \*4278 TEACHERS AIDES—Mr Paul Lynch asked the Minister for Education—

- (1) What financial allocattion is made to the Liverpool electorate for teachers' aides in Government schools?
- (2) Has this allocation decreased or increased in the last three financial years?
- (3) Does the Government have a policy of using parental volunteers rather than employing teachers' aides in schools in New South Wales or in the Liverpool electorate?
- (4) If so, how much money was not spent in the last financial year in the Liverpool electorate by using parental volunteers rather than employing teachers' aides?

#### Answer-

- (1) For the 2012-13 financial year more than \$1.5 million was allocated to schools in the Liverpool electorate to support students with disability and additional learning and support needs. Principals are responsible for determining the most appropriate ways of using the funding which can be used flexibly to support students with additional teacher and/or school learning support officer (formerly teachers aide) time. Funding is not exclusively used to employ school learning support officers.
- (2) The funding allocated for the 2012-13 financial year increased by more than 60% from the 2010-11 financial year.
- (3) The Government does not have a policy of using parent volunteers rather than employing school learning support officers in the Liverpool electorate or any public school in New South Wales.
- (4) Not applicable.

### \*4279 FUNDING FOR TRAINING—Mr Paul Lynch asked the Minister for Education—

- (1) Have State Government grants or funding been paid to the following entities since 1 July 2011:
  - (a) Precision Training Australia;
  - (b) Insight Training Group;
  - (c) Precision Industries and Employment?
- (2) If so, how much and in what periods?

#### Answer-

State government grants of funding to these entities for 1 July 2011 to 30 June 2012 is documented in the 2012 Department of Education and Communities' Annual report, pages 187-8.

Funding for 2012-13 will be released in the 2013 Department of Education and Communities' Annual report.

\*4280 SHARED CELLS IN CORRECTIONAL FACILITIES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

How many inmates in correctional facilities shared cells with another inmate or inmates as at:

- (a) 1 January 2013;
- (b) 1 July 2013;
- (c) 1 August 2013?

## Answer—

I am advised:

Corrective Services NSW does not centrally collate this data. The resources required to manually collate this data could not be justified.

- \*4281 CORRECTIVE SERVICES—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) Has Corrective Services New South Wales completed the future plan, with an outlook of up to 2030?
  - (2) If so,
    - (a) Where may it be viewed;
    - (b) Which facilities are identified for closure if prisoner numbers reduce further?
  - (3) If not, when will it be completed?

Answer-

I am advised:

A strategic assessment of New South Wales correctional centres has been prepared to guide decision making to achieve a structured, well integrated network which is efficient, flexible and focussed on strategic outcomes. The strategic assessment was prepared for Cabinet and, as such, is not publicly available.

\*4282 1 HOXTON PARK ROAD—Mr Paul Lynch asked the Minister for Health, and Minister for Medical Research—

What proposals does the Government have for 1 Hoxton Park Road, Liverpool?

Answer-

I am advised: The Government is in the process of acquiring a parcel of land for strategic health purposes on the site of the old Liverpool City Council Chambers on Hoxton Park Road. The acquisition is expected to be completed in September 2013.

- \*4283 JOBS AT YETTA DHINNAKKAL—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) How many jobs were advertised for positions at Yetta Dhinnakkal in the period 1 December 2010 to 27 March 2011?
  - (2) How many of these positions were filled?
  - (3) How many jobs have been advertised for positions at Yetta Dhinnakkal in the period from 27 March 2011 to 13 August 2013?

Answer-

I am advised:

- (1) 12.
- (1) None.
- (2) 3.
- \*4284 MOTORING OFFENCES DETECTED BY POLICE—Mr Ryan Park asked the Attorney General, and Minister for Justice—

How many cars have been confiscated and forfeited to the Crown in the current financial year?

Answer—

I am advised:

The Department of Attorney General and Justice does not hold this information. This data is not readily available from police information systems and an accurate figure could not be ascertained.

- \*4285 NUMBER OF MOTORING OFFENCES SINCE JULY 2012—Mr Ryan Park asked the Minister for Finance and Services—
  - (1) Since 1 July 2012, how many motorists have been caught exceeding the speed limit by more than 45 kilometres per hour?
  - (2) How many motorists referred to in question (1) have had their number plate confiscated?
  - (3) Since 1 July 2012, how many motorists have been convicted for burnout offences?

Answer—

This question should be referred to the Minister for Police and Emergency Services.

\*4286 CENTRAL STATION AVENUE OF HONOUR—Mr Ryan Park asked the Minister for Transport—

In relation to the 'Avenue of Honour' in rememberance of the service and sacrifice of railwaymen that existed along the western wall of the concourse above platforms 24 and 25 at Central Station:

- (1) When was the 'Avenue of Honour' removed and replaced with commercial advertisements?
- (2) Why was it replaced?
- (3) Who approved the replacement?
- (4) Where are the honour boards now located?
- (5) Will the Minister order that they be reinstated?

Answer-

I am advised:

The honour boards were temporarily removed from the Wall of Remembrance at Central Station and stored at Chullora. This was to allow for a pedestrian ramp to be constructed as part of the Devonshire Street access upgrade.

Commercial advertising was temporarily installed during the construction period.

A conservator has cleaned the boards and these are scheduled to be reinstalled along the concourse by the end of September 2013. The advertising will be removed at that time.

- \*4287 WORKERS COMPENSATION BENEFITS—Mr Richard Amery asked the Treasurer, and Minister for Industrial Relations—
  - (1) Since the introduction of the new workers compensation laws, how many workers in New South Wales have been notified that their workers compensation benefits are to be reduced or removed?
  - (2) How many of these workers reside in the following postcodes:
    - (a) 2770;
    - (b) 2766;
    - (c) 2761?

#### Answer-

- \*4288 CYCLIST FATALITIES AND INJURIES—Mr Jamie Parker asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
  - (1) Regarding cycling fatalities for the calendar year ending 2012 and the 2013 calendar year to date:
    - (a) Of the fatalities that were a result of motorist error, how many of these were subsequently the subject of police investigation?
    - (b) Of the fatalities that were a result of motorist error, how many of these were subsequently charged?
      - (i) What was the nature of the charges?

## Answer—

The NSW Police Force has advised me:

In 2012 there were seven fatal crashes involving cyclists, all of which were investigated, with three motor vehicle drivers identified as at fault. All three drivers were charged accordingly.

In 2013 (as at 22 August 2013) there were twelve fatal crashes involving cyclists, all of which were investigated, with four drivers identified as at fault. Of these, one driver has been charged and three matters are still under investigation.

The drivers in these matters were charged with offences including dangerous driving occasioning death - drive manner dangerous; negligent driving occasioning death; and not give way at lights to oncoming vehicle. One of these matters has so far been finalised at court, with the penalty imposed on the offending driver including an intensive correction order for 9 months, court costs of \$83 and 12 month licence disqualification.

According to the NSW Police Force questions in relation to cycling injuries cannot be answered in the terms requested.

#### Answer-

- (1) NSW Trade & Investment continues to provide support for Aboriginal businesses through a range of programs and services. For example, Aboriginal businesses can access the popular Small Biz Connect program that provides important guidance and support services to SMEs across New South Wales through its network of over 60 business advisors. Small Biz Connect is working with Aboriginal Affairs to increase the awareness of their programs and services to the Aboriginal business community. Small Biz Connect is a Government funded initiative. Furthermore, NSW Trade & Investment staff across the State work with all businesses, including Aboriginal businesses, to help them access targeted financial support programs to deliver jobs growth and business investment including the Jobs Action Plan and the Regional Industries Investment Fund. Staff will also be encouraging businesses to utilise the recently announced Skilled Regional Relocation Incentive, another program providing targeted financial support for businesses, including Aboriginal businesses, in the State.
- (2) The Aboriginal Business Development Manager (ABDM) positions were originally created with assistance from the Commonwealth Government. With the cessation of this support from the Commonwealth, and in light of a constrained fiscal environment where difficult decisions are required to ensure services for all businesses, including Aboriginal businesses, across New South Wales are maintained, the Department has focused resources on delivering services to Aboriginal businesses in New South Wales through its existing network of business development staff, Regional Export Advisors and the Small Biz Connect business advisors. Together these represent a substantial level of expertise that Aboriginal businesses can draw on to help drive employment outcomes and grow their business.
- (3) Both of these positions will continue to service Aboriginal businesses to achieve employment and investment outcomes as part of their roles within the Department. With the integration of the Office of Regional Development with Investment and Export Services we will be looking to these staff to ensure Aboriginal businesses are taking full advantage of the programs and services offered by the Department including opportunities for international expansion and export. We are also working to ensure that the expertise of these staff in working with Aboriginal businesses can be leveraged for job growth and business investment outcomes across the state.
