*0125 GLENDALE TECHNOLOGY HIGH SCHOOL—Ms Sonia Hornery asked the Minister for Education—

Will the Government match the former Government's election promise to provide upgrades to school science laboratories at Glendale Technology High School, Glendale?

Answer-

A project to upgrade the existing science laboratories at Glendale Technology High School is nominated for inclusion in a future capital works program. Funding for this project will be considered in the context of future capital works priorities.

*0126 FUNDING FOR STUDENTS WITH A PHYSICAL OR INTELLECTUAL DISABILITY—Mr Jamie Parker asked the Minister for Education—

- (1) How many students in government schools in the electorate of Balmain are receiving funding support for a physical or intellectual disability?
- (2) How many students in non-government schools in the electorate of Balmain are receiving funding support for a physical or intellectual disability?
- (3) Which schools, both government and non-government, in the electorate of Balmain run special units for students with physical or intellectual disabilities?
- (4) How many students are enrolled in each of these special units?

Answer—

- (1) There are 17 students with confirmed intellectual or physical disabilities in government schools in the electorate of Balmain who receive funding support.
- (2) The Department of Education and Communities does not maintain specific disability data for students enrolled in non-government schools.
- (3) Government schools in the electorate of Balmain which have support units for students with confirmed intellectual or physical disability are: Leichhardt Public School; Sydney Secondary College, Balmain Campus; Sydney Secondary College, Blackwattle Bay Campus; and Sydney Secondary College, Leichhardt Campus.
 - The Department has no equivalent data for non-government schools.
- (4) There are 27 students in the support unit at Leichhardt Public School; 8 students in the support unit at Sydney Secondary College, Balmain Campus; 19 students in the support unit at Sydney Secondary College, Blackwattle Bay Campus; and 26 students in the support unit at Sydney Secondary College, Leichhardt Campus.

The Department has no equivalent data for non-government schools.

*0127 WORK EXPERIENCE FOR STUDENTS WITH A PHYSICAL OR INTELLECTUAL DISABILITY—Mr Jamie Parker asked the Minister for Education—

- (1) In the last three years which State Government workplaces have taken school students with physical or intellectual disabilities from within the electorate of Balmain for work experience?
- (2) How many school students with physical or intellectual disabilities undertook work experience with a State Government department or agency in each of the last three years?

Answer-

- (1) Within the past three years students with a physical or intellectual disability from within the electorate of Balmain have undertaken work experience in the following State Government workplaces the Office of Environment and Heritage, the Department of Transport Sydney Ferries and Royal Prince Alfred Hospital.
- (2) It is not possible to identify the specific numbers of students with a physical or intellectual disability who undertook work experience with a State Government department or agency in the past three years as the Department of Education and Communities does not collect this information.

*0128 FUNDING FOR RESPITE CARE SERVICES—Mr Jamie Parker asked the Minister for Ageing, and Minister for Disability Services—

- (1) What Government funding is provided to services operating in the electorate of Balmain to provide respite care for school students with disabilities?
- (2) What Government funding is provided to services operating in the electorate of Balmain to provide

respite care for post-school adults with disabilities?

Answer-

The Electorate of Balmain includes the Local Government Area of Leichhardt and part of the Local Government Area of Ashfield.

- (1) Ageing, Disability and Home Care (ADHC) funds a total of 21 respite services in the Electorate of Balmain which can be accessed by people with a disability who are of school age. Seventeen of these services are funded through Disability funding at an amount of \$7,010,982. Four additional services are funded through the Home and Community Care (HACC) Program at an amount of \$619,506. The total funding for these services is \$7,630,488.
- (2) ADHC funds a total of 20 respite services in the Electorate of Balmain which can be accessed by people with a disability who are post school adults. Sixteen of these services are funded through Disability funding at an amount of \$6,566,689 and as noted above four of these services are funded through the HACC Program for \$619,506 (as per HACC guidelines these services are currently available to all age groups). The total funding for these services is \$7,186,195.

This review will give the community an opportunity to help shape a new planning system for the State.

*0142 COMPENSATION FOR LOCAL COUNCILS—Ms Sonia Hornery asked the Minister for Transport—

- (1) Will the Government compensate local councils for the extra time and finances that are being consumed for the upkeep of local roads, which in some places are already quite damaged due to these new and increased bus services?
- (2) How will this compensation be distributed?
- (3) How much will the compensation be for each council?

Answer—

I am advised:

- (1) Yes.
- (2) The Transport Administration Act 1988 (the Act) provides for grants to be made to councils to defray the cost of maintaining public roads used by buses in the Sydney, Newcastle, and Wollongong Transport Districts.

The extent of funds distributed is based on the total Bus Weight Tax Collection in the previous financial year.

(3) For the current year (2010-11) \$1,490,700 (which was collected in 2009-10) is being distributed to councils as follows:

*0143 TRUNDLE MULTI PURPOSE SERVICE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

- (1) Is the Minister aware of nursing staff shortages at Trundle Multi Purpose Service (MPS)?
- (2) How many full-time staff are employed at Trundle MPS?
- (3) How many vacancies are there?
- (4) When will these vacancies be advertised or filled?
- (5) Is the position of Permanent Manager of Trundle MPS being advertised or filled?

Answer-

I am advised:

(1) to (4) There are currently 9.8 full-time equivalent nursing staff at the Trundle Multipurpose Service.

At any one time most hospitals operate with a degree of staff vacancies. However, where vacancies exist, temporary qualified staff are employed where required pending recruitment to these positions.

The Trundle Multipurpose Service continues to actively recruit for 4.2 full time equivalent registered nurse positions and 1 full time equivalent enrolled nurse position. The positions were advertised on 7 March 2011, 9 March 2011, 11 April 2011 and 21 April 2011.

- (5) The permanent incumbent is on secondment to Wellington Hospital. A suitably qualified person is currently undertaking this role.
- *0144 SOUTH WESTERN SYDNEY LOCAL HEALTH NETWORK—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) (a) Are there any open access adult ophthalmology outpatient clinics in South Western Sydney Local

Health Network (SWSLHN)?

- (b) If so, where?
- (2) (a) How many patients for cataract surgery are on the waiting list in SWSLHN category 1, 2, 3?
 - (b) What is the average waiting time in each category?

Answer-

I am advised:

- (1) (a) and (b) There are two open access adult ophthalmology outpatient clinics in the South Western Sydney Local Health District. They are located at Bankstown and Liverpool Hospitals.
- (2) The previous NSW Labor Government had a policy to artificially reduce waiting lists.

A special taskforce is currently undertaking an audit of unmet demand and waiting times.

*0145 TOMAREE COMMUNITY HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With respect to Tomaree Community Hospital:

- (1) What is the budget for the 2010-11 financial year?
- (2) Are there plans for radiology and/or dialysis on site at this hospital?

Answer-

I am advised:

- (1) The revised Net Cost of Services budget for Tomaree Community Hospital for 2010-11 is \$3.235 million.
- (2) The Hunter New England Local Health District is currently undertaking a planning exercise of service needs for the Greater Newcastle Region, inclusive of Tomaree Community Hospital.
- *0146 RENAL DIALYSIS—KEMPSEY DISTRICT HOSPITAL—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) How many renal dialysis chairs are available at Kempsey District Hospital?
 - (2) How many patients in the Kempsey area are on home dialysis?
 - (3) How many patients on renal dialysis need to travel to Port Macquarie Hospital?
 - (4) Are there any planned enhancements for renal dialysis at Kempsey Hospital?

Answer-

I am advised:

- (1) Five chairs currently operate each morning Monday to Saturday and evenings on Monday, Wednesday and Friday.
- (2) As of June 2011 there are 10 home dialysis patients in the Kempsey area.
- (3) At present one patient requiring isolation facilities is transported to Port Macquarie Hospital for dialysis.
- (4) The Government is currently undertaking a review of health priorities for capital investment. The specific timing of hospital projects will be announced after the budget process is completed in September 2011.
- *0147 MOUNT DRUITT HOSPITAL EMERGENCY DEPARTMENT—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

In the six months July to December 2010:

- (1) How many children presented to Mount Druitt Emergency Department?
- (2) How many children needing after-hours emergency surgery were transferred from Mount Druitt Hospital to Blacktown for surgery, and then back to Mount Druitt for post-operative care?
- (3) Were any adverse outcomes recorded?

Answer—

I am advised that in the period stipulated in the question:

- (1) 5,633 children presented to the Mount Druitt Hospital Emergency Department.
- (2) 9 children needing after-hours emergency surgery were transferred from Mount Druitt Hospital to Blacktown Hospital Emergency Department. None of these children were transferred back to Mount Druitt Hospital for post-operative care.
- (3) There were no adverse outcomes recorded for any of these children.

*0148 RAYMOND TERRACE HEALTHONE CLINIC—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

What is the status of the construction of the Raymond Terrace HealthOne Clinic?

Answer-

I am advised:

The Government is currently undertaking a review of health capital infrastructure.

The specific timing and scope of hospital projects will be announced after the budget process is completed in September 2011.

*0149 NELSON BAY AMBULANCE STATION—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

What is the status of the construction of the Nelson Bay Ambulance Station?

Answer-

I am advised:

The new station at Nelson Bay has been completed.

*0150 NEW PARENT AND INFANT NETWORK—Ms Clover Moore asked the Minister for Family and Community Services, and Minister for Women—

Noting that Newpin (New Parent and Infant Network) intensive child protection and parent education programs have been working therapeutically for more than 10 years with families under stress to break destructive family behaviour cycles and enhance parent-child relationships:

- (1) What evidence does the Government have about the success of Newpin programs?
- (2) What Newpin services are available for families under stress in the inner city?
- (3) What intensive family support programs does the Government fund for families under stress in the inner city?
- (4) What family support services are available for families under stress in Woolloomooloo, Millers Point, Ultimo and Surry Hills?
- (5) What plans does the Government have to expand intensive family support services for the inner city? Answer—
- (1) Newpin is an early intervention support program run under licence in Australia by Uniting Care Burnside. It aims to increase children's safety, wellbeing and life opportunities by responding to families exhibiting child protection risk factors. Evaluations of Newpin have generally assessed its qualitative impact and identified improved parental confidence and self esteem resulting from the program. However, there is currently insufficient data to determine whether Newpin has led to a measurable improvement in child protection outcomes.
- (2) There are no Newpin services located in the inner city. Newpin based services currently operate in Western Sydney.
- (3) Community Services funds a range of service providers to deliver support to families under stress in the inner city through Brighter Futures, Early Intervention and Placement Prevention Programs and Families NSW Programs as well as Specialist Homelessness Services.
 - In 2010-11, funding of \$140,000 was committed as part of the service system realignment reforms to create two new intensive family support services in the South East Sydney Network. This funding will service families in the City of Sydney Local Government Area (see question 5).
- (4) The following family support services operate in Woolloomooloo, Millers Point, Ultimo and Surry Hills:
 - Walla Mulla Family and Community Support Service is an Aboriginal Specific Service that runs family support projects in the Woolloomooloo area.
 - Barnardo's' Aboriginal Early Years project provides family support services across the inner city.
 - The Factory Community Centre and the Weave Women and Children's Centre are based in Waterloo and provide family support services to families across the inner city.
 - The Lone Parent Family Support Service based in Young Street, adjacent to Millers Point, provides services to families from all over the Inner City.
 - SDN Child and Family Service Pty Limited is the lead organisation contracted to deliver the Brighter Futures program in the Inner City and is based in Alexandria and Redfern.

- The Inner City Youth At Risk Service is a Specialist Homelessness Service that works in collaboration with other inner city services to provide brokerage, housing and intensive case management to homeless teenage parents.
- (5) From 2011-12 the Early Intervention and Placement Prevention program will provide an integrated system of appropriately targeted child, youth and family support services to reduce the likelihood of children and young people entering or remaining in the child protection and out-of-home care systems.

The program will have an annual on-going budget of \$64.2 million to provide an integrated system of appropriately targeted child, youth and family support services to reduce the likelihood of children and young people entering or remaining in the child protection and out-of-home care systems.

Within the South East Sydney and Inner West Networks, which encompass Woolloomooloo, Millers Point, Ultimo and Surry Hills, a total of \$248,000 per annum in new funding is being committed to Intensive Family Support services for 2011-12. This is in addition to over \$400,000 per annum in existing funds being realigned to Intensive Family Support Services and over \$60,000 per annum in existing funds to Intensive Family Preservation services in the same locations. The new services will be open and accepting referrals from 1 July 2011.

*0151 ULTIMO/PYRMONT BUSES—Ms Clover Moore asked the Minister for Transport—

With respect to bus services for Ultimo and Pyrmont precincts, and noting that the residential population at the 2006 Census was 16,500 compared to the 2023 estimate of 13,500 under the Ultimo-Pyrmont Plan:

- (1) What needs assessment has the Government carried out about bus services for Ultimo and Pyrmont since the Region 6 Bus Review?
- (2) What data has the State Transit Authority used to estimate need for bus services in this precinct?
- (3) What increased bus services have been provided over the past five years?
- (4) What plans does the Government have to extend and expand bus services to these precincts?

Answer-

I am advised:

- (1) The Region 6 bus network review was implemented in March 2010. The Department of Transport will be conducting a follow up review during 2011-12.
- (2) The Department of Transport uses actual and forecast demand data as well as customer feedback and operational performance statistics in determining service requirements. This includes passenger boarding and service reliability data; customer feedback, including from community consultation; information on emerging trends including land use developments, and community travel patterns.
- (3) There has been no change in bus services provided in Ultimo and Pyrmont over the past five years.
- (4) This will be considered in the 2011-12 Region 6 timetable review.

*0152 ADULT COMMUNITY EDUCATION—Ms Clover Moore asked the Minister for Education—

Noting that Adult Community Education (ACE) provides second chance education opportunities, engages with alienated learners and has strong social inclusion outcomes:

- (1) What funds has the NSW Government provide for ACE over the past five years?
- (2) How many people in NSW have attended ACE programs and how many hours of tuition were provided over the past five years?
- (3) How many people have attended ACE programs in the Sydney electorate and how many hours of tuition in this electorate were provided over the past five years?
- (4) How does overall NSW Government funding for ACE compare with Victorian Government funding?
- (5) How does NSW Government per capita funding for ACE compare with Victorian Government per capita funding?
- (6) What additional funds do NSW ACE providers harness from business, community and other sources to provide ACE programs?
- (7) What plans does the Government have to expand funding and support for ACE?
- (8) What plans does the Government have to expand funding and support for ACE in the Sydney electorate?

Answer-

- (1) Approximately \$109 million from 2006 to 2010.
- (2) Around 578,000 people have undertaken 35 million hours of training over the five-year period.
- (3) Over 52,000 people have undertaken 1.5 million hours of training in Sydney electorate from 2006 to 2010.

- (4) In the 2009-10 financial year, the NSW Government provided \$33 million to ACE colleges, while the Victorian Government provided \$58 million. The difference is largely due to ACE colleges in Victoria delivering more vocational education and training than ACE colleges in New South Wales.
- (5) NSW Government per capita funding in 2010 is estimated to be approximately \$600 to \$700 per student. Comparable Victorian data are not available on a calendar year basis.
- (6) The latest data show NSW ACE colleges accessed an additional \$52.4 million from business, community and other sources in 2009.
- (7) The NSW Government will consider funding for the ACE sector as part of the process for the 2011-12 State Budget.
- (8) Future funding for ACE colleges in the Sydney electorate will reflect decisions made in the 2011-12 State Budget.

*0153 ADULT LITERACY—Ms Clover Moore asked the Minister for Education—

Noting the recent assessment of international adult literacy policies by the Irish National Adult Literacy Agency showing the success of jurisdictions where there is a "culture of adult learning by removing barriers to learning", and Australian data that 40% of employed and 60% of unemployed people were found to have had poor or very poor literacy and numeracy skills:

- (1) Is the Government aware of the criticism of Australia's poor progress with adult literacy?
- (2) What assessment has the Government made of the findings of this review of the impact of literacy policies and programs, including:
 - (a) the need for a minimum 100 hours for effective literacy programs;
 - (b) embedding adult literacy programs in vocational education;
 - (c) the benefits of expanding adult literacy across a range of providers, venues and situations;
 - (d) helping parents support their children's literacy through family literacy programs?
- (3) What action will the Government take to increase adult literacy opportunities through:
 - (a) workplace education programs;
 - (b) vocational education programs including TAFE;
 - (c) migrant and refugee support services;
 - (d) indigenous organisations;
 - (e) local community organisations;
 - (f) adult education providers?
- (4) What other plans does the Government have to expand literacy education?

Answer-

- (1) The Government is aware of the international review of adult literacy commissioned by the National Adult Literacy Agency in Ireland.
- (2) to (4) The National Research and Development Centre for Adult Literacy and Numeracy which undertook this research has acknowledged limitations in terms of available research evidence. For example, in relation to the finding of the need for a minimum 100 hours for effective literacy programs, it does not reflect the fact that TAFE NSW exceeds this minimum by delivering adult literacy and numeracy qualifications ranging between 180 to 360 hours, based on individual student need.

The Australian research quoted in the Review refers to 2001-2004 research which is narrow in its focus and does not recognise the significant work that has been undertaken on language, literacy and numeracy over the past six years, including the development of a National VET Equity Advisory Council Equity Blueprint and a National Foundation Skills Strategy and National Foundation Skills Training Package.

The Department of Education and Communities delivers a diverse range of strong and effective programs in adult literacy and will continue to do so.

*0154 COMPANY TITLE DISPUTES—Ms Clover Moore asked the Attorney General, and Minister for Justice—

With regard to the 2007 NSW Law Reform Commission Report 115: Disputes in Company Title Home Units, which recommends legislative changes to enable some company title disputes to be heard by the Consumer Trader and Tenancy Tribunal and through mediation:

- (1) What plans does the Government have to implement the six recommendations?
- (2) What recommendations does the Government reject and what are the reasons for this?

Answer-

I am advised:

The recommendations of the Law Reform Commission were directed to establishing a simpler mechanism to resolve company title disputes between residents. My Department has identified difficulties in conferring this jurisdiction on the Consumer Trader and Tenancy Tribunal and is identifying other options for a Government response this year. The Government will also consider whether further consultation should be conducted.

- *0155 REPORT FROM INFORMATION COMMISSIONER—Ms Clover Moore asked the Attorney General, and Minister for Justice—
 - (1) Will the NSW Government ask the Information Commissioner to report on the operations of the Government Information (Public Access) Act 2009 to identify barriers to open governance, recommend legislative changes, and identify agencies failing to comply with requirements?
 - (2) If not, why not?

Answer-

I am advised:

The Government Information (Information Commissioner) Act 2009 requires the Information Commissioner to prepare and publish a report on the operation of the Government Information (Public Access) Act 2009 as soon as practicable after 30 June each year. The Commissioner must provide the report to the Presiding Officer of each House of Parliament, and to myself as the Minister responsible for the Act. The Government Information (Public Access) Act 2009 commenced on 1 July 2010.

*0156 PREVENTING VIOLENCE AGAINST GAY, LESBIAN, BISEXUAL AND TRANSGENDER PEOPLE—Ms Clover Moore asked the Attorney General, and Minister for Justice—

With respect to implementation of the Government's "Strategic Framework 2007-2012 Working Together: Preventing violence against gay, lesbian, bisexual and transgender people":

- (1) What projects and action have been initiated since the projects listed on the Crime Prevention website for 2007-2008?
- (2) What new projects have been developed since 2008 to address problems arising in "key sites of violence, particularly education facilities and workplaces"?
- (3) What new projects have been developed since 2008 to address "service delivery reform"?
- (4) What new projects have been developed since 2008 to "reduce the incidence of hostility and violence by providing information and education"?
- (5) What new projects have been developed since 2008 to provide "support for victims of prejudice related violence"?
- (6) What new projects have been developed since 2008 to "research into prejudice related violence against GLBT people, with a focus on transgender and bisexual people"?
- (7) What further action will the Government take to address homophobic and transphobic violence and abuse?

Answer-

I am advised:

- (1) The Government remains committed to the whole of government strategy, "Strategic Framework 2007-2012 Working Together: Preventing violence against gay, lesbian, bisexual and transgender people". The Department of Attorney General and Justice (DAGJ) is currently compiling updated achievements and initiatives from participating agencies for 2010. Projects and actions for 2009, as reported to the Department by participating agencies, are listed in response to questions 2 to 6 below.
- (2) New projects include:
 - "Proud Schools", launched by the Department of Education and Communities (DEC) in January 2011, tackling homophobia in NSW high schools.
 - The NSW Anti Homophobia Interagency (NSW AHI) Committee has supported projects to implement anti-homophobia training and resources within DEC, including:
 - meeting with members of the NSW Teachers Federation GLBT Training Course to report on DEC initiatives
 - contributing to the development of "FAIR (Fairness, Acceptance, Individuality, Respect), Putting Anti-Bullying into Action", a Student Services Initiative of the South Western Sydney Region of DEC.
 - · A review of the "Hate Comes Home" anti-homophobia DVD was sent to all NSW Government

Schools.

- The NSW Police Force provided ongoing training to specialist and generalist police on a range of issues affecting GLBT communities, including training for School Liaison Police.
- The WorkCover NSW "Young Workers" website provides information on workplace violence and bullying for young workers.
- (3) Legislative changes in NSW since 2008 include:
 - The Adoption Amendment (Same Sex Couples) Act 2010
 - The Relationships Register Act 2010
 - The Surrogacy Act 2010

Service delivery initiatives include:

- Anti-discrimination awareness raising for staff of the Greater Southern Area Health Service.
- A conference hosted by the Same Sex Domestic Violence Interagency that examined same sex domestic violence.
- DAGJ published "Understanding your Legal Rights: A guide for lesbians and gay men in NSW".
- A training session conducted by DAGJ for the NSW Police Force regarding the Strategic Framework and research into homophobic violence.

(4) New projects include:

- The "This Is Oz" online gallery launched in 2009 and now managed by the Aids Council of NSW (ACON).
- A resource providing information regarding 'beats', developed by the Northern Sydney Central Coast and Sydney South West Area Health Services, in partnership with National Parks and Wildlife and North Sydney Council.
- Presentations to student officers at Goulburn Police College on GLBT issues, a new initiative by the NSW Police Force.

(5) New projects include:

- An education and awareness resource, "However you wanna see me, I'm just me", to assist Aboriginal gay, lesbian and sistergirl people.
- Expanded clinical Sexual Health Services provided by the Northern Sydney Central Coast Area Health Service for gay men.
- Gay and Lesbian Liaison Officer (GLLO) training courses conducted by the NSW Police Force in Tweed Heads and Parramatta
- (6) In 2011, DAGJ will continue to develop a research framework examining the prevalence of hate crime, which includes crimes based on prejudice on the grounds of race, religion, ethnicity, gender, sexuality and disability.
- (7) The Department will update the Framework beyond 2012 and publish the "2010 Annual Report Key projects, Initiatives and Highlights" on an appropriate Crime Prevention Division website when available.
- *0157 NATIONAL DISABILITY INSURANCE SCHEME—Ms Clover Moore asked the Minister for Ageing, and Minister for Disability Services—

Noting the Productivity Commission's report on a national disability insurance scheme that supports individualised funding for people with significant disability:

- (1) What action has the NSW Government taken in support of a national scheme?
- (2) What assessment has the Government made of the benefits of such a scheme?
- (3) What contribution has the Government made to national discussions towards a scheme?
- (4) What action will the Government take to lobby for and support a national disability insurance scheme?

Answer-

(1) A response was provided to the Productivity Commission's Draft Report - and is available on the Ageing, Disability and Home Care website at www.adhc.nsw.gov.au

The response welcomed the Commission's Draft Report and gives in-principle support to the National Disability Insurance Scheme (NDIS). It noted that such a national scheme is essential to ensuring a sustainable disability support system to provide certainty for people with a disability, their families and carers.

An information pack on the NDIS was provided to all members of both Houses of the NSW Parliament and to peak bodies and other significant disability organisations in NSW - including a fact sheet, newsletter article and press release.

It was also proposed, to the Commission, that the Hunter Region be the location for any trial of the NDIS.

- (2) Proposed NDIS was assessed for its social and financial impacts and viability, leading to the NSW Government giving in-principle support but also identifying a number of areas that required further analysis for the Commission's final report.
 - Assessment of the proposed NDIS and development of the NSW Government response was overseen by a cross-Departmental Steering Committee including NSW Treasury; NSW Health; Premier and Cabinet; Ageing, Disability and Home Care; Lifetime Care and Support Authority; and NSW Trustee and Guardian. Additional information was sought from the Departments of Education and Transport; WorkCover Authority and NSW Self Insurance Corporation.
- (3) Provided response to the Commission publicly available on the Ageing, Disability and Home Care website.
 - Participated in a national meeting of Disability Ministers on 19 April 2011, at which the NDIS was discussed. At this meeting discussions were also held with Commissioners Patricia Scott and John Walsh and representatives of the Independent Panel advising the Commission on the Disability Care and Support Inquiry.
- (4) The NSW Government recognises that this is a critical opportunity to fight hard for the futures of people with a disability in NSW.
 - The information packs sent to Members of Parliament and peak bodies contained details of the Every Australian Counts campaign, which is being led by the National People with Disability and Carers Council and the National Disability Services. The NSW Government strongly supports this campaign.

It is essential that there is widespread support through the community for the introduction of a NDIS. As Minister, I have encouraged all people in NSW to express support for the NDIS through this national campaign at www.everyaustraliancounts.com.au

The NSW Government looks forward to the release of the Commission's Final Report and working with the Australian Government and other State and Territory Governments in developing a NDIS.

*0158 PEDESTRIAN SAFETY PADDINGTON/DARLINGHURST—Ms Clover Moore asked the Minister for Transport representing the Minister for Roads and Ports—

With respect to community-supported City of Sydney recommendations for measures to improve pedestrian safety and access in Paddington and Darlinghurst:

- (1) Will the Government review options to address longstanding concerns about through traffic using South Dowling Street north?
- (2) What can be done to redirect northbound through traffic along Flinders Street instead of narrower residential South Dowling Street north?
- (3) What options have been considered to provide for northbound traffic to turn right from Flinders Street at Taylor Square?
- (4) What assessment has been made of options to provide safer crossing of South Dowling Street north near Napier Street?
- (5) What assessment has been made to provide pedestrian crossings:
 - (a) at Three Saints Square on the eastern side of Oxford Street at the intersection of Barcom Avenue and South Dowling Street;
 - (b) at Centennial Square on the eastern side of Oxford Street at the intersection with Moore Park Road and Lang Road?
 - (c) at Drivers Triangle on South Dowling Street, at the intersection with Moore Park Road and Flinders Street and with Fitzroy Street?
- (6) What plans does the Government have to improve pedestrian safety at these locations?

Answer-

I am advised:

(1) In early 2006 the local Member met with the then Minister for Roads and agreement was reached to remove the clearways on the section of South Dowling Street between Oxford Street and Flinders

Street, reducing the carriageway to one lane in each direction. The intention was to reduce traffic volumes and act as a traffic calming strategy.

- The RTA has reviewed the State road network in this area and believes that it is operating at maximum efficiency.
- (2) Northbound traffic using South Dowling Street has the Darlinghurst/Paddington area as a destination. South Dowling Street is considered the most suitable access for this traffic.
- (3) A proposal has been previously considered at the request of the City of Sydney Council but did not proceed because of safety concerns about pedestrian and vehicle conflicts. Another concern is the limited capacity of this intersection. Under the current configuration the intersection is operating at maximum capacity and it is considered that the addition of a right turn movement would result in extensive delays, queuing and localised congestion.
- (4) In 2005, the RTA carried out an investigation of the signalisation of South Dowling Street and Napier Street.
 - In December 2005, the Member for Sydney convened a community meeting to determine the views of residents about installing traffic lights with pedestrian facilities at this intersection. There were numerous objections due to the loss of on-street parking, removal of established trees and the loss of access to Hannam Street. It was decided not to proceed with the installation because of community opposition.
- (5) (a) Due to the high vehicle volumes and limited capacity of the intersection, the addition of a pedestrian crossing on the eastern leg would result in a decreased level of service for the whole intersection, causing extensive queuing and congestion on South Dowling, Victoria and Oxford streets.
 - (b) These traffic lights are operating at capacity. Additional pedestrian facilities at this location would result in extensive delays, queuing and localised congestion.
 - (c) Drivers Triangle is an area isolated by the three surrounding high volume roads. There is a single pedestrian access between Flinders Street, the eastern side of South Dowling Street and the southern side of Moore Park Road, linking to Anzac Parade. Effective pedestrian links along other desire lines do not require access to Drivers Triangle.

Encouraging additional pedestrians onto Drivers Triangle is unnecessary, potentially dangerous and would have an immediate detrimental effect on the traffic flow pattern.

(6) The RTA will review the existing pedestrian crossing facilities on major roads in the Paddington/Darlinghurst area to determine what enhancements can be reasonably provided.

*0161 HURSTVILLE PRIMARY SCHOOL—ADDITIONAL CLASSROOMS—Ms Cherie Burton asked the Minister for Education—

When will construction begin on the \$8 million additional classrooms for Hurstville Primary School?

Answer—

Planning for the provision of additional classrooms at Hurstville Public School is currently underway. Priority consideration will be given for inclusion of the project in the forthcoming State Budget.

*0162 ALLAWAH BRIDGE WIDENING—Ms Cherie Burton asked the Minister for Transport—

When will construction begin to widen the Allawah Bridge?

Answer-

I am advised:

RailCorp will commence work on the bridge renewal project in 2013-2014, with major construction to commence in 2015-2016.

*0163 ST GEORGE HOSPITAL EMERGENCY DEPARTMENT—Ms Cherie Burton asked the Minister for Health, and Minister for Medical Research—

When will construction begin on the new \$30 million emergency department at St George Hospital?

Answer—

I am advised:

The Government is currently undertaking a review of health capital infrastructure. The specific timing of hospital projects will be announced after the budget process is completed in September 2011.

- *0164 HUNTER REGION RESPITE SERVICES—Ms Sonia Hornery asked the Minister for Ageing, and Minister for Disability Services—
 - (1) What respite services are available in the Hunter Region for parents of young adults with disabilities?
 - (2) How often is respite available?

Answer-

(1) Ageing, Disability and Home Care (ADHC) operates six centre-based respite units in the Hunter Region, which provide 29 respite beds per night. Twenty of these beds are available for young people and adults.

Additionally, ADHC funds 18 non-government organisations to deliver 45 respite services for carers of adults with a disability. These respite services include centre based respite, own home, host family, peer support and flexible respite packages.

A centre-based respite service offers a minimum of 25 days of respite per year per person for 16 hours per day. This equates to 400 hours of respite per annum per person. A flexible respite place provides a minimum of 168 hours of respite per annum per person.

(2) Centre-based respite operated by ADHC is allocated and available on a quarterly basis. An average allocation is four nights per stay and most families receive three stays per quarter.

Own home, host family and flexible respite programs are allocated on either a six or 12 month basis, depending on the particular application and prioritisation process used by an individual service provider. The use of the respite allocation is planned between the respite provider, the carer, and (where relevant) the case manager. Carers may receive different amounts of respite from their package, depending on their expressed preferences, choice of service model or individual respite plan.

Peer Support programs usually operate every week and activities are provided two or three times per week on average, on weeknights and weekends.

*0165 JOHN PAGET—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

- (1) Is John Paget employed or retained by the Department of Attorney General and Justice?
- (2) If so:
 - (a) What are the terms and conditions of his employment?
 - (b) When did his employment commence?
 - (c) What selection process was adopted?
- (3) Has John Paget Consulting been engaged by the Department of Attorney General and Justice?
- (4) If so, and in relation to that consultancy:
 - (a) What are the terms and conditions of his employment?
 - (b) When did his employment commence?
 - (c) What selection process was adopted?

Answer—

I am advised:

- (1) Dr John Paget has been engaged as a consultant by the Department of Attorney General and Justice.
- (2) (a) Dr Paget is engaged as a consultant to give high-level policy advice in regard to corrections. His remuneration is based on an hourly rate commensurate with his expertise. He is subject to standard departmental requirements with respect to insurance coverage, ABN disclosure and confidentiality.

Payments for consultants are published in the Department's Annual Report in accordance with the Annual Reports (Departments) Act 1985.

- (b) Dr Paget has been engaged since 19 May 2011.
- (c) Dr Paget was engaged on the basis of his known Senior Executive expertise as a former Senior Corrections Executive (including Chief Executive Officer) in three jurisdictions.
- (3) John Paget Consulting has not been engaged by the Department of Attorney General and Justice, though it is open to Dr John Paget to submit invoices through that entity.
- (4) Not applicable.

*0166 POTENTIAL CONFLICTS OF INTEREST—Mr Paul Lynch asked the Premier, and Minister for Western Sydney—

- (1) Has the Government or your department retained the services of the legal firm DLA Phillips Fox, now known as DLA Piper?
- (2) If so, what consideration has been given to managing potential conflicts of interest?

Answer-

I am advised:

I refer to the responses provided by the Attorney General in relation to Question 0167 and the Minister for Finance and Services in relation to Question 0168.

There is no record of recent payments to legal firm DLA Piper (formerly known as DLA Phillips Fox) in the Department of Premier and Cabinet's finance system.

- (1) My Department has retained the services of DLA Phillips Fox regarding leasing matters.
- (2) Potential conflicts of interest are managed in accordance with NSW Government procurement policies and the relevant provisions of the Law Society of NSW's Revised Professional Conduct and Practice Rules 1995.
- *0169 NATIONAL PARTNERSHIPS REWARD PAYMENTS—Ms Carmel Tebbutt asked the Minister for Education—

What discussions have occurred between the NSW Government and the Australian Government about the use of National Partnerships reward payments since 26 March 2011?

Answer-

There have been no discussions.

*0170 NATIONAL PARTNERSHIPS REWARD PAYMENTS—Ms Carmel Tebbutt asked the Minister for Education—

Has the Australian Government agreed to the use of National Partnerships reward payments to fund the NSW Government's election commitment to employ additional literacy and numeracy teachers?

Answer—

The National Partnership Agreement on Literacy and Numeracy between the Commonwealth and New South Wales requires only that "states and territories that receive reward funding must use this funding for education purposes".

There is no requirement for the State to reach agreement with the Commonwealth on the specific use of National Partnership reward payments.

- *0171 NUMBER PLATE RECOGNITION TECHNOLOGY—Mr Richard Amery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Has the Mount Druitt Police Station been equipped with the new number plate recognition technology?
 - (2) If so, what results have been achieved in detecting stolen vehicles and unregistered vehicles with this technology?

Answer-

The NSW Police Force has advised me:

- (1) The Mount Druitt Local Area Command became involved in the trial of mobile automated number plate recognition (ANPR) technology in January 2010.
- (2) This technology has led to 650 Traffic Infringement Notices issued for unregistered vehicles. Police cannot advise the number of stolen vehicles detected due to the way the data is currently recorded, however this issue will be addressed in the near future.
- *0172 JOHN HUNTER HOSPITAL—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—
 - (1) For the period covering the first quarter of 2011, how many persons attended the John Hunter Hospital for medical treatment in all categories?
 - (2) Of this number, how many were treated by the emergency department?
 - (3) How many were admitted to hospital?
 - (4) Of the number admitted at question (3), how many patients were transferred to other hospitals?

Answer-

I am advised:

- (1) and (2) 93,286 patients attended the John Hunter Hospital for medical treatment from 1 January to 31 March 2011. 16,379 of these patients were treated in the Emergency Department.
- (3) and (4) 18,196 patients were admitted to the John Hunter Hospital from 1 January to 31 March 2011. 630 of these patients were transferred to other hospitals.
- *0173 INGLEBURN POLICE STATION—Dr Andrew McDonald asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—
 - (1) Does the Government plan to reopen Ingleburn Police Station?
 - (2) What staff enhancements would be required?
 - (3) What cost implications are there?
 - (4) When would any reopening occur?
 - (5) Would this station be manned/staffed 24 hours per day and seven days per week?
 - (6) What effect would any reopening have on staffing at Macquarie Fields Local Area Command?

Answer—

The NSW Police Force has advised me hat there is no existing or planned police stations at Ingleburn. Police from Macquarie Fields Local Area Command patrol the Ingleburn area on a regular basis.

- *0174 TIGERS DEVELOPMENT APPLICATION—Mr Jamie Parker asked the Minister for Planning and Infrastructure, and Minister Assisting the Premier on Infrastructure NSW—
 - (1) Given the transitional arrangements announced by the Government in relation to development applications previously being dealt with under Part 3A of the Environmental Planning and Assessment Act, why has the Tigers development application in Rozelle not been referred back to Leichhardt Council for determination?
 - (2) Will the applicant be required to comply with the voluntary planning agreement (VPA) between council and applicant?
 - (3) How will any requirement to comply with the VPA be ensured?
 - (4) What planning rules will apply to consideration of the Tigers development application?
 - (5) (a) Has a deadline been set for determining the Tigers development application?
 - (b) If so, what is that deadline?

Answer-

- (1) The NSW Government has acted on a pre-election commitment to repeal Part 3A of the EP&A Act by initially removing residential, commercial, retail and coastal subdivision projects from the Major Development SEPP. This means these projects will no longer be identified as major projects. Transitional arrangements were established such that projects which had already had Director General's Requirements issued as at 8 April 2011 were retained as Part 3A projects given that they had substantially progressed in the assessment system. The Tigers project will therefore continue to be assessed as a major project consistent with the transitional arrangements.
- (2) and (3) The Director General's requirements issued for the proposal specifically require the proponent to address public benefit and provide details of any proposed contributions or any VPA. The Department

of Planning and Infrastructure will ensure full consultation with Leichhardt Council on this issue and that the development contributes reasonably to any additional demands it generates. The VPA previously negotiated between Council and the applicant will be fully considered as part of this process.

(4) The Department will undertake a full merit based assessment of the application and will consider Council's planning controls for the site as well as the Director General's requirements. The project will be determined by the Planning Assessment Commission.

The assessment process will also include a full public exhibition through which the views of the Council and community will be sought and carefully considered.

The "Sobering Up Centres" project is in the planning stages, and a range of agencies including the NSW Police Force have been, and will continue to be, consulted on the development of the Centres.

Mental health reform across the state will be achieved through developing community solutions that are practical, financially viable and sustainable.

Healthy Lifestyles

On 4 March 2011 the Coalition announced a Preventative Health election commitment to establish:

- 1. A \$120 million Preventative Health Fighting Fund which pools health promotion resources for prevention programs and facilitates a more strategic and integrated approach to keeping people healthy and out of hospital.
- 2. An Office of Preventative Health Located in South West Sydney, the office will have a state-wide focus and be established in partnership with the University of Western Sydney.

This year, significant funds will be invested into preventative health in NSW. The National Partnership Agreement on Preventive Health will bring more than \$100 million over four years to provide evidence-based programs supporting children's and adult's health through targeting chronic disease risk factors including healthy weight, fruit and vegetable consumption, physical activity& smoking.

The Childhood Physical Activity and Healthy Weight Program will involve a revised and refocused state wide roll out of existing evidence-based programs that promote physical activity and healthy nutrition. These programs will be delivered in a variety of community settings such as playgroups, child care services and schools.

In addition to the state wide roll out of existing programs, new initiatives that address the promotion of physical activity and healthy nutrition through community education and sporting club settings will be developed.

Implementation plans specifying the program to be delivered, program scheduling and performance targets have been approved by the Commonwealth and NSW Ministers for Health.

NSW Health is now planning and delivering the Childhood Physical Activity and Healthy Weight Program across NSW as well as targeted programs such as the Targeted Family Physical Activity and Healthy Eating Program provides intensive support for families with a child aged seven to 13 years who is overweight or obese, to provide lifestyle change for better health.

The Targeted Family Physical Activity and Healthy Eating Program will reach 7,000 children aged seven to 13 years will participate in the program over the next four years.

Recruitment will shortly be underway to ensure NSW Health staffs are ready to deliver these important programs across NSW.

The National Partnership Agreement on Preventive Health will also bring \$46 million to NSW for investment in healthy workplaces.

The NSW Healthy Workers initiative will have a strong focus on supporting working adults to achieve lifestyle change by achieving and maintaining a healthy weight, consuming two serves of fruit and five serves of vegetables a day, undertaking at least 30 minutes of physical activity at least five times a week and quitting smoking.

- (1) In relation to current coal seam gas exploration activities in the northern Illawarra region, where is the water that is extracted from the bores during this process stored?
- (2) In relation to the current exploration activities by APEX Energy NL in the northern Illawarra, is APEX Energy NL able to conduct hydraulic fracturing under their current development application for the AI16 and AI19 bores?
- (3) What is the status of the Illawarra Coal Measures Project and is this or has this project carried out seismic testing or drilling in the area?

Answer-

This matter is primarily for the Minister for Infrastructure and Planning. However, I am advised as follows:

- (1) The coal seam gas exploration activities are regulated by a Major Project Approval granted by the Department of Planning and Infrastructure under Part 3A of the Environmental Planning and Assessment Act 1979. Under the requirements of this approval, Apex Energy is required to install a sump at each drill site to store the water that is extracted from the bores. The sump is required to be lined with plastic and a tanker empties the sumps as necessary.
- (2) No. Hydraulic fracturing was not considered as part of the current development application for boreholes AI16 and AI19. Borehole AI19 was not included as part of the original development application and currently does not have approval. The Department of Planning and Infrastructure is considering a modification to the project approval to include borehole AI19.
- (3) The Department of Planning and Infrastructure has advised the Office of Environment and Heritage that the Illawarra Coal Measures Project has not commenced gas exploration activities in the northern Illawarra Region to date. No seismic testing or drilling has occurred in the area.

- *0204 NO COST TO CONSUMER DENTAL SERVICES—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

What no cost to consumer dental services are available in the NSW Public Health system to adults who are not in possession of a Health Care Card?

Answer-

As it was under the previous government, eligibility for public dental services in New South Wales is governed by NSW Health Department Policy Directive 2009/74 Oral Health - Eligibility of Persons for Public Oral Health Care in NSW.

This Policy Directive states inter alia:

"For an adult to be eligible for free public oral health services they must:

- Hold, or be listed as a dependent on, one of the following valid Australian Government concession cards;
 - · Health Care Card
 - · Pensioner Concession Card
 - · Commonwealth Seniors Health Card."

Therefore, in addition to Health Care Card holders, those adults who hold a valid Pensioner Concession Card or a valid Commonwealth Seniors Health Card are also eligible for free public dental services in New South Wales.

- *0205 NURSE PRACTITIONERS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) (a) How many nurse practitioners have been appointed in NSW?
 - (b) Where are they located?
 - (2) Are there plans to create new positions for Nurse practitioners in the NSW public health system?

Answer-

I am advised:

- (1) 185 nurses are currently appointed to Nurse Practitioner positions in NSW across rural, remote and metropolitan regions.
- (2) Yes.
- *0206 METHADONE DISPENSERS—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—
 - (1) How many private clinics are authorised by the Government to dispense methadone?
 - (2) How many pharmacies have been authorised to dispense methadone?
 - (3) How many other dispensing agencies are there?
 - (4) What measures are taken to ensure security controls of methadone dispensers?

Answer—

I am advised:

(1) to (4) Controls on the dispensing of methadone and/or buprenorphine are primarily under the provisions of the Poisons and Therapeutic Goods Act 1966, which governs the receipt, storage, prescribing, recording, accountability, supply and the labelling of takeaway doses. As for all Schedule 8

drugs, methadone and buprenorphine are fully accountable by way of drug register entries and must be stored in a safe.

12 privately operated clinics are licensed under the provisions of the Poisons and Therapeutic Goods Act to supply methadone and/or buprenorphine for the treatment of opioid dependence.

Privately operated clinics are additionally subject to a range of conditions attaching to their licenses, including the need to maintain accreditation. Accreditation standards address issues such as patient assessment treatment and care, amenity, community liaison, safety and the ongoing monitoring of the clinic's total operation.

Prior to licensing, private clinics are inspected to ensure that security is of a high standard, including the installation of safes, the security of the premises and that procedures are in place to properly account for the receipt, storage and supply of methadone and/or buprenorphine.

772 community pharmacies in NSW are authorised to supply methadone and/or buprenorphine for the treatment of opioid dependence.

Community pharmacists are required to provide a signed undertaking to comply with the Department of Health's Guidelines for Community Pharmacies supplying Methadone and Buprenorphine, prior to authorisation. The Guidelines incorporate the requirements of the Poisons and Therapeutic Goods Act and the Department of Health's Clinical Practice Guidelines.

37 clinics operated by NSW Health and 185 other administration points, including hospital pharmacies, adult correctional centres, juvenile justice centres and doctors' surgeries are authorised to supply methadone and/or buprenorphine for the treatment of opioid dependence.

The public sector clinics are subject to rigorous accreditation standards. All public sector administration points are subject to auditing and the governance of the local public sector authority.

Privately licensed clinics, community pharmacies and all administration points in the public sector can be subject to inspections at any time by Department of Health inspectors.

*0210 INCENTIVE TRANSFER SCHEME FOR TEACHERS—Ms Sonia Hornery asked the Minister for Education—

What are the details of the Government's incentive transfer scheme for teachers, referred to by the Minister for Education during question time on 30 May 2011?

Answer—

A wide range of incentives are provided to attract and retain teachers in rural and isolated locations, including small schools.

Teachers in our remote rural schools receive additional benefits and incentives including subsidised housing, additional vacation and leave periods, retention benefits and additional training and development days. Furthermore, they may apply for an incentive transfer to a school to which they wish to be appointed. Incentive transfer applications are given priority when positions are filled.

The Department's incentive transfer scheme enables classroom teachers, executive staff and principals in 8 and 6 point incentive schools to apply for a transfer to a school of their choice after completing 3 years of service, or 2 years of service in an identified small number of schools.

Teaching partners of classroom teachers, executive staff and principals appointed to or transferring out of positions in 8 and 6 point incentive schools are eligible for concurrent compassionate transfer status, enabling them to transfer when a suitable vacancy arises.

Classroom teachers, executive staff and principals in 4 point incentive schools are eligible to apply for transfer to a school of their choice after completing 5 years of service.

- *0212 SEWERAGE CONNECTION TO WEST HOXTON—Dr Andrew McDonald asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—
 - (1) What are the current plans of Sydney Water for connection of sewerage to West Hoxton?
 - (2) Is there a possible timeframe?
 - (3) Is there an estimate of total cost?
 - (4) Is there an estimate of likely cost to the individual consumer?

Answer-

I am advised:

- (1) Sydney Water commenced planning for the West Hoxton Sewerage Scheme in early 2011 and has identified a number of suitable and efficient servicing strategies. All the proposed options connect to the wastewater system being constructed as part of the Middleton Grange development, which is to the east of the West Hoxton village.
 - Further planning is in progress to determine the preferred servicing strategy, the environmental impacts and the best way of delivering the scheme.
- (2) At this time no construction commencement date has been determined. Planning typically takes about two years as public health and environmental requirements are assessed.
- (3) A preliminary estimate of \$10 million has been prepared for the scheme.

(4) The costs to the customer are typical and standard for connecting to a sewerage system. These include:

Connection Fees and Sewerage Charges as at 1 July 2011 (to Sydney Water)

- A one off fee of \$178.75 to connect to the system, which consists of an application fee plus a \$94.70 inspection fee. A further fee of \$94.70 would be required if the property needs extra inspections.
- An on-going Sydney Water standard sewerage service charge, currently \$134.89 per quarter. Pensioner rebates apply for eligible customers.

On-site Costs for information

- The installation of new pipework to connect the house to Sydney Water's wastewater network
 and any remedial works to ensure that the existing house plumbing conforms with plumbing
 standards.
- The decommissioning of existing septic tanks if they are no longer required.
- If the sewerage system provided requires pumping from the property, the additional costs would be for:
 - Electricity charges associated with operating pumps. (About \$36 per year for a normal residential property)
 - Any remedial works that may be required to ensure the household electrical distribution board meets relevant energy supplier's requirements.
 - Industrial zoned properties and some commercial properties will be required to provide their own on-property pumping equipment where pumped systems are used.

Given that many of the costs associated with the connection can vary from property to property, it is not possible to provide a clear guide to the costs associated with connection. Sydney Water does advise the community of the costs during the community consultation process.

*0213 BUS SERVICE FROM CARNES HILL VIA PRESTONS—Dr Andrew McDonald asked the Minister for Transport—

- (1) Has a daily bus run from Carnes Hill via Prestons, catering for students at the selective schools at Hurlstone Agricultural High School and Macquarie Fields High School, been investigated?

The Department of Transport considers that viable route bus and rail services are available for students travelling from Carnes Hill, Horningsea Park and Prestons to Hurlstone Agricultural High School and Macquarie Fields High School.

Students can currently catch a Route 851 or 852 bus service to Liverpool Station. Students may then either transfer to a Route 870, 871 or 872 bus service or catch a train to Glenfield or Ingleburn.

*0214 LOW SOCIO-ECONOMIC STATUS SCHOOL COMMUNITIES NATIONAL PARTNERSHIP—Ms Carmel Tebbutt asked the Minister for Education—

I provide the following details in response to your questions:

- (1) The Division of Local Government is currently undertaking an infrastructure audit on all councils that were in Group 1 for integrated planning and reporting purposes. Lake Macquarie City Council was in Group 1. It is expected that the infrastructure audit will be completed by late August 2011.
 - Newcastle City Council is in Group 2, and it is anticipated that the infrastructure audit for all Group 2 councils will be completed by December 2011.
- (2) The information being gathered in the audit is for information only. All councils in NSW are required to report on infrastructure maintenance and backlogs in their annual reports. Councils' annual reports are publicly available.
- (3) The management of local infrastructure is the responsibility of each council.
 - Councils, in consultation with their communities, are expected to take necessary action is to address the backlog. This may include seeking approval from IPART to increase rate revenue, borrowing additional funds or seeking grants.

The Government is committed to ensuring local communities have appropriate infrastructure and will use the audit information to assist in meeting that aim.

The Government will establish a Local Infrastructure Renewal Scheme, which will provide interest subsidies to councils. This will unlock up to \$1 billion in funds that councils can borrow for infrastructure upgrades.

Work is currently occurring to embed these changes and includes action to ensure that the health system is a patient centred one, supported by high quality clinical care, strengthened local decision making, enhanced clinician engagement and reduced red tape.

The recent establishment of Local Health Districts and Boards brings all decision making closer to the patient and means local clinicians and local communities have a greater role in the way health services are provided and delivered.

This structural change will drive the major cultural changes needed in the health system as identified by Commissioner Garling. Culture change under the O'Farrell Stoner Government will be supported by CORE values - collaboration, openness, respect and empowerment to ensure supportive working environments free of bullying and harassment.
